**DESCRIPTION**

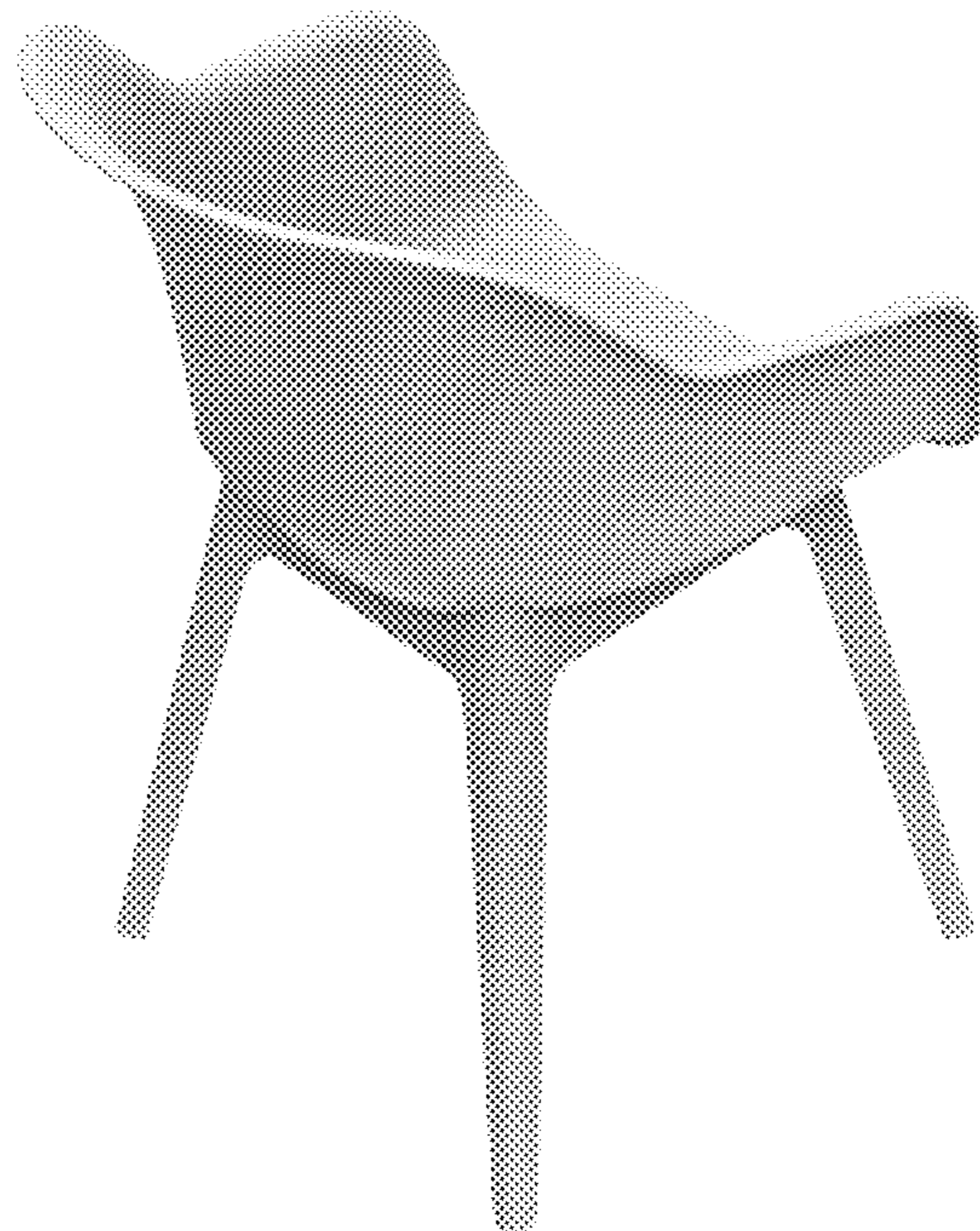

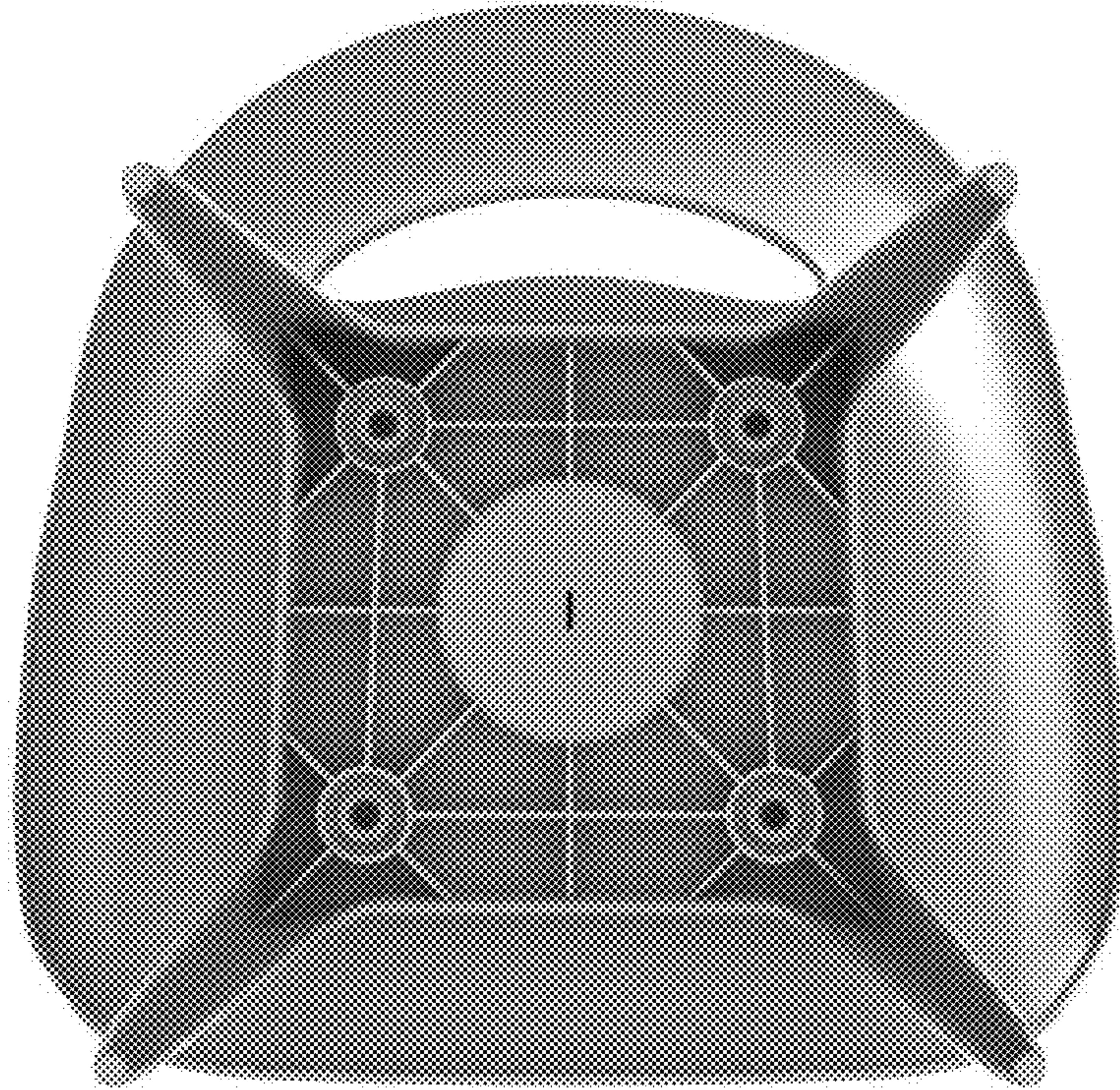
