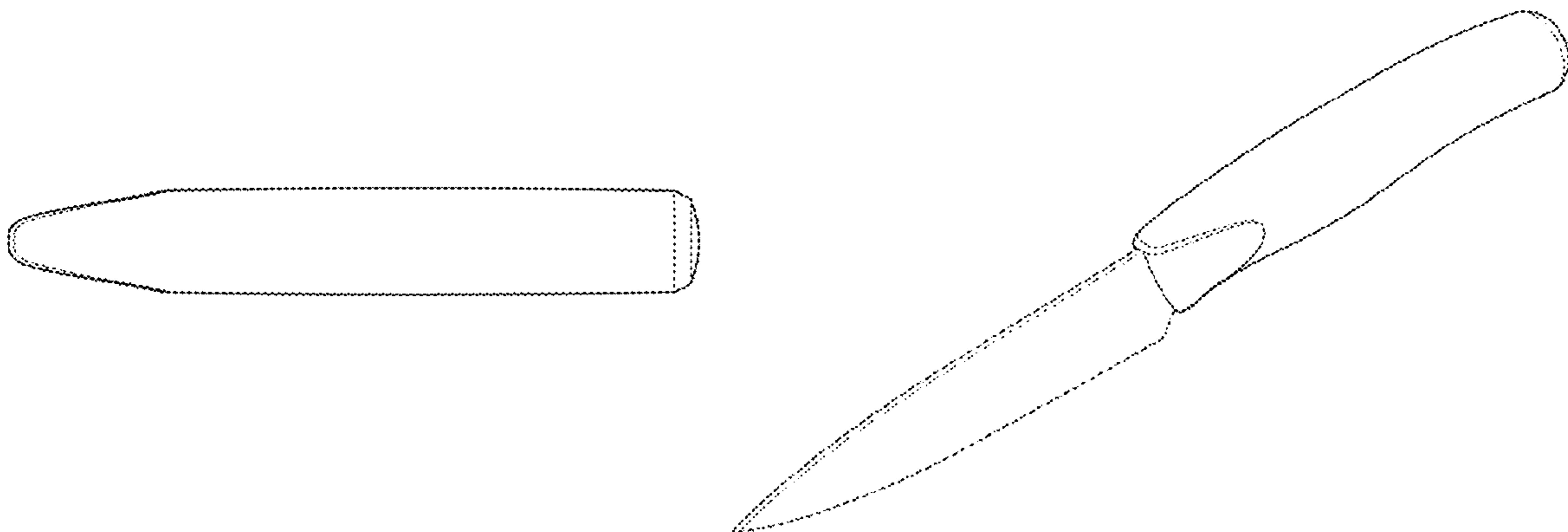
(57) **CLAIM**

The ornamental design for a kitchen knife handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a kitchen knife handle design; FIG. 2 is a first side view of the kitchen knife handle design; FIG. 3 is a second side view of the kitchen knife handle design; FIG. 4 is a front side view of the kitchen knife handle design; FIG. 5 is a rear side view of the kitchen knife handle design; FIG. 6 is a top plan view of the kitchen knife handle design; FIG. 7 is a bottom plan view of the kitchen knife handle design; and, FIG. 8 is a reference view of the kitchen knife handle attached to a knife blade. The broken lines illustrate the environment of the knife handle and form no part of the claimed design.

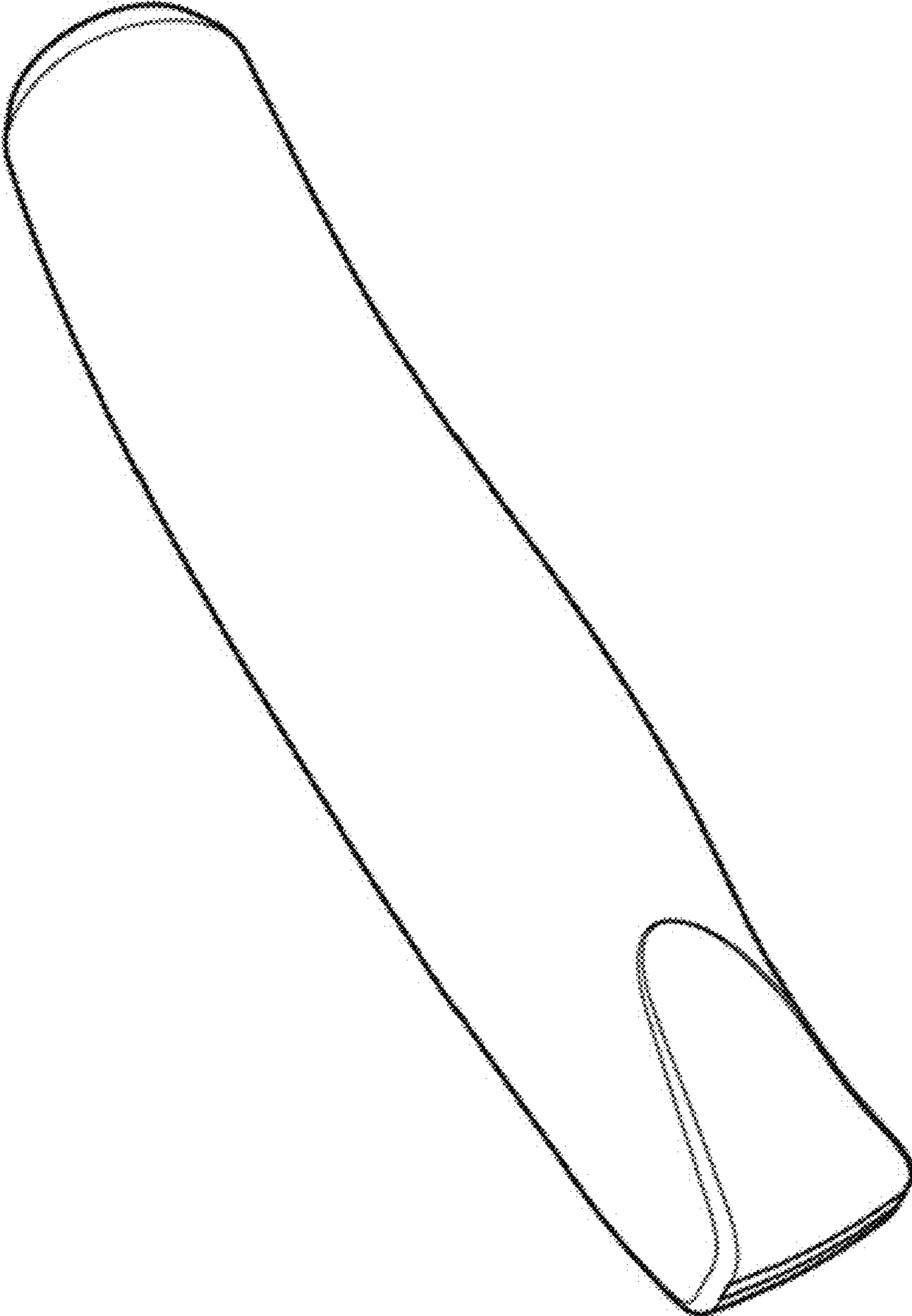

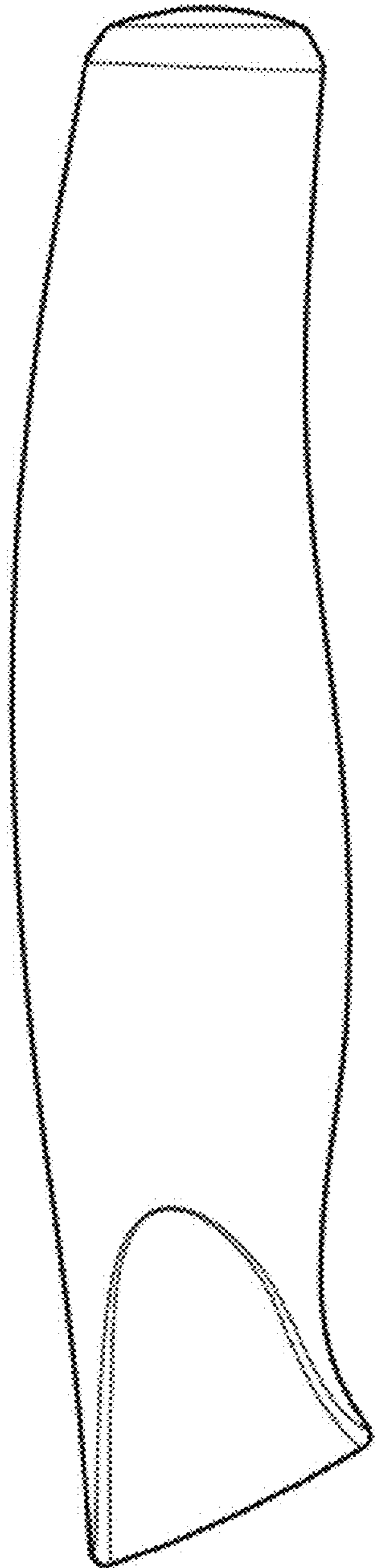

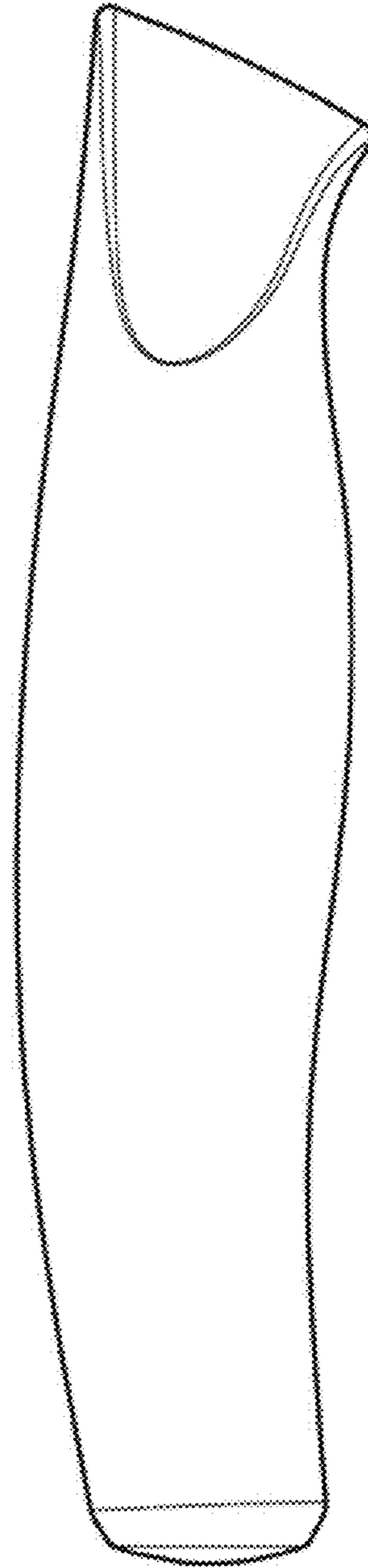

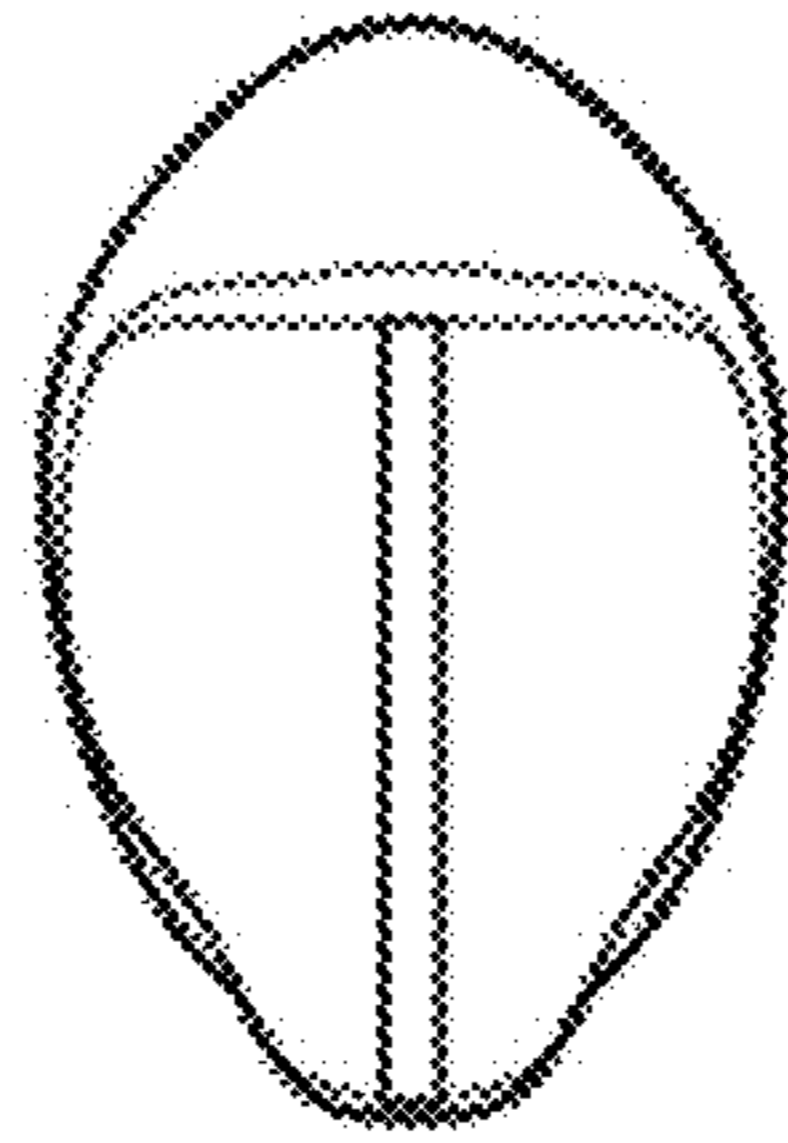

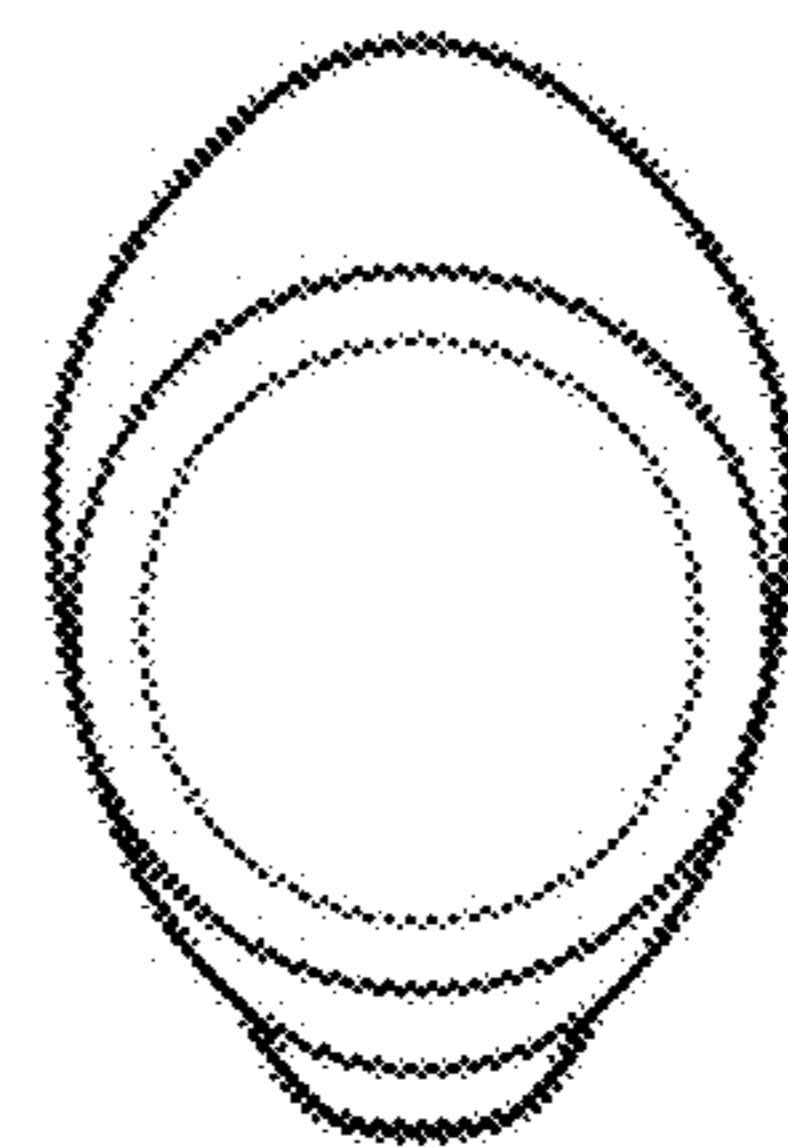

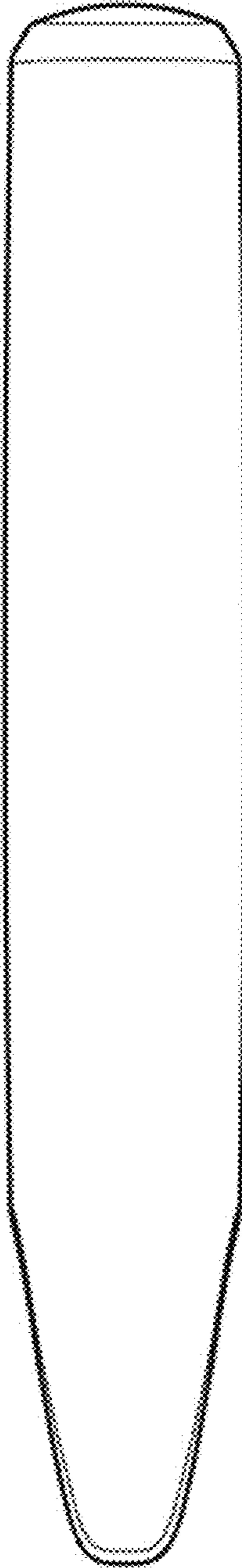

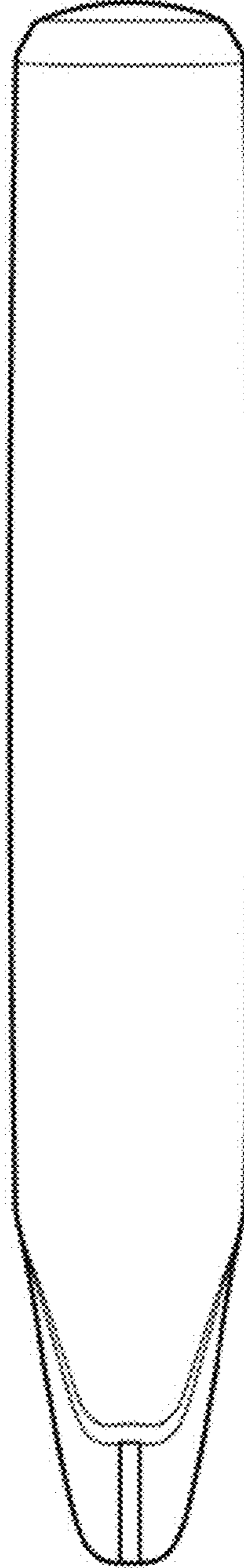

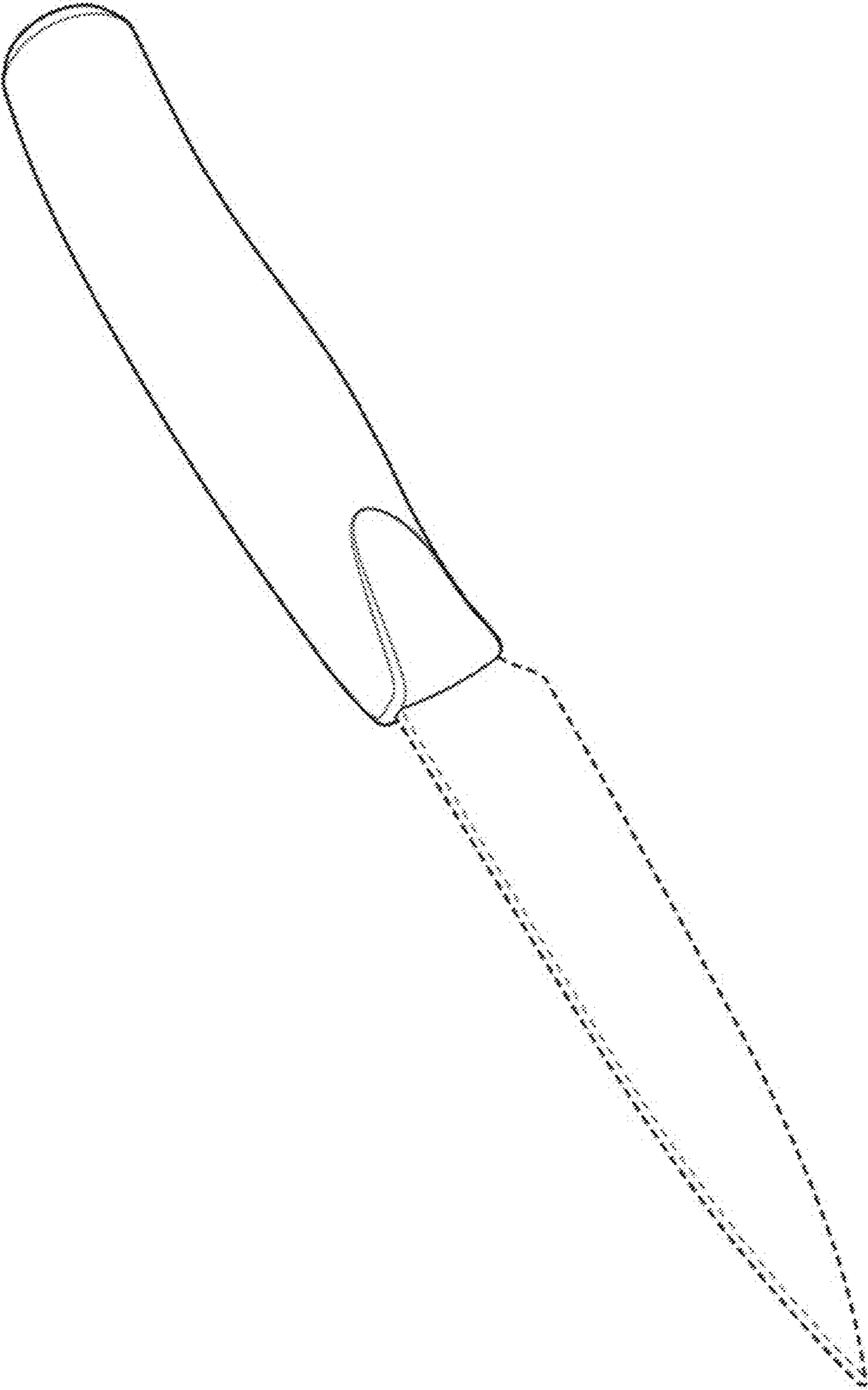
