(57) **CLAIM**

The ornamental design for a fry basket with saddle-design support frame and splayed handle and hanger assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a fry basket of a first size according a first embodiment of our design, a fry basket of a second size according a second embodiment of our design, and a fry basket of a third size according a third embodiment of our design;

FIG. 2 is a perspective view of the fry basket of the first size according to the first embodiment viewed from a front end; FIG. 3 is a perspective view thereof viewed from a back end; FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;

FIG. 5 is a front elevational view thereof; FIG. 6 is an enlarged rear elevational view thereof;

FIG. 7 is a top plan view thereof; and FIG. 8 is a bottom plan view thereof;

FIG. 9 is a perspective view of the fry basket of the second size according to the second embodiment viewed from a front end;

FIG. 10 is a perspective view thereof viewed from a back end;

FIG. 11 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;

FIG. 12 is a front elevational view thereof;

FIG. 13 is an enlarged rear elevational view thereof;

FIG. 14 is a top plan view thereof; and

FIG. 15 is a bottom plan view thereof;

FIG. 16 is a perspective view of the fry basket of the third size according to the third embodiment viewed from a front end;

FIG. 17 is a perspective view thereof viewed from a back end;

FIG. 18 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;

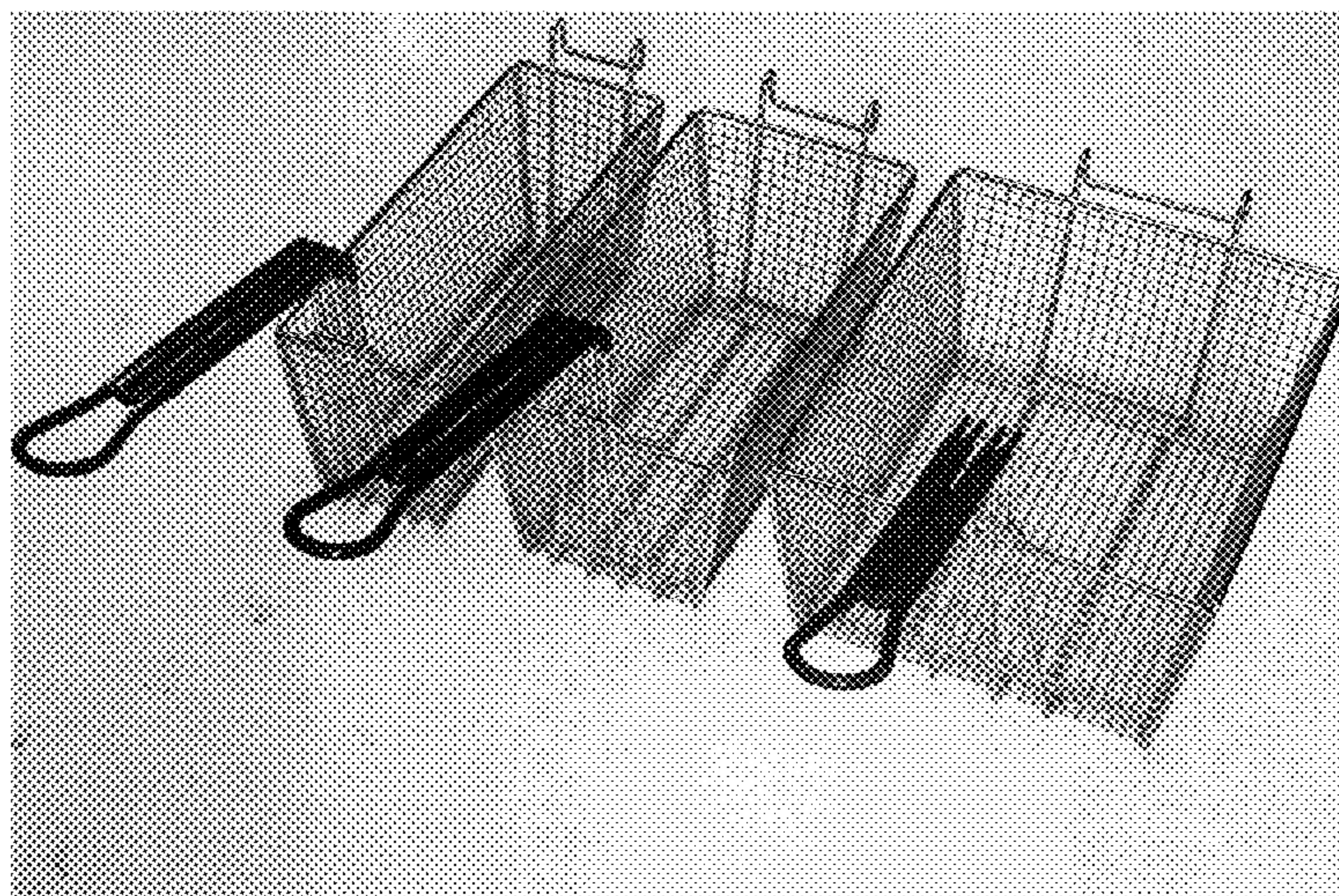
FIG. 19 is a front elevational view thereof;

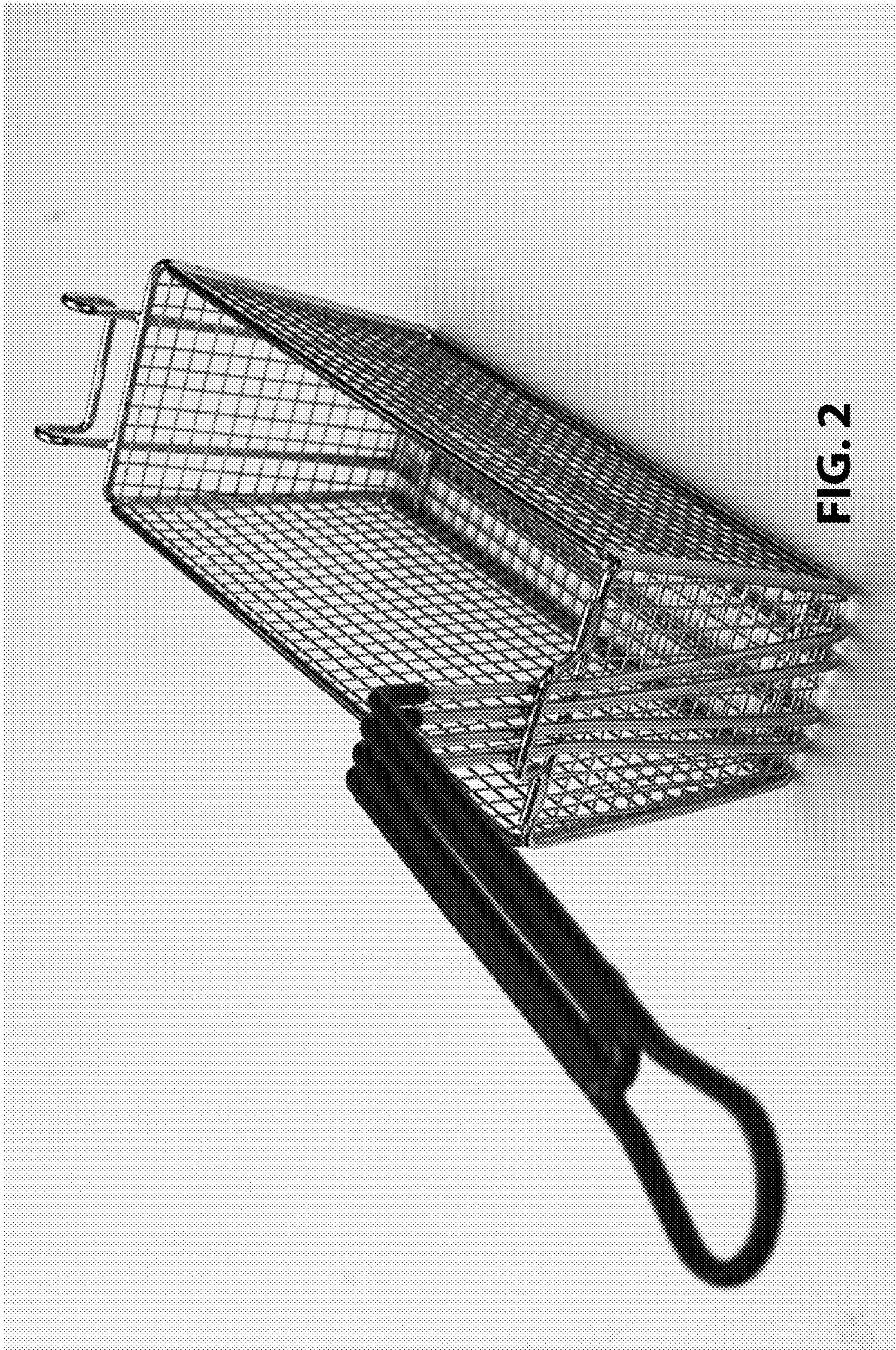
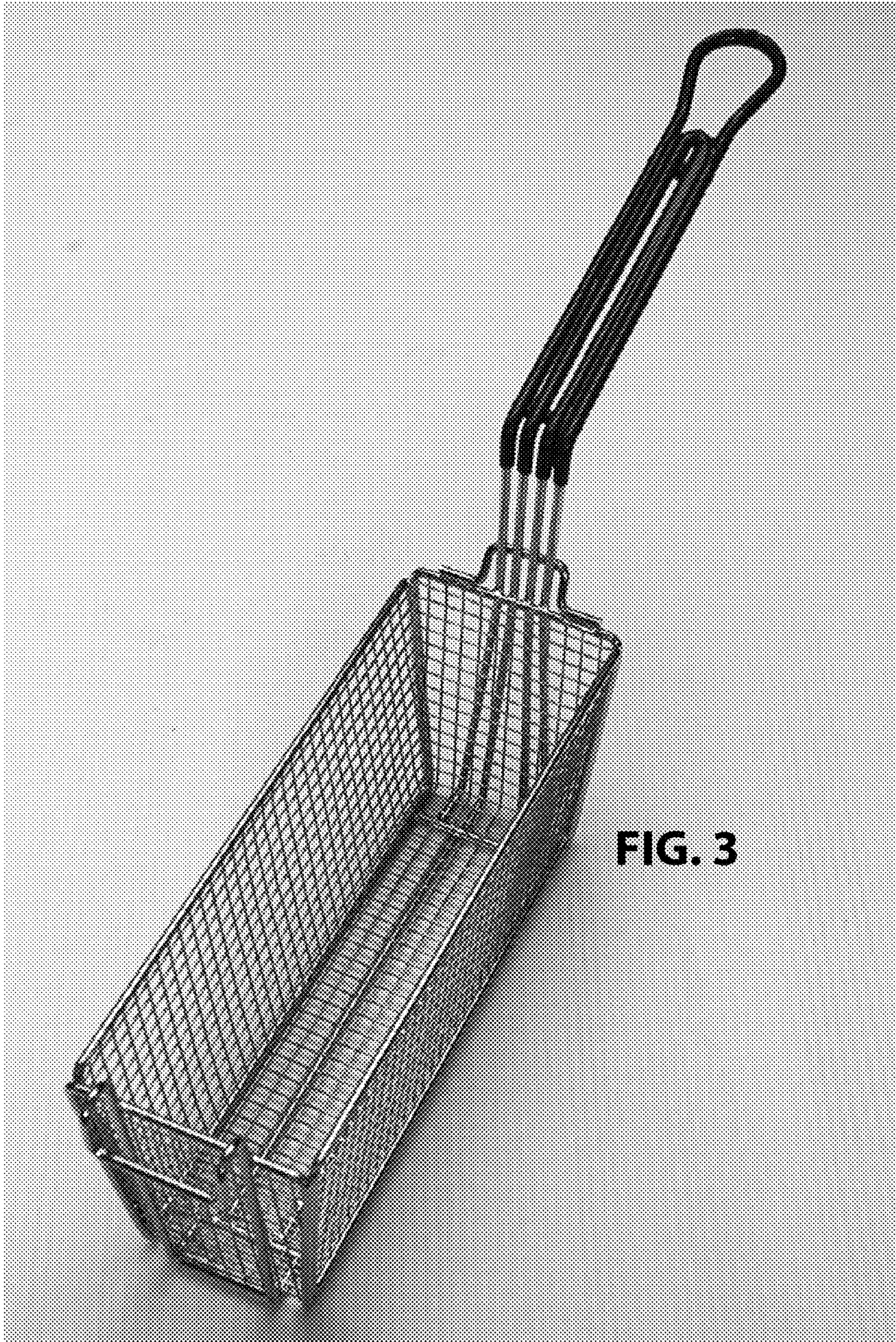

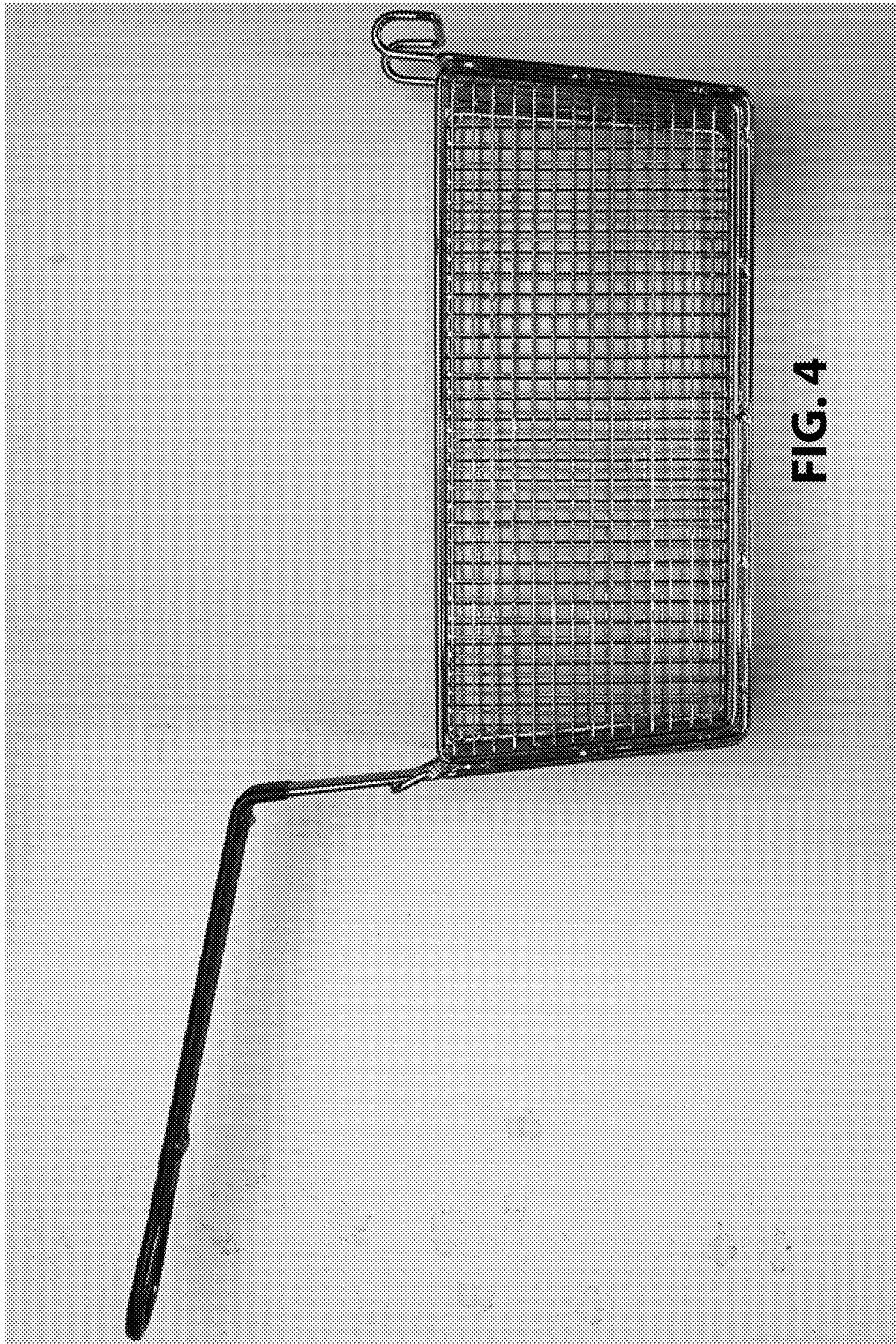
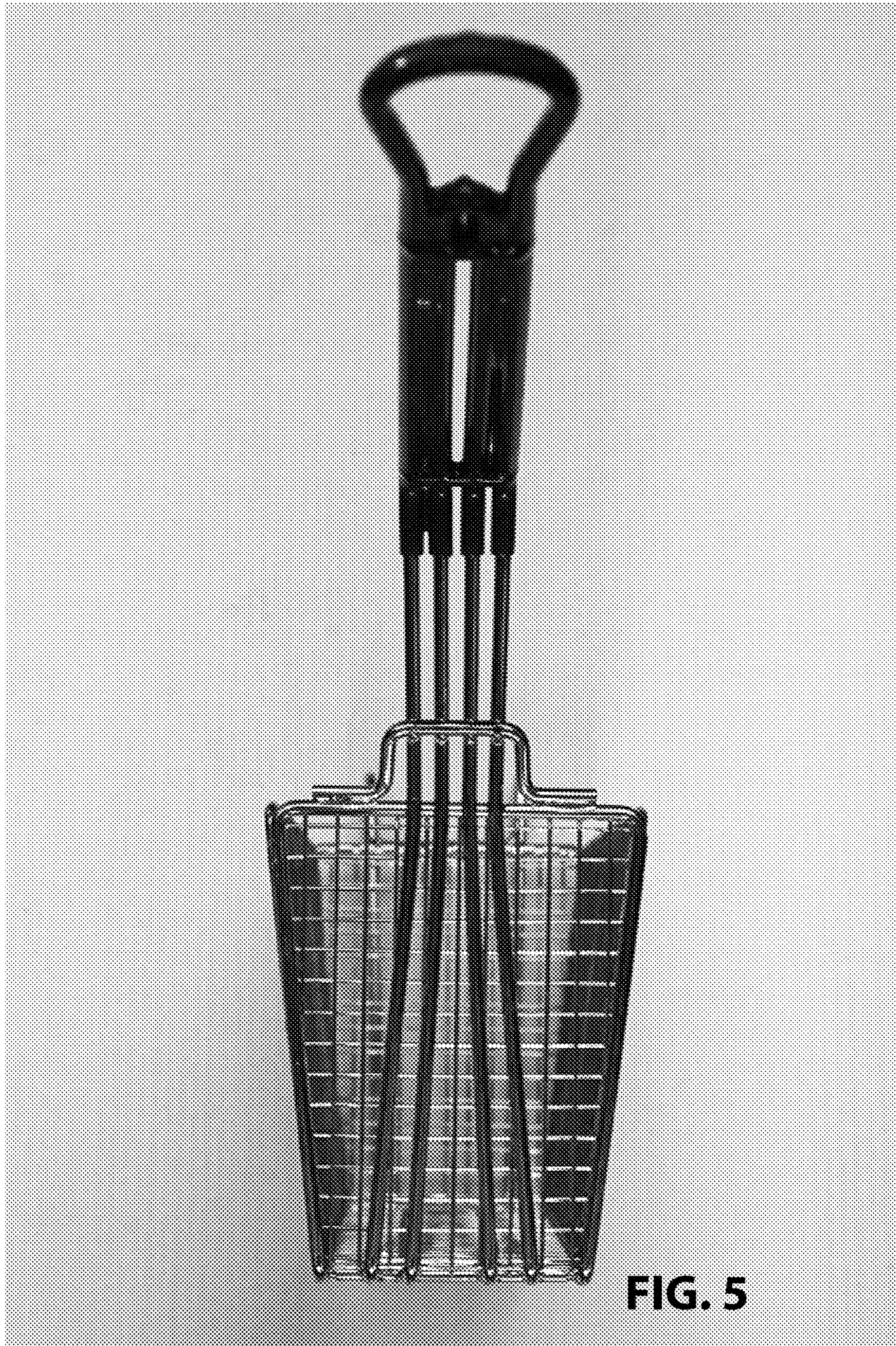
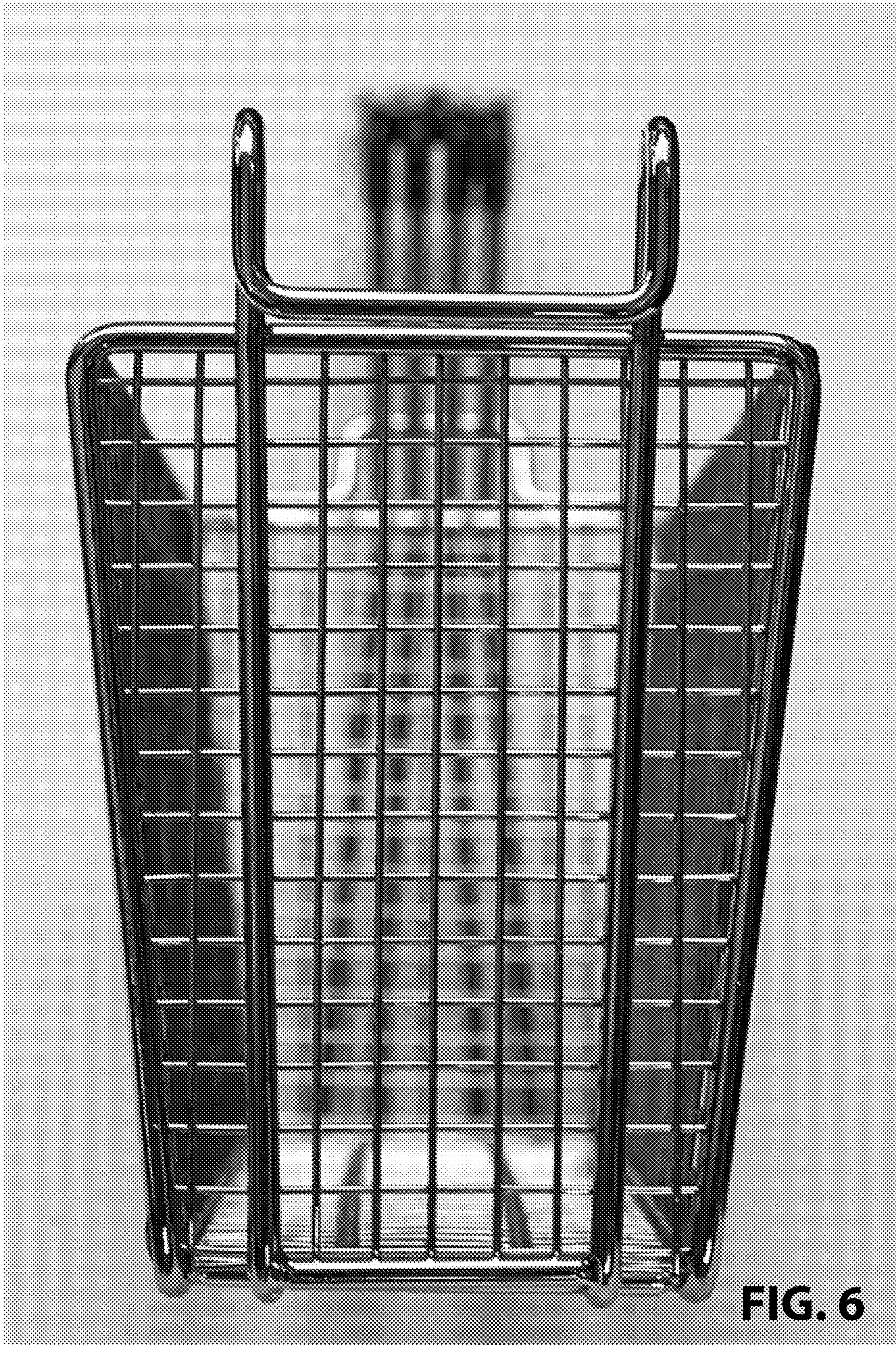

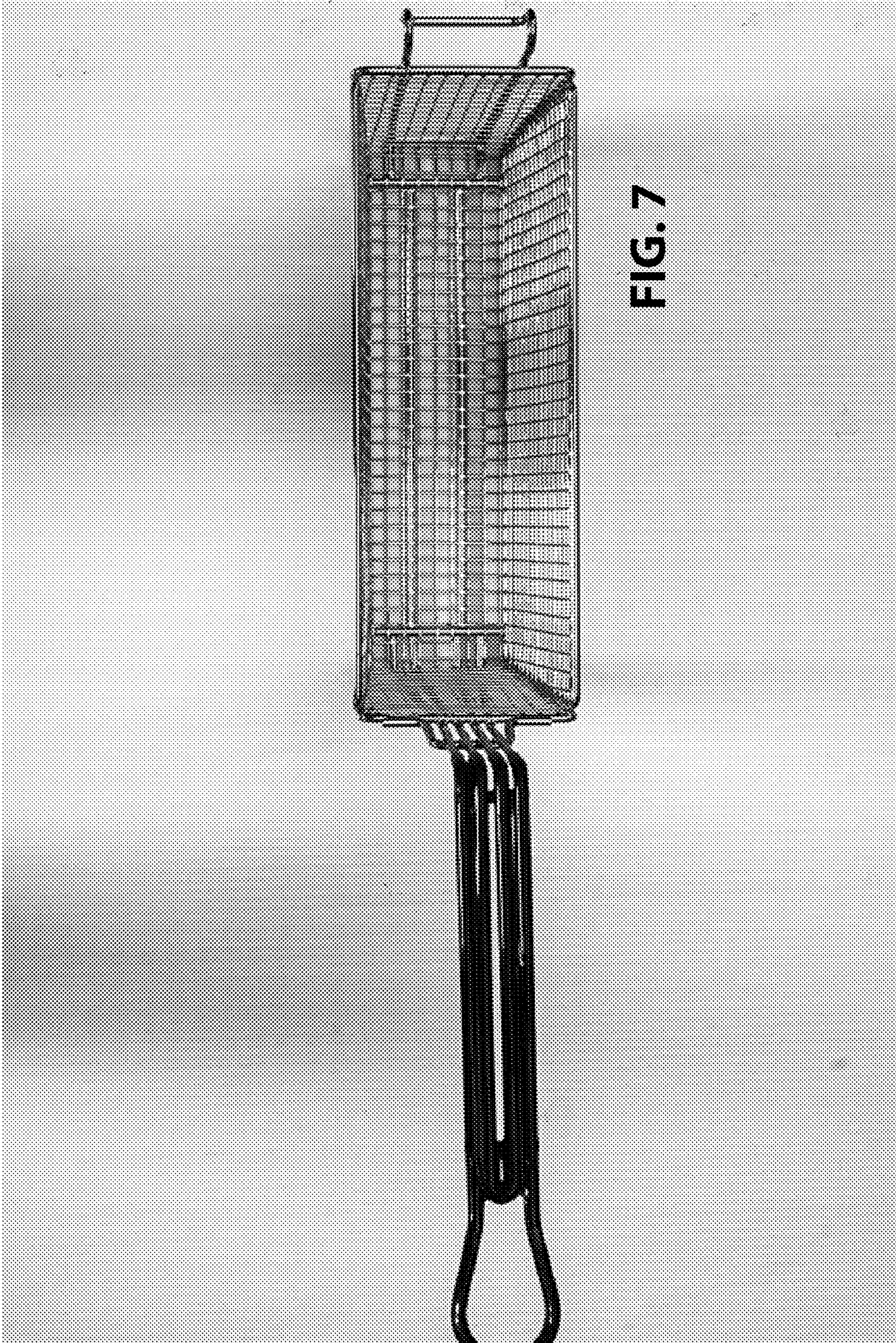

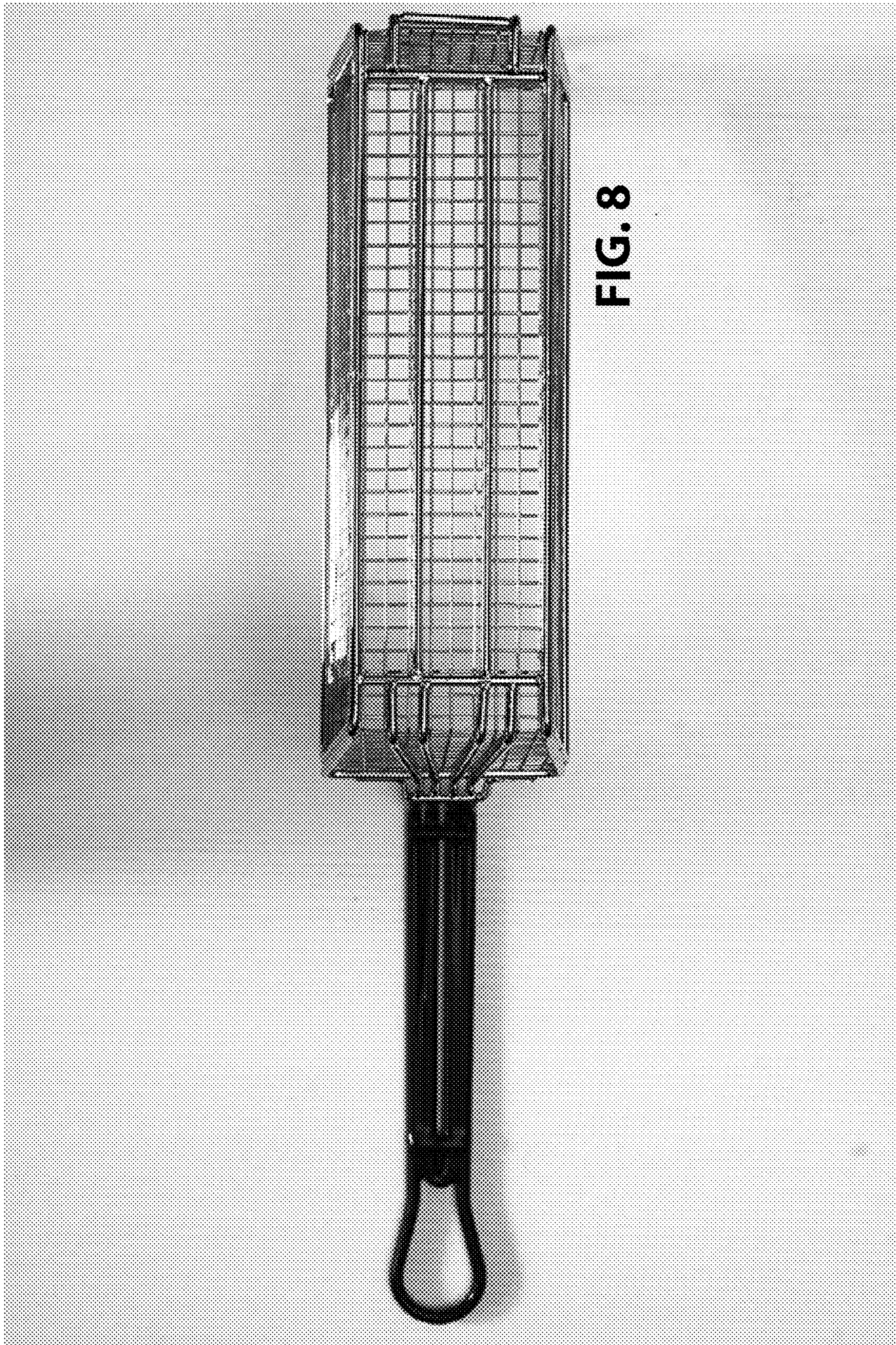

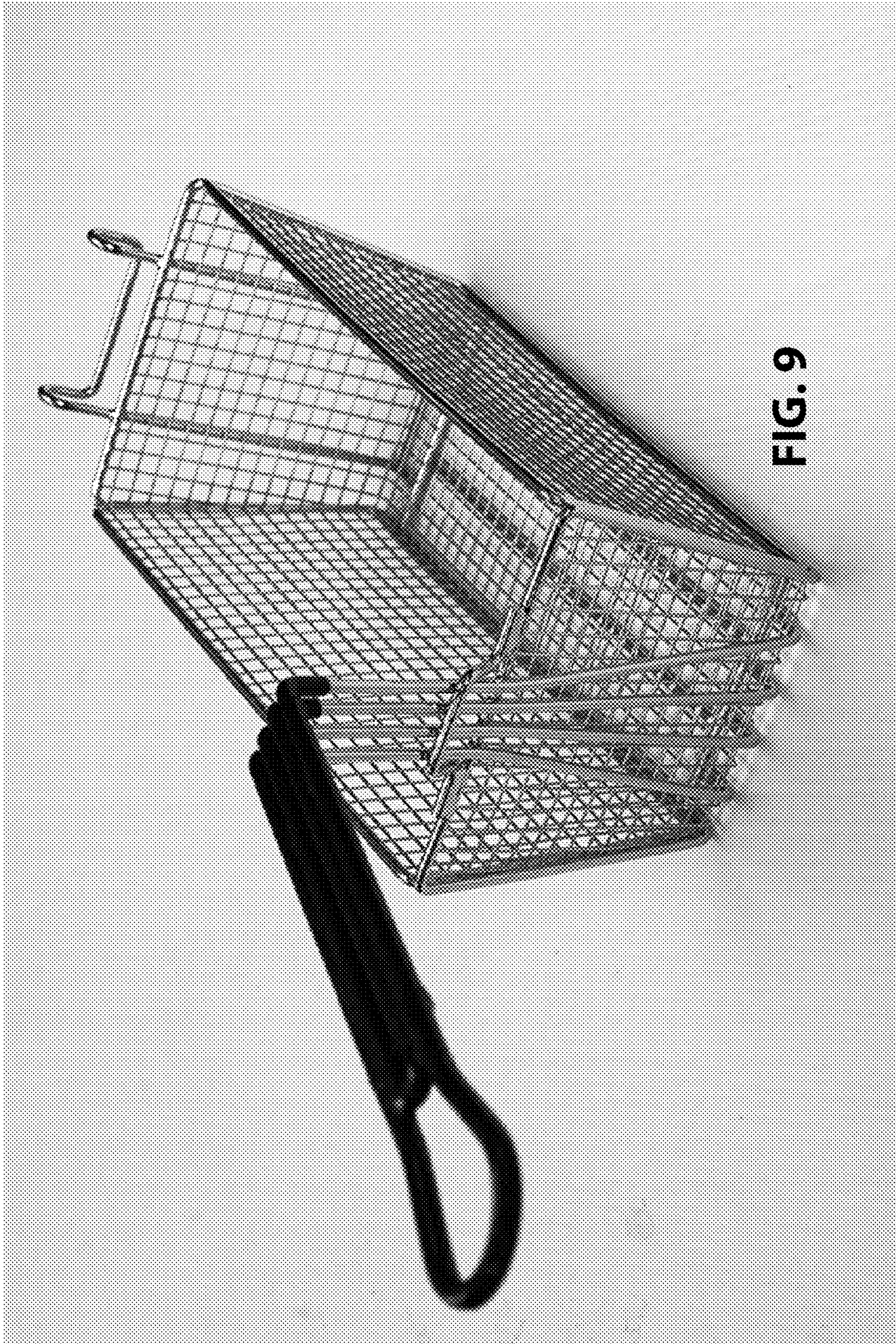
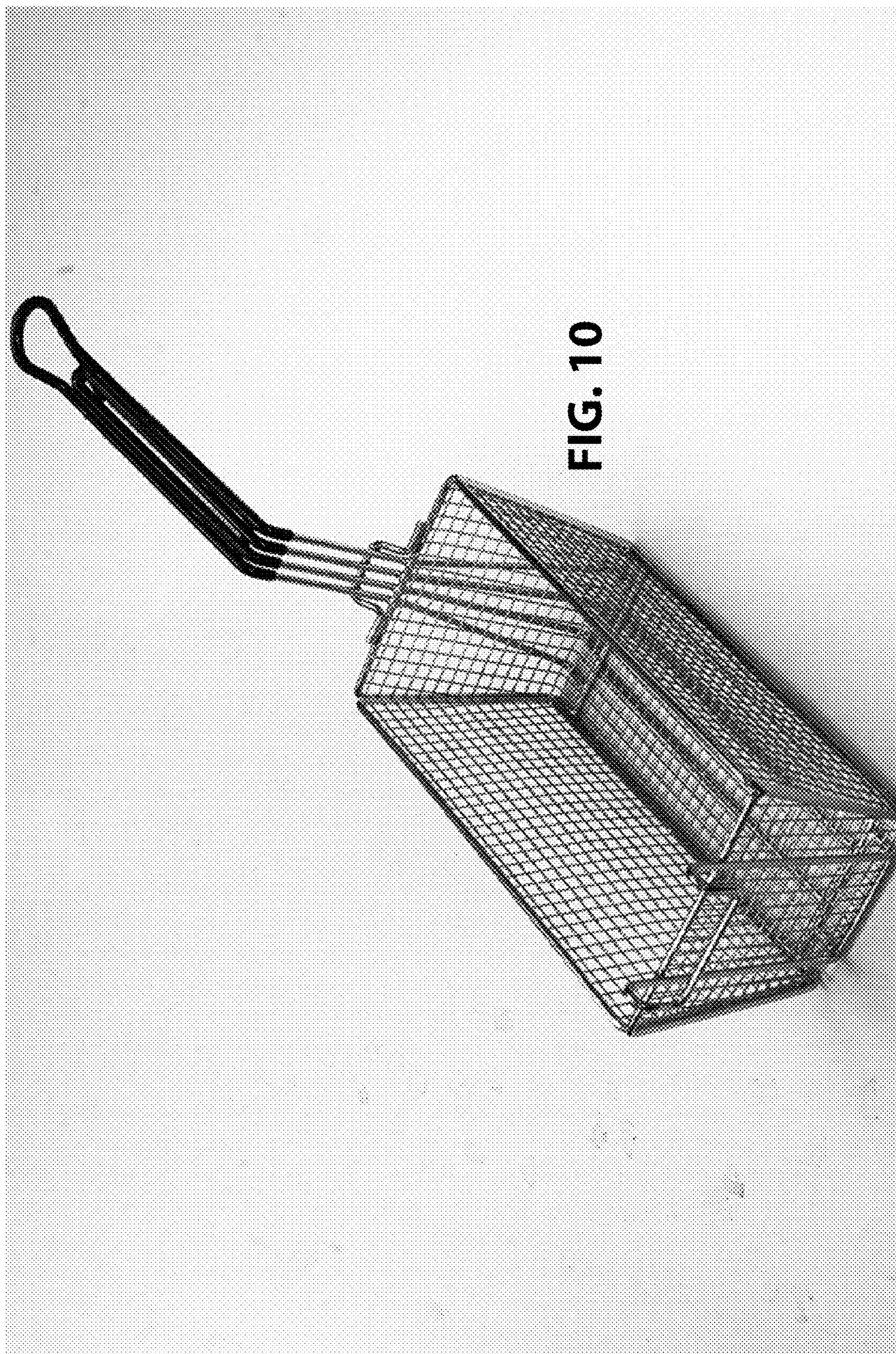

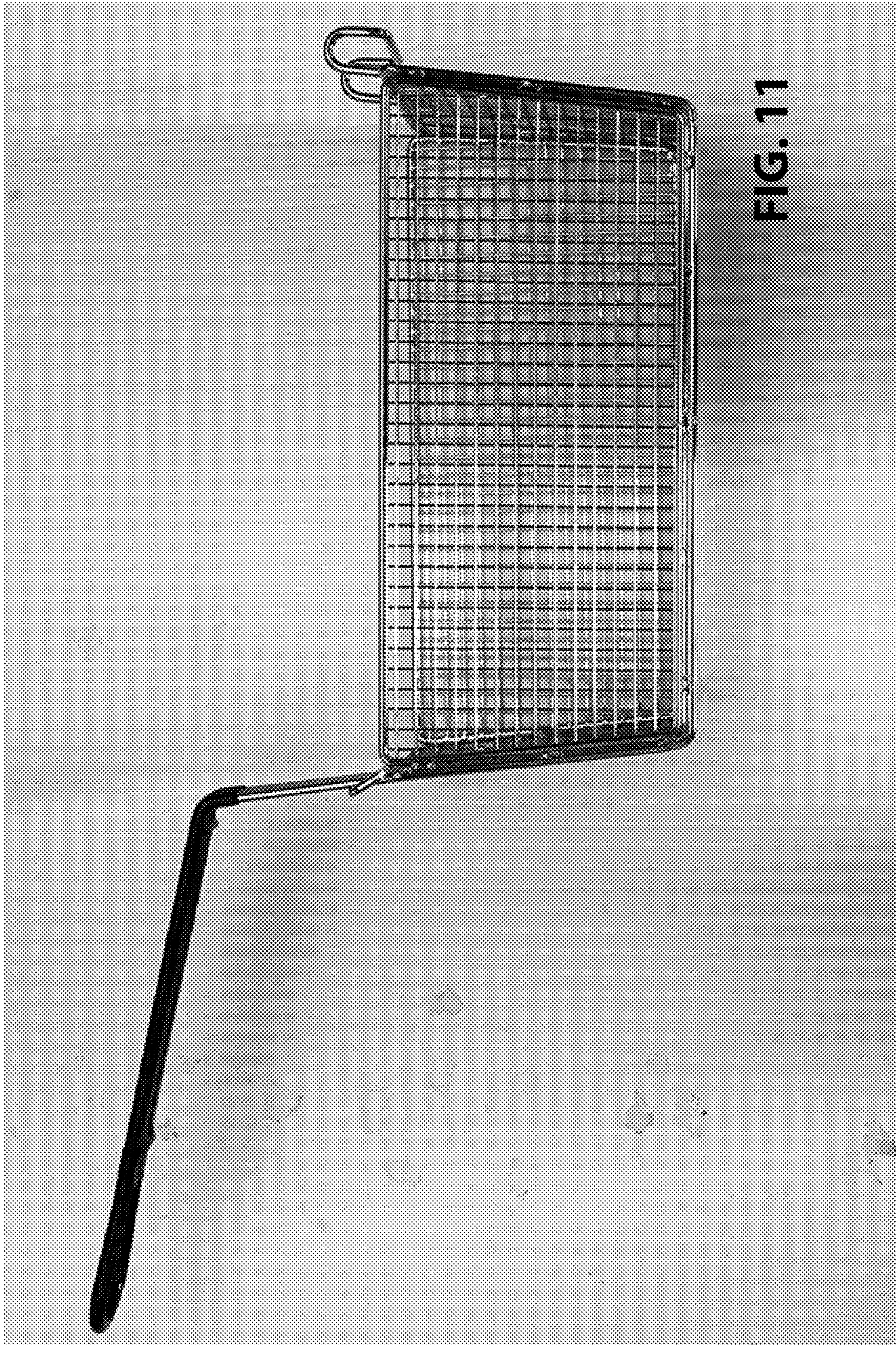

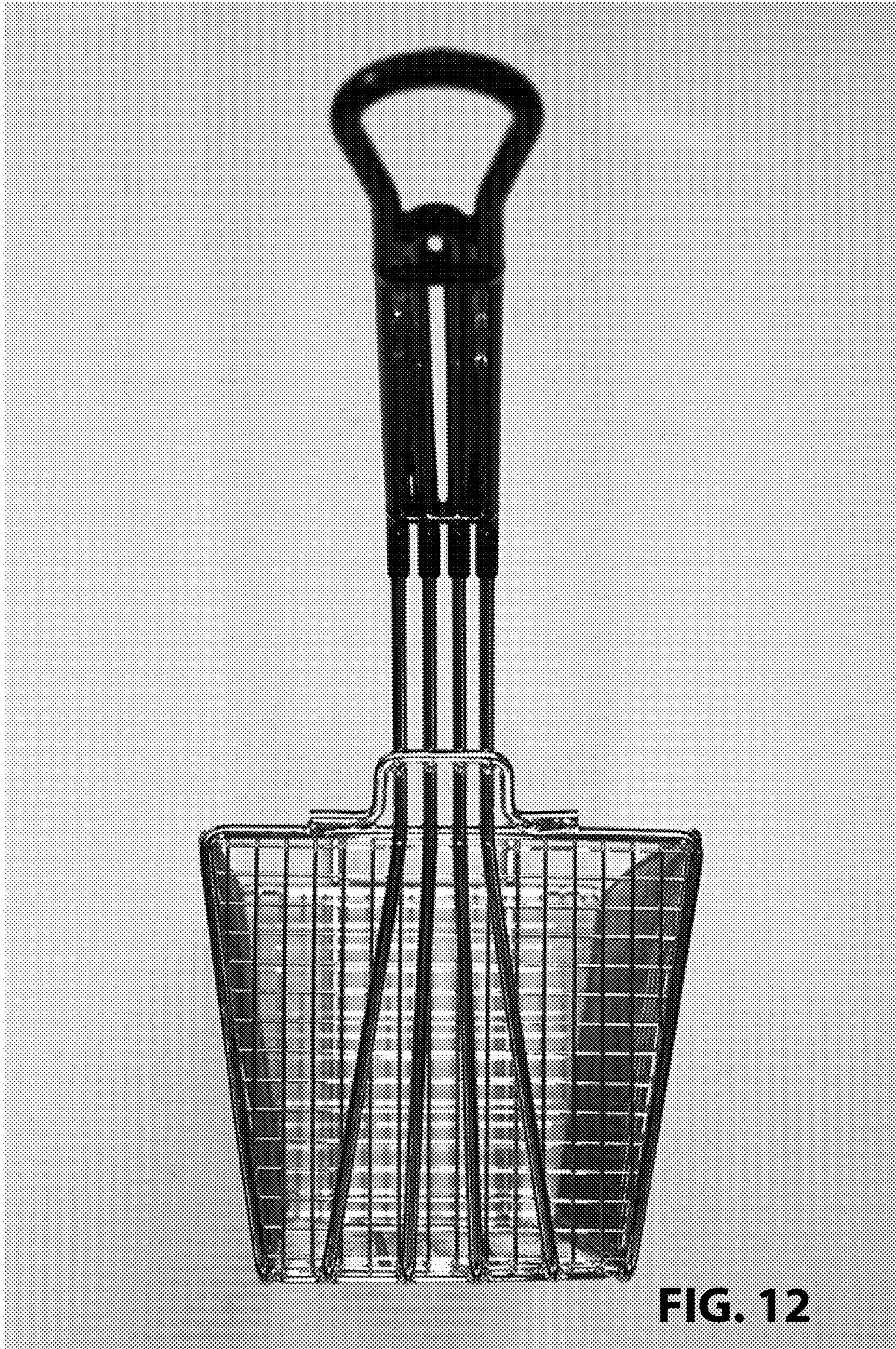
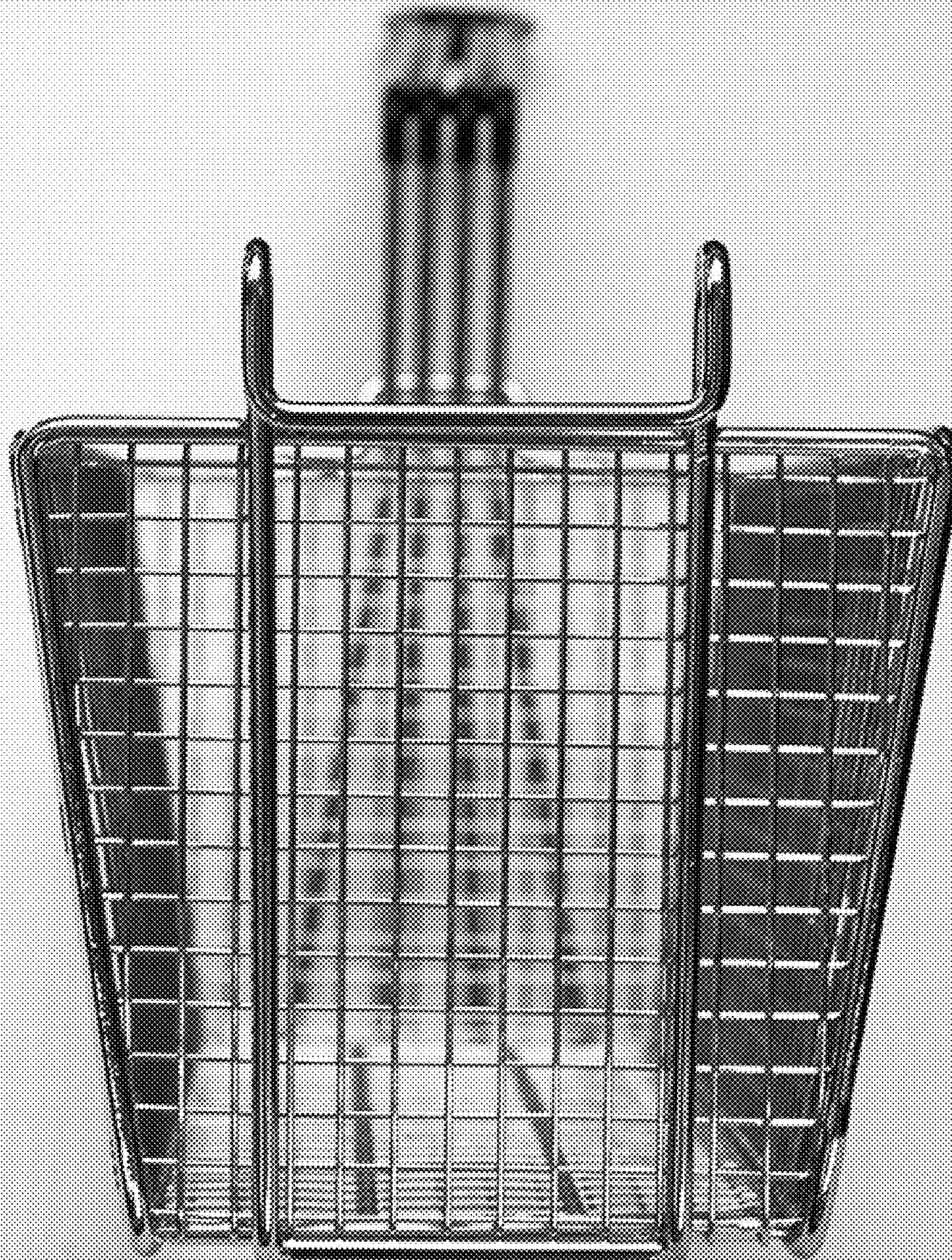

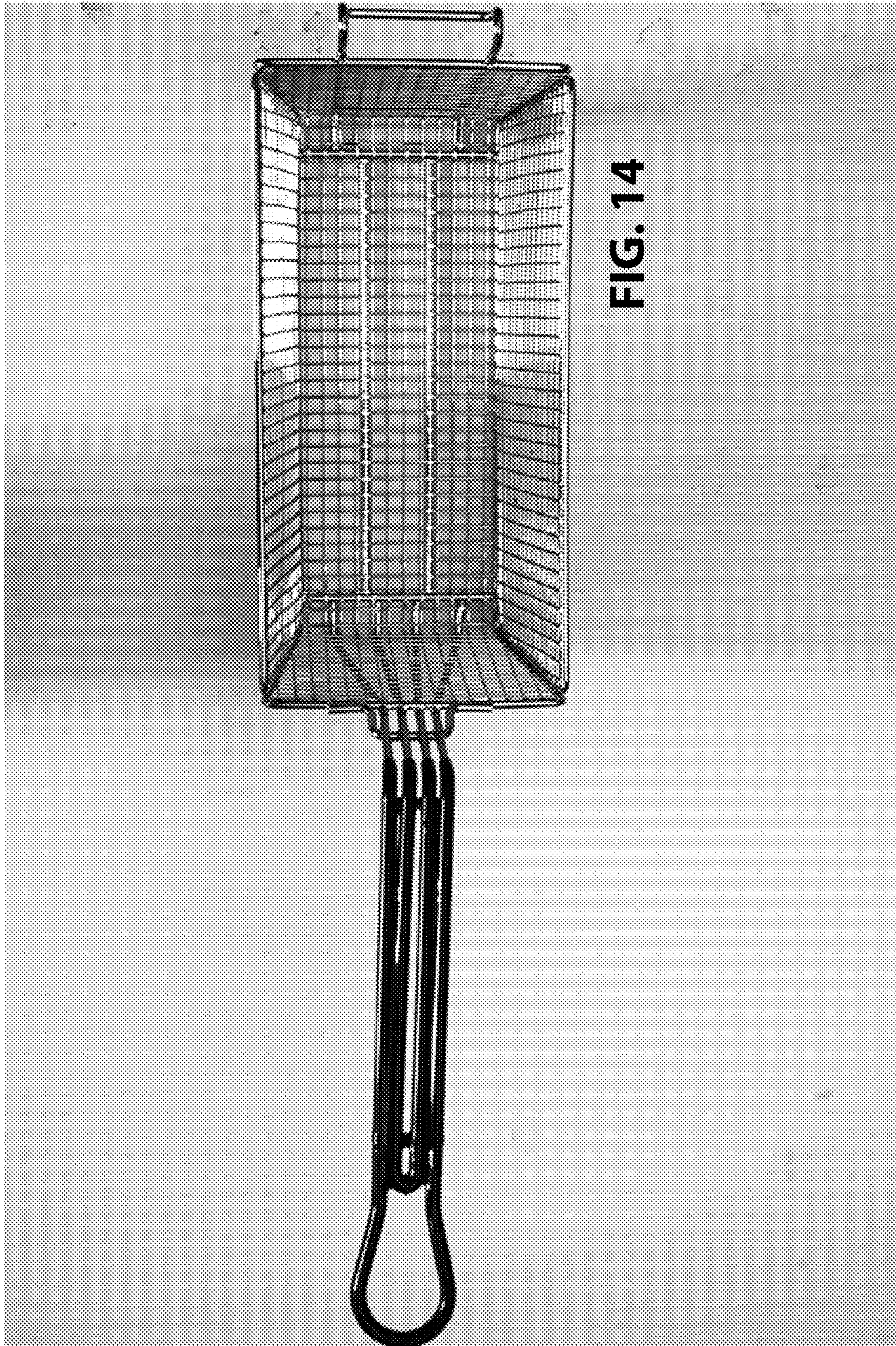

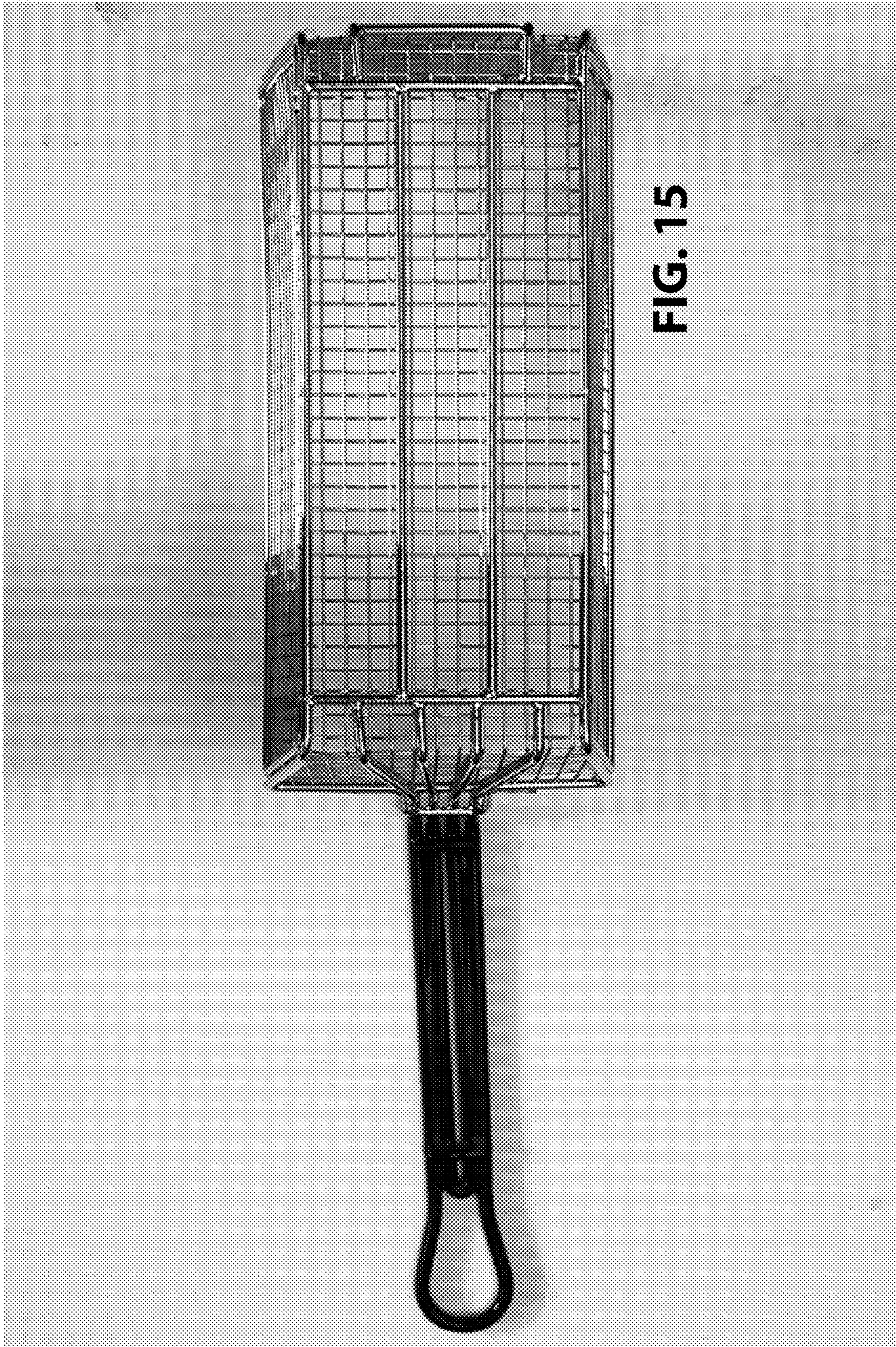

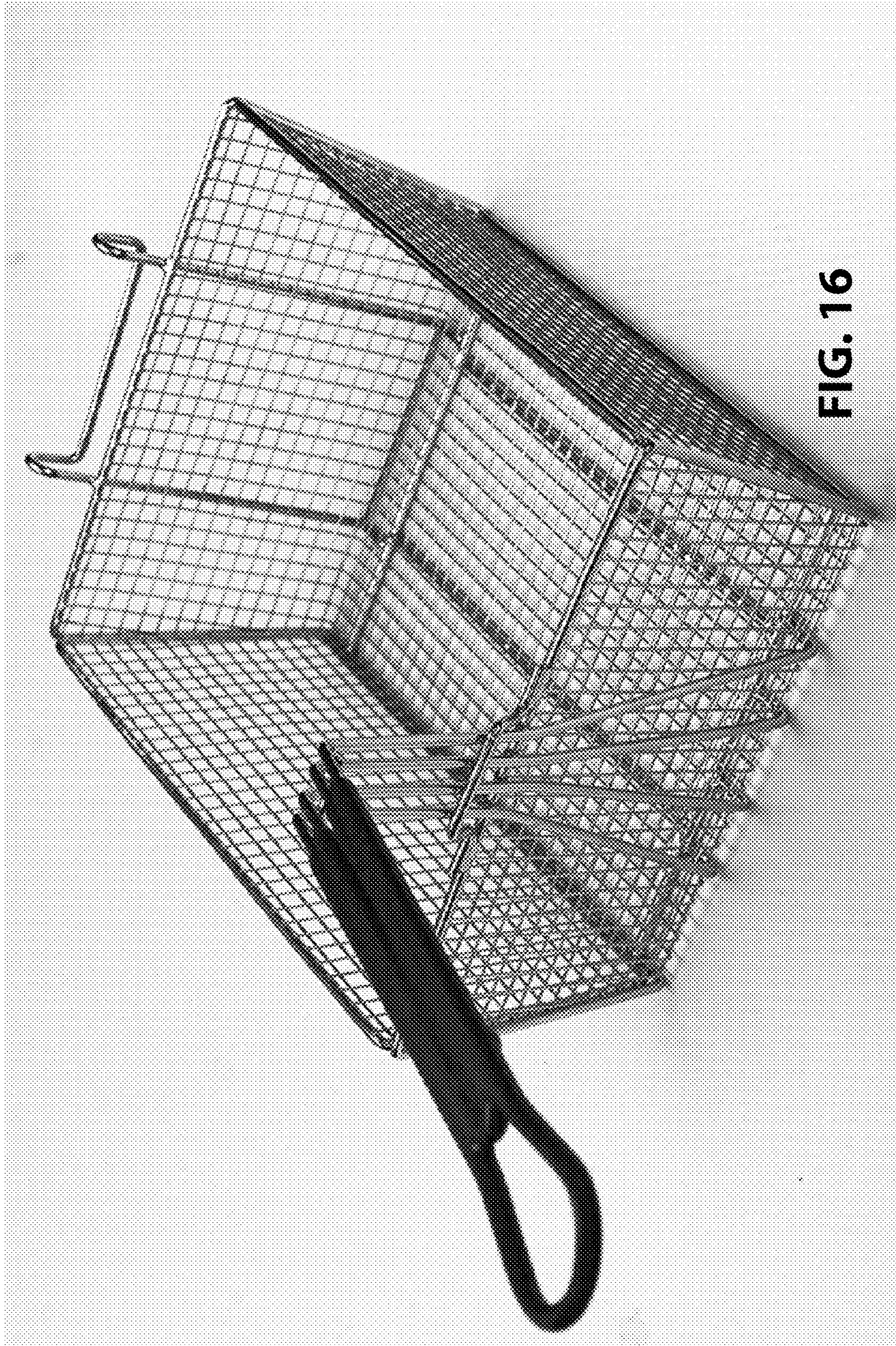
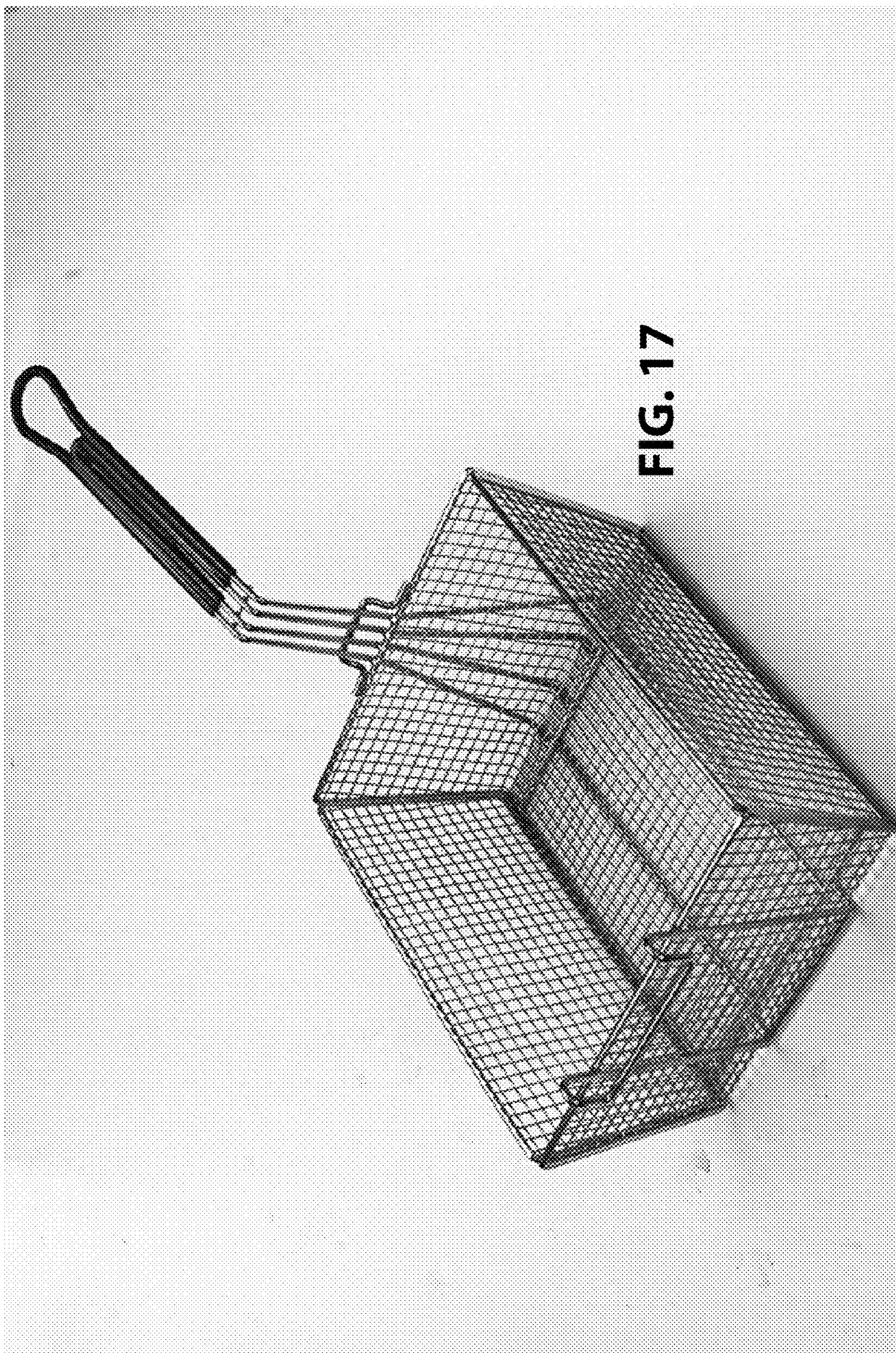

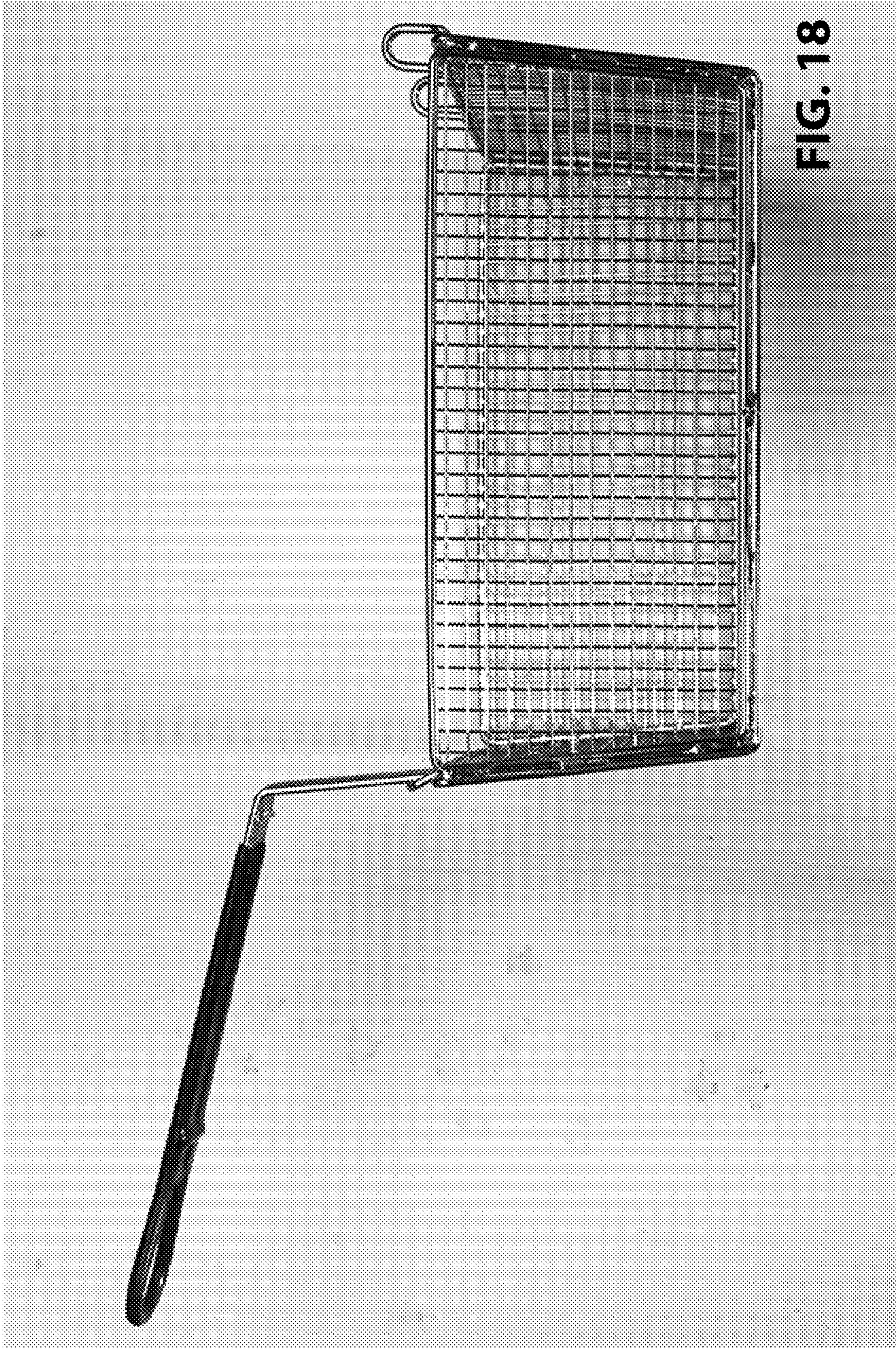

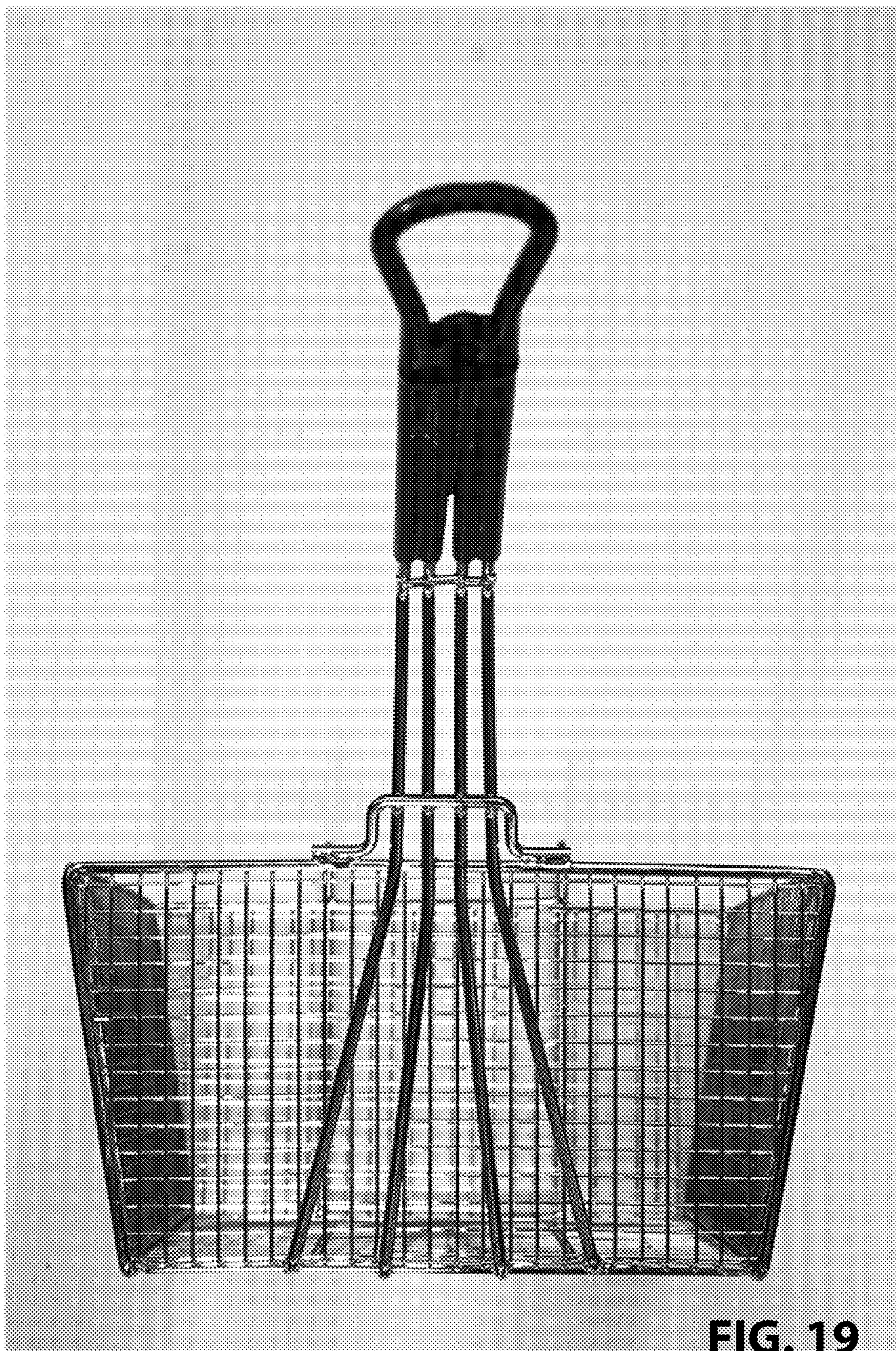

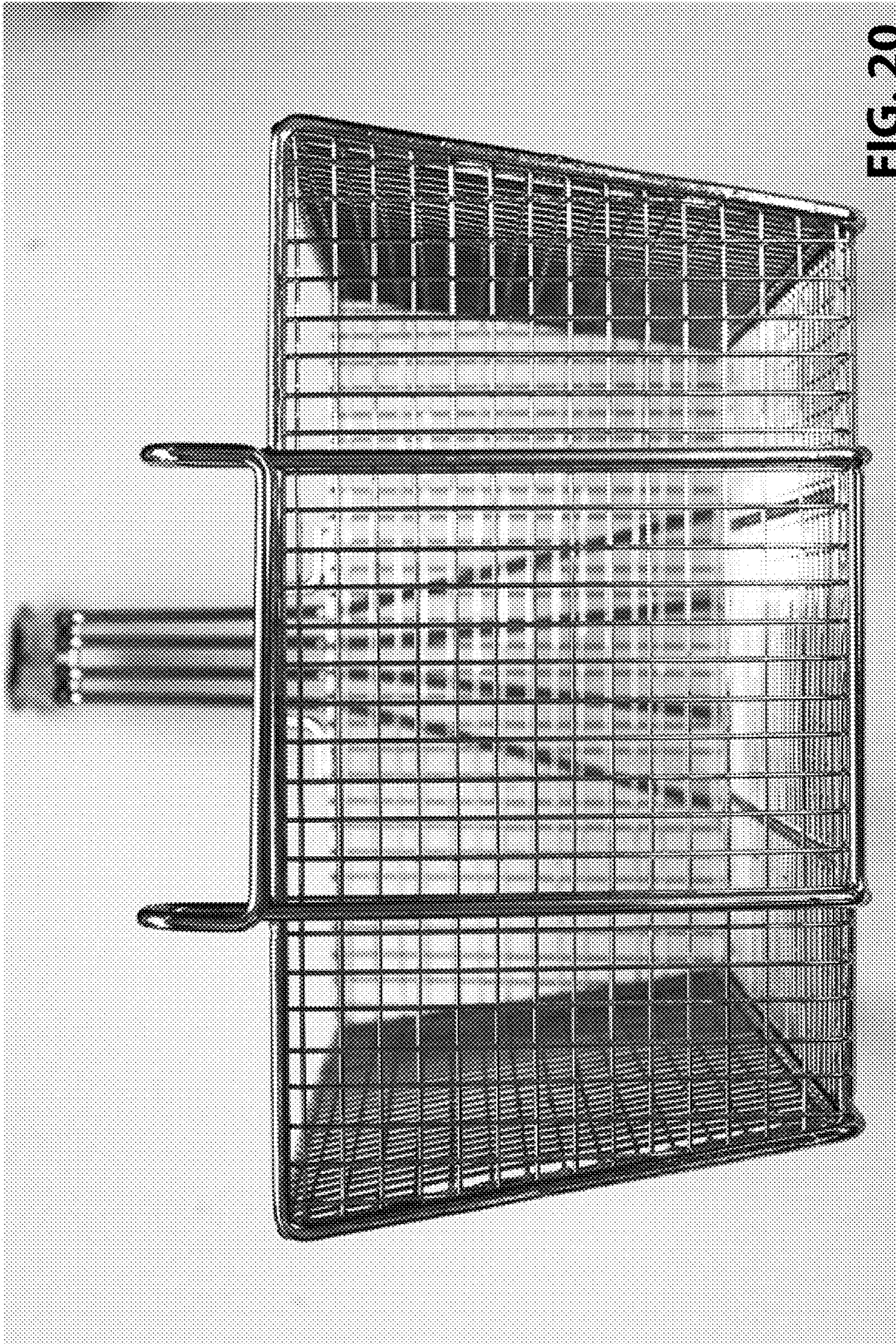

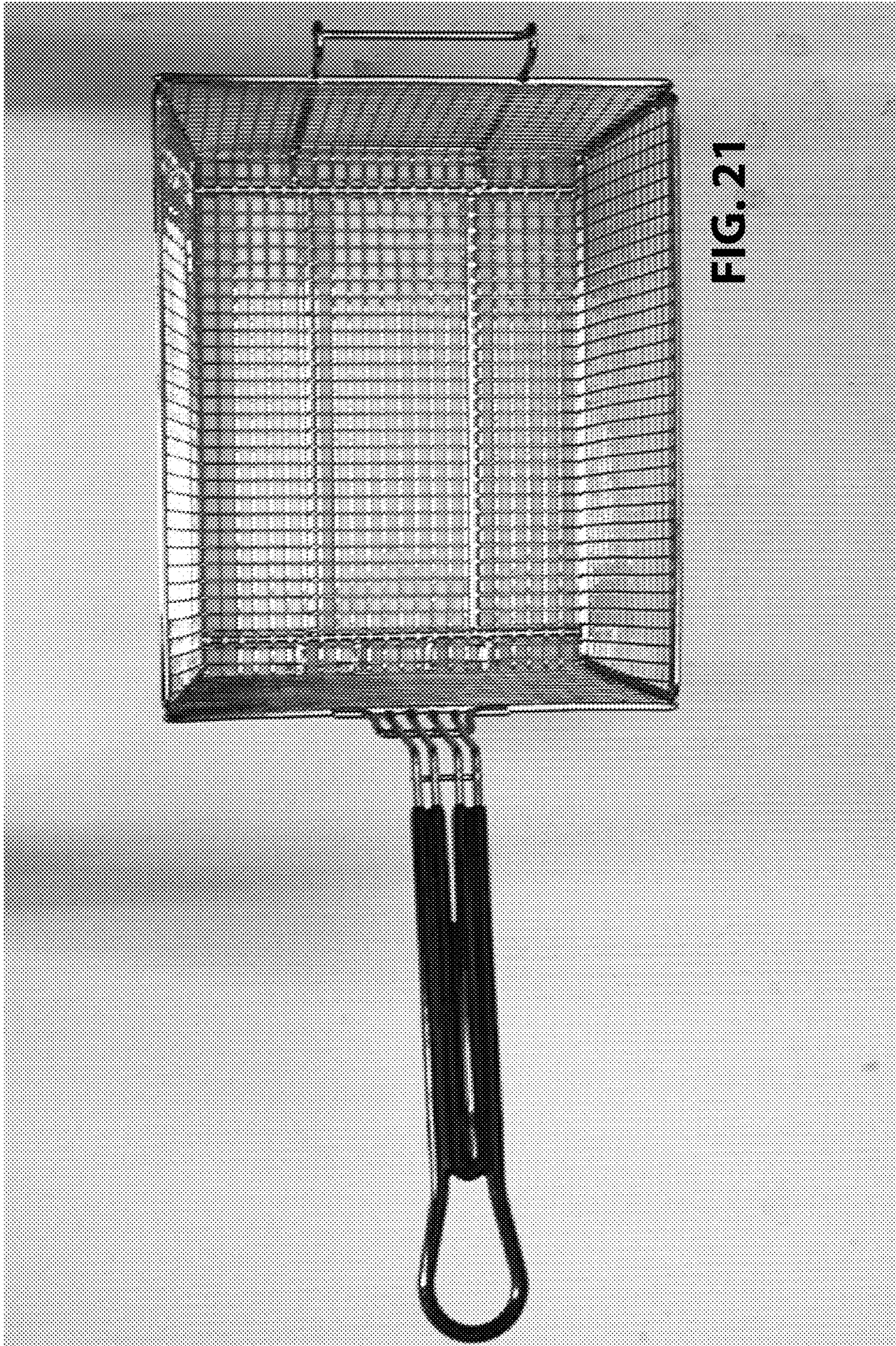
