DESCRIPTION

FIG. 1 shows a right, front perspective view of a cooler showing my new design.

FIG. 2 shows a top view of the cooler of FIG. 1.

FIG. 3 shows a front view of the cooler of FIG. 1.

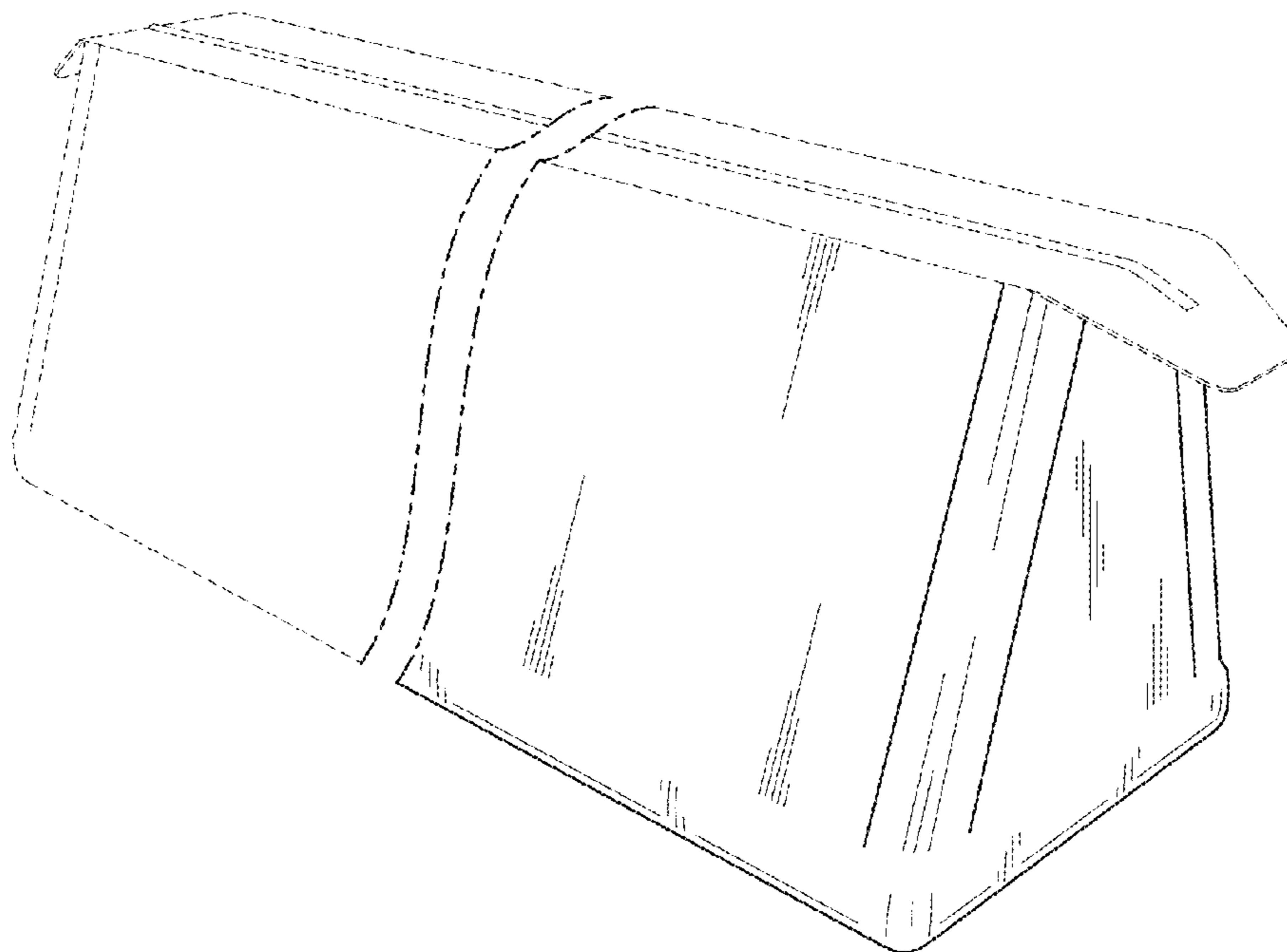
FIG. 4 shows a back view of the cooler of FIG. 1.

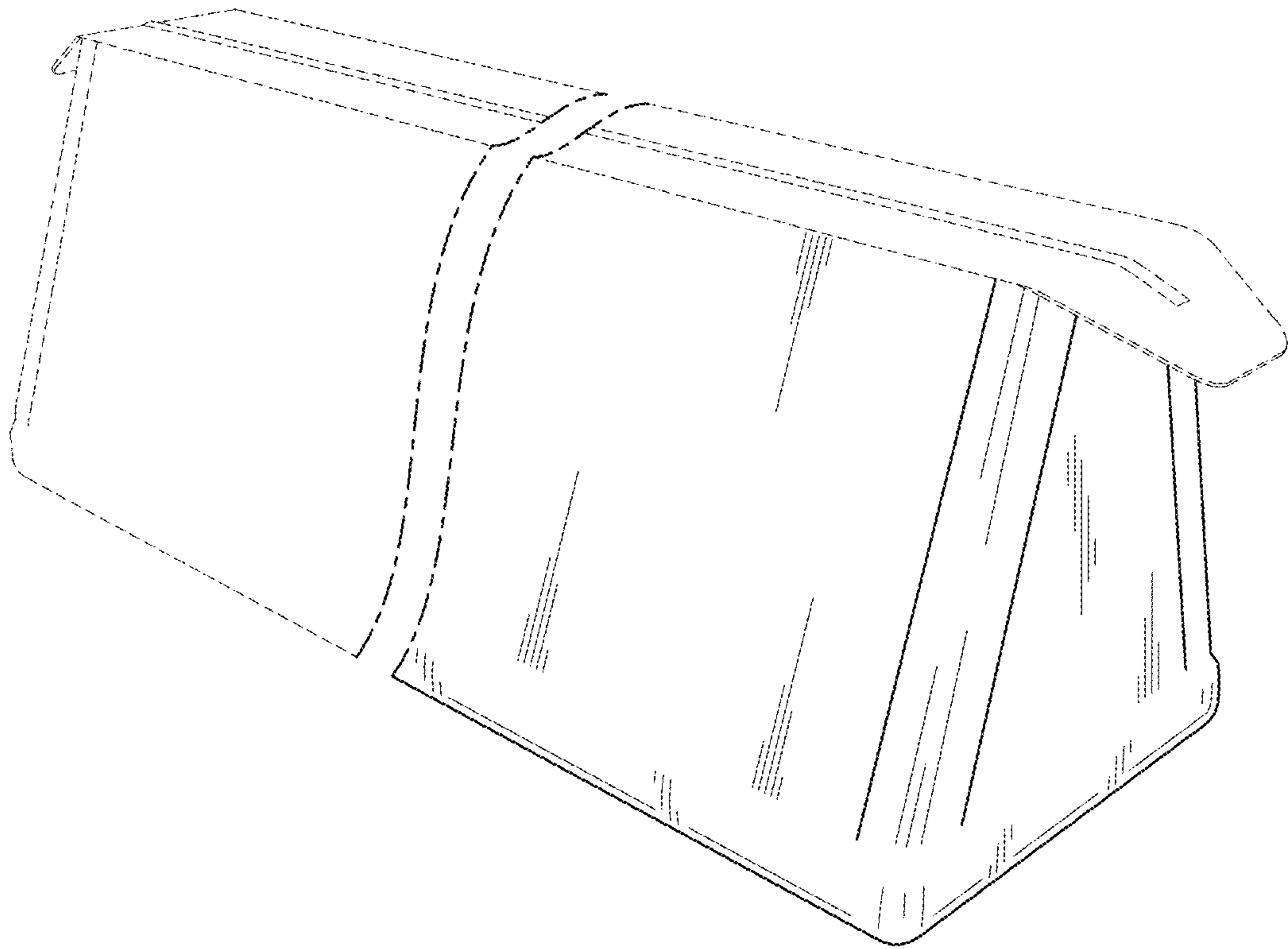

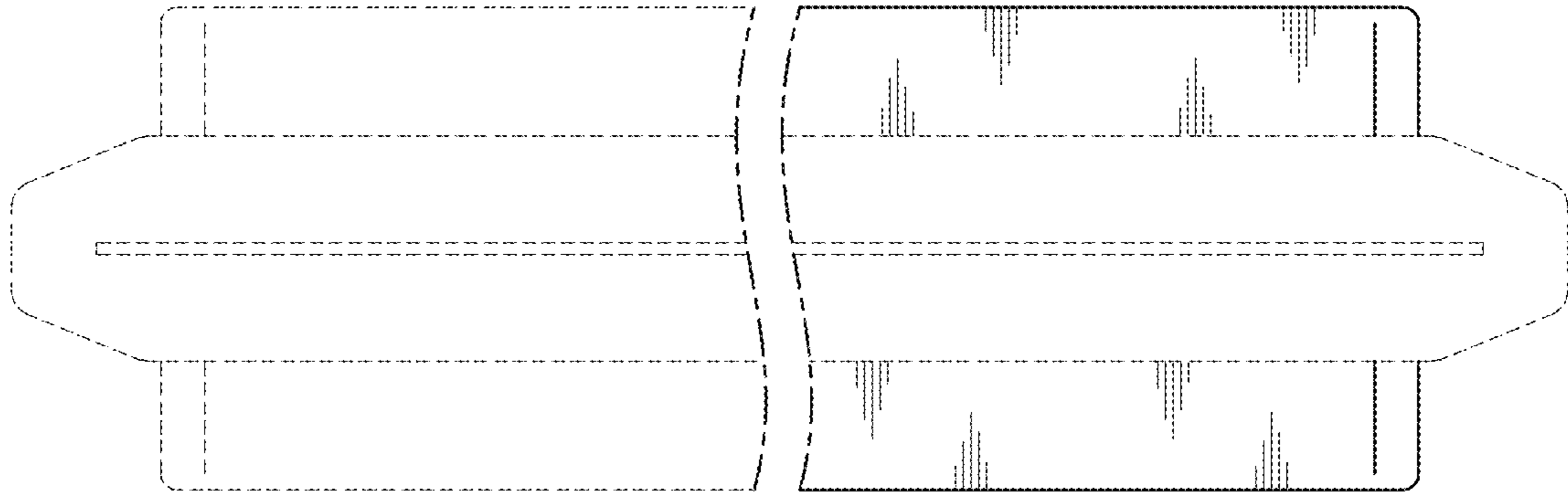

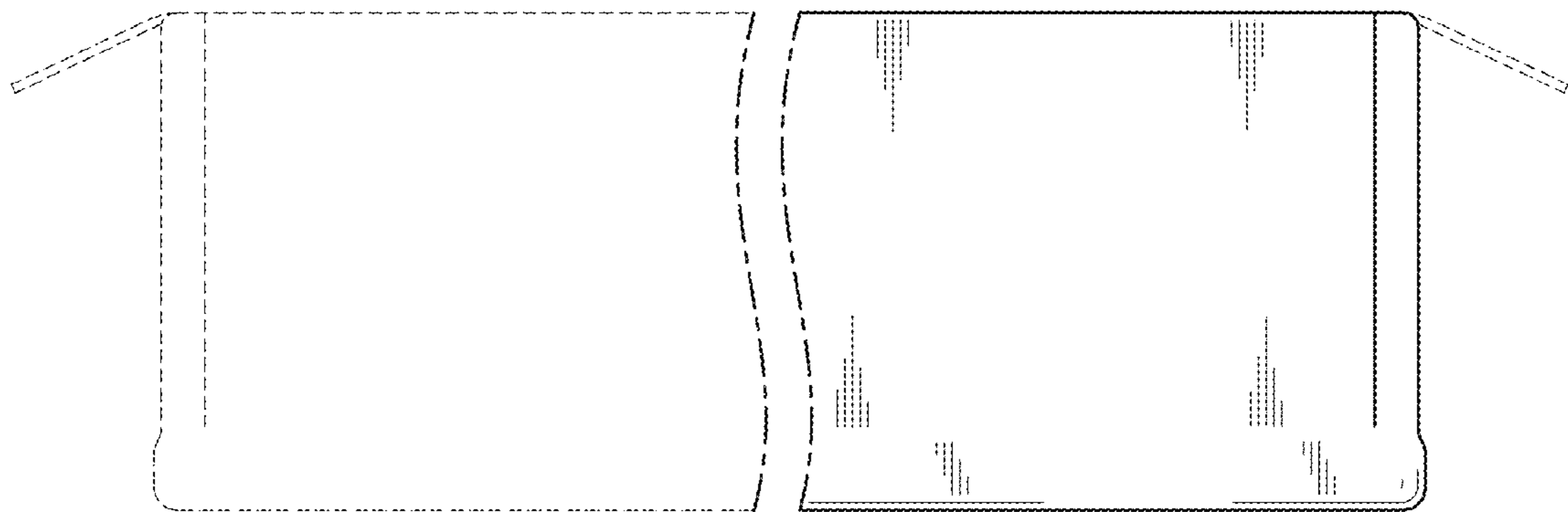

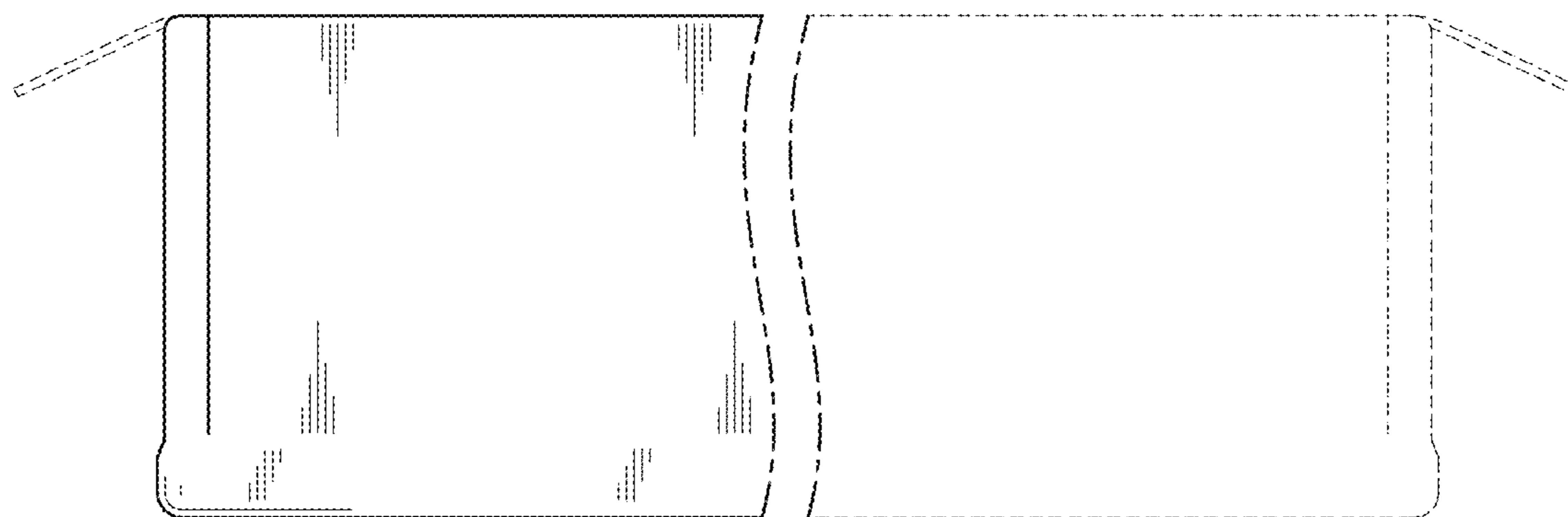

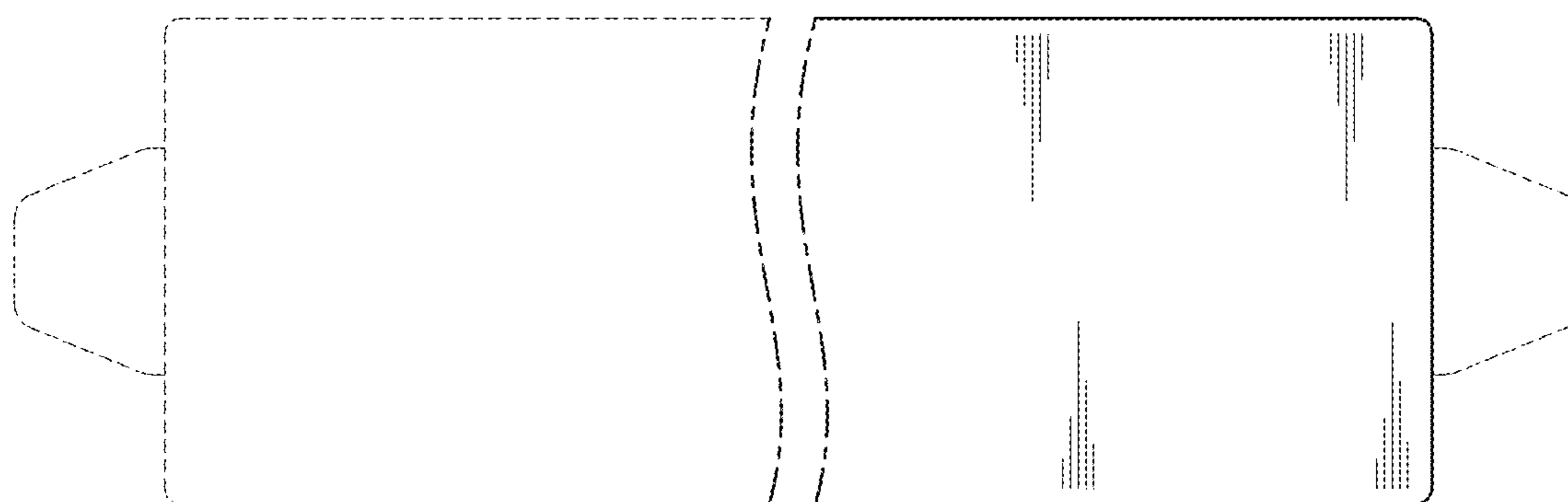

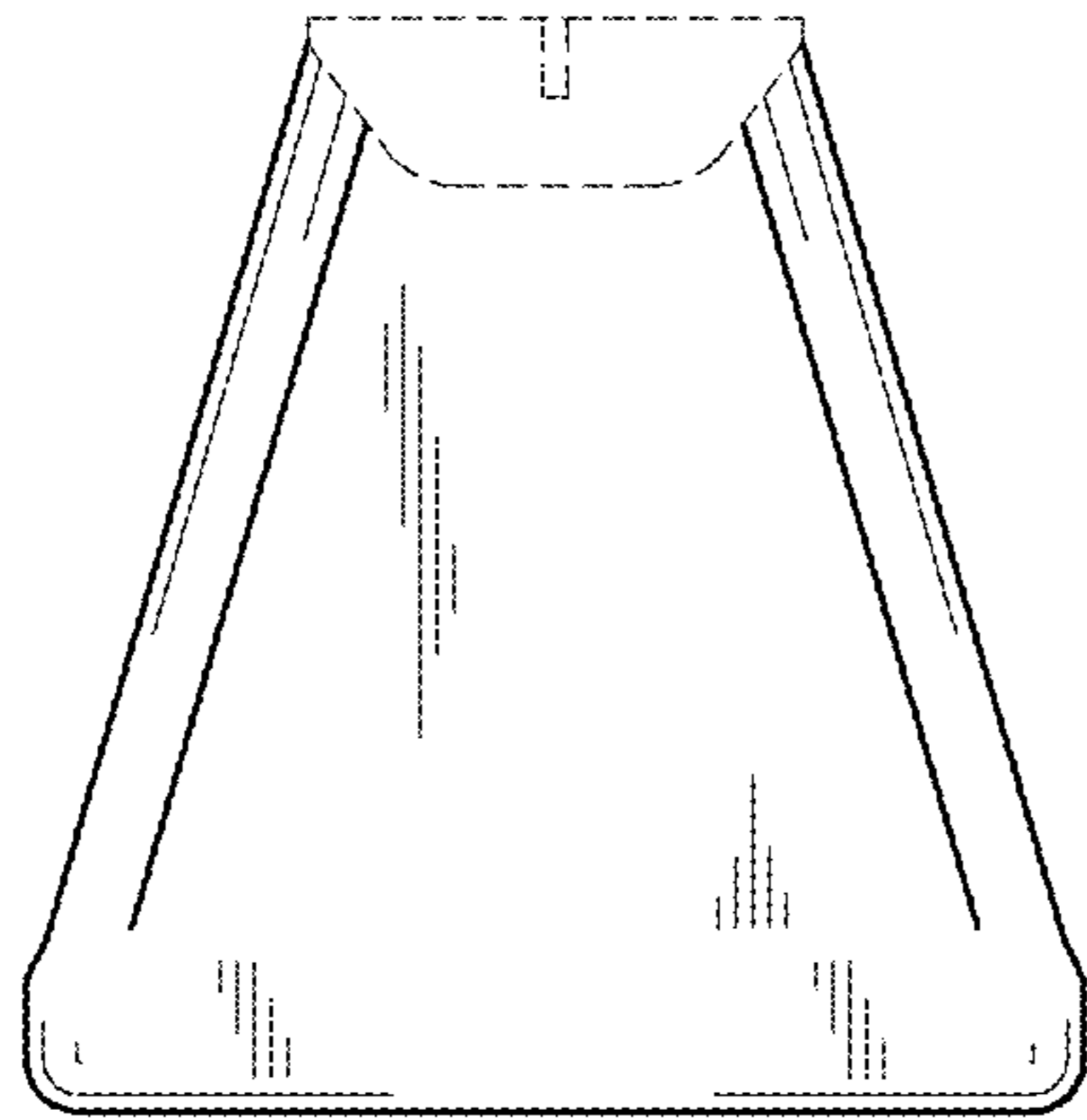

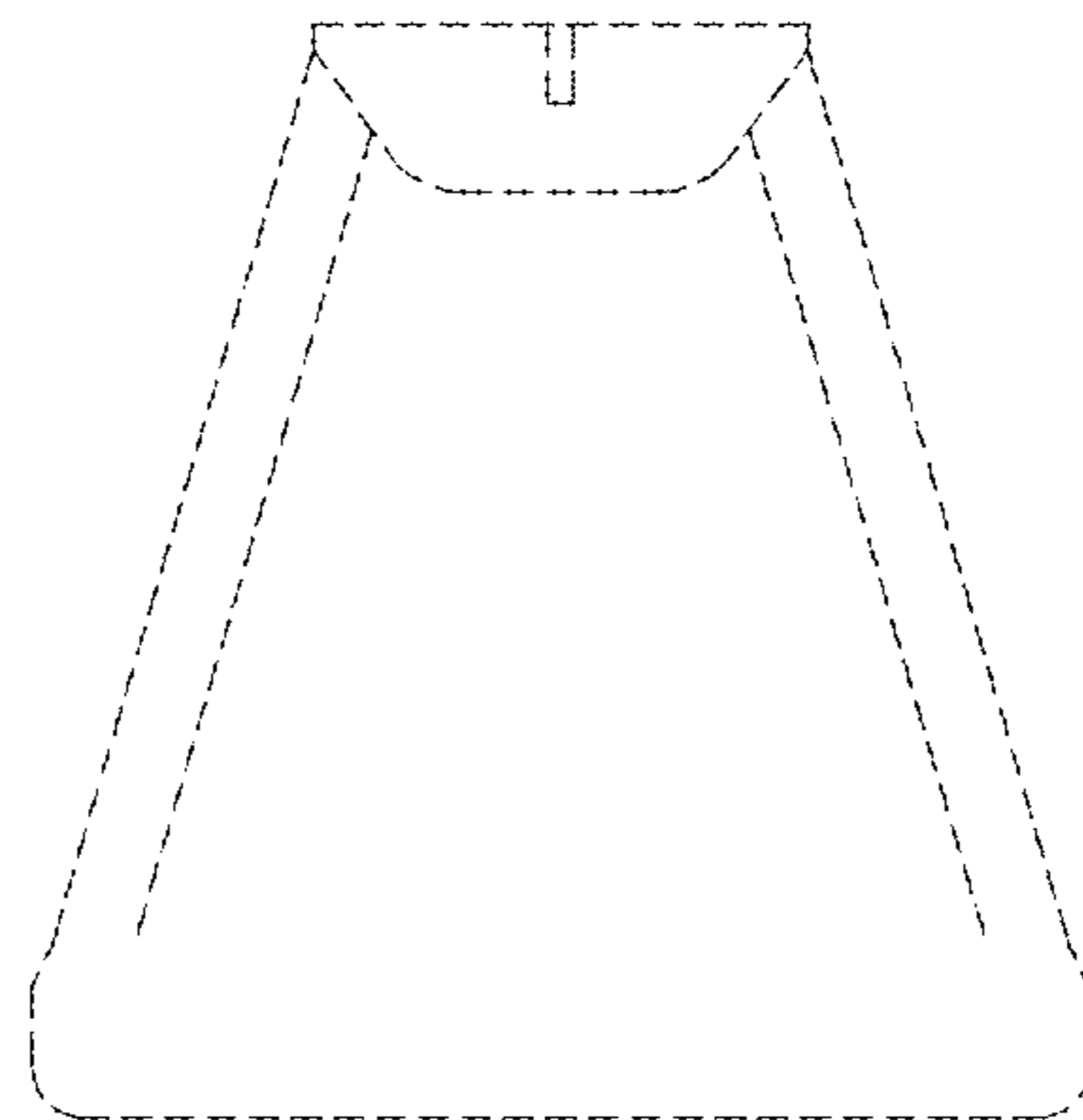
