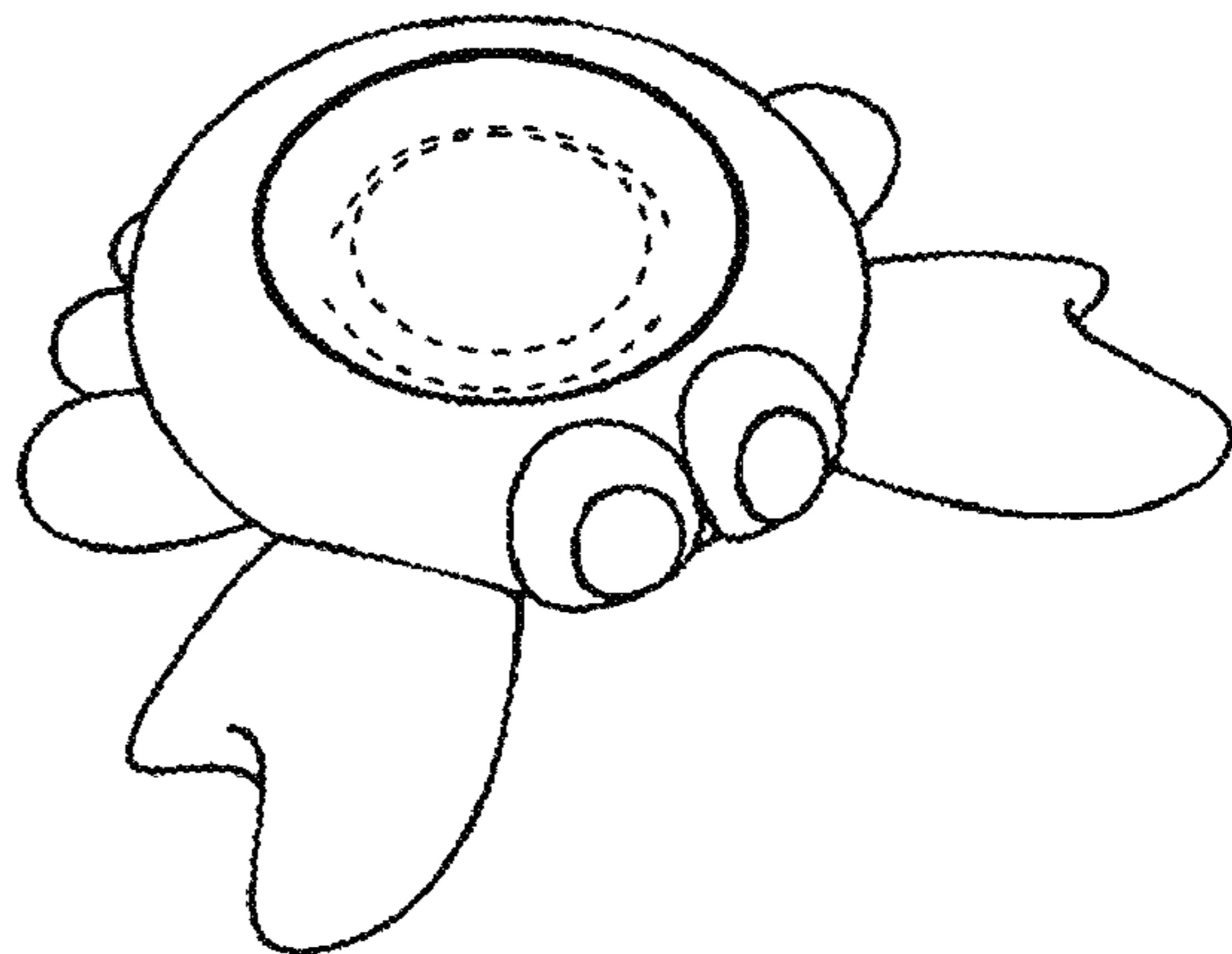
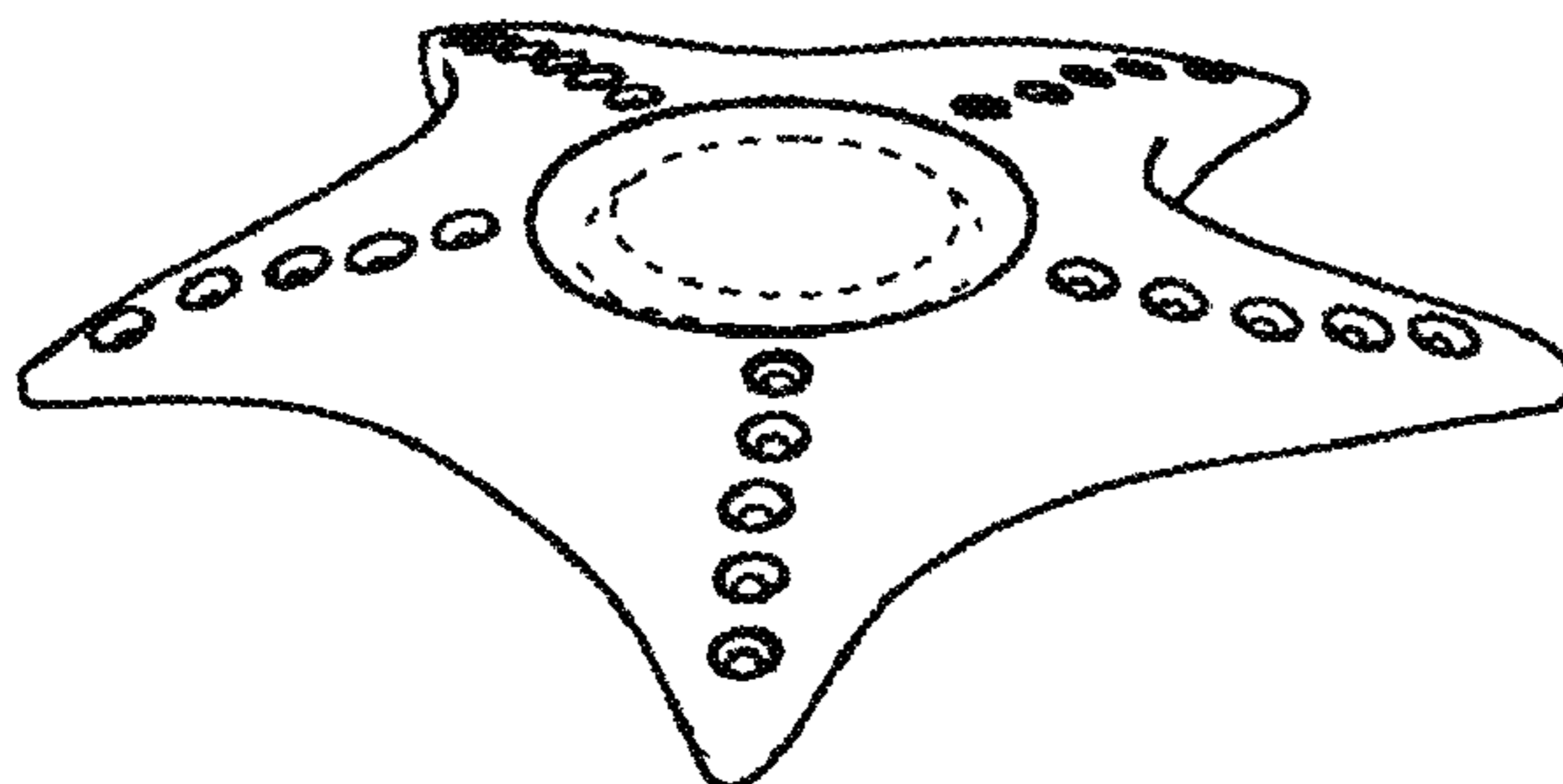
The ornamental design for a set of five combined beverage holder and beach towel weight, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the starfish component of the set of five combined beverage holder and beach towel weight in accordance with the design;

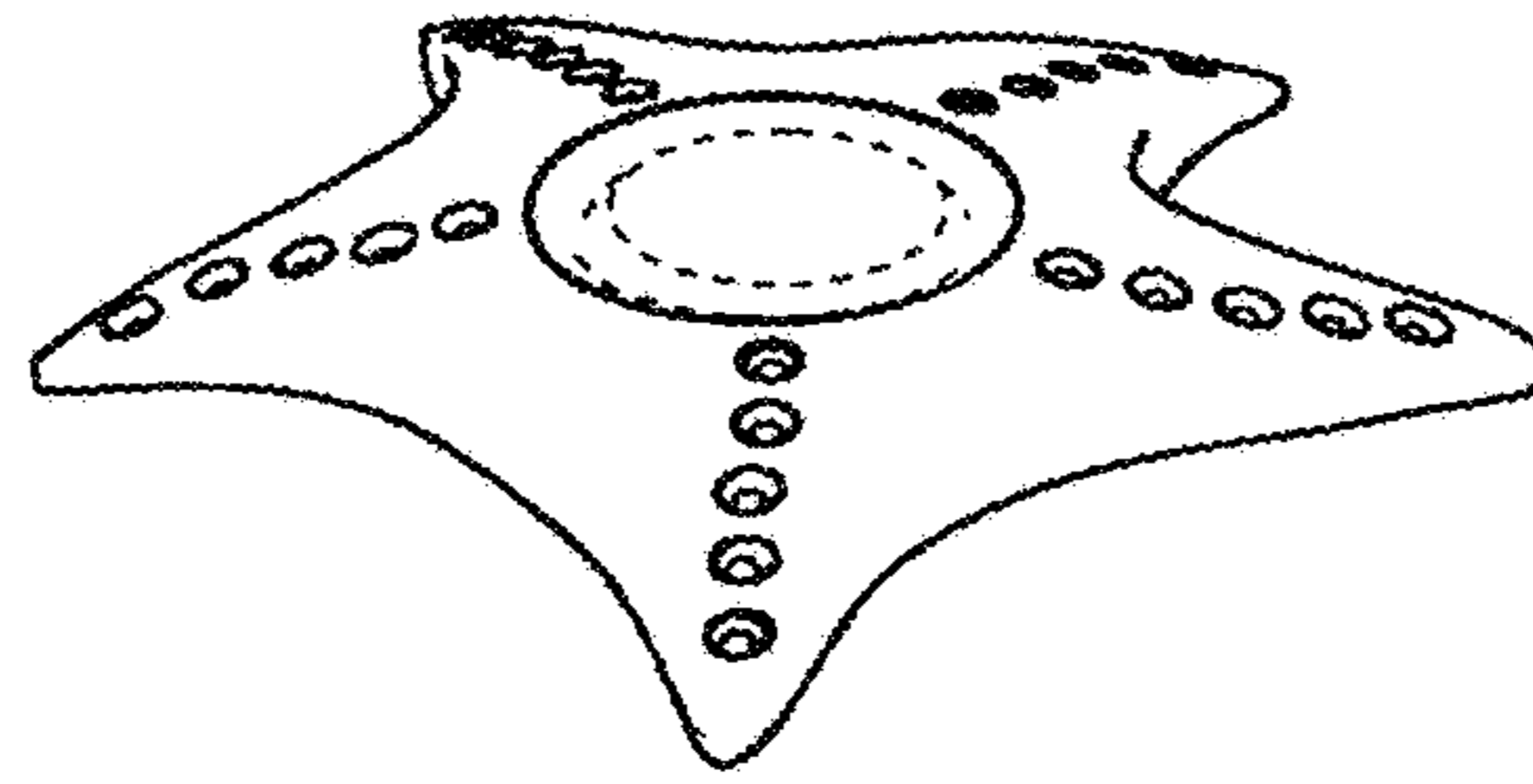

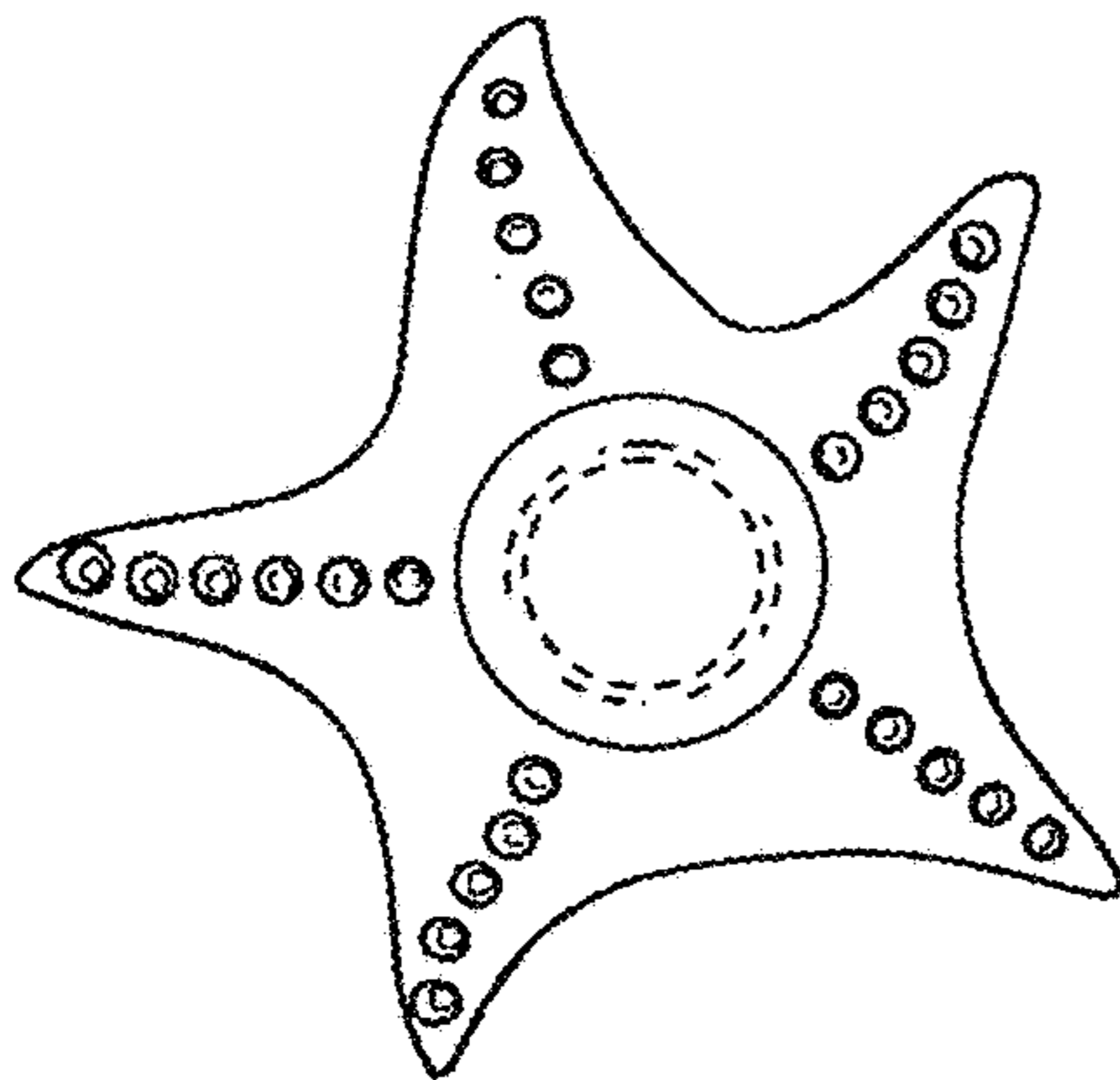

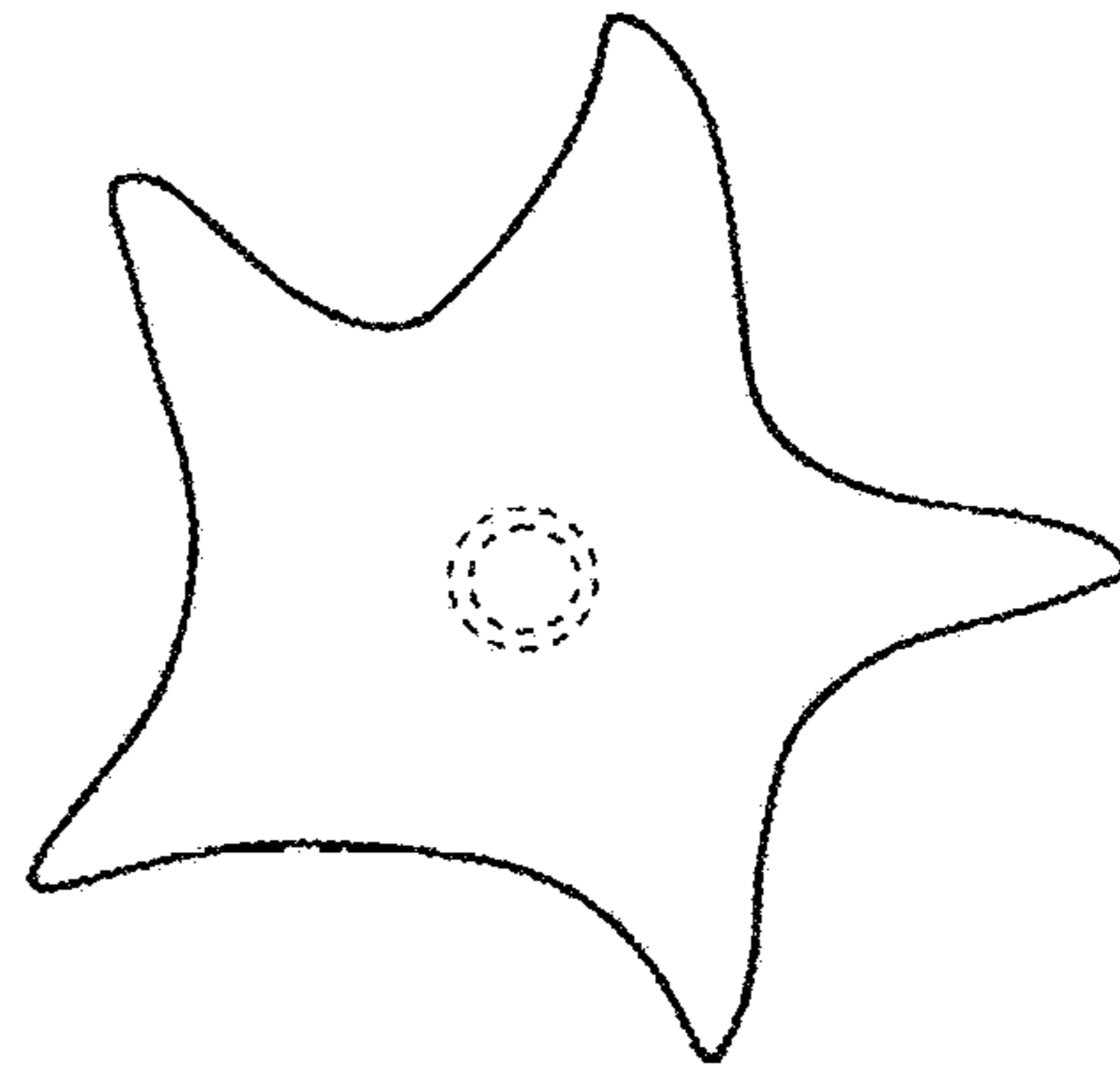

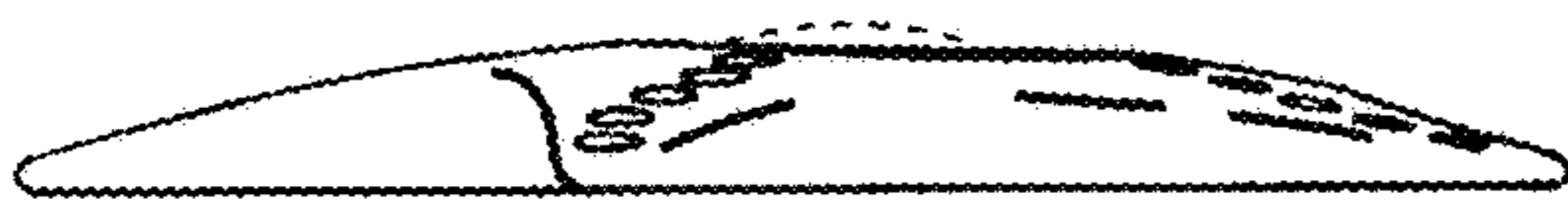

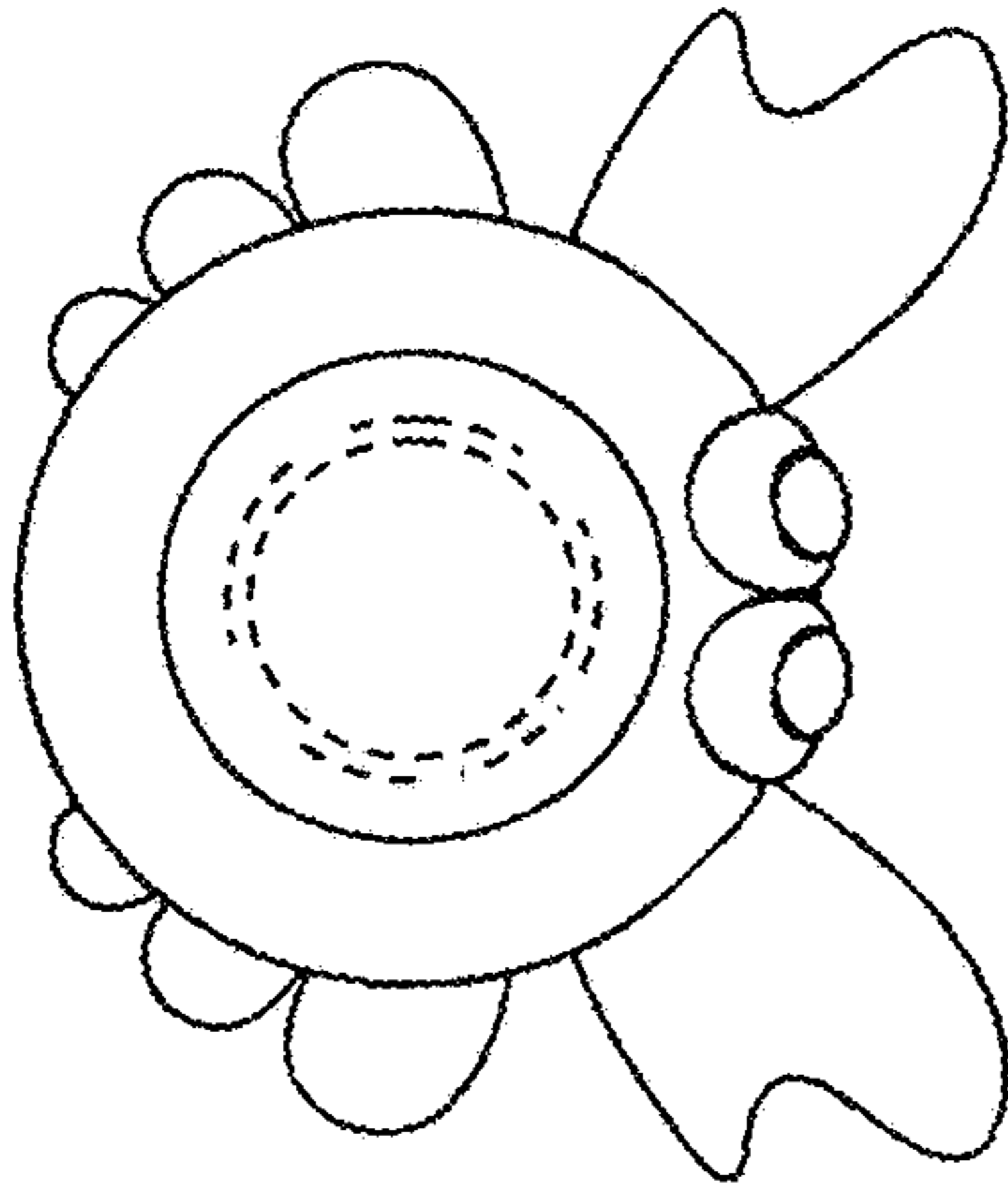

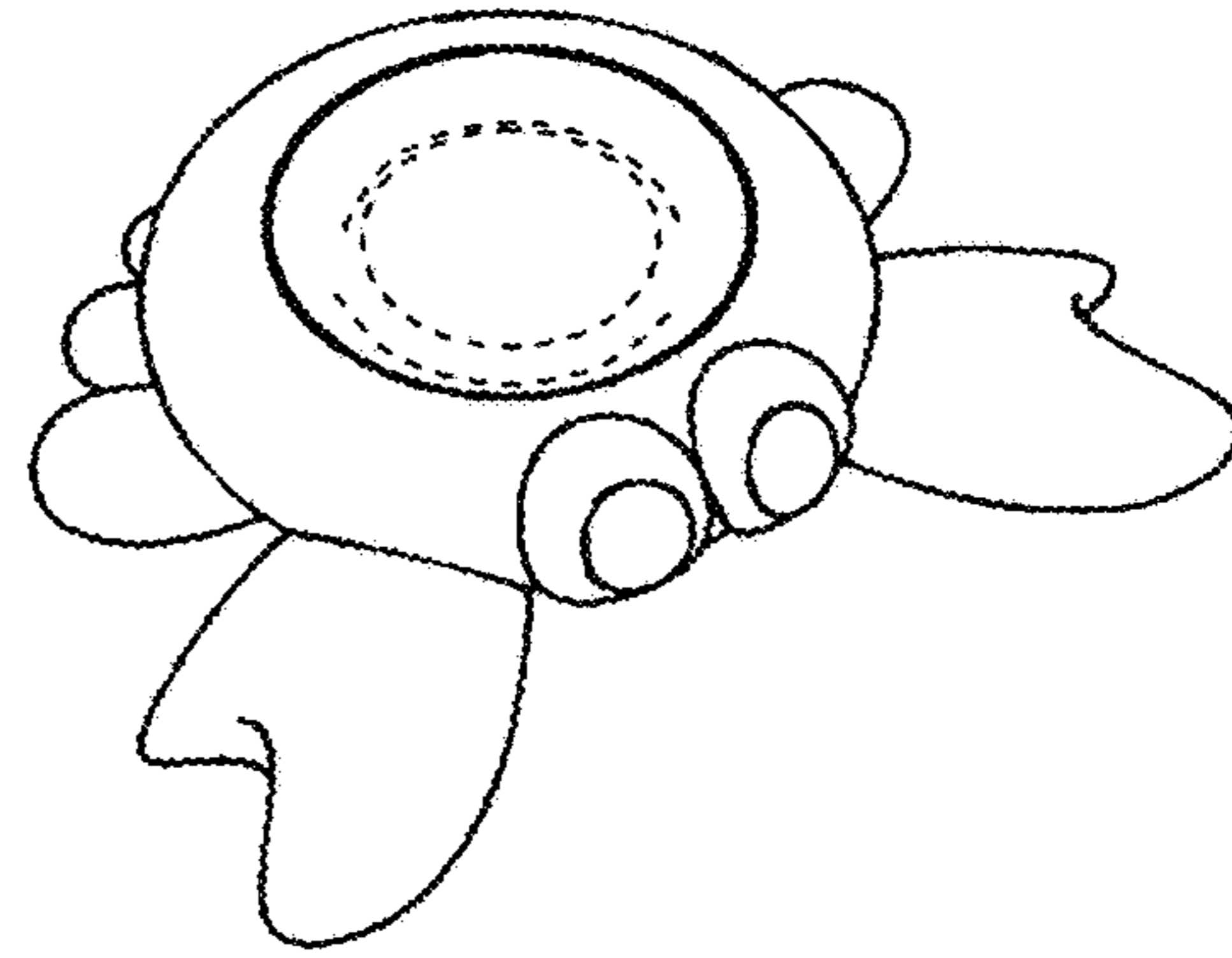

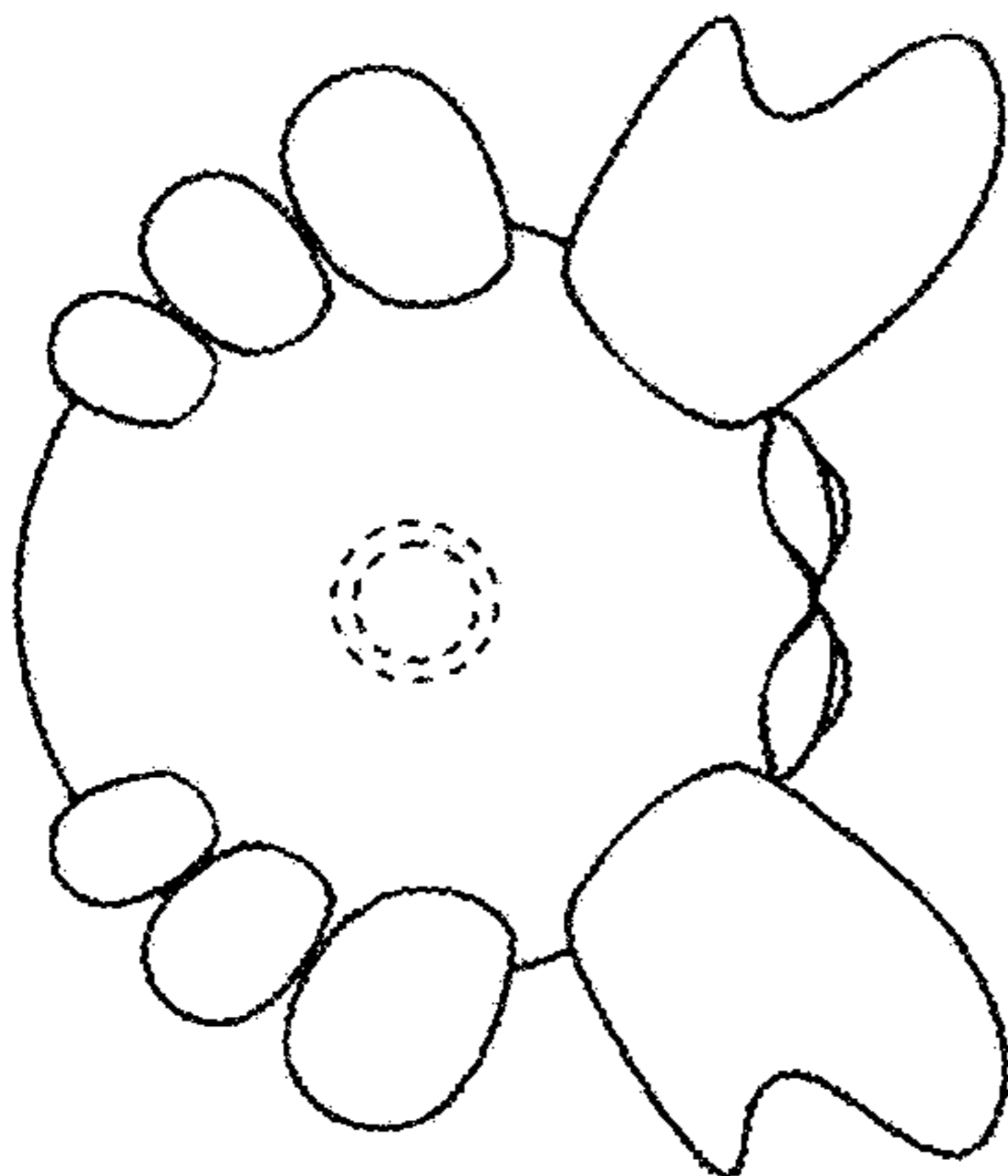

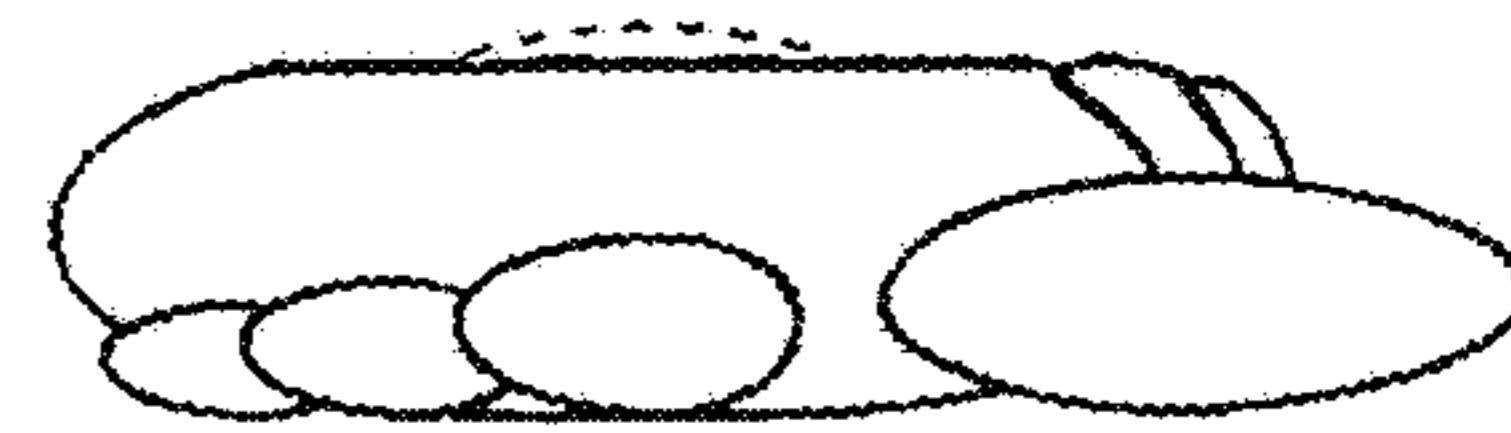

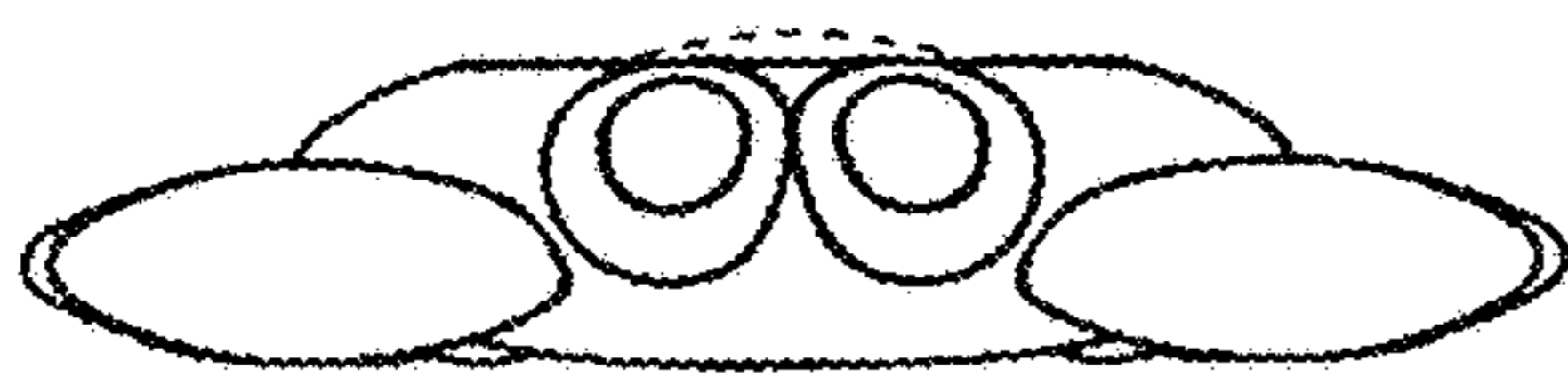

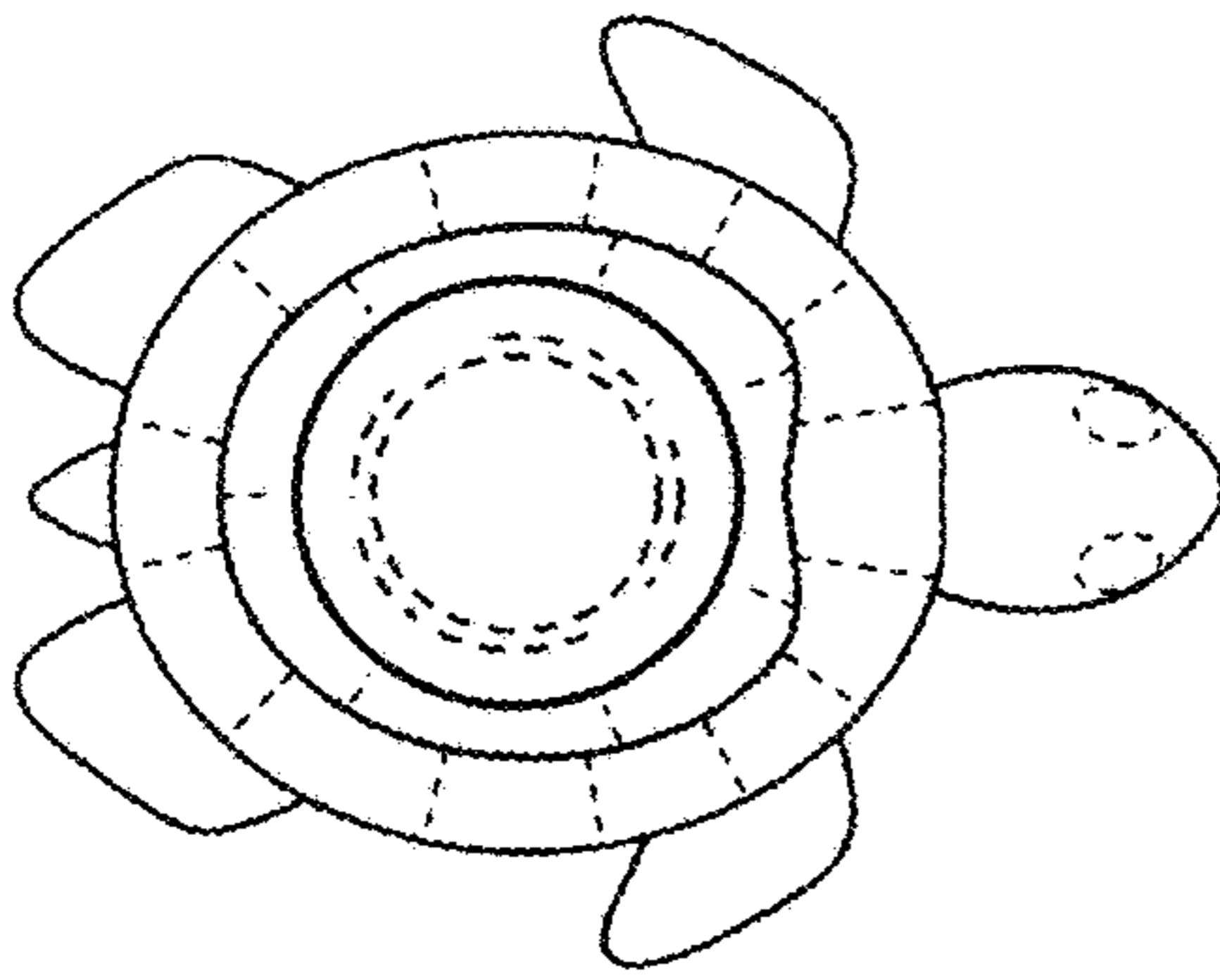

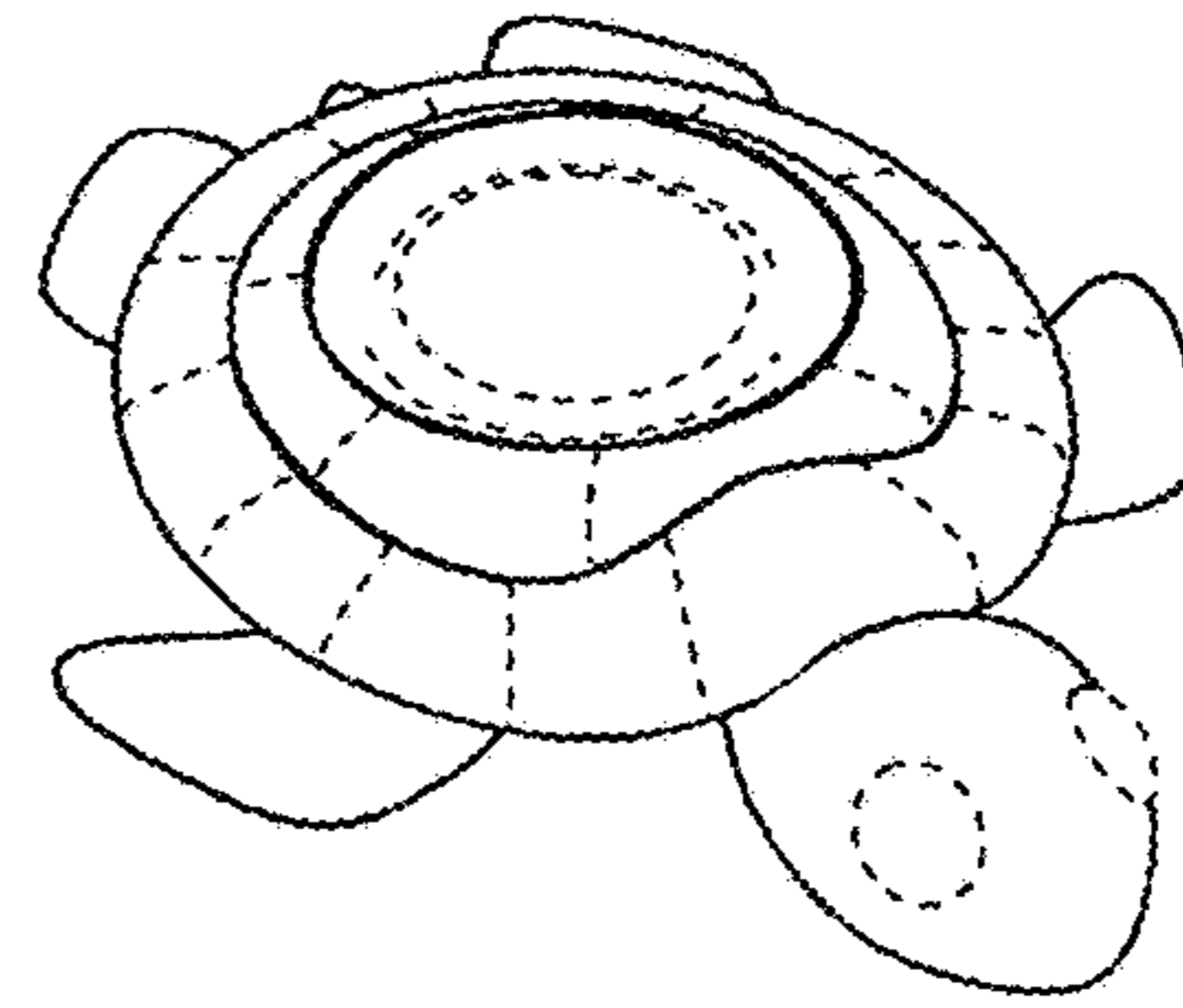

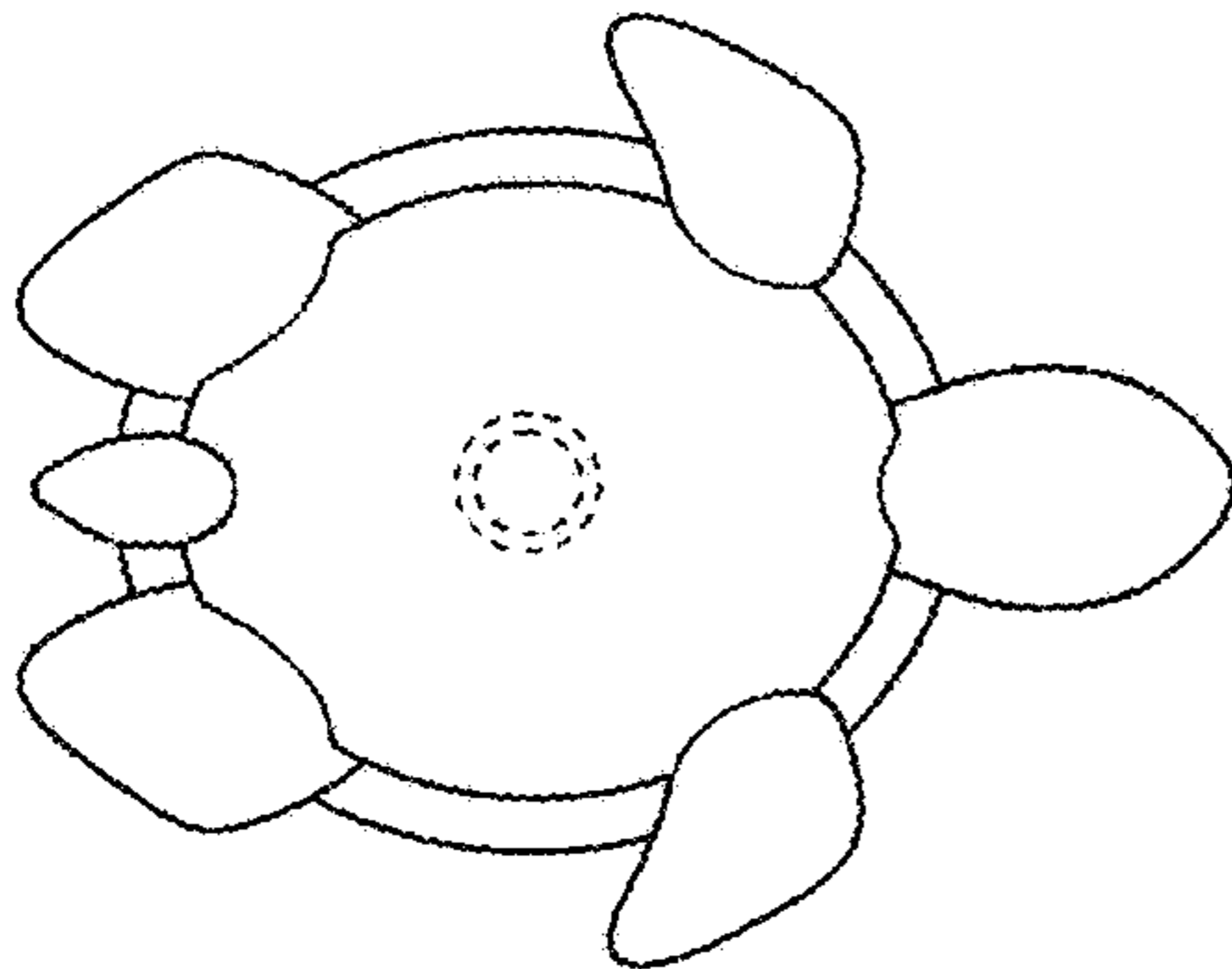

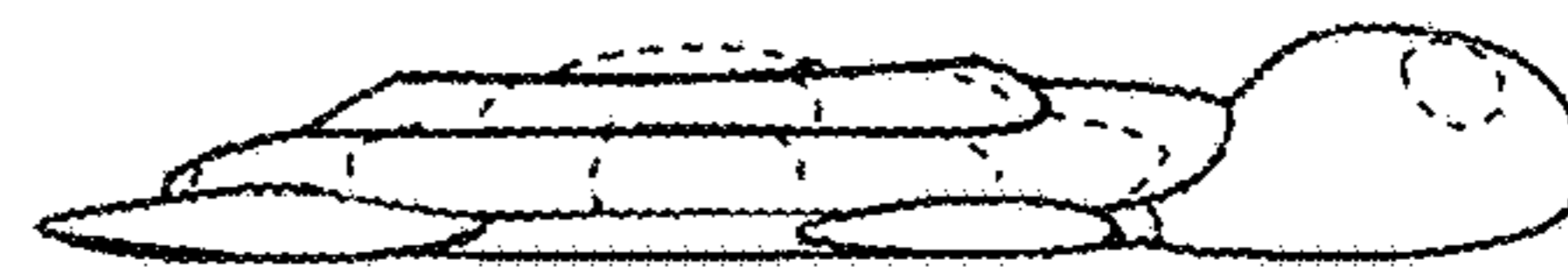

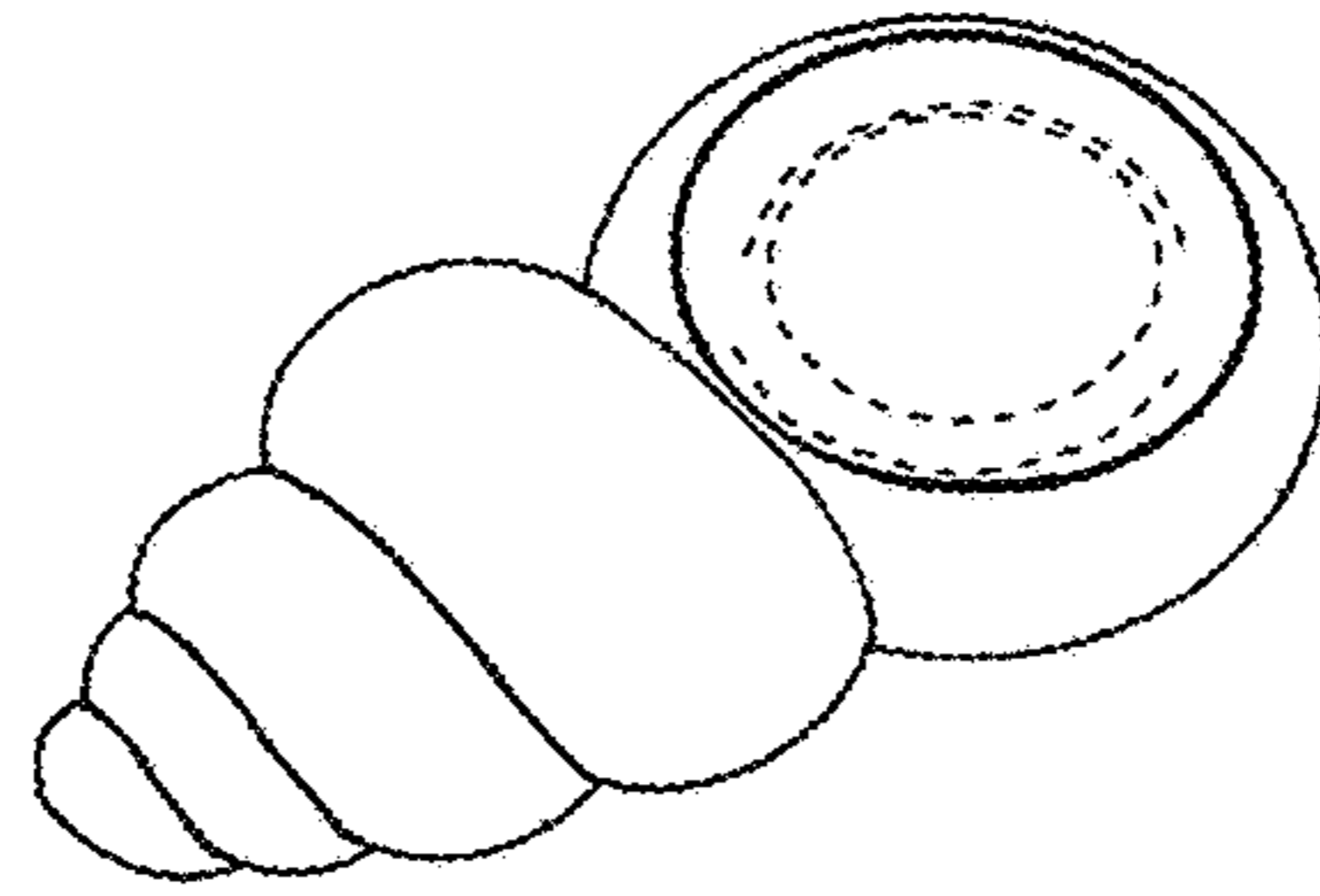

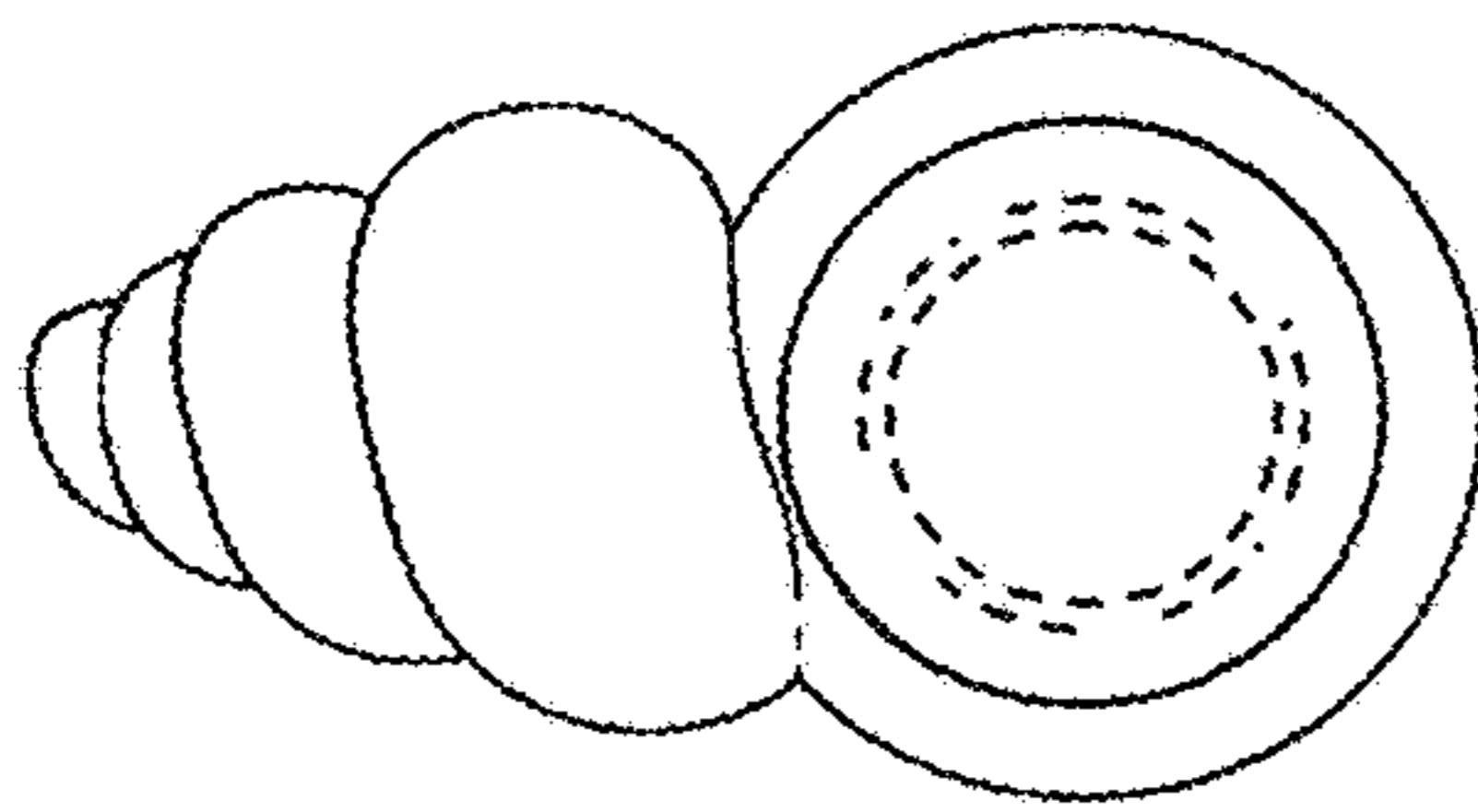

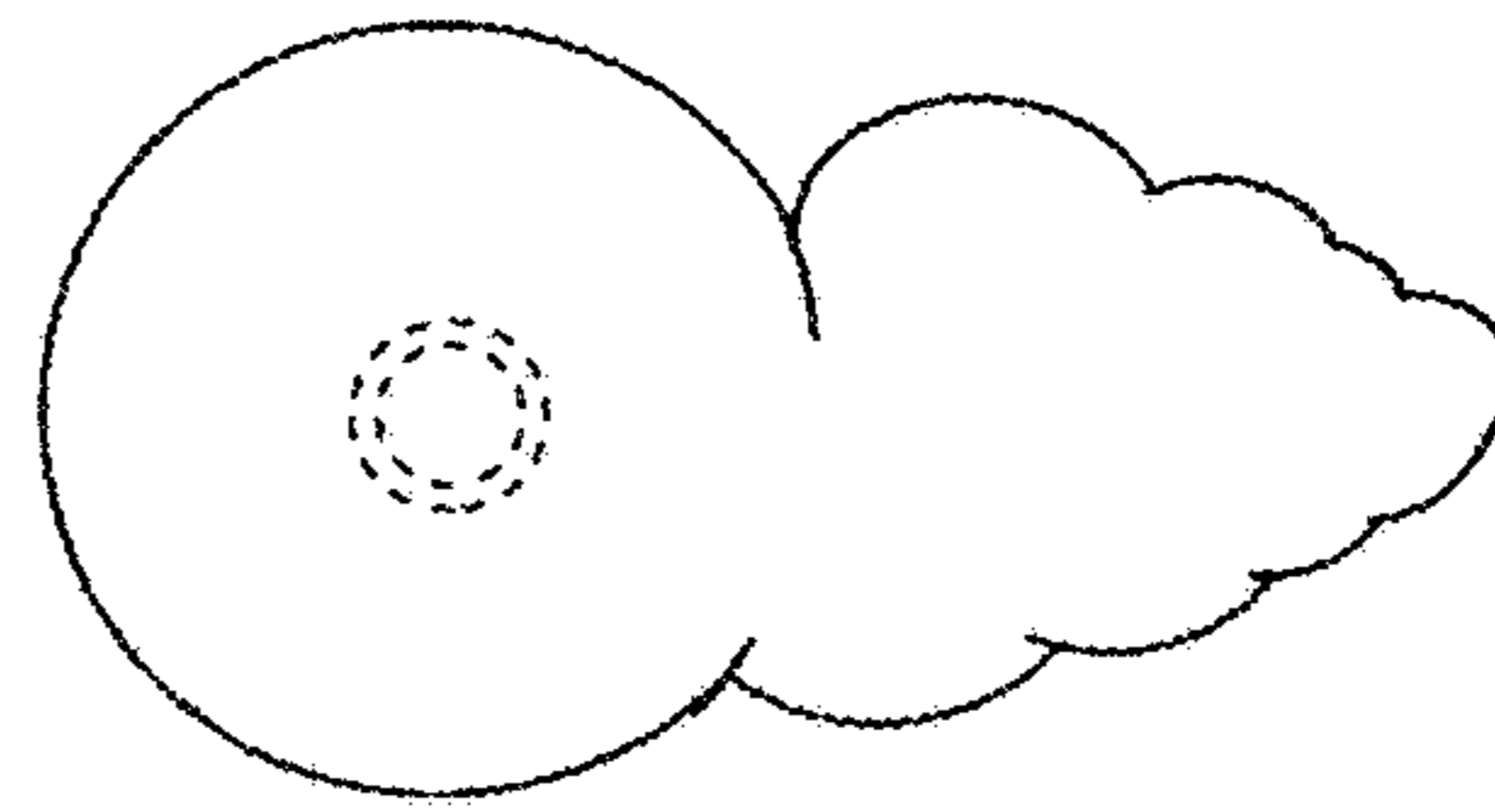

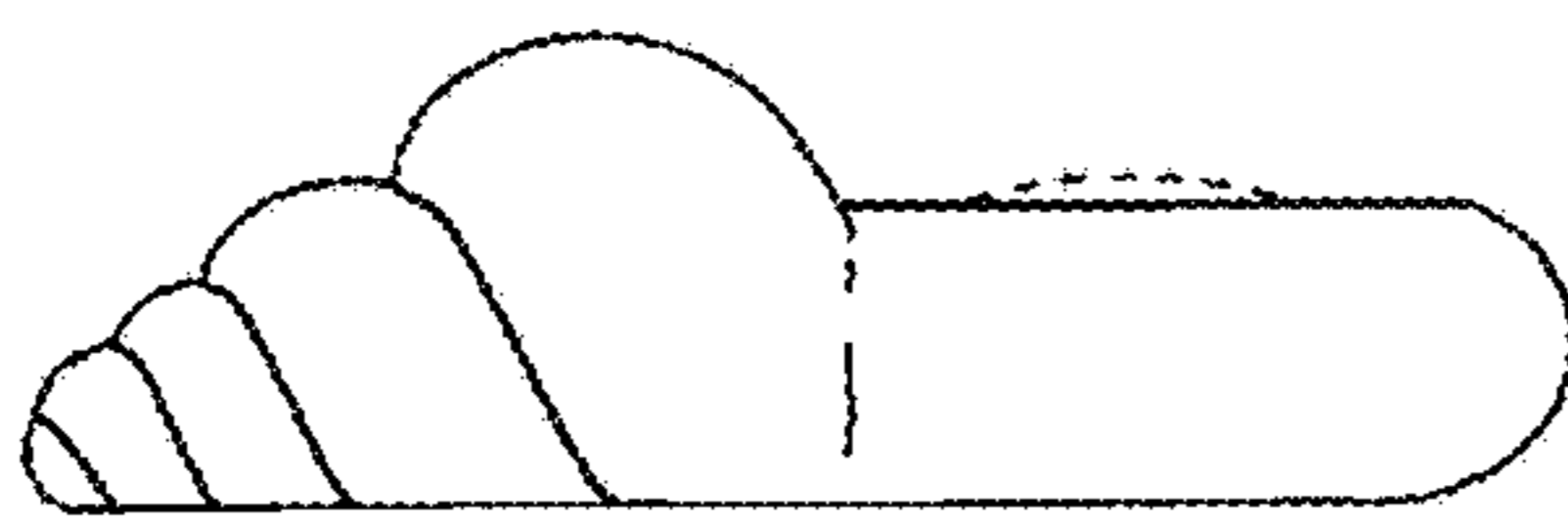

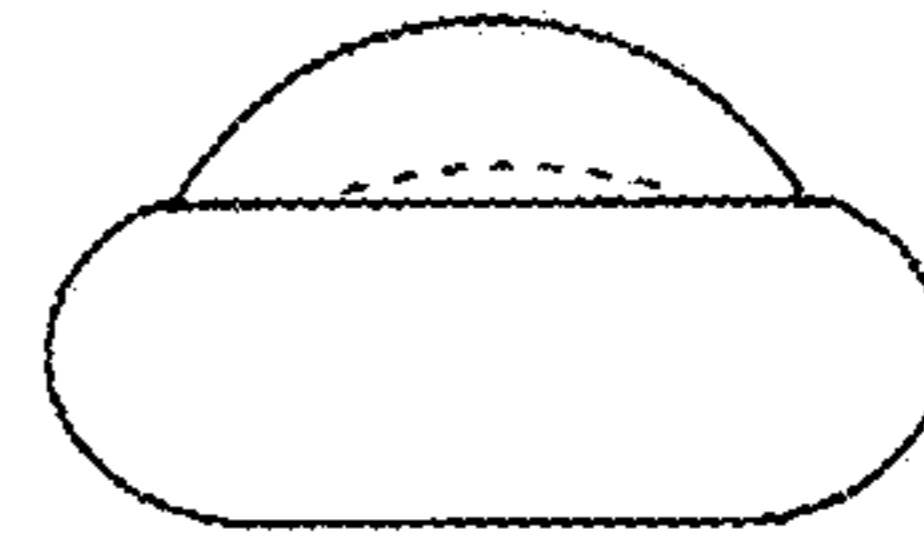

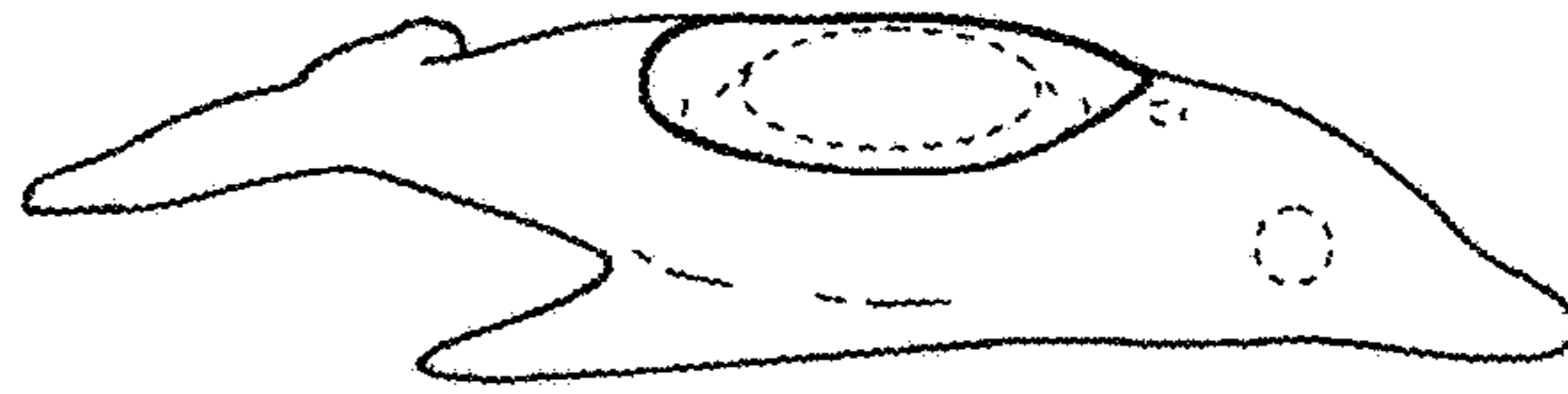

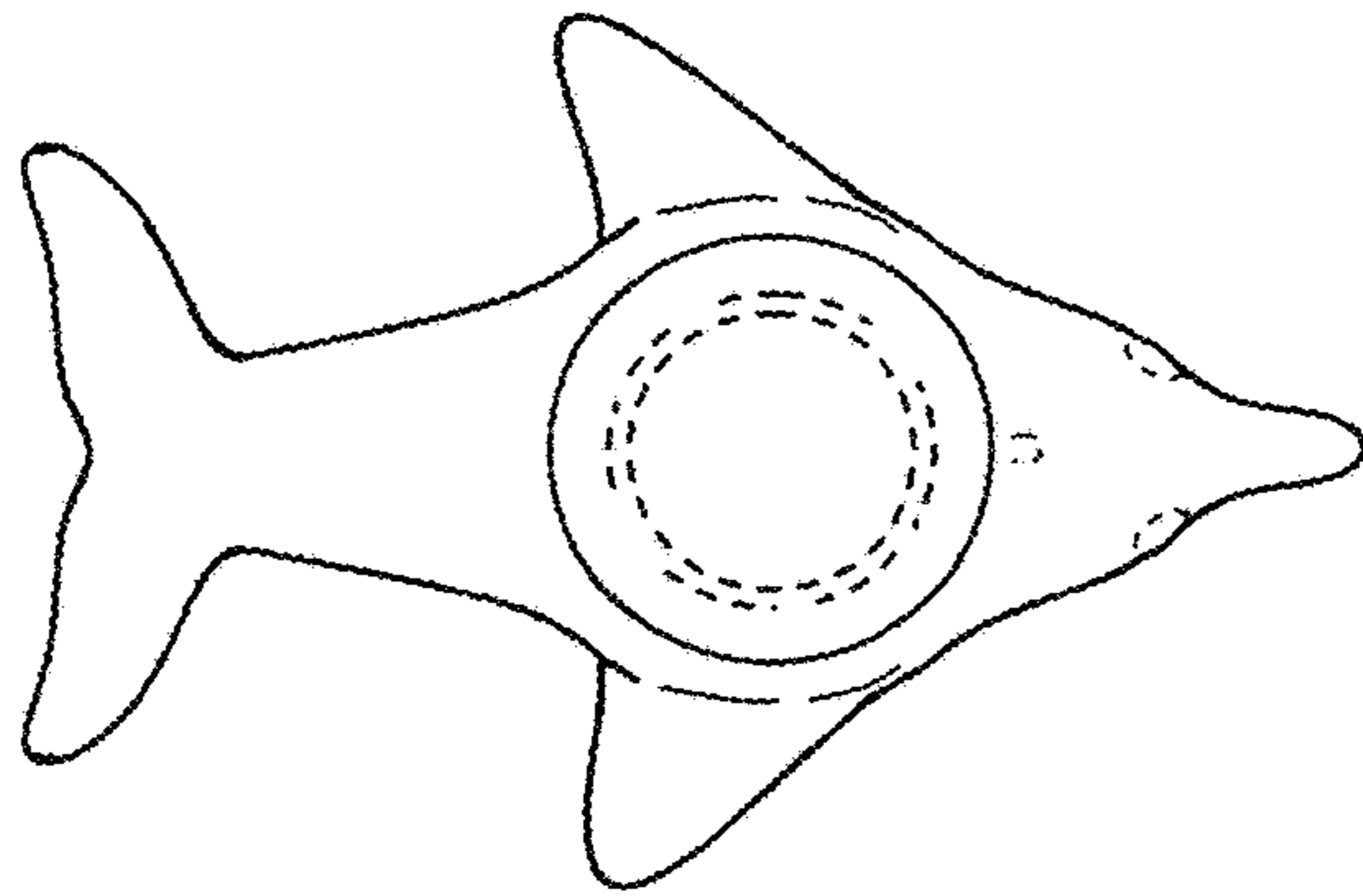

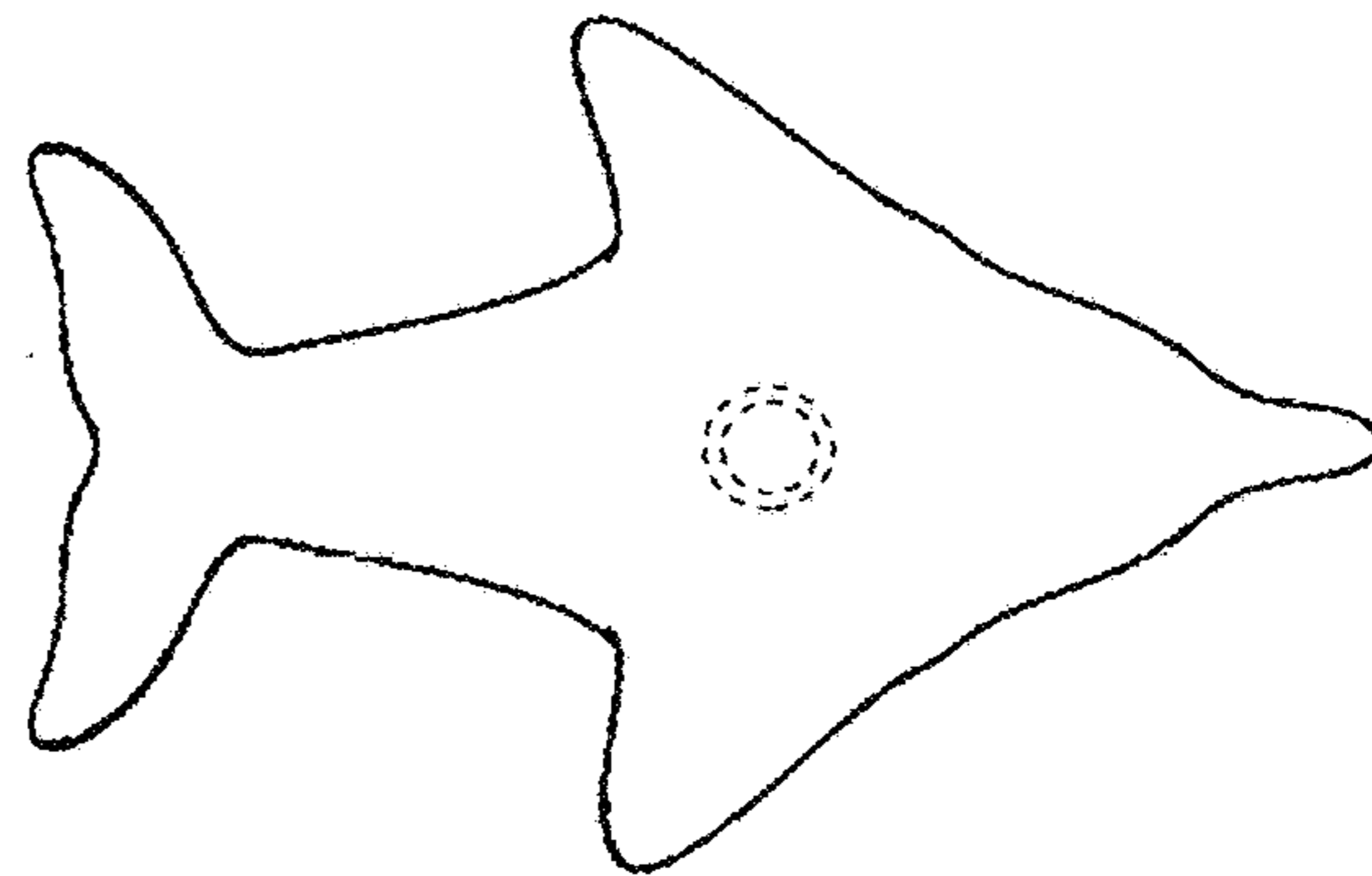

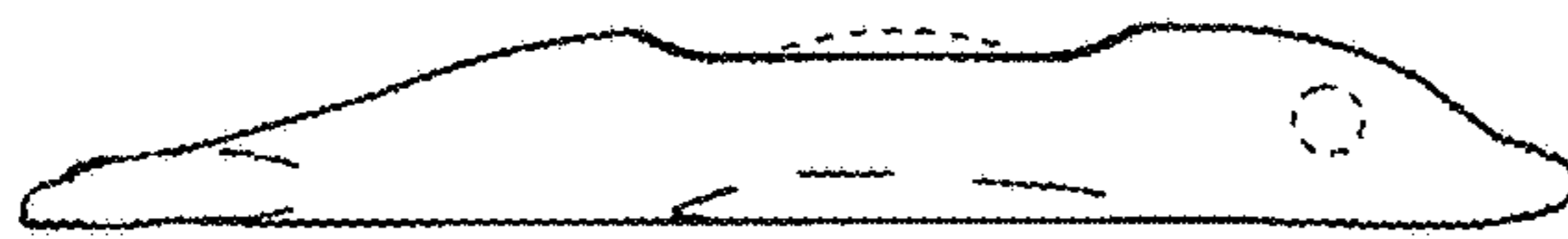
