The ornamental design for a landscape irrigation pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a landscape irrigation pad embodying our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a front elevational view thereof.

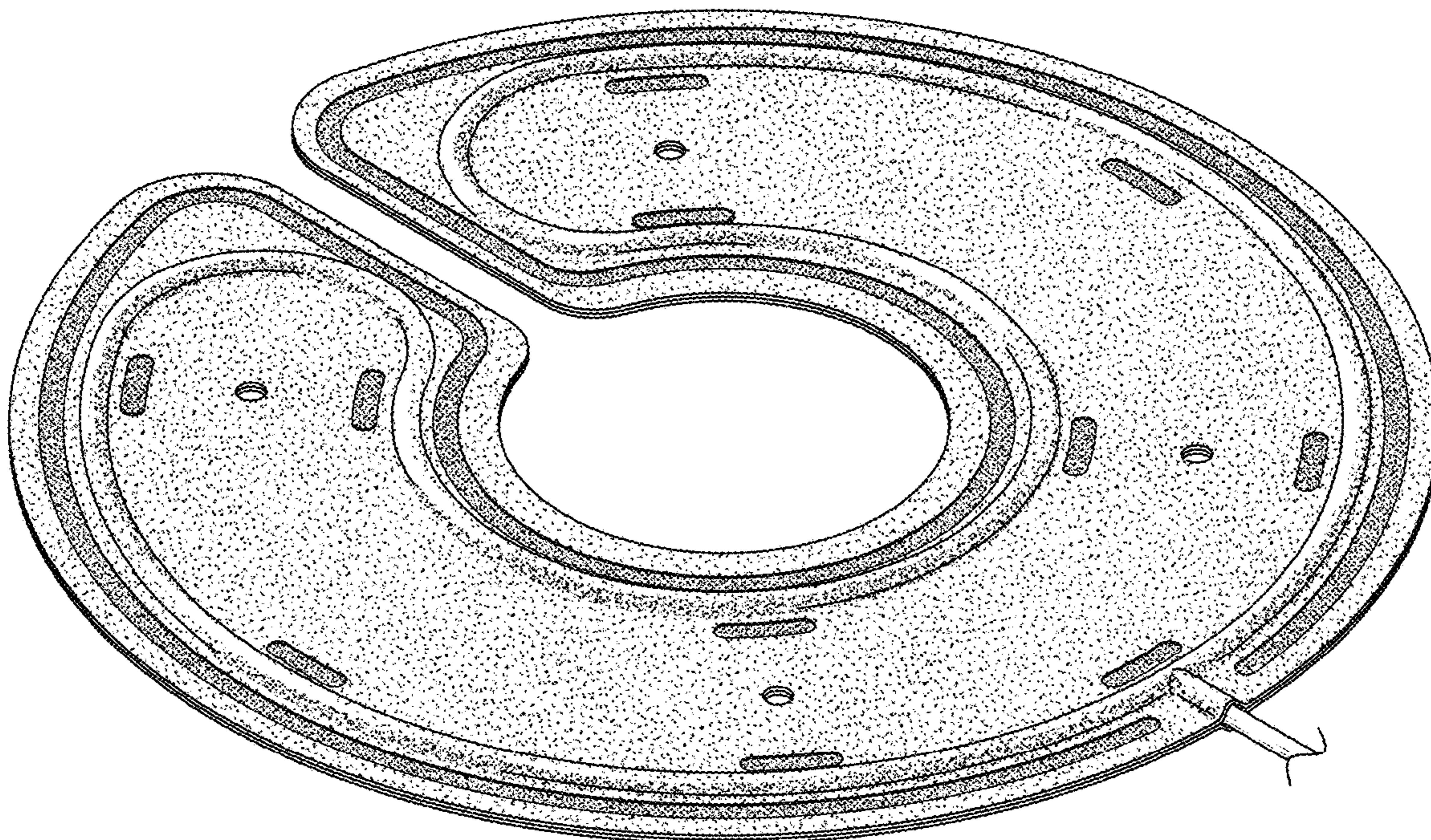
It is understood that the interior of the tube element forms no part of the claimed design.

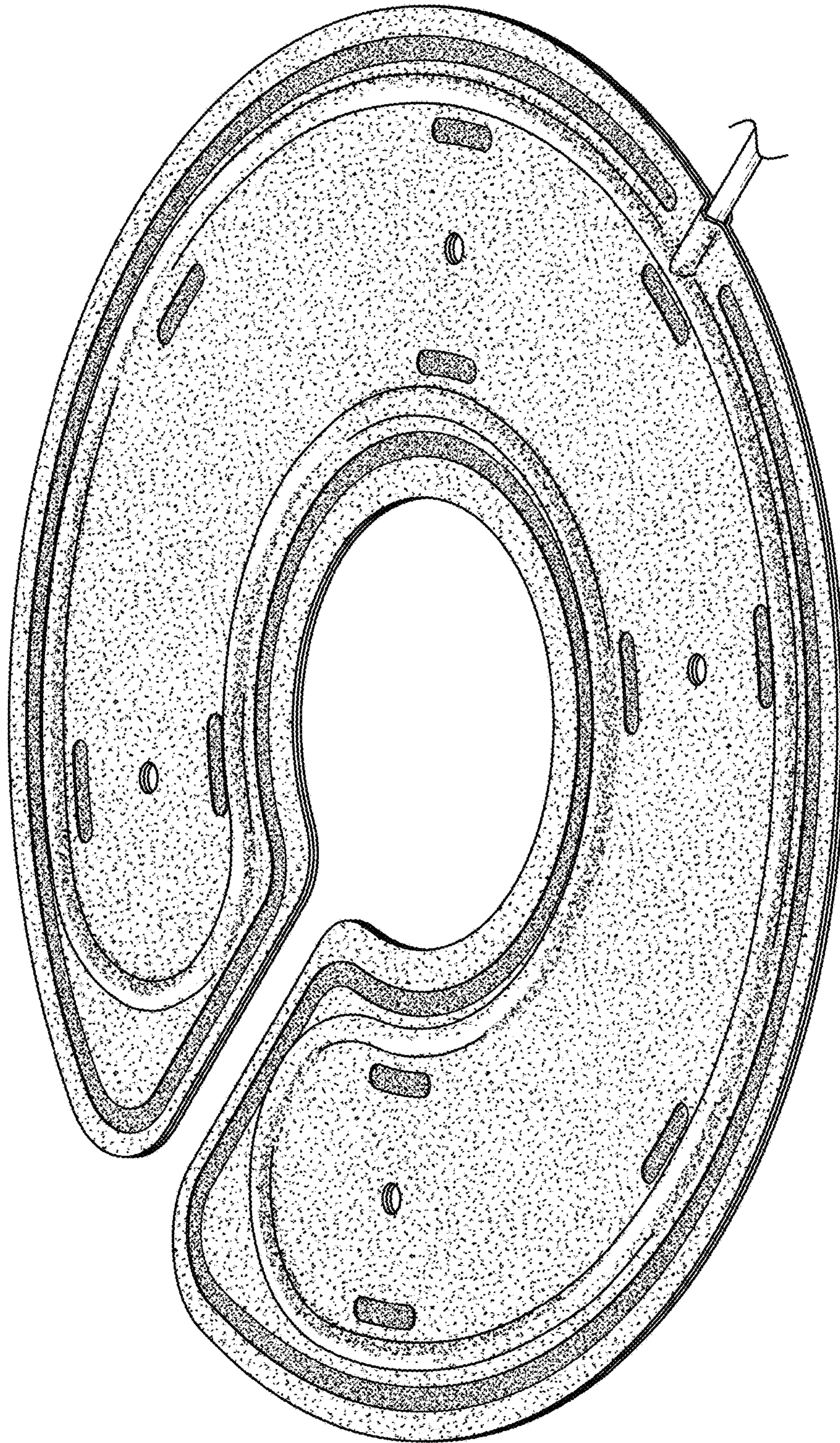

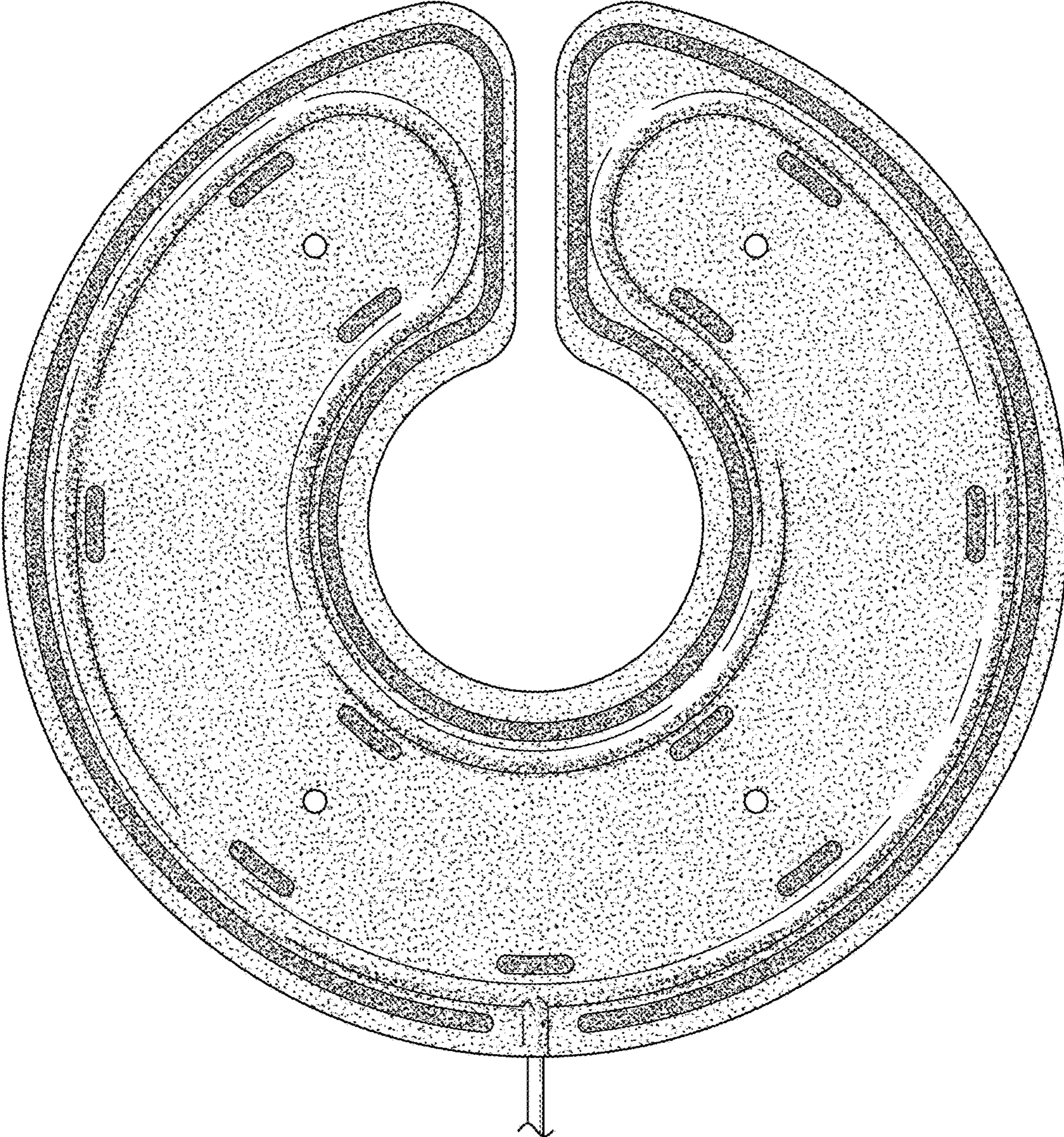

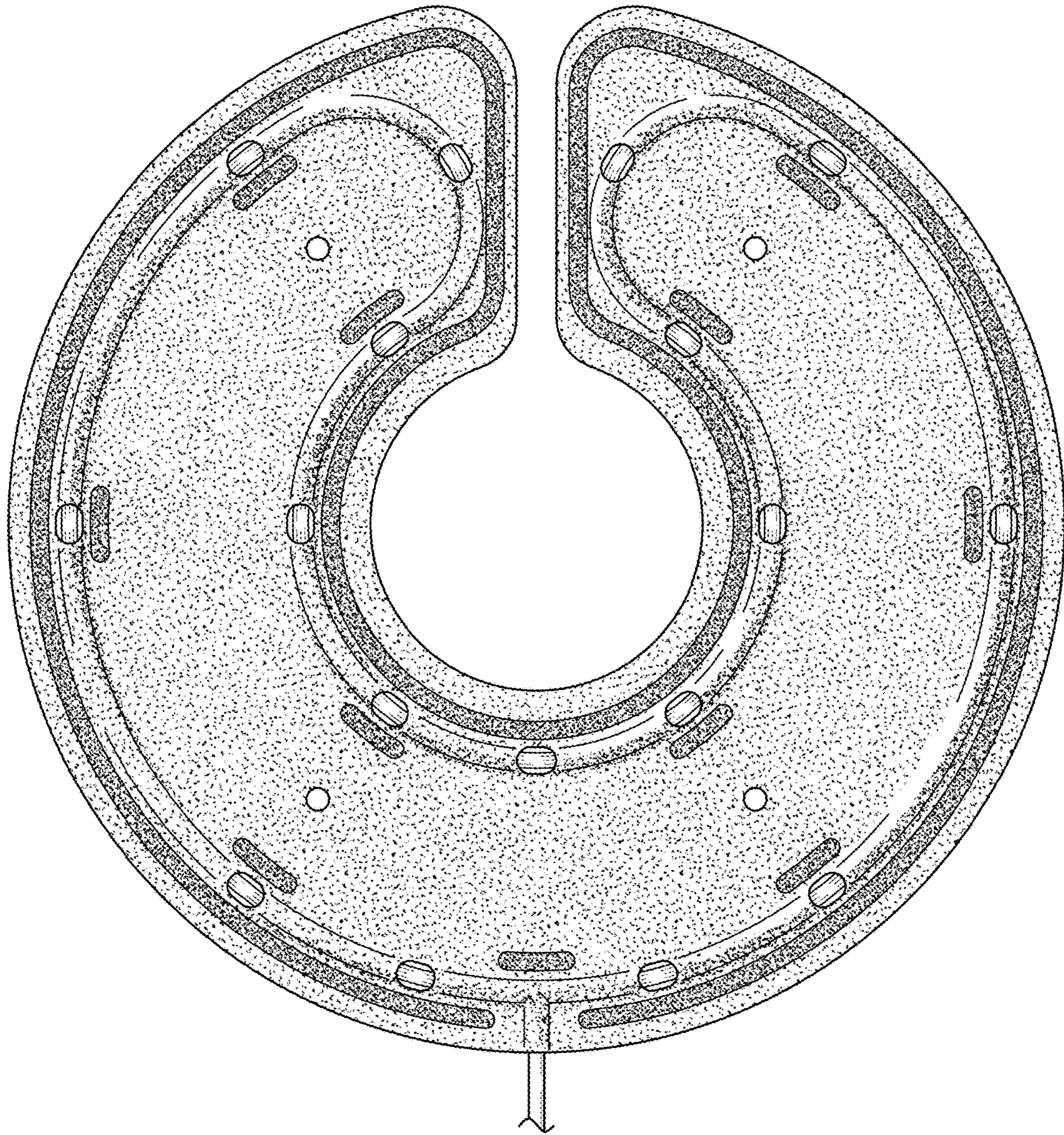

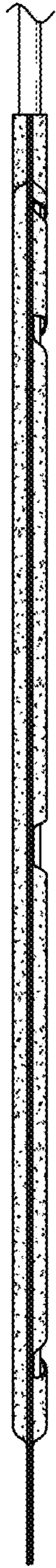
