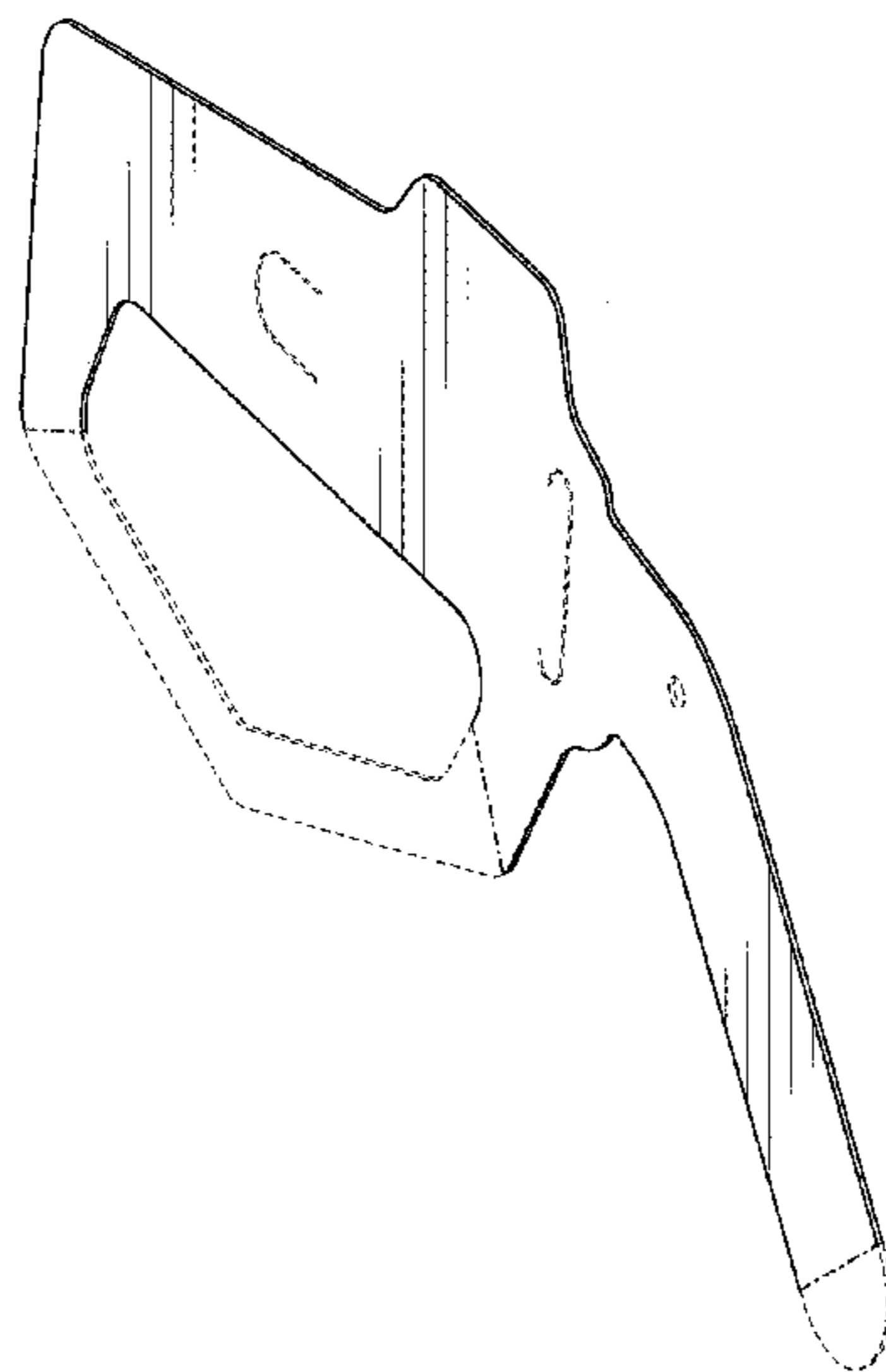
(57) **CLAIM**

The ornamental design for product packaging, as shown and described.

**DESCRIPTION**

FIG. 1 is a right-frontal perspective view of product packaging showing our new design according to a first embodiment;  
FIG. 2 is a right-side elevation view thereof;  
FIG. 3 is a left-side elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a front elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a right-frontal perspective view thereof illustrated with a product positioned thereon, where the product is illustrated as obstructing a portion of the product packaging;  
FIG. 9 is a right-frontal perspective view of product packaging showing our new design according to a second embodiment;  
FIG. 10 is a right-side elevation view thereof;  
FIG. 11 is a left-side elevation view thereof;  
FIG. 12 is a rear elevation view thereof;  
FIG. 13 is a front elevation view thereof;  
FIG. 14 is a top plan view thereof;  
FIG. 15 is a bottom plan view thereof; and,  
FIG. 16 is a right-frontal perspective view thereof illustrated with a product positioned thereon, where the product is illustrated as obstructing a portion of the product packaging.

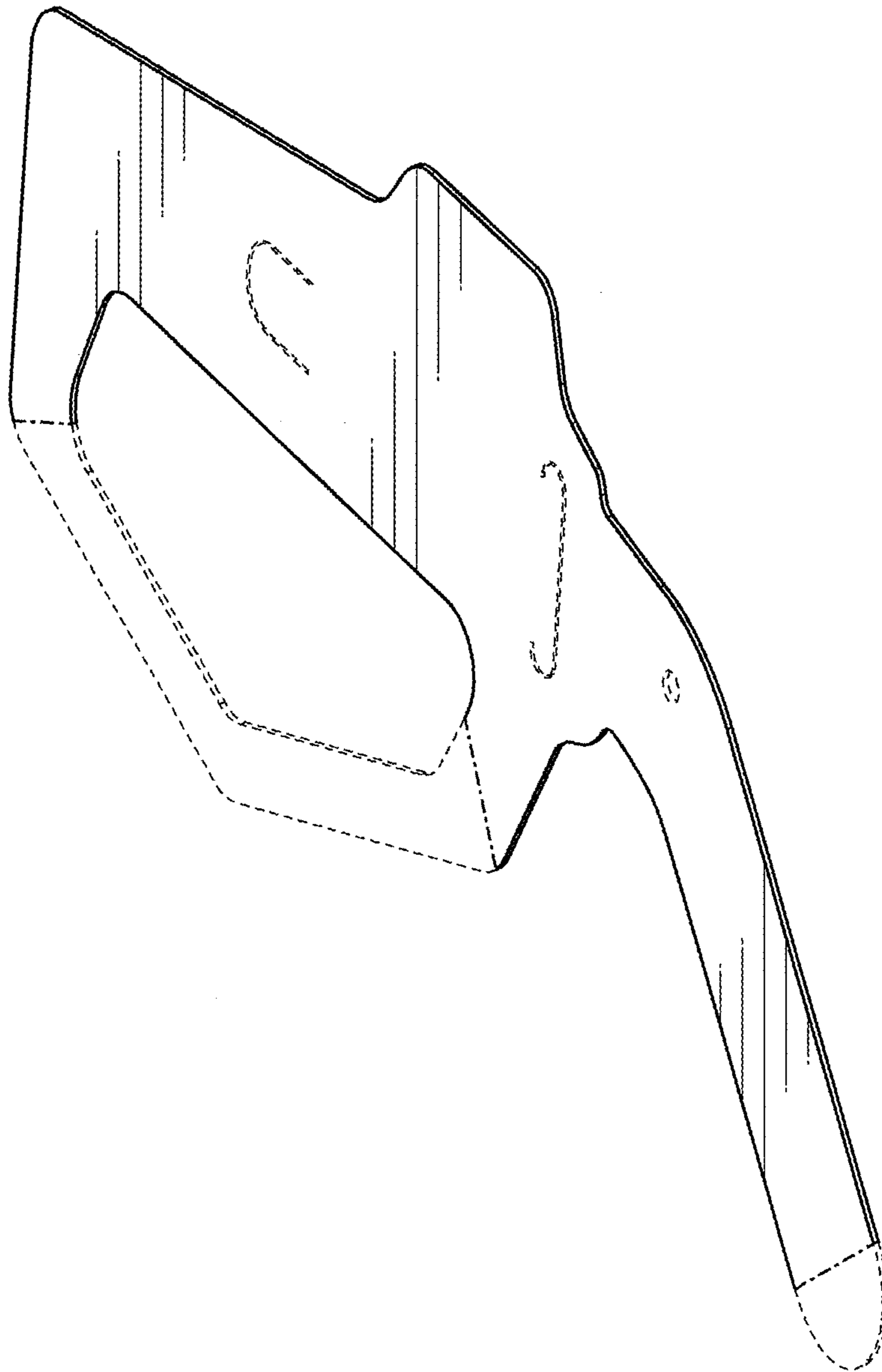

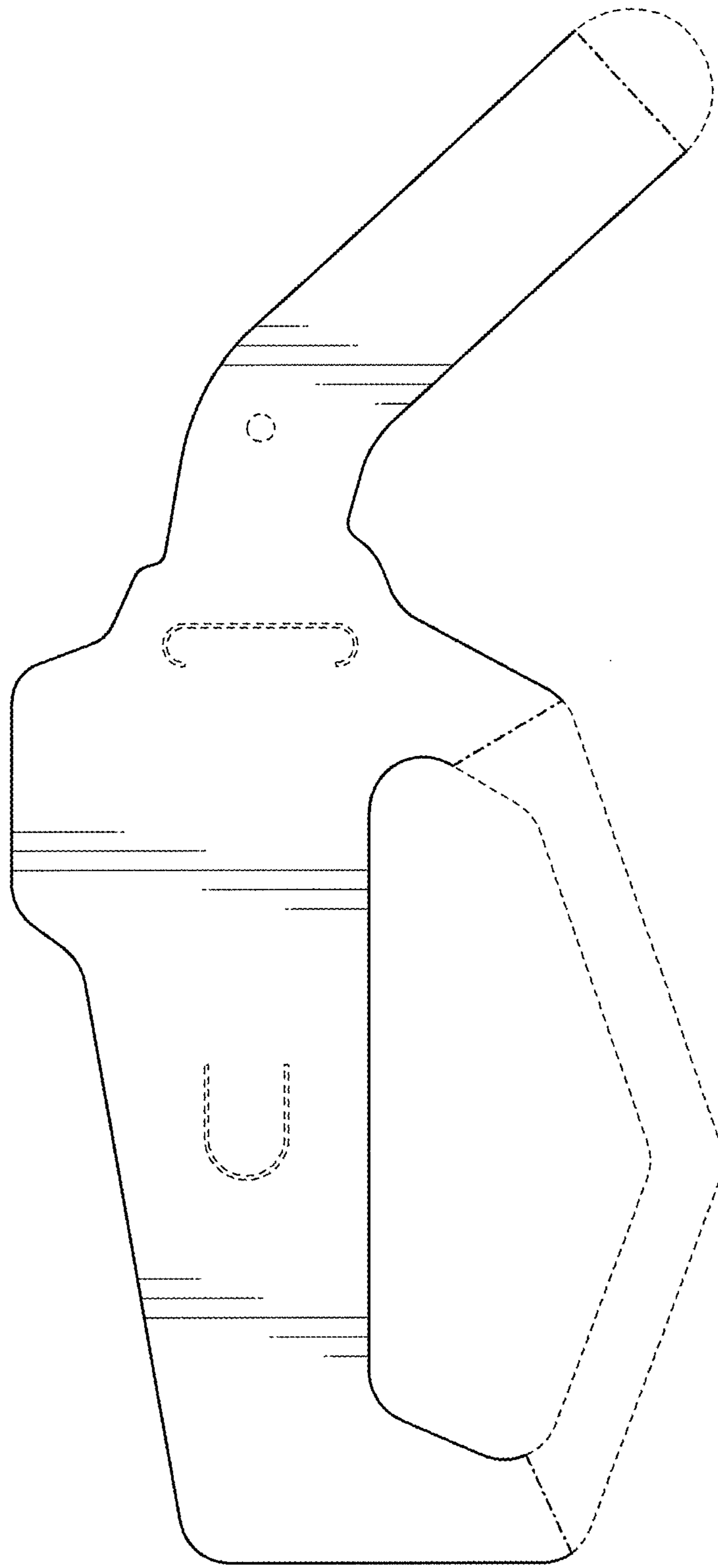

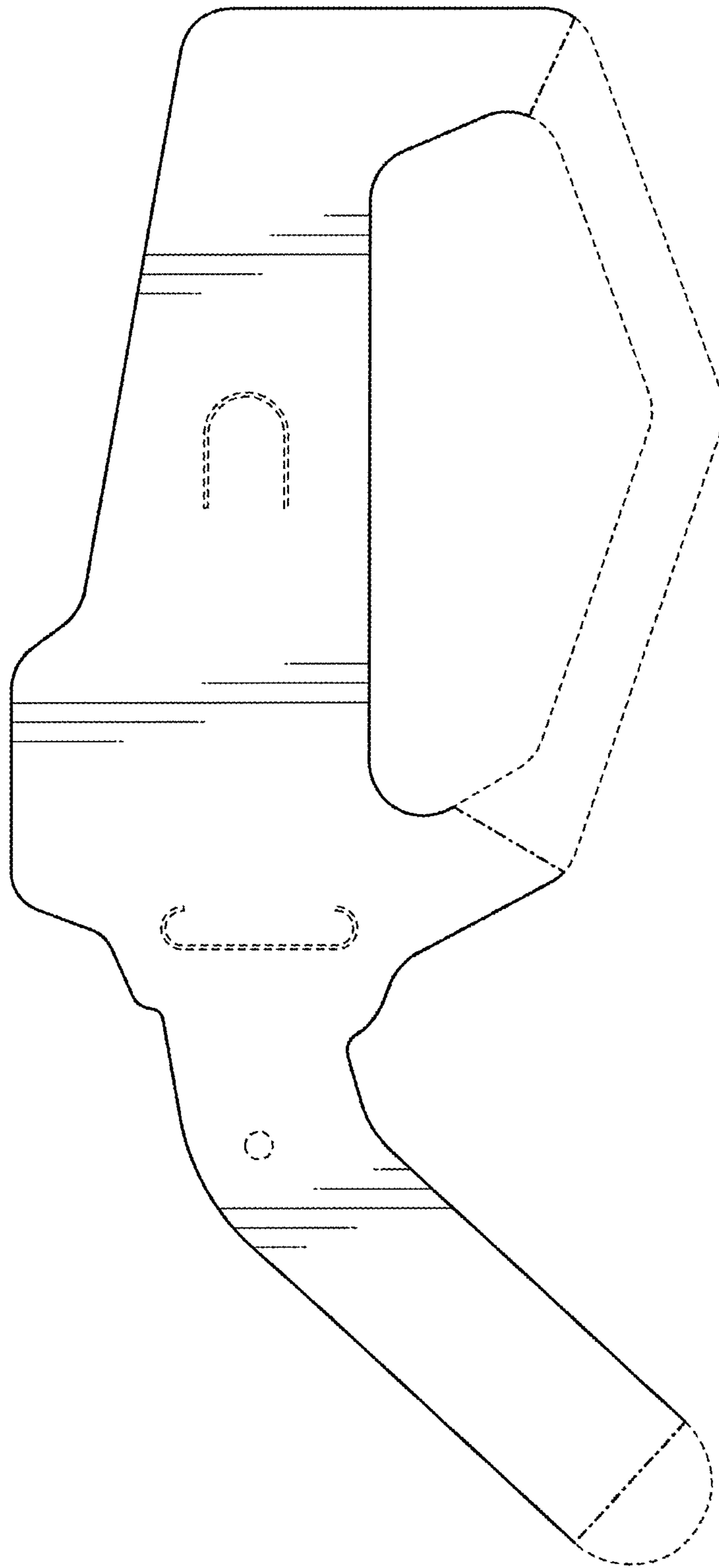

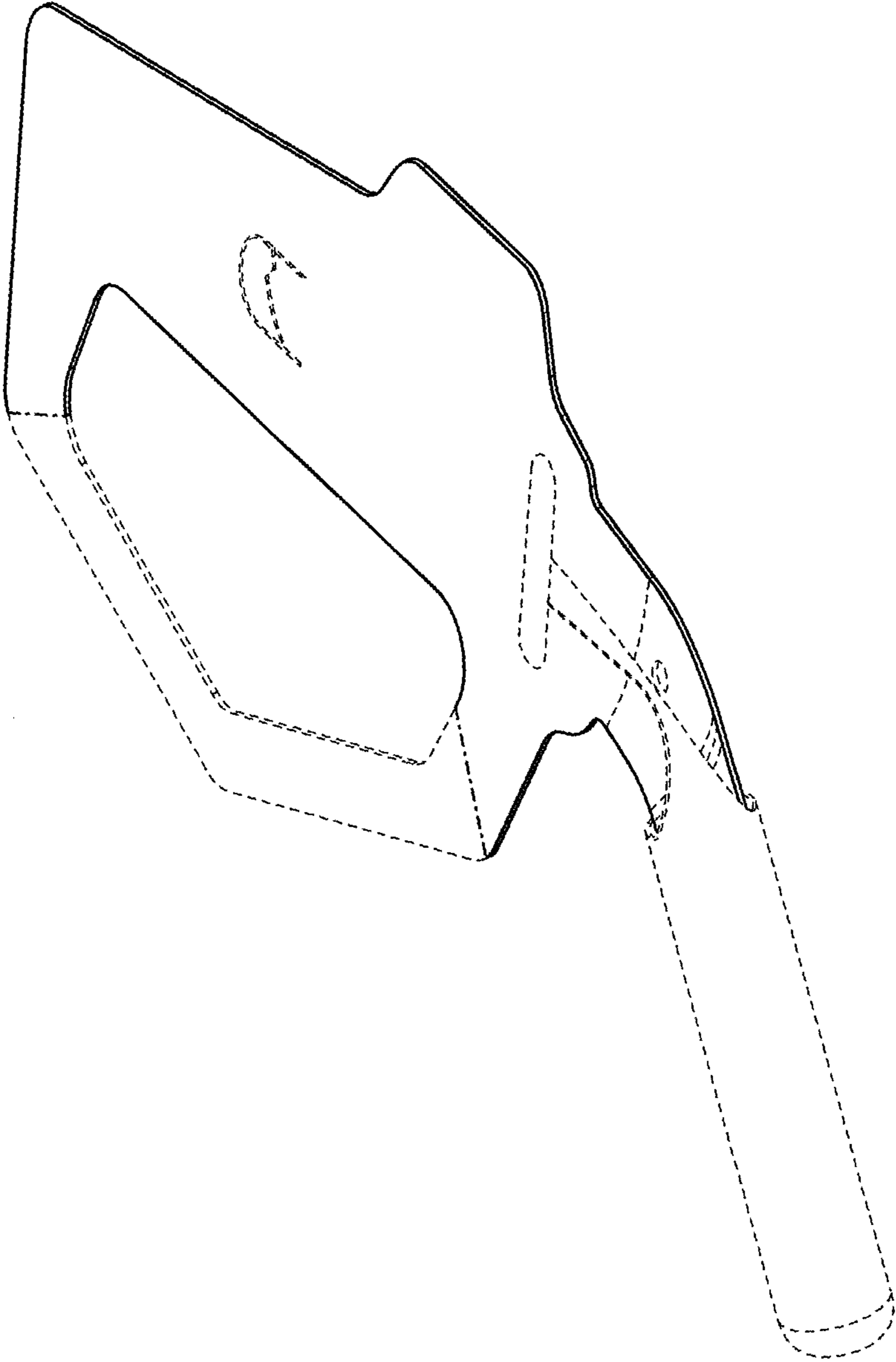

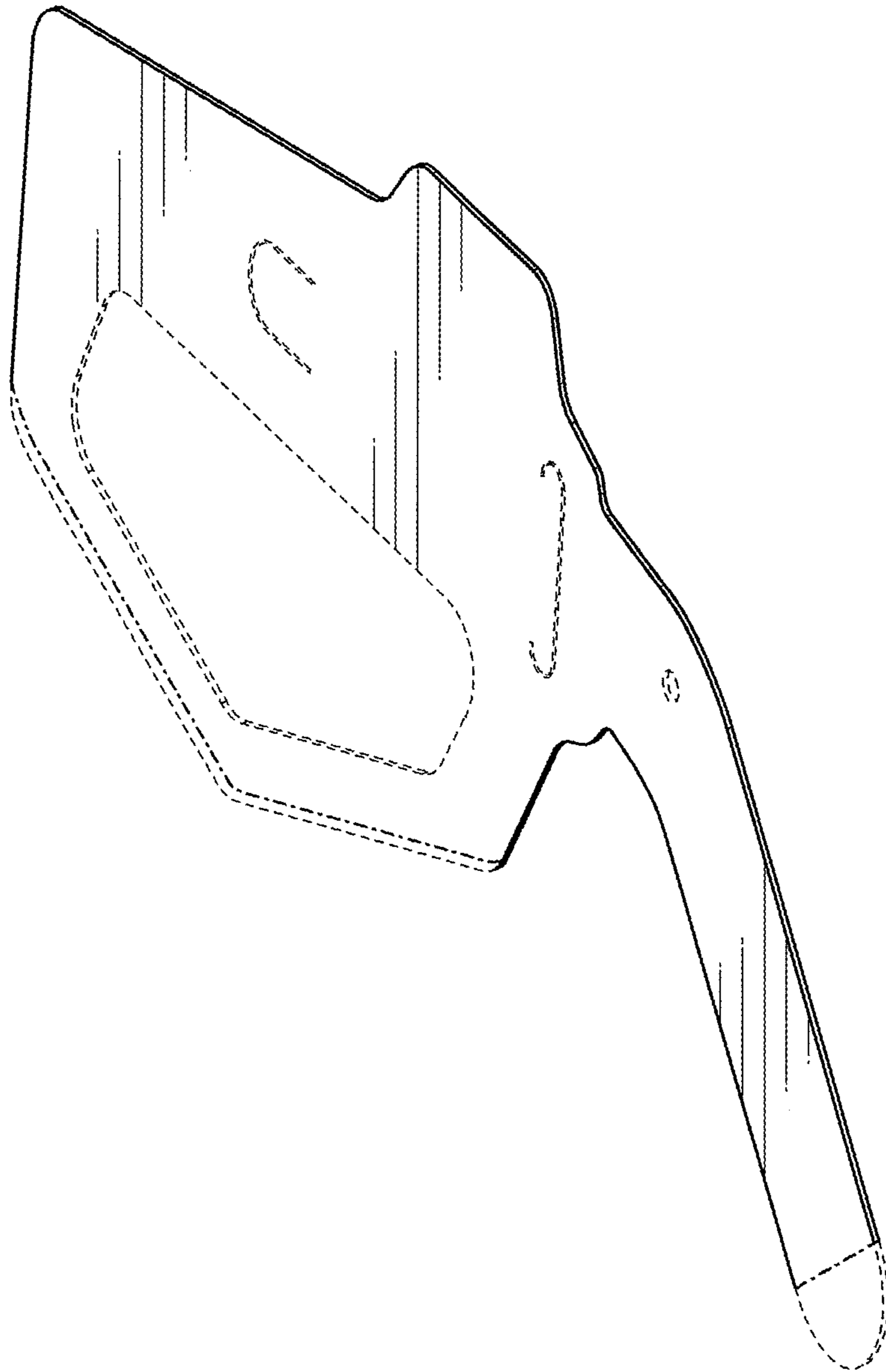

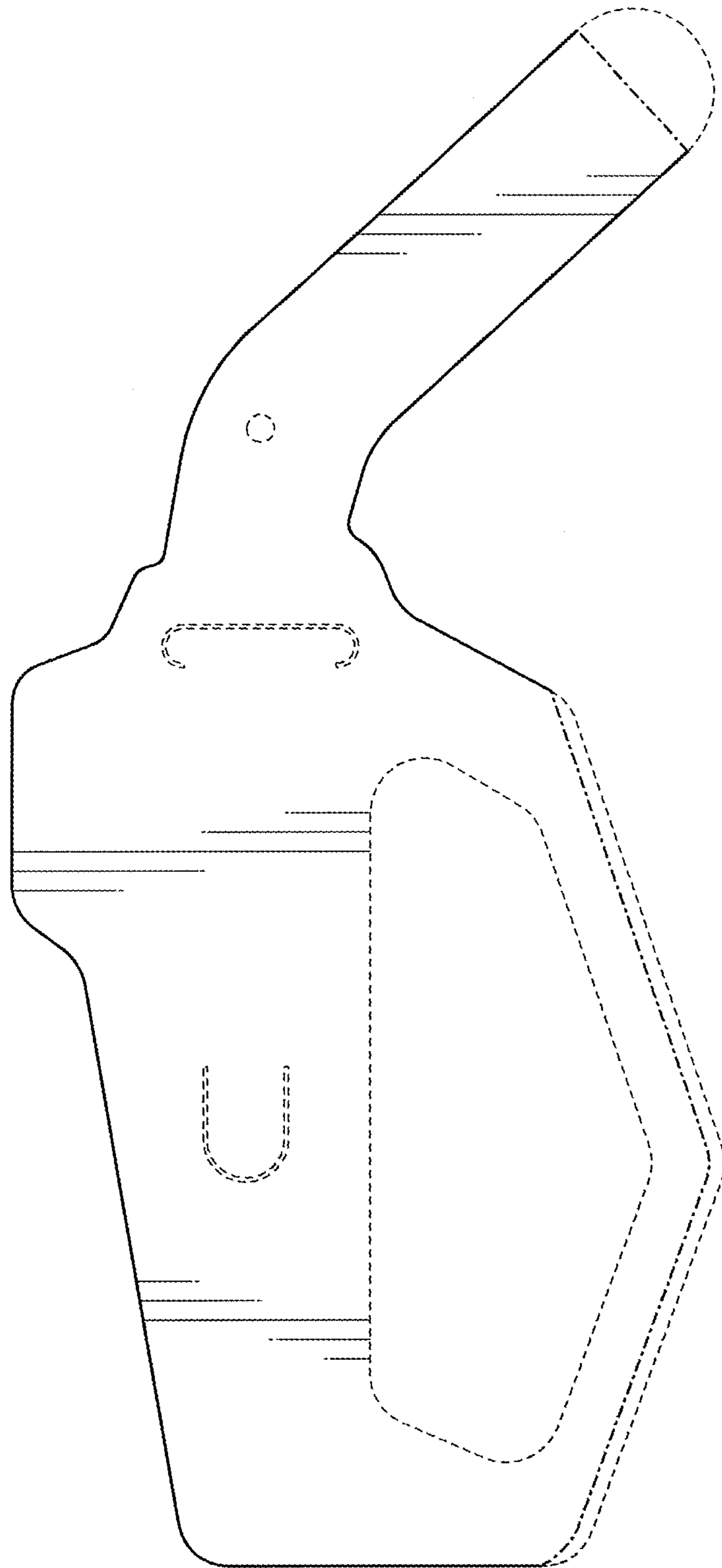

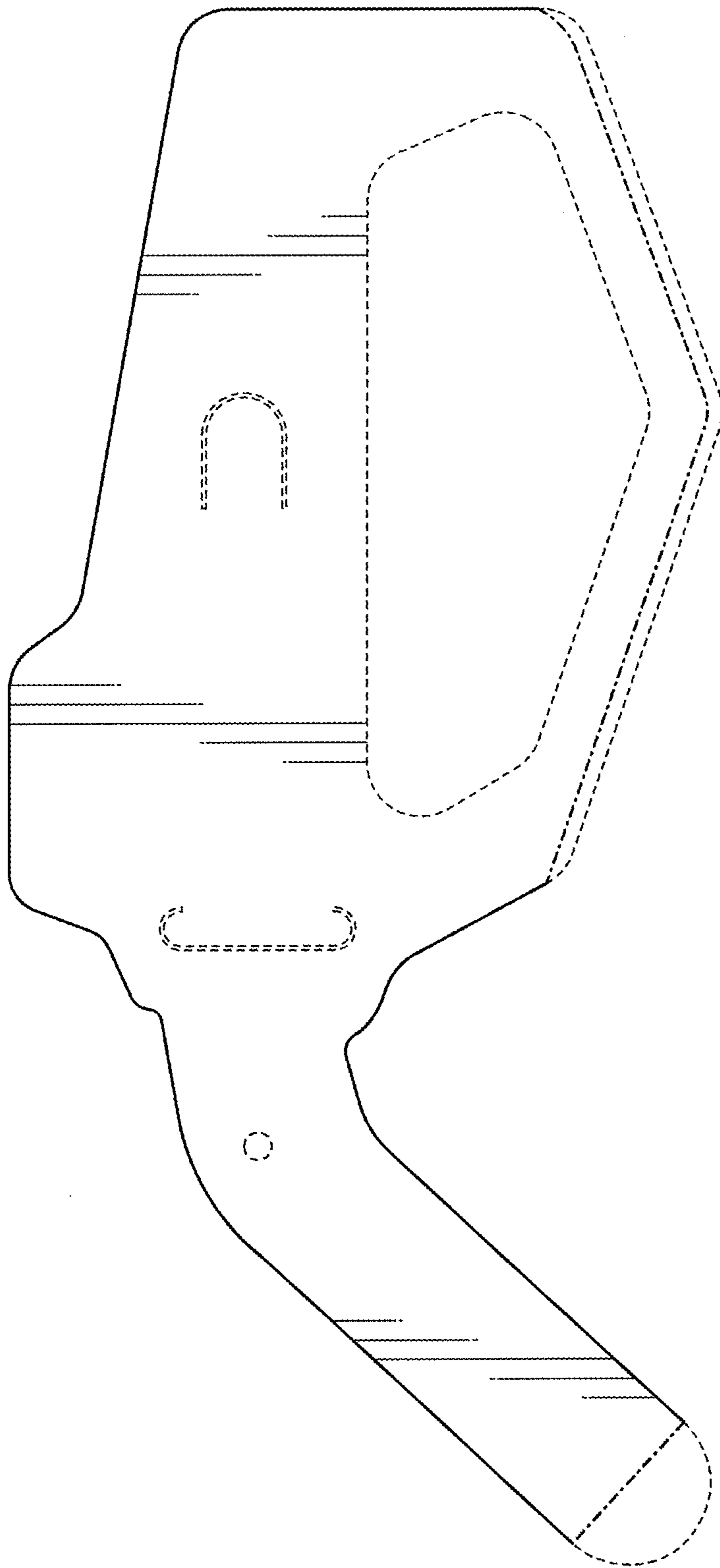

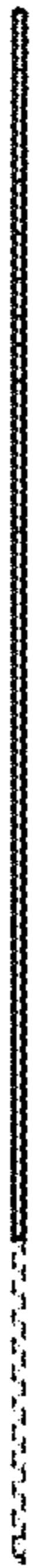

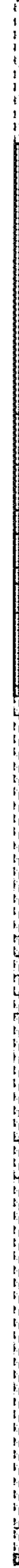

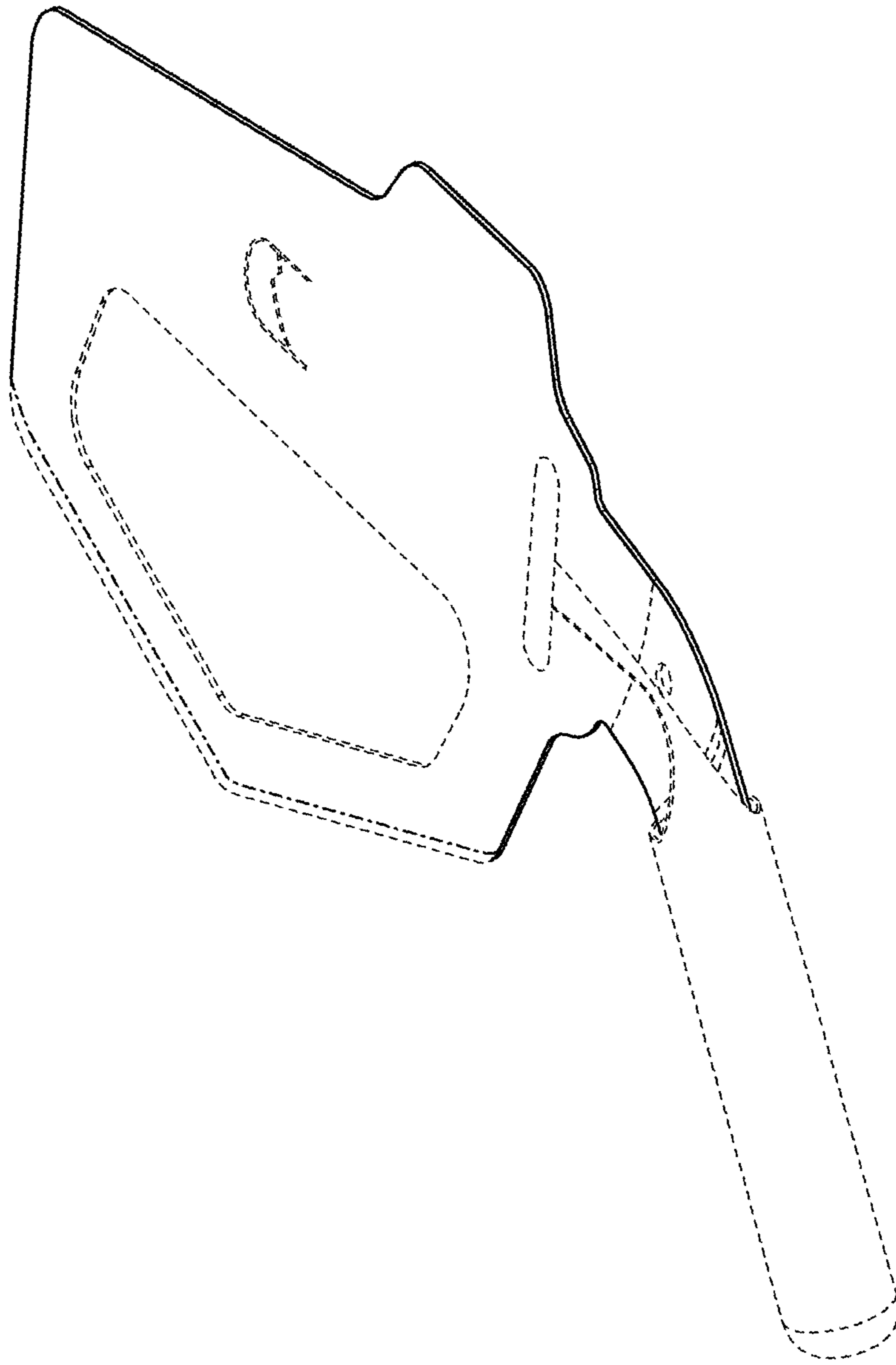
