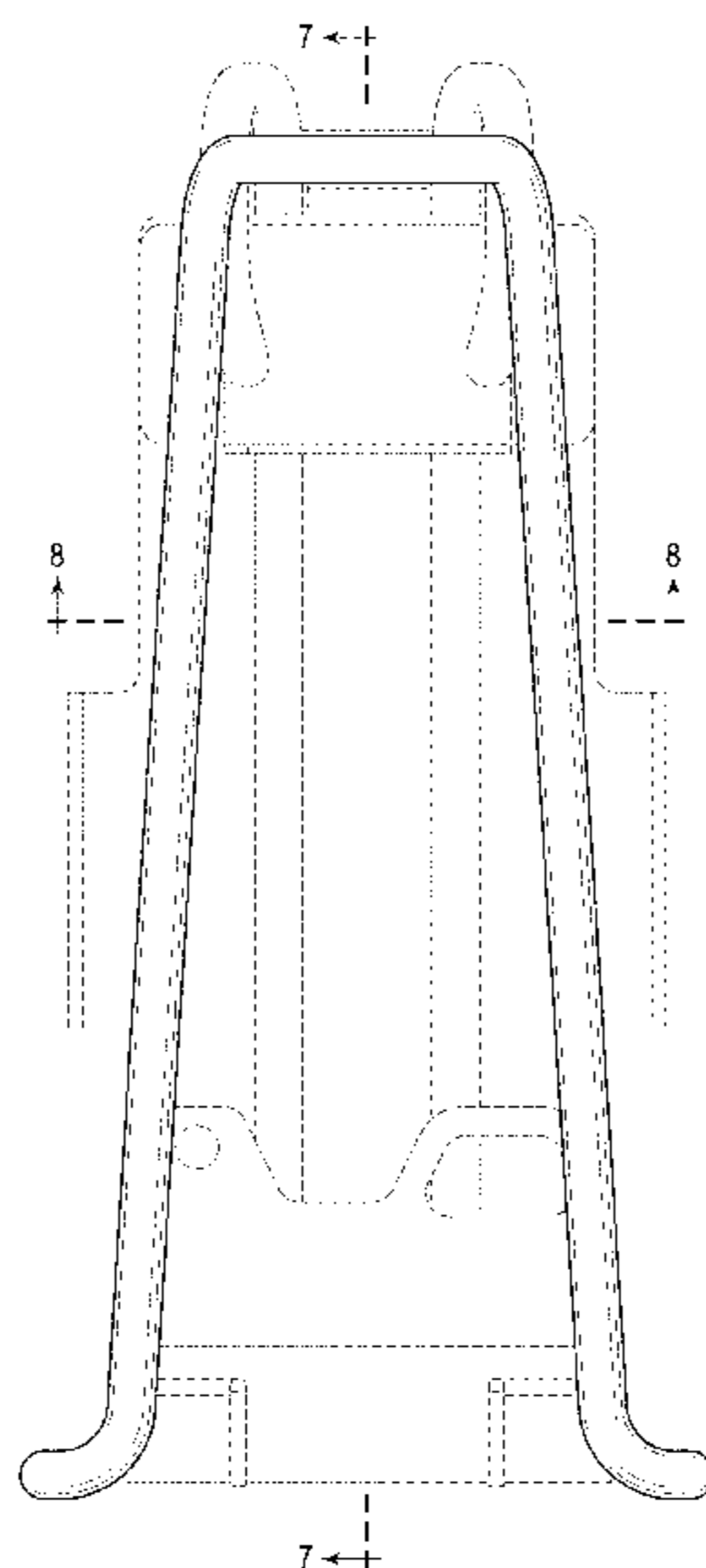
The ornamental design for a bicycle rack for vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a bicycle rack for vehicle;
 FIG. 2 is a rear view thereof;

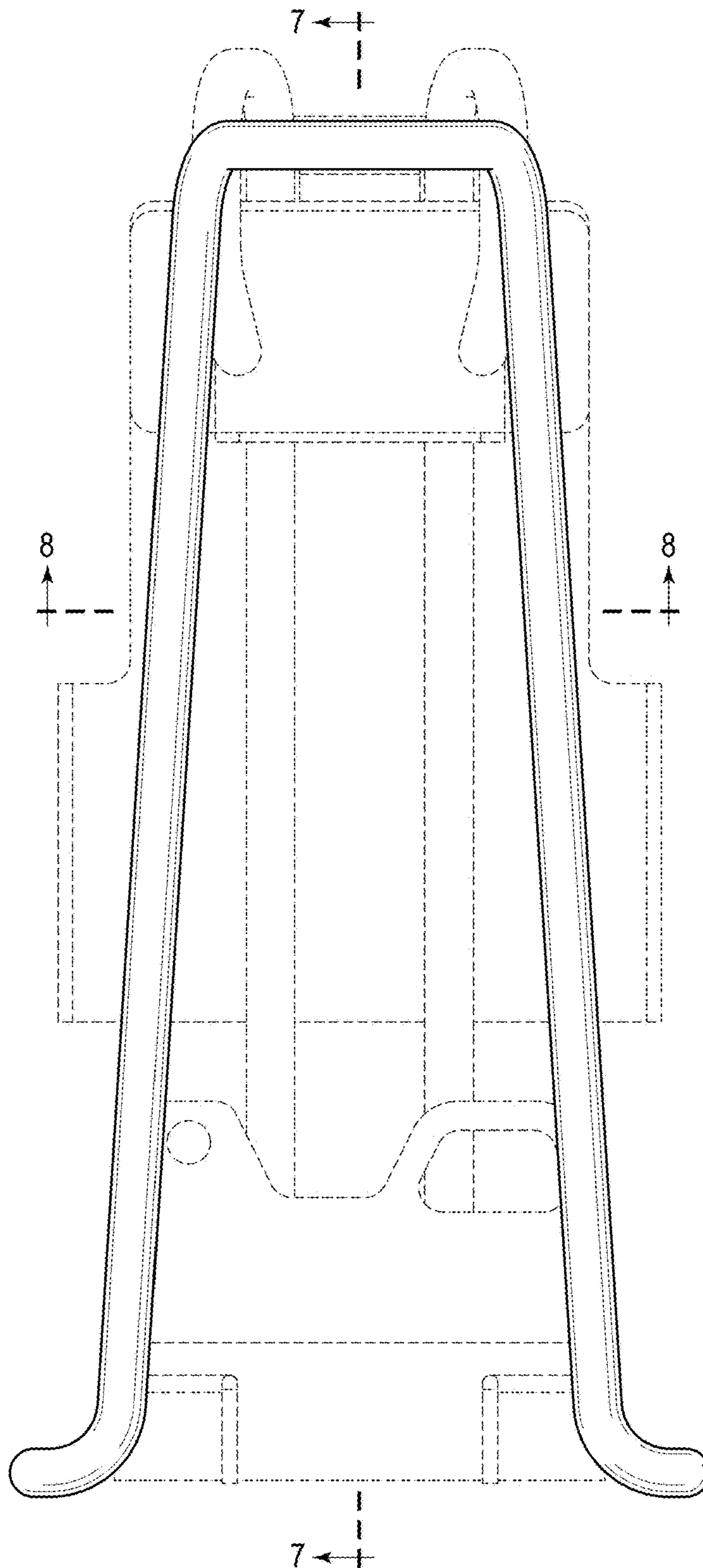

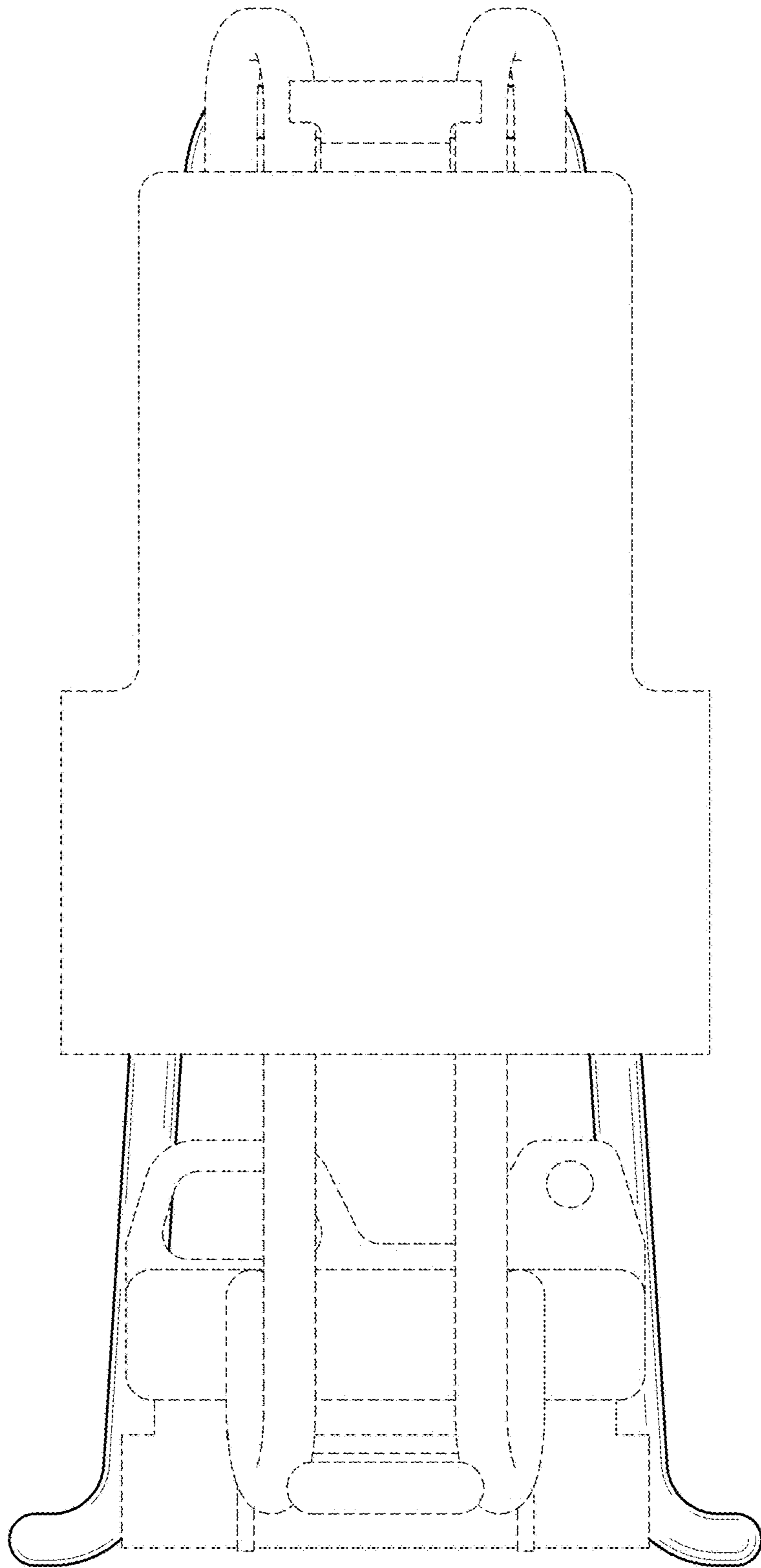

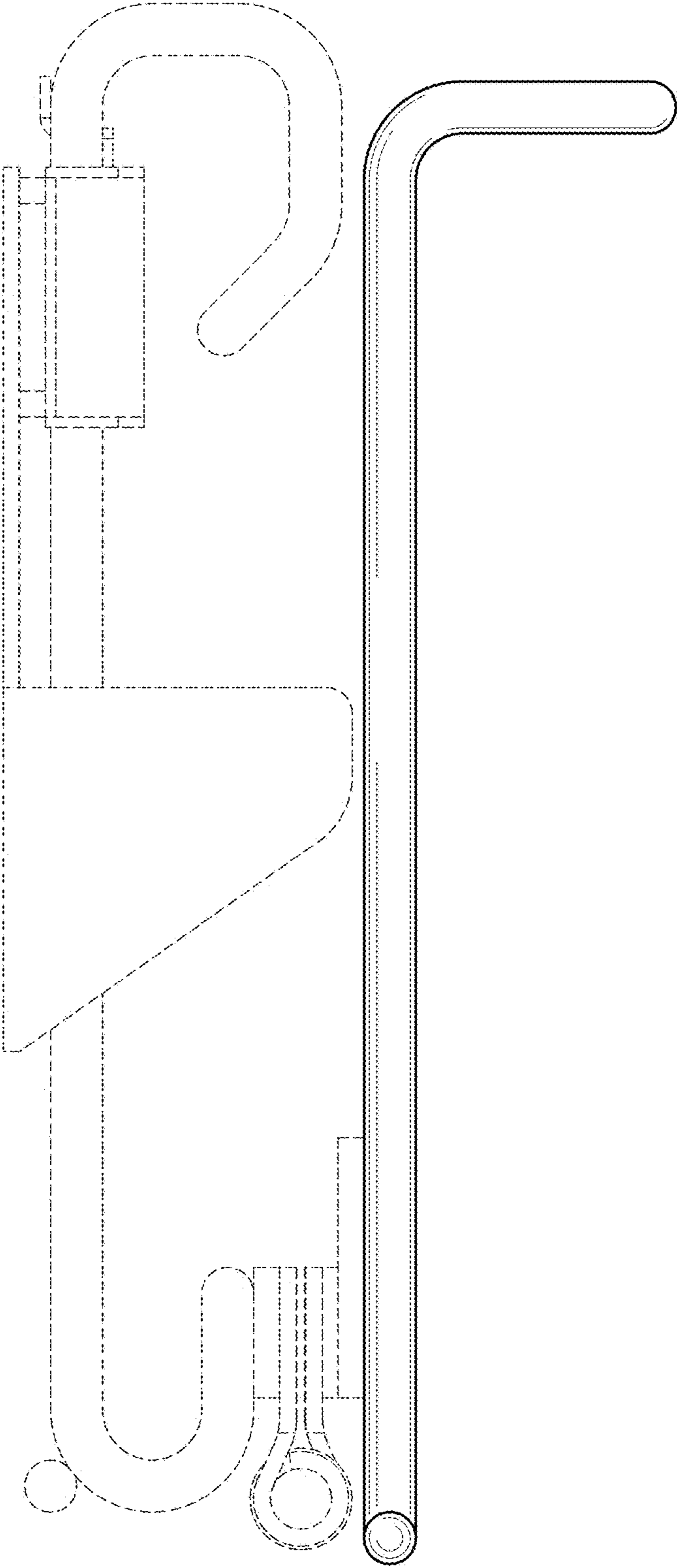

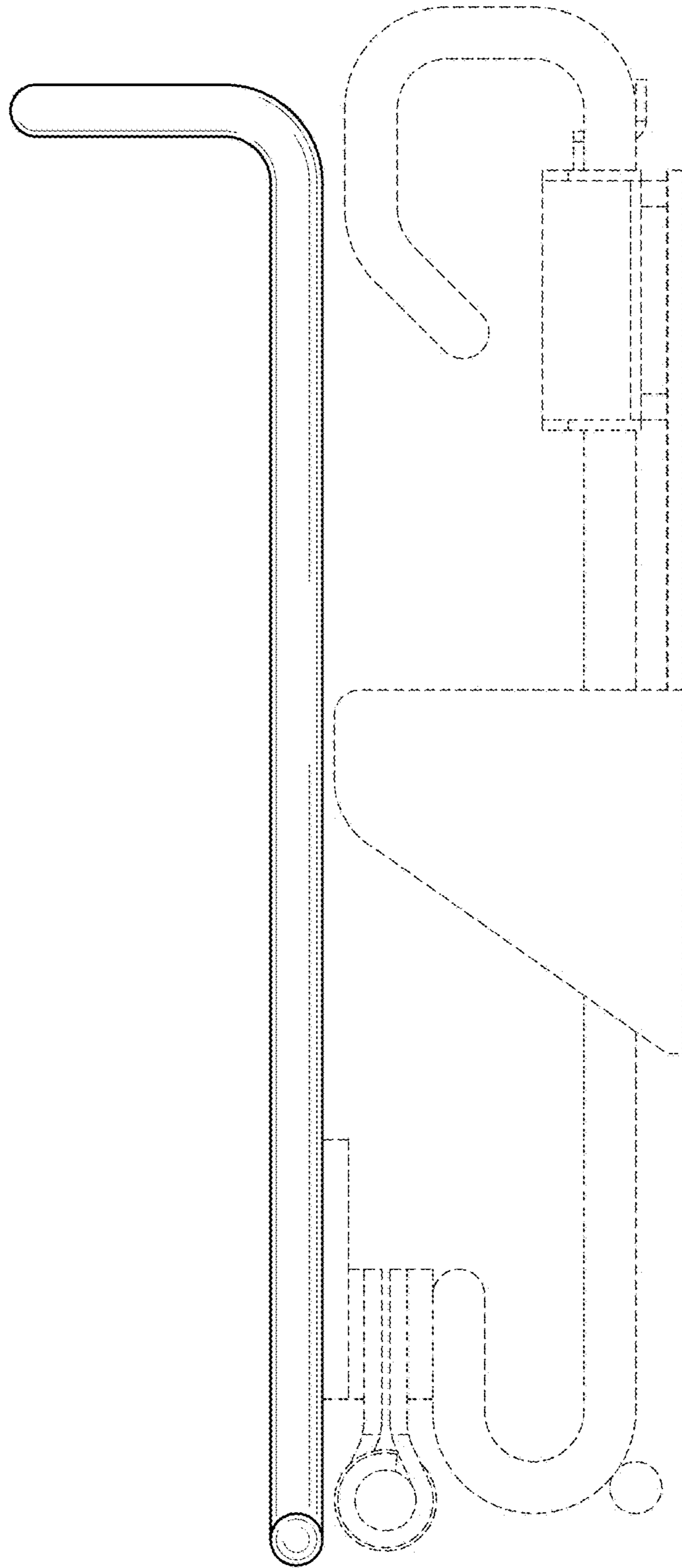

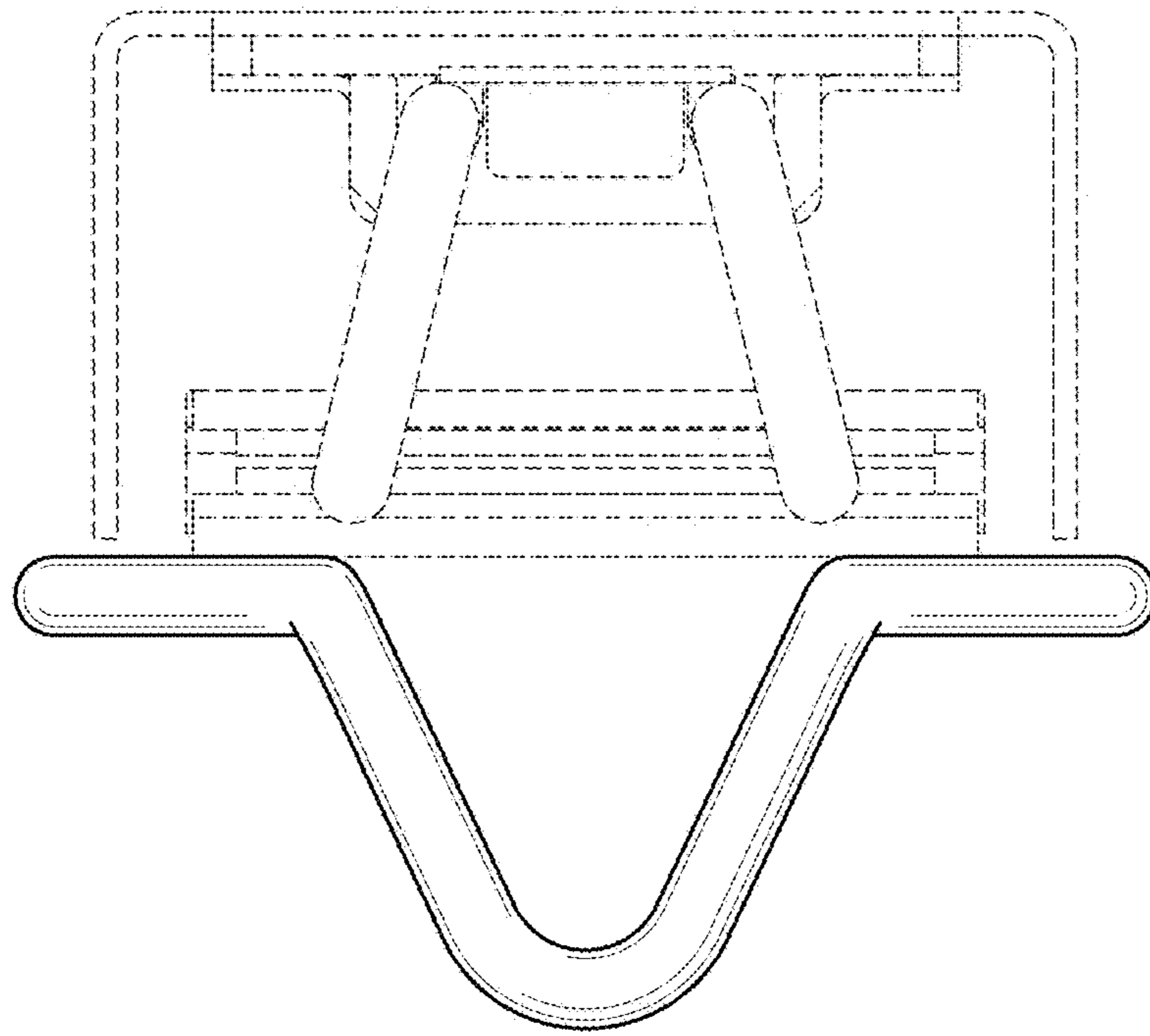

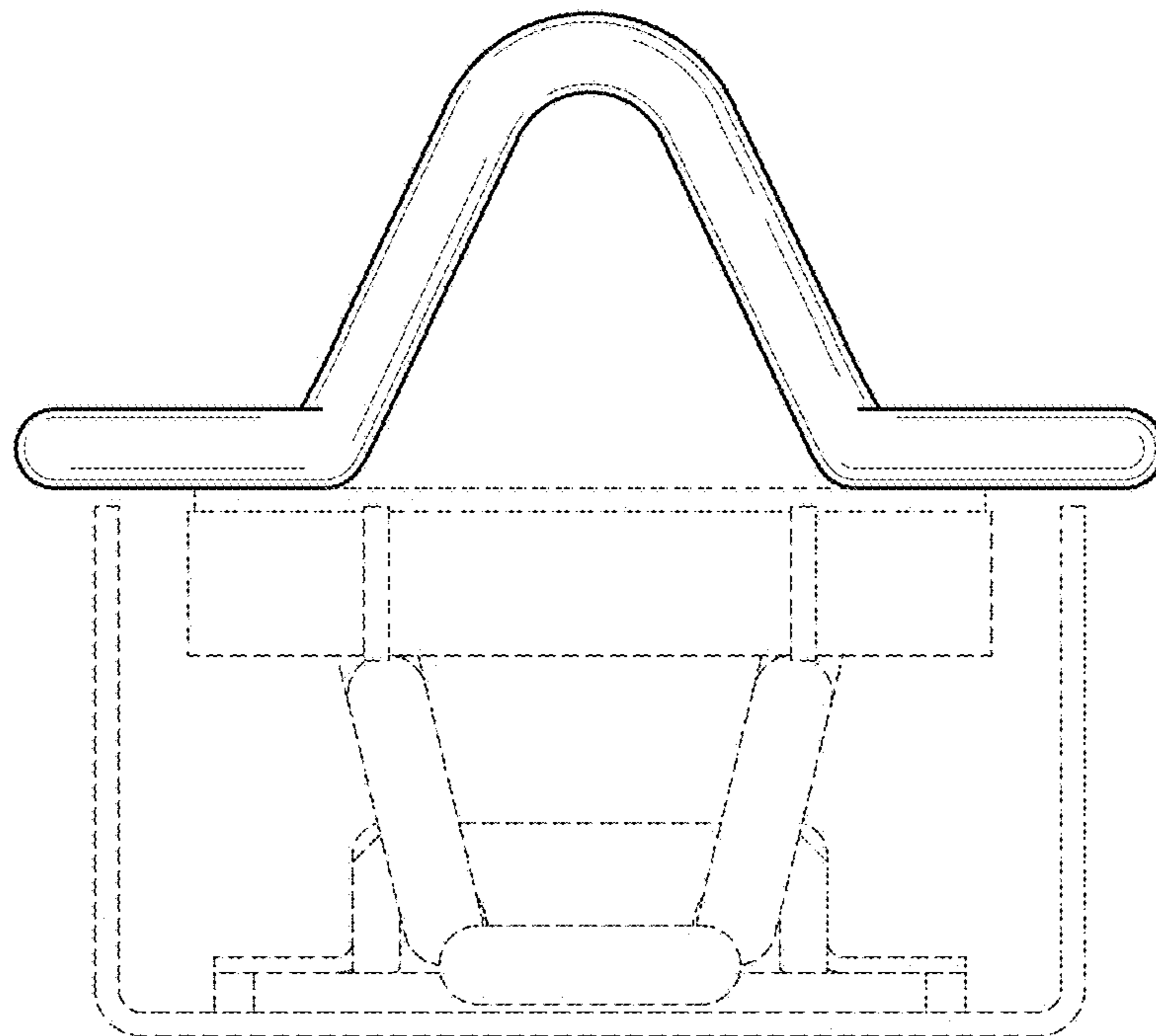

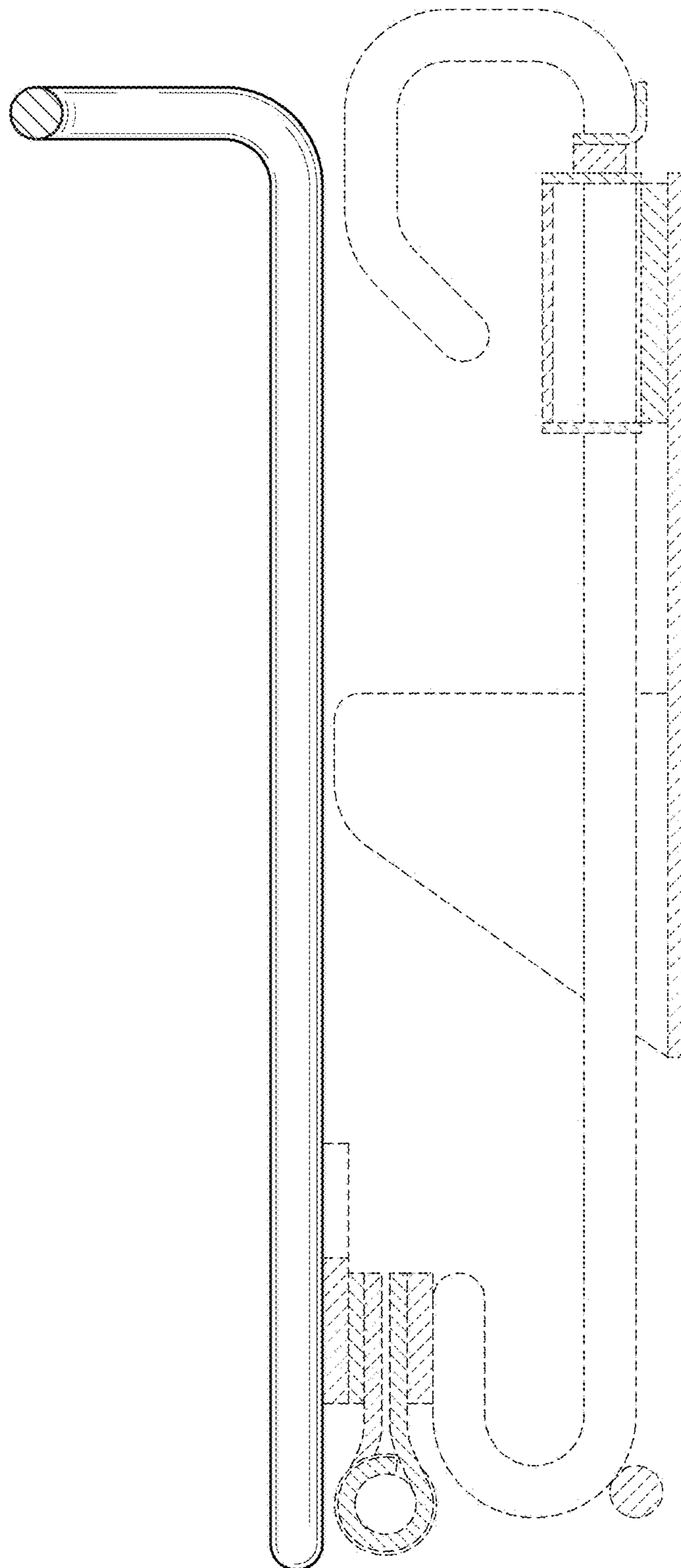

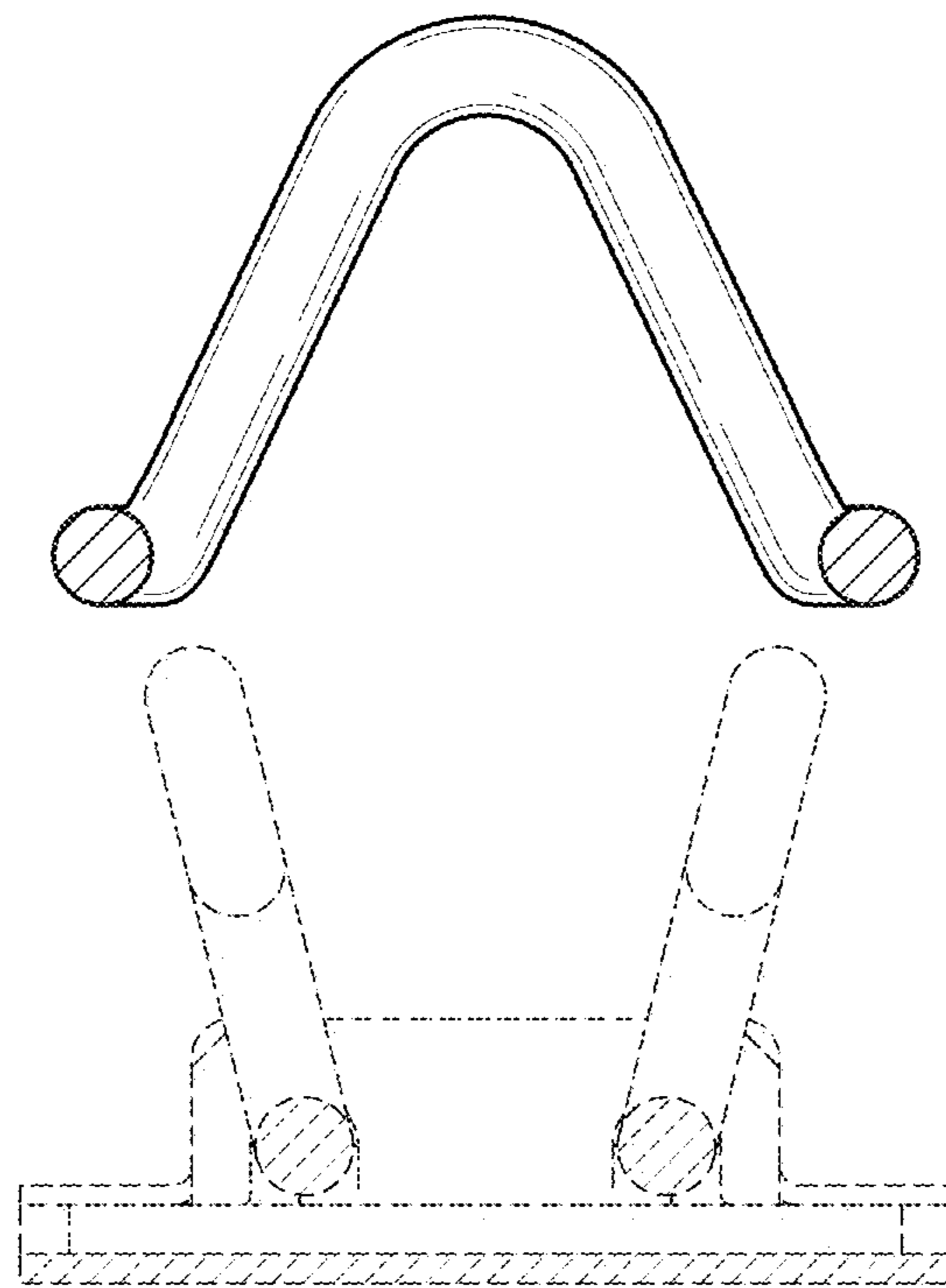

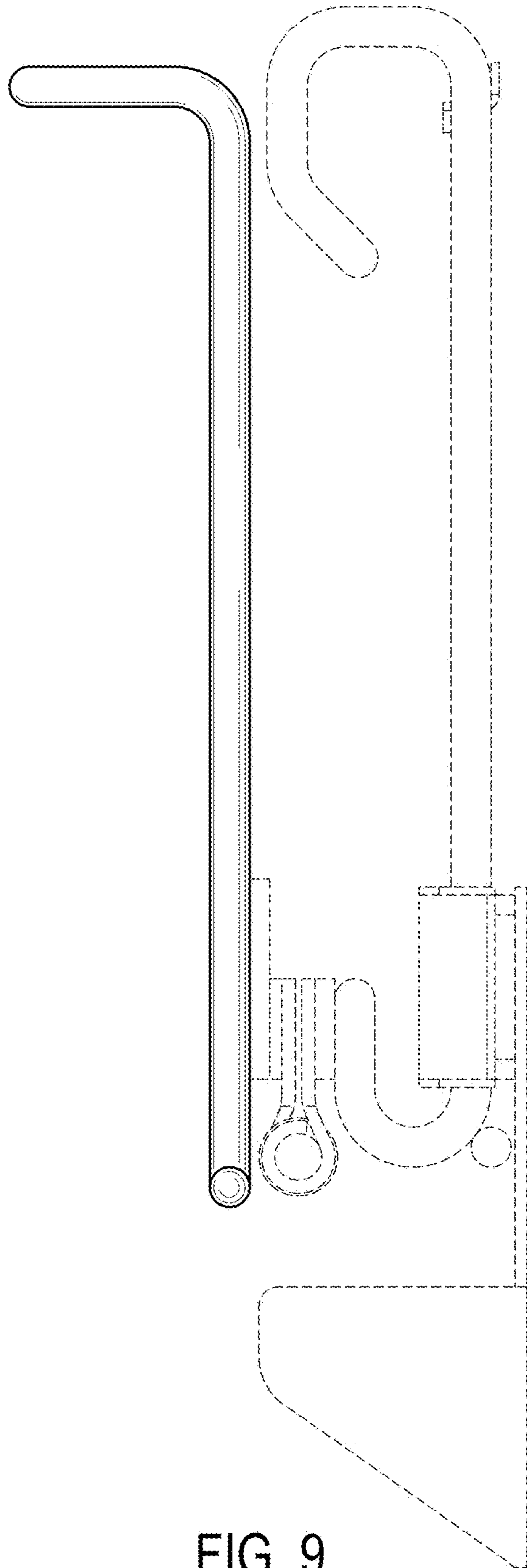

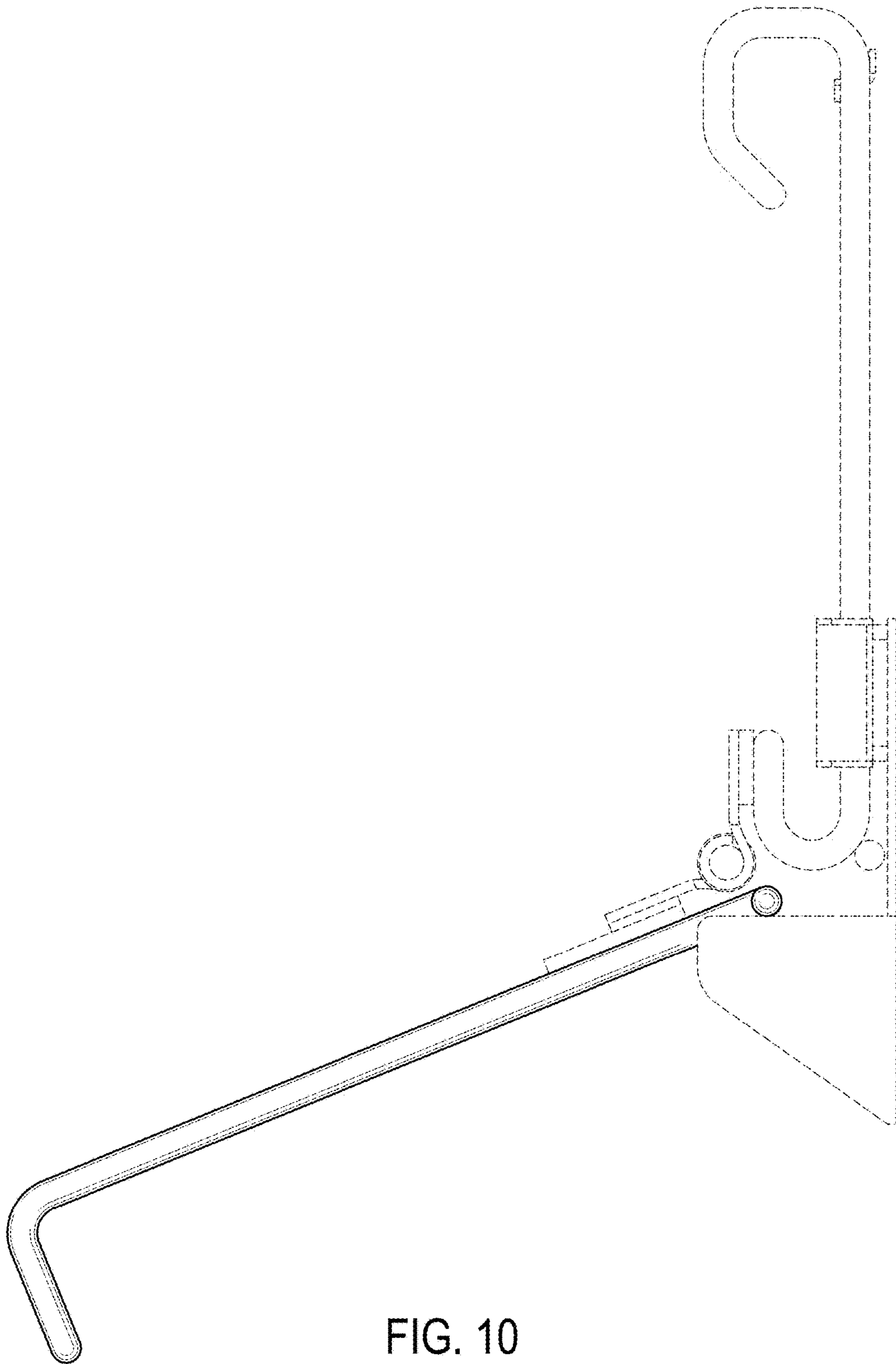

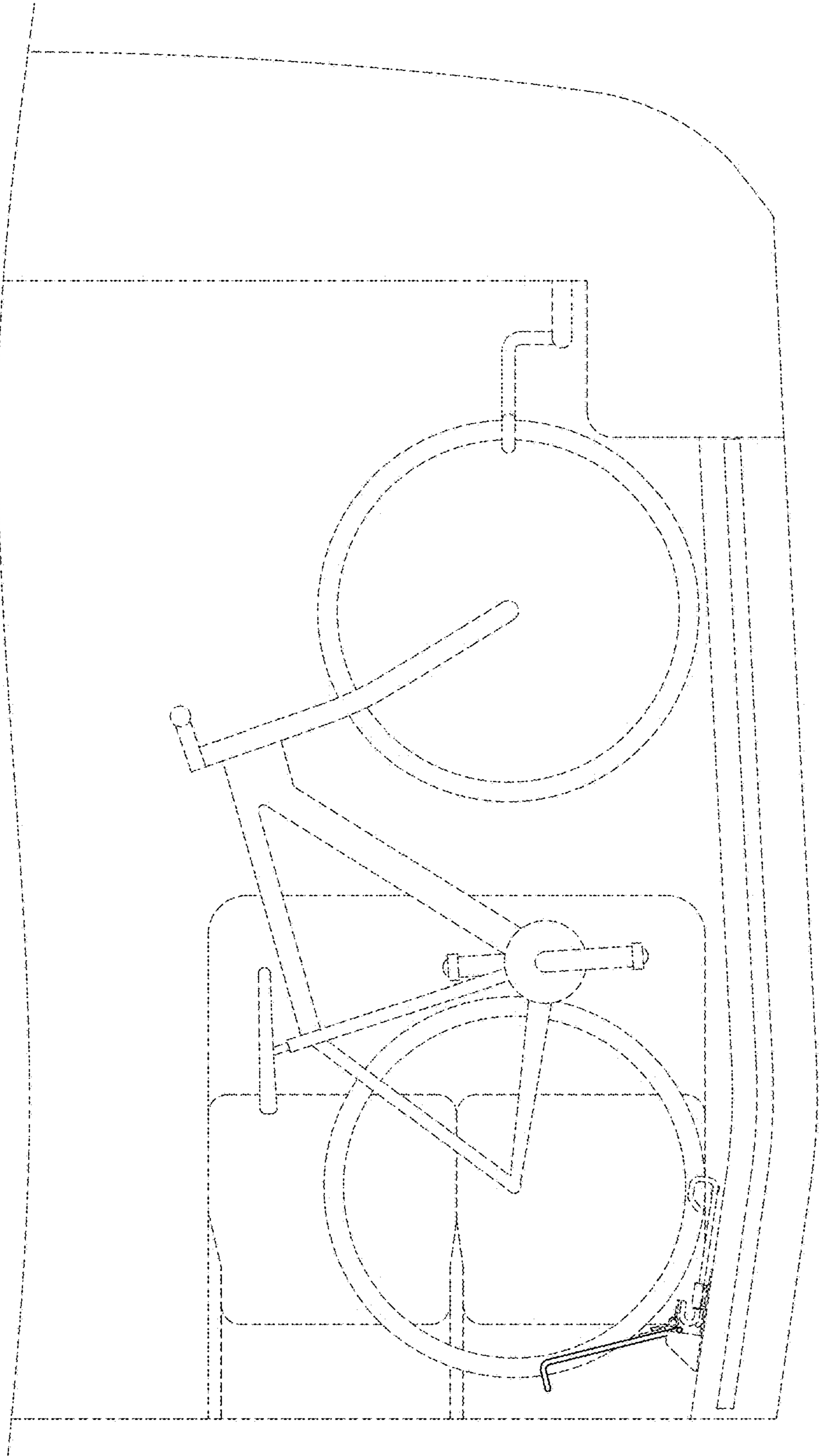
