The ornamental design for a touch pad, as shown and described.

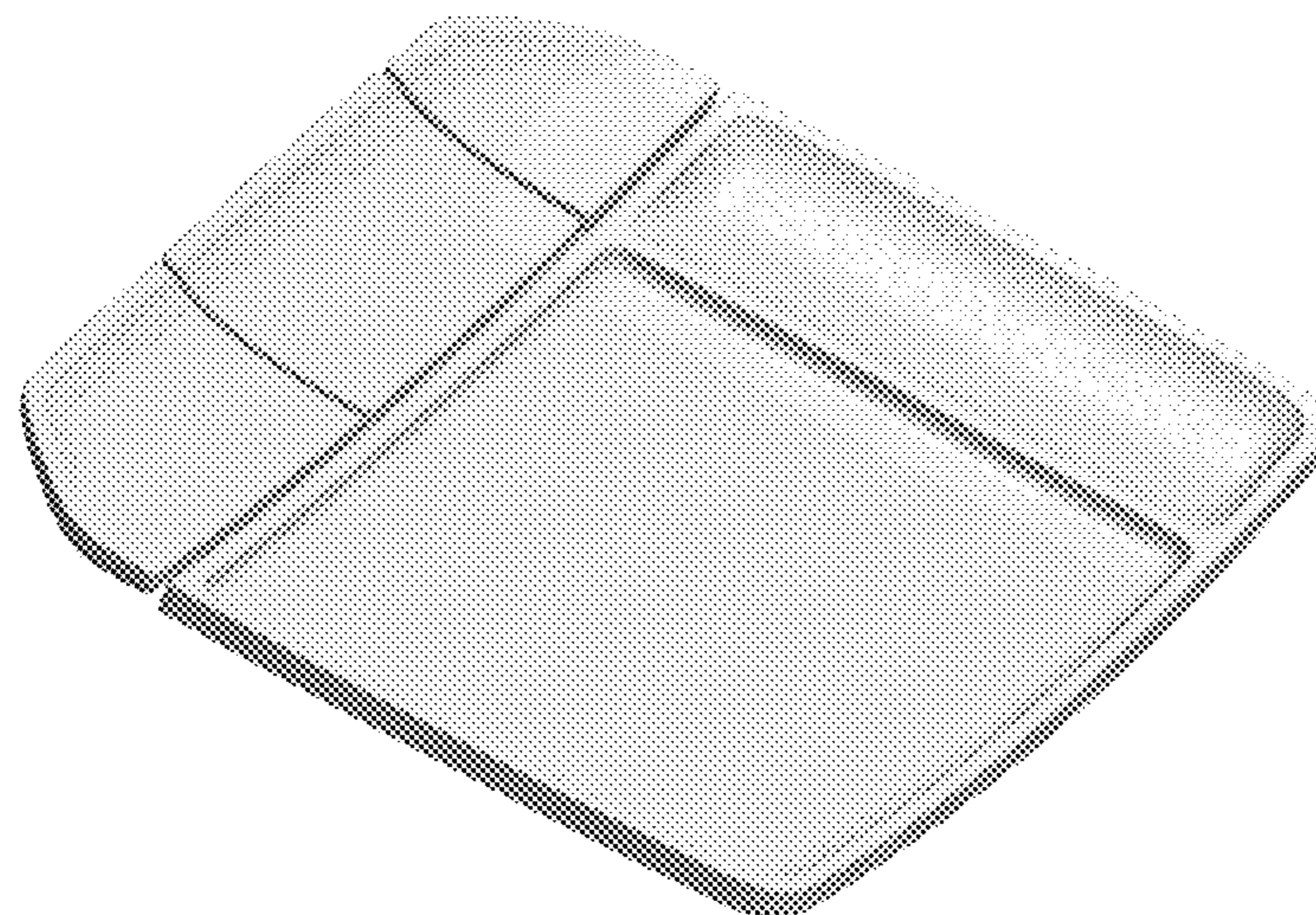
DESCRIPTION

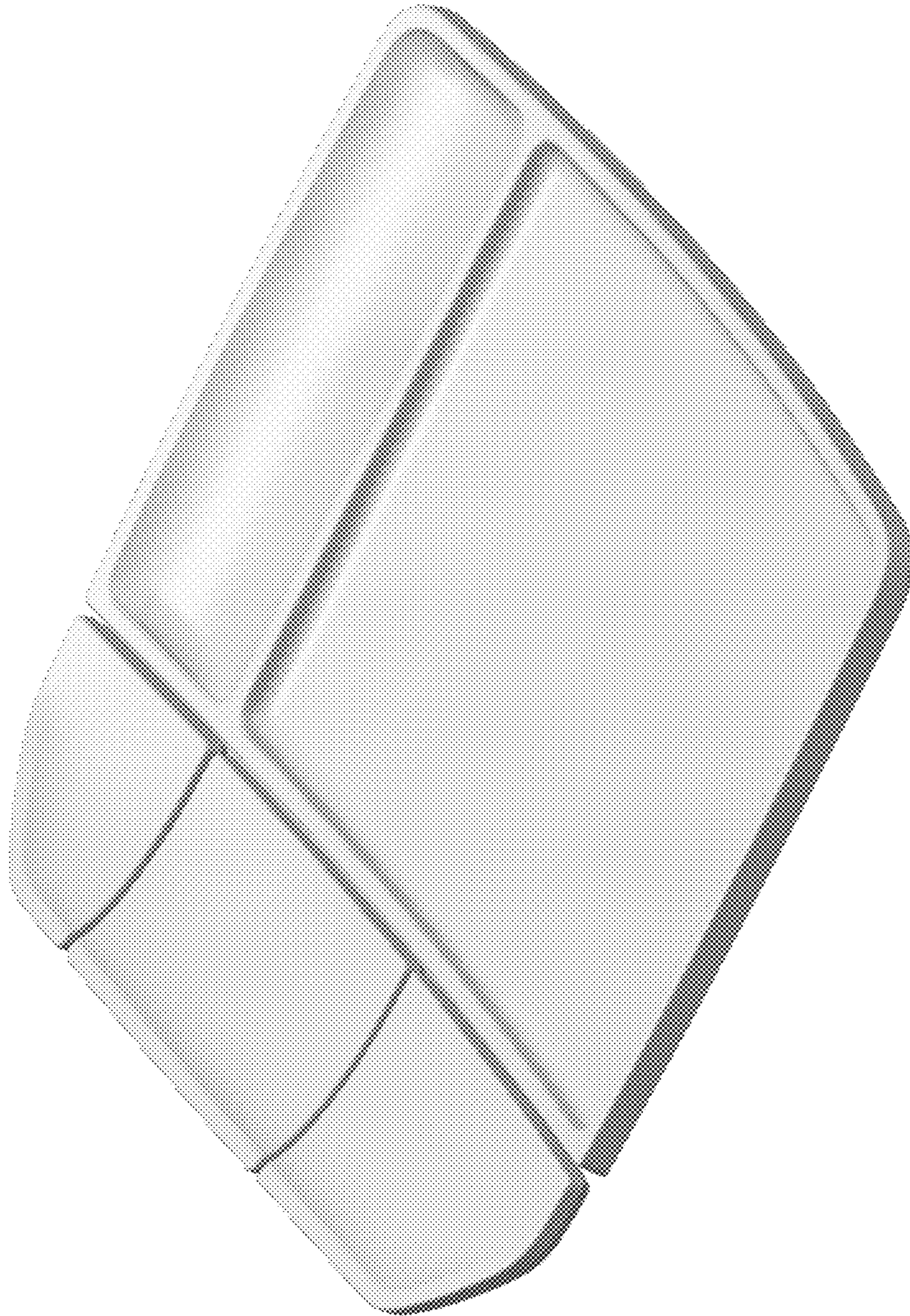

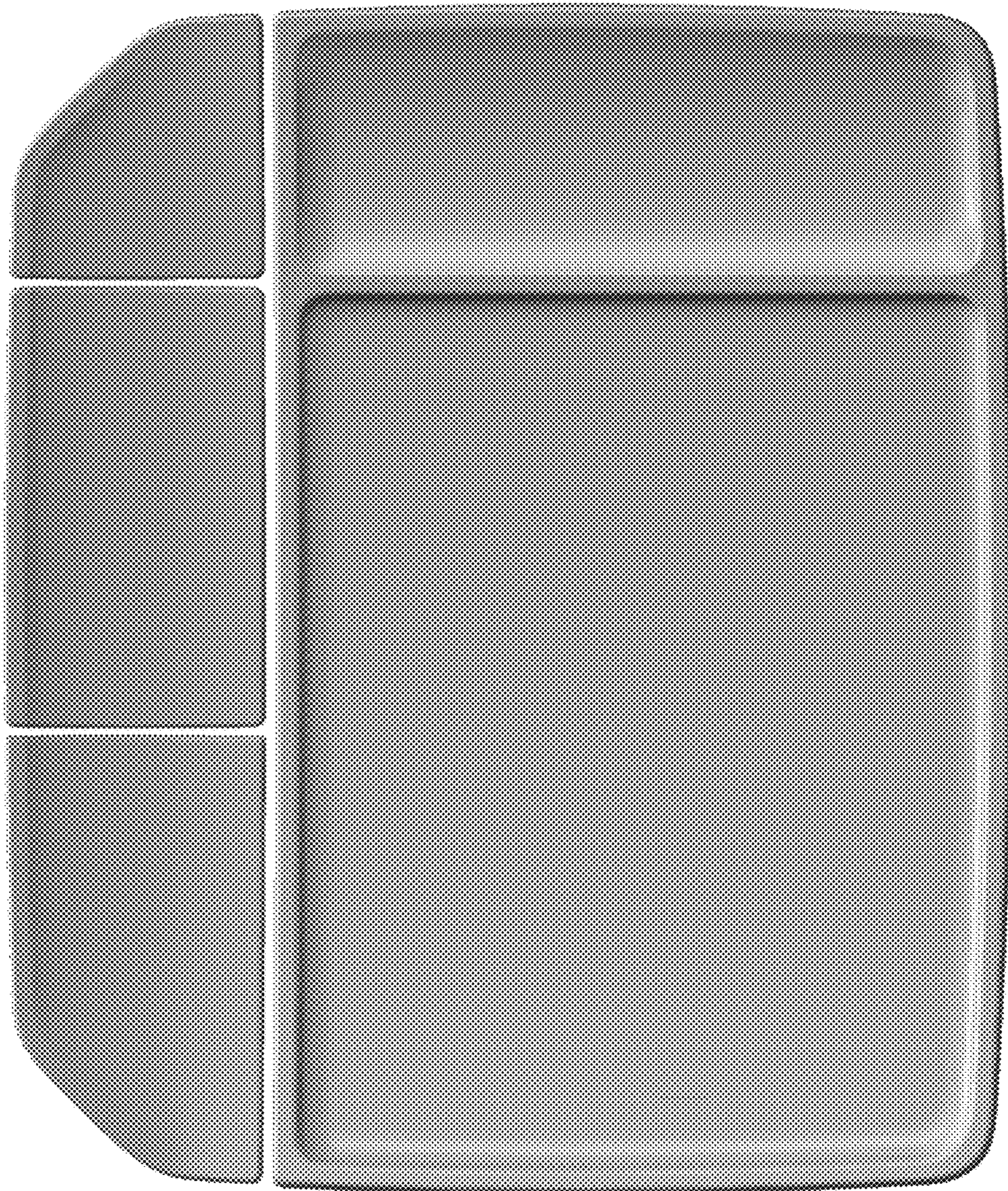

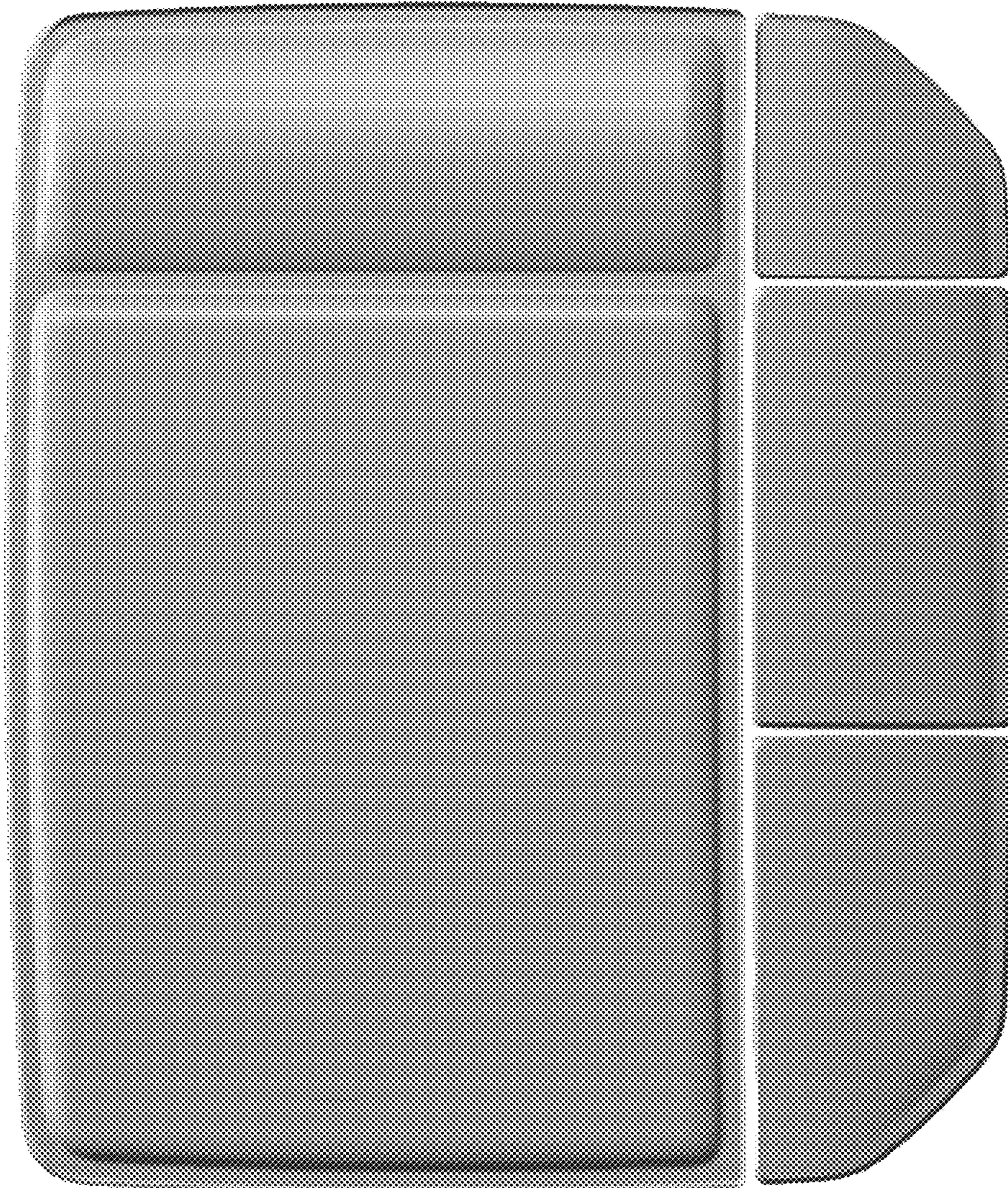

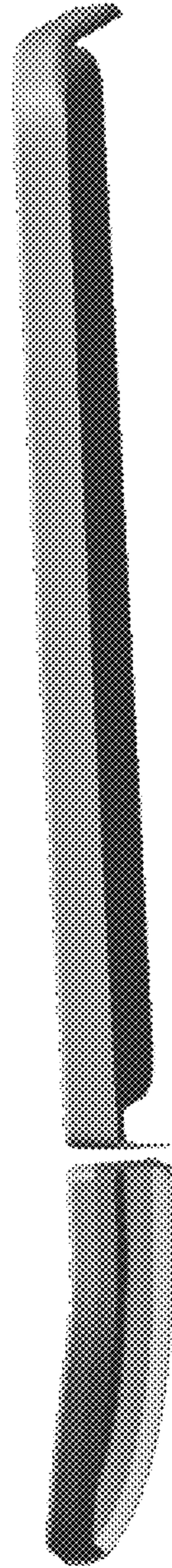

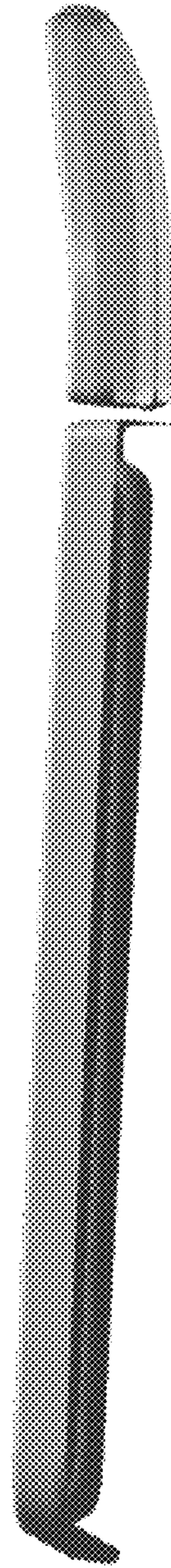

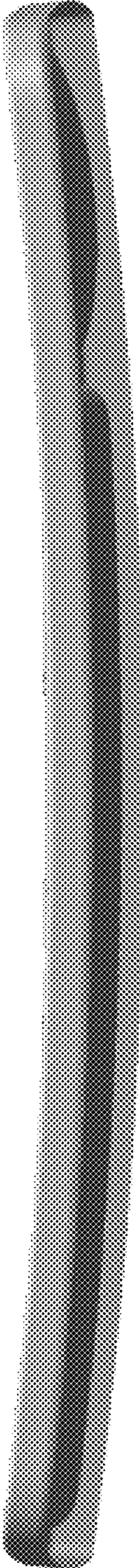

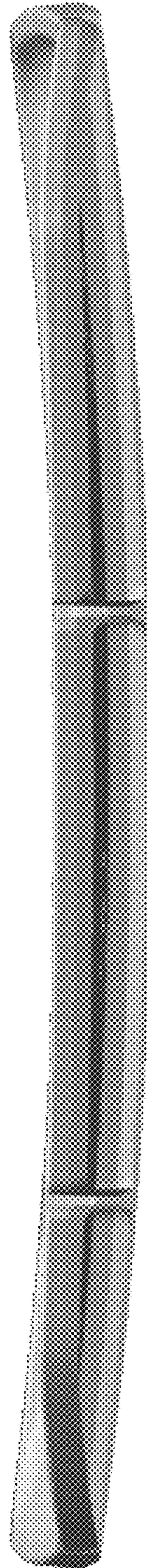
