DESCRIPTION

FIG. 1 is a front perspective view of the front, right, and top sides of distribution board showing our new design;

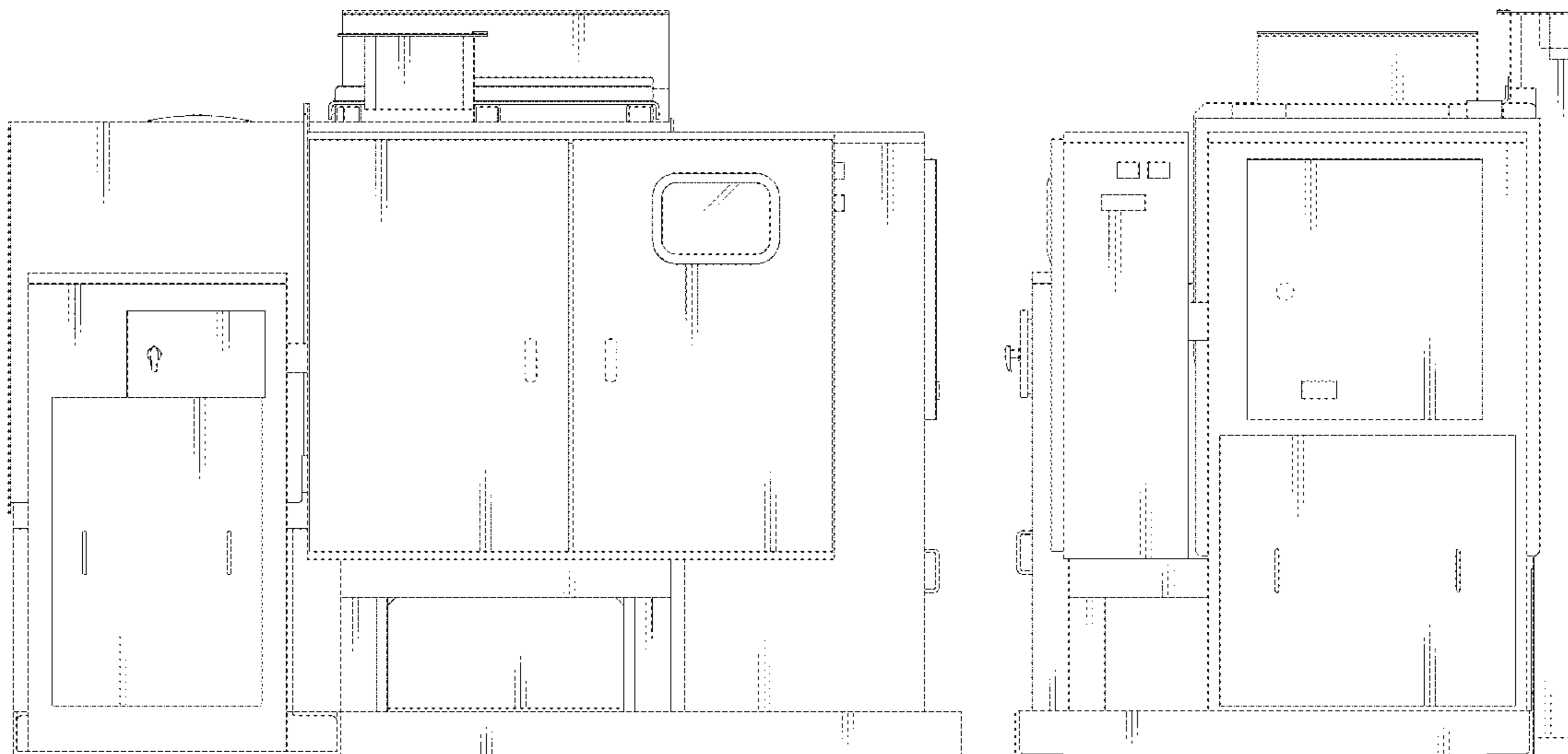

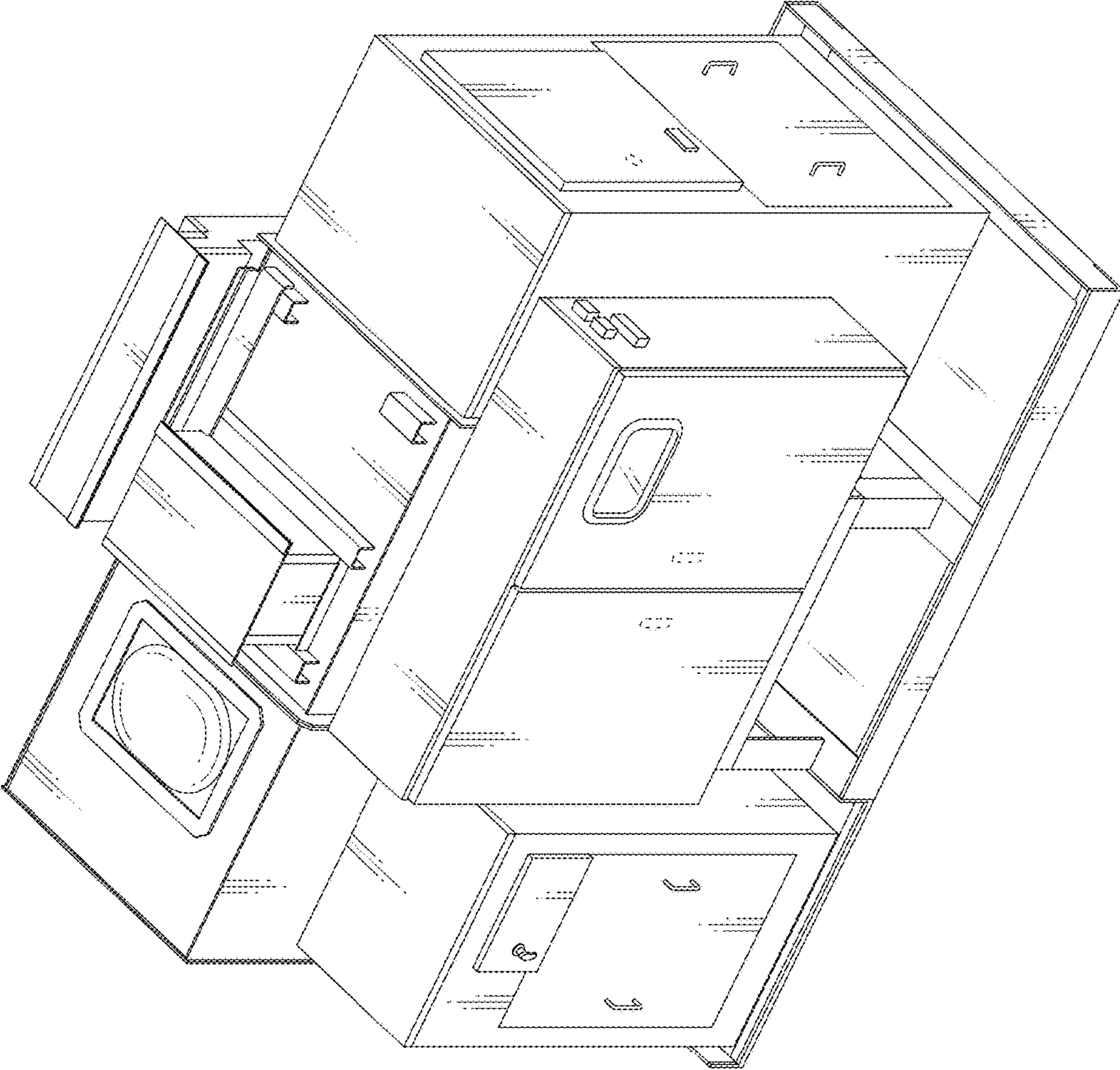

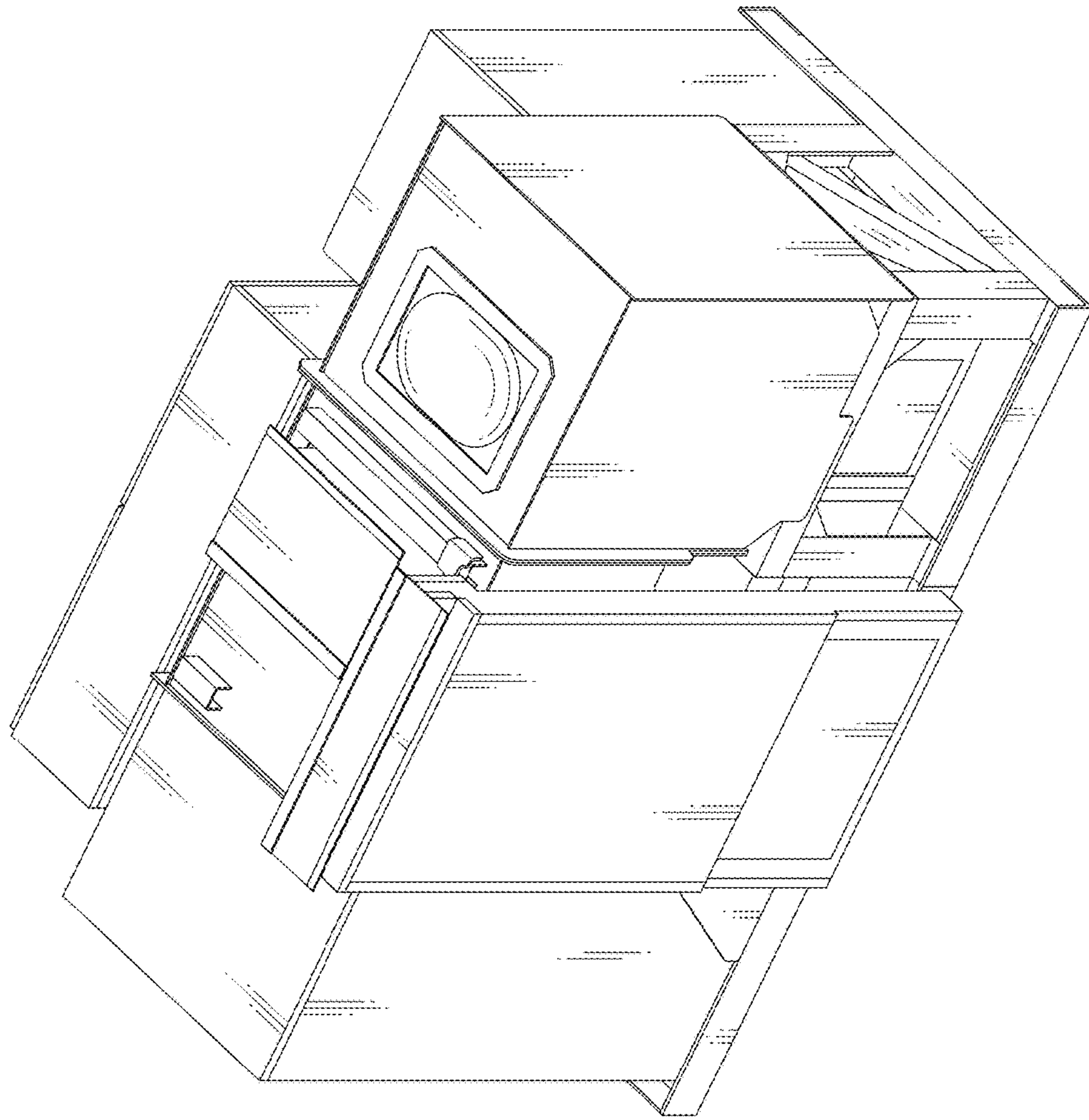

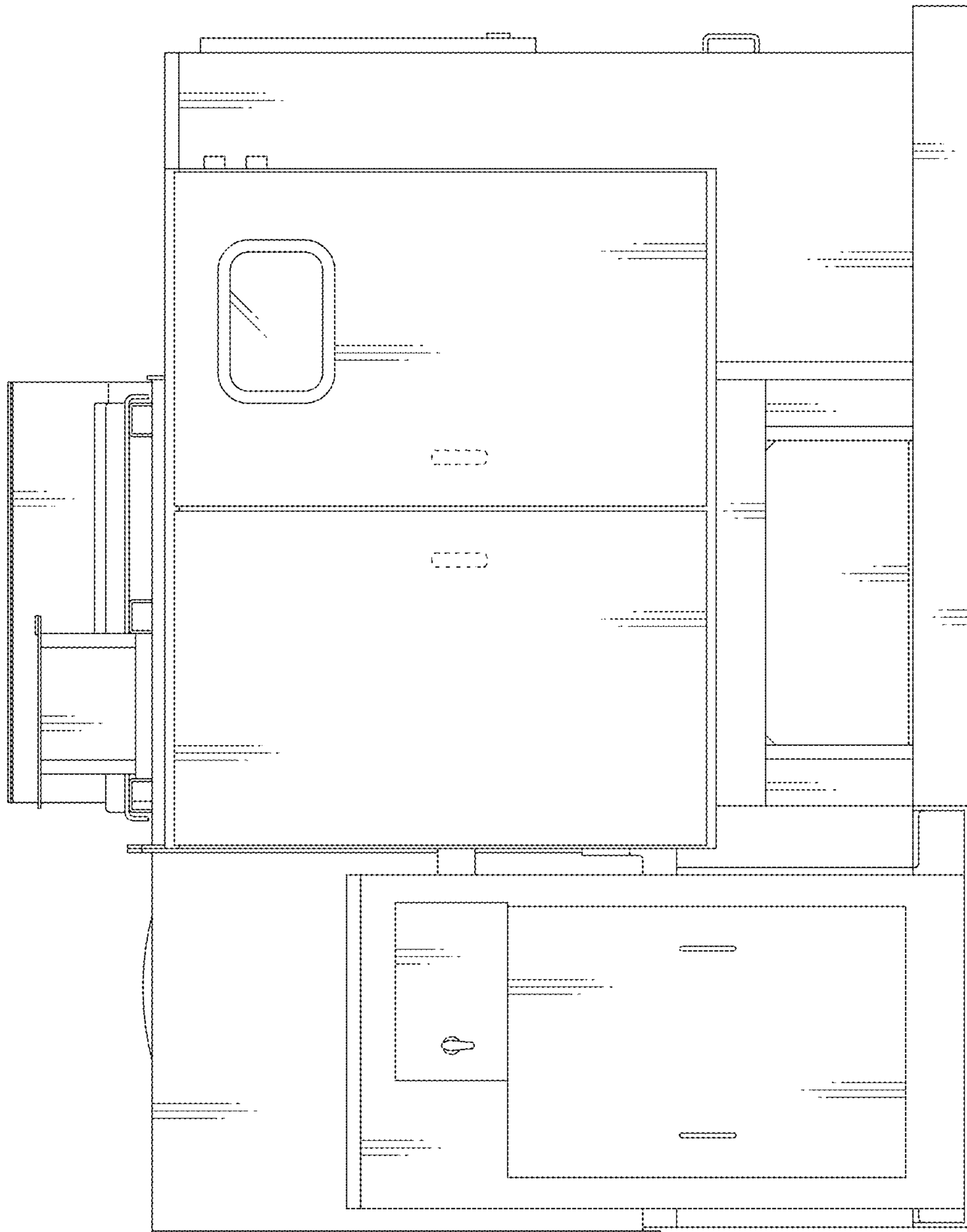

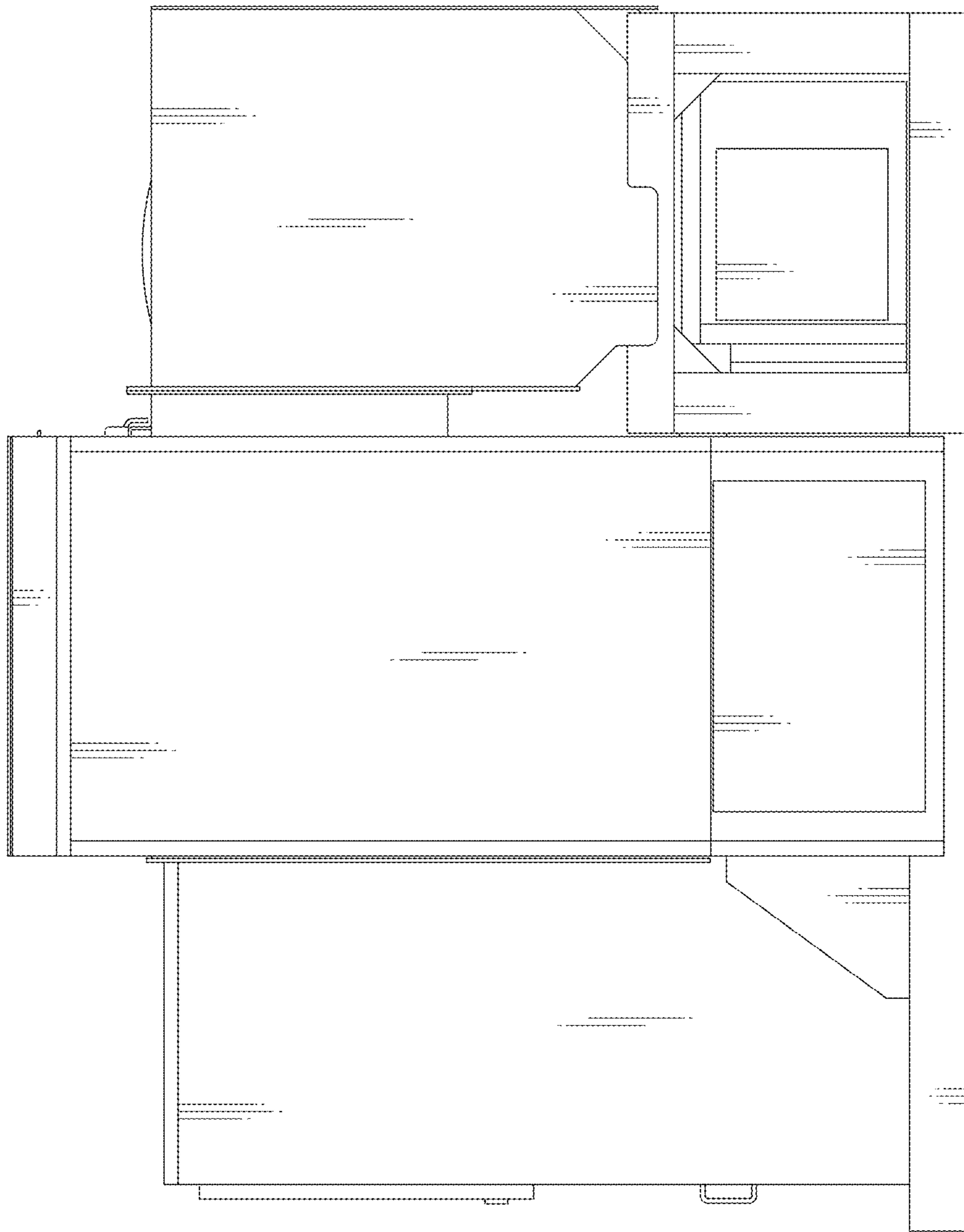

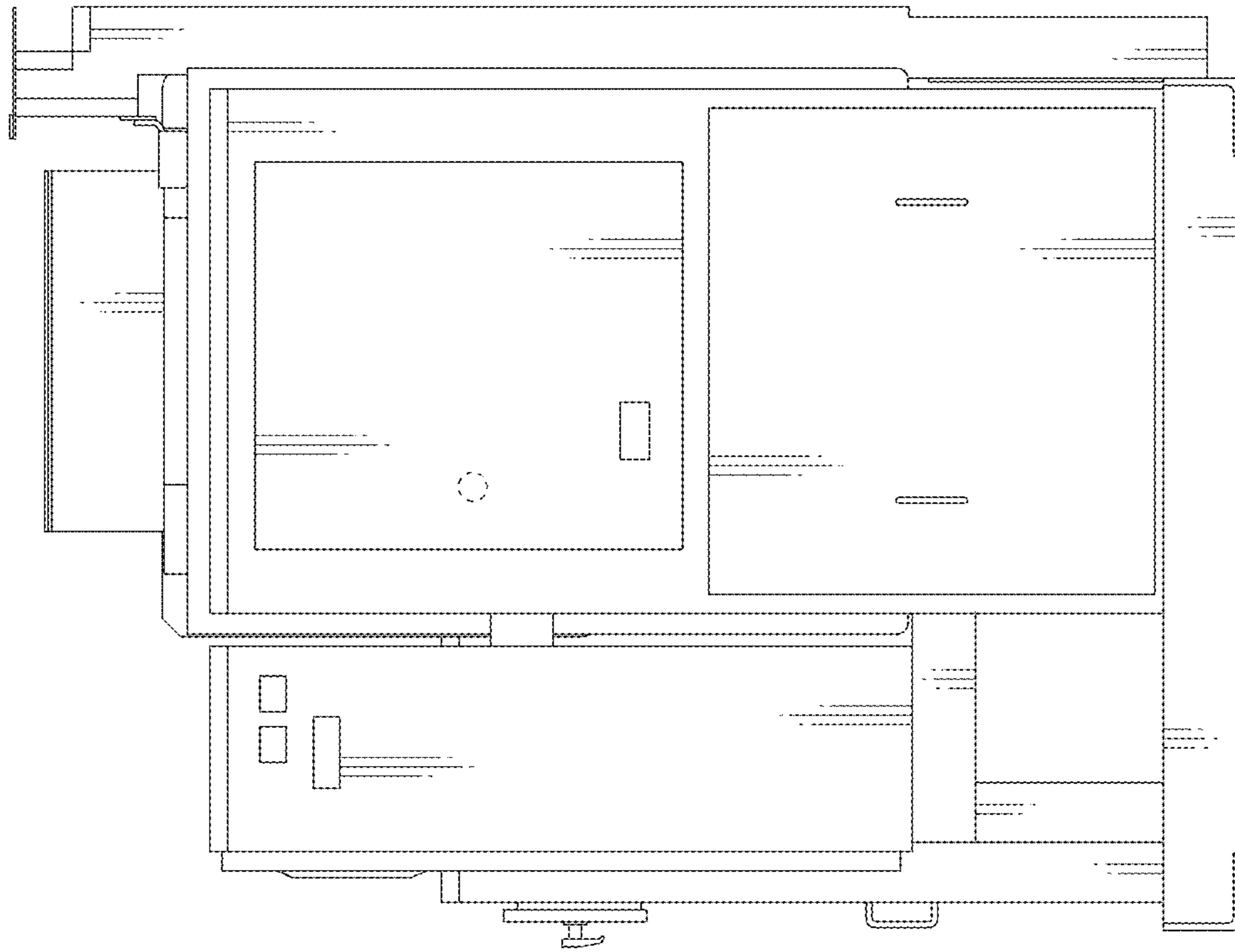

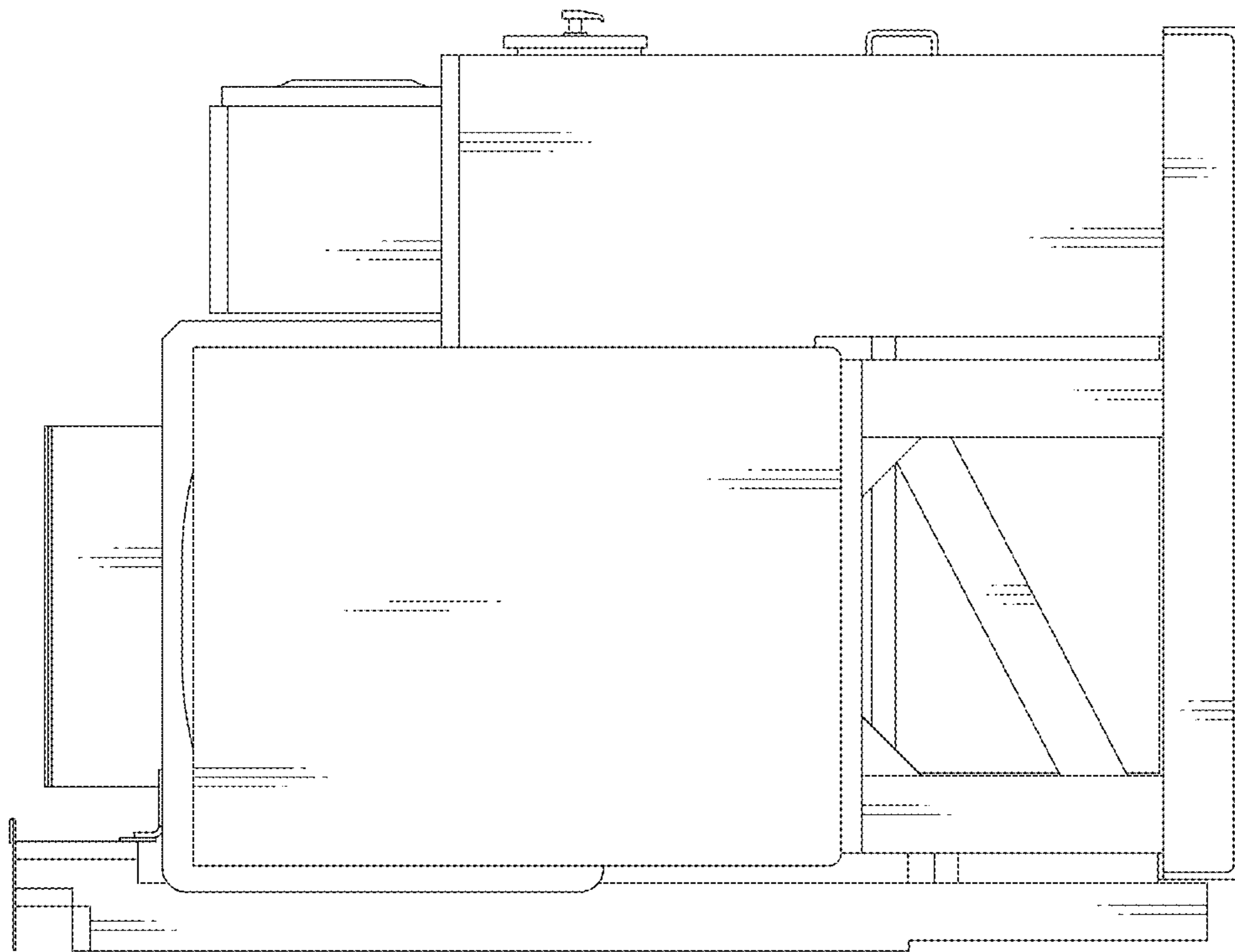

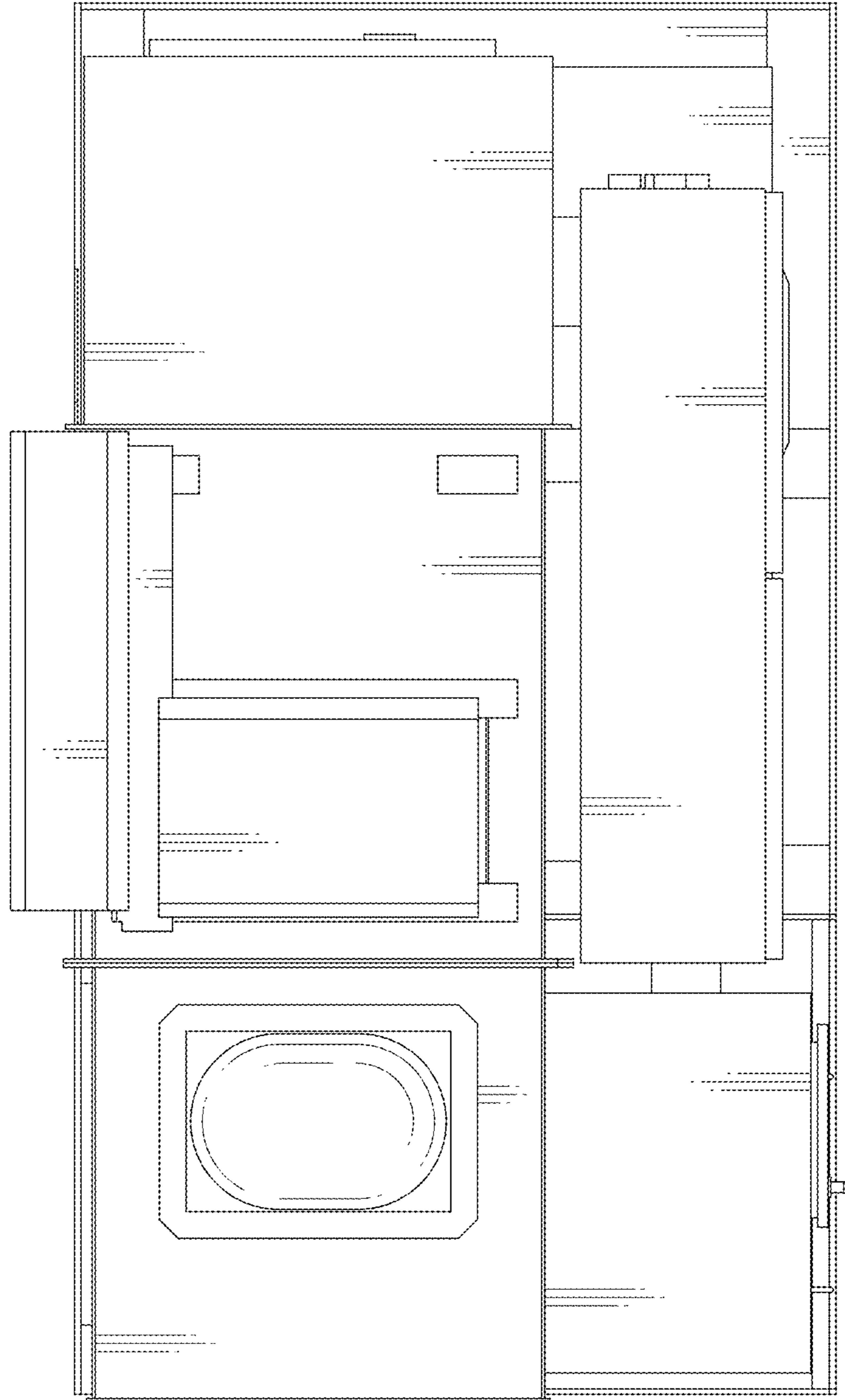
