(57) **CLAIM**

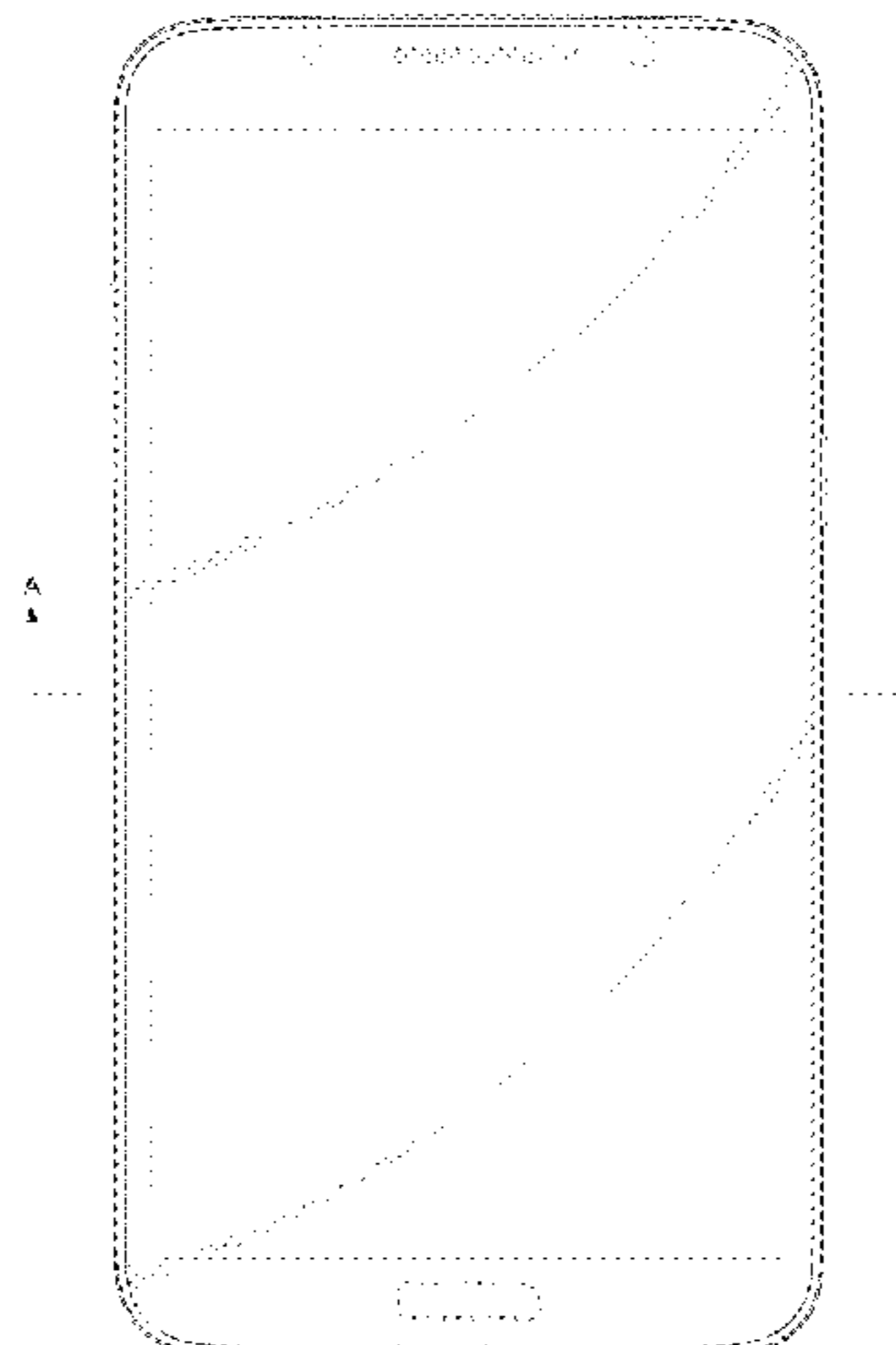
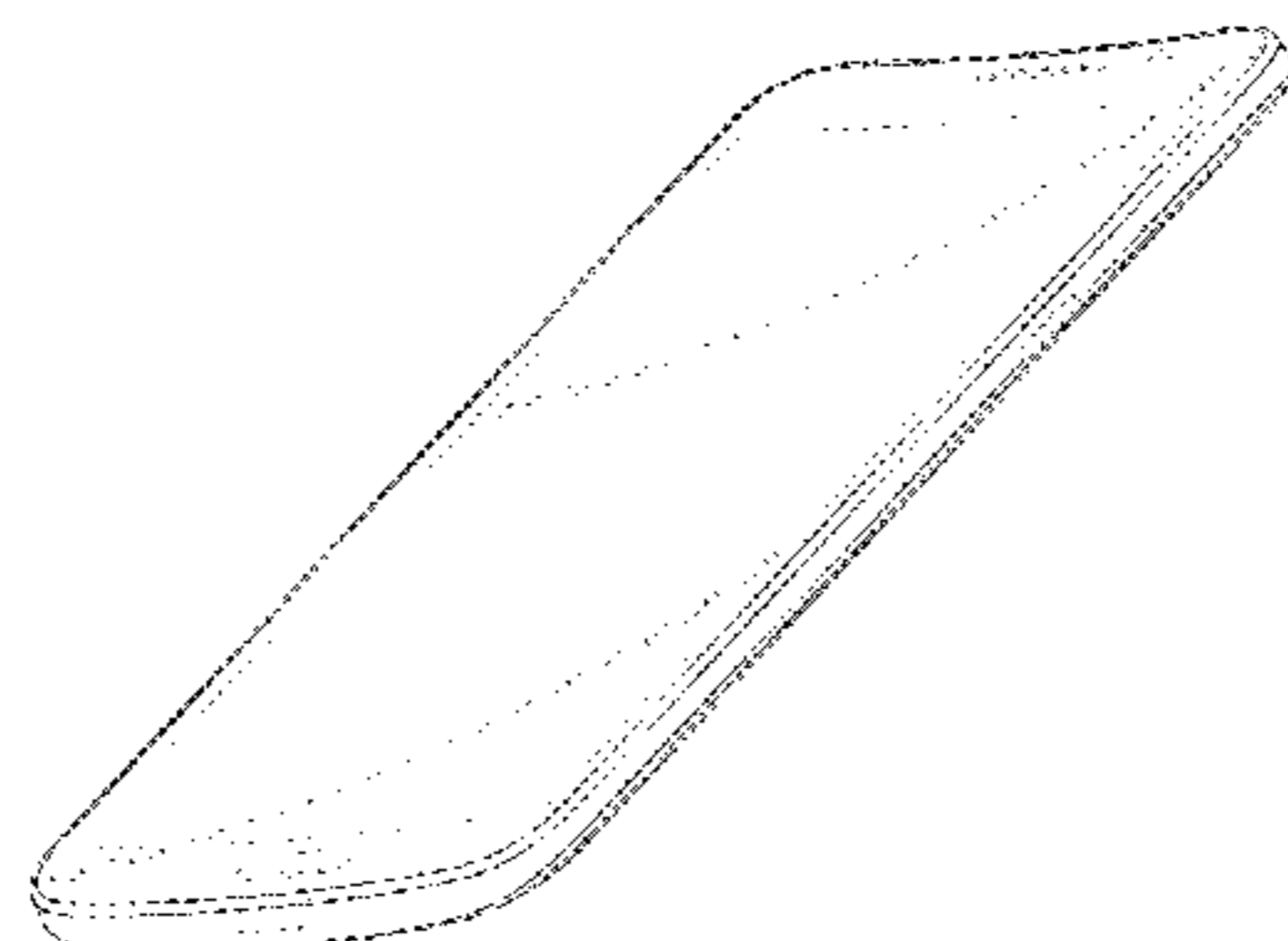
We claim the ornamental design for an electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an electronic device showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left-side view thereof;  
FIG. 5 is a right-side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is a cross-sectional view taken along the line A-A in FIG. 2.

The broken lines shown in the figures that are immediately adjacent to the shaded areas and define unshaded regions represent the bounds of the claim. All other broken lines, including the features within the broken line boundaries and the broken lines on the front surface to the right and left of the speaker are directed to environment. The broken lines form no part of the claimed design.

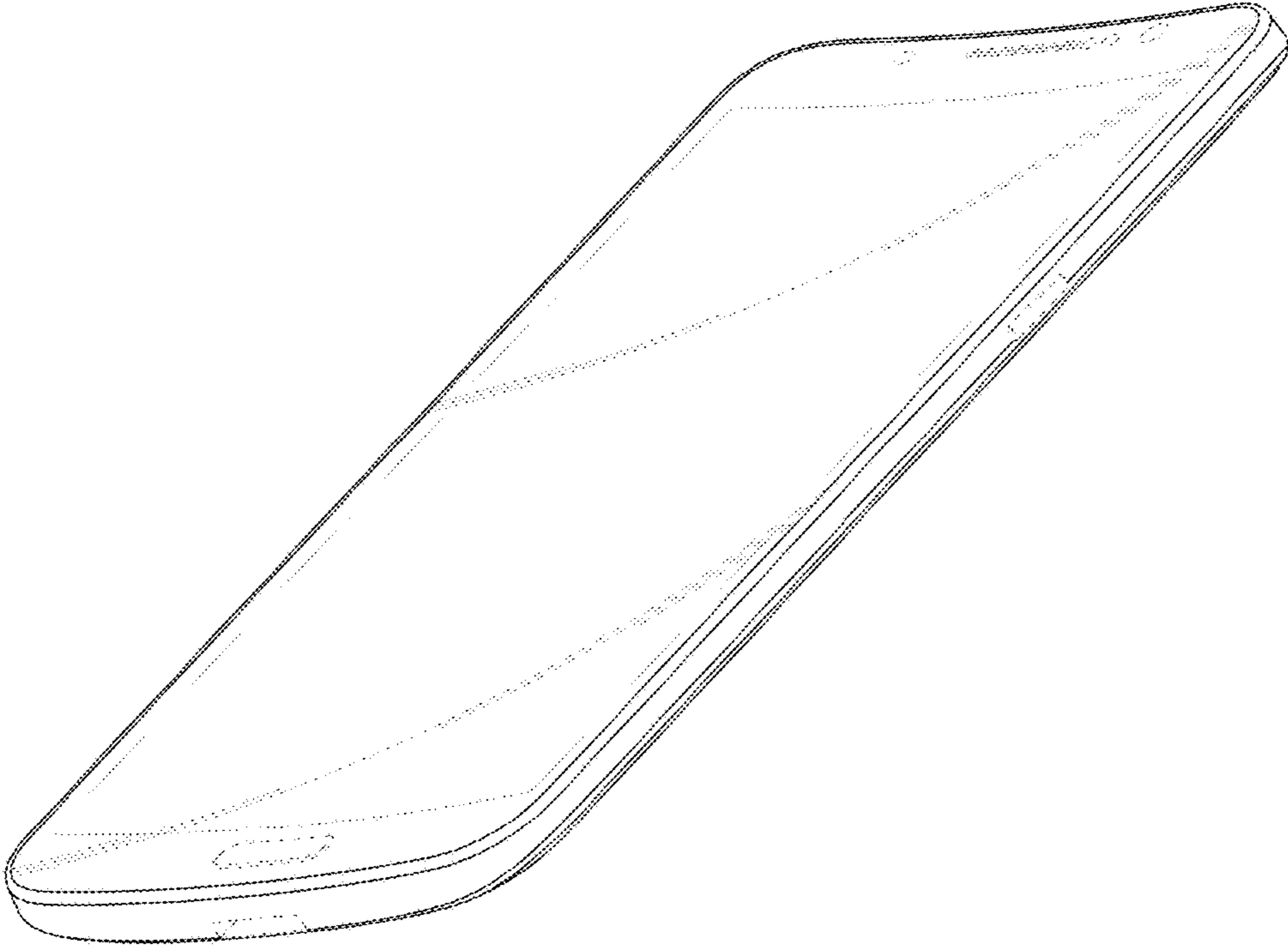

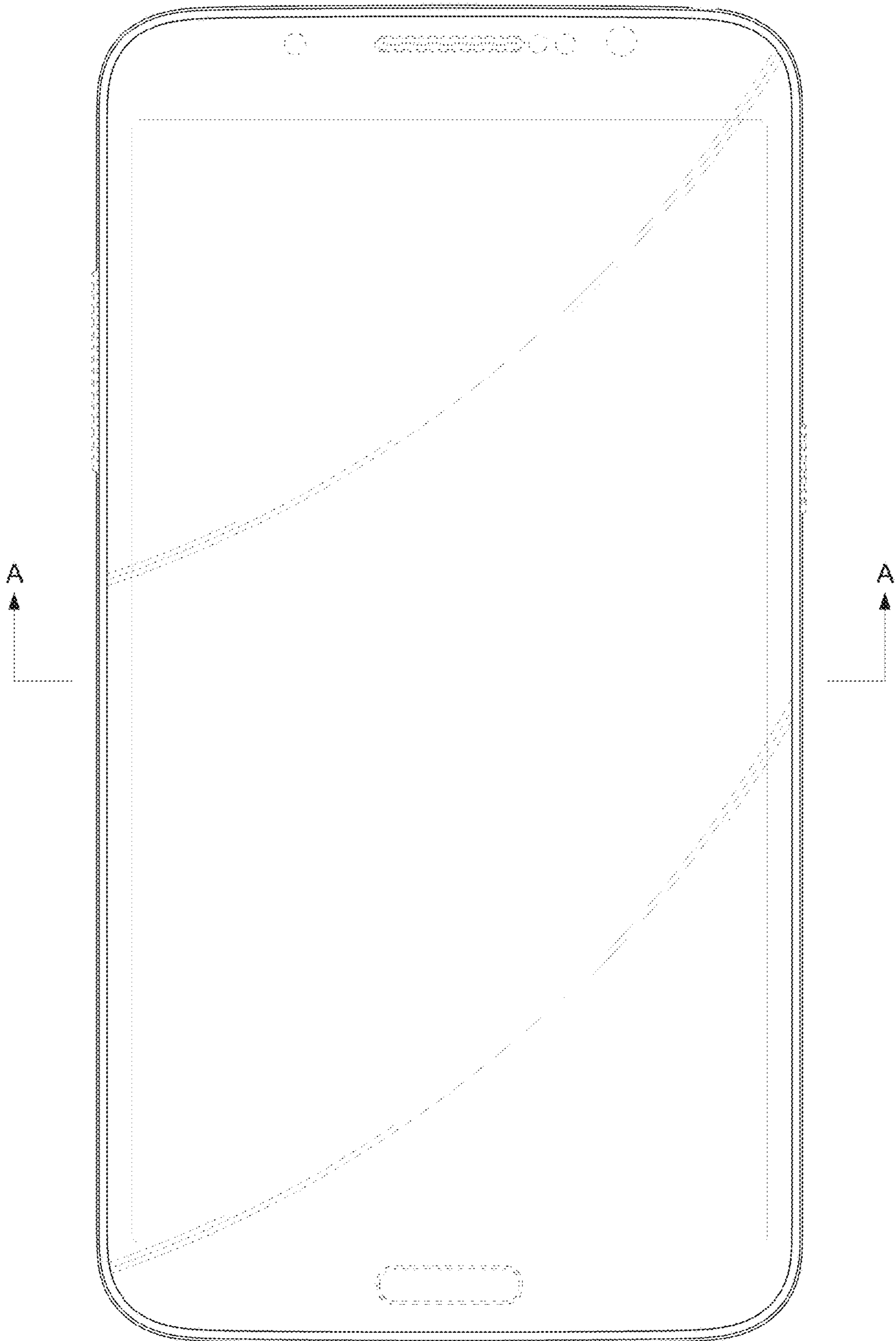

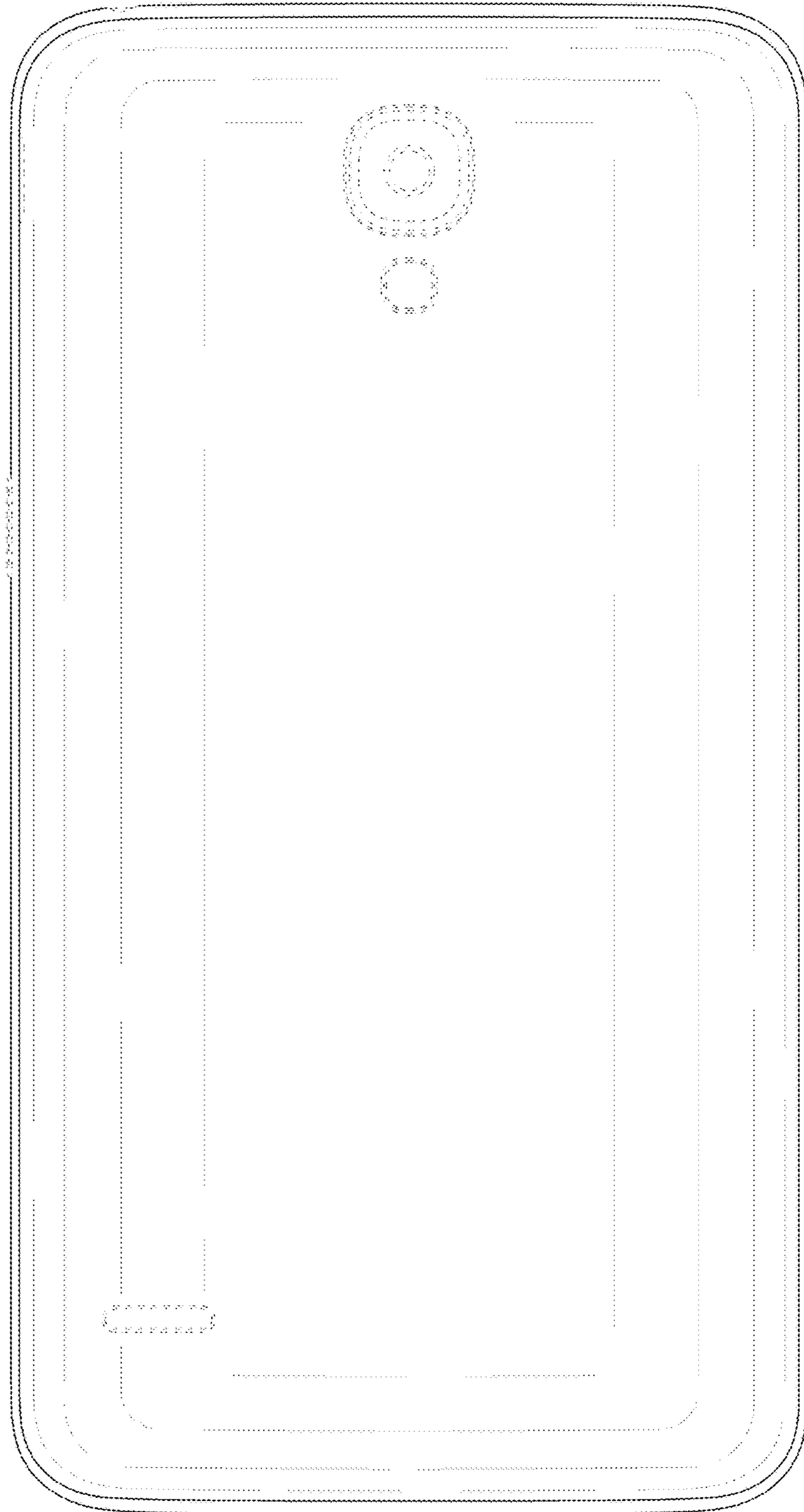

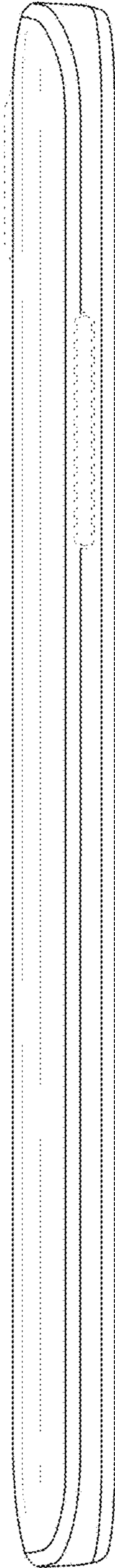

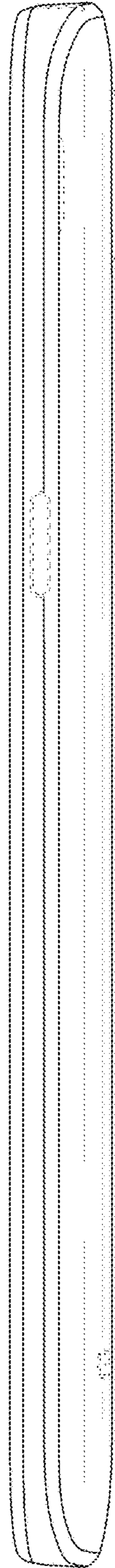

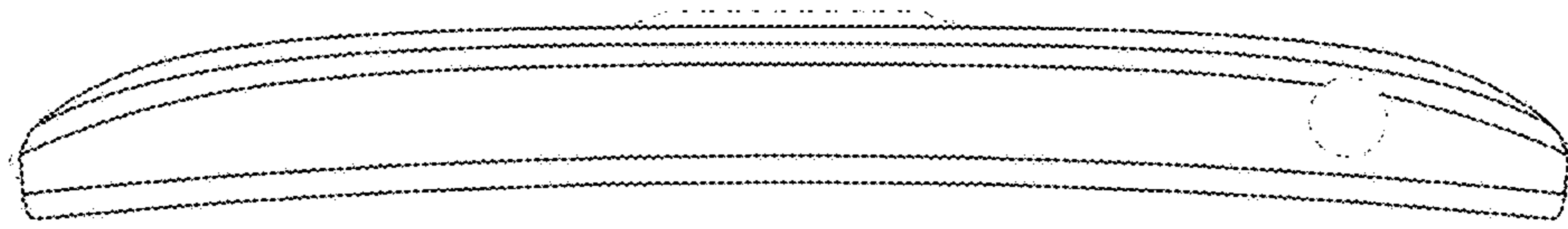

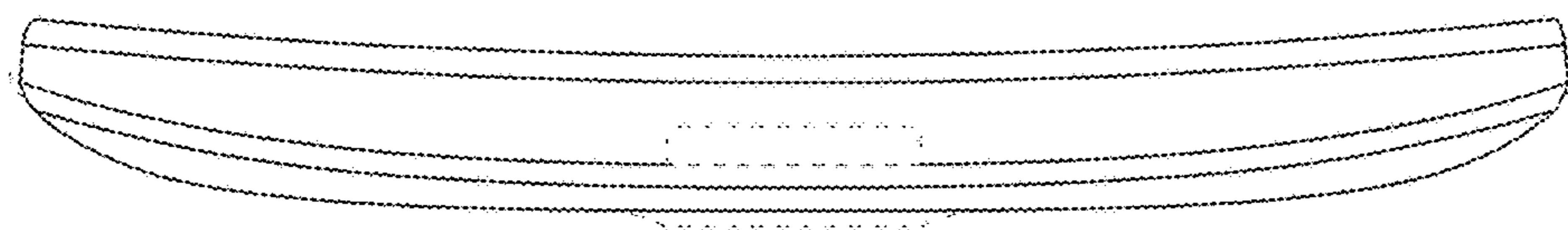
