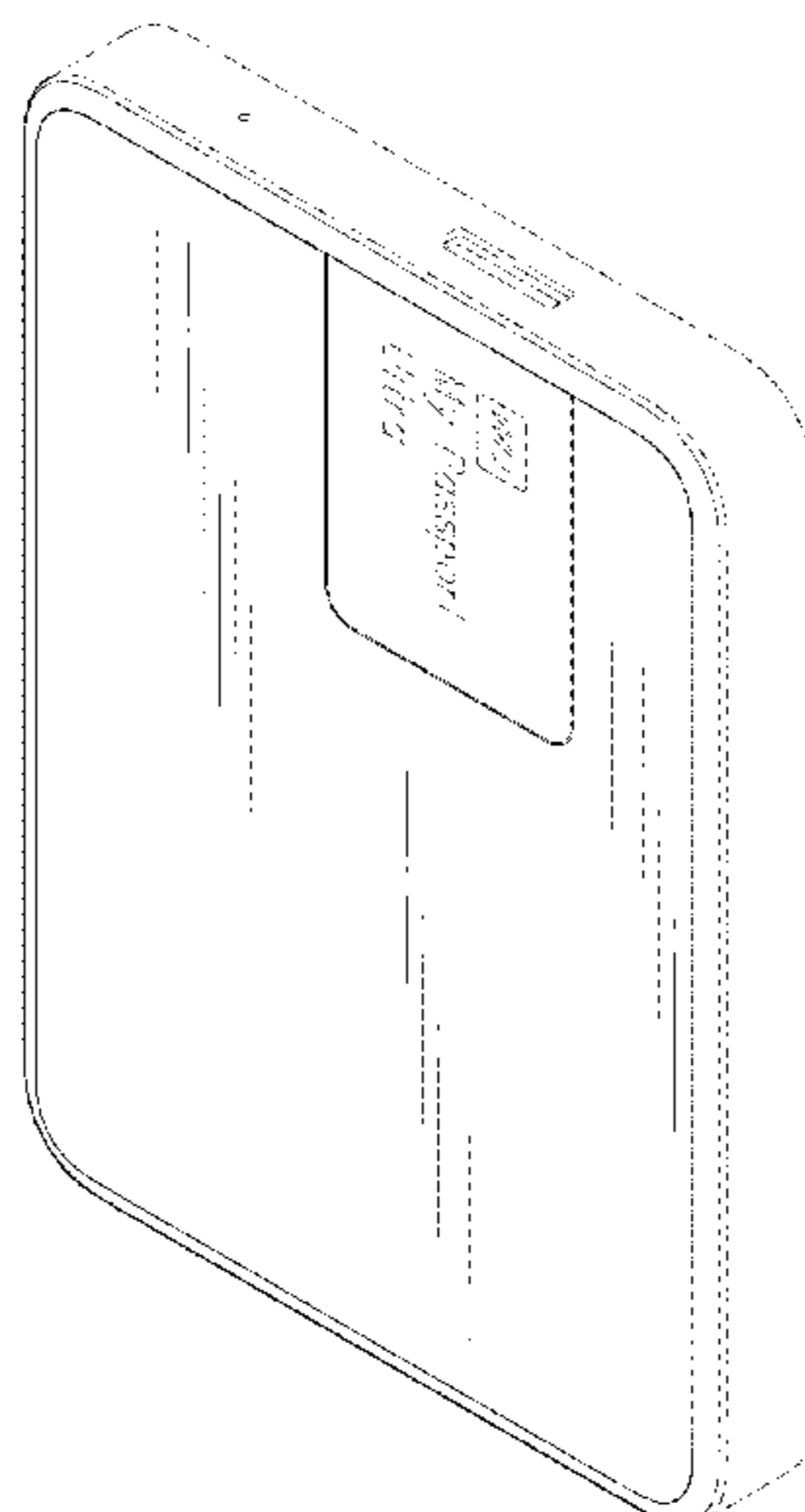
FIG. 1 is a top front side perspective view of a storage drive

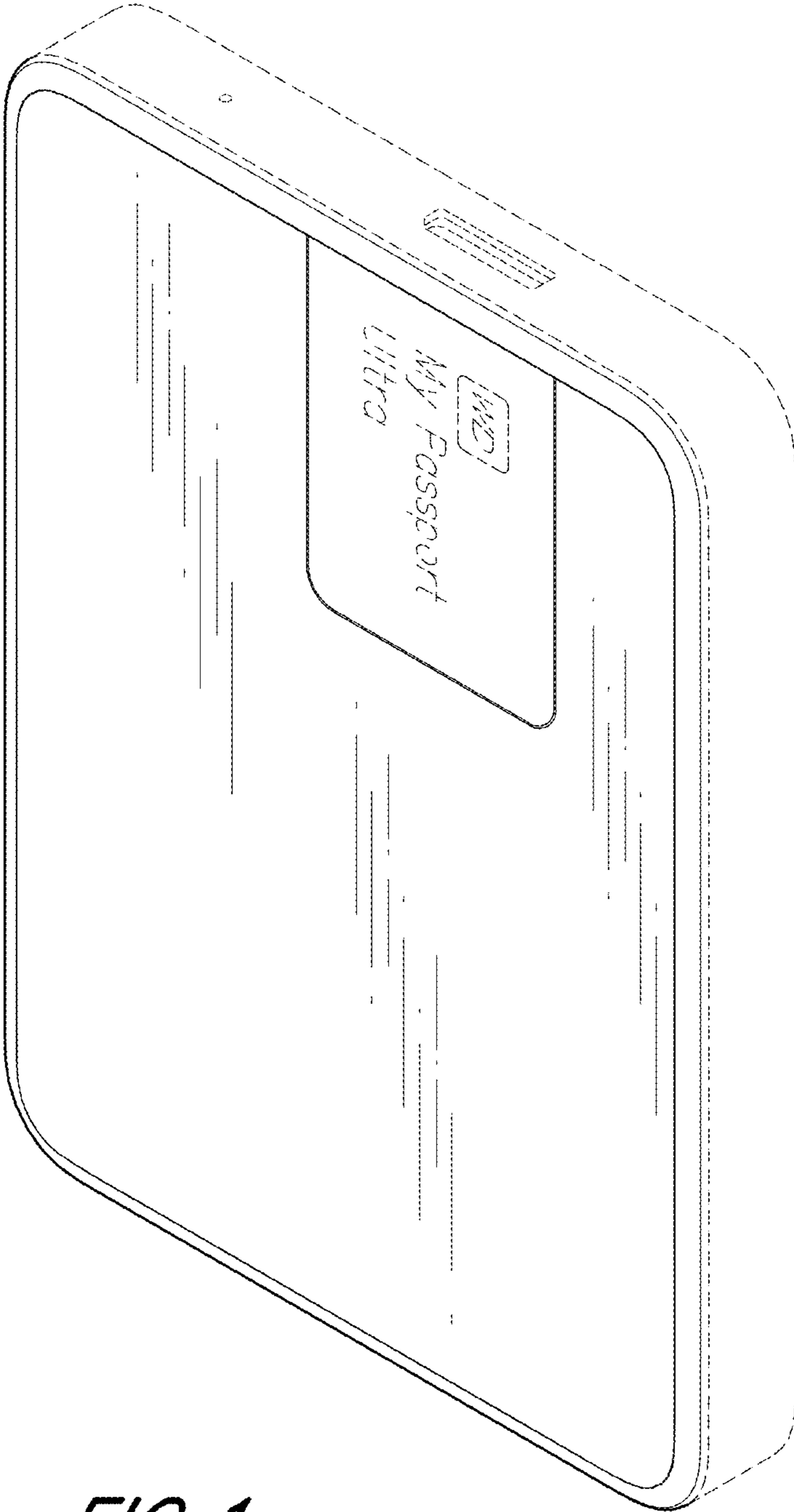

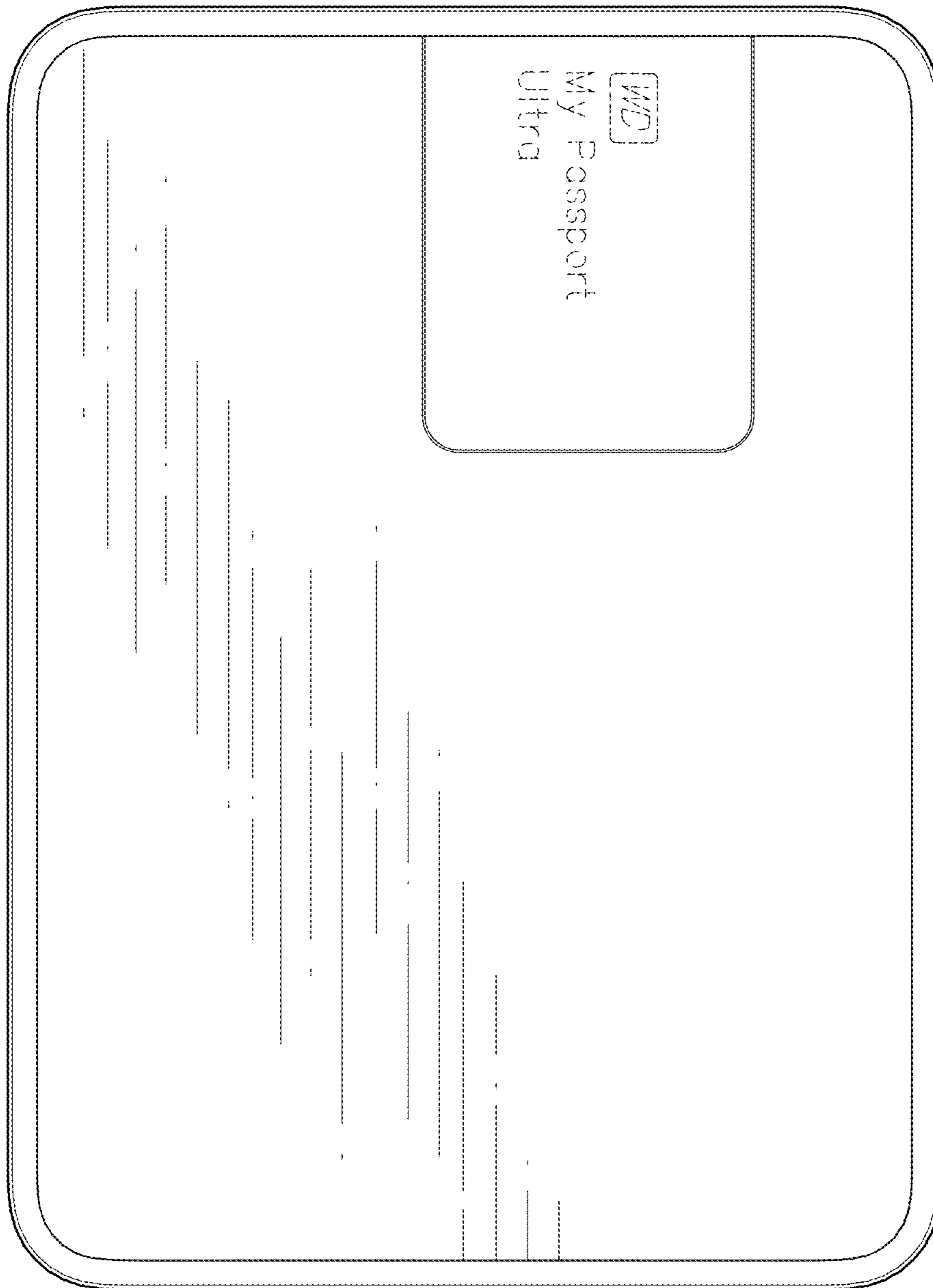

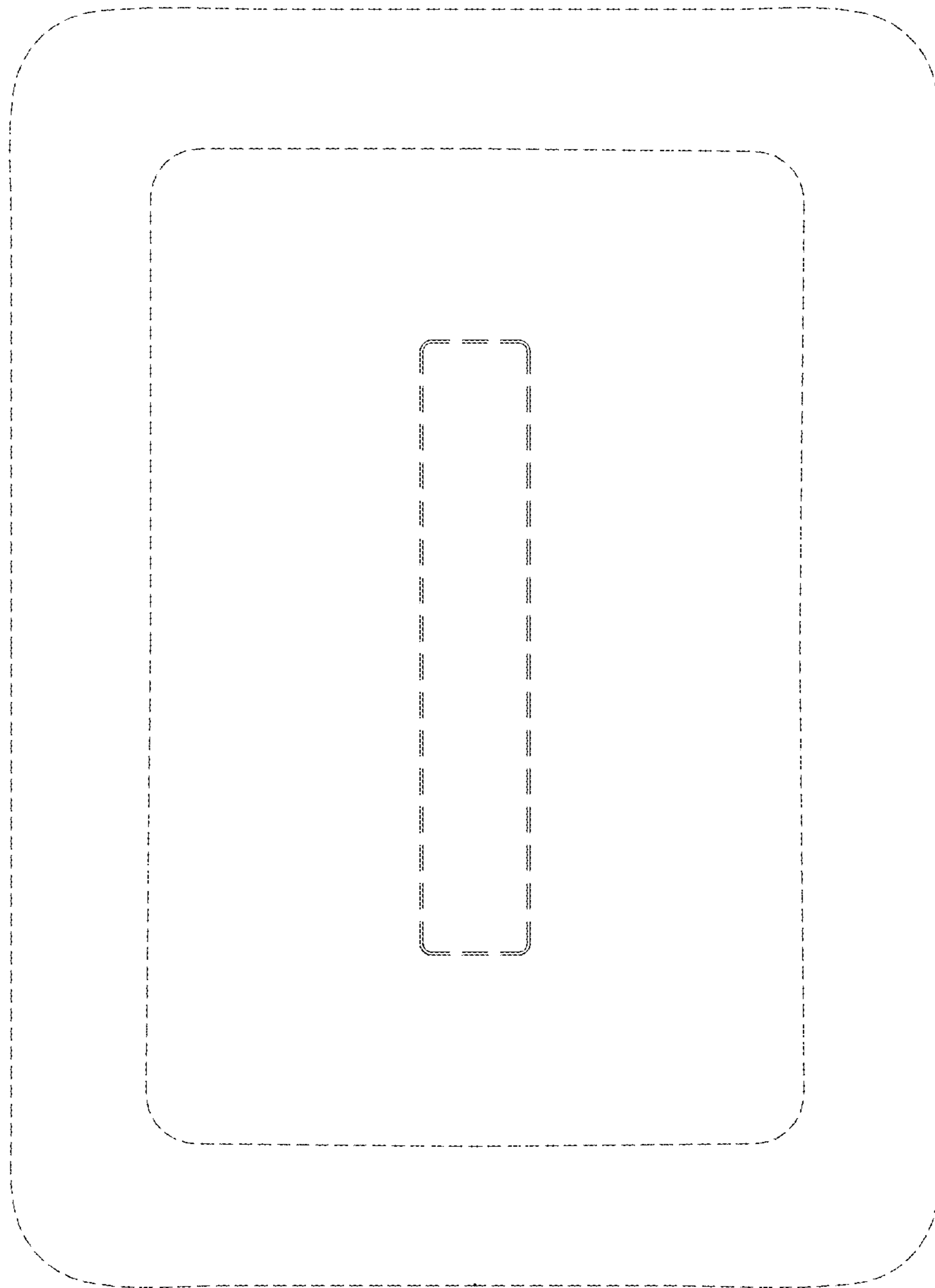

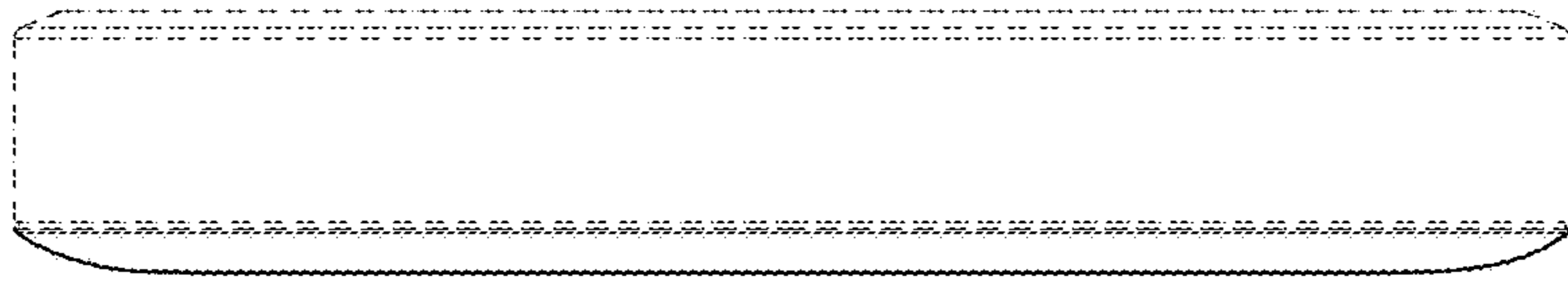

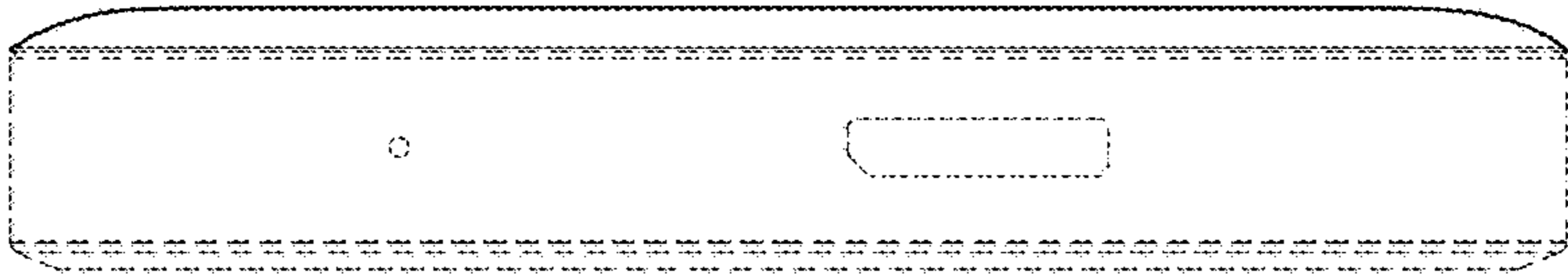

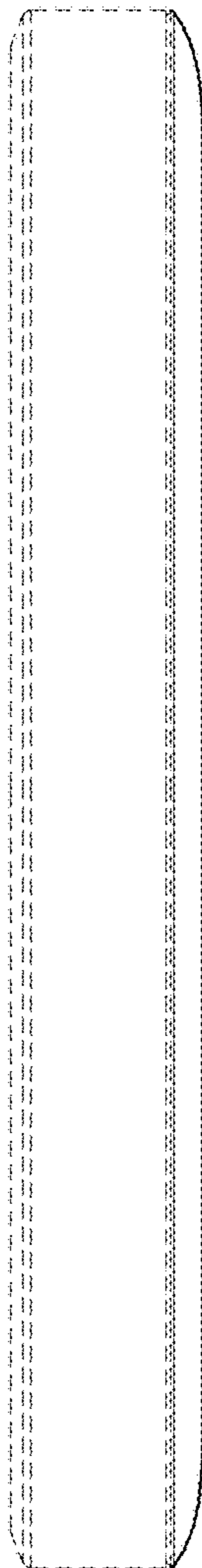

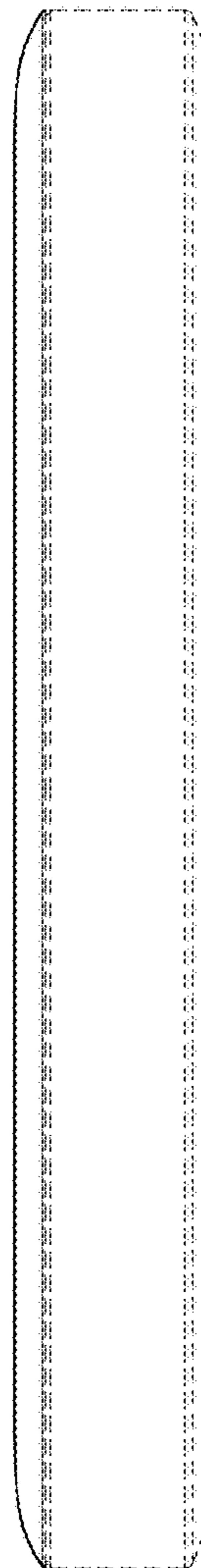
