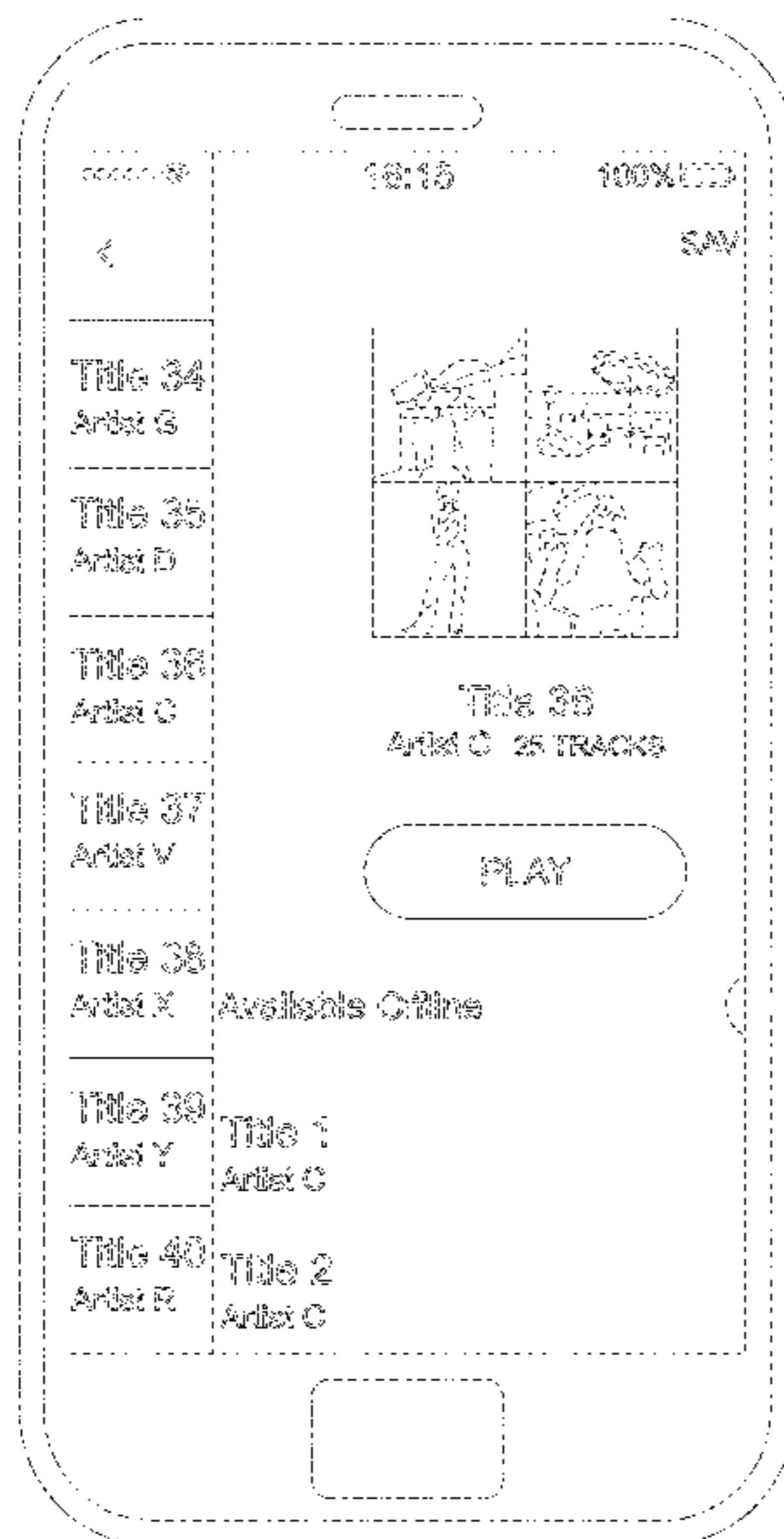
(57) **CLAIM**

The ornamental design for a display screen with a graphical user interface, as shown.

DESCRIPTION

The even broken lines showing a display screen and elements of the graphical user interface illustrate portions of the article.
