FIG. 16 is another rear perspective view thereof.

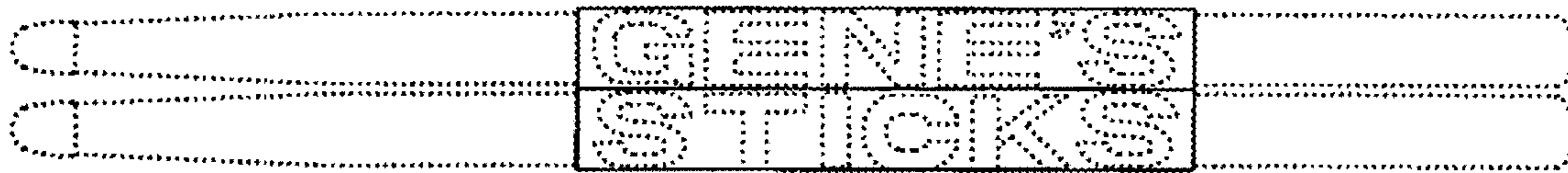

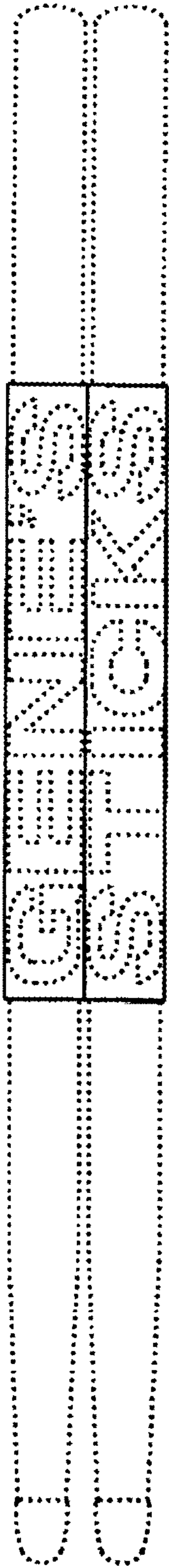

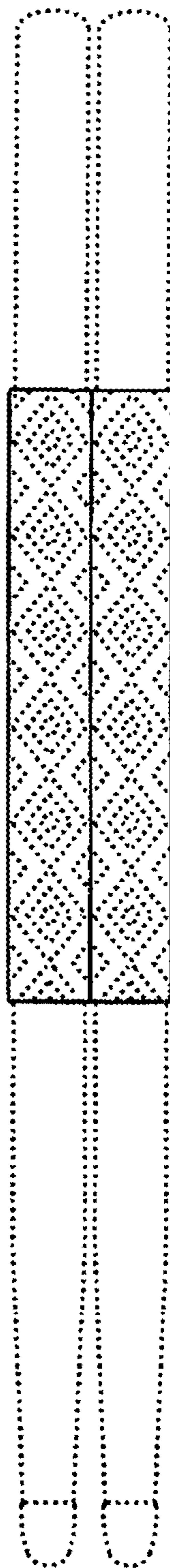

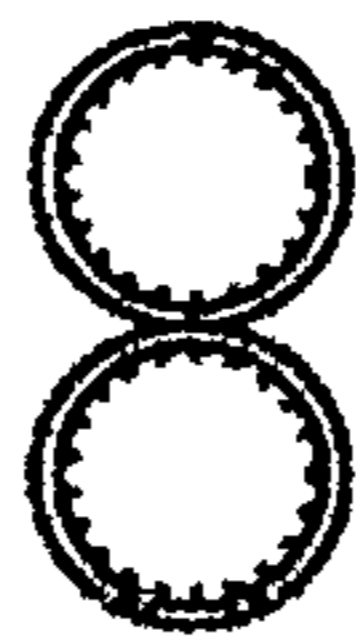

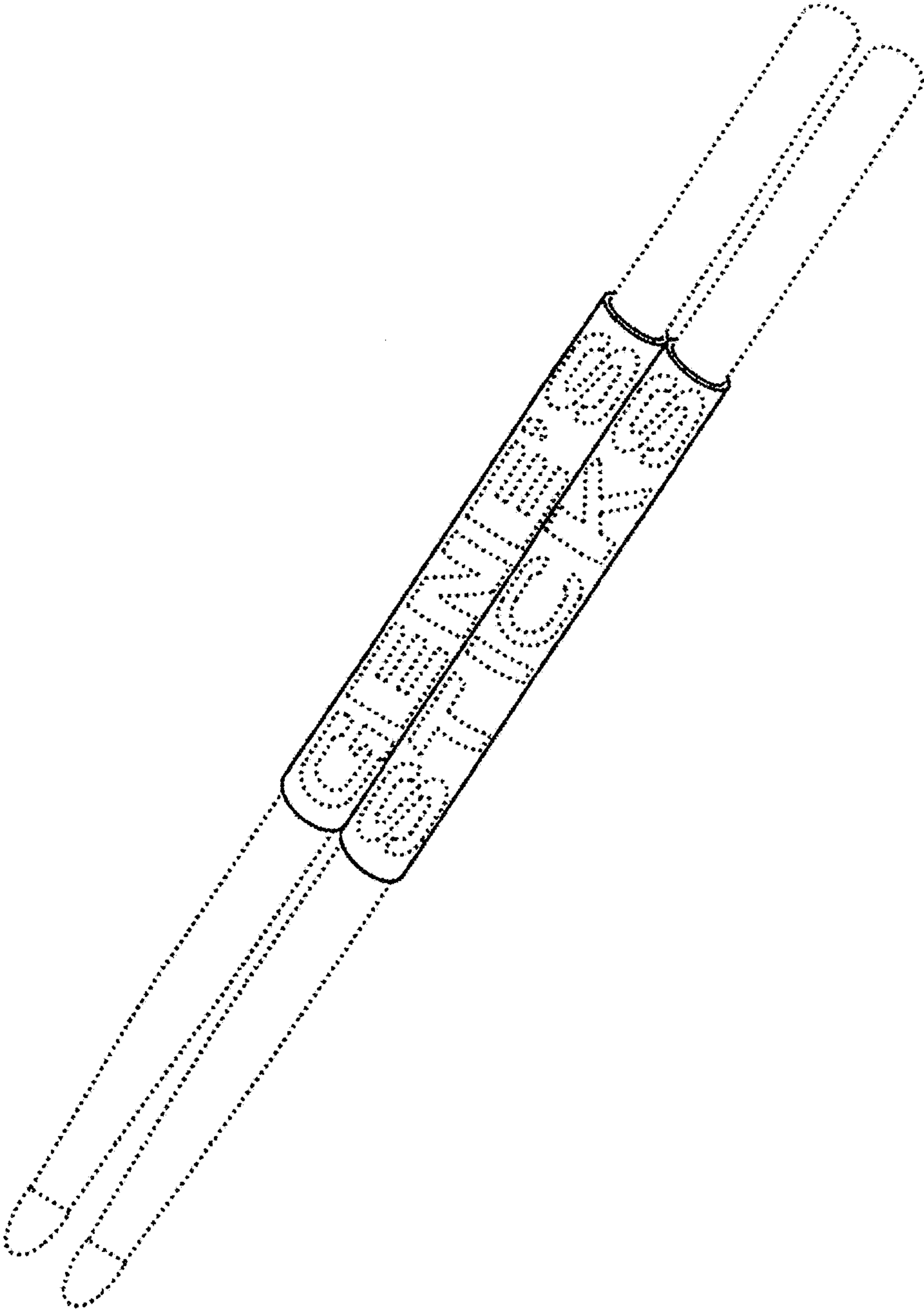

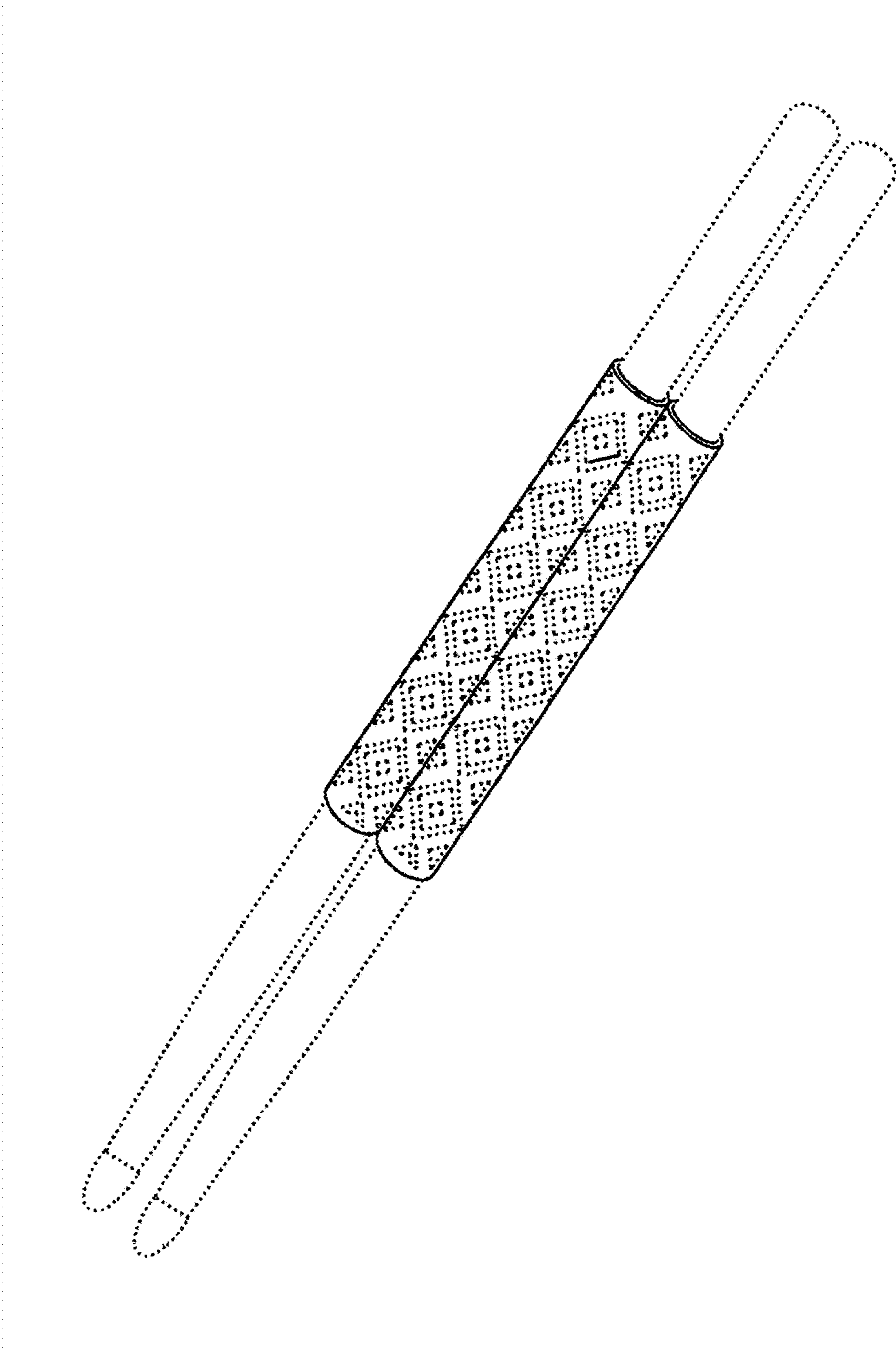

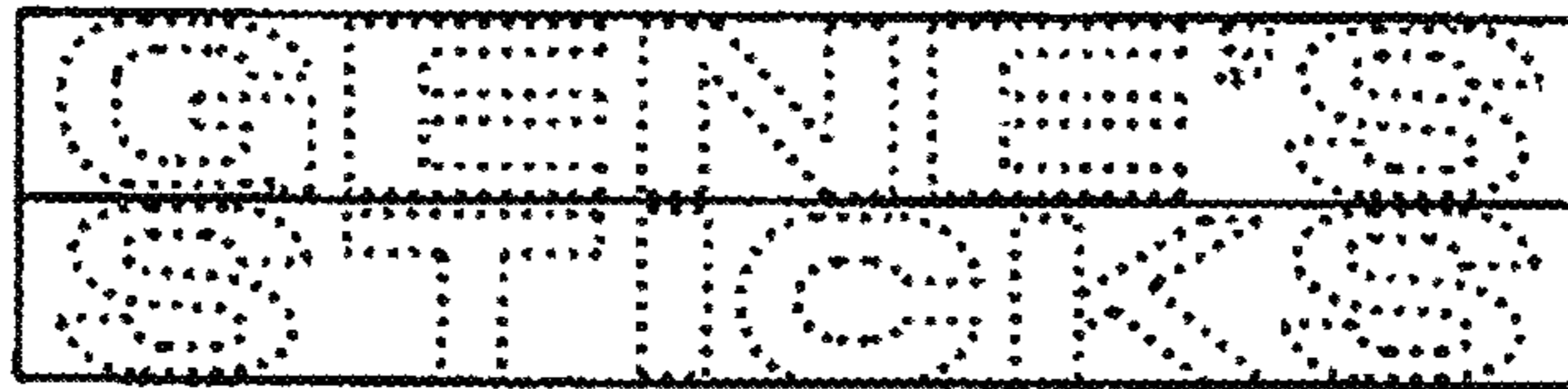

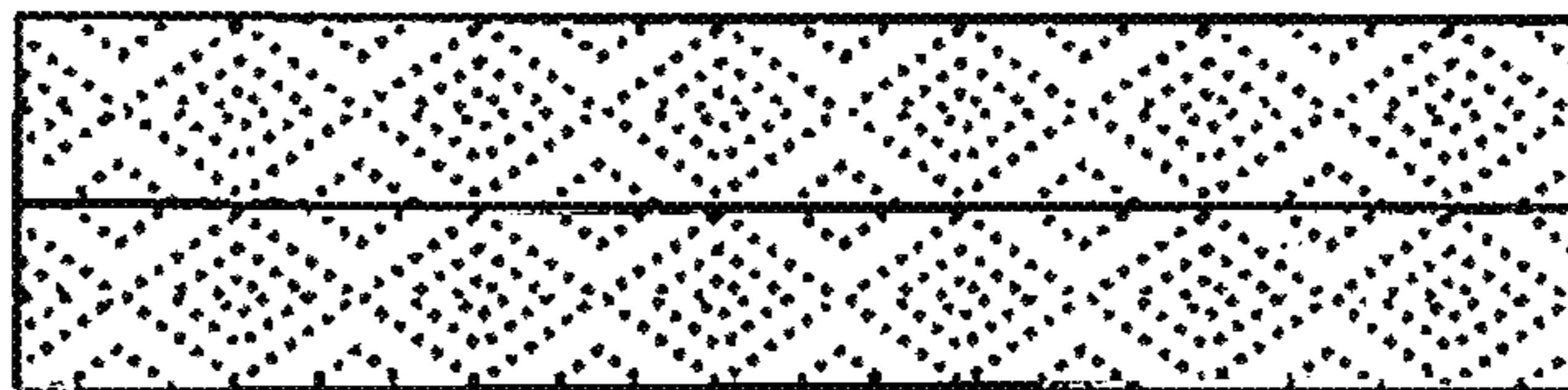

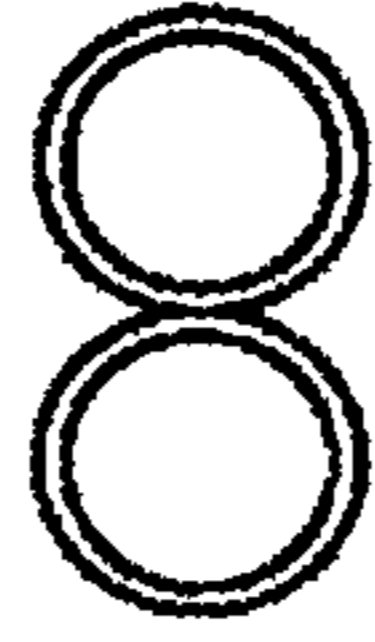

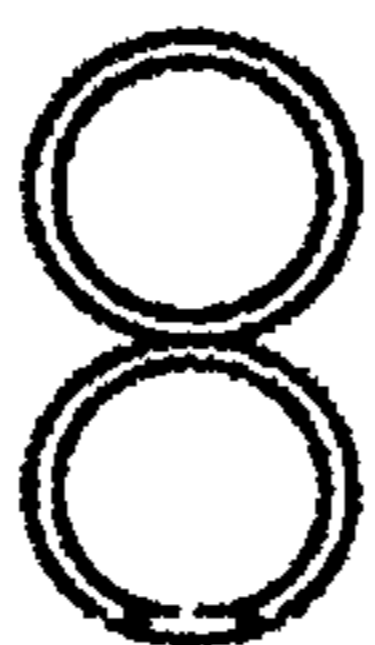

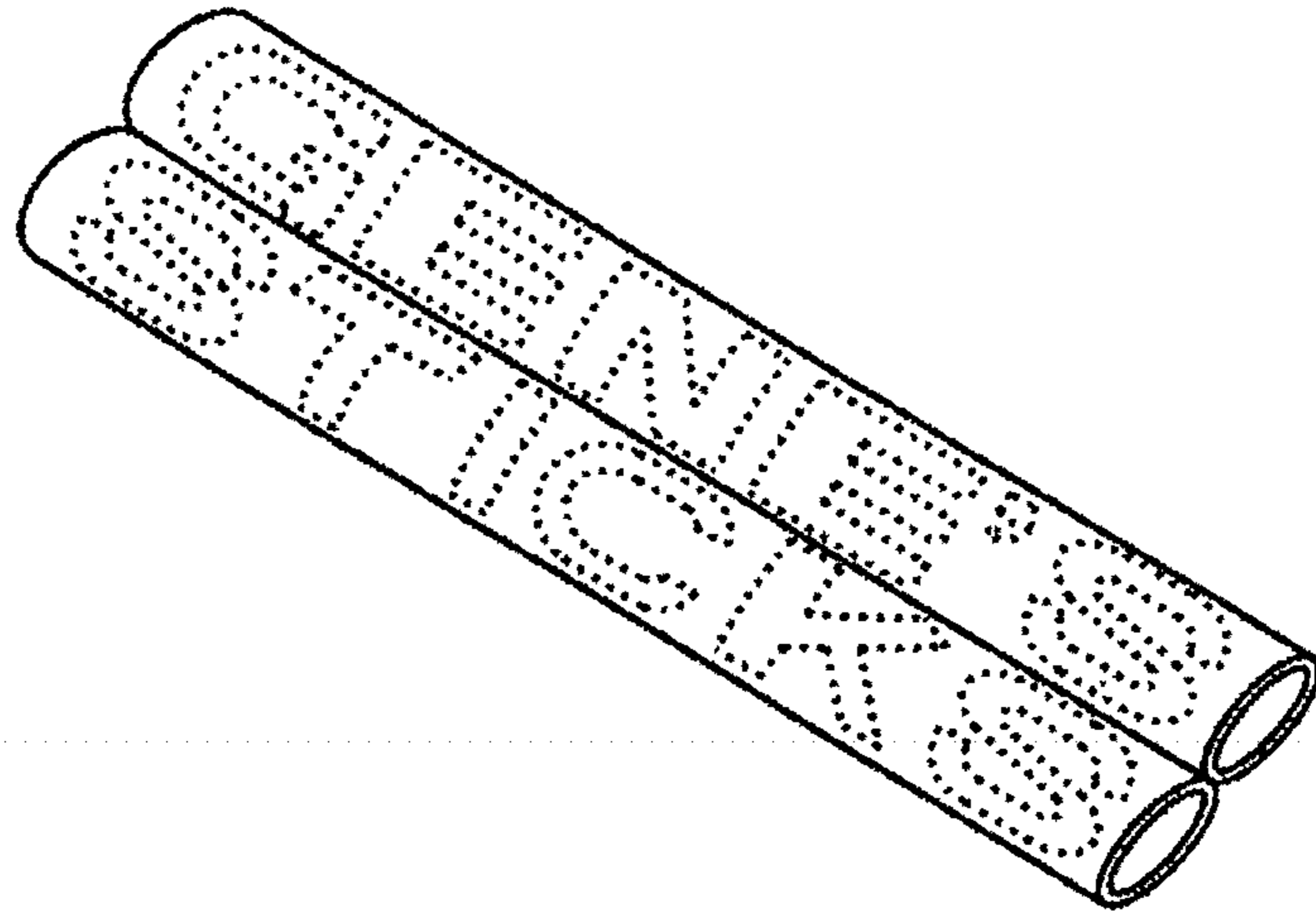

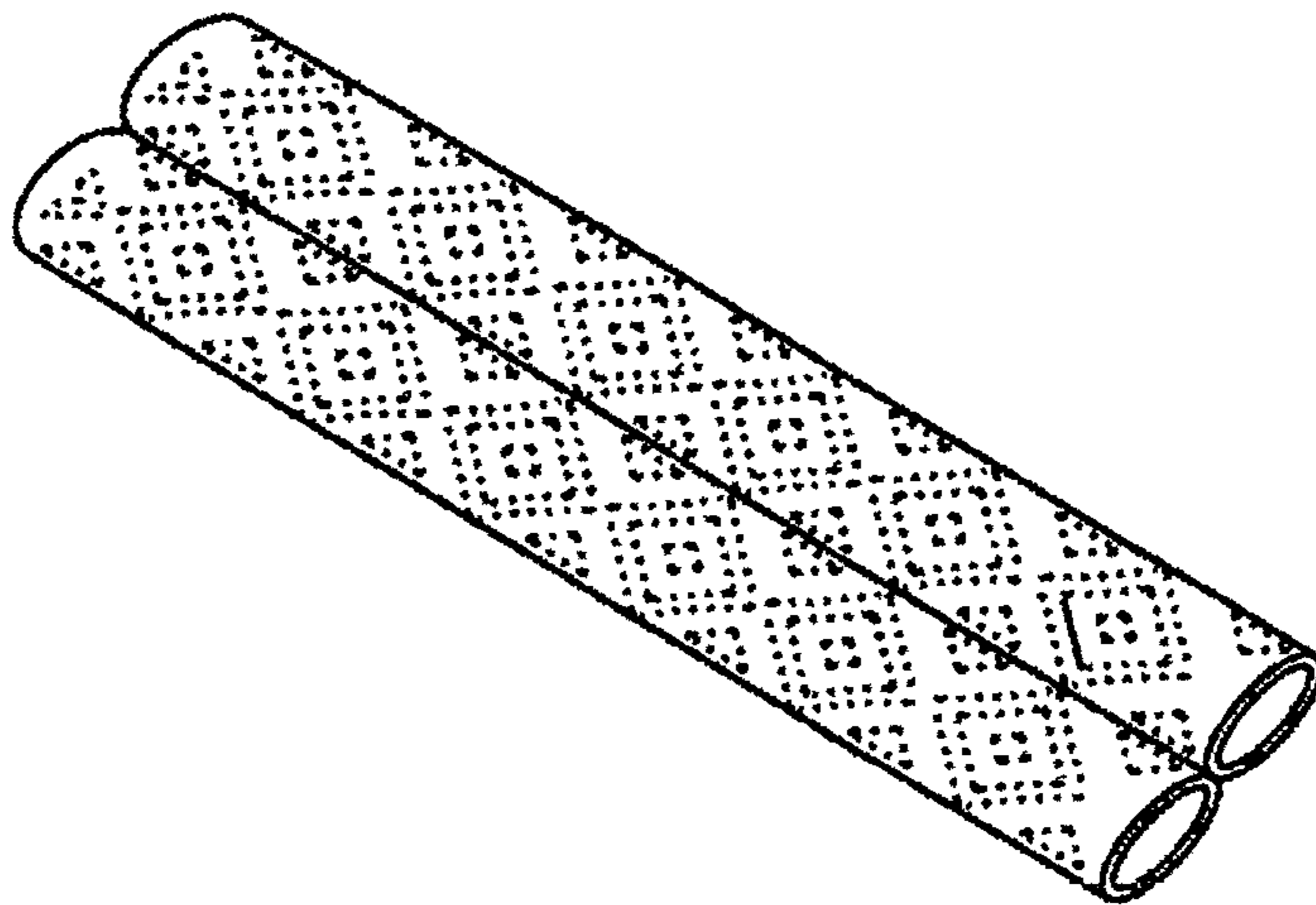
