DESCRIPTION

FIG. 1 is a perspective view showing the roof, front, a left side, and a portion of the interior of a toy house, showing my new design;

FIG. 4 is a rear view thereof;

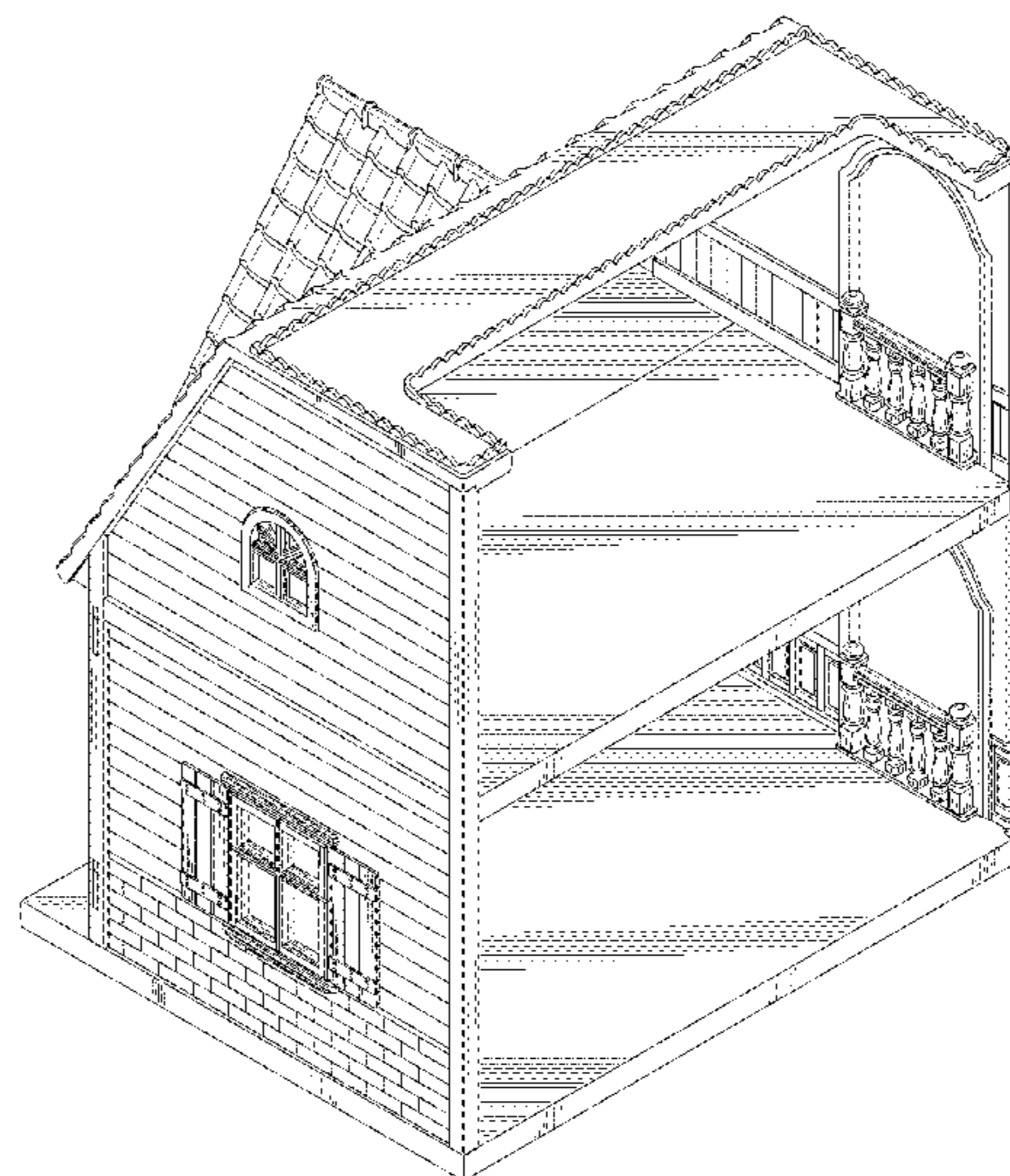
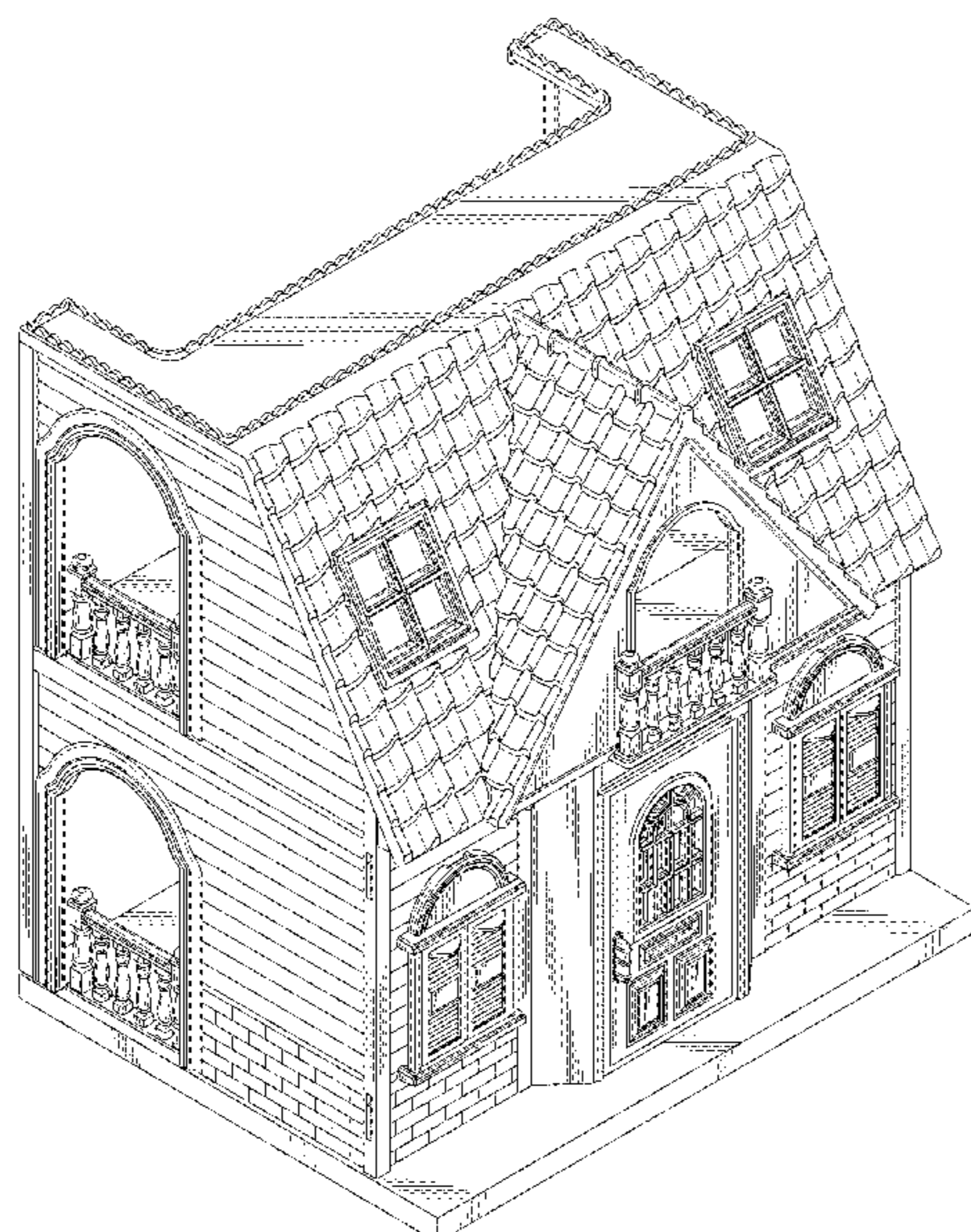
FIG. 5 is an overhead view thereof;

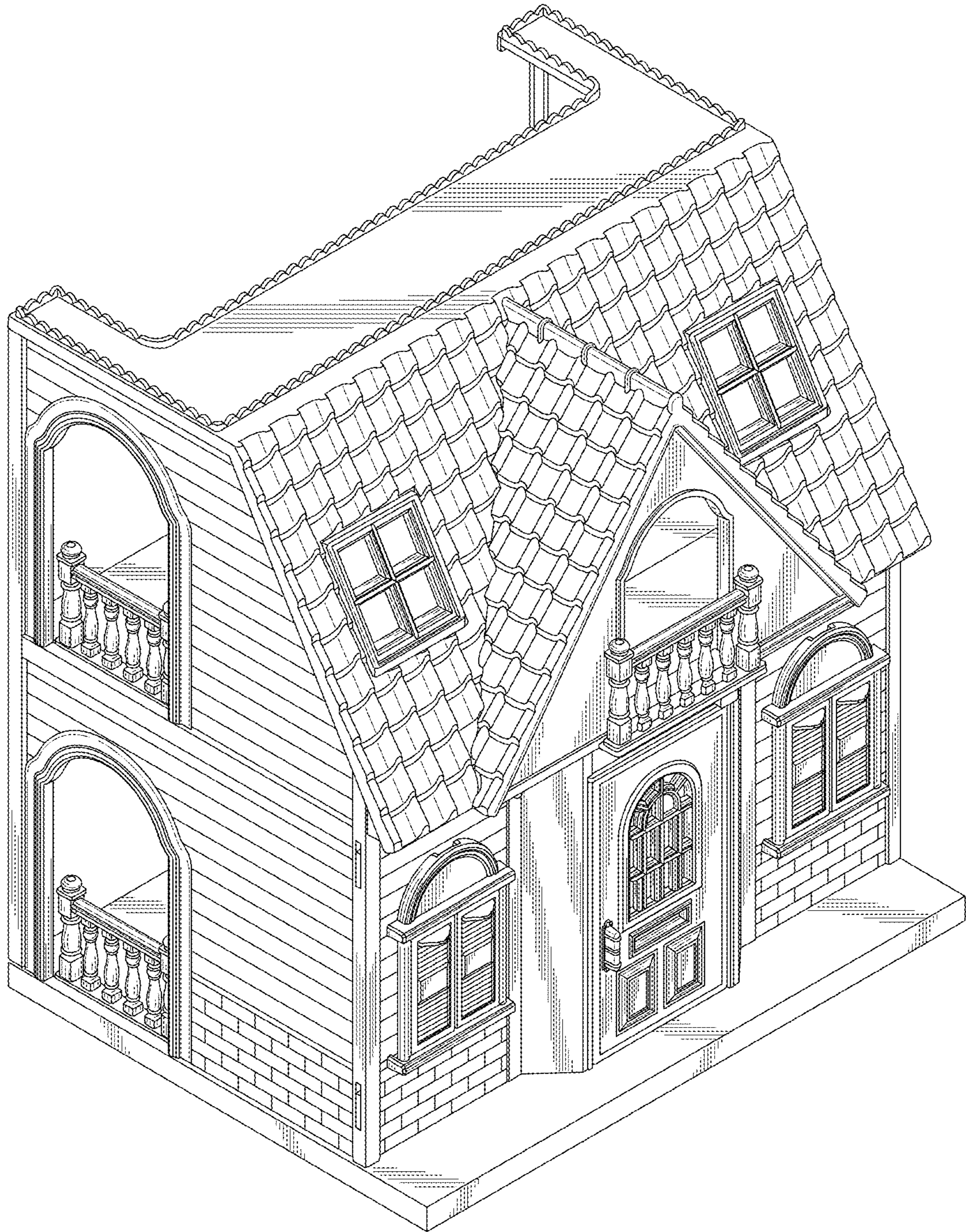

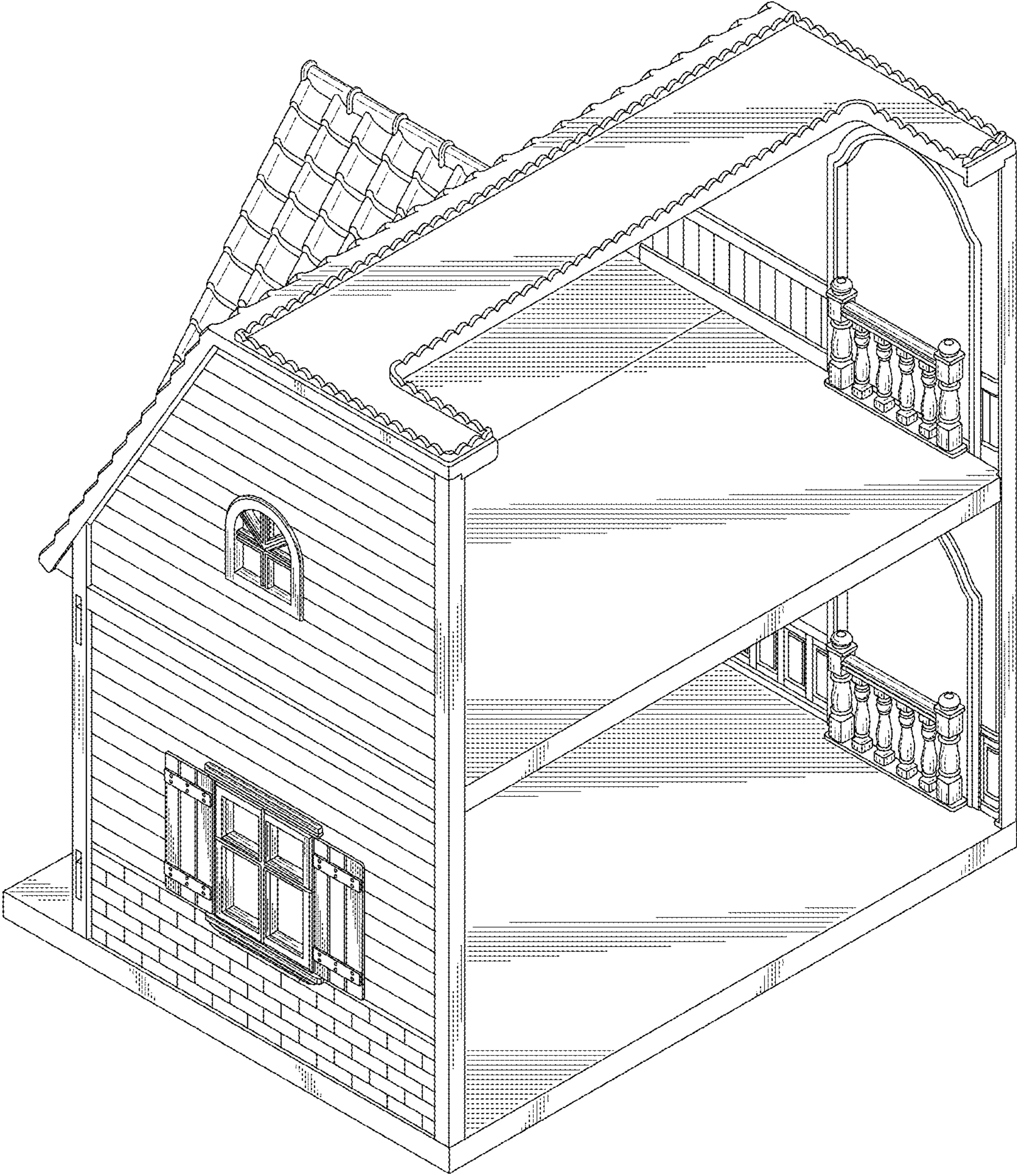

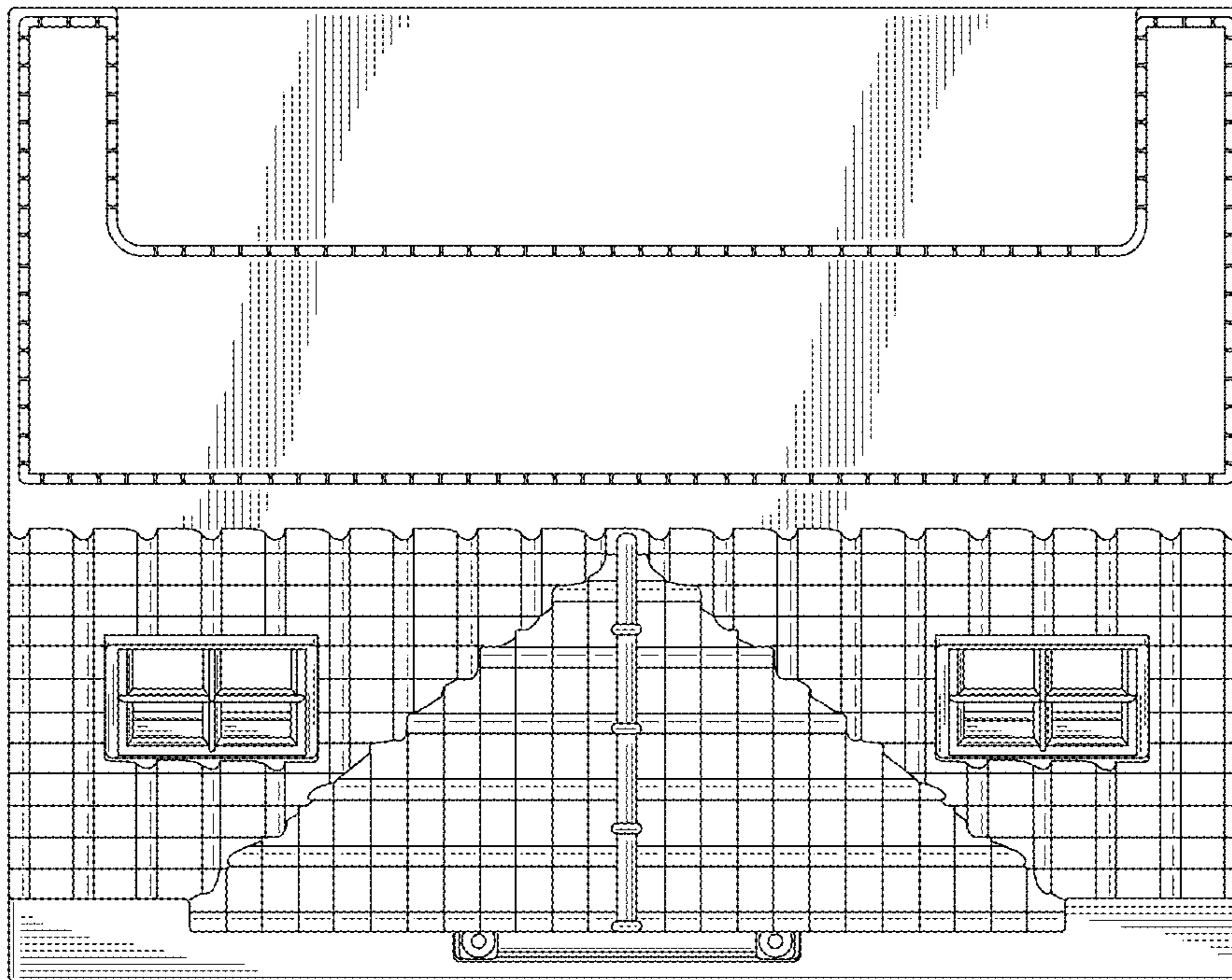

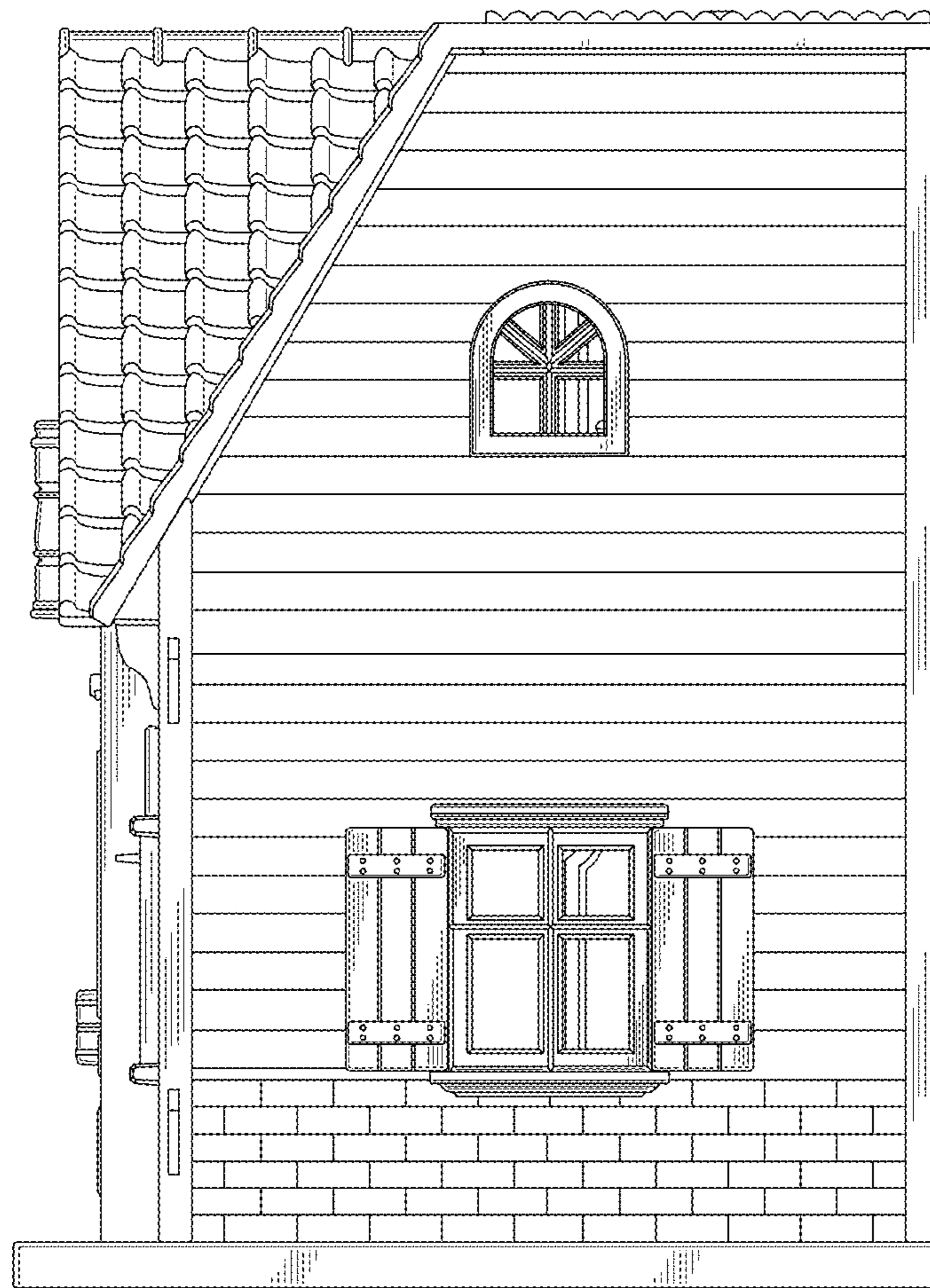
