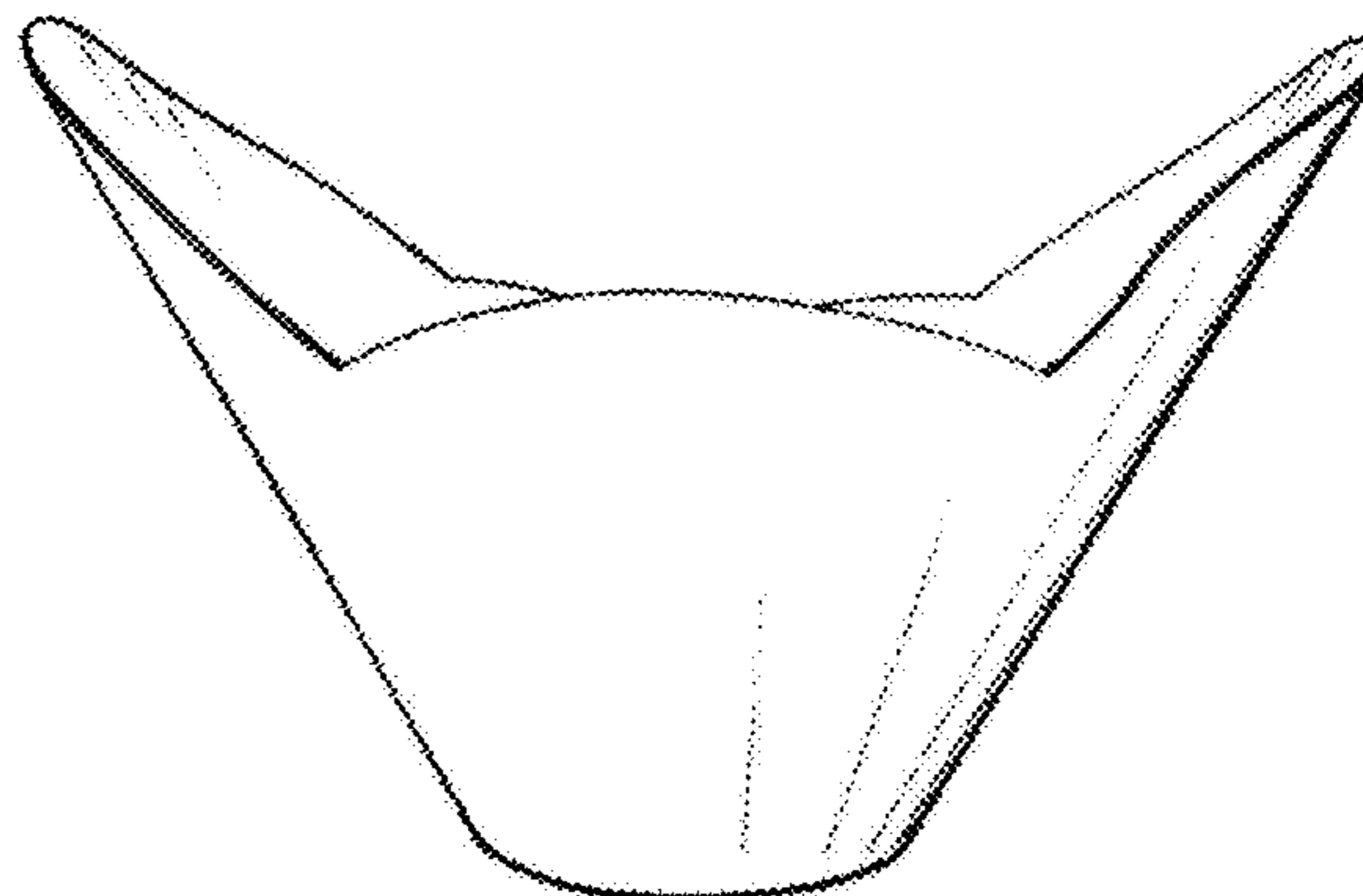
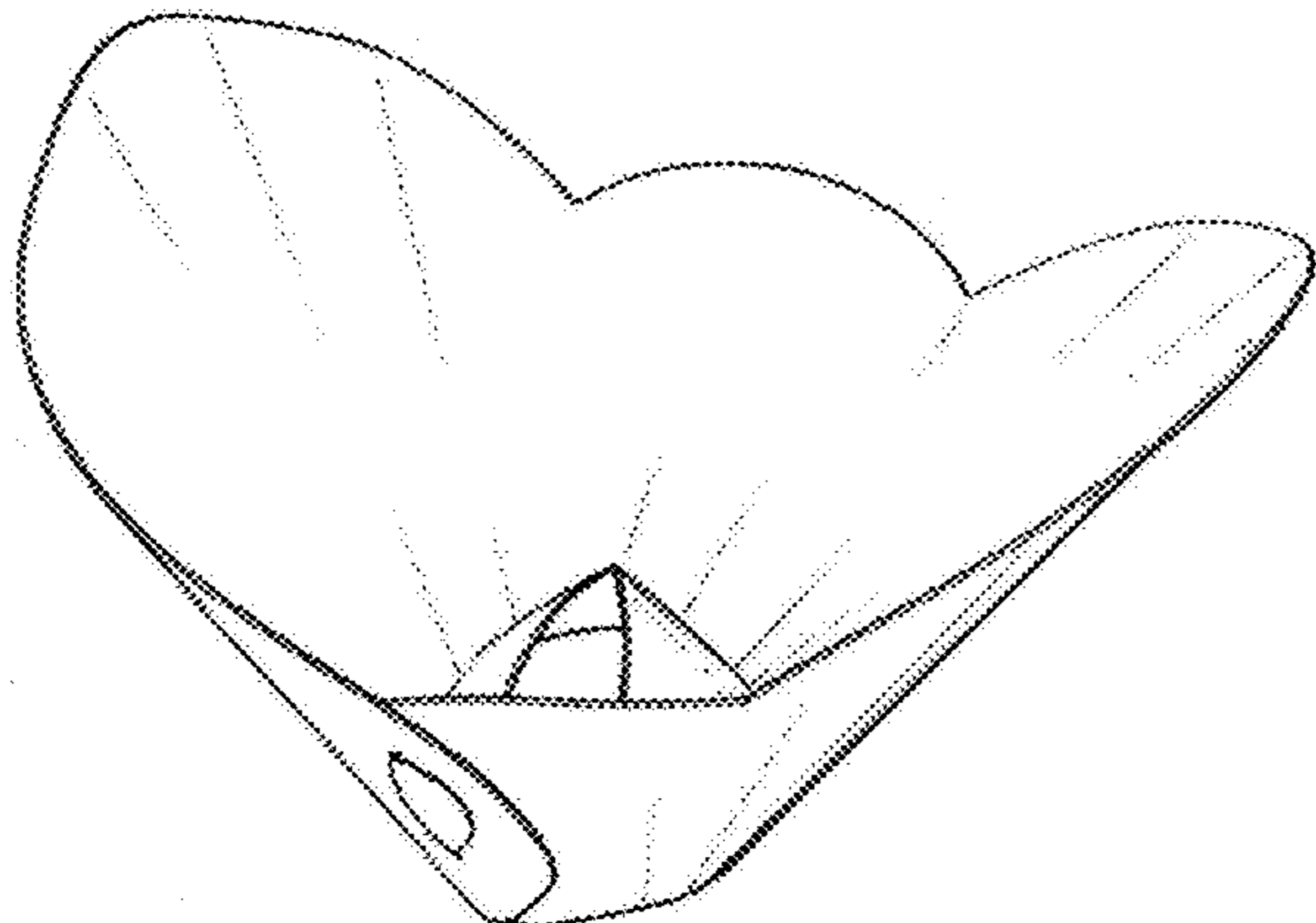

The ornamental design for air freshener, as shown and described.

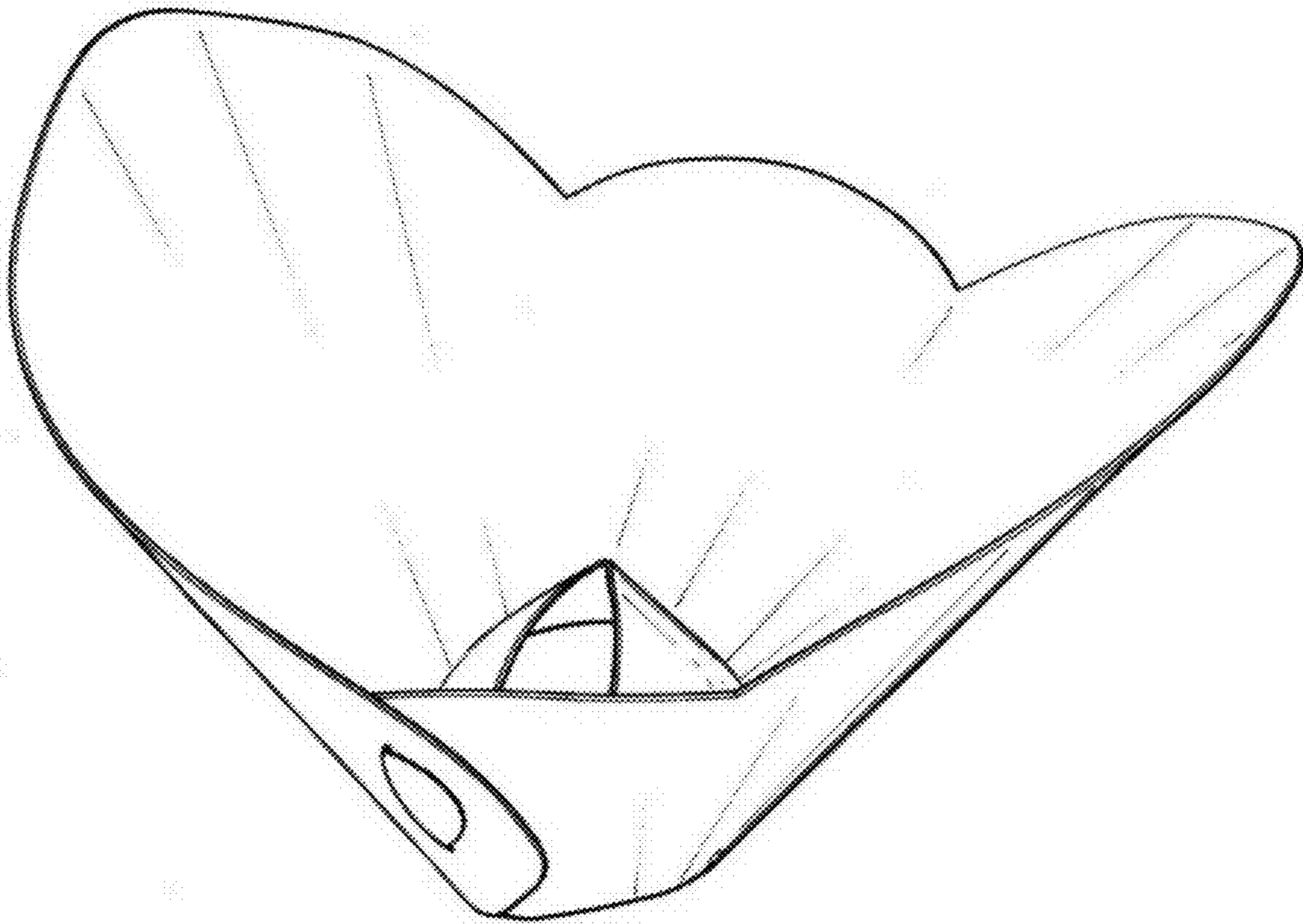
DESCRIPTION

- 1.4 is a front elevation view.

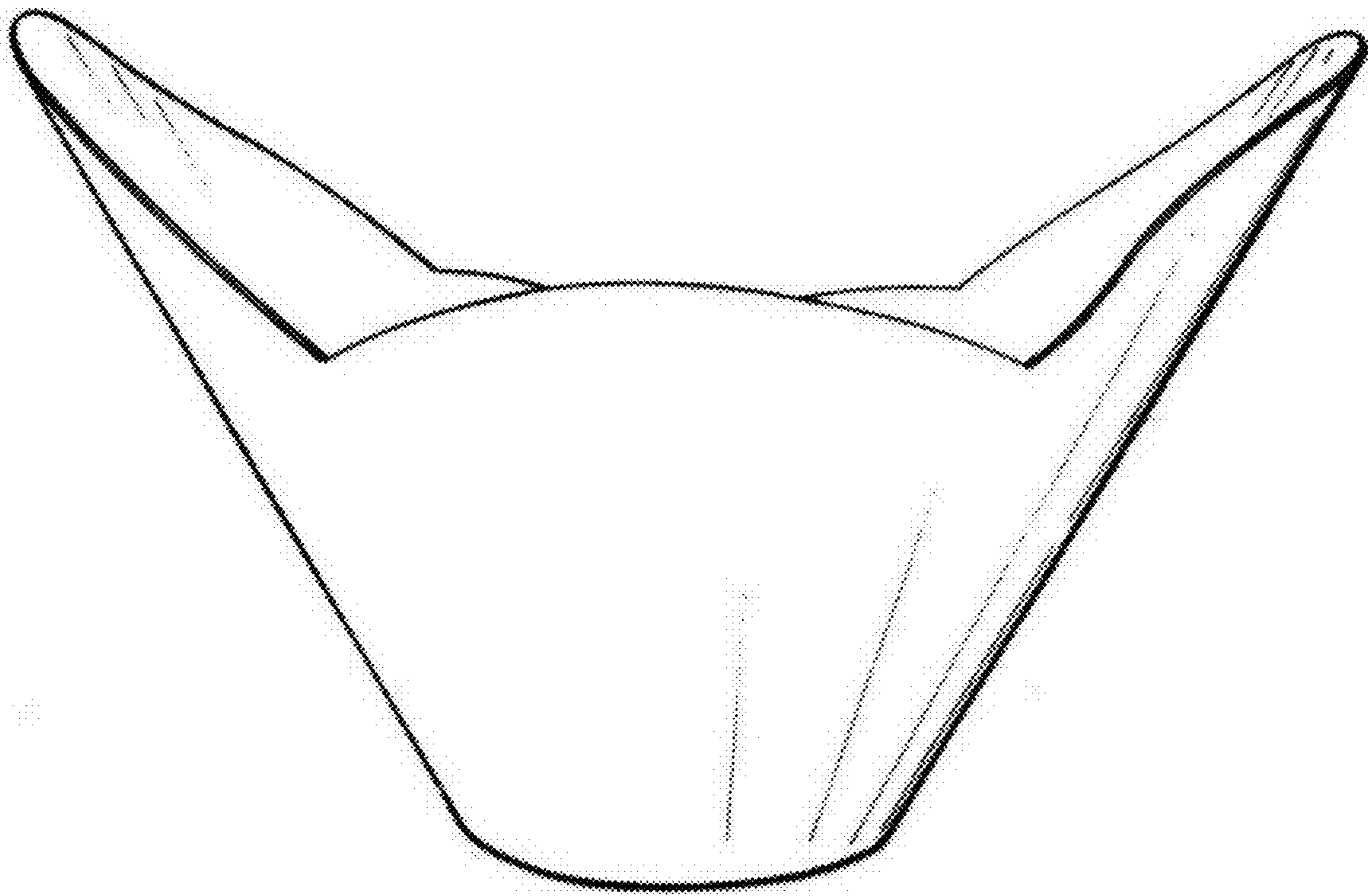

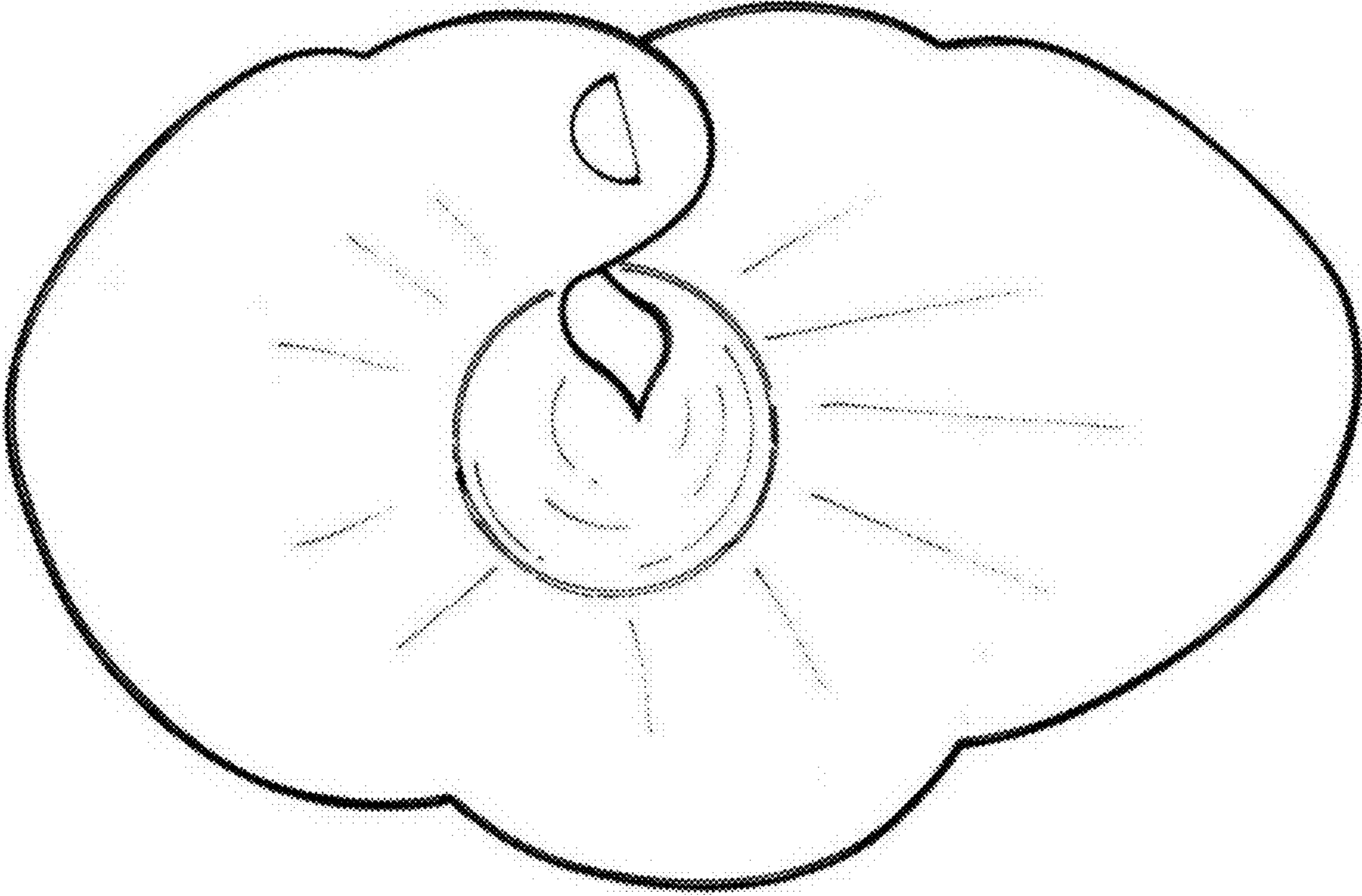
