The ornamental design for a manual debridement implement, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a manual debridement implement;

FIG. 2 is a top view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a back view thereof;

FIG. 6 is a bottom view thereof; and,

FIG. 7 is an enlarged, bottom perspective view showing only the scraper head.

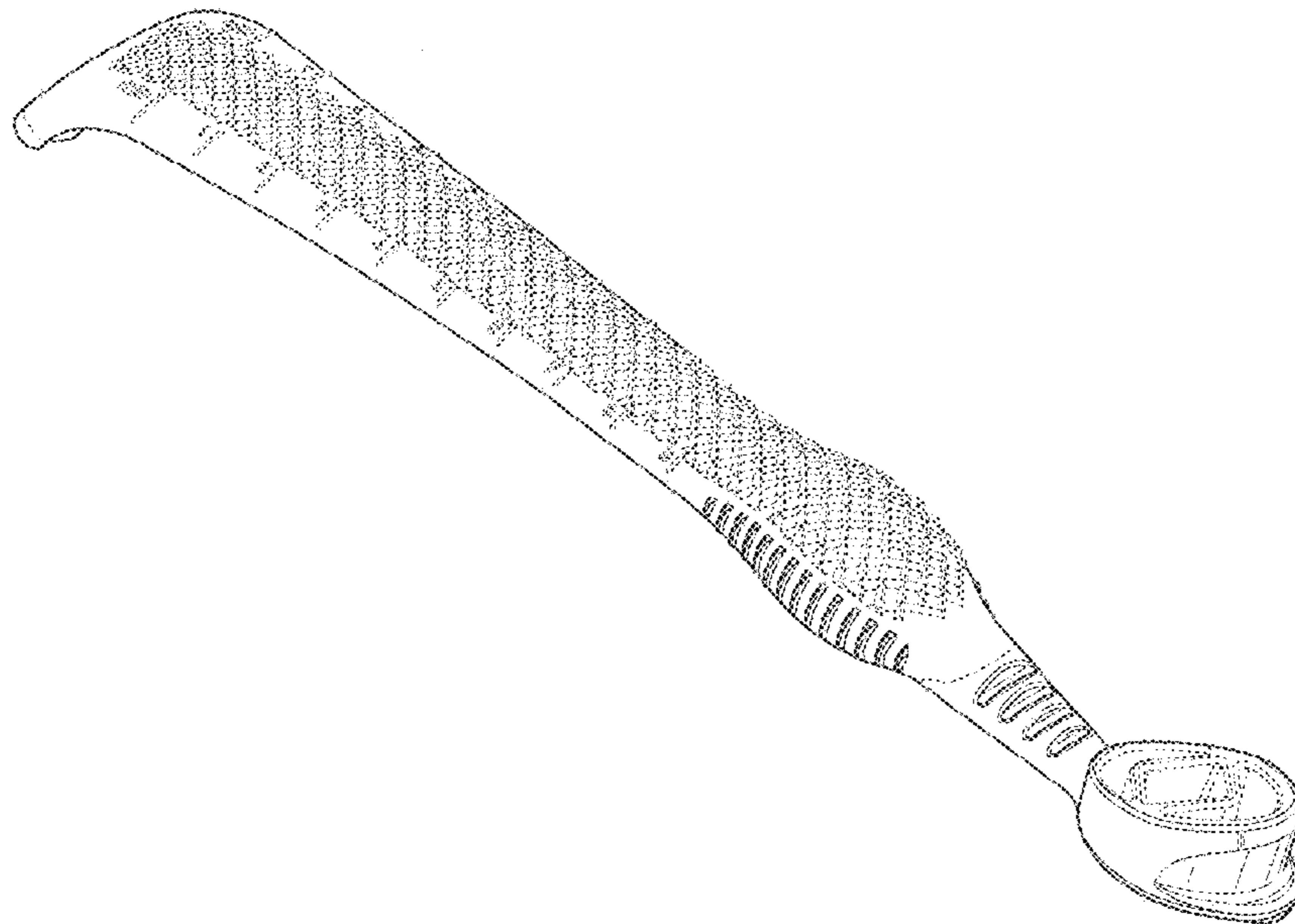
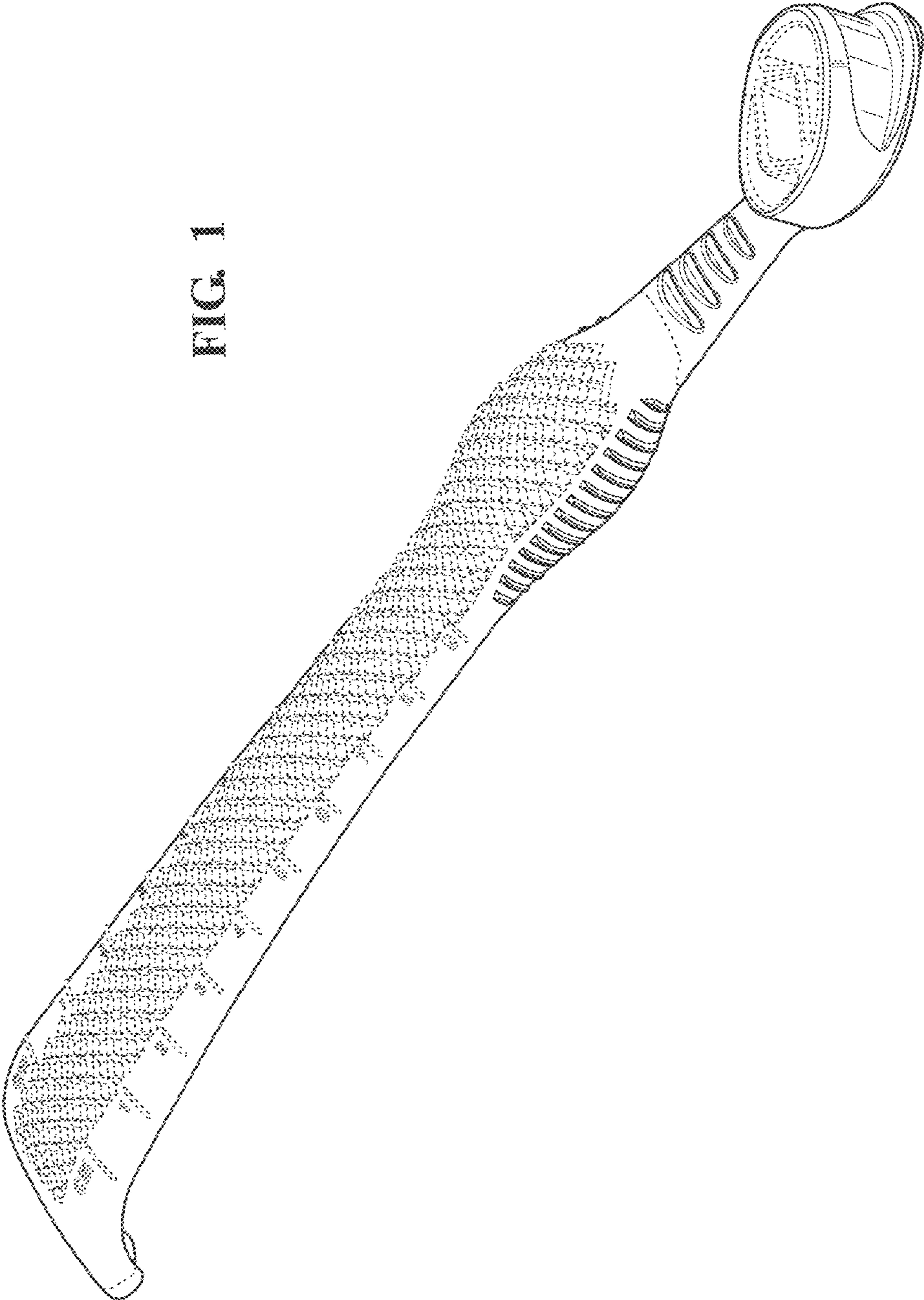

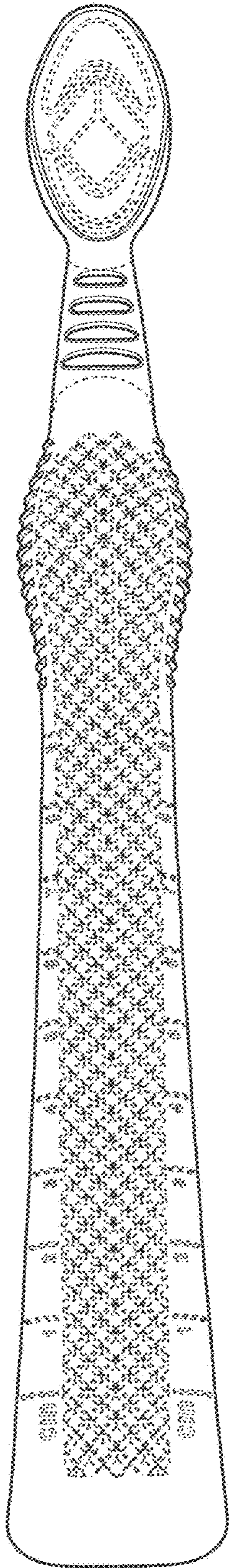

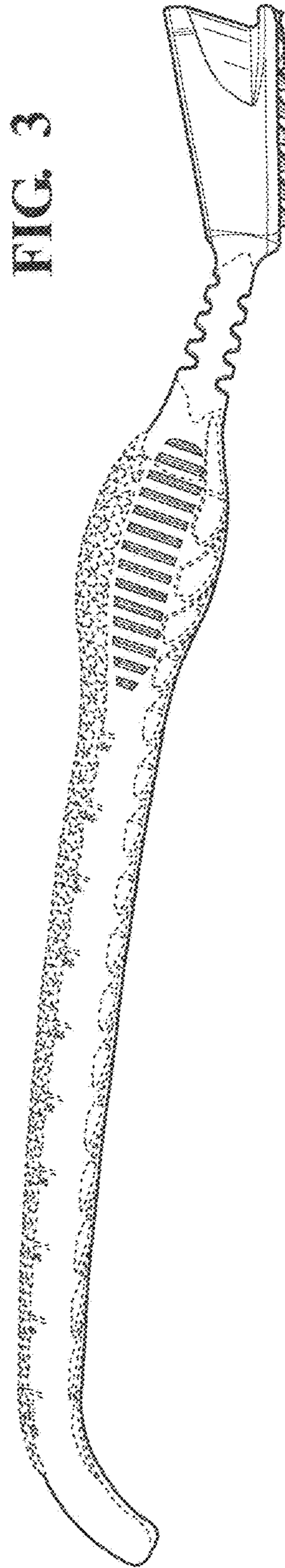

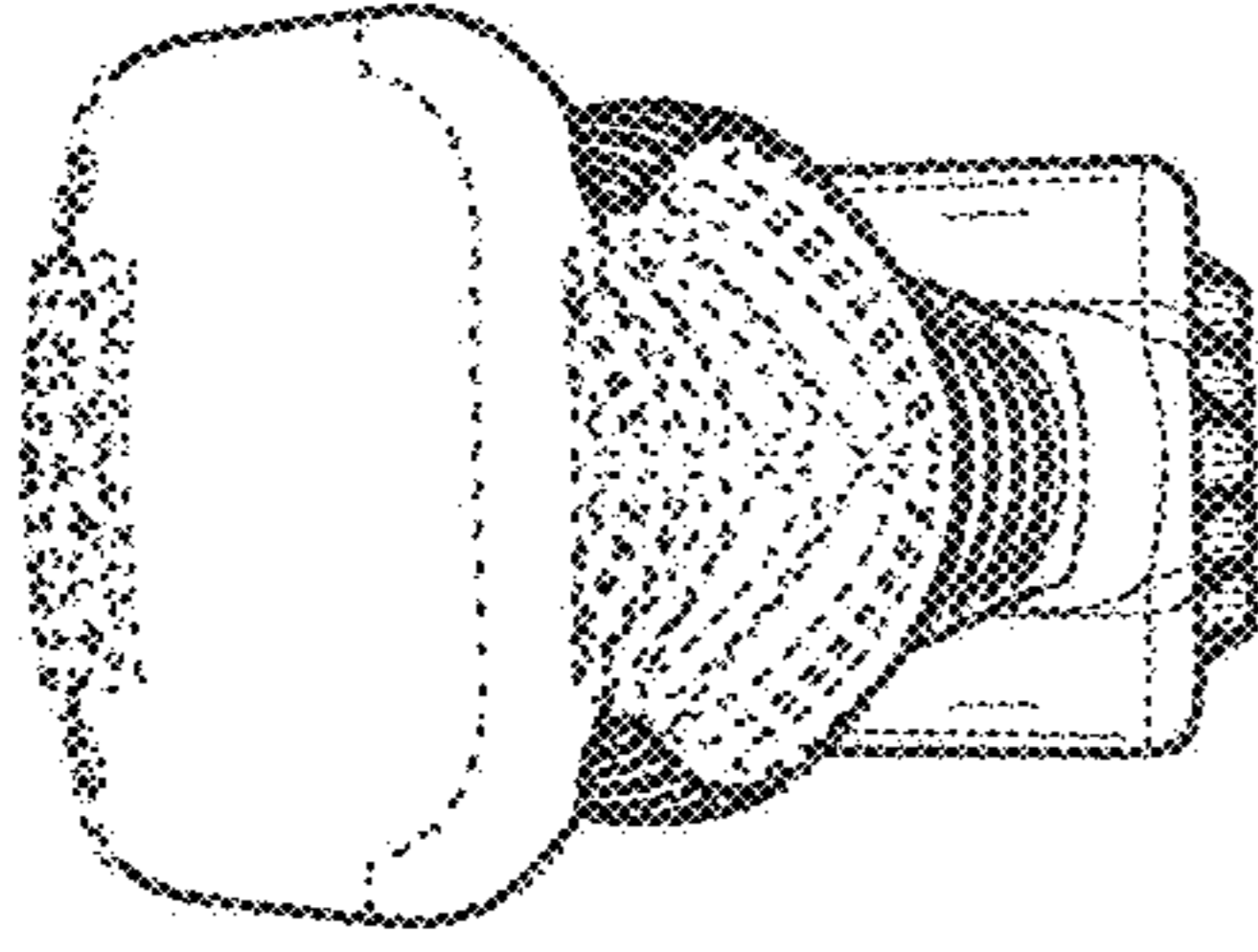

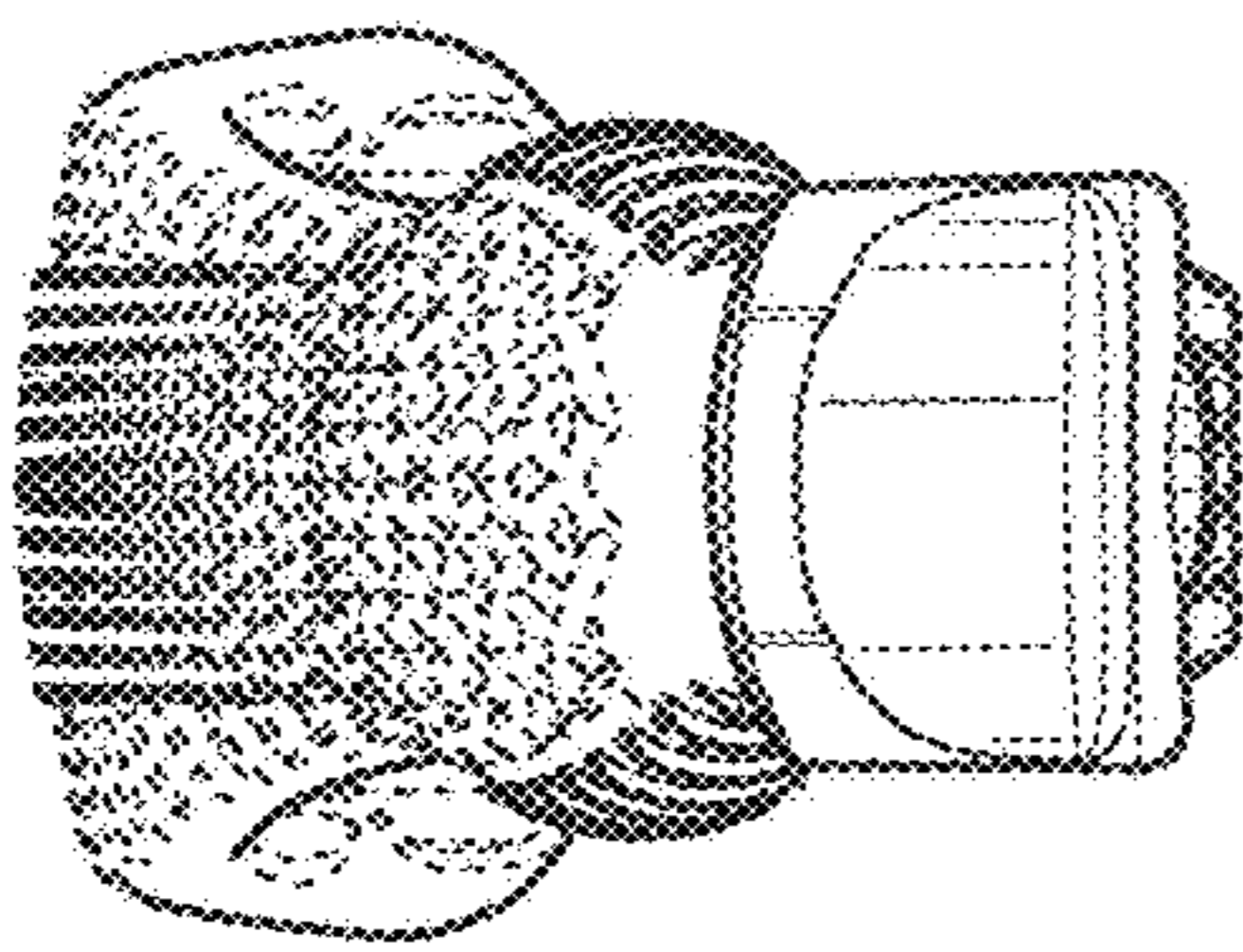

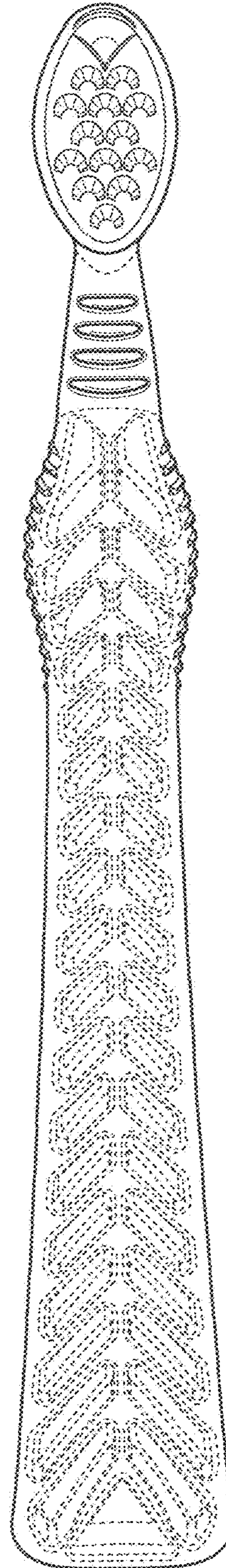
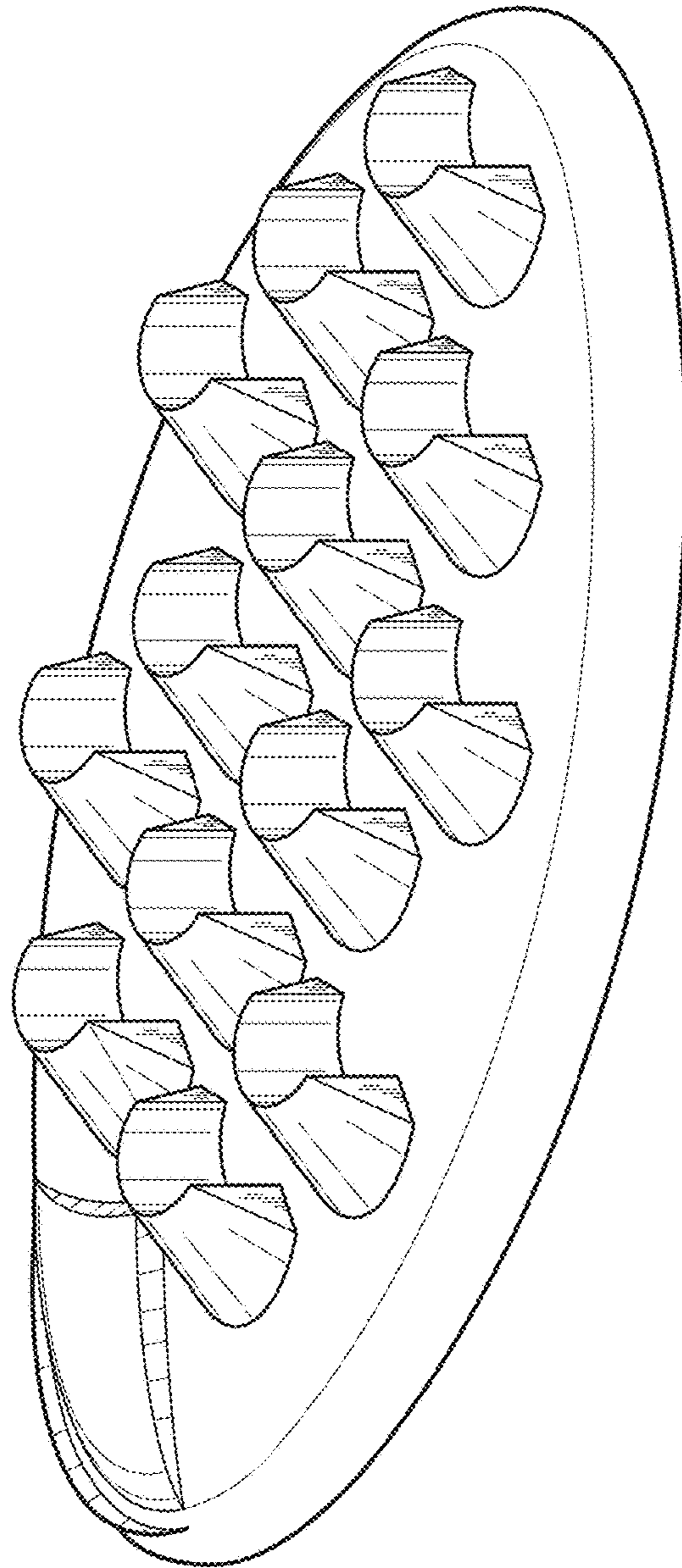
