**DESCRIPTION**

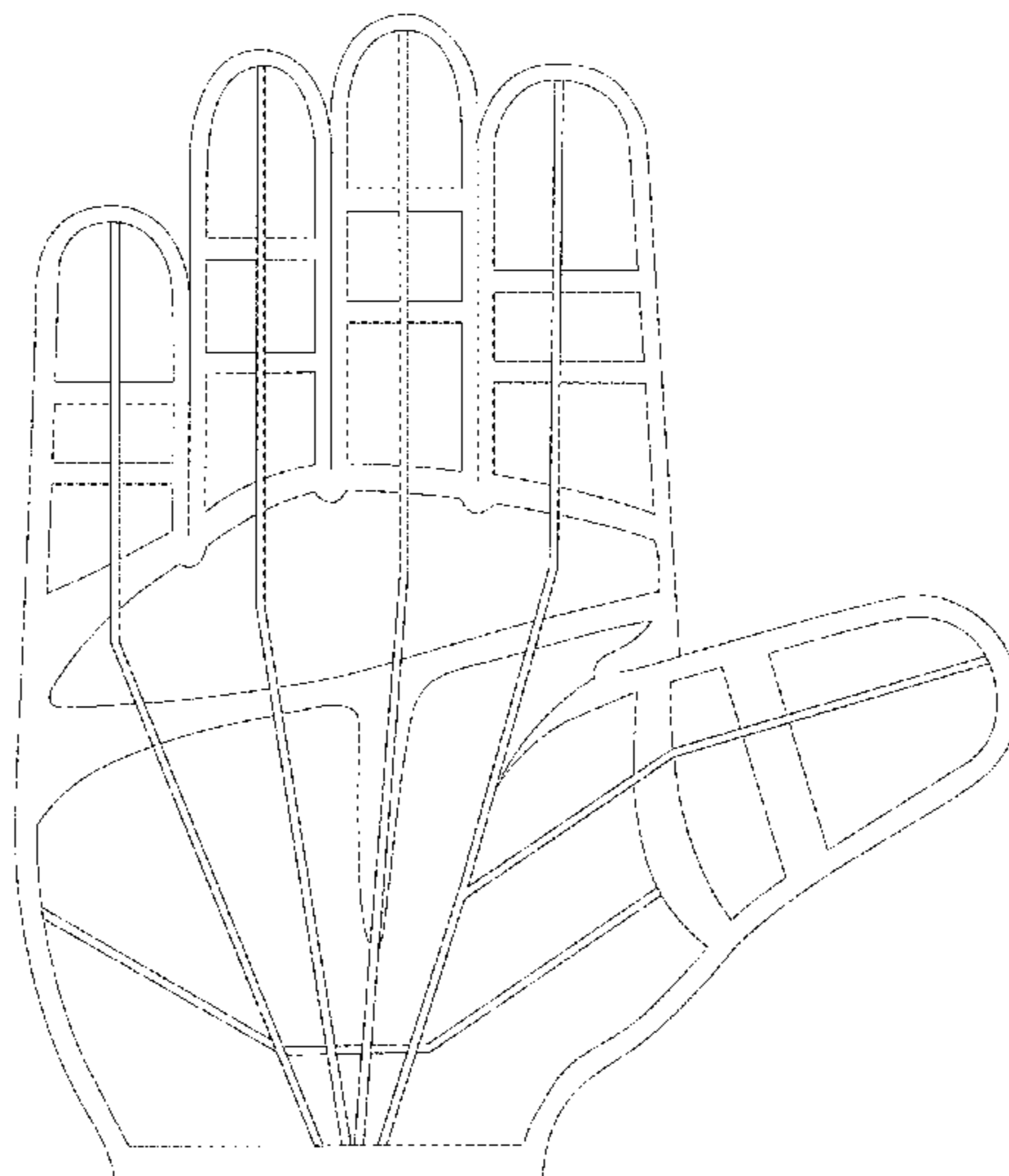
FIG. 1 is a front view of the glove palm showing my new design.

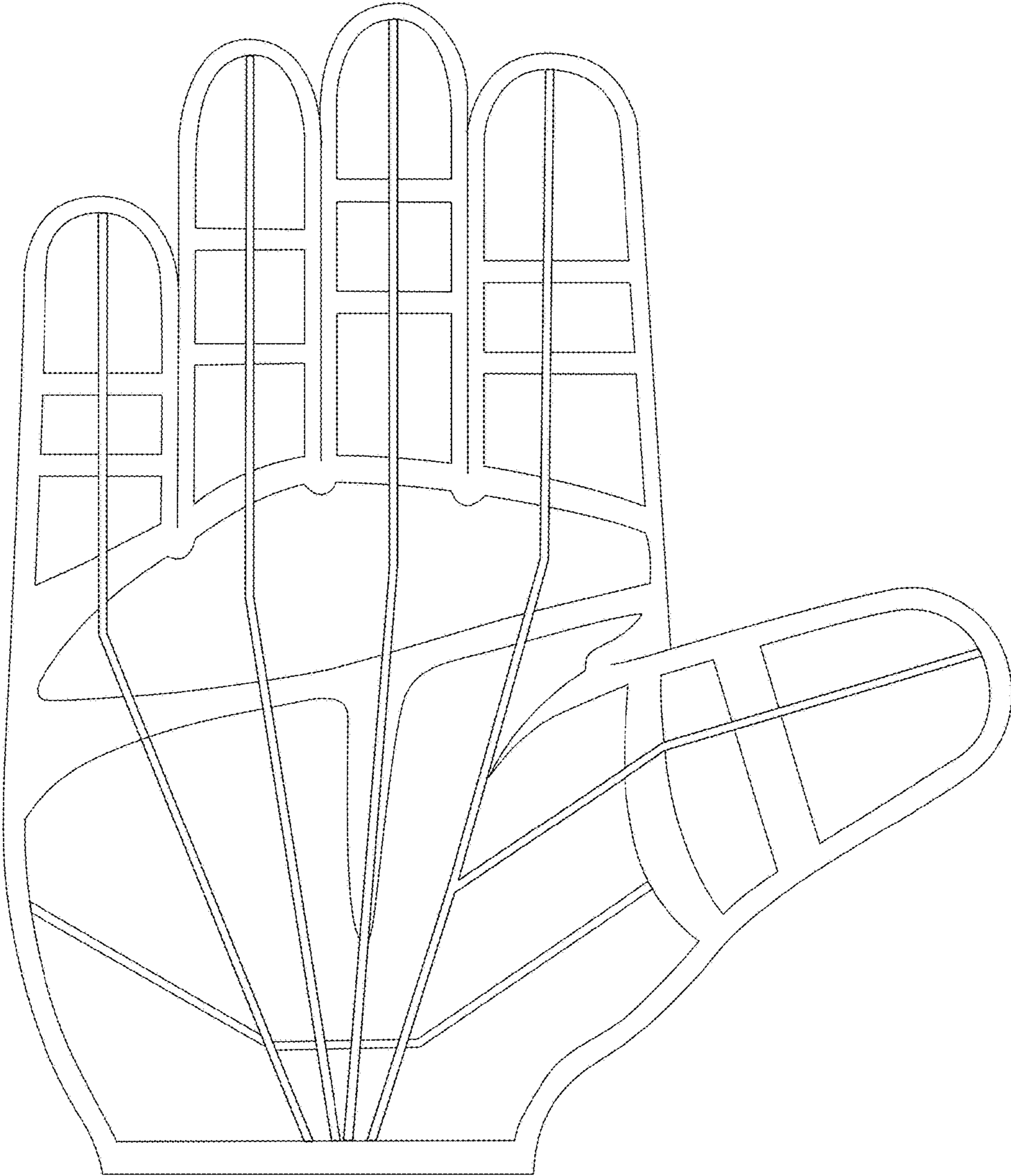

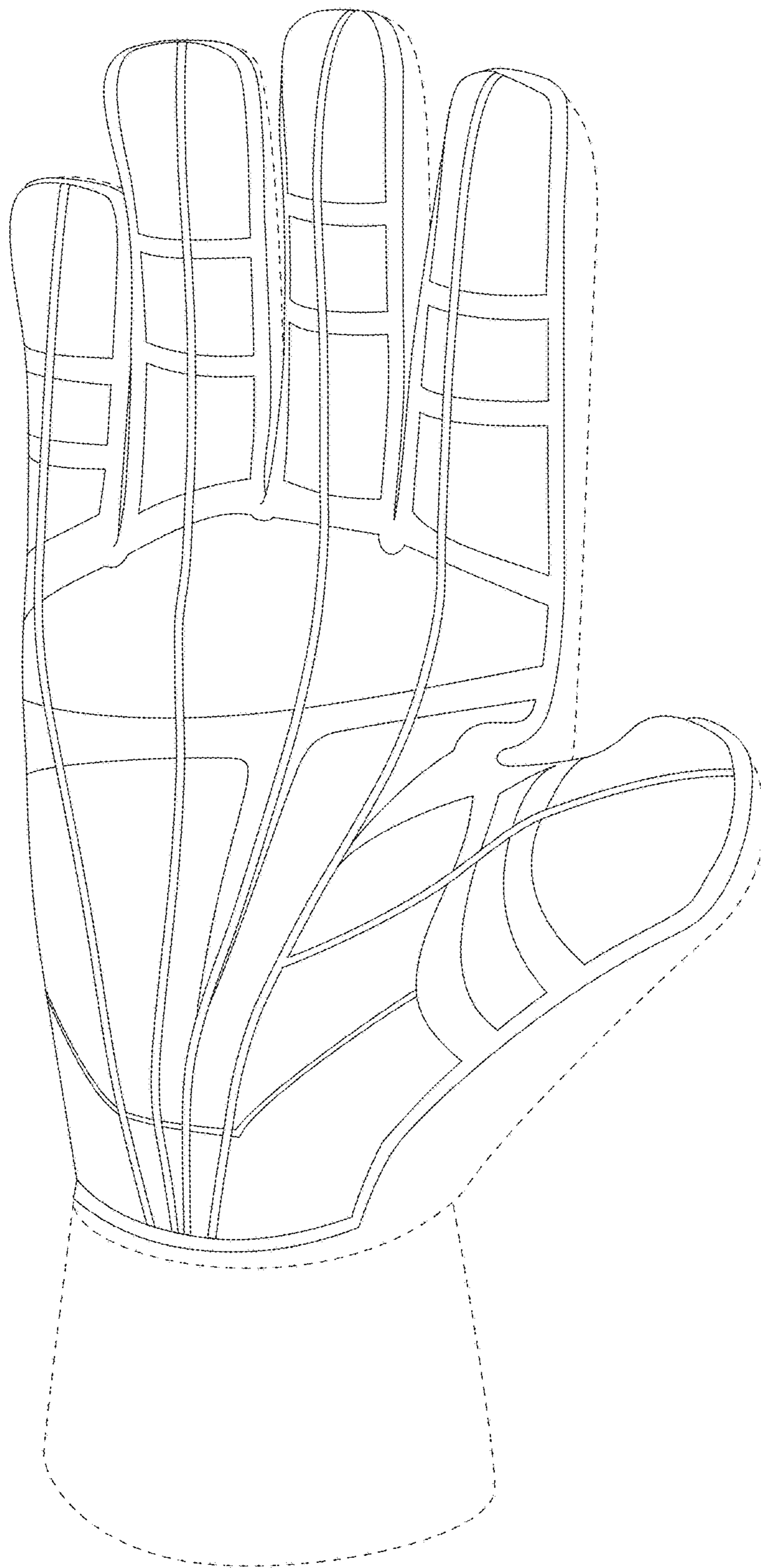

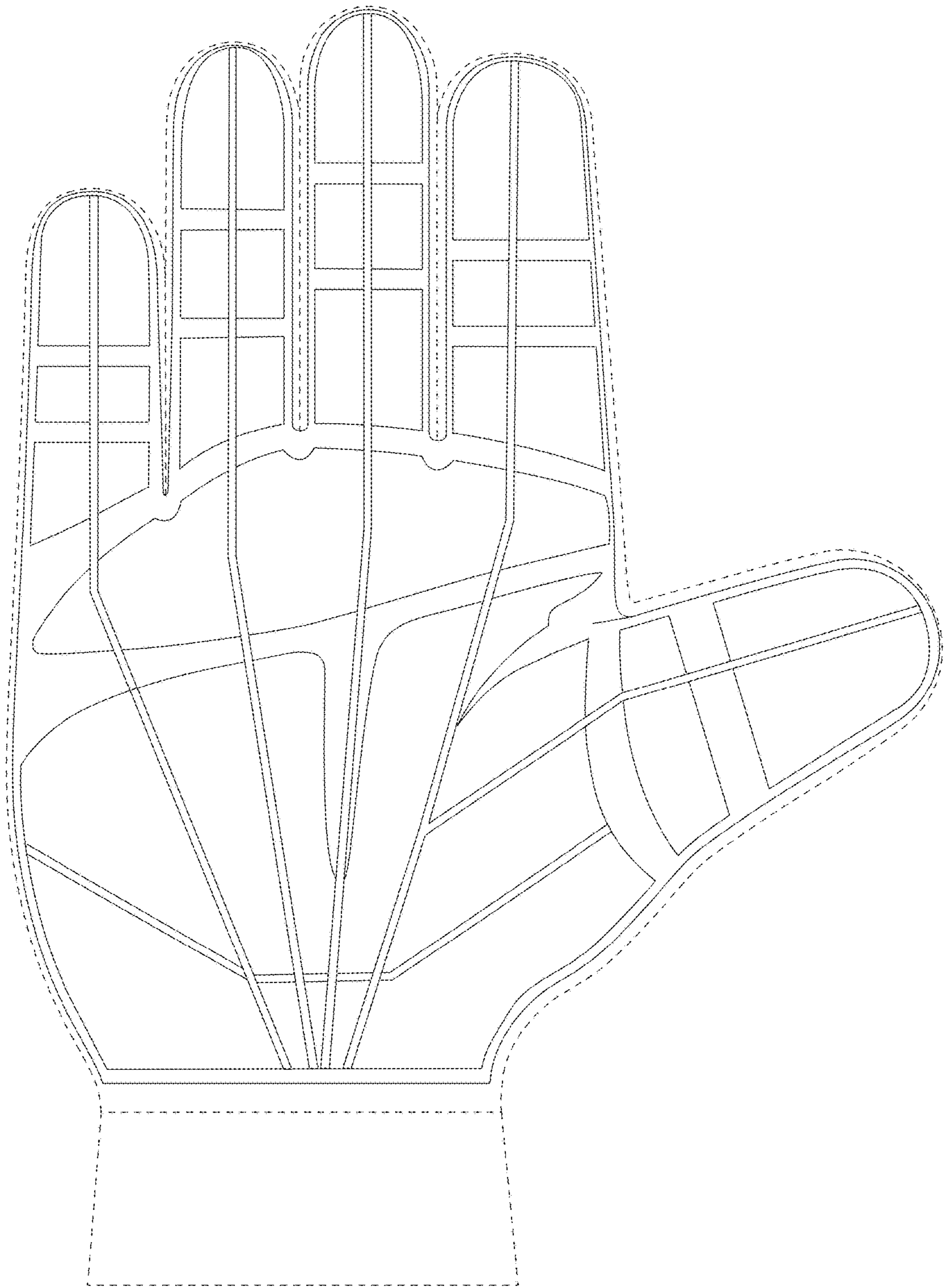

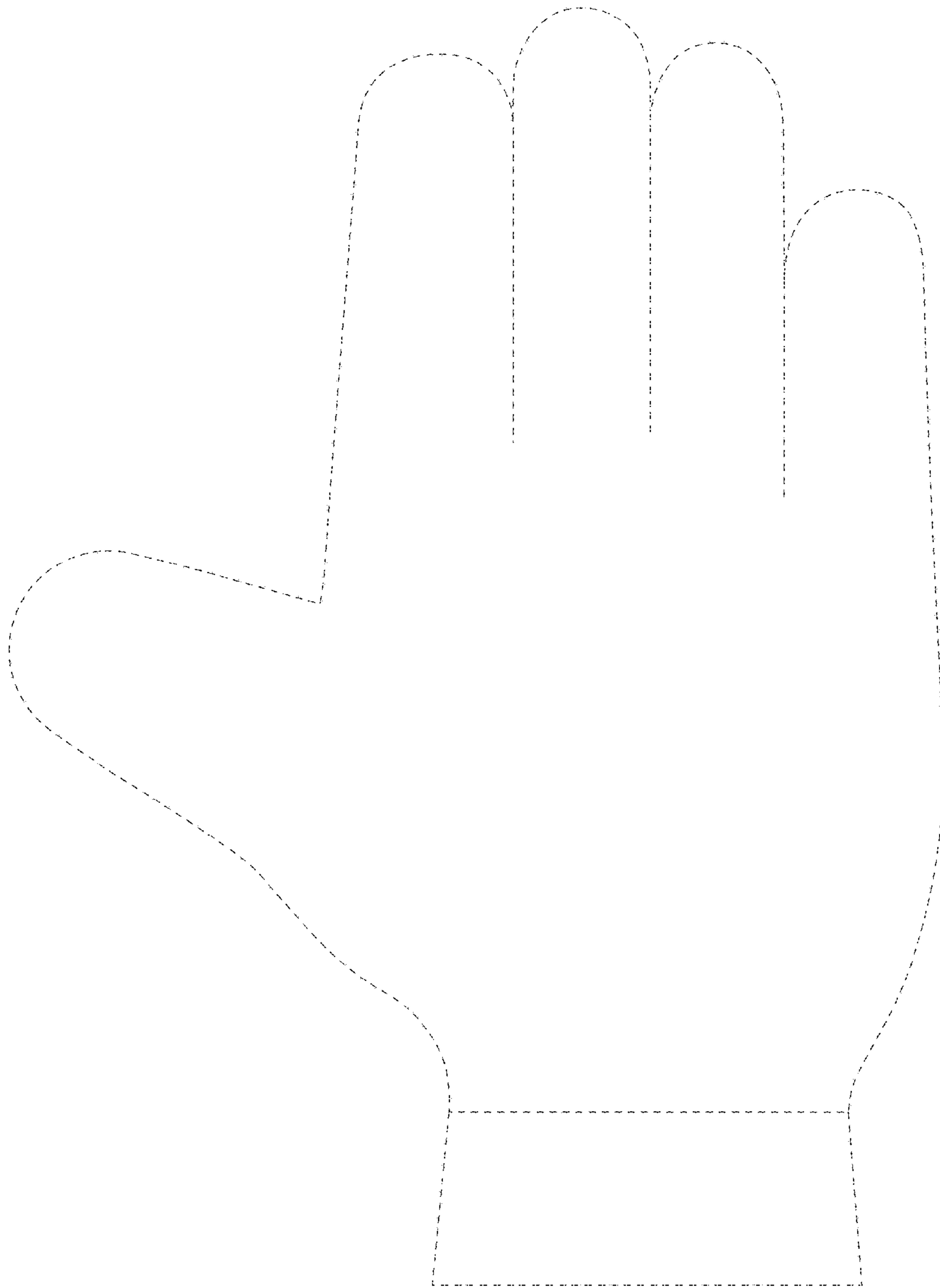

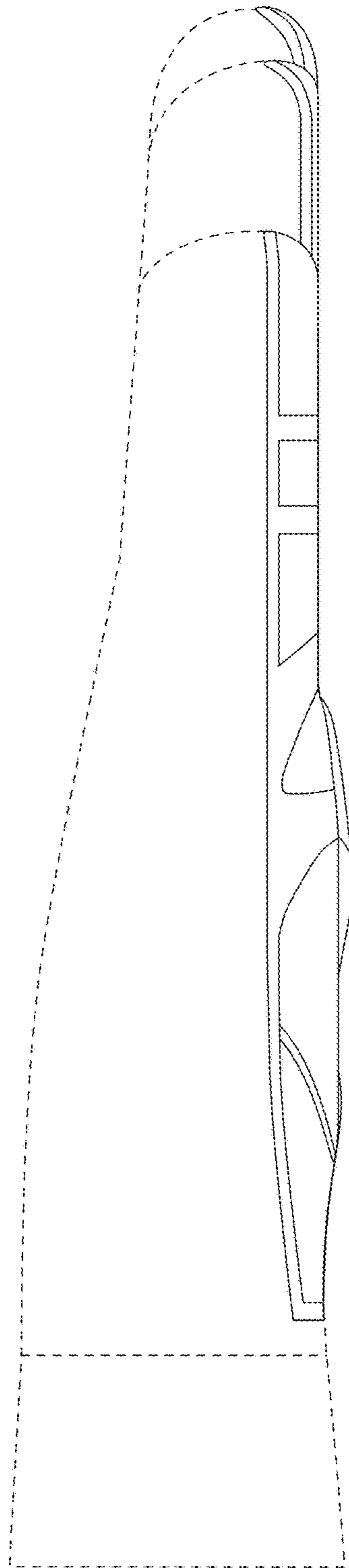

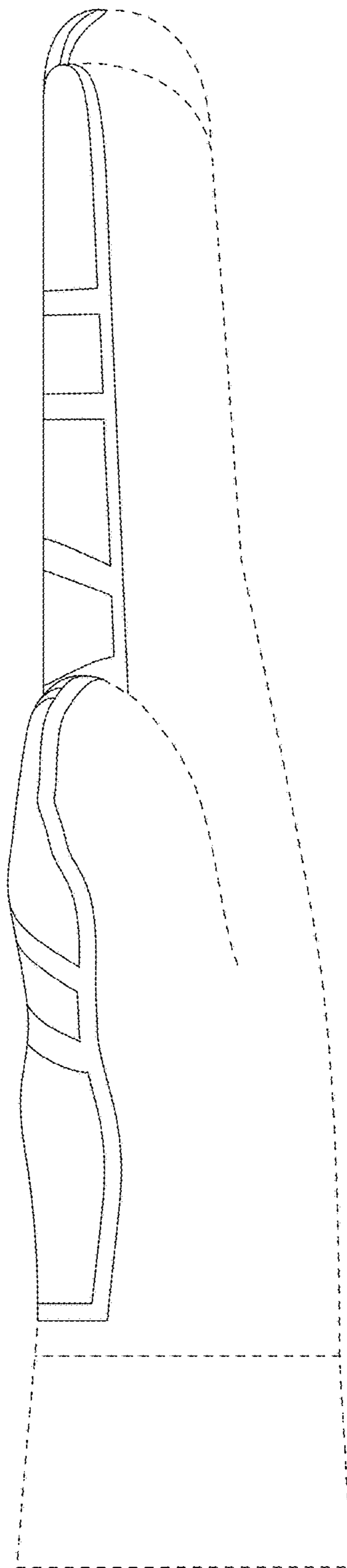

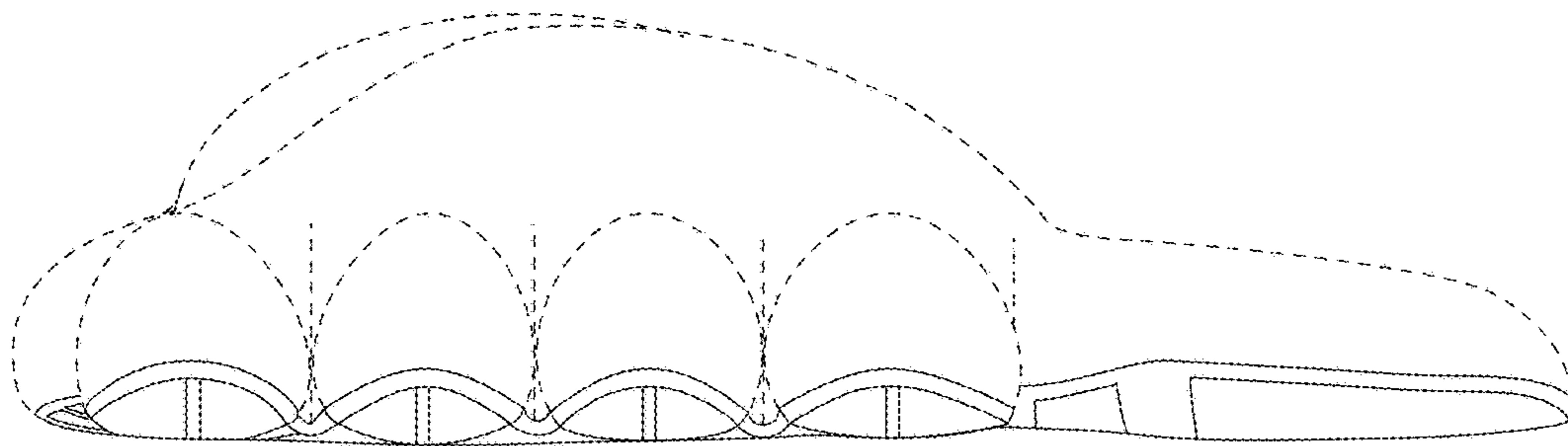

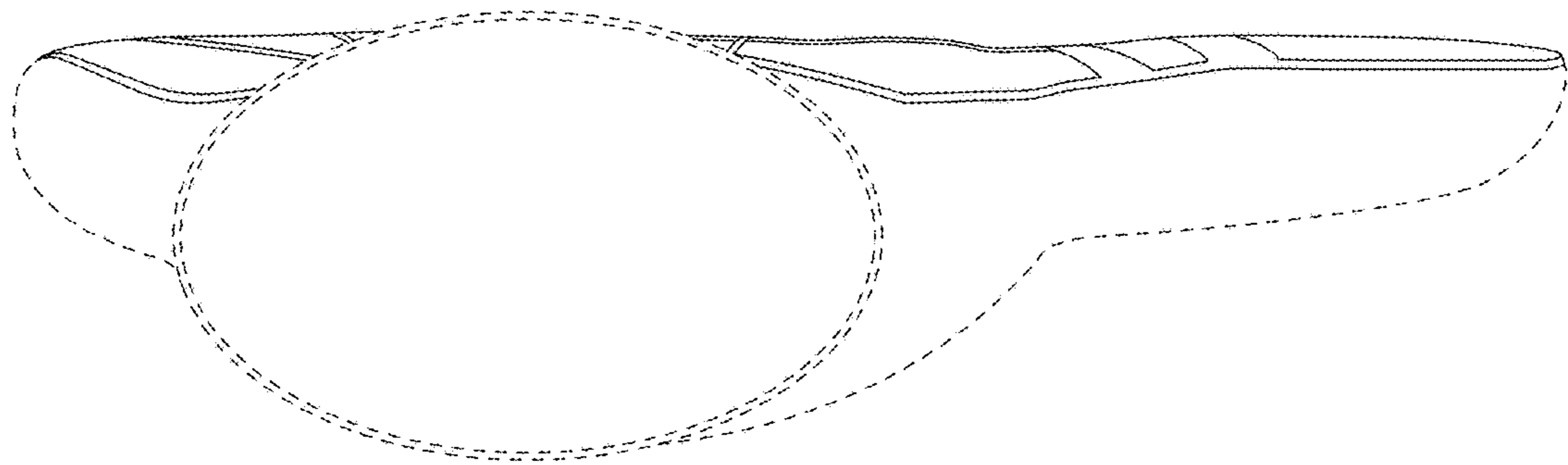
