The ornamental design for a garment, as shown and described.

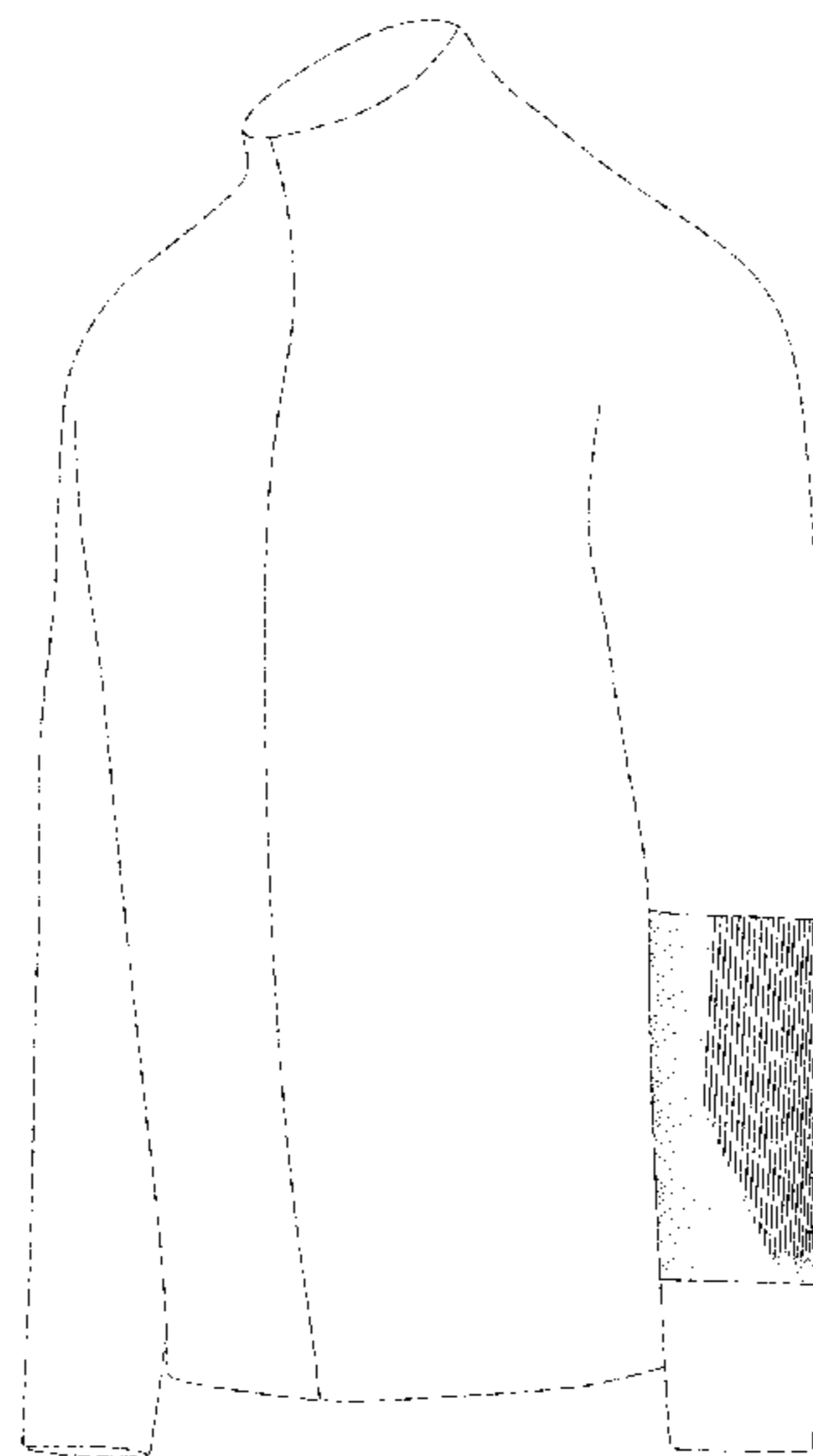
**DESCRIPTION**

FIG. 1 is a front perspective view of a garment showing my new design;

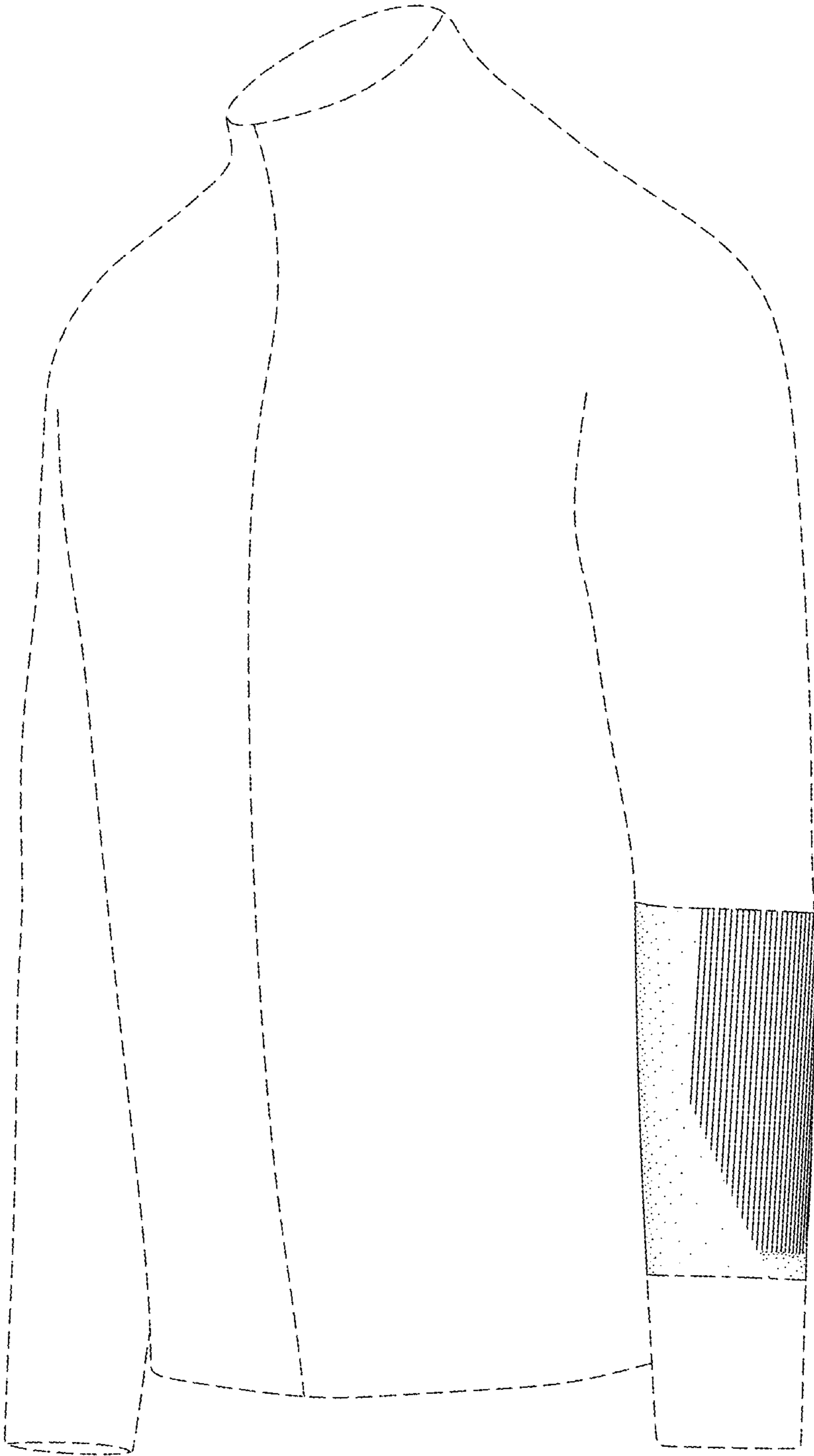

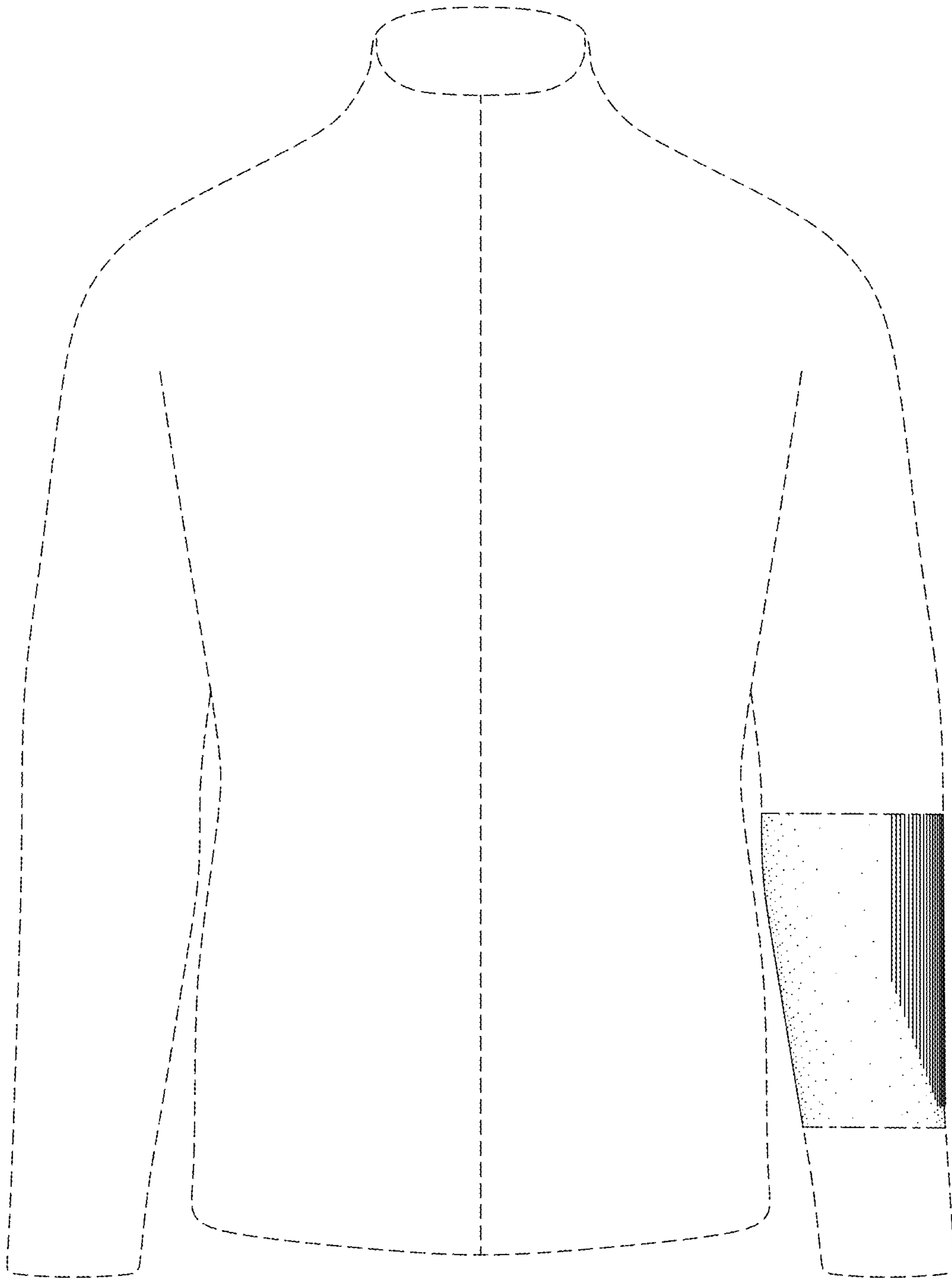

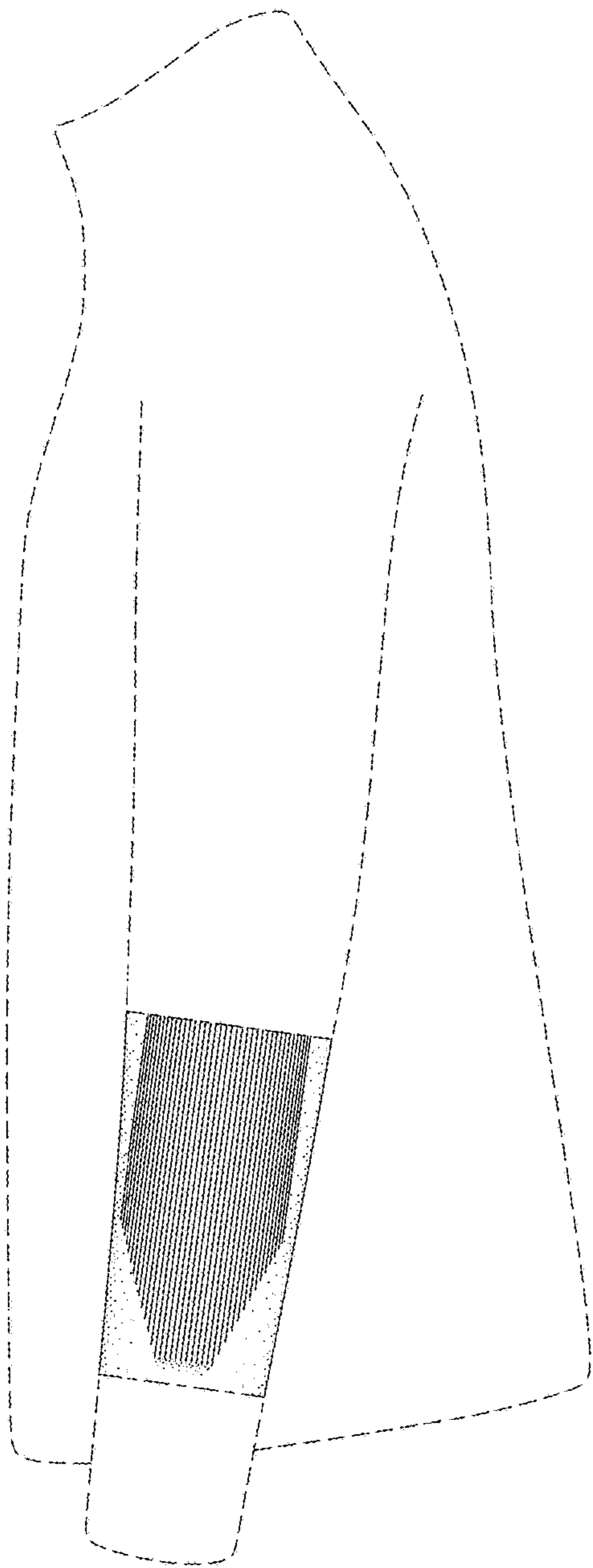

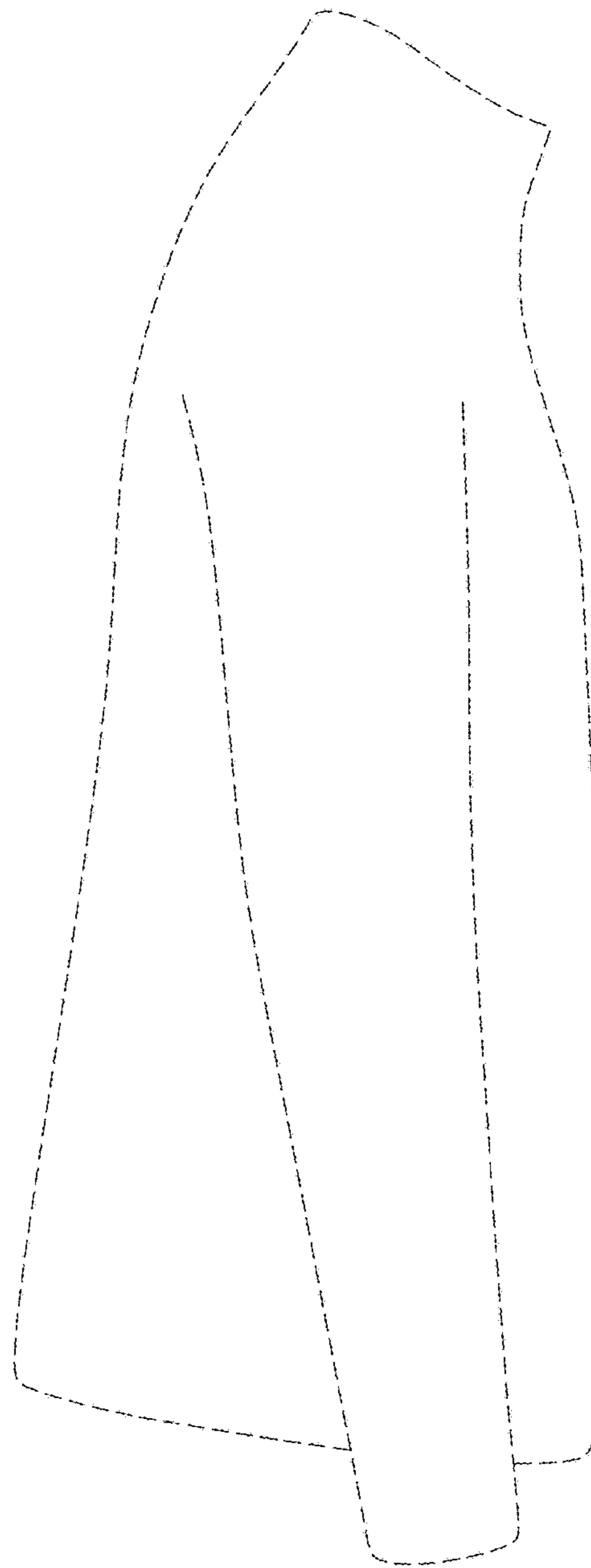

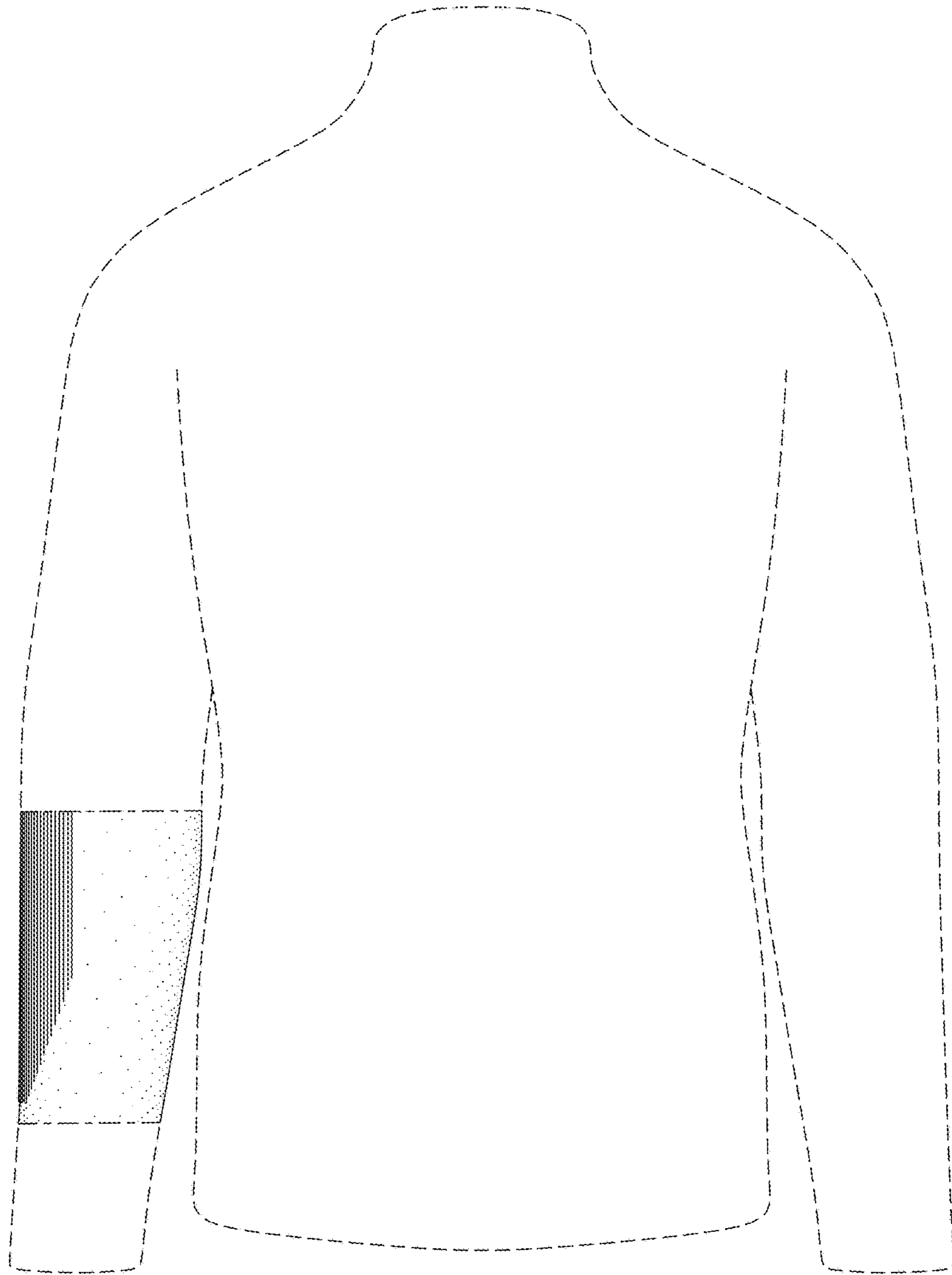

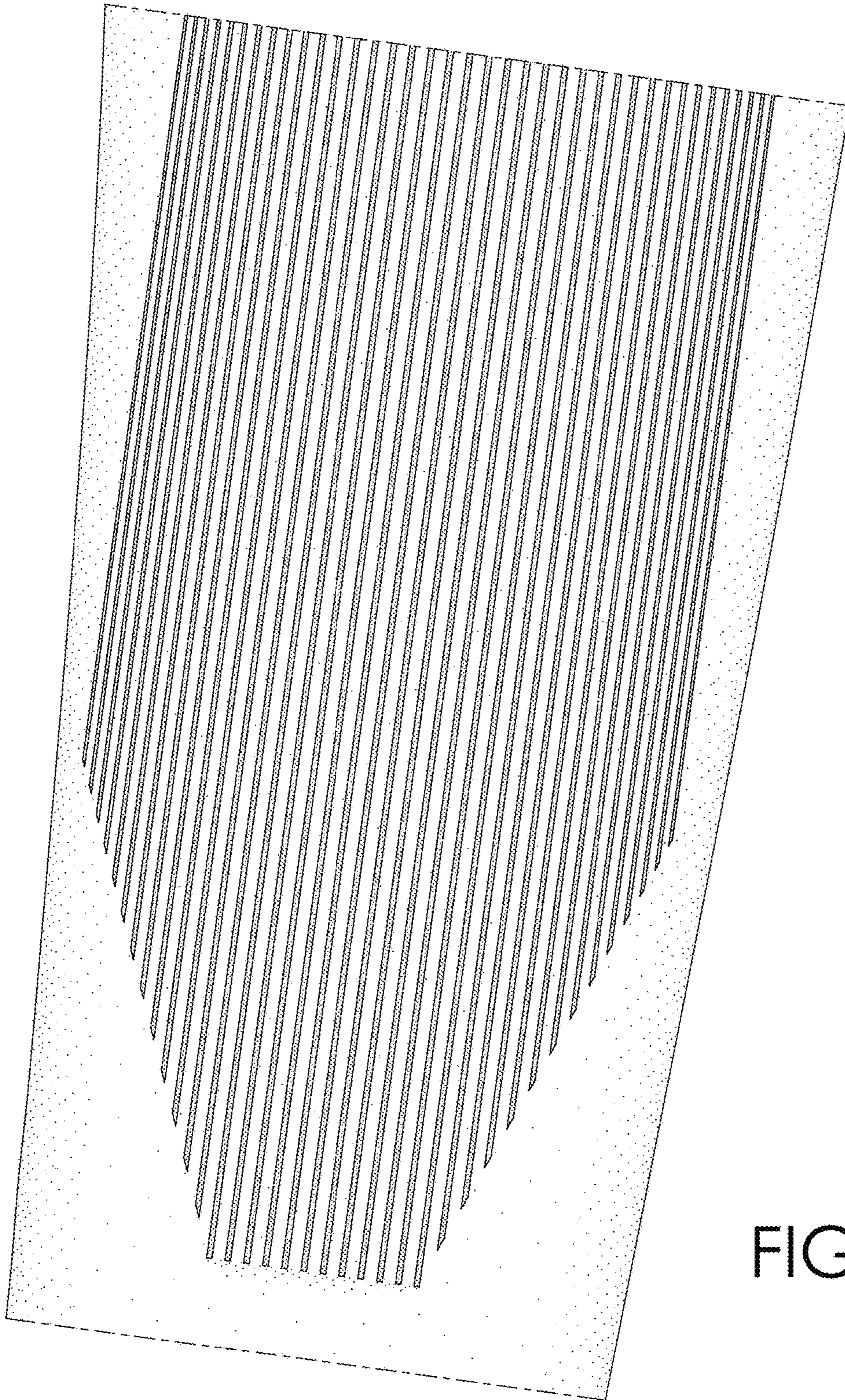
