DESCRIPTION

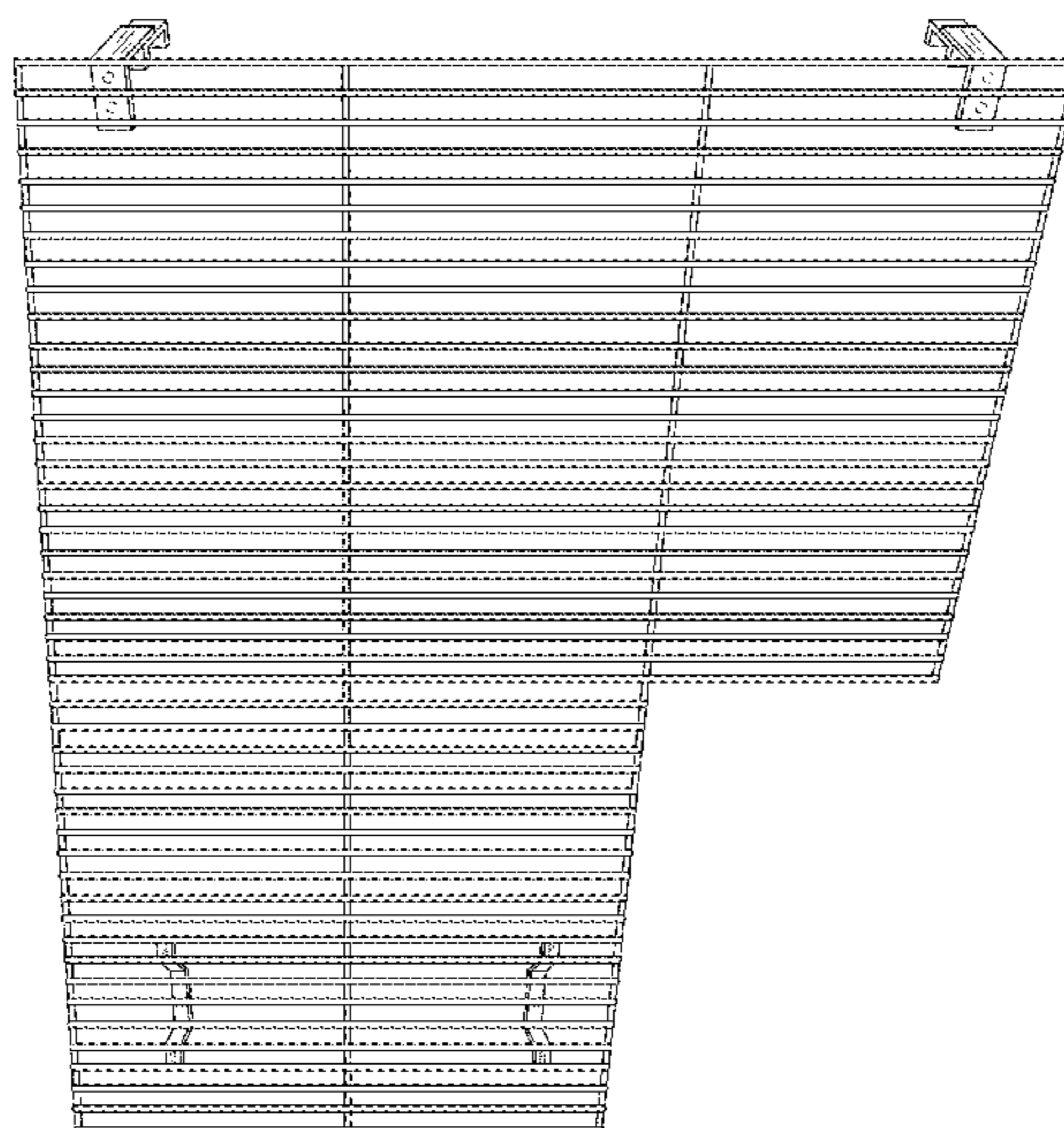
FIG. 1 is a front perspective view of a retail store fixture showing my new design;

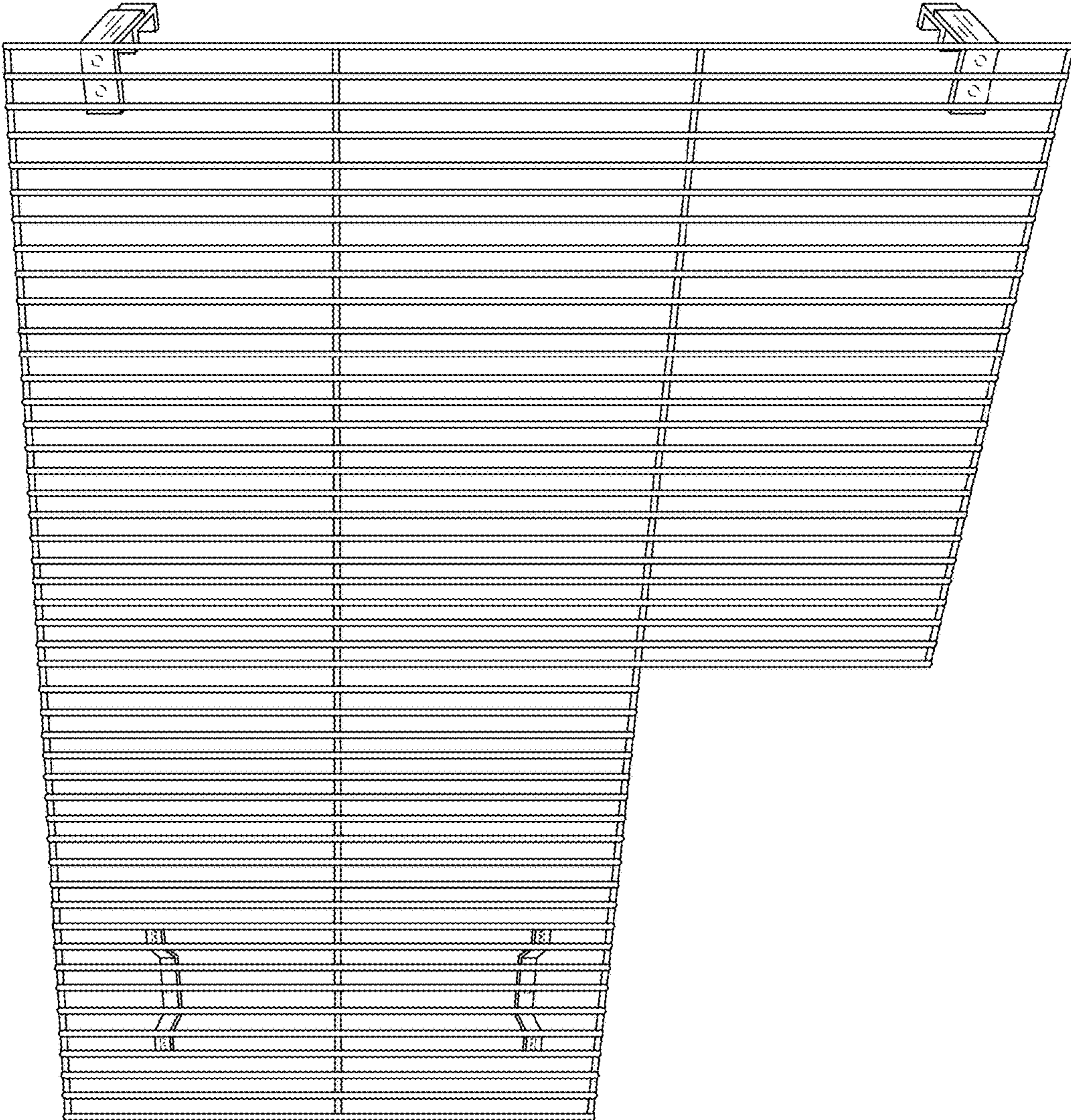

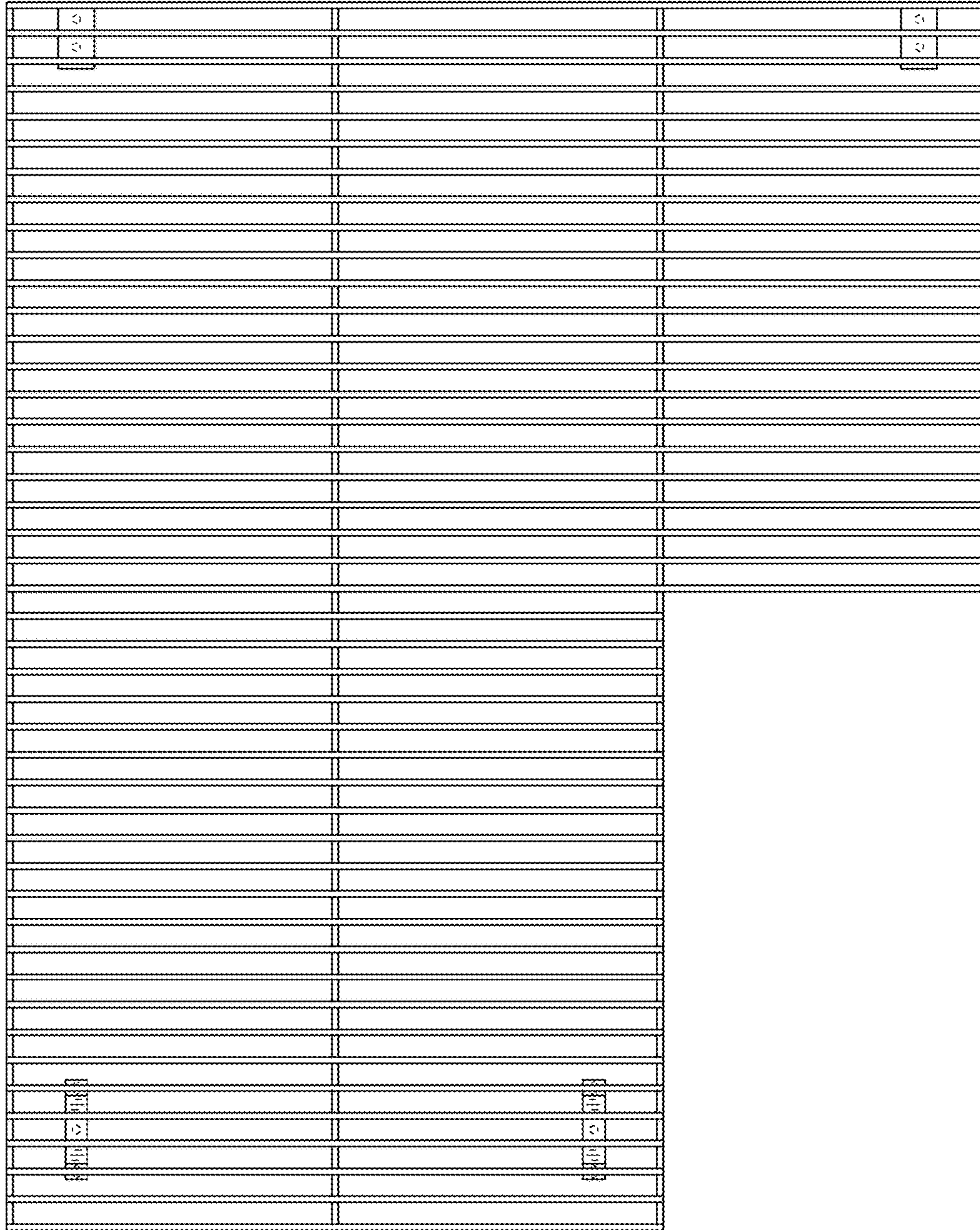

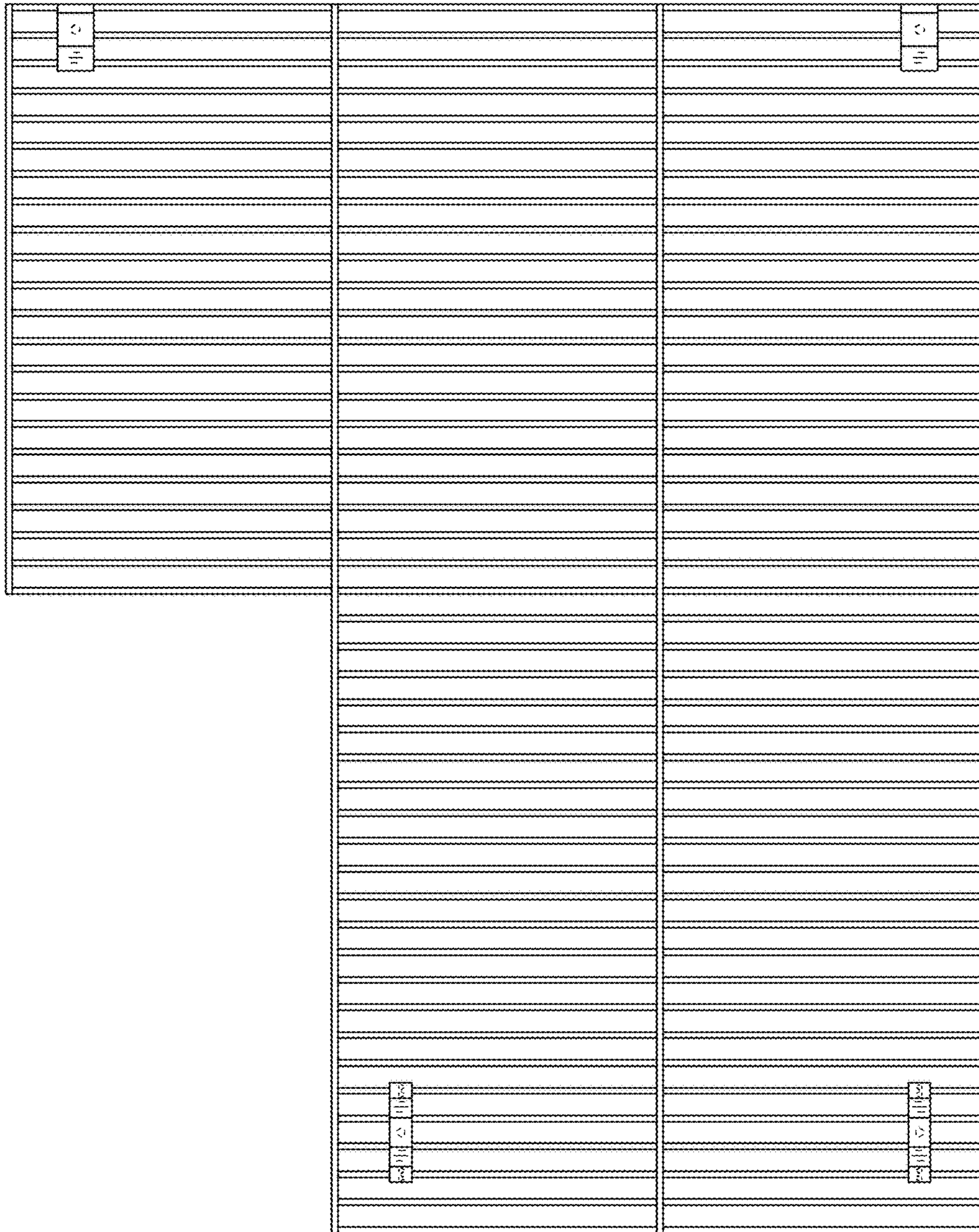

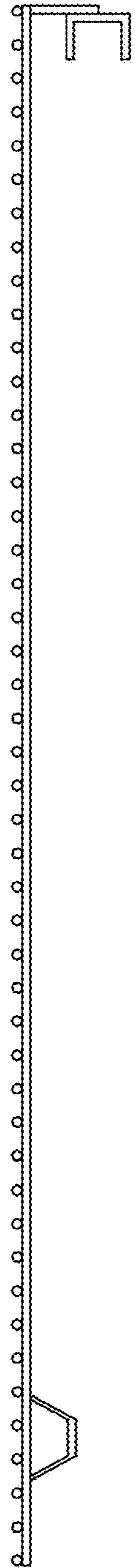

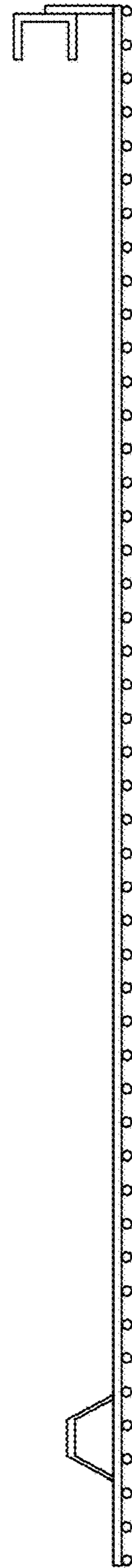

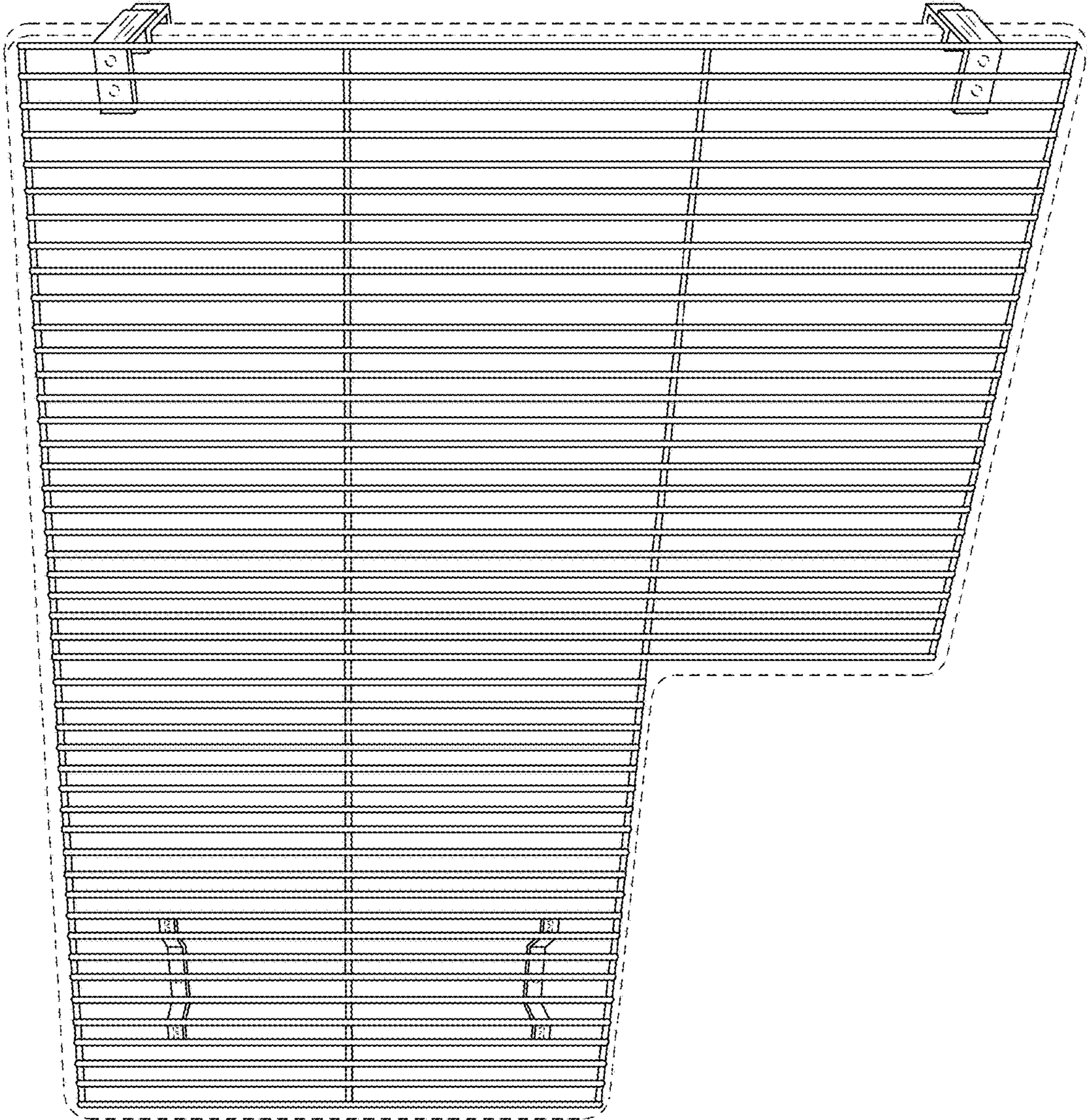
