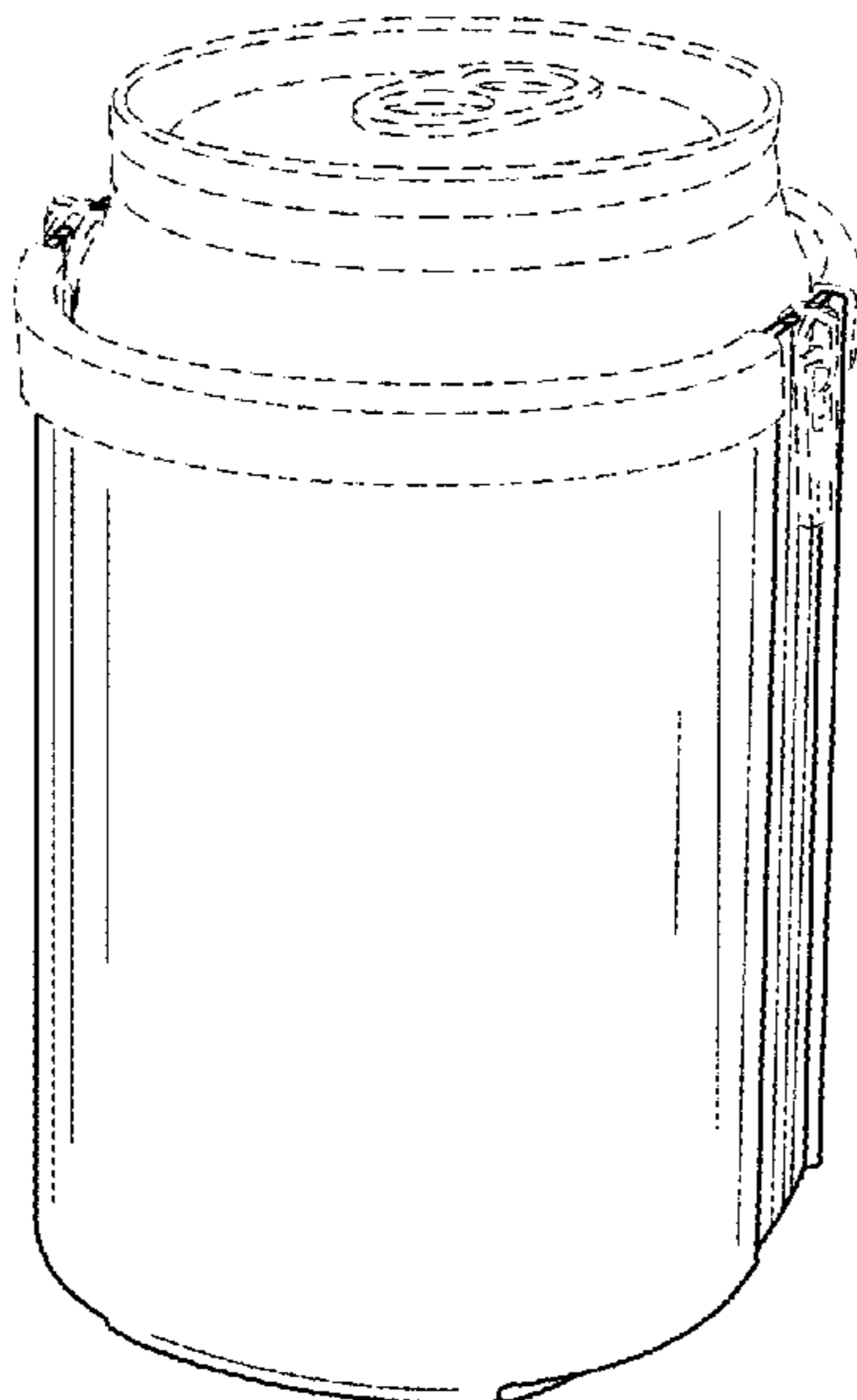

(57) **CLAIM**  
The ornamental design for a vessel holder, as shown and described.

**DESCRIPTION**

FIG. 1 is an illustration of an isometric view of a vessel holder according to a first aspect showing my new design; FIG. 2 is an illustration of a front view of the vessel holder; FIG. 3 is an illustration of a back view of the vessel holder; FIG. 4 is an illustration of a right side view of the vessel holder; FIG. 5 is an illustration of a left side view of the vessel holder; FIG. 6 is an illustration of a top view of the vessel holder; and FIG. 7 is an illustration of a bottom view of the vessel holder. FIG. 8 is an illustration of an isometric view of the vessel holder showing a second aspect of my new design; FIG. 9 is an illustration of a front view of the vessel holder; FIG. 10 is an illustration of a back view of the vessel holder; FIG. 11 is an illustration of a right side view of the vessel holder; FIG. 12 is an illustration of a left side view of the vessel holder; FIG. 13 is an illustration of a top view of the vessel holder; and, FIG. 14 is an illustration of a bottom view of the vessel holder. The broken lines immediately adjacent the shaded surfaces represent the bounds of the claimed design. All other broken lines depict environmental subject matter that forms no part of the claimed design. The broken lines and unshaded regions bounded by broken lines form no part of the claimed design.

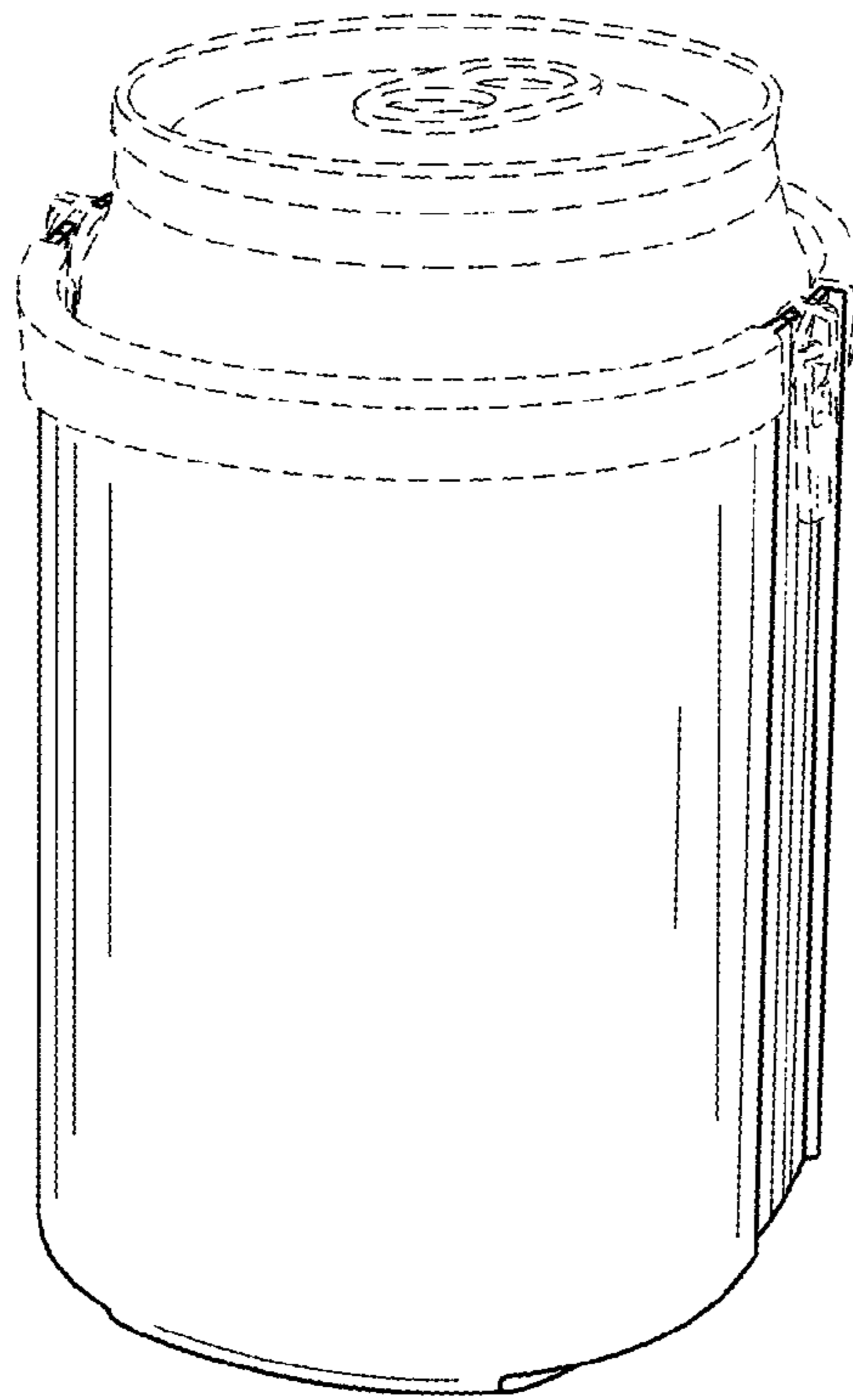

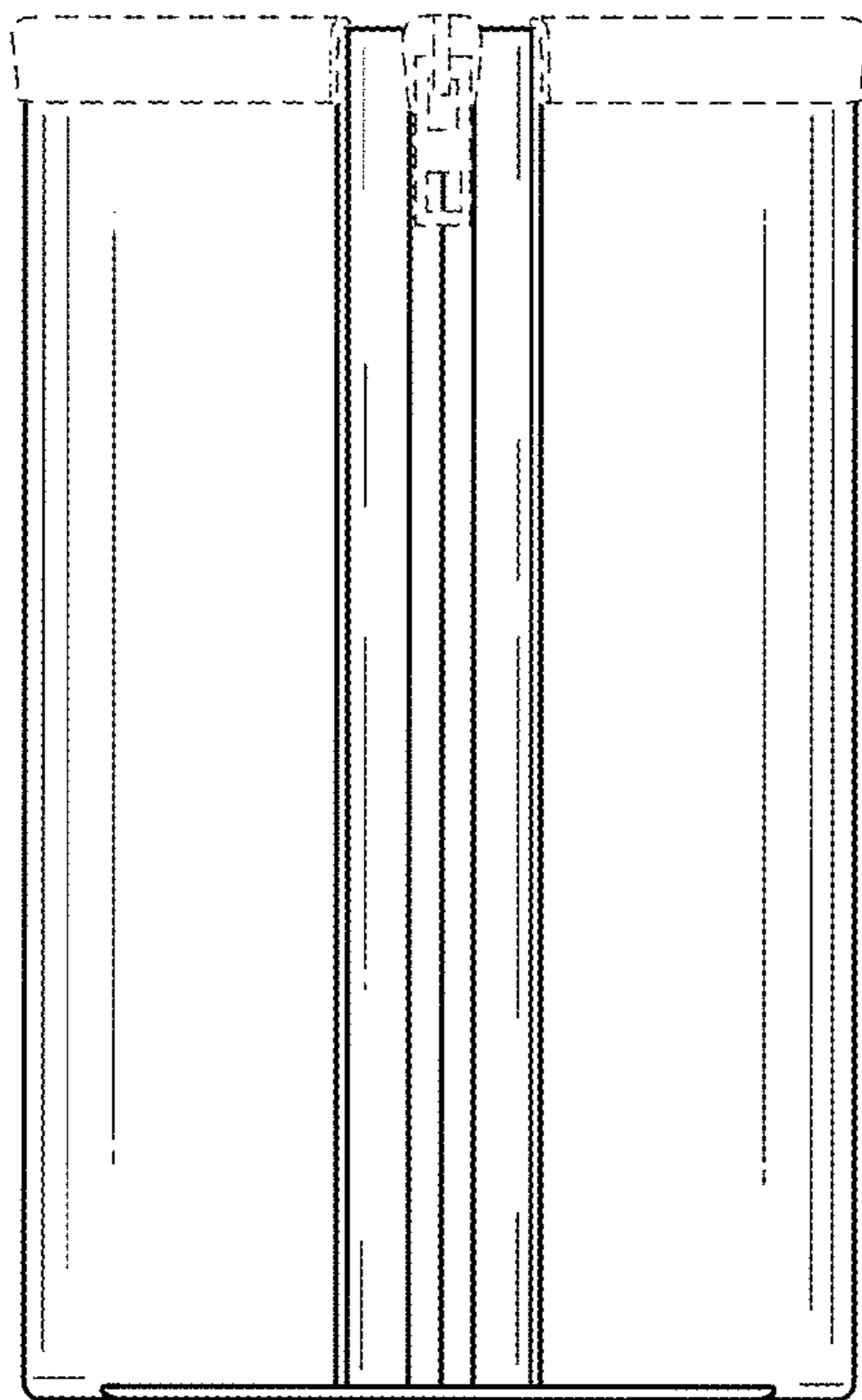

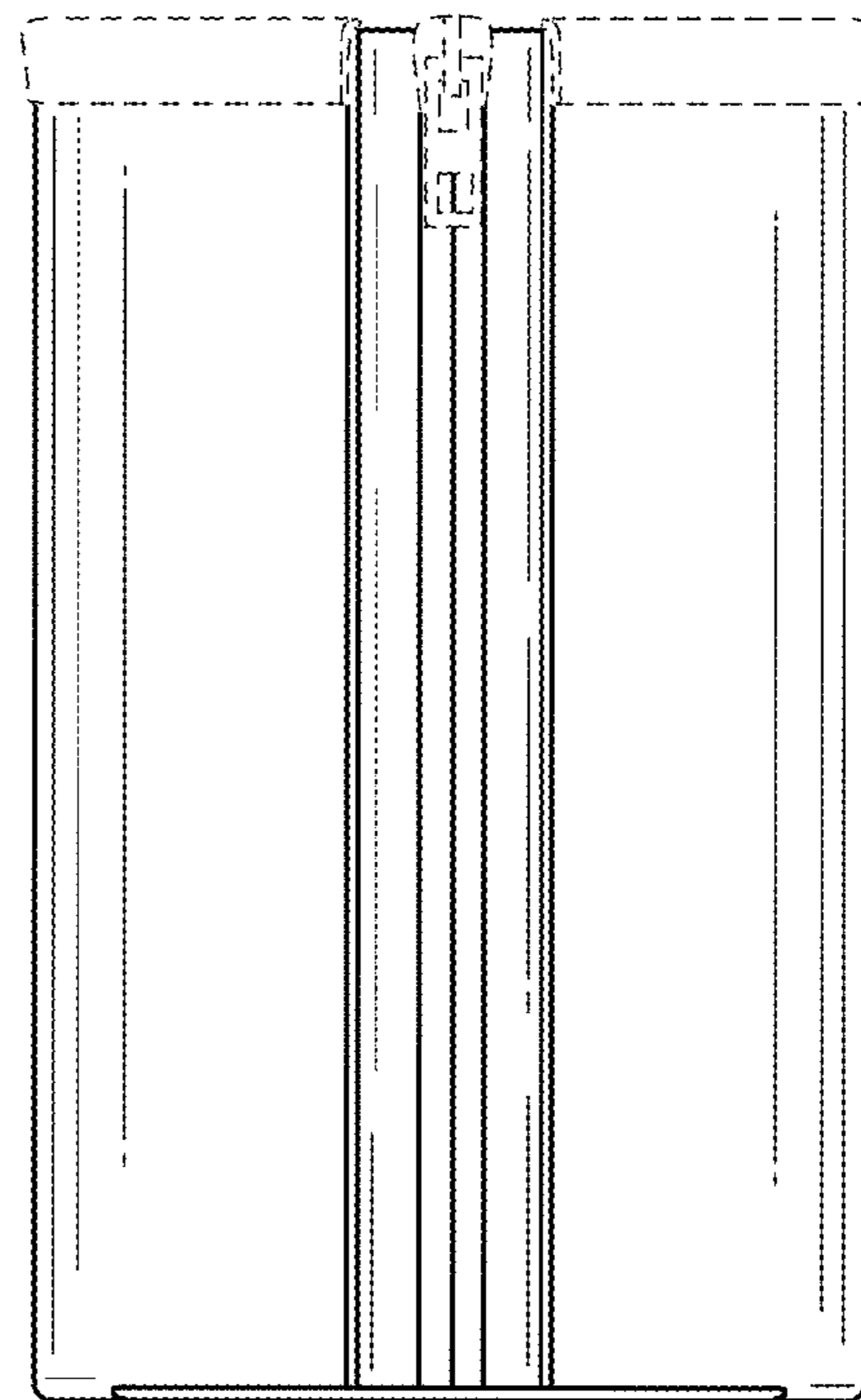

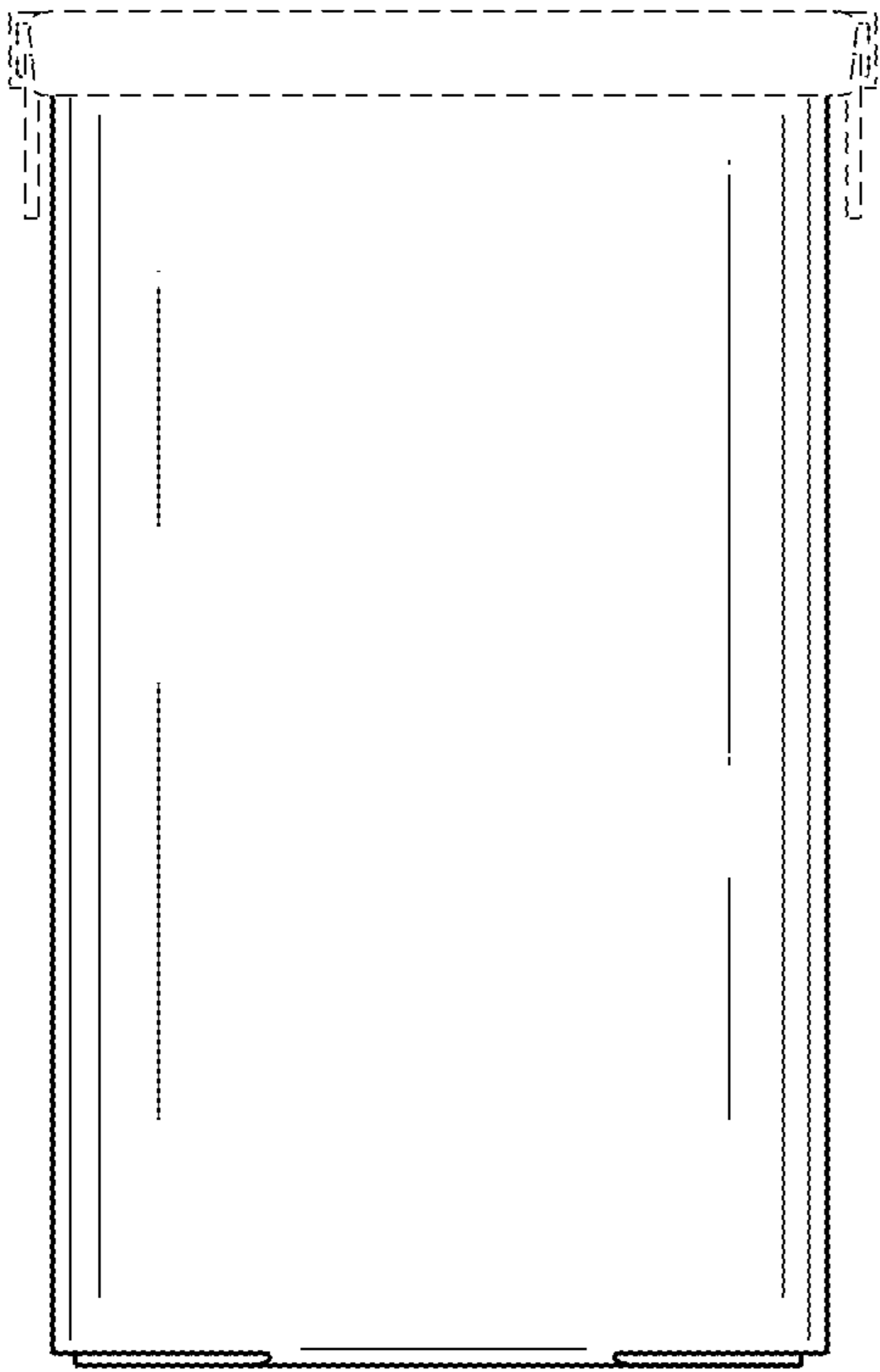

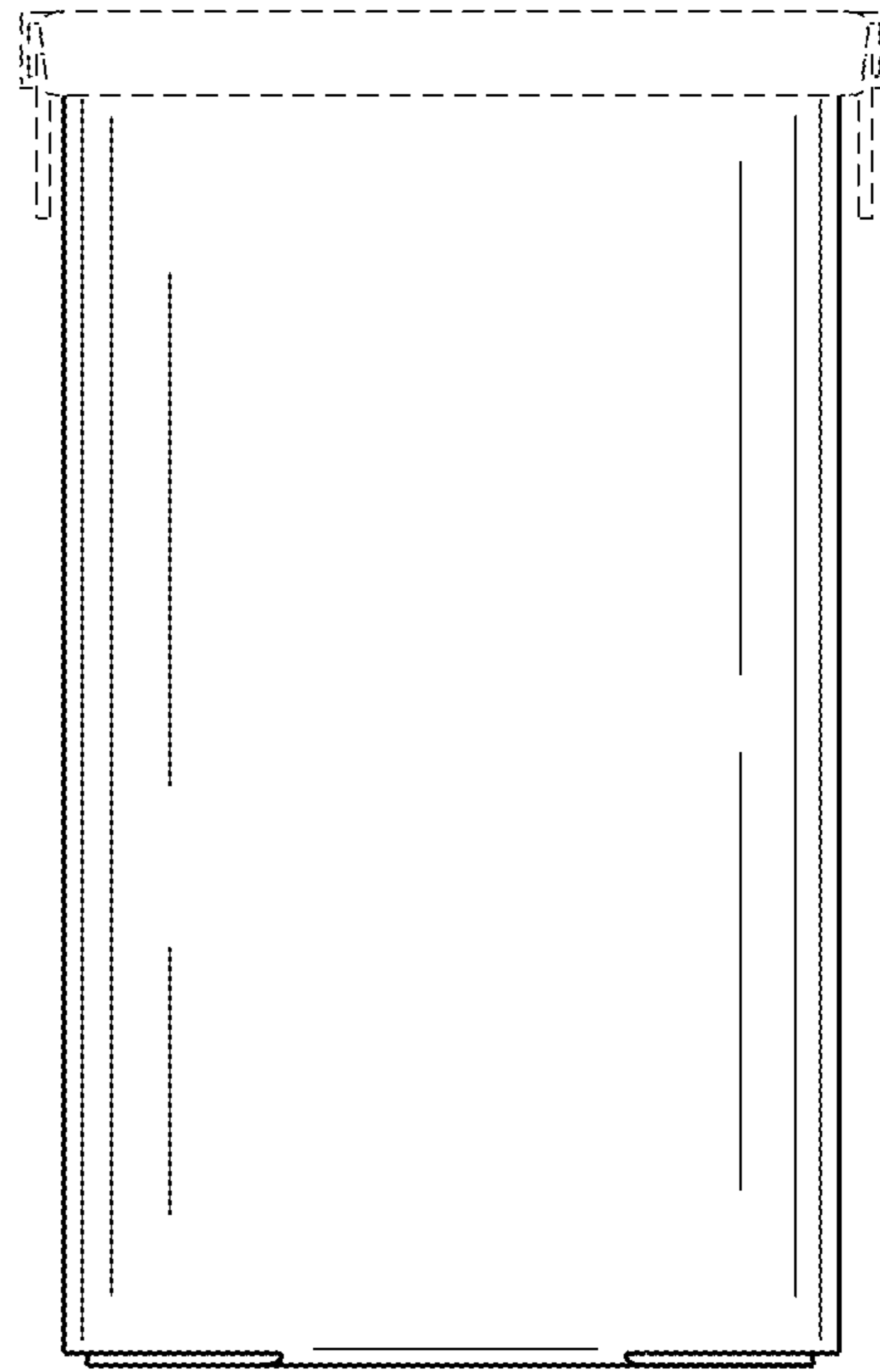

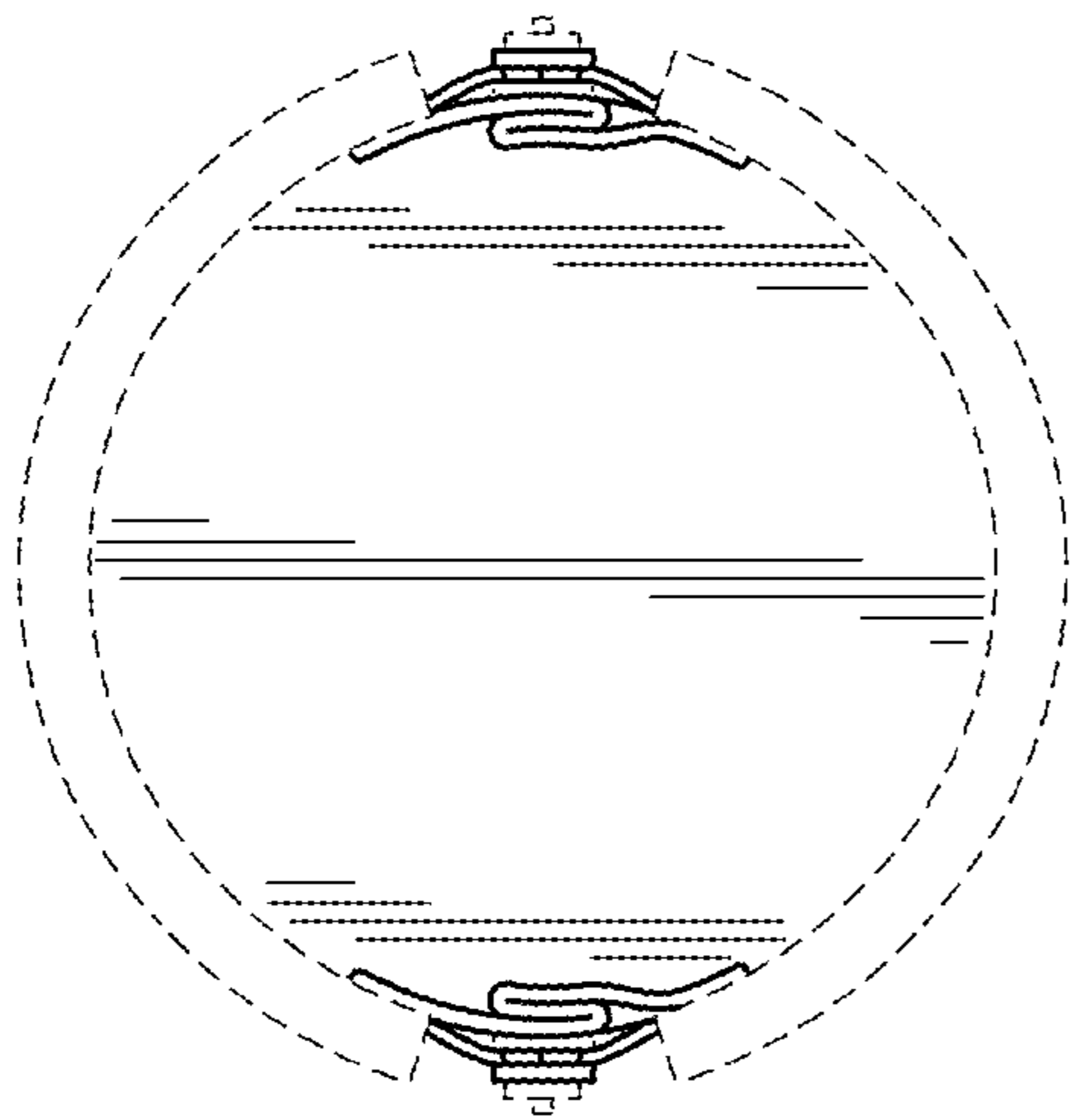

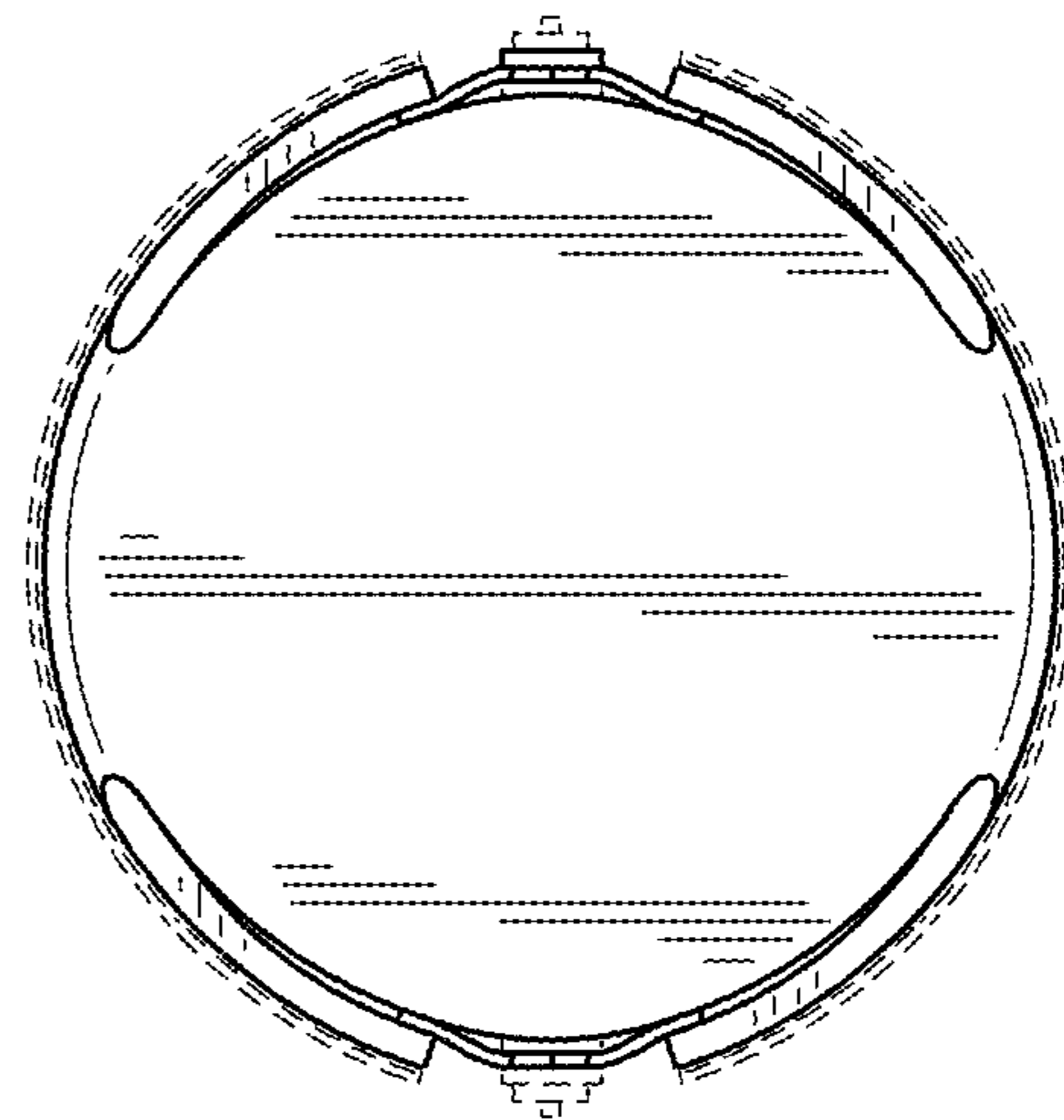

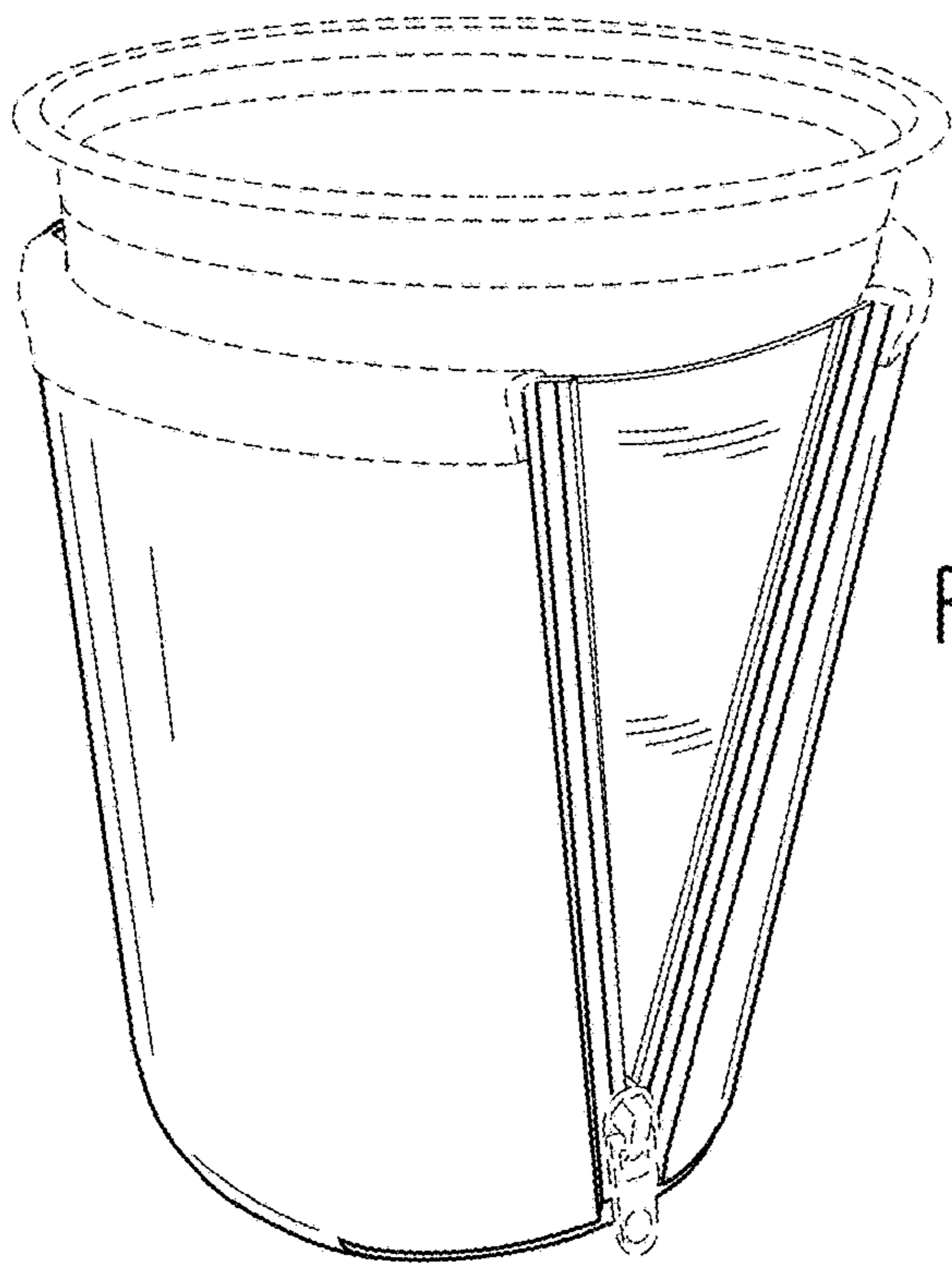

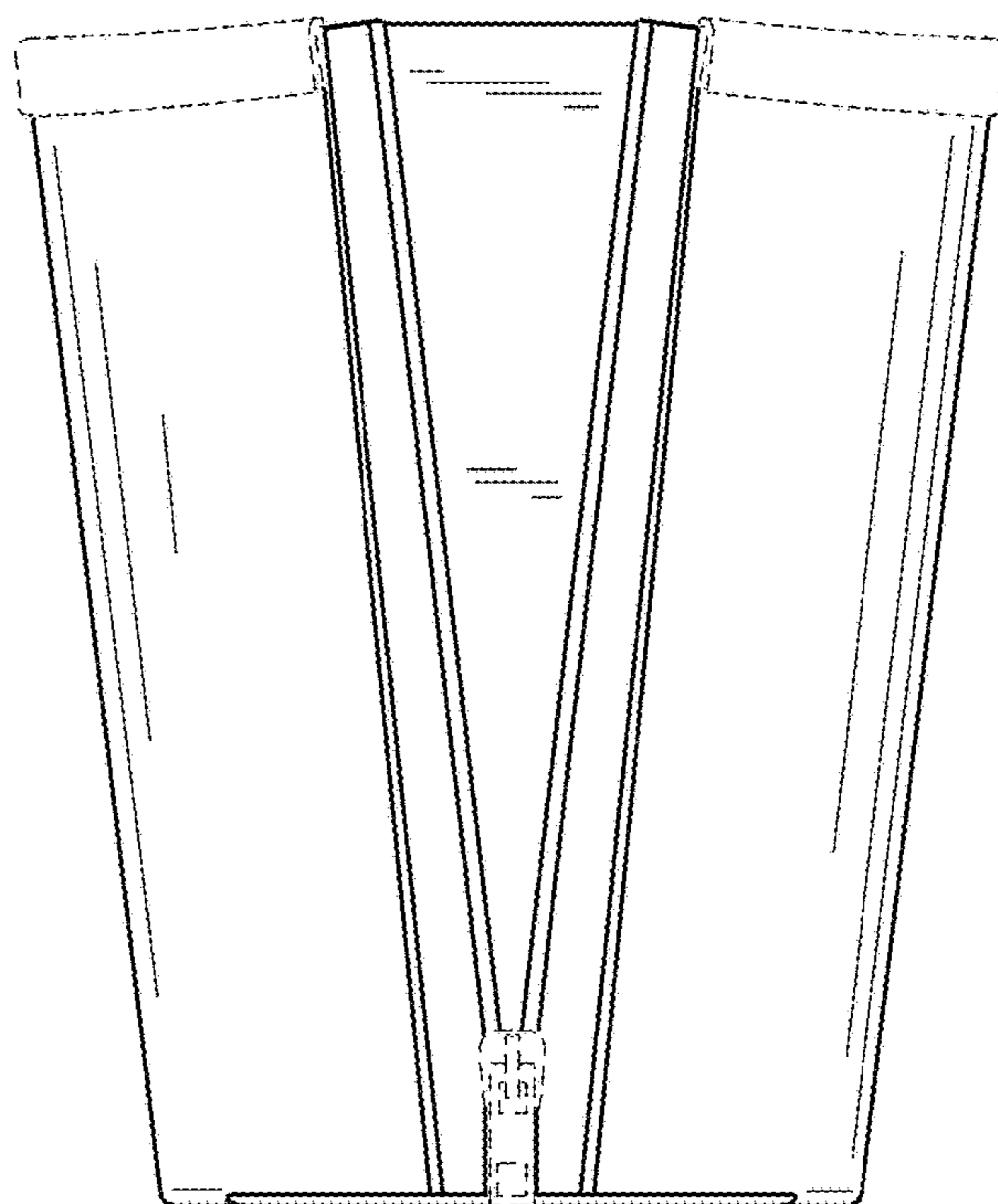

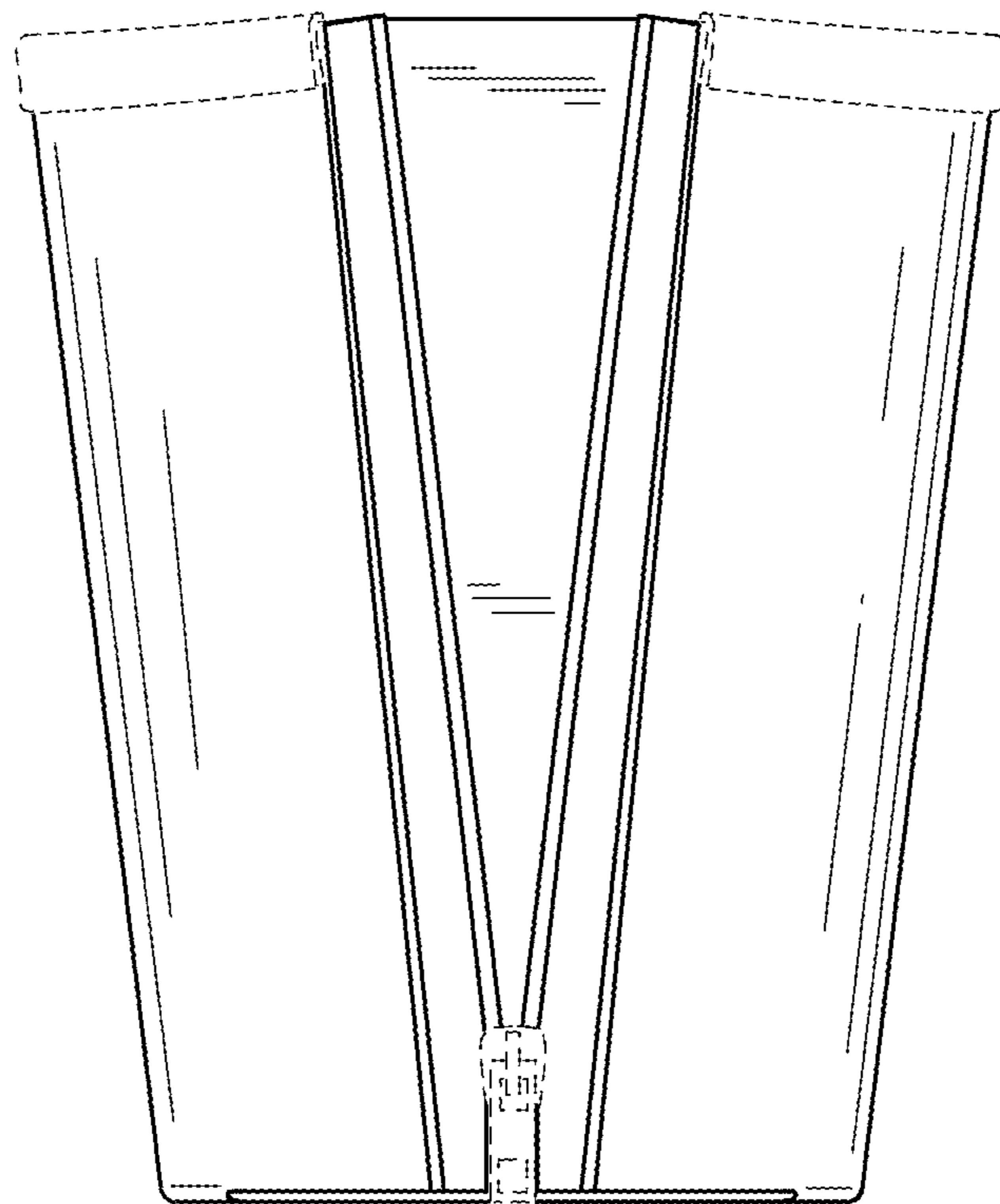

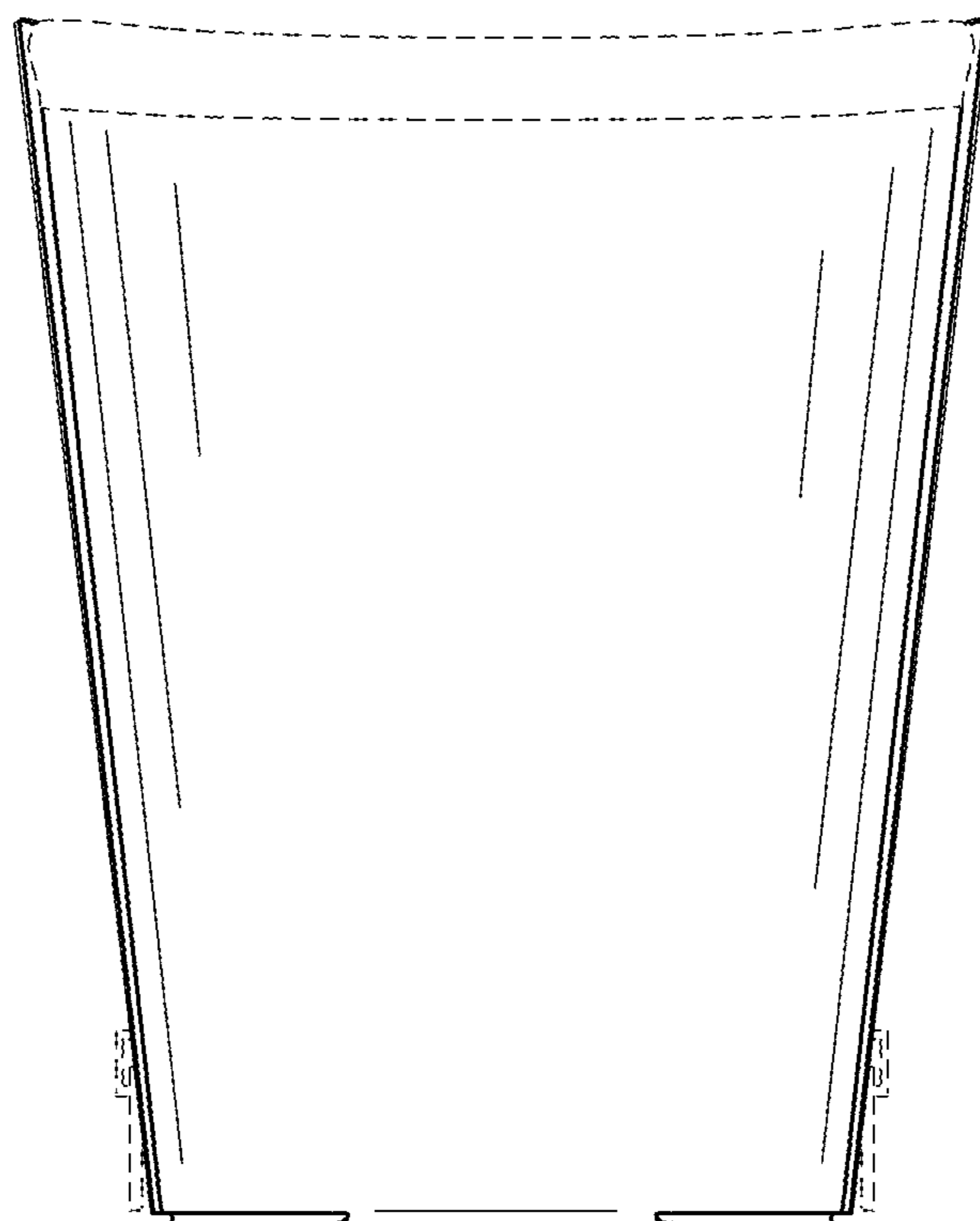

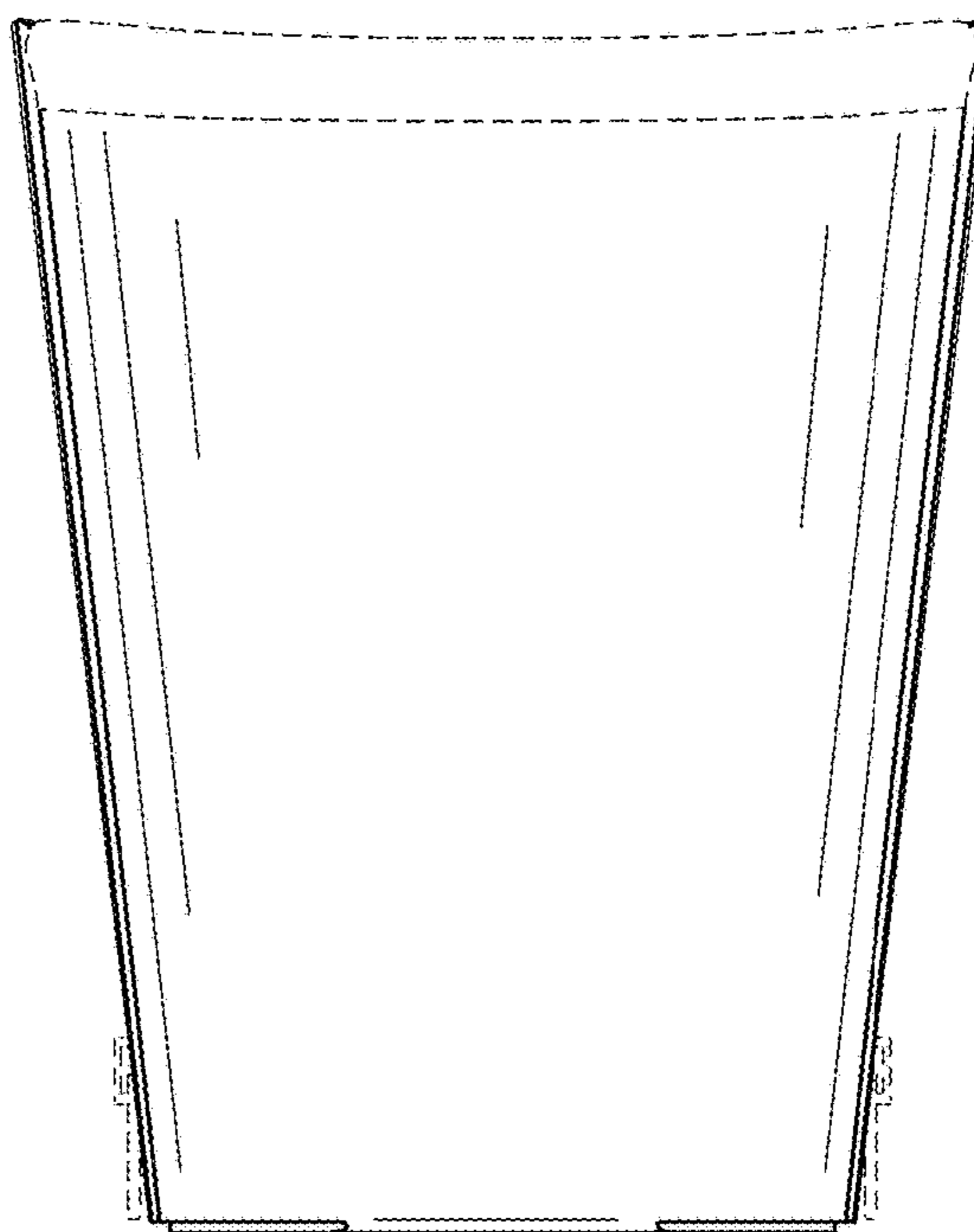

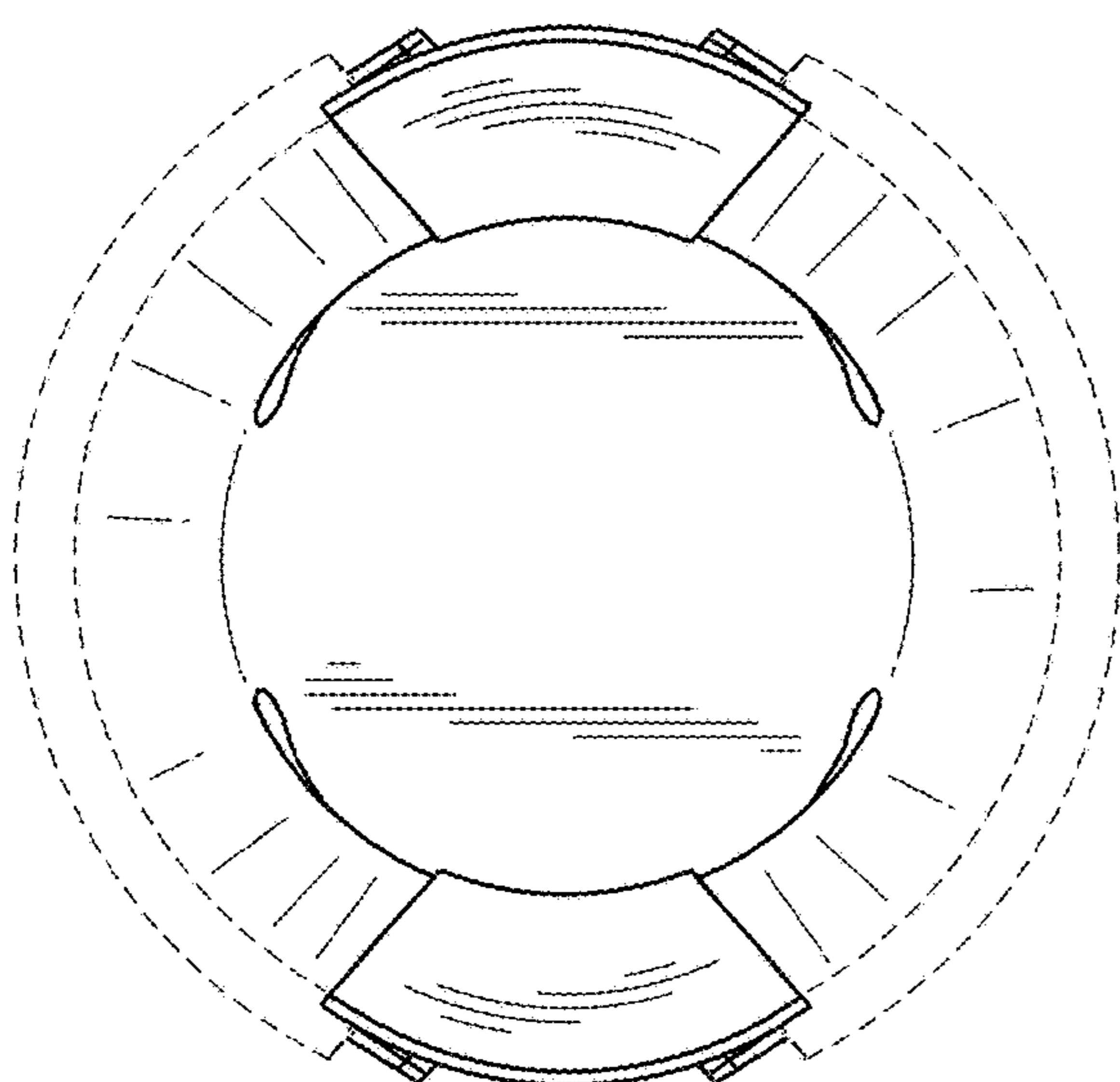

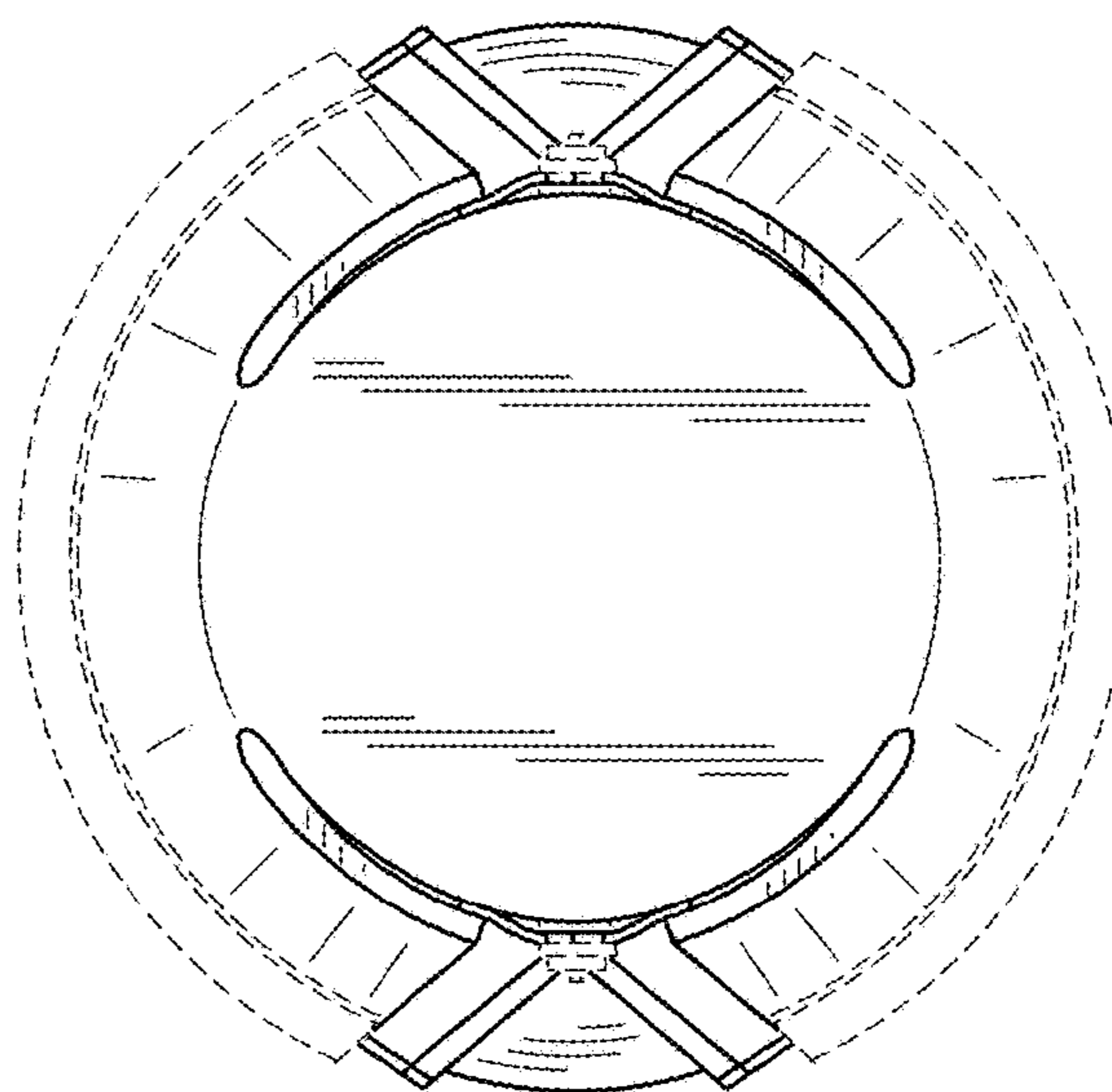
