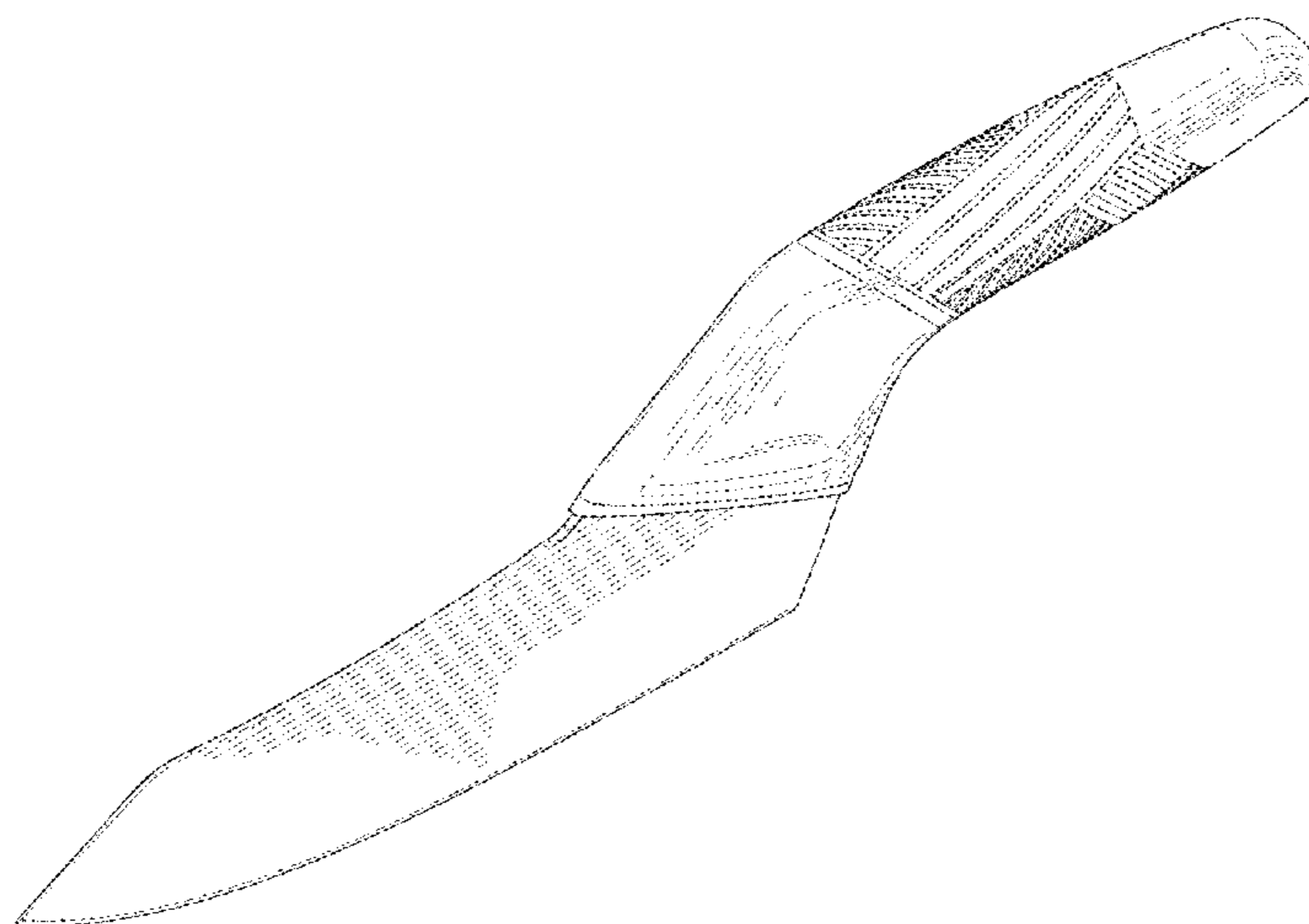
We claim the ornamental design for a knife, as shown and described.

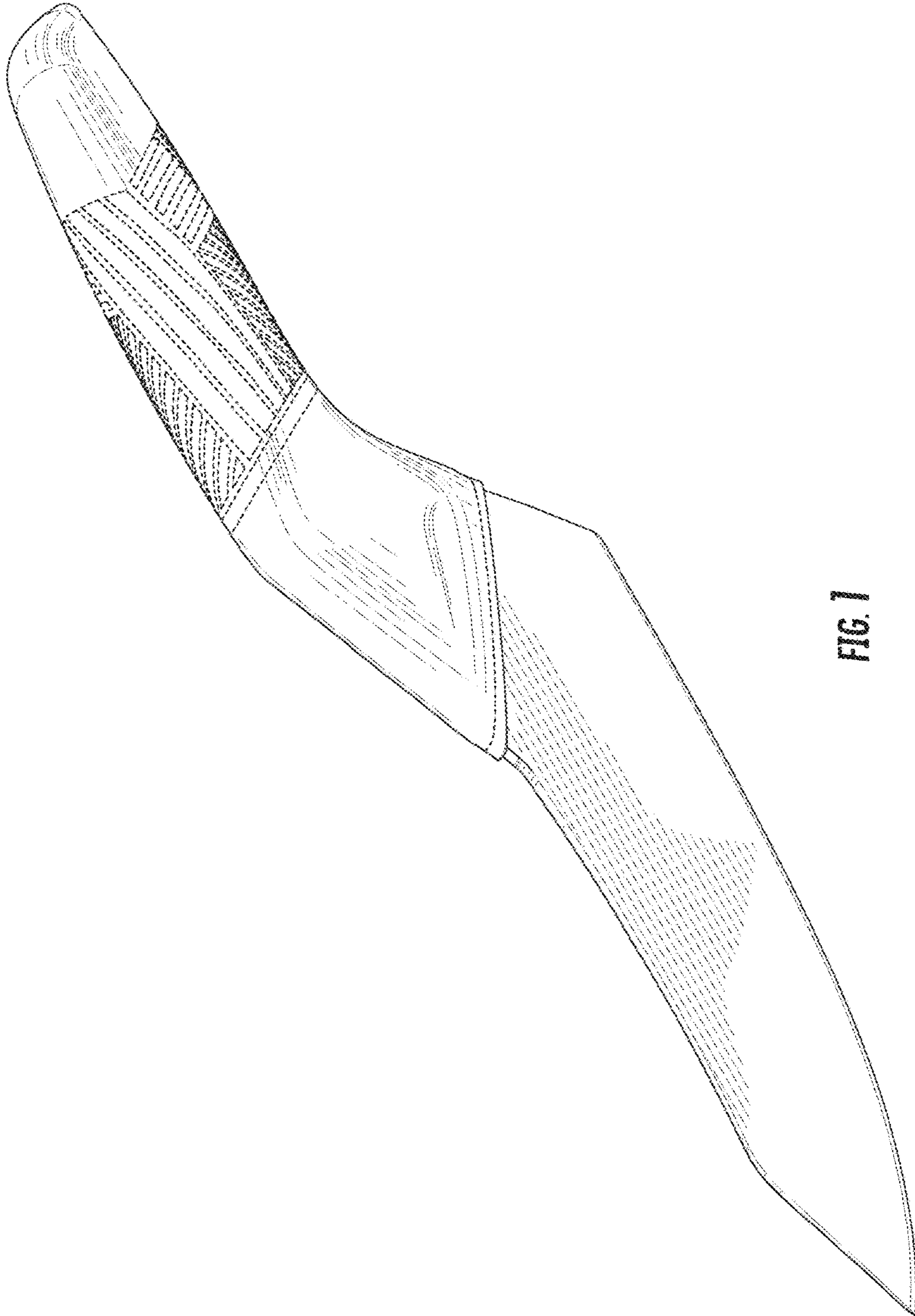

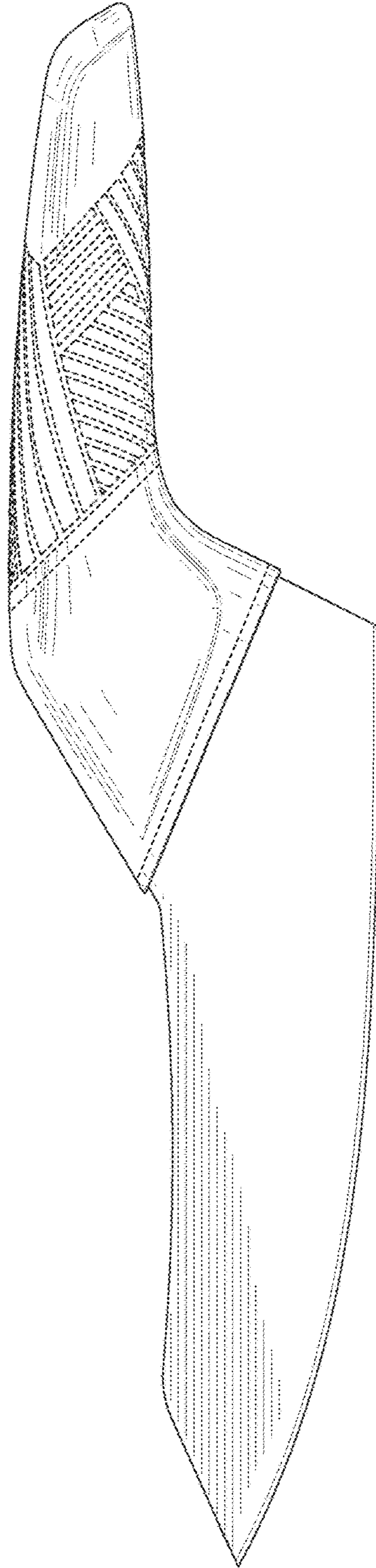

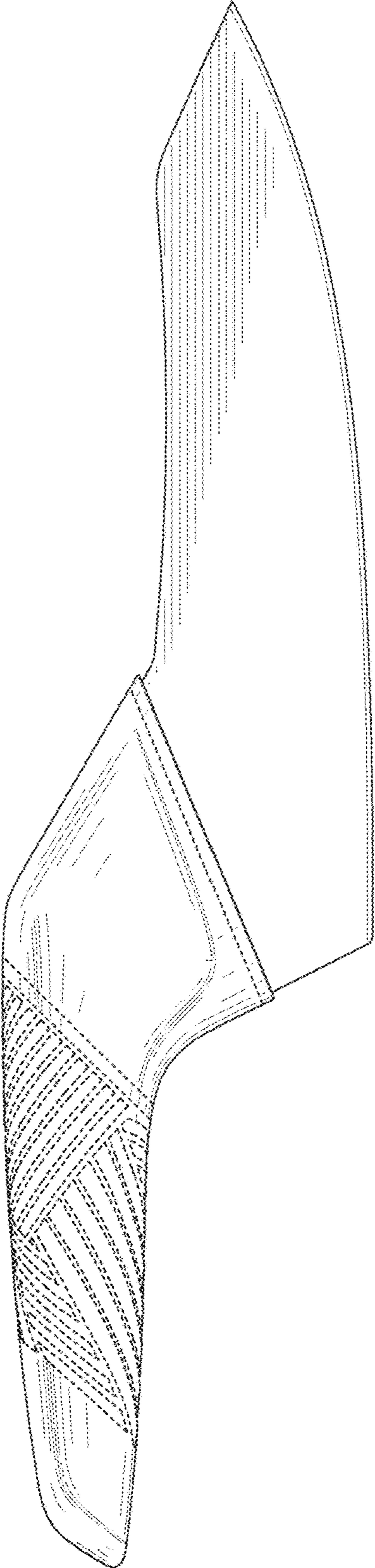

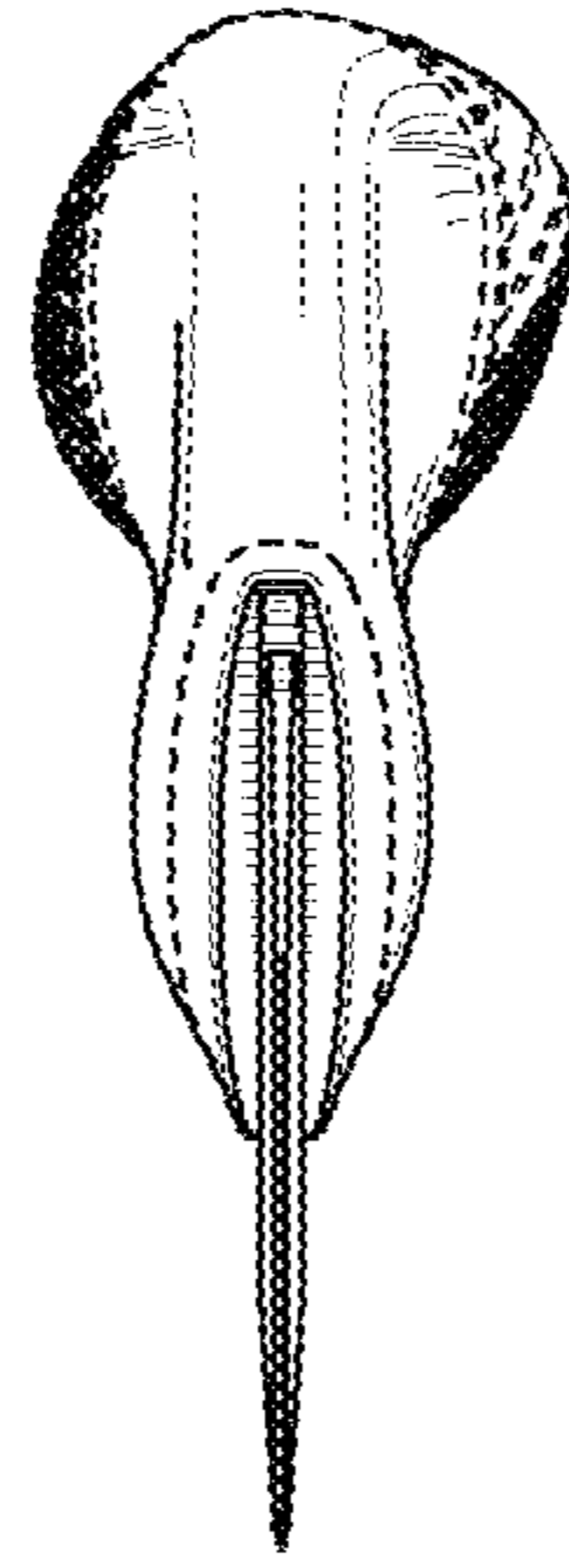

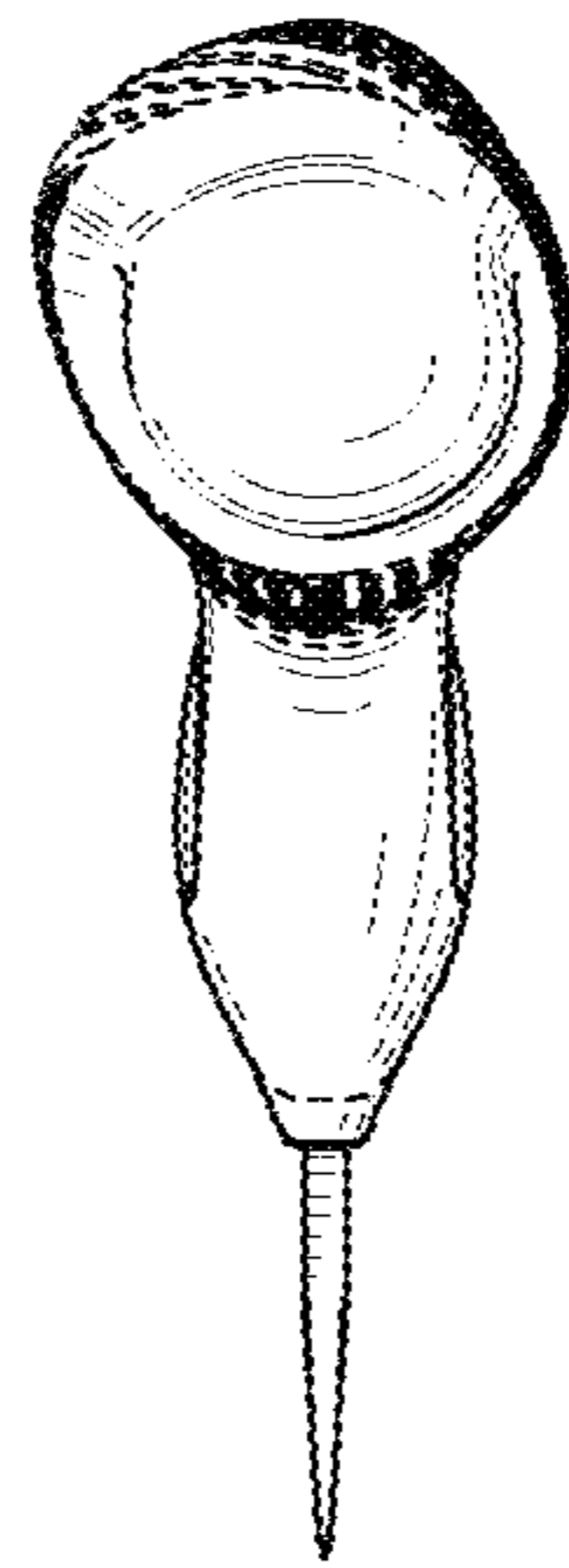

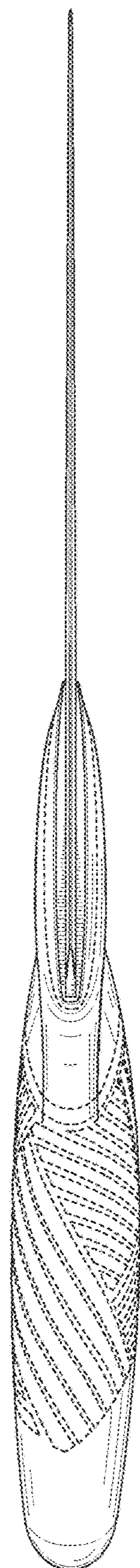
