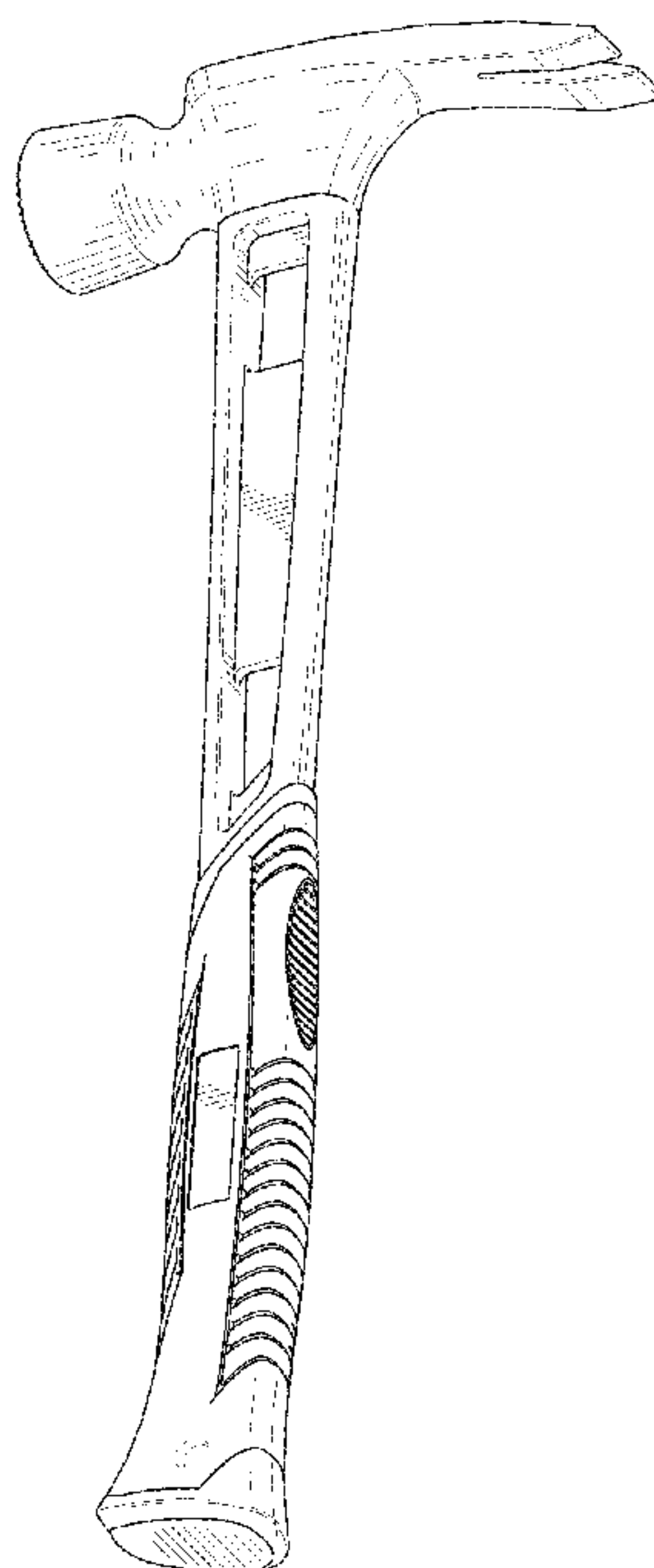
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear, bottom, right-side perspective view of the hammer
FIG. 2 is a right-side elevational view thereof; and
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a left-side elevational view thereof; and,

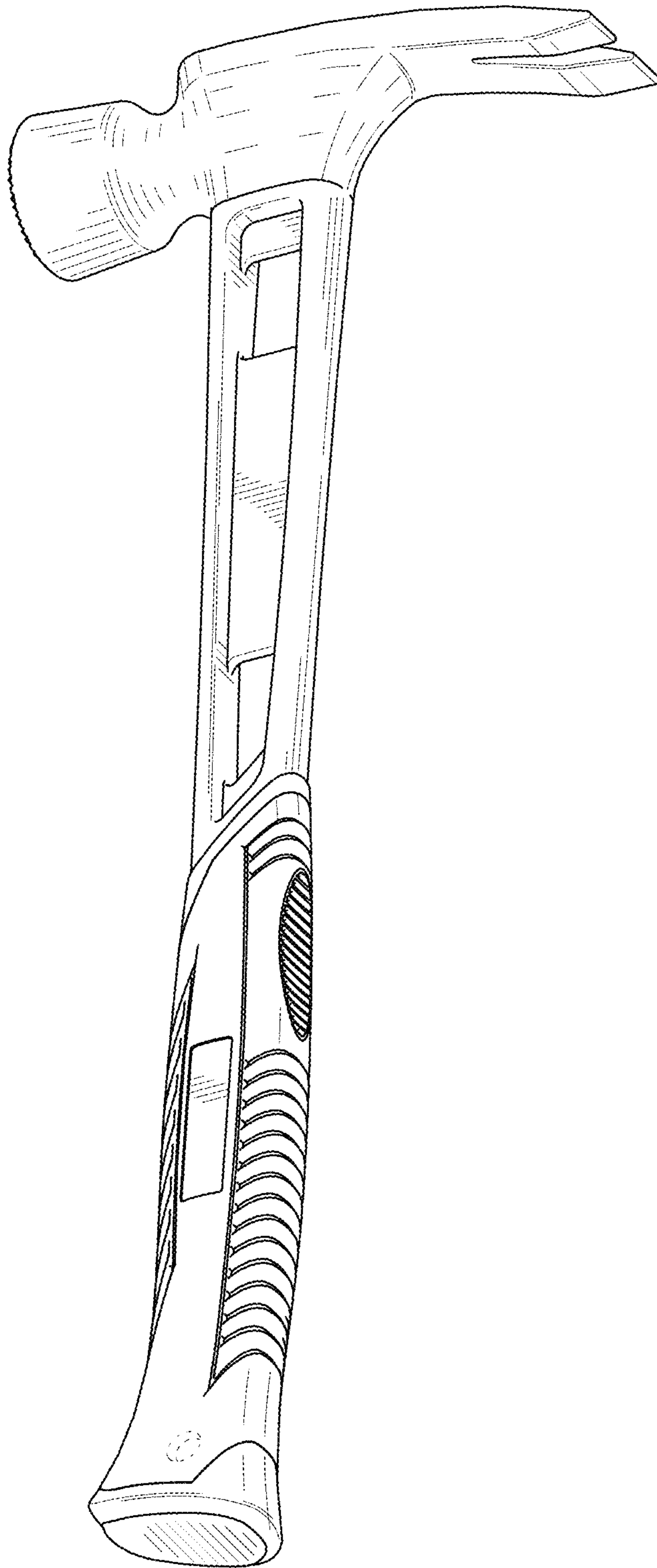

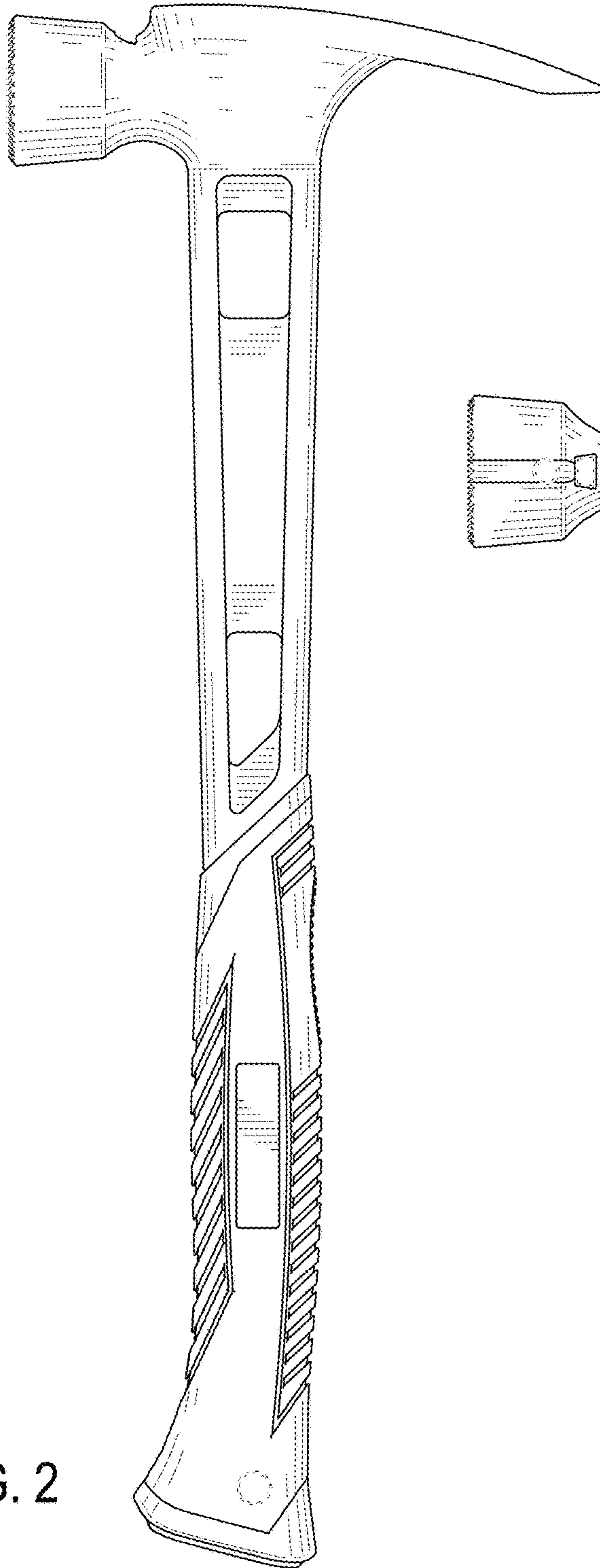

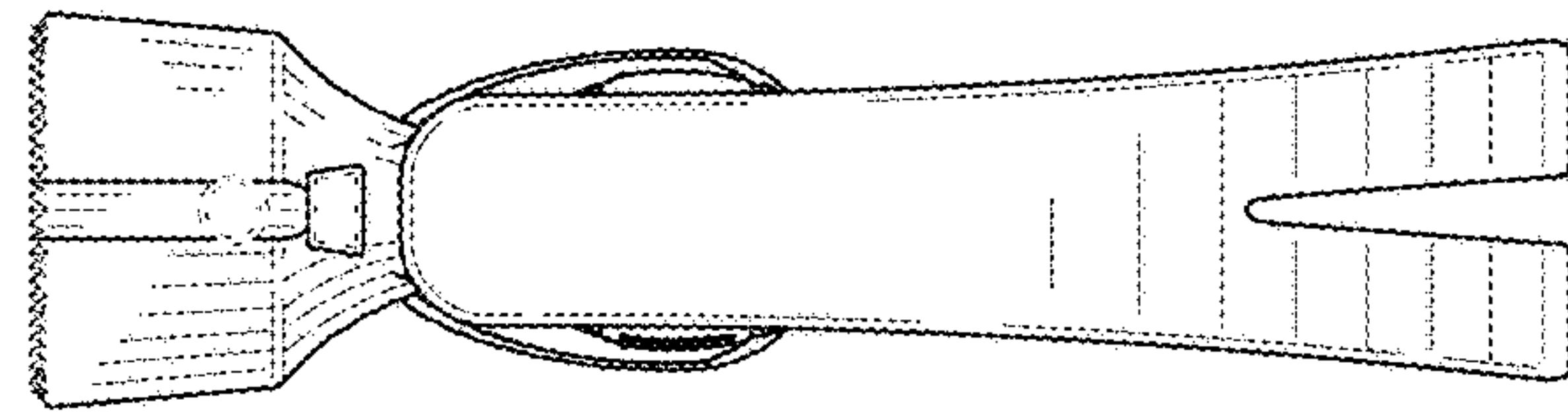

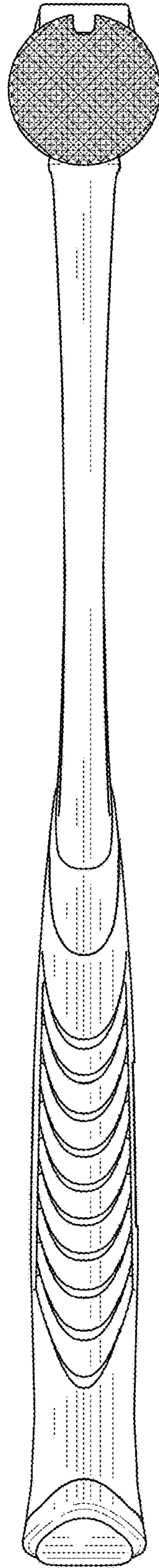

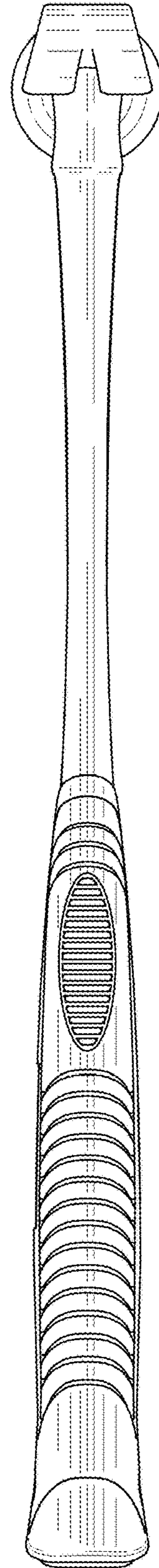

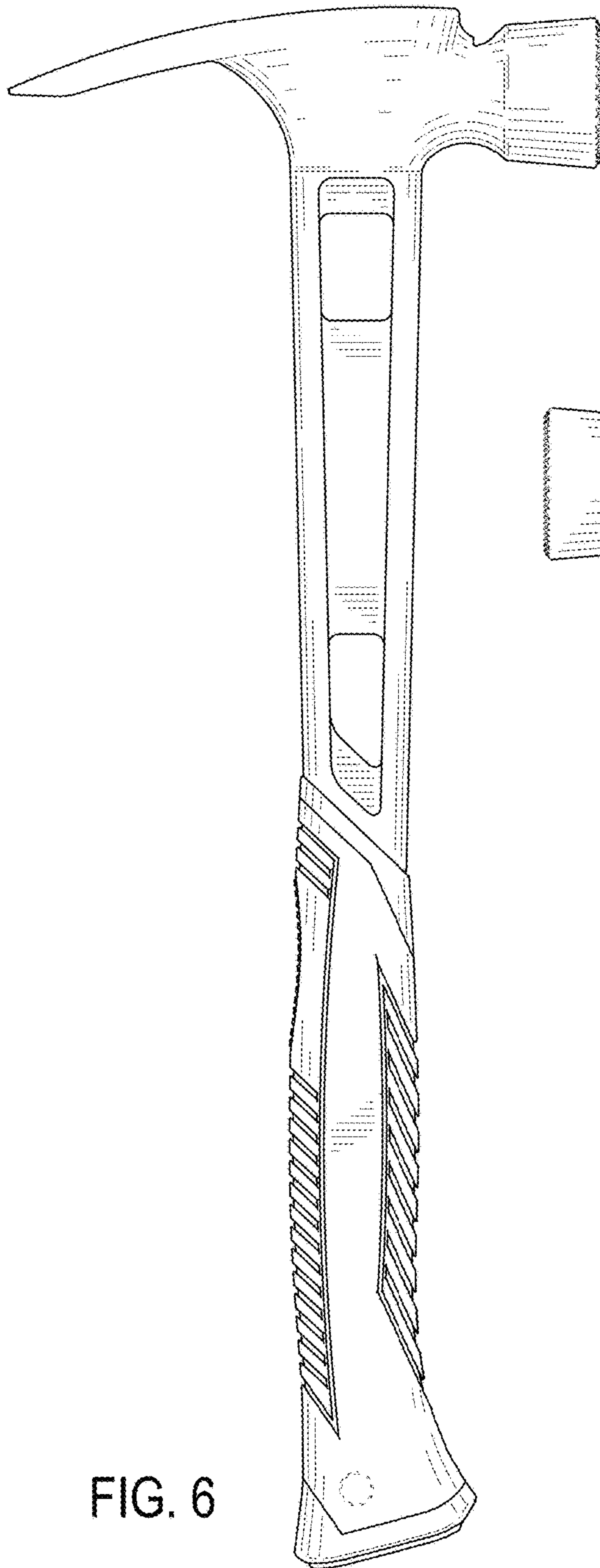

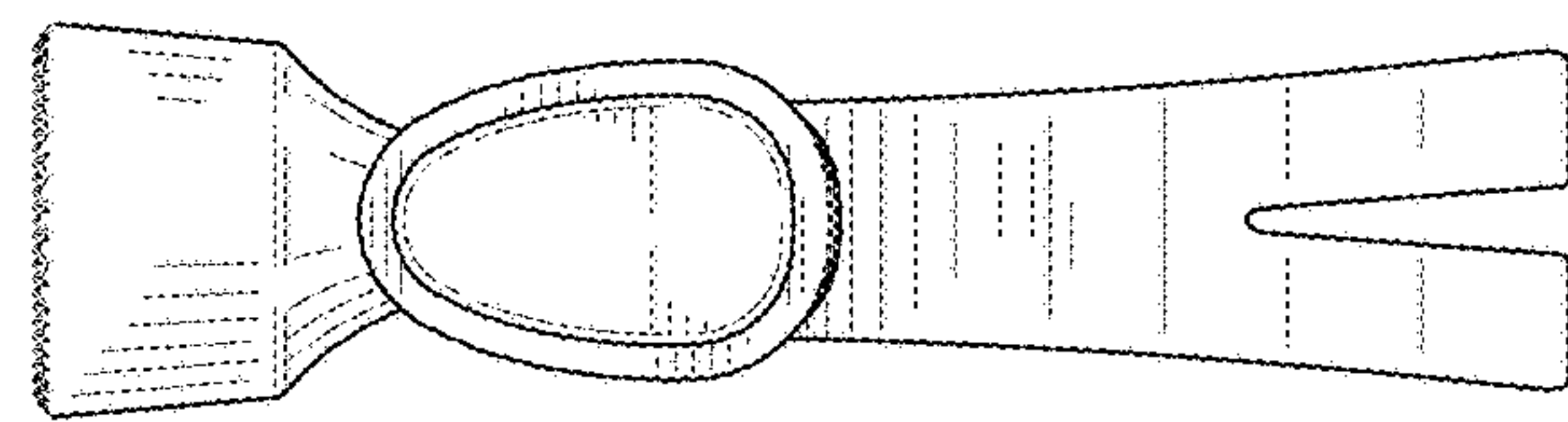
