The ornamental design for a razor package, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a razor package of the present invention;

FIG. 2 is a front view of the razor package of FIG. 1;

FIG. 3 is a back view of the razor package of FIG. 1;

FIG. 4 is a right side view of the razor package of FIG. 1;

FIG. 5 is a left side view of the razor package of FIG. 1;

FIG. 6 is a top view of the razor package of FIG. 1;

FIG. 7 is a bottom view of the razor package of FIG. 1;

FIG. 8 is perspective view of another embodiment of a razor package of the present invention;

FIG. 9 is a front view of the razor package of FIG. 8;

FIG. 10 is a back view of the razor package of FIG. 8;

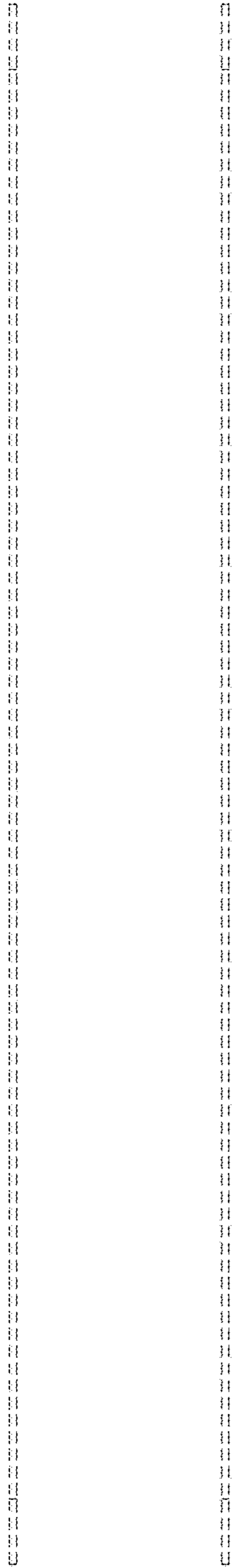


FIG. 11 FIG. 12

FIG. 11 is a right side view of the razor package of FIG. 8;

FIG. 12 is a left side view of the razor package of FIG. 8;

FIG. 13 is a top view of the razor package of FIG. 8; and,

FIG. 14 is a bottom view of the razor package of FIG. 8.

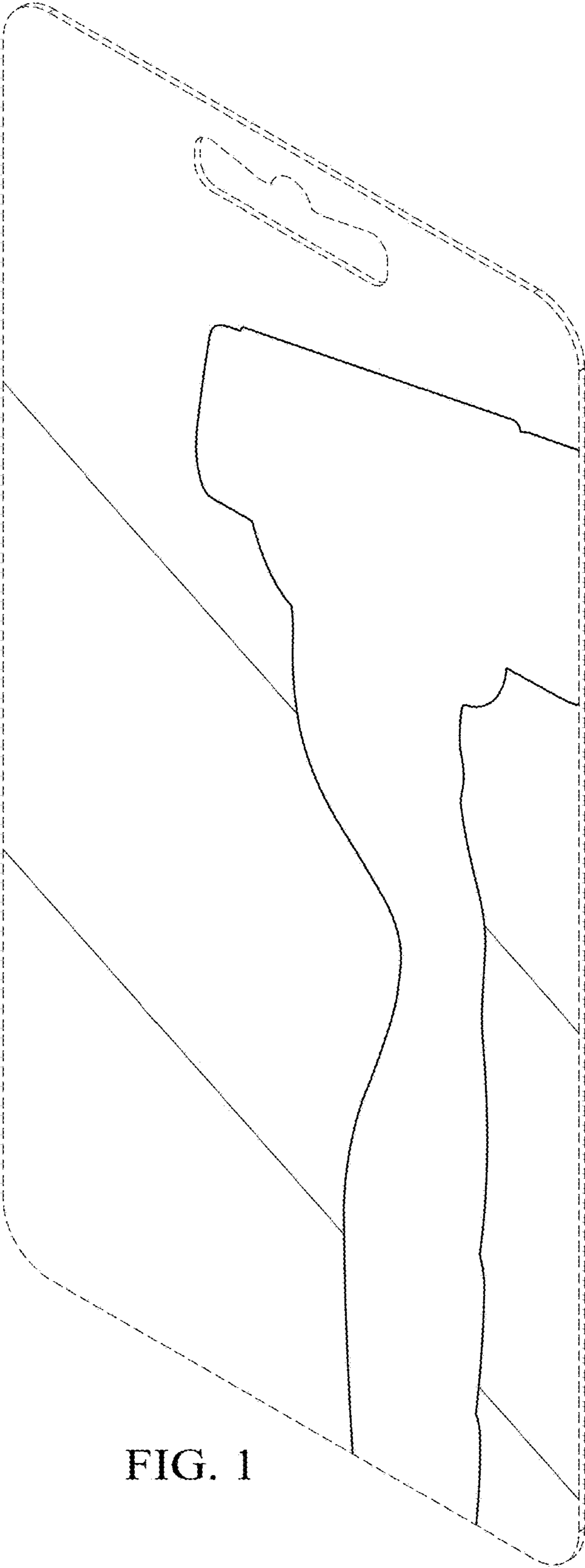

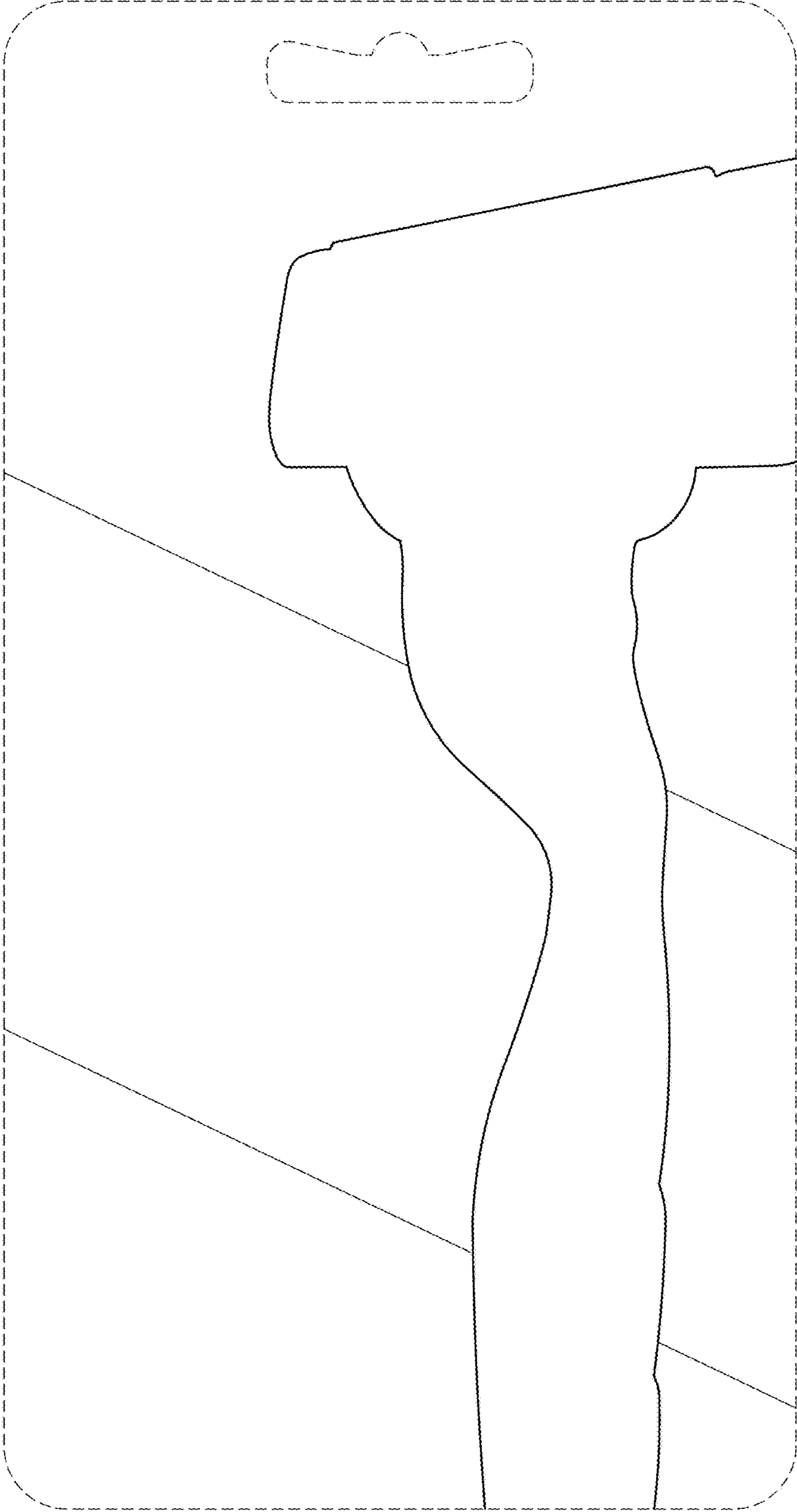

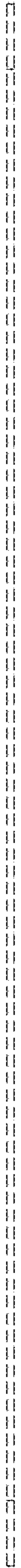

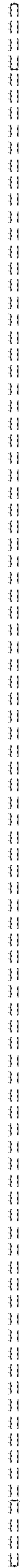

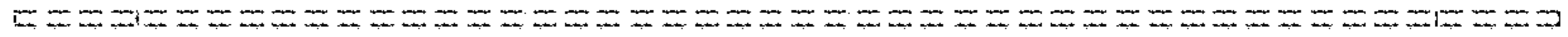

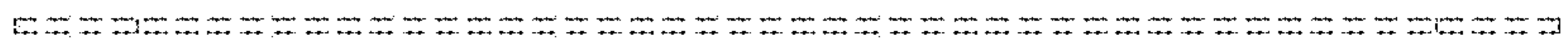

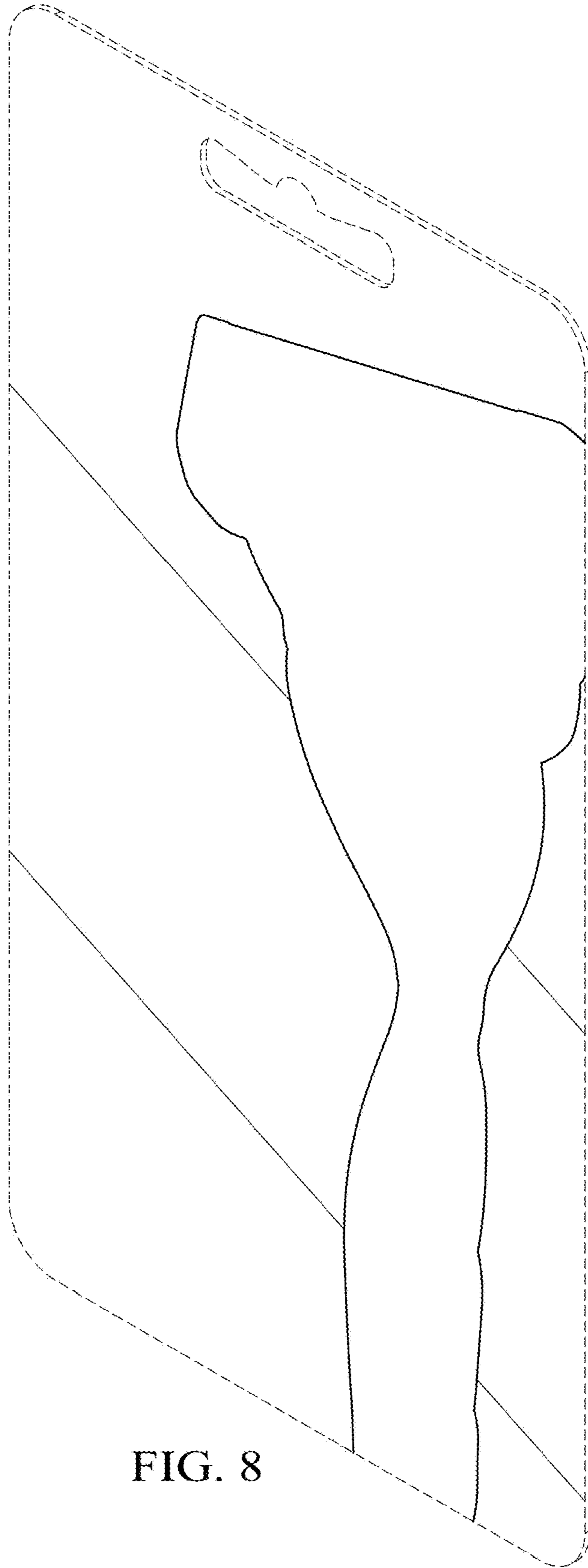

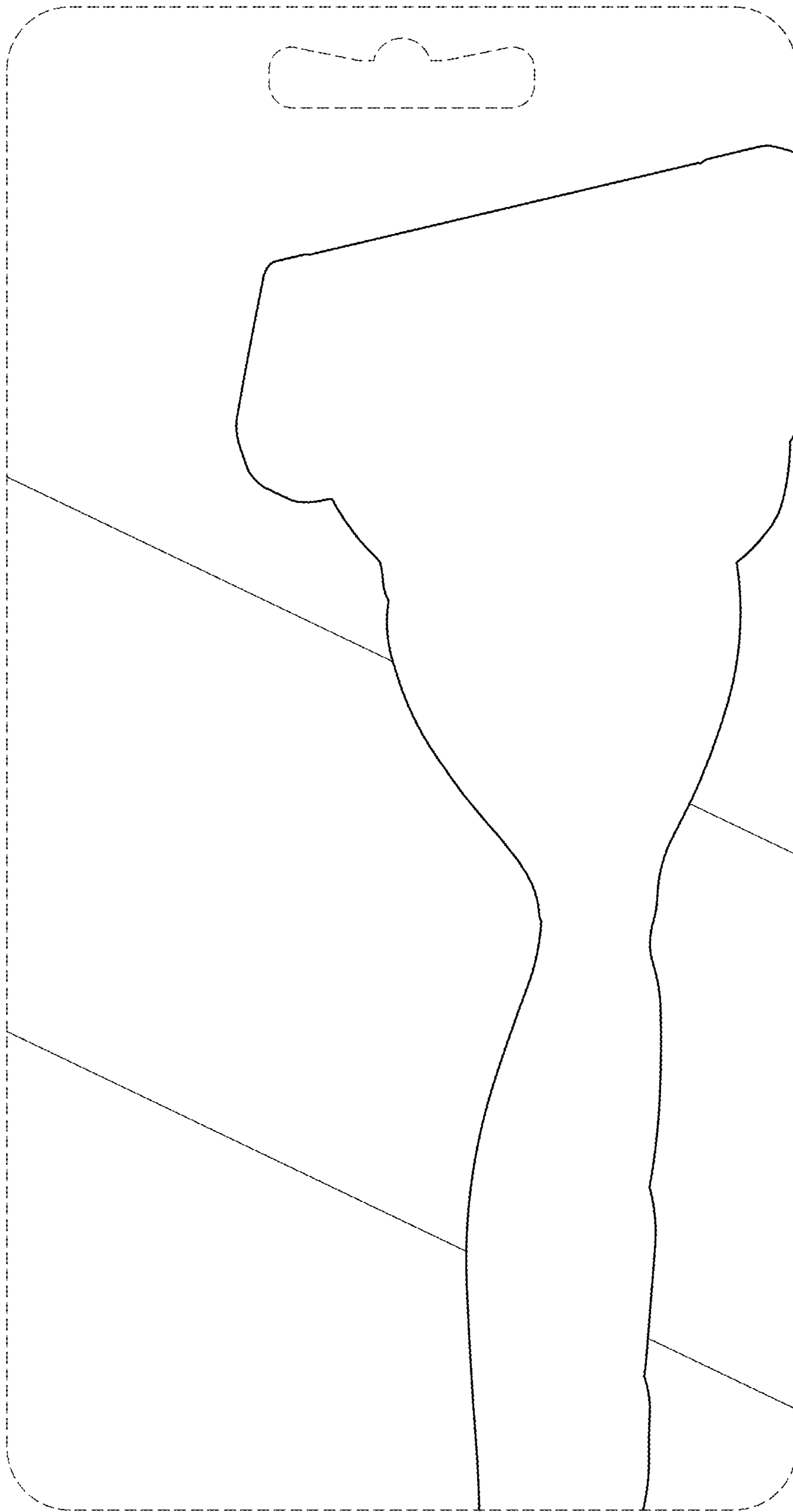

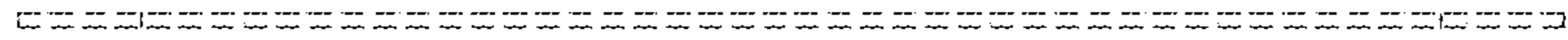

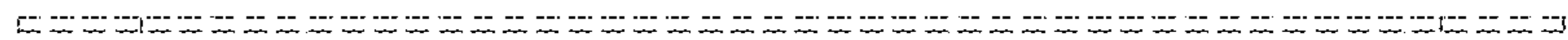
