(57) **CLAIM**

The ornamental design for a sprayer with nozzle on tank, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of the present invention;

FIG. 2 is a left side view thereof;

FIG. 3 is a back view thereof and opposite that shown in FIG. 1;

FIG. 4 is a right side view thereof;

FIG. 5 is a top view thereof;

FIG. 8 is an exploded perspective view thereof showing the manner of assembly with an unclaimed cap drawn in broken lines;

FIG. 9 is a perspective view of the design of FIG. 1 shown in a position of use with an unclaimed cap drawn in broken lines placed on top of the sprayer with nozzle on tank;

FIG. 10 is a front view of a second embodiment thereof;

FIG. 11 is a left side view of FIG. 10;

FIG. 12 is a back view of FIG. 10 and opposite that shown in FIG. 10;

FIG. 13 is a right side view of FIG. 10;

FIG. 14 is a top view of FIG. 10;

FIG. 15 is a bottom view of FIG. 10;

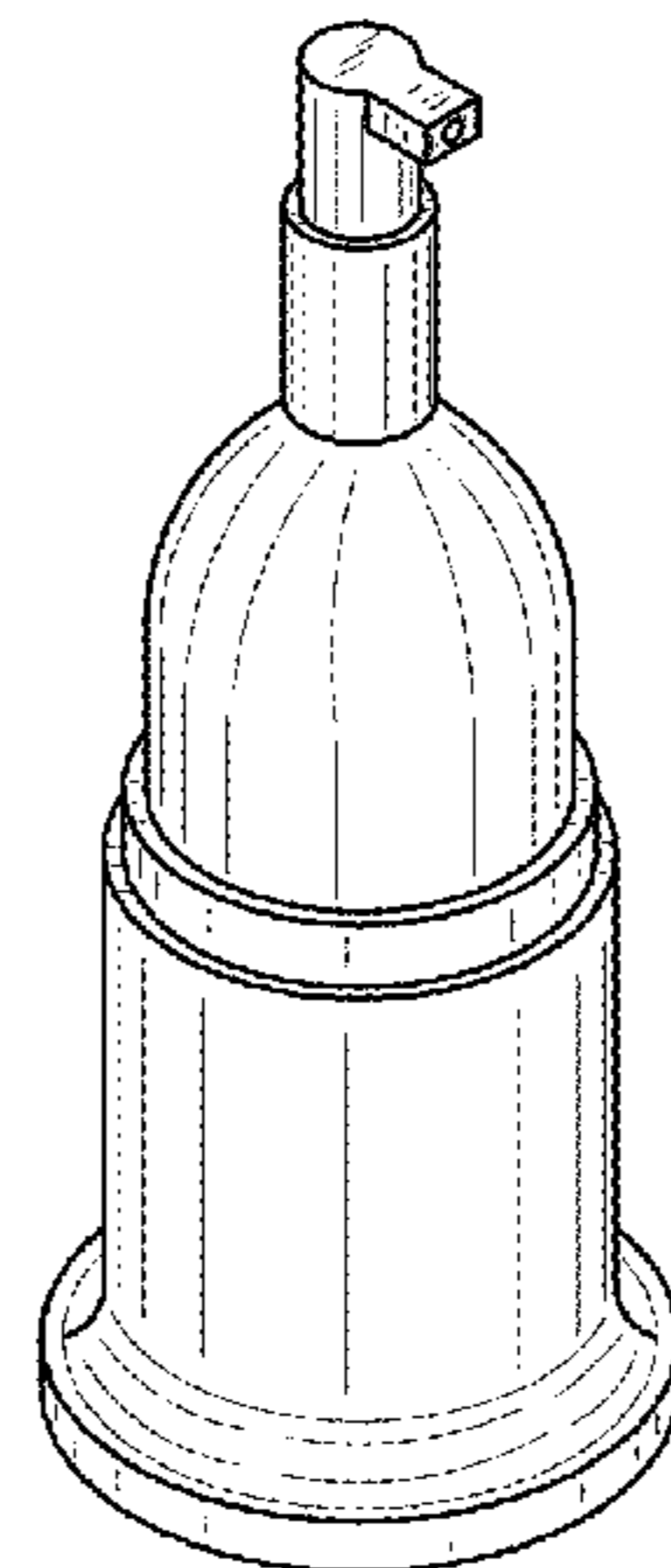
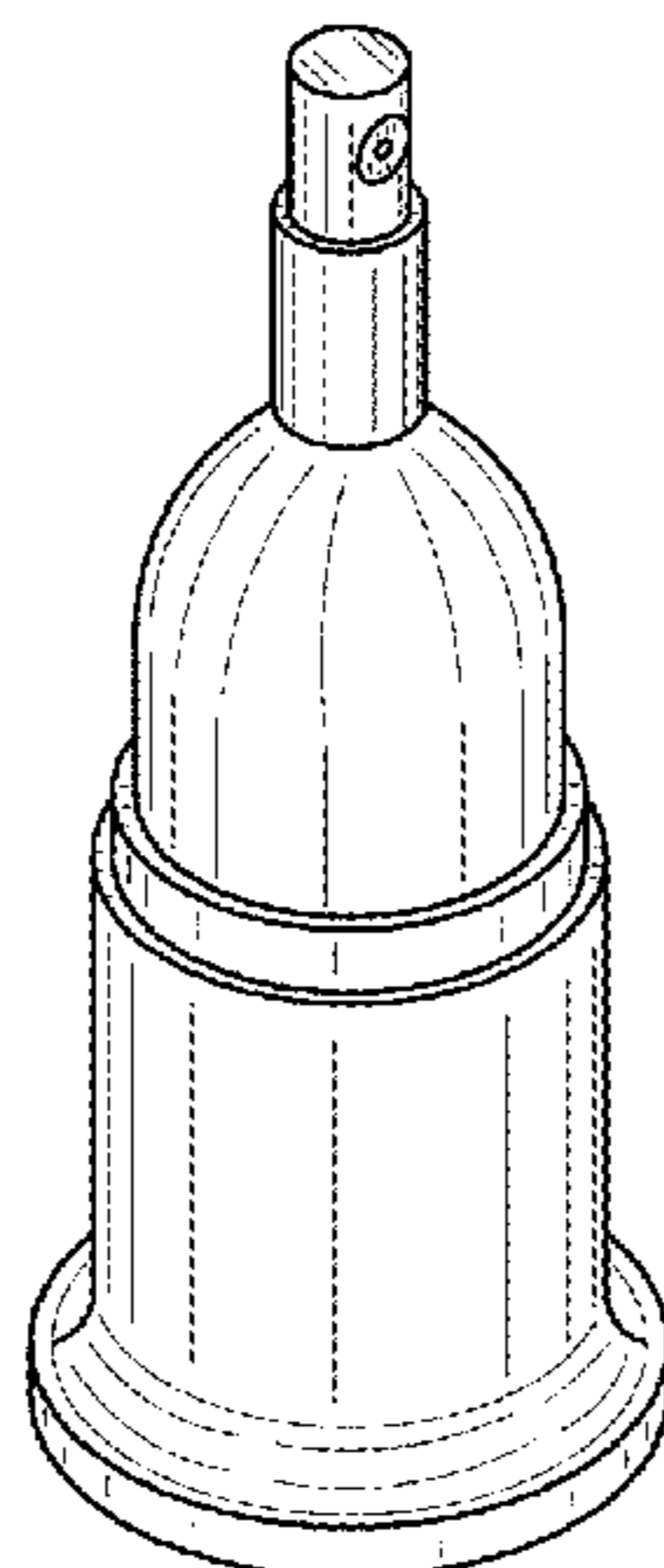
FIG. 16 is a perspective view of FIG. 10;

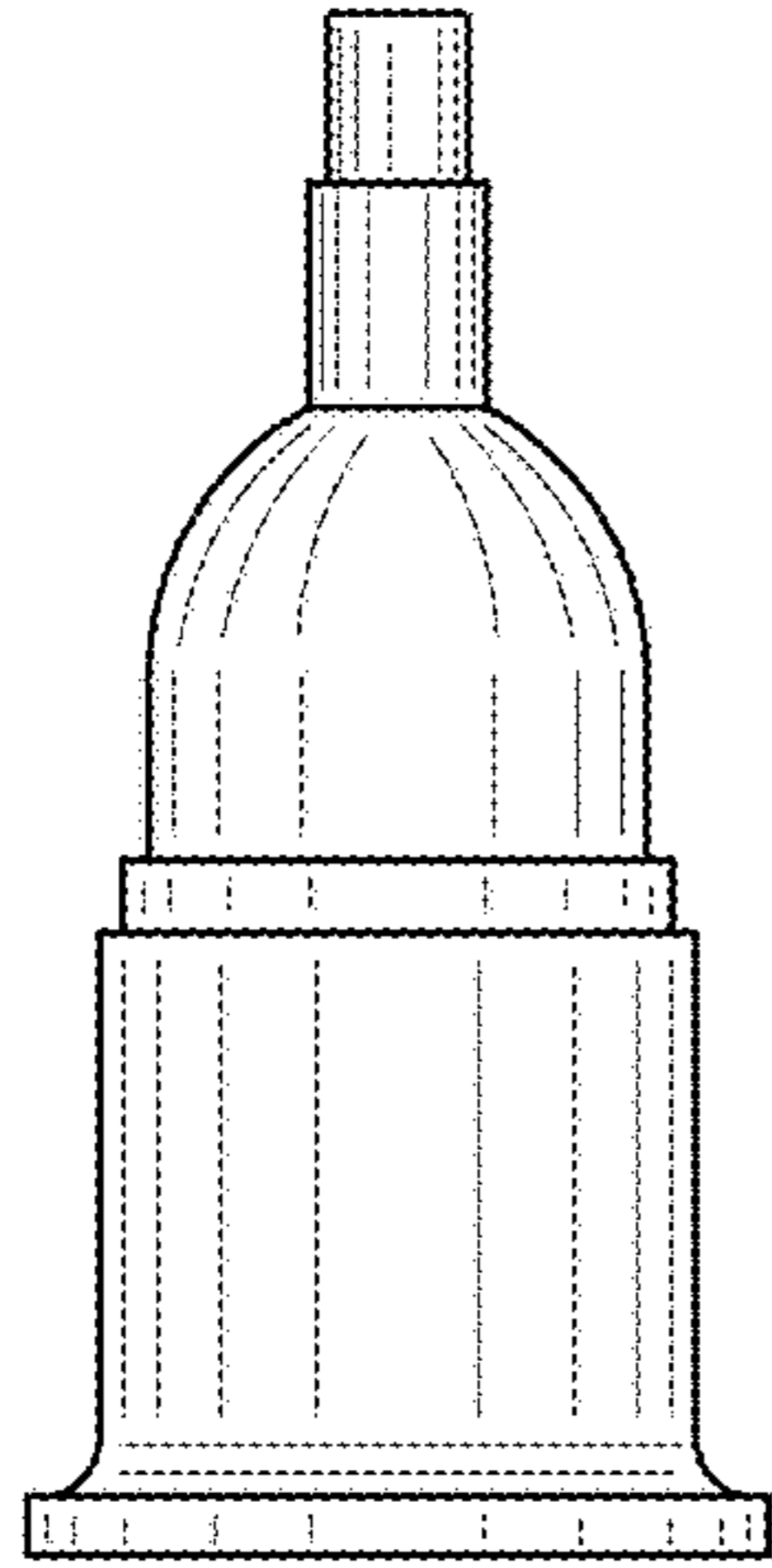

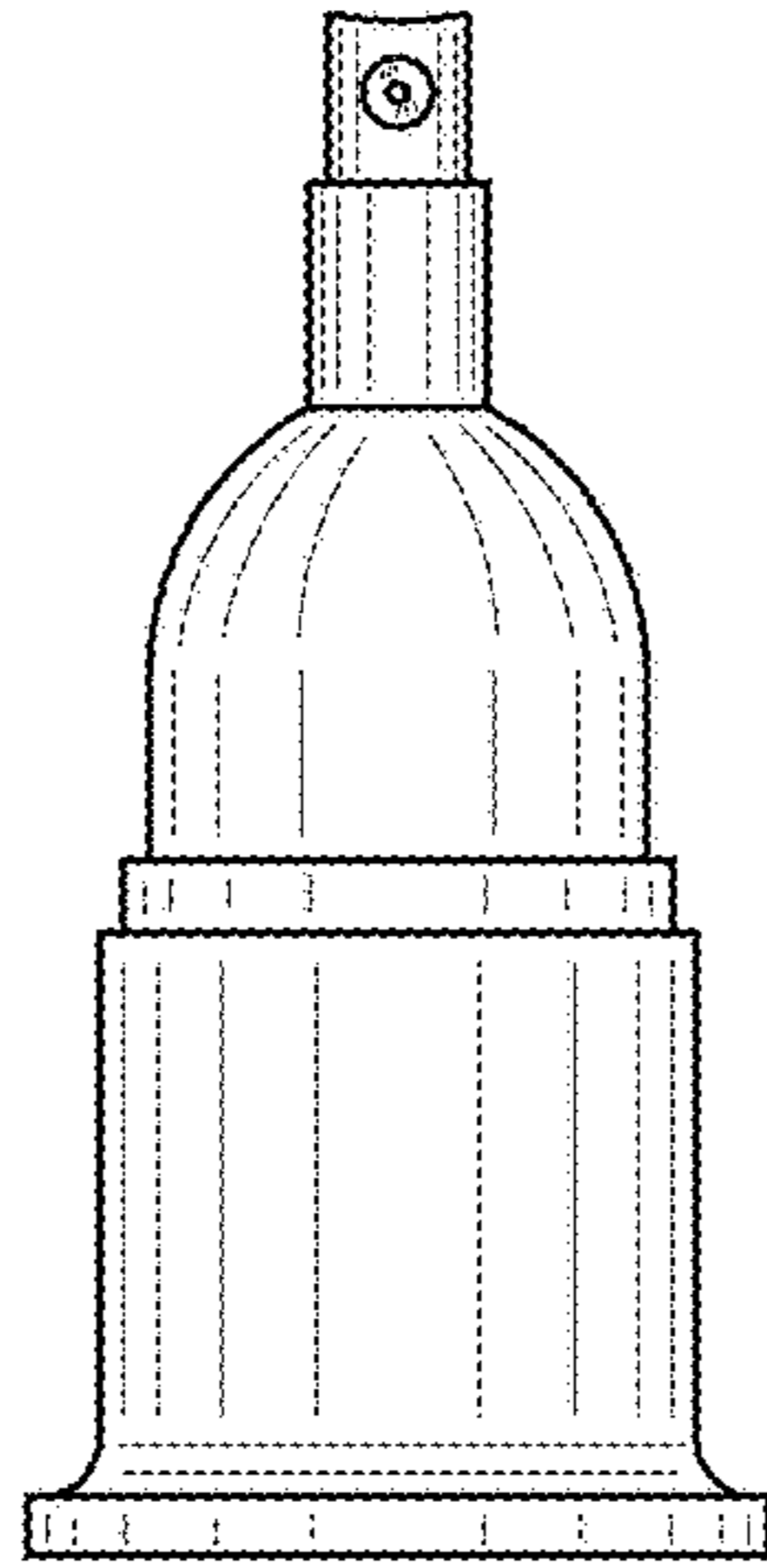

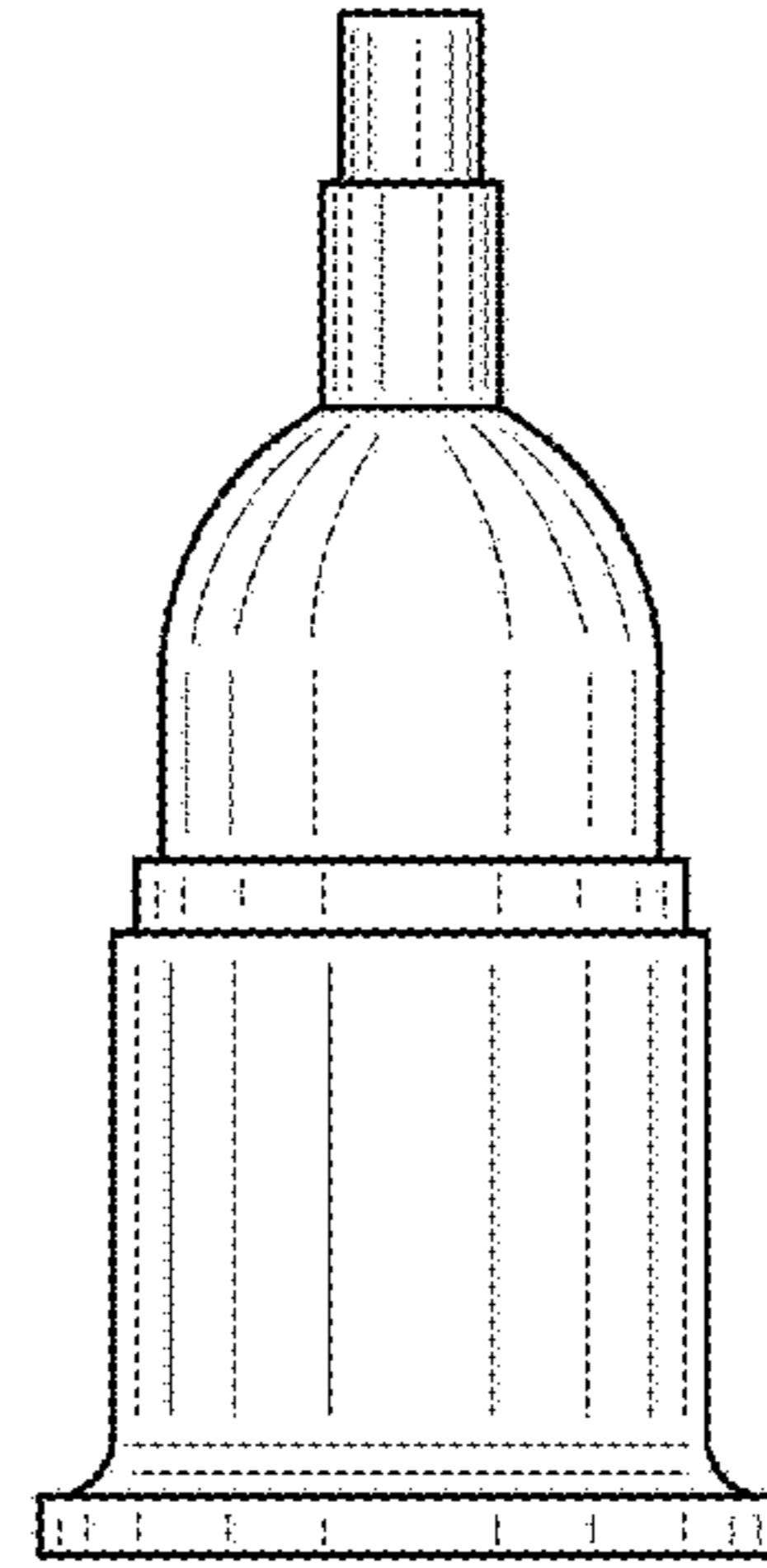

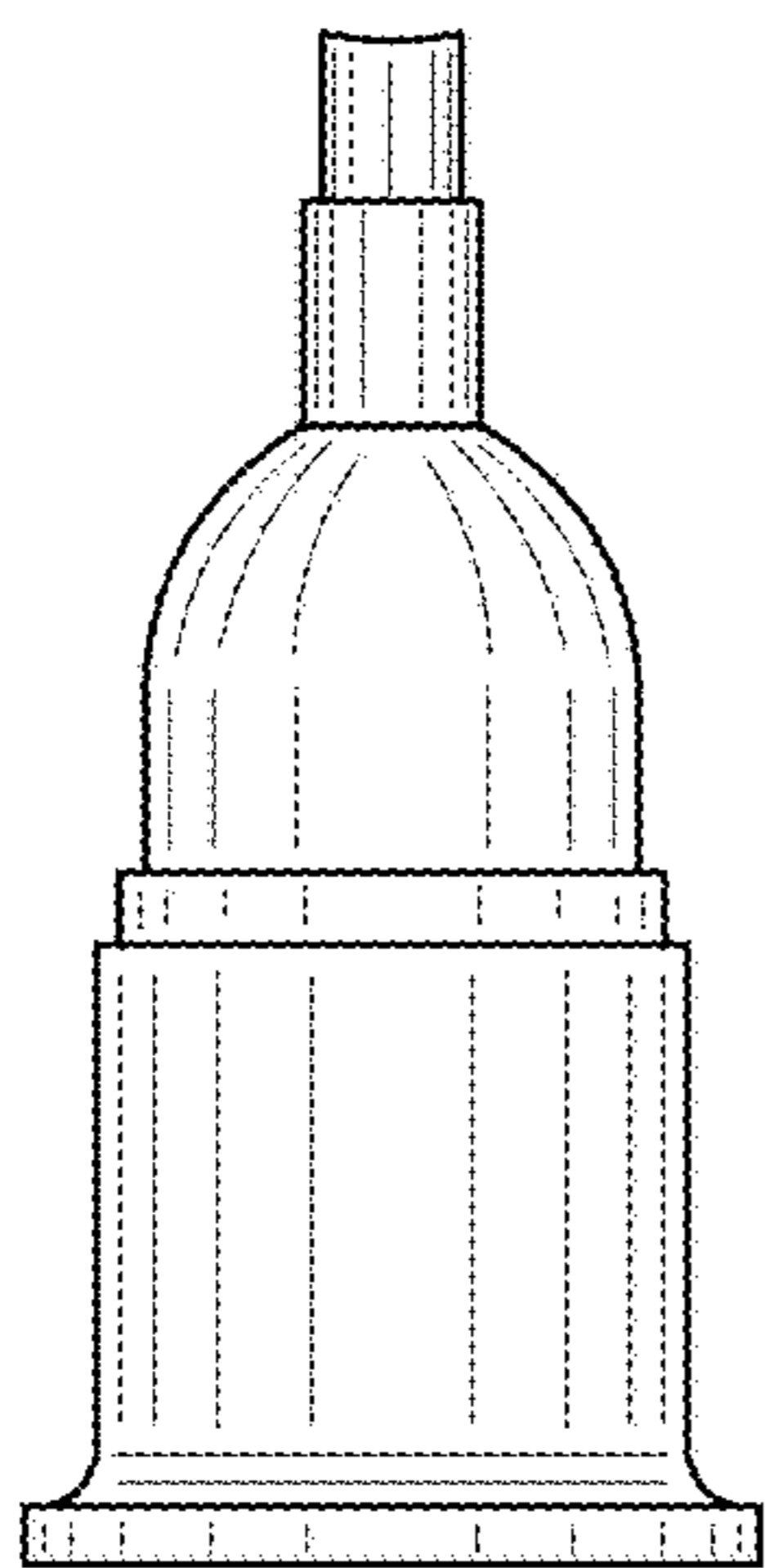

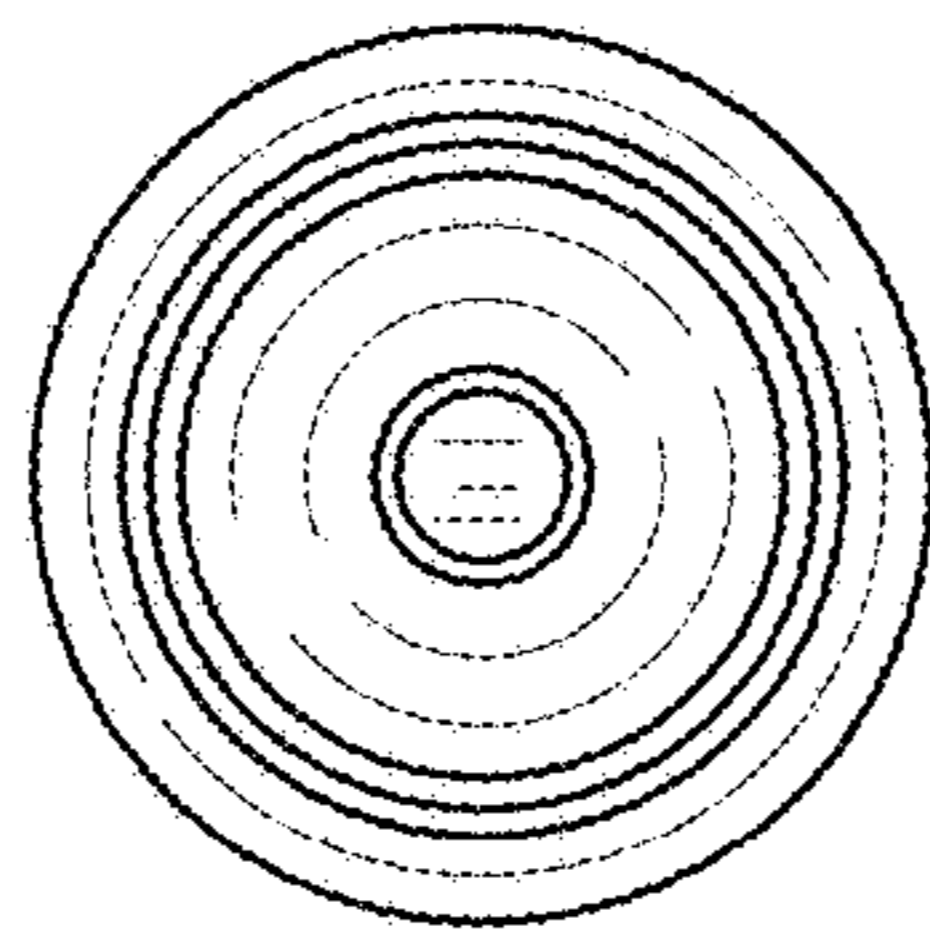

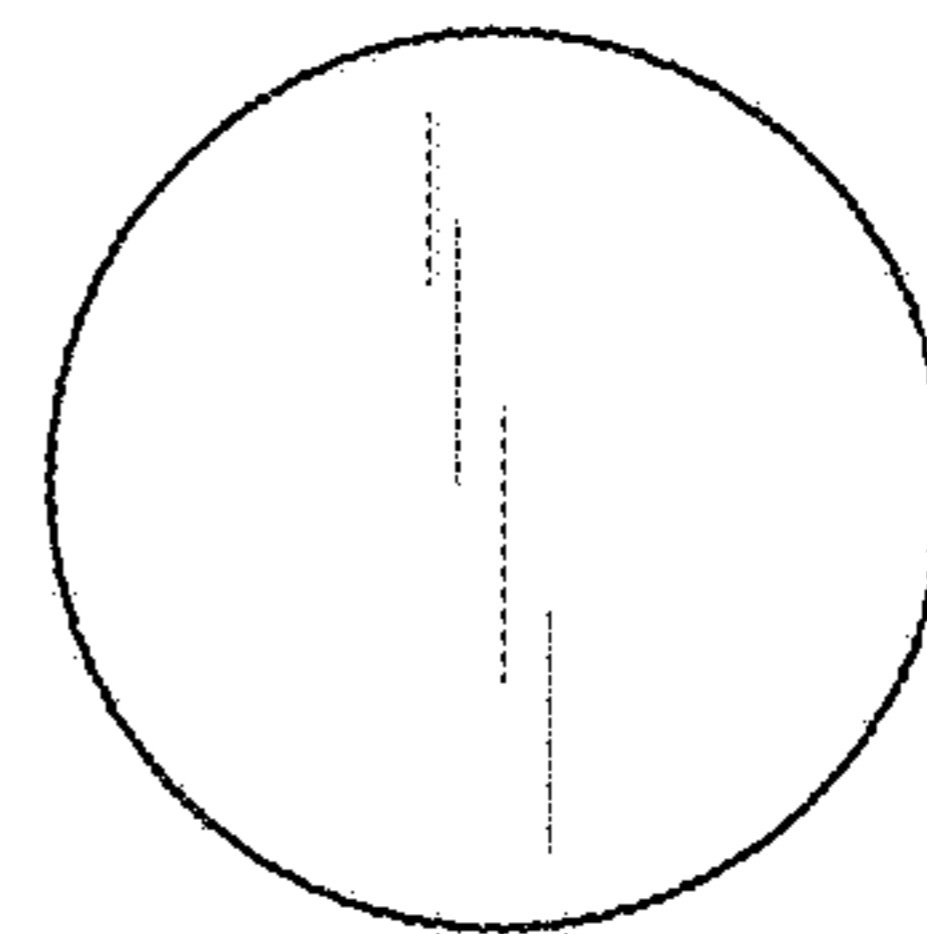

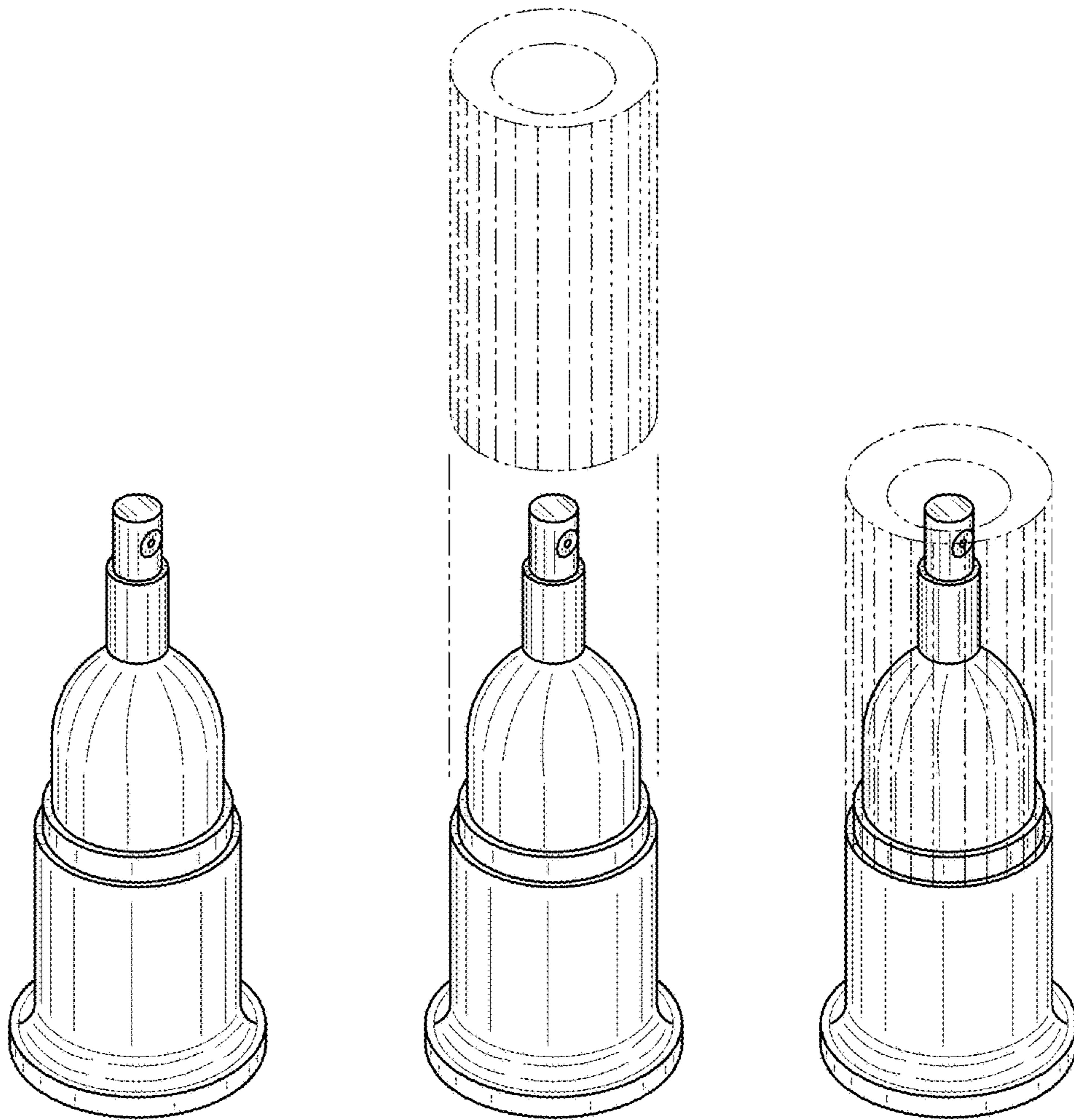

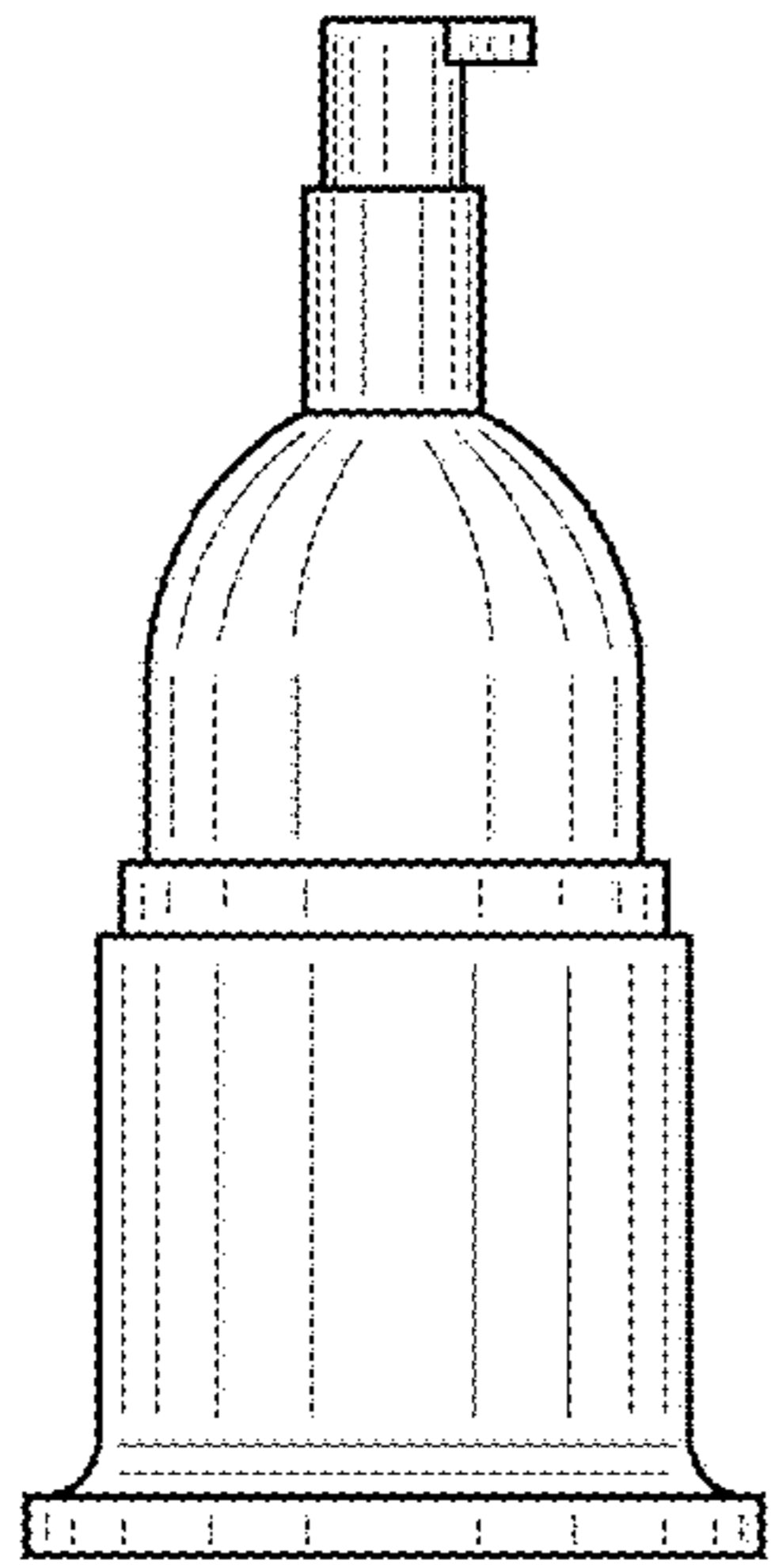

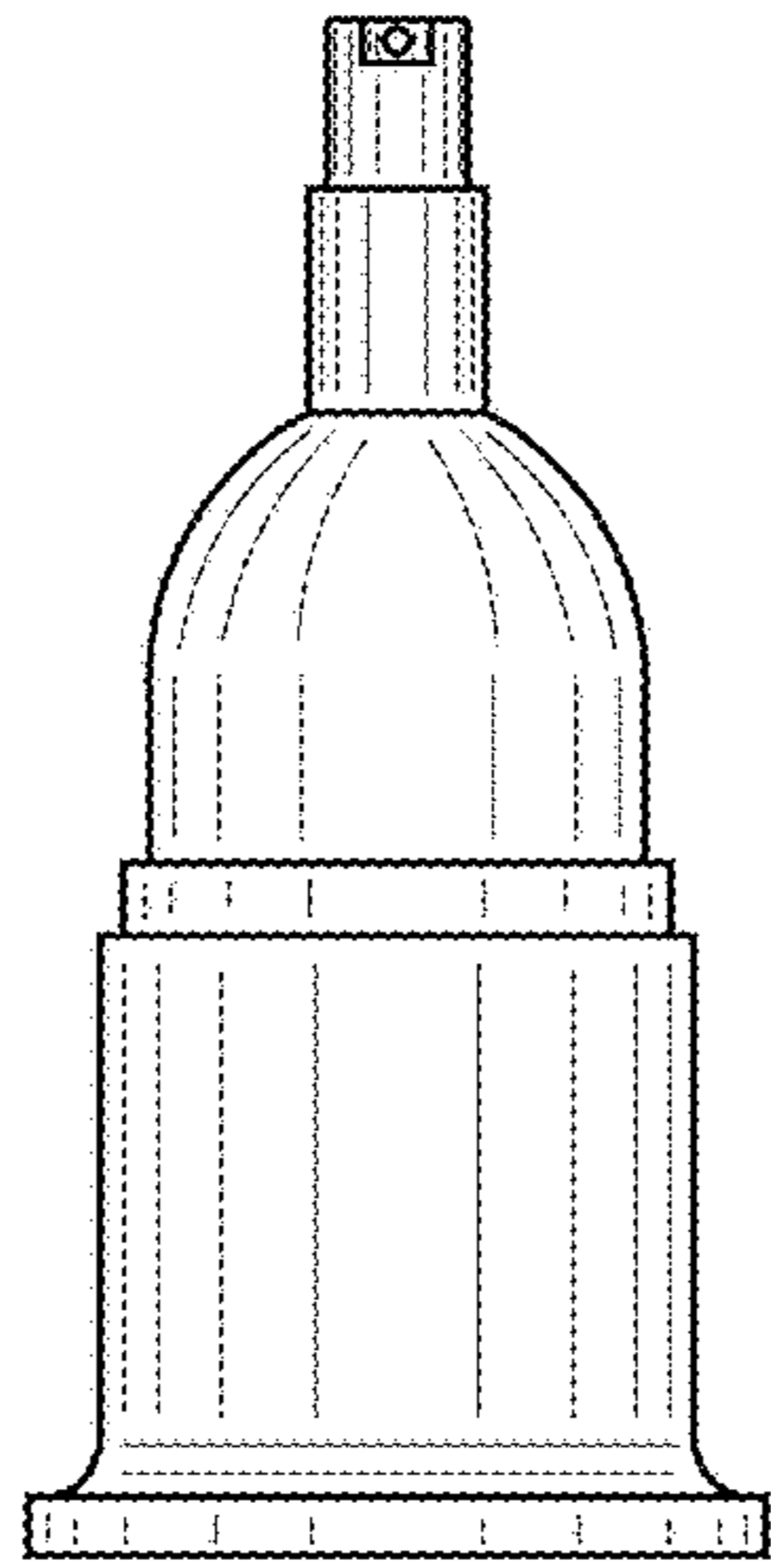

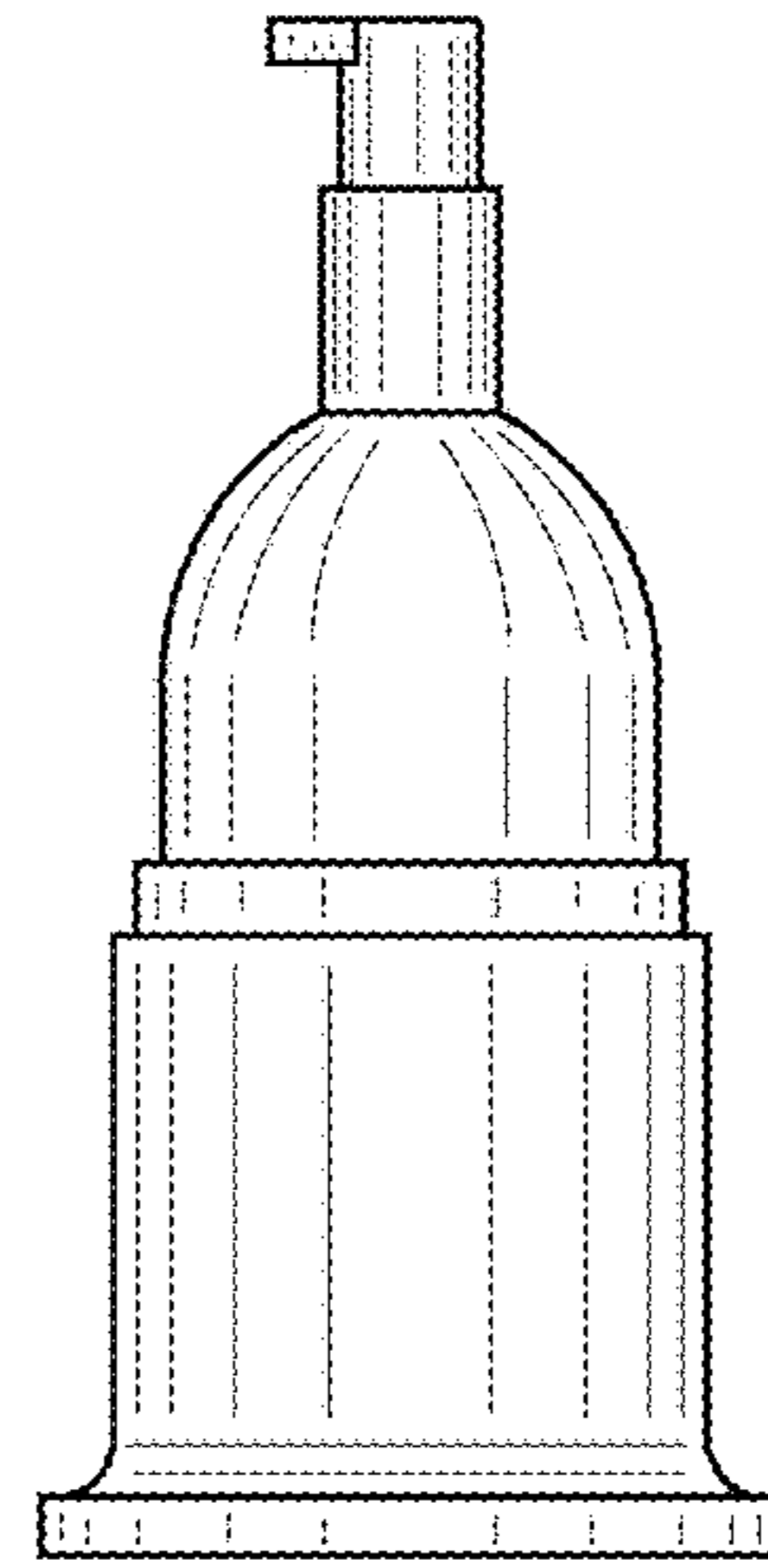

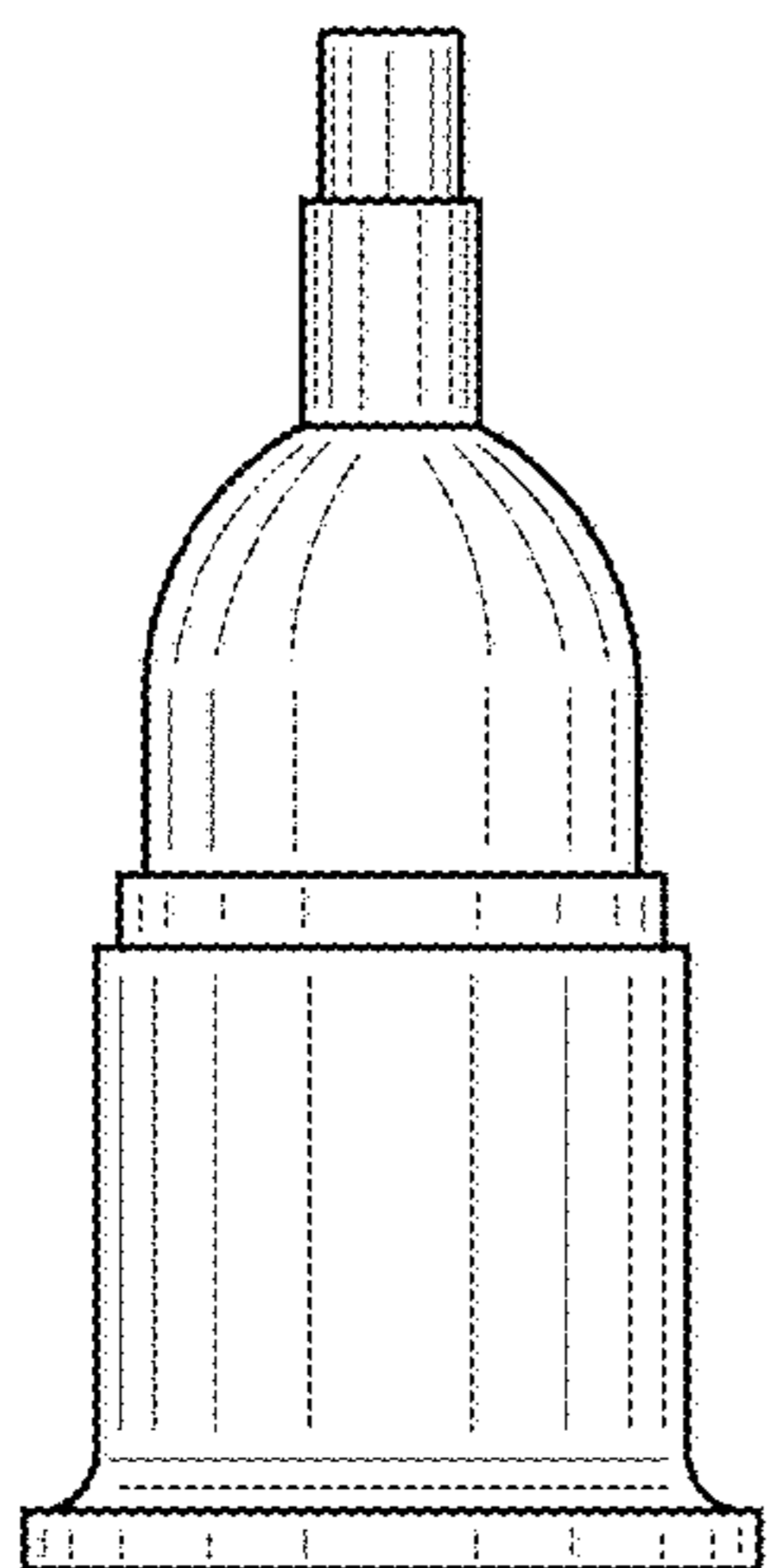

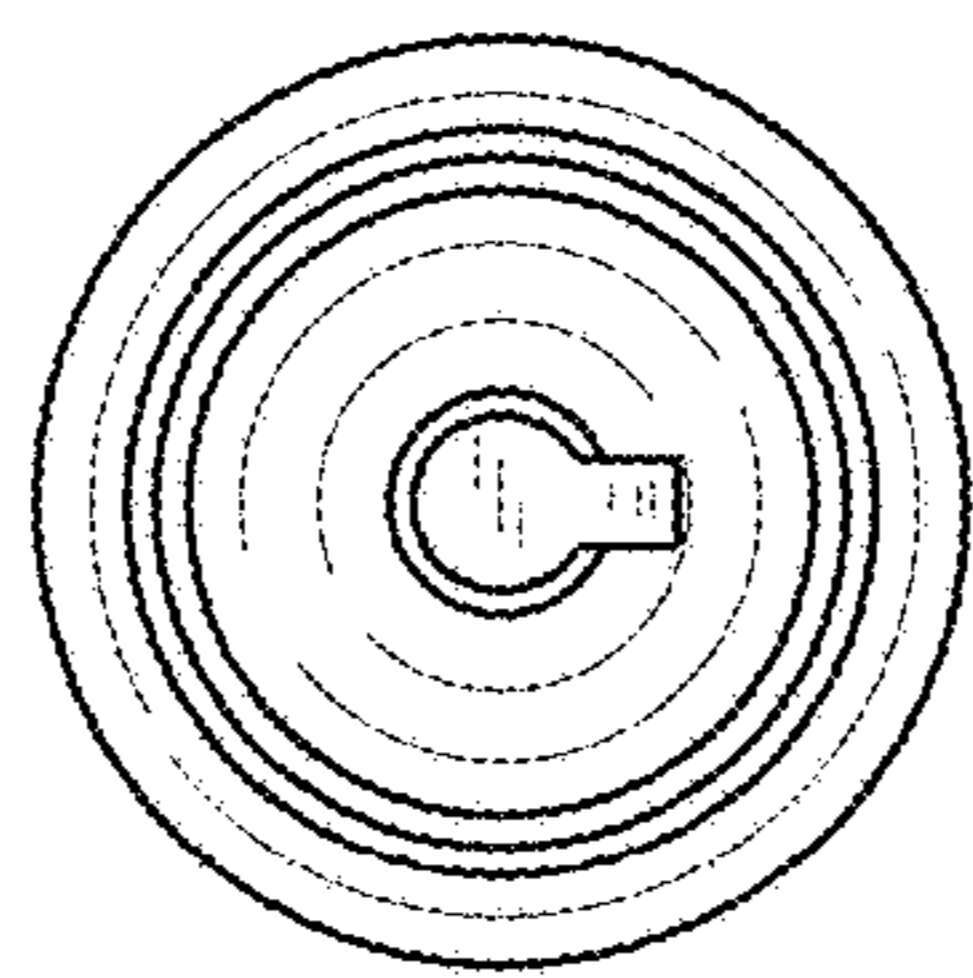

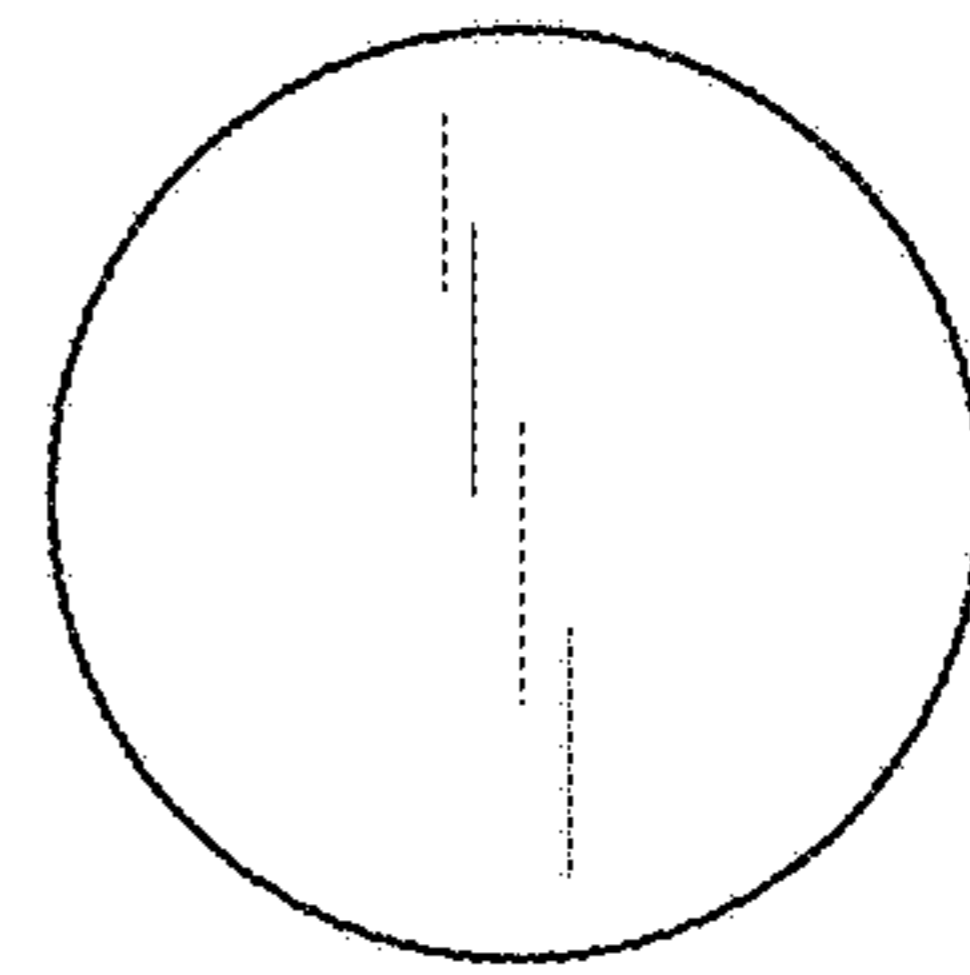

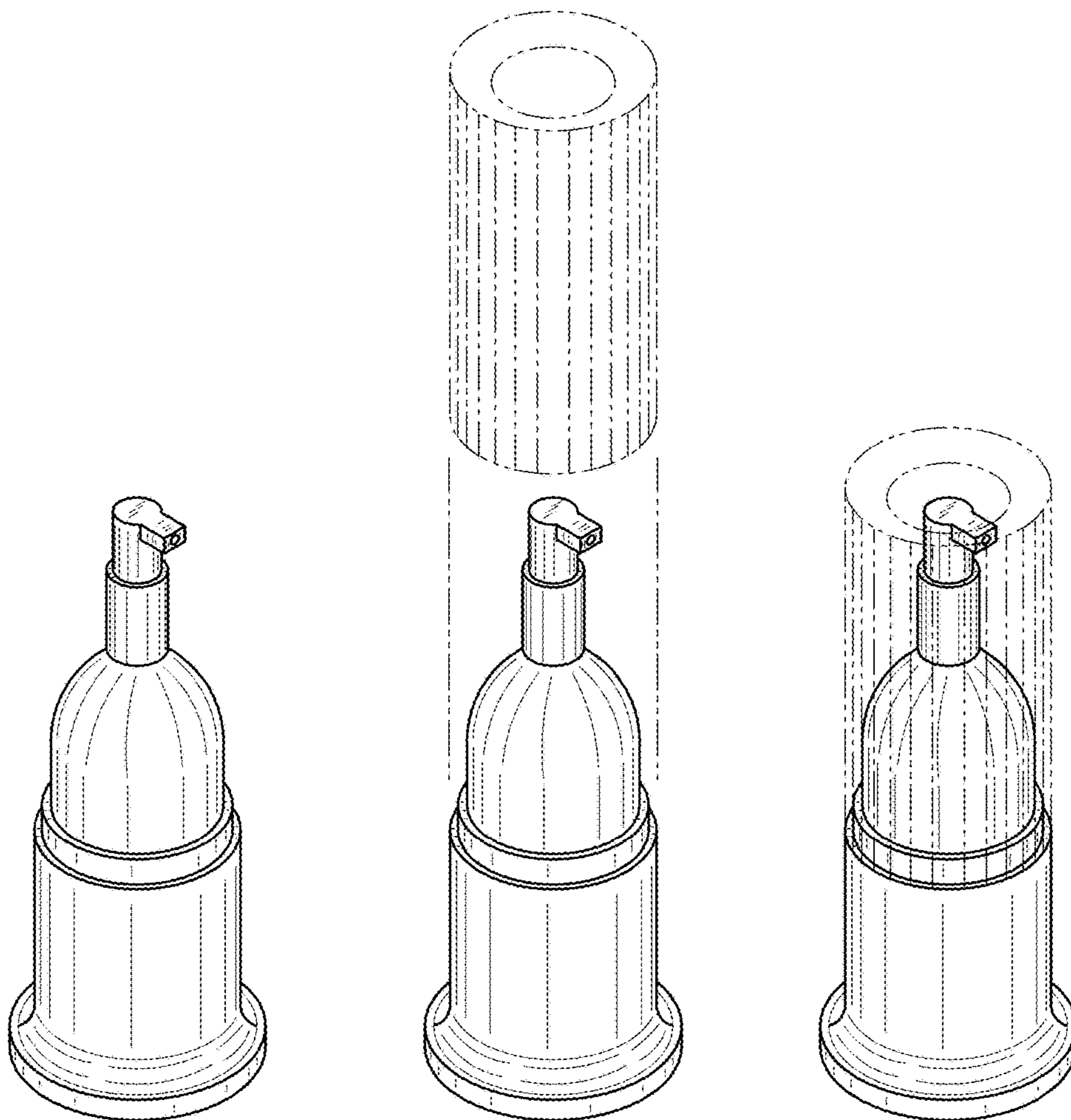
