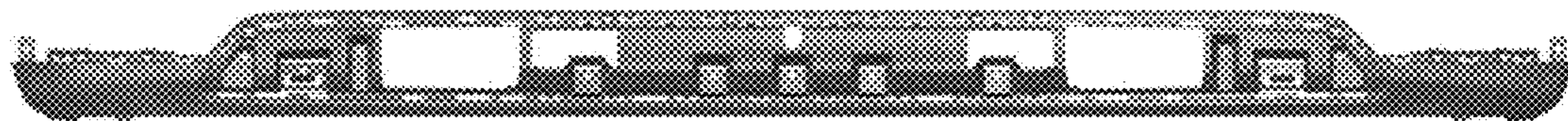
(57) **CLAIM**

The ornamental design for a vehicle front lower bumper cover, as shown.

**DESCRIPTION**

FIG. 1 is a top and left side perspective view of a vehicle front lower bumper cover showing our new design;

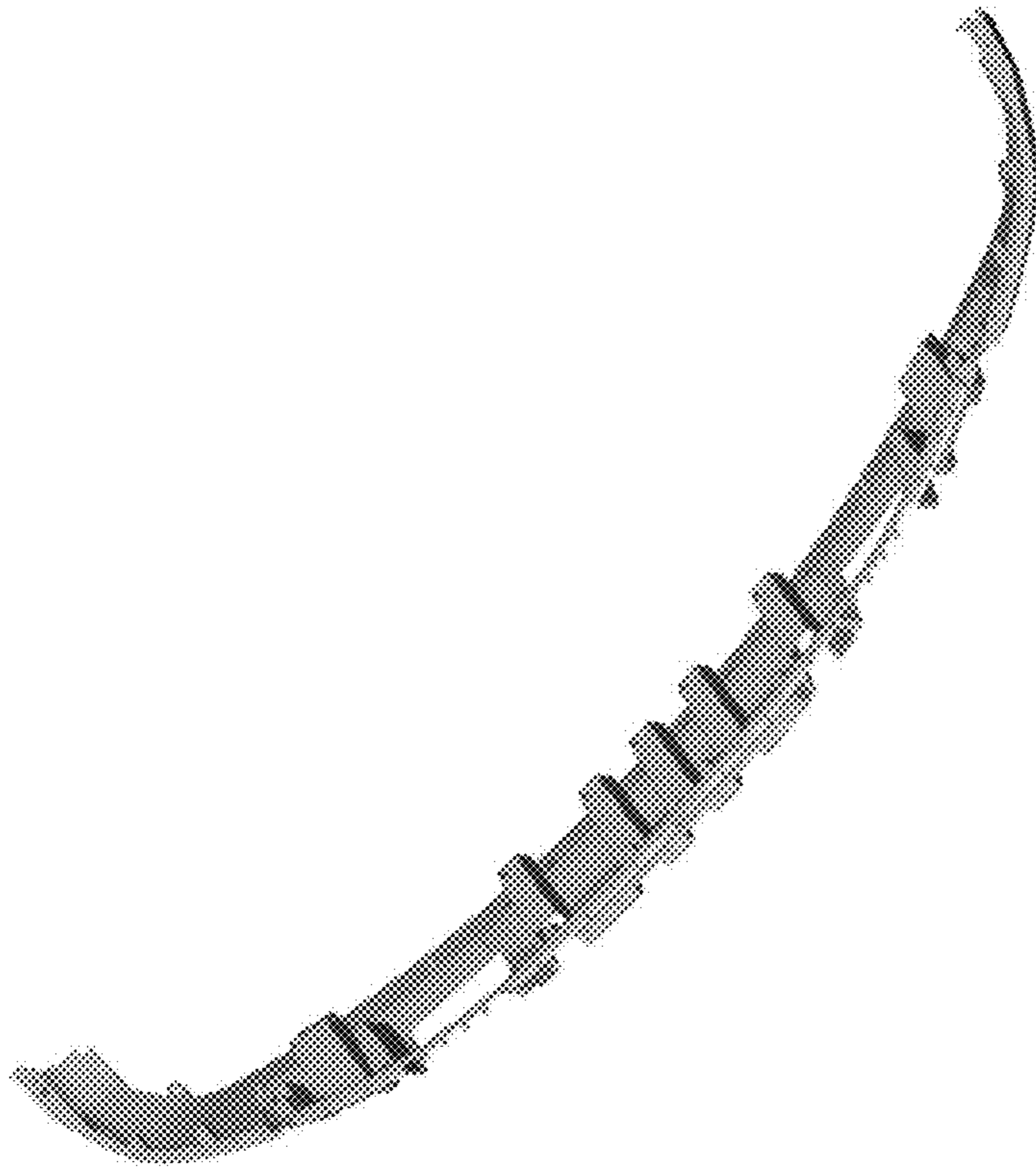

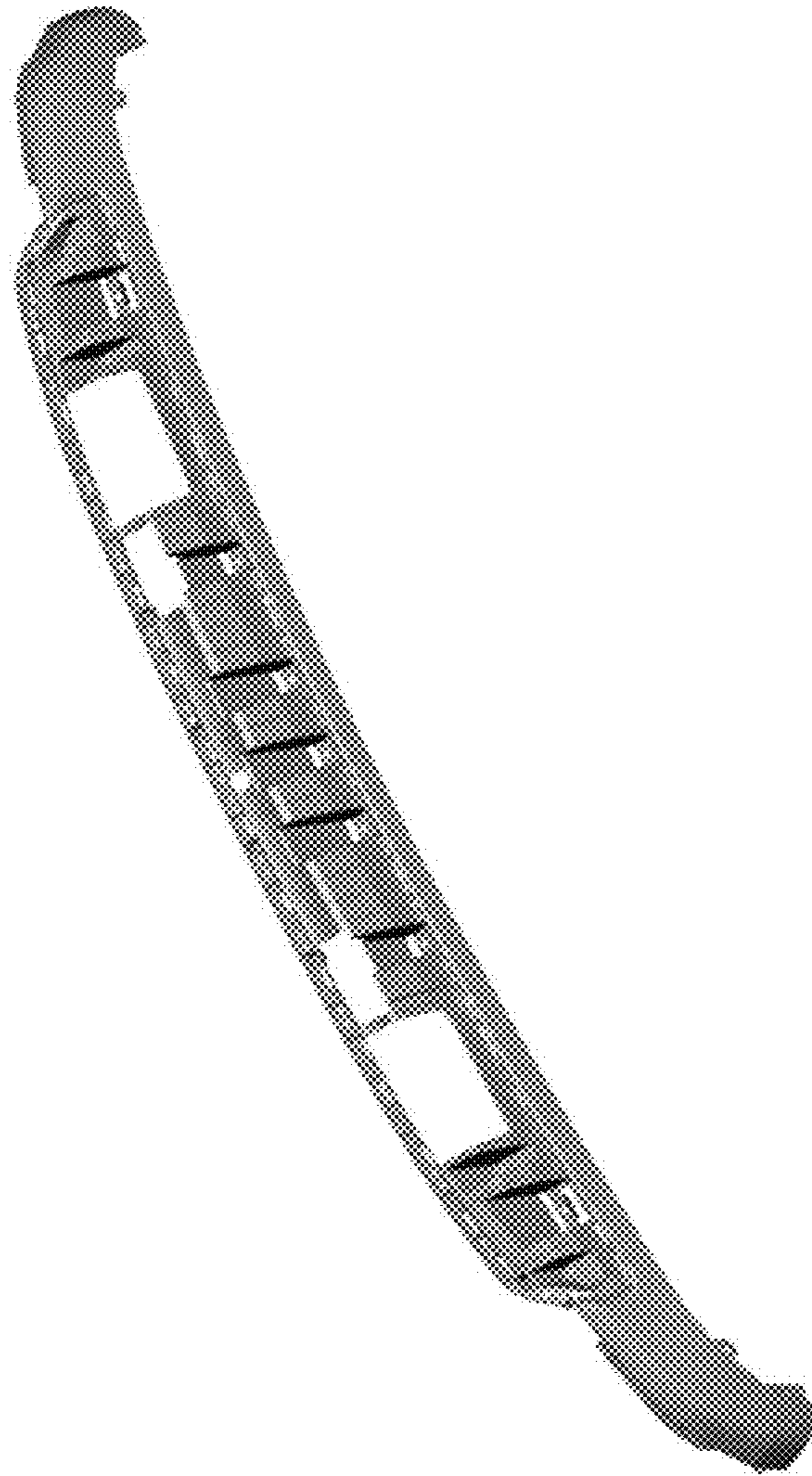

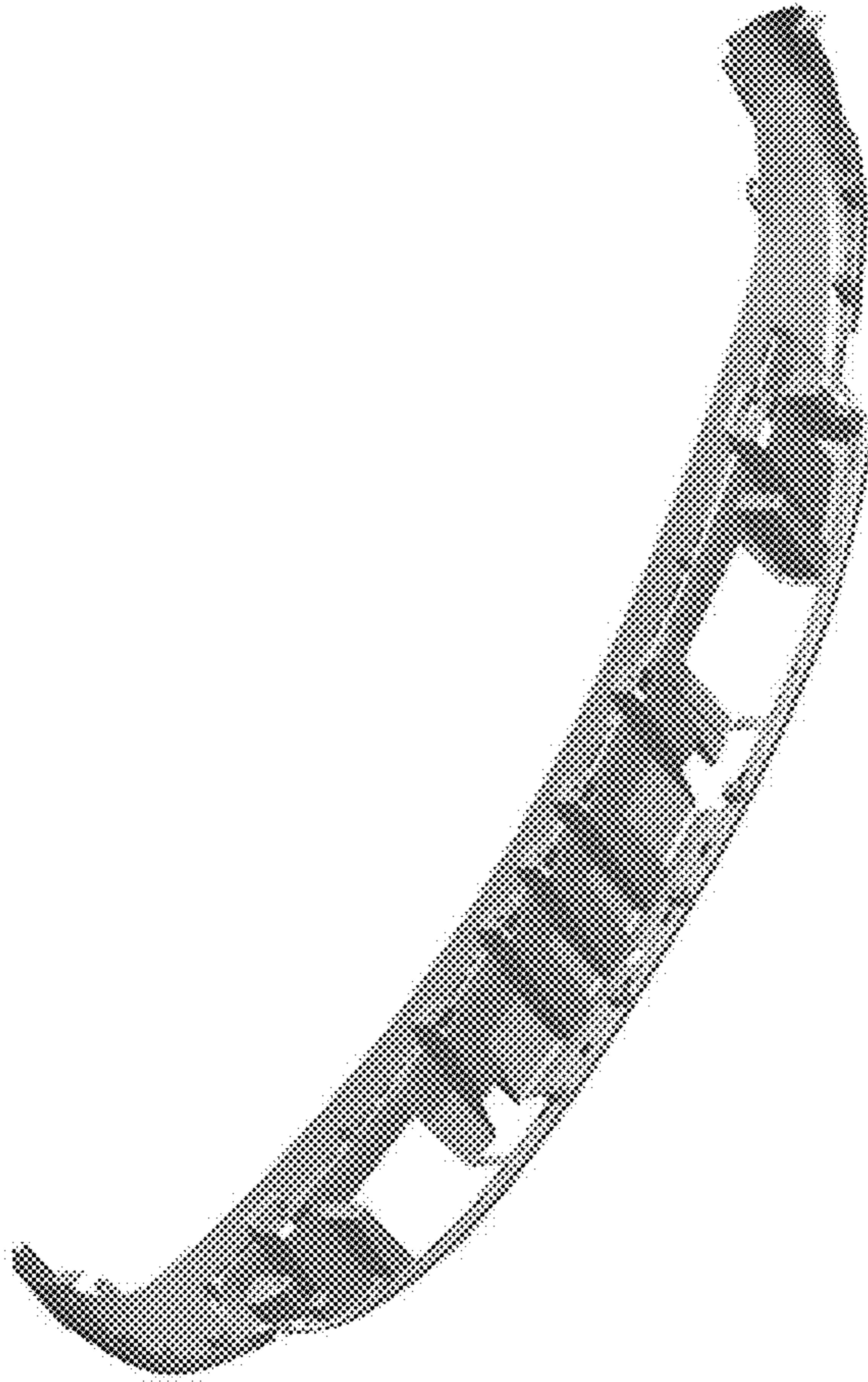

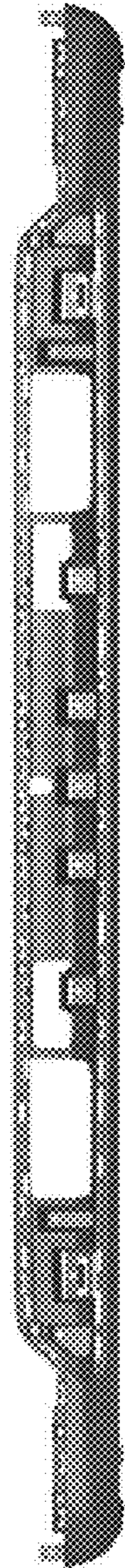

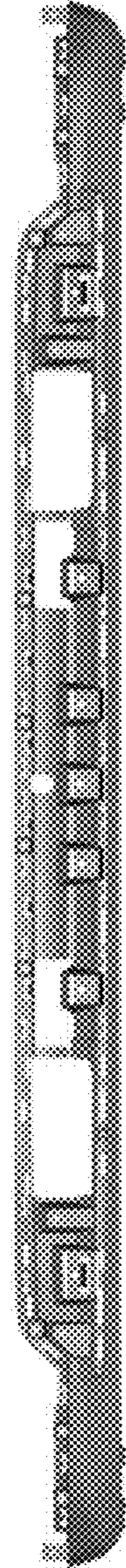

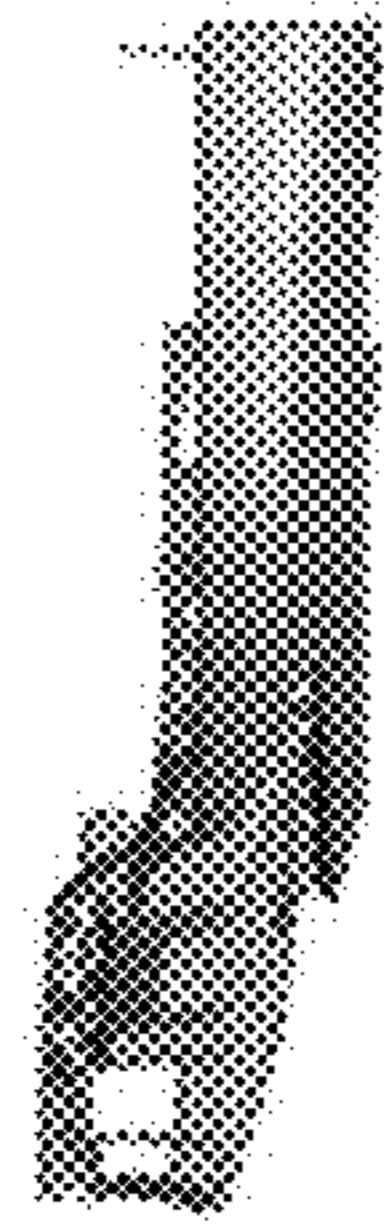

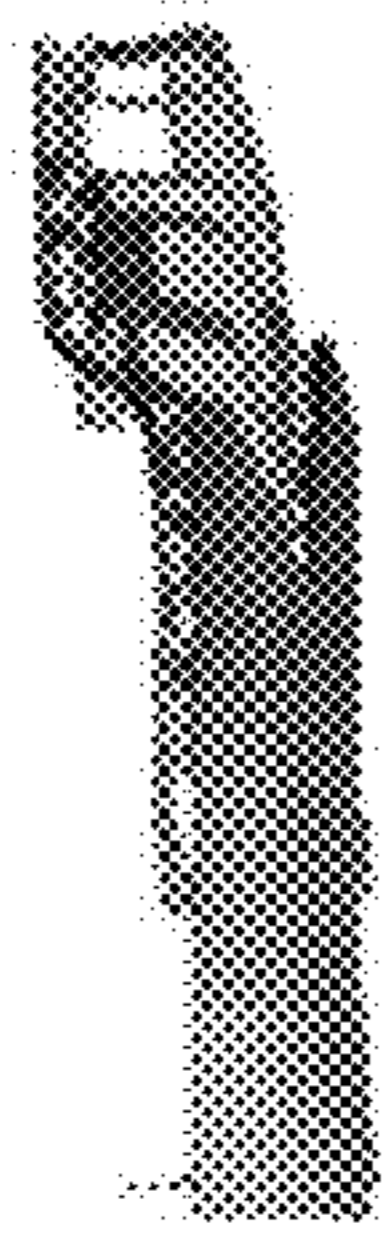
