FIG. 4 is a right-side elevational view thereof, the left-side elevational view (not provided) being a mirror image thereof;

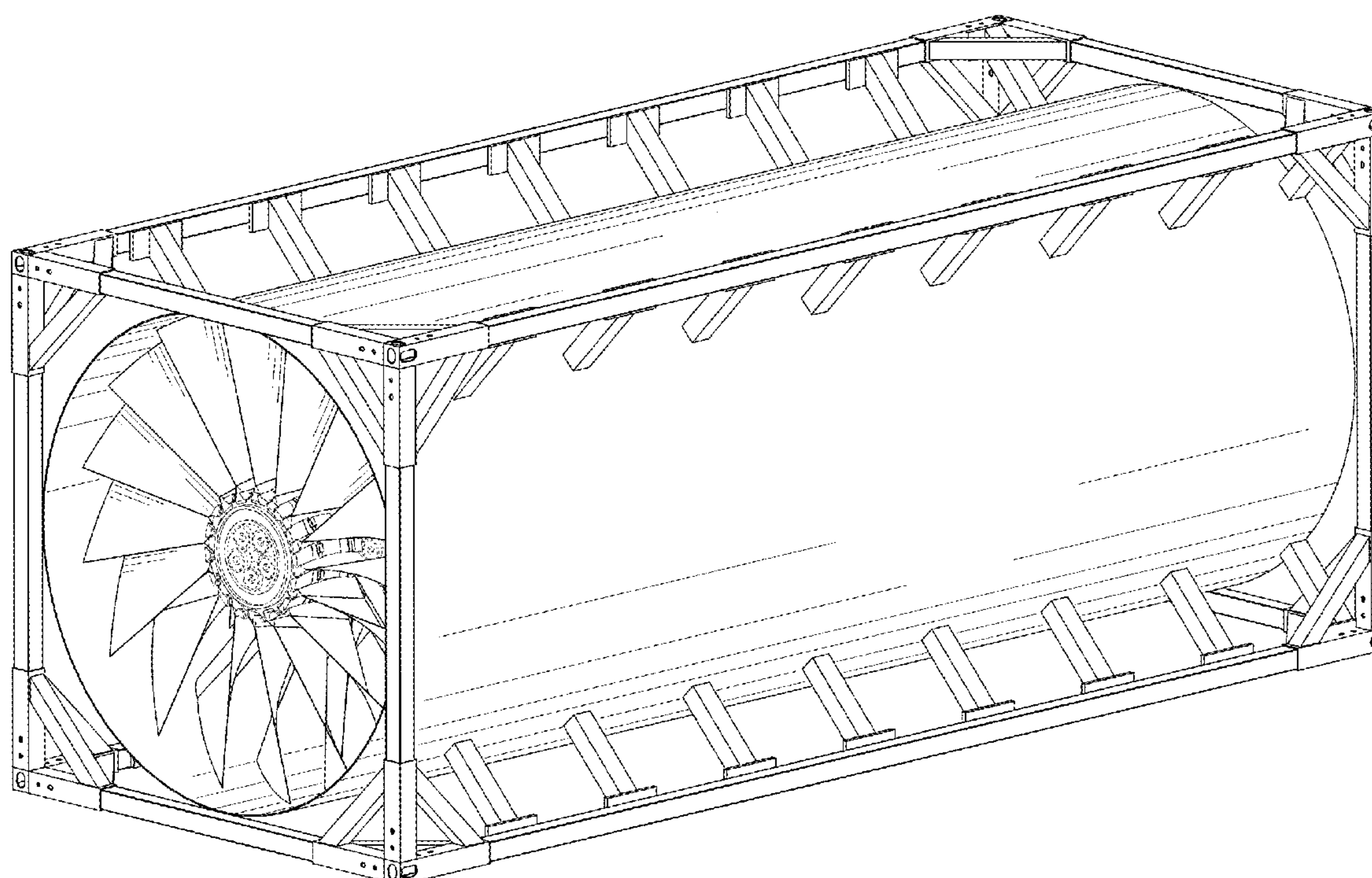
FIG. 5 is a rear elevational view thereof;

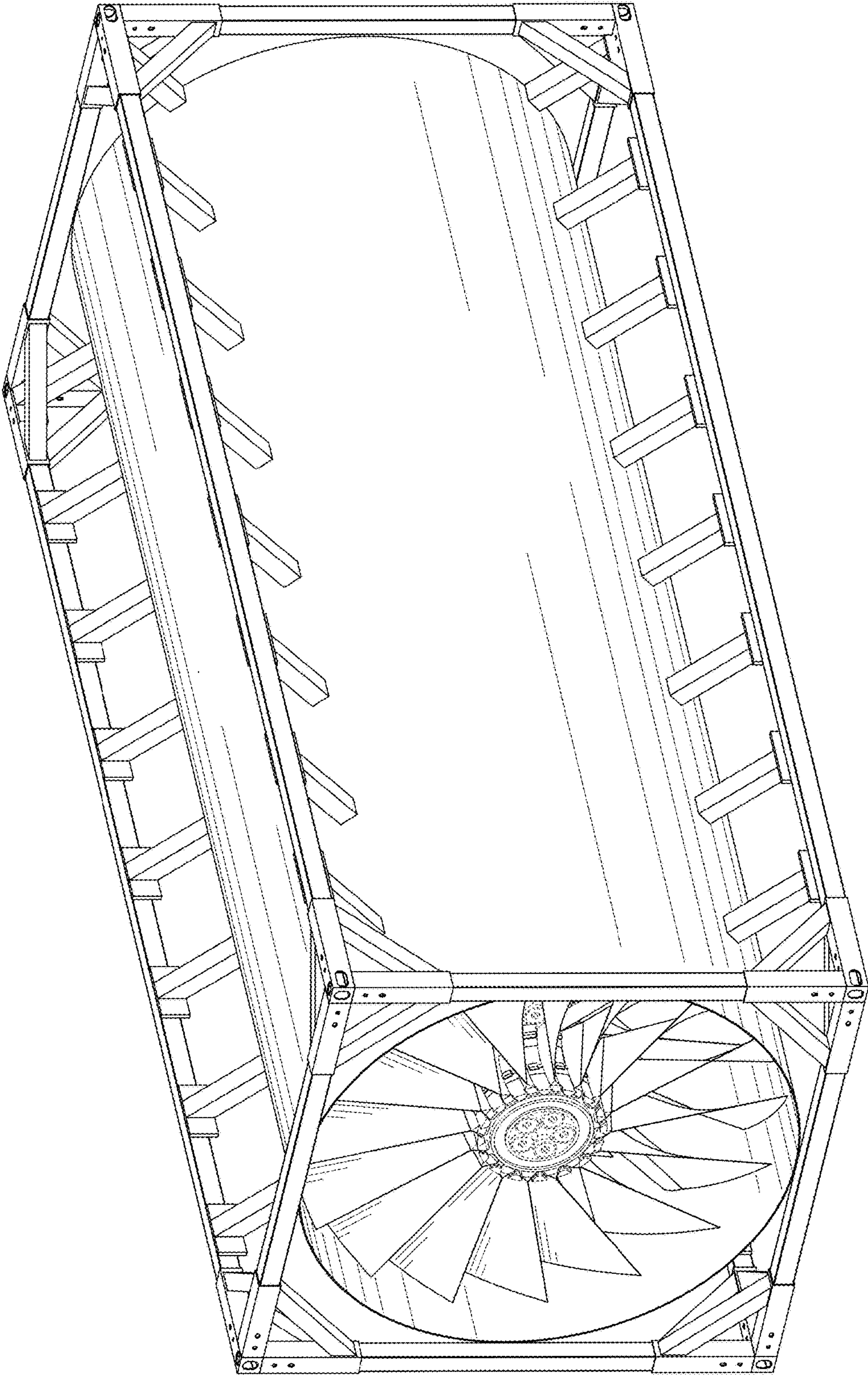

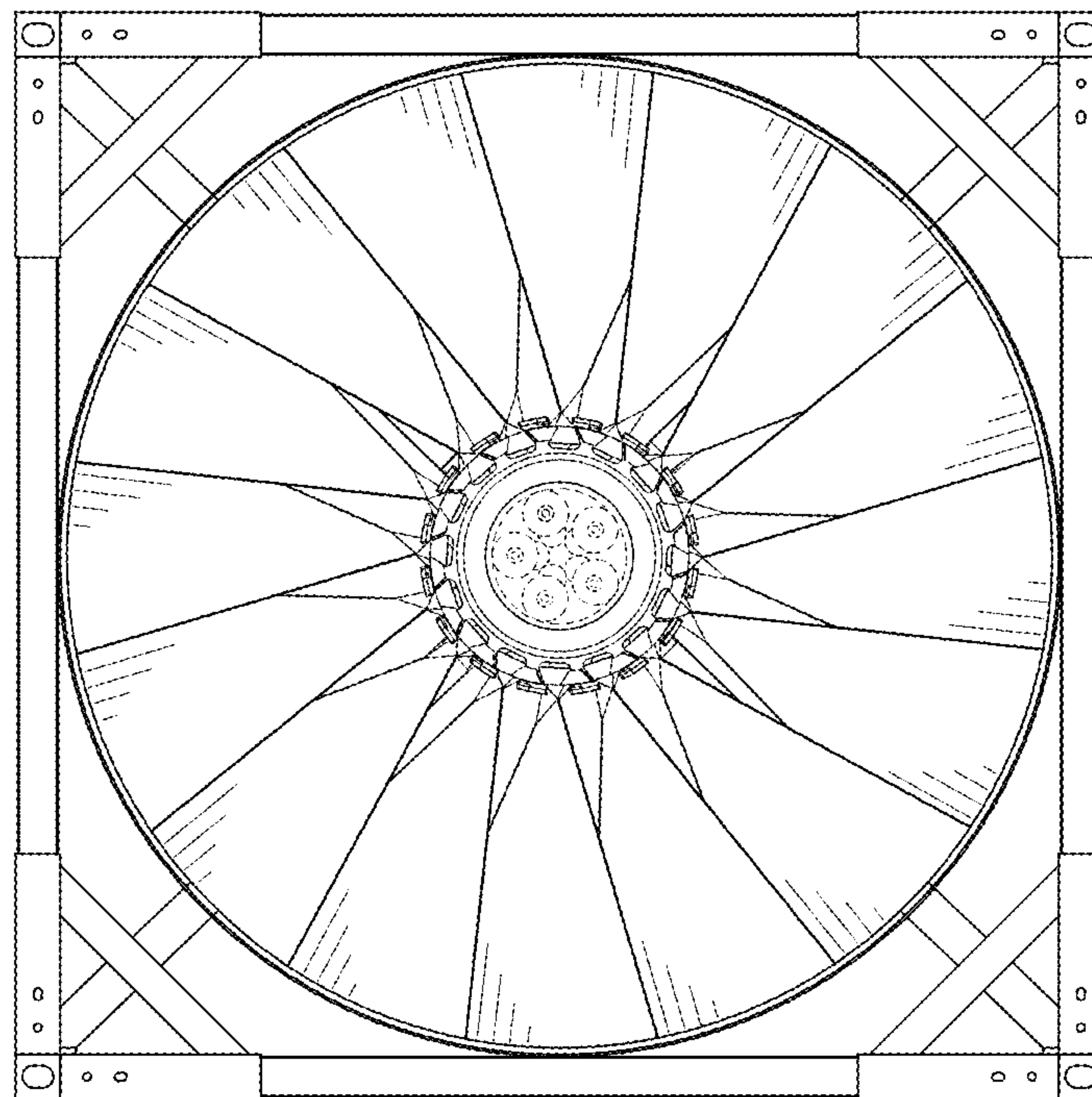
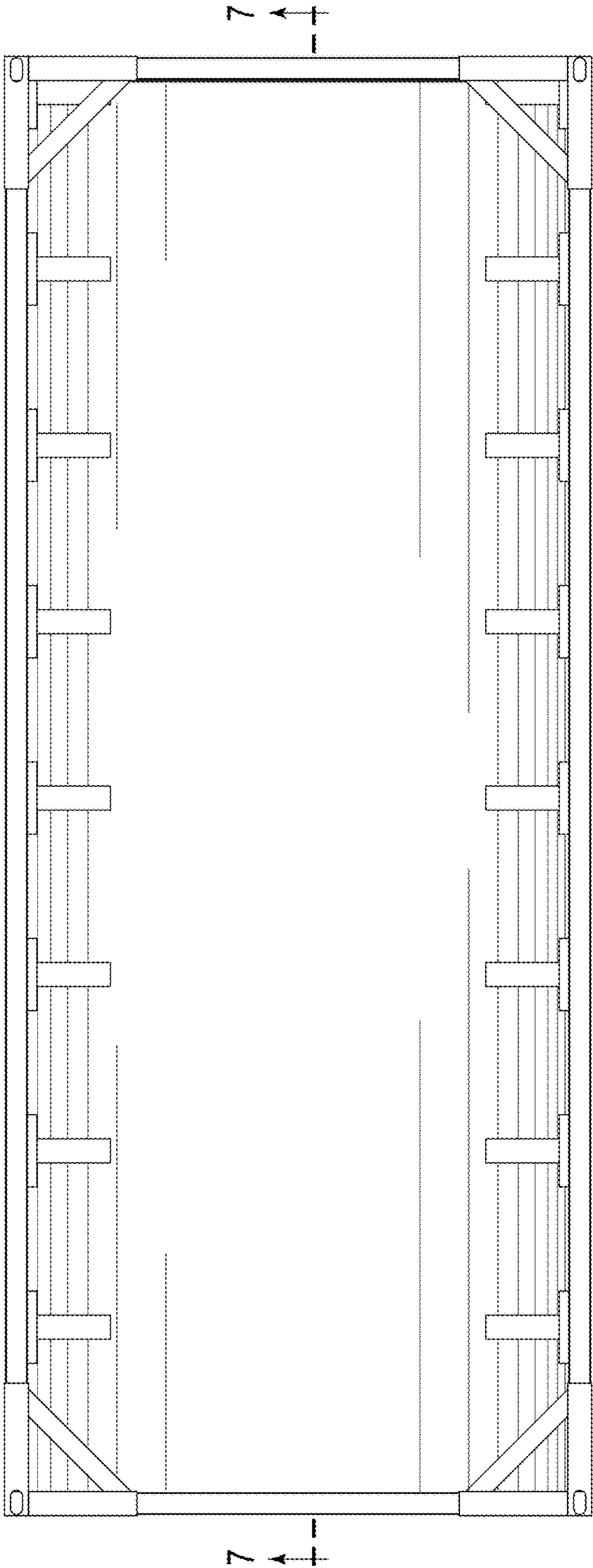

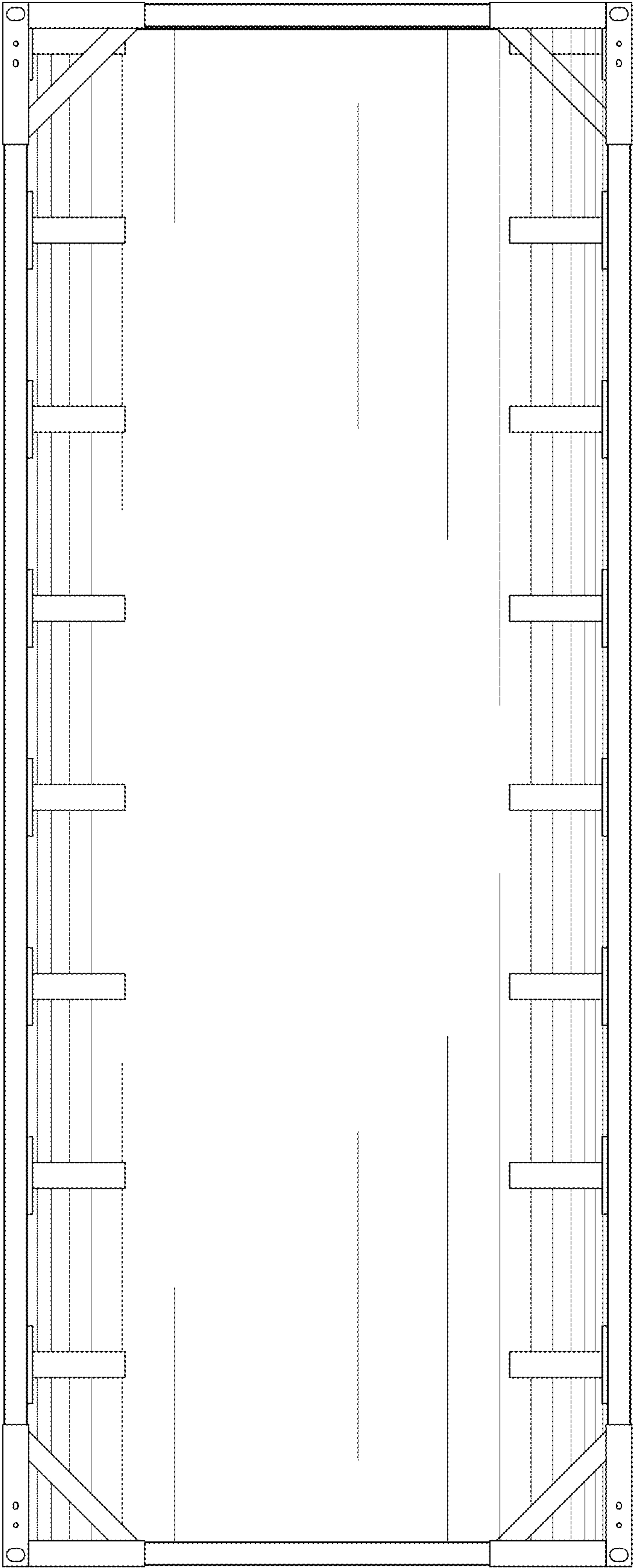

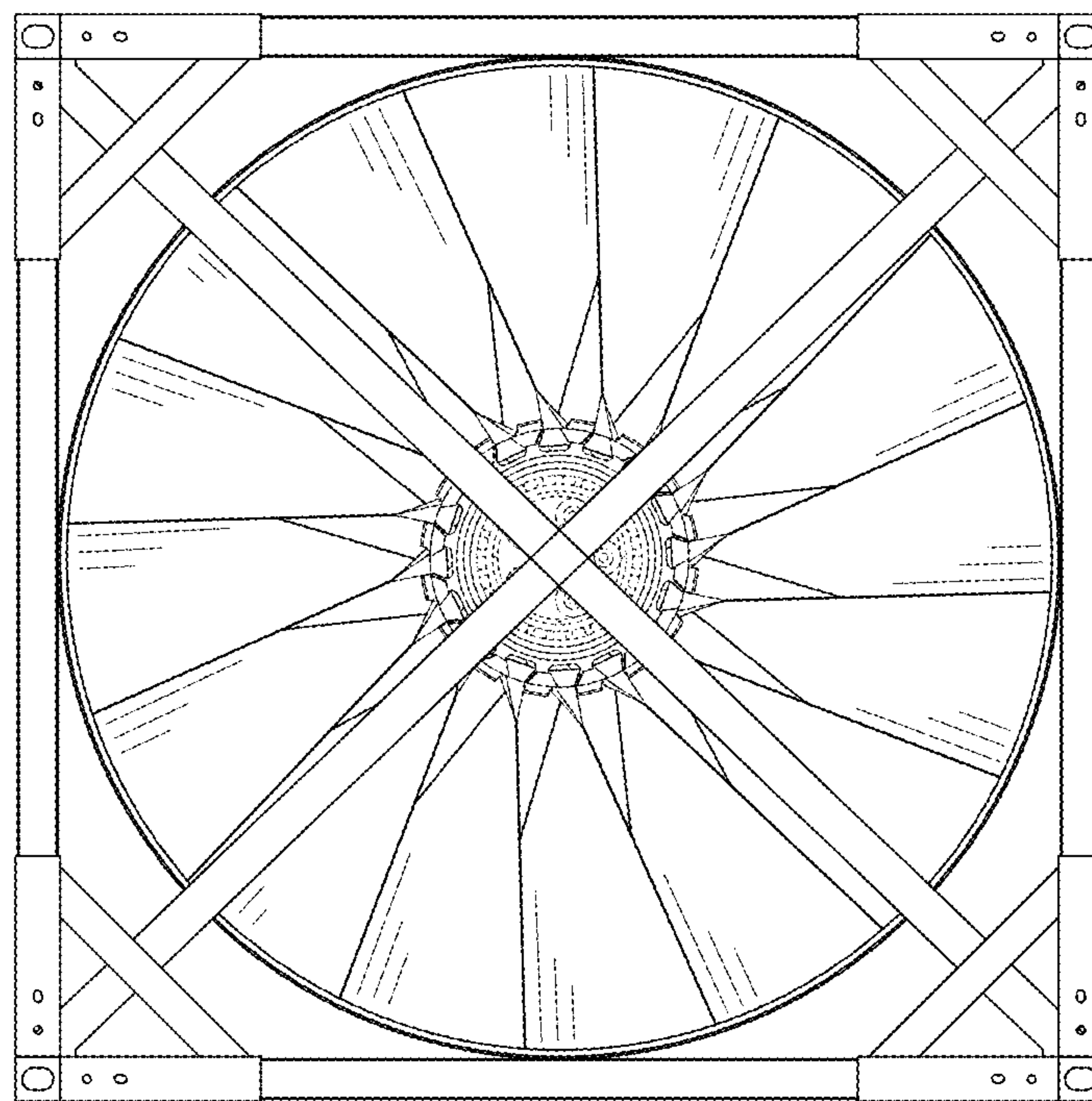
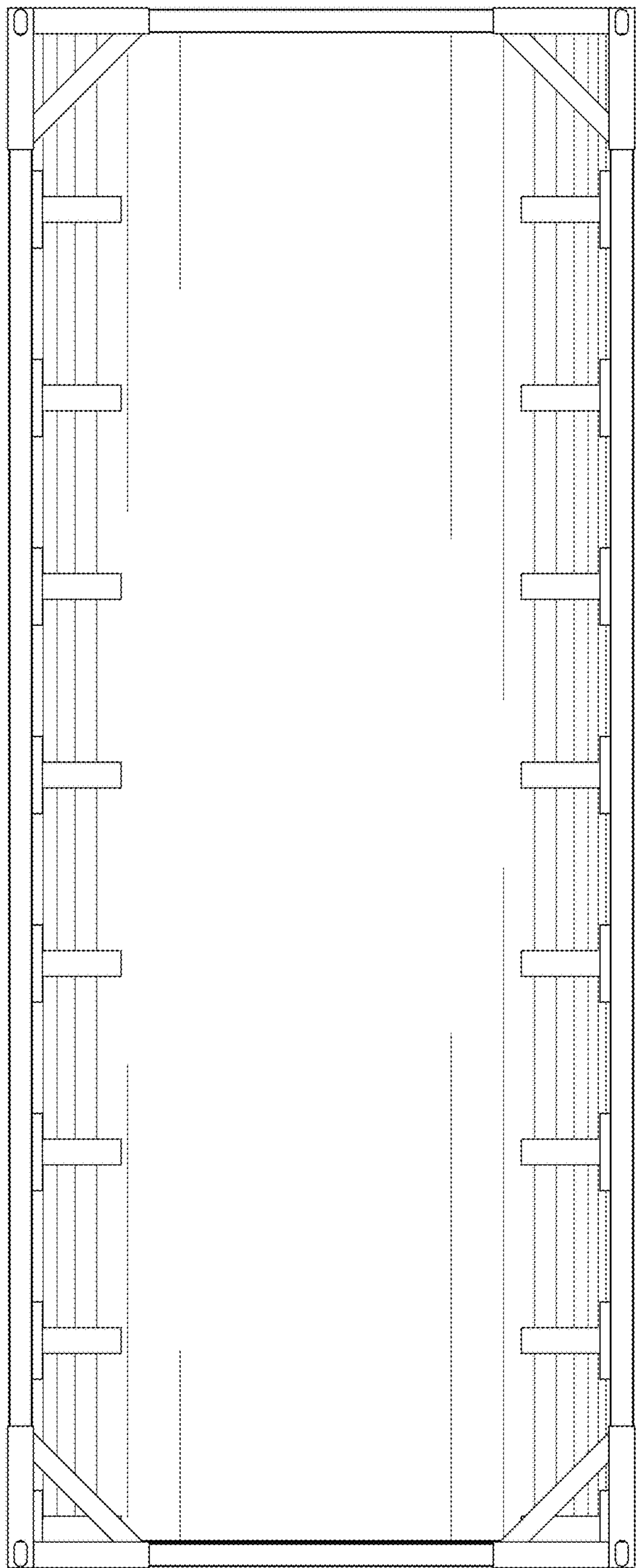

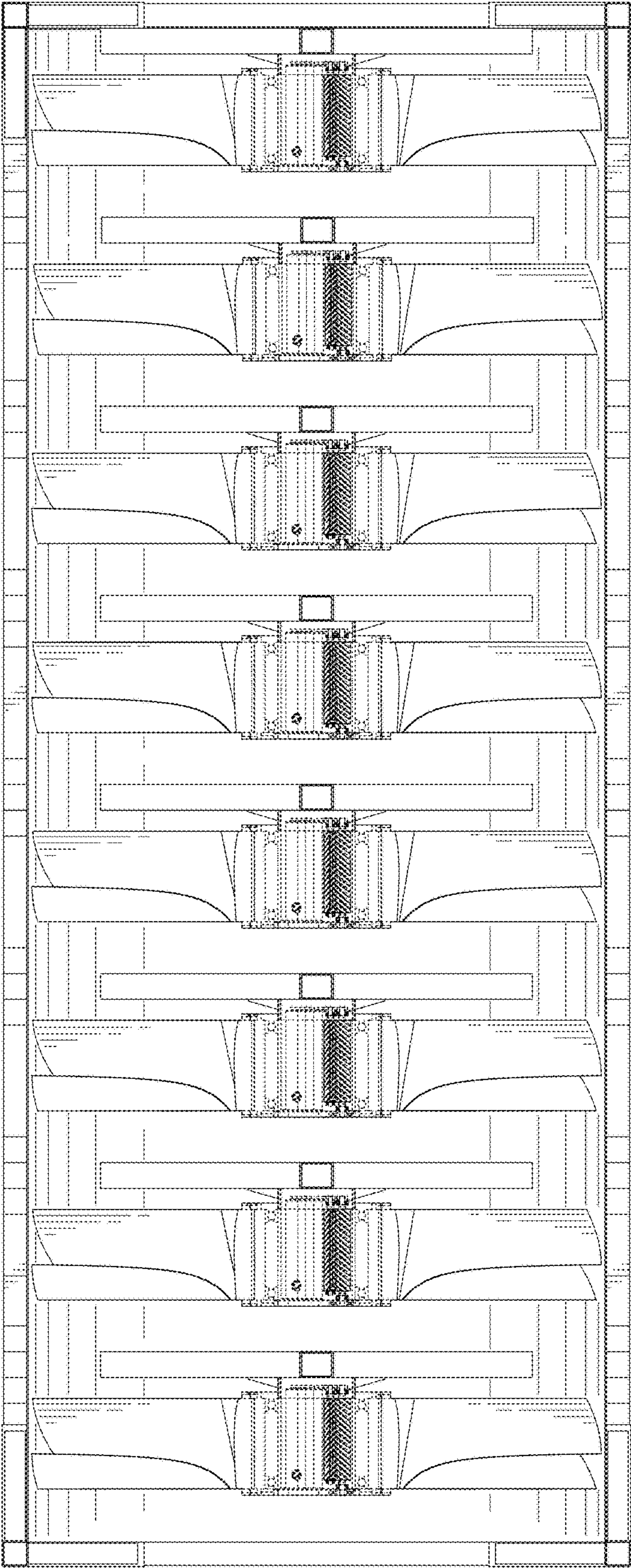
