(57) **CLAIM**

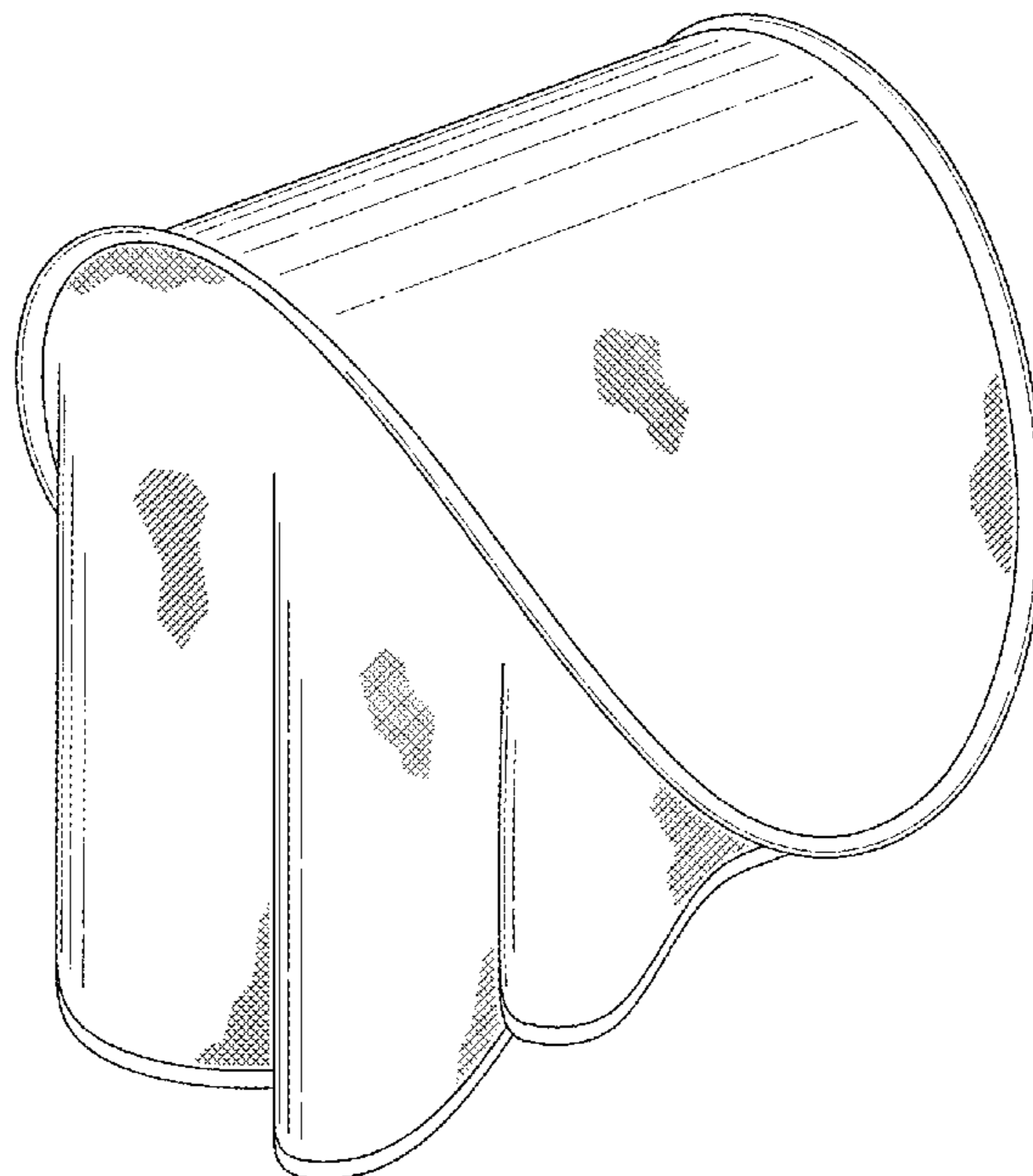
I claim the ornamental design for a tabletop tent, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the tabletop tent.
FIG. 2 is a front view thereof.
FIG. 3 is a right side elevation view thereof, the left side elevation view being a mirror image.
FIG. 4 is a rear plan view thereof.
FIG. 5 is a top view thereof; and,
FIG. 6 is a perspective view also showing the environment of the invention.
The bottom is plain and unornamented, and thus a view of it is omitted.
The broken lines shown illustrate the environment of the invention and form no part of the design to be patented.

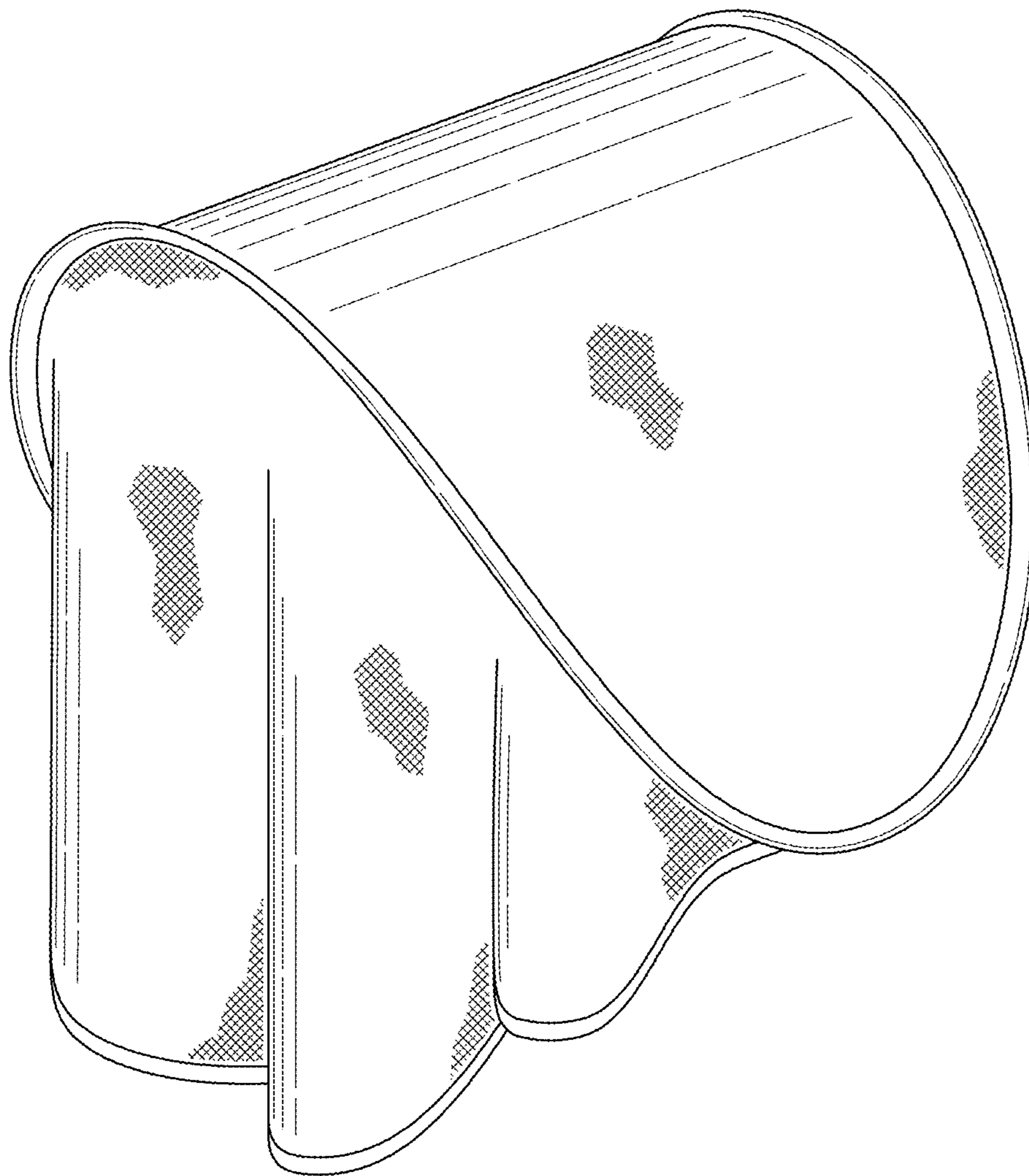

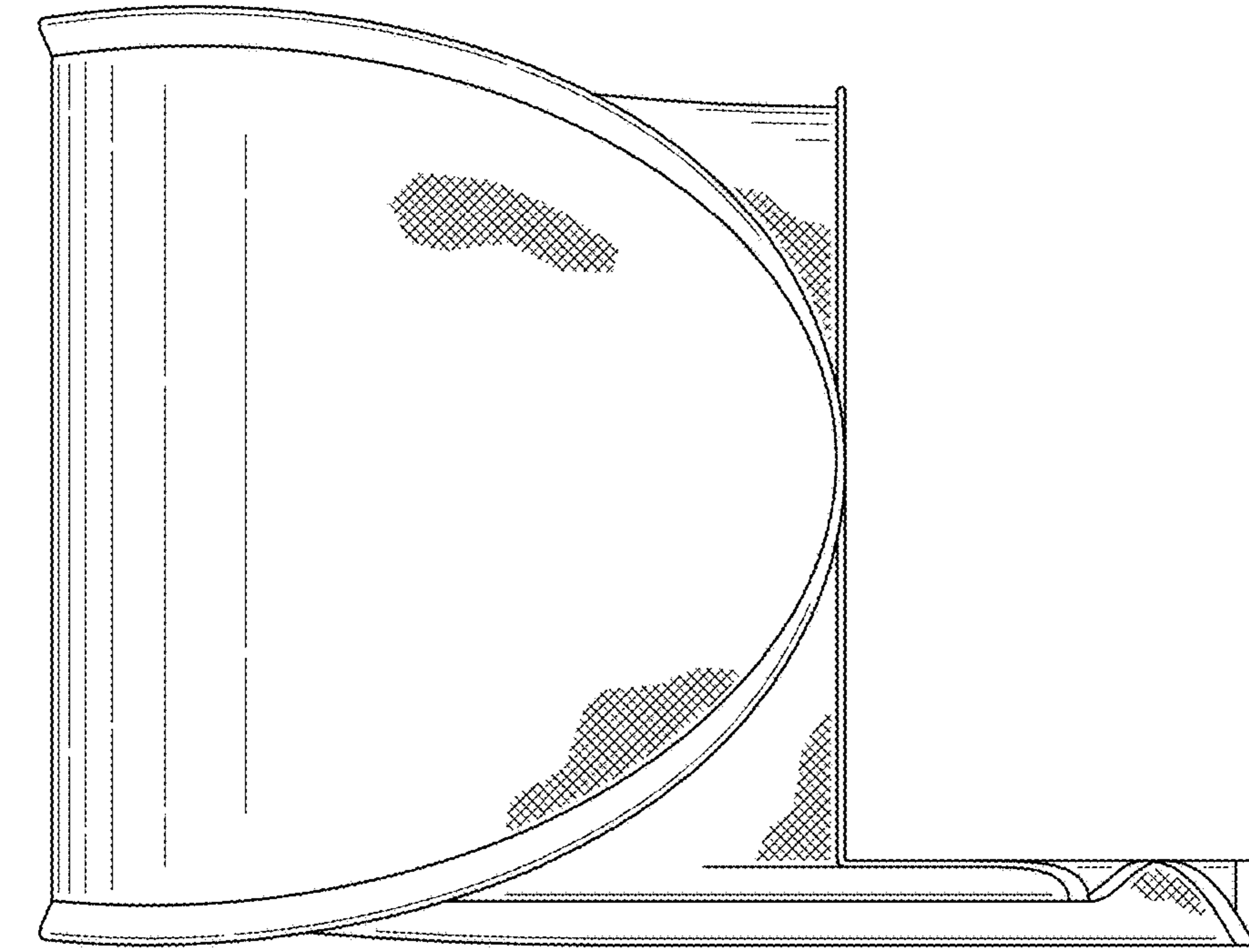

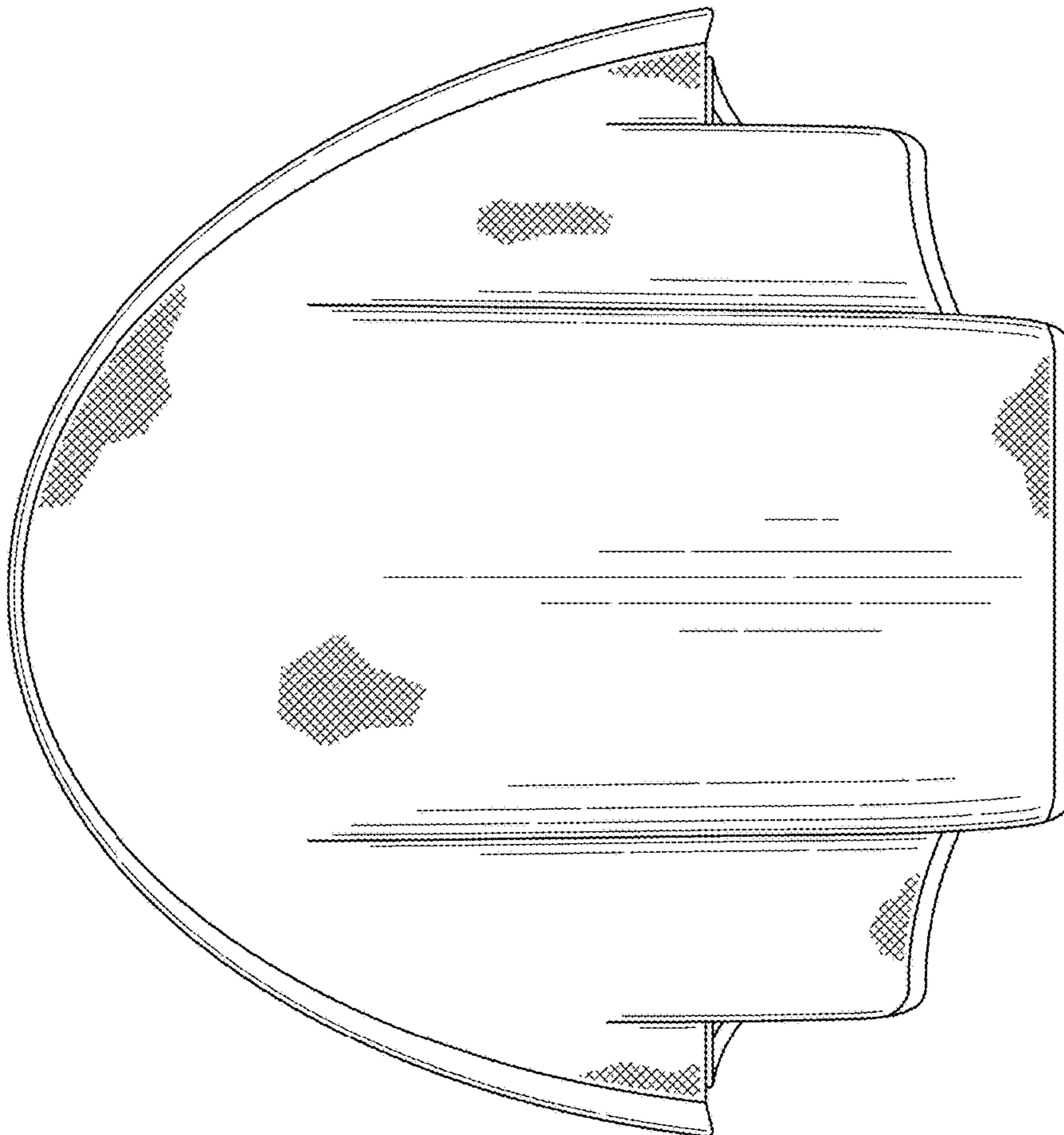

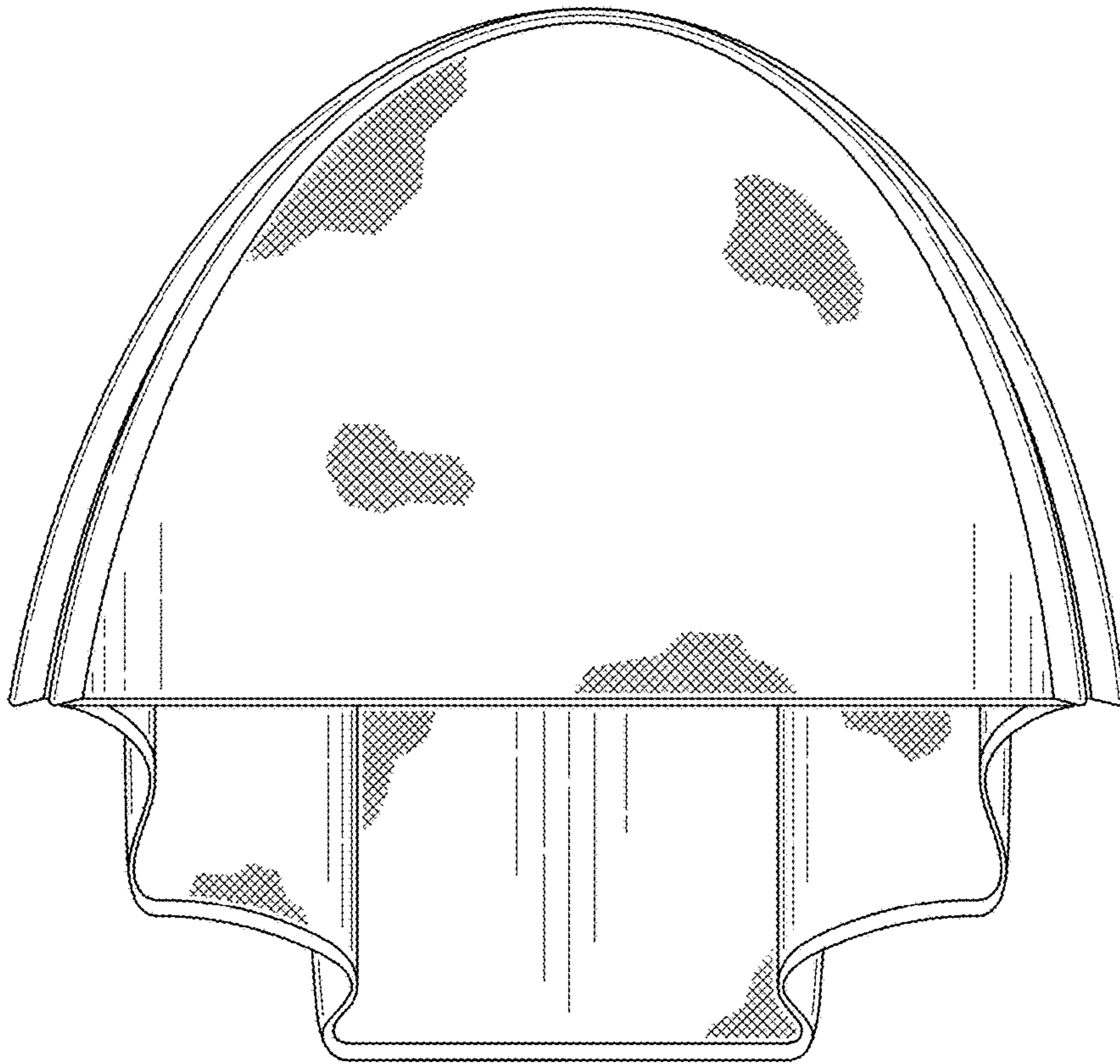

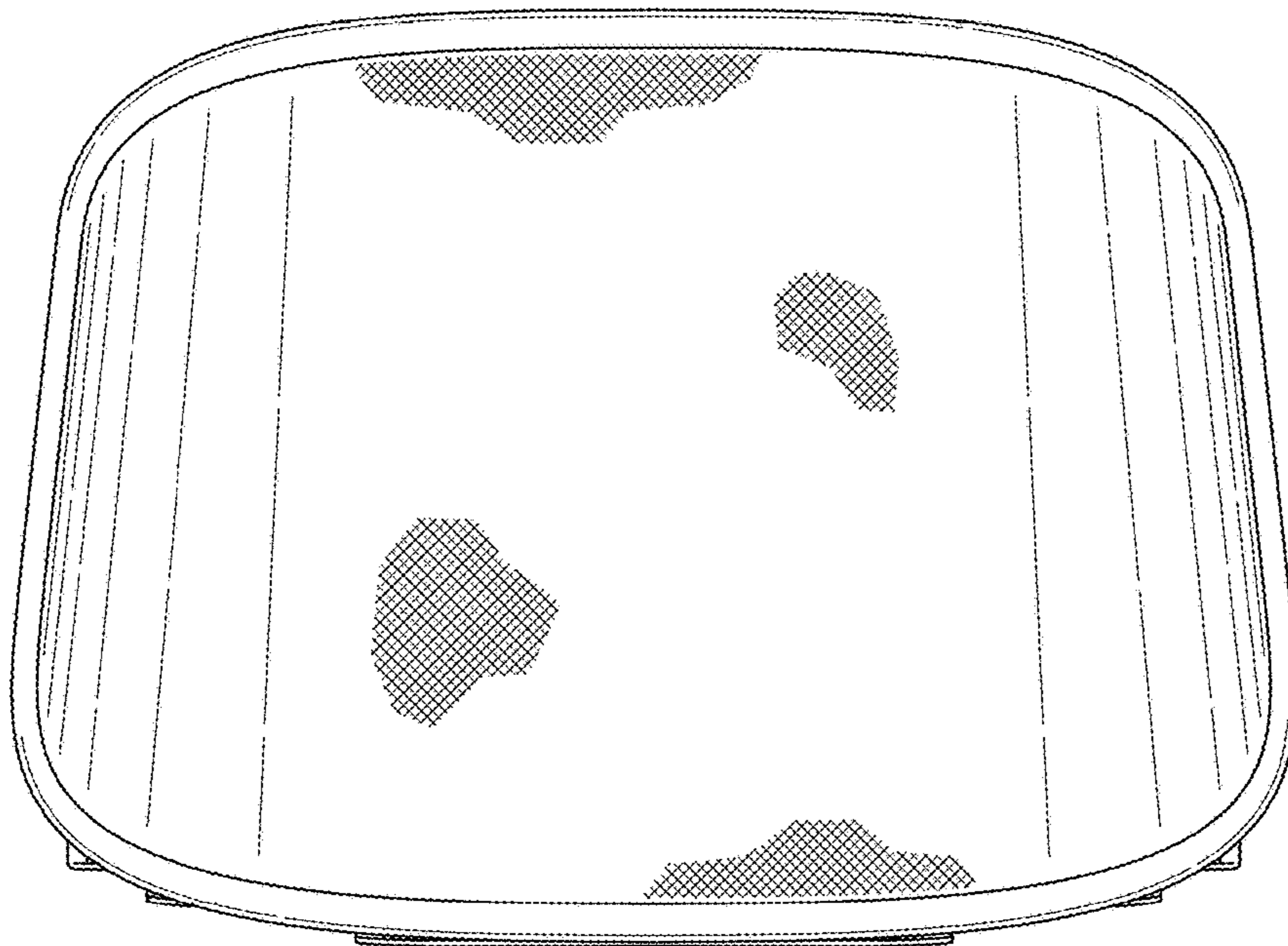

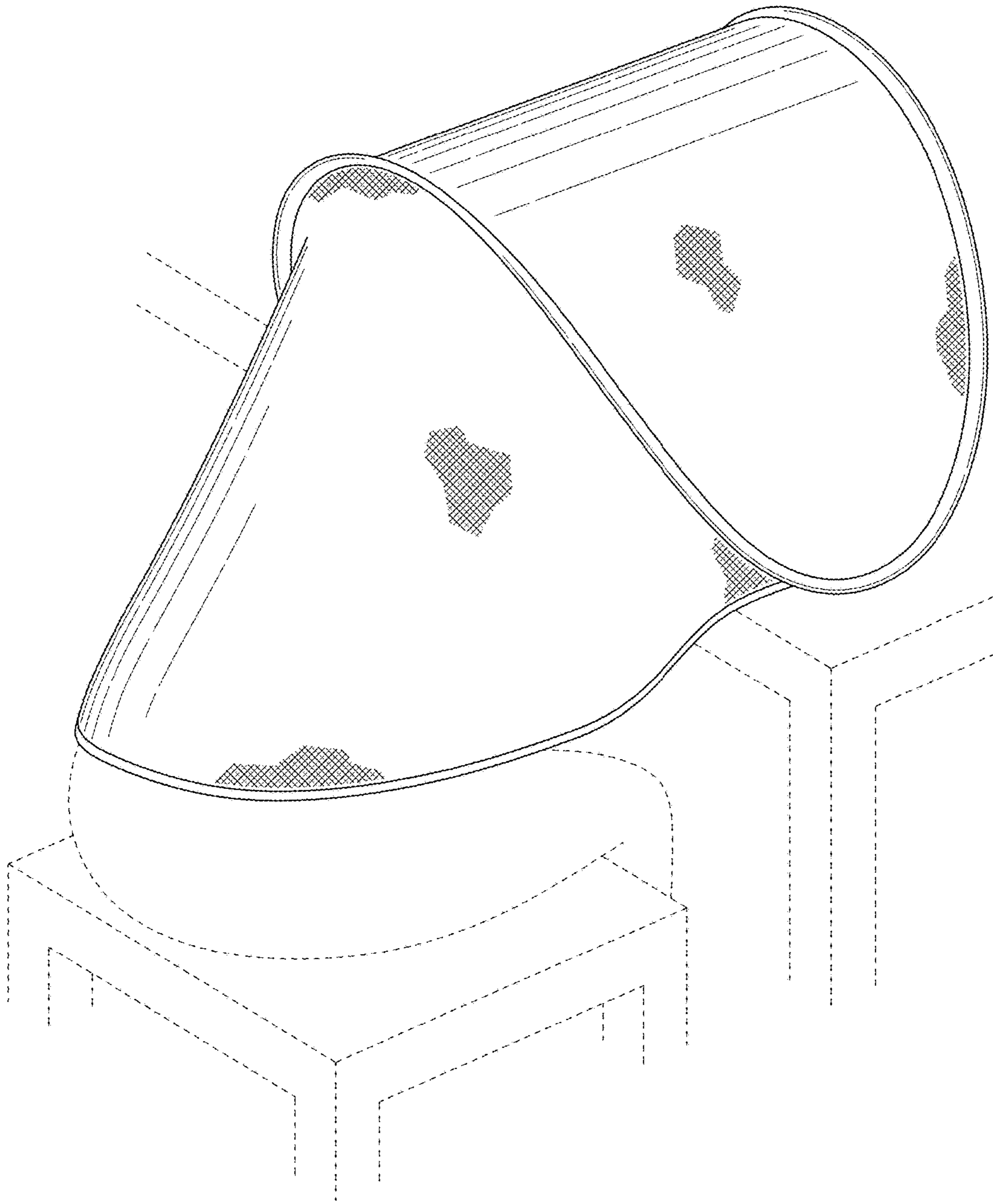
