FIG. 7 is a front view of the on-body injector for drug delivery of FIG. 1.

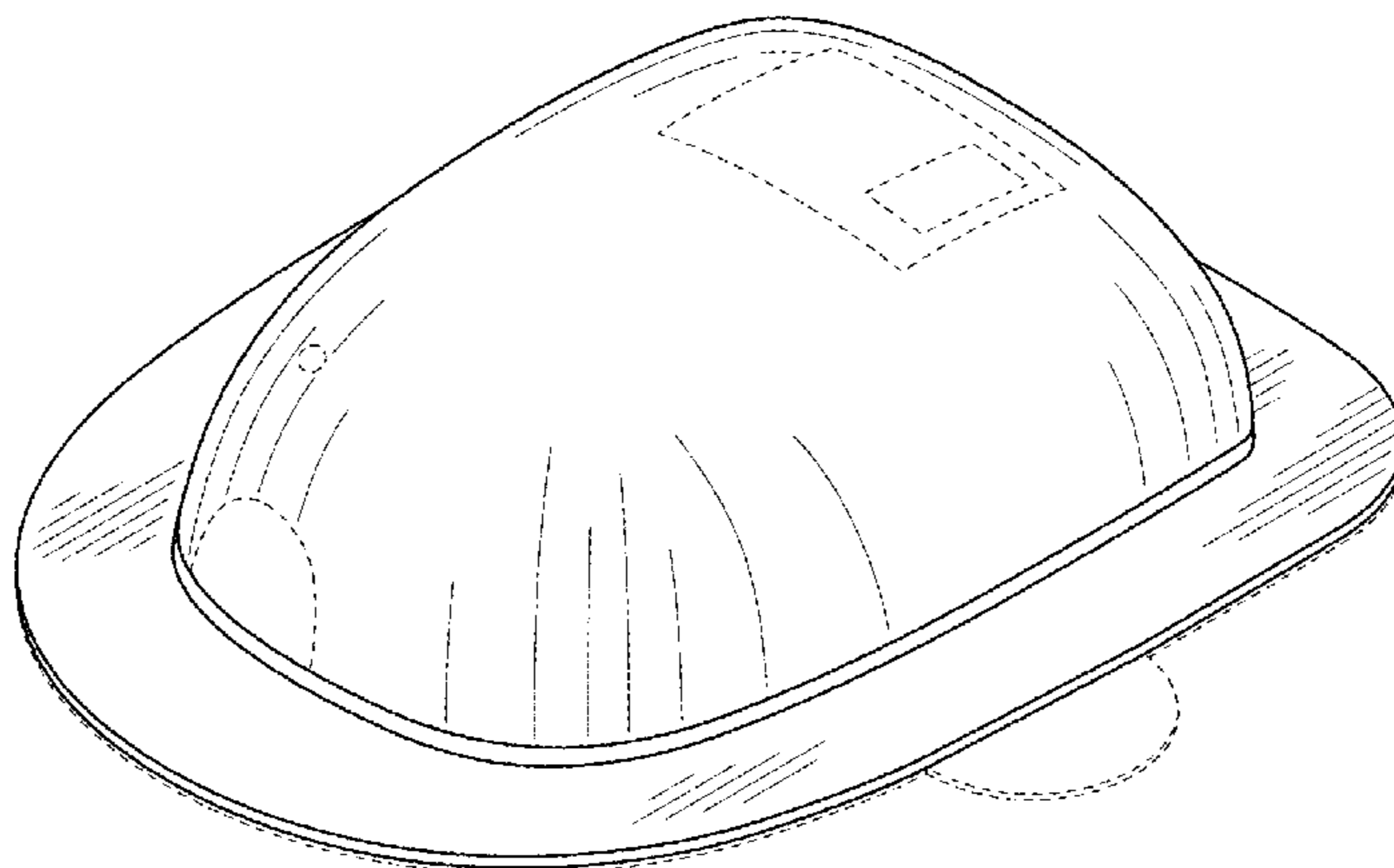

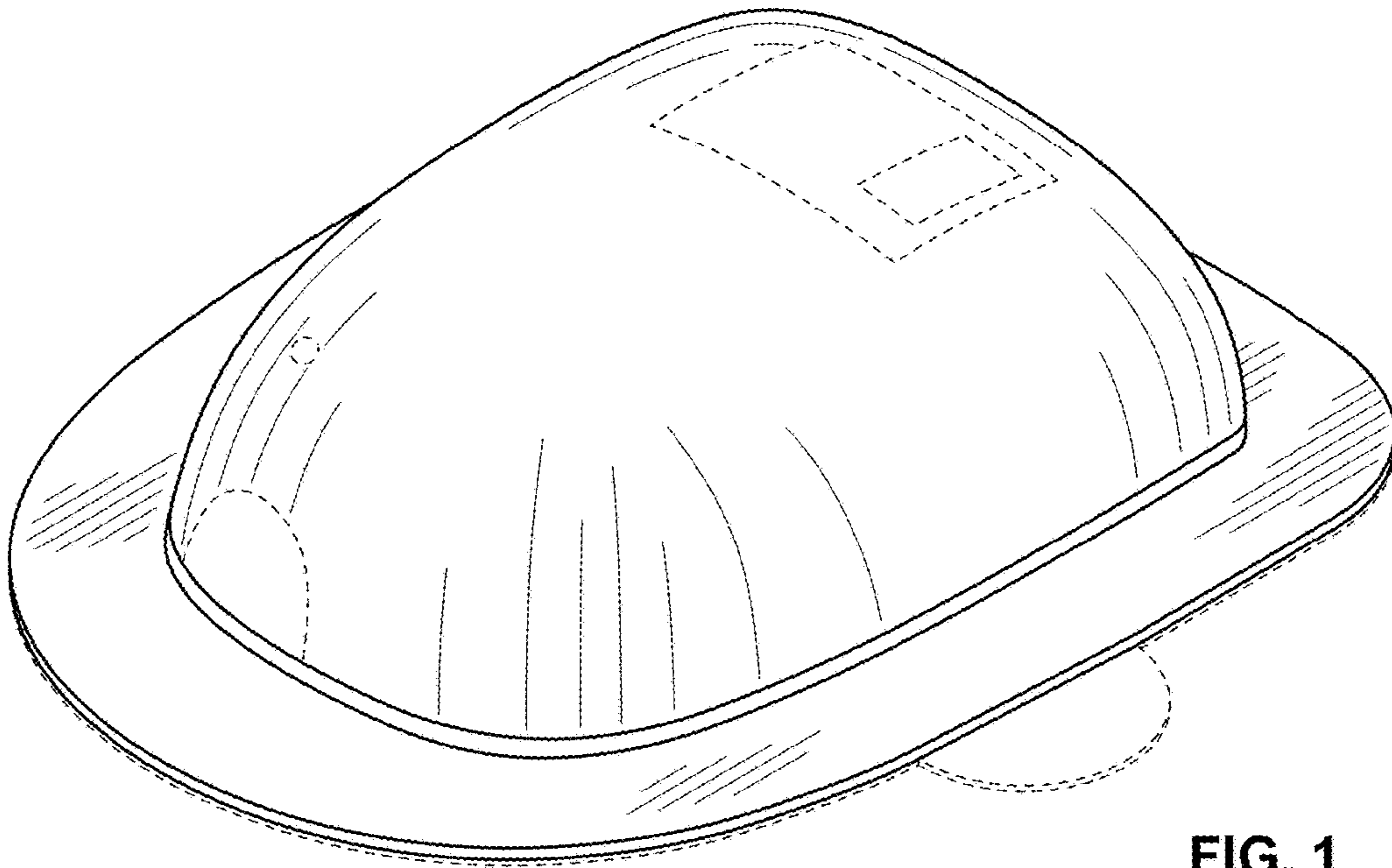

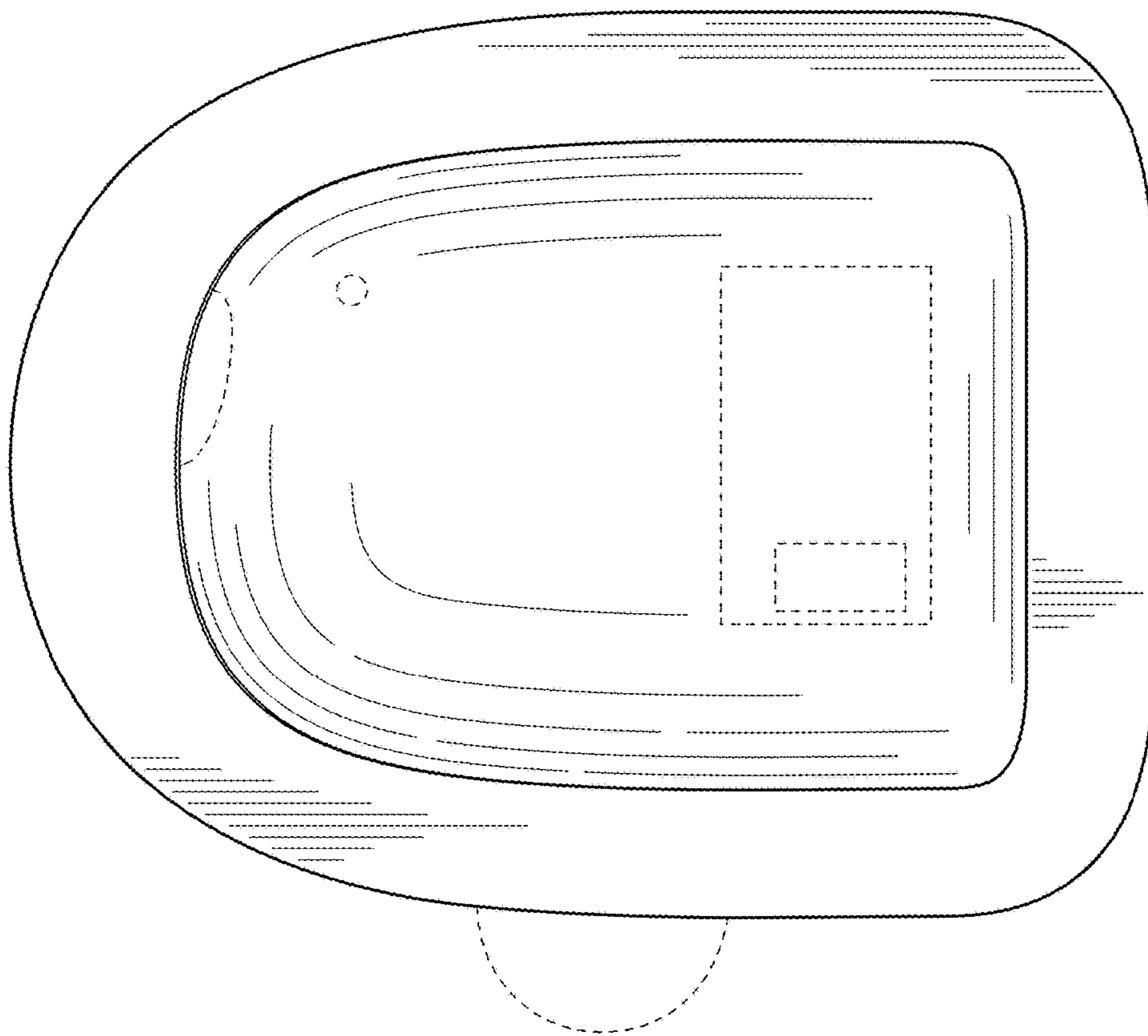

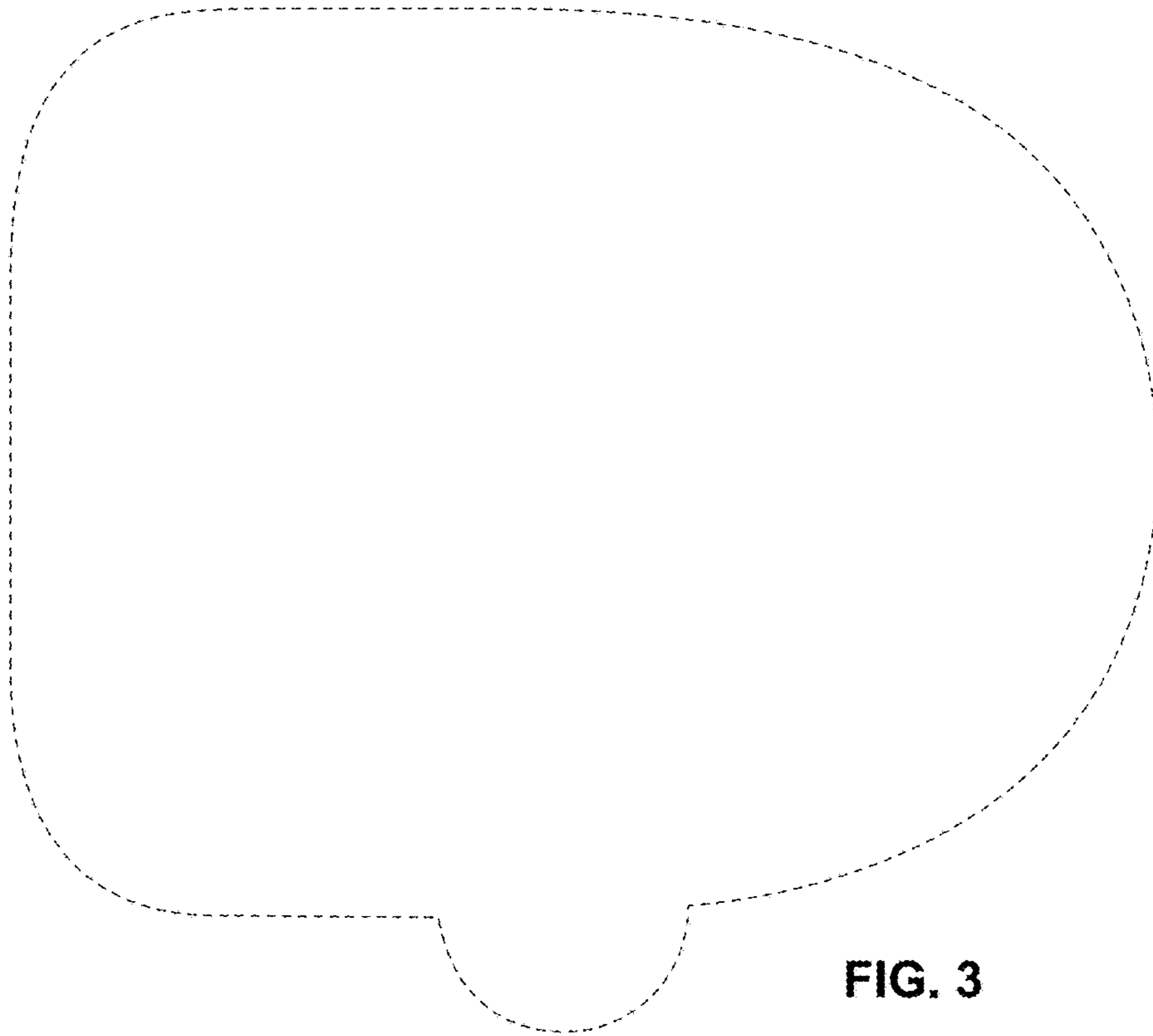

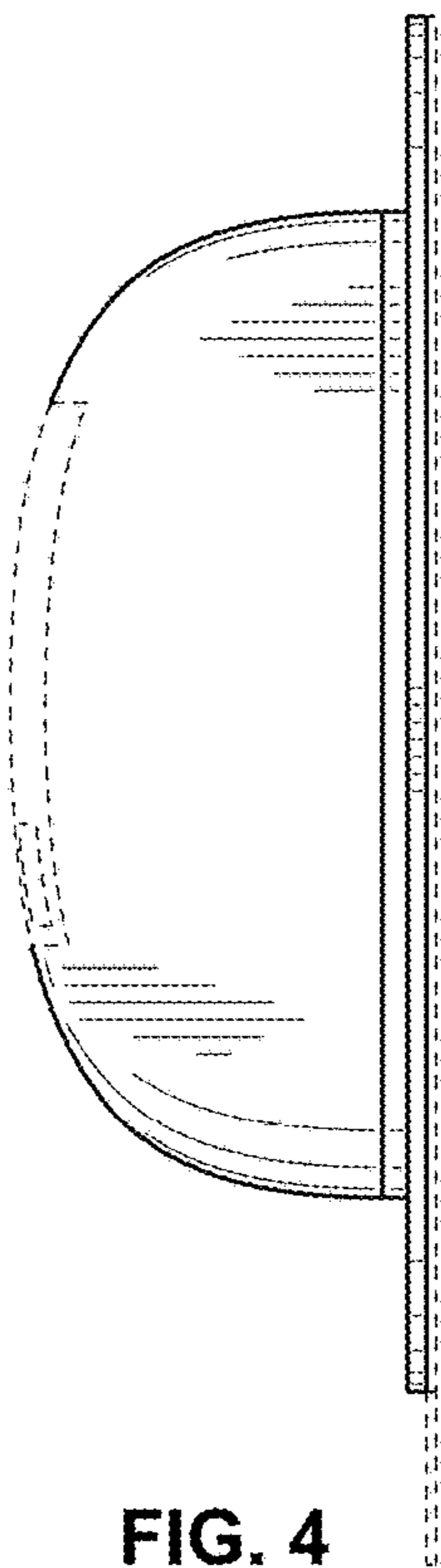

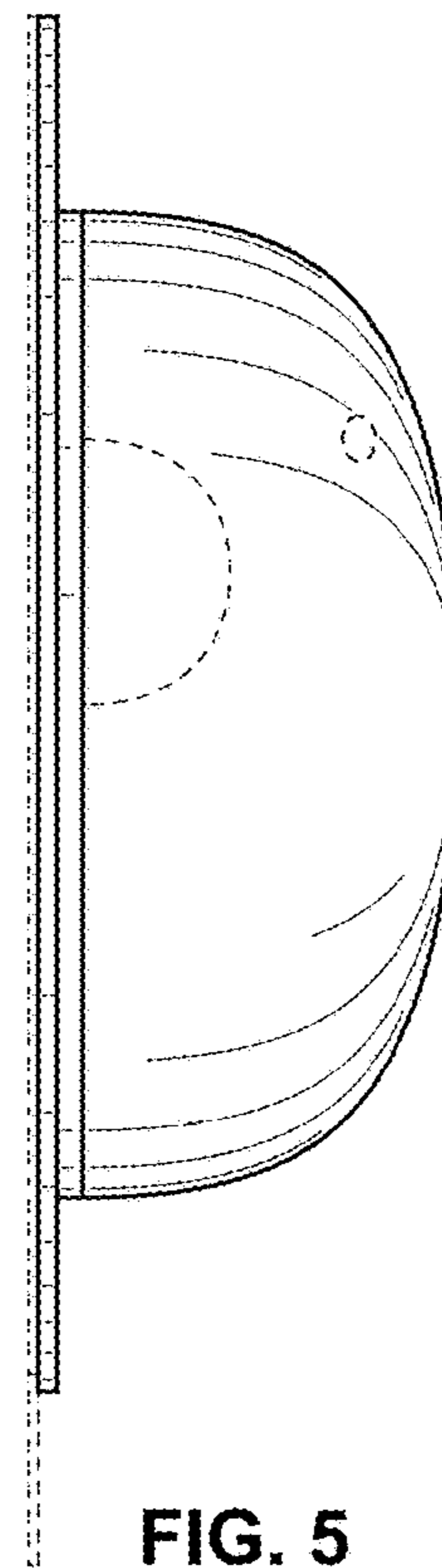

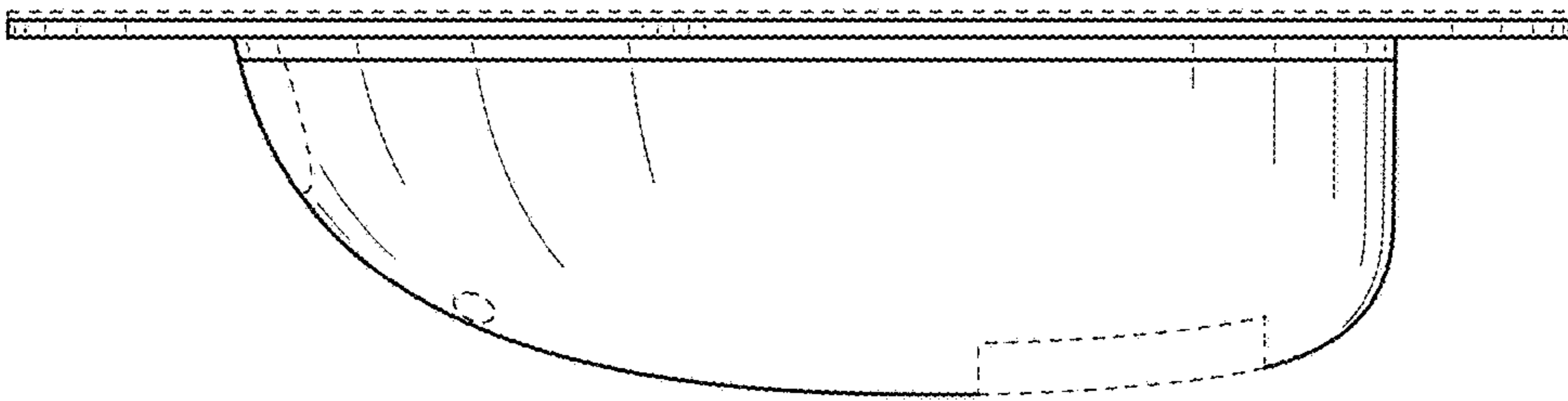

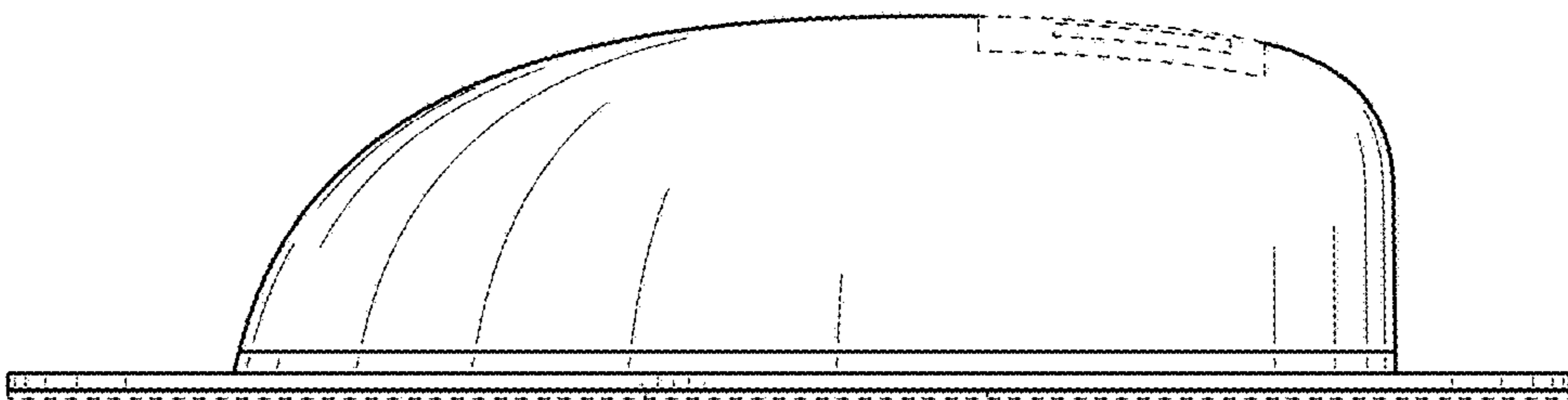
