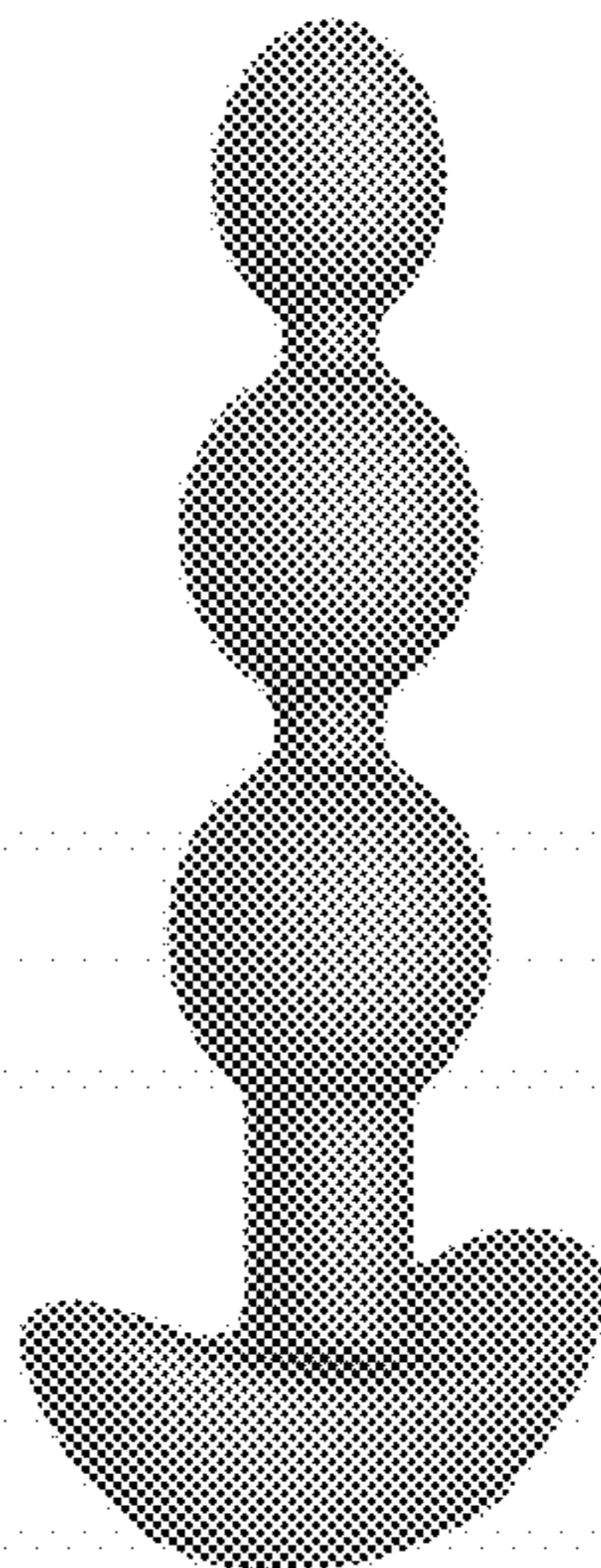
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a vibrator showing my new design;  
FIG. 2 is a front elevational view of the vibrator of FIG. 1, with the back elevational view being a mirror image thereof;  
FIG. 3 is a right side view of the vibrator of FIG. 1; with the left side being a mirror image thereof;

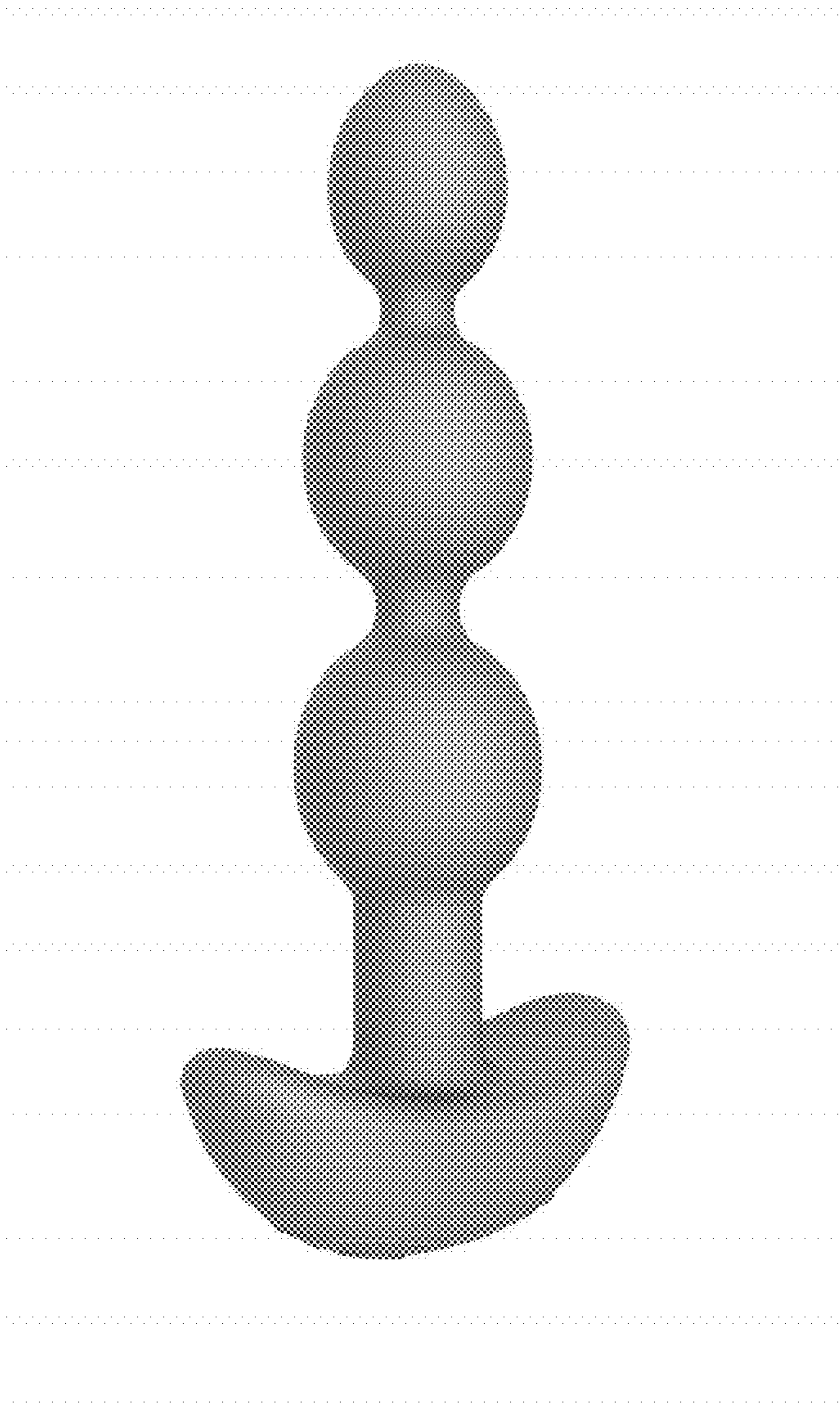

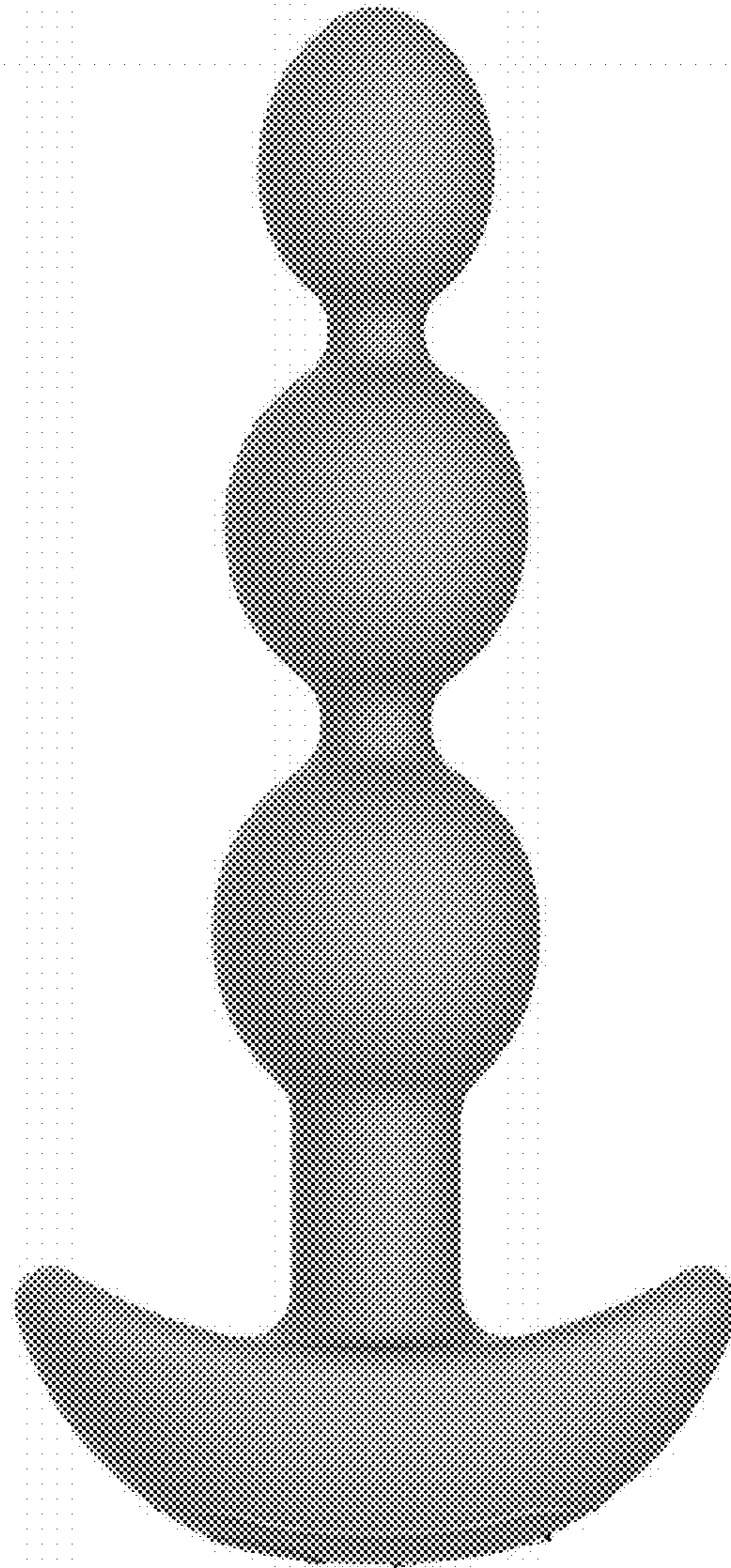

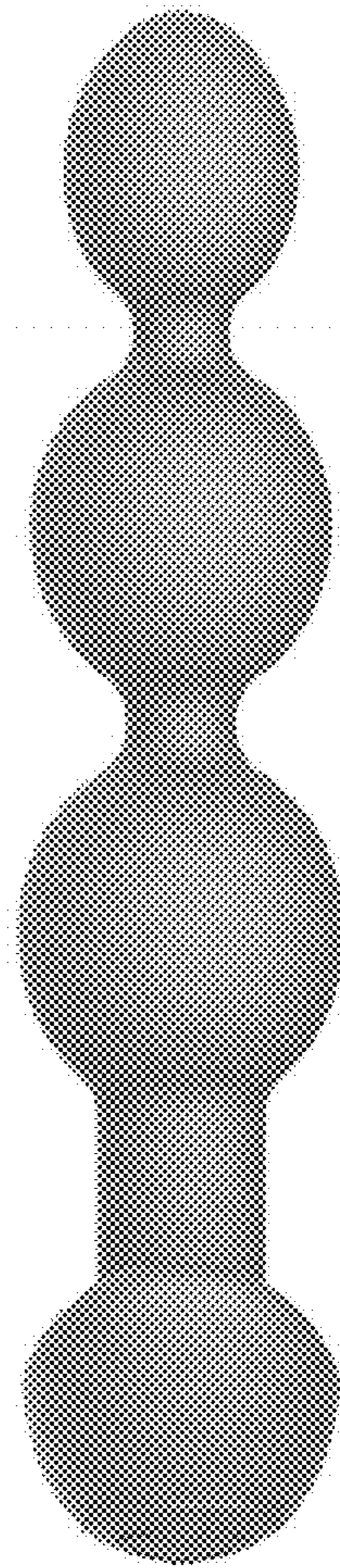

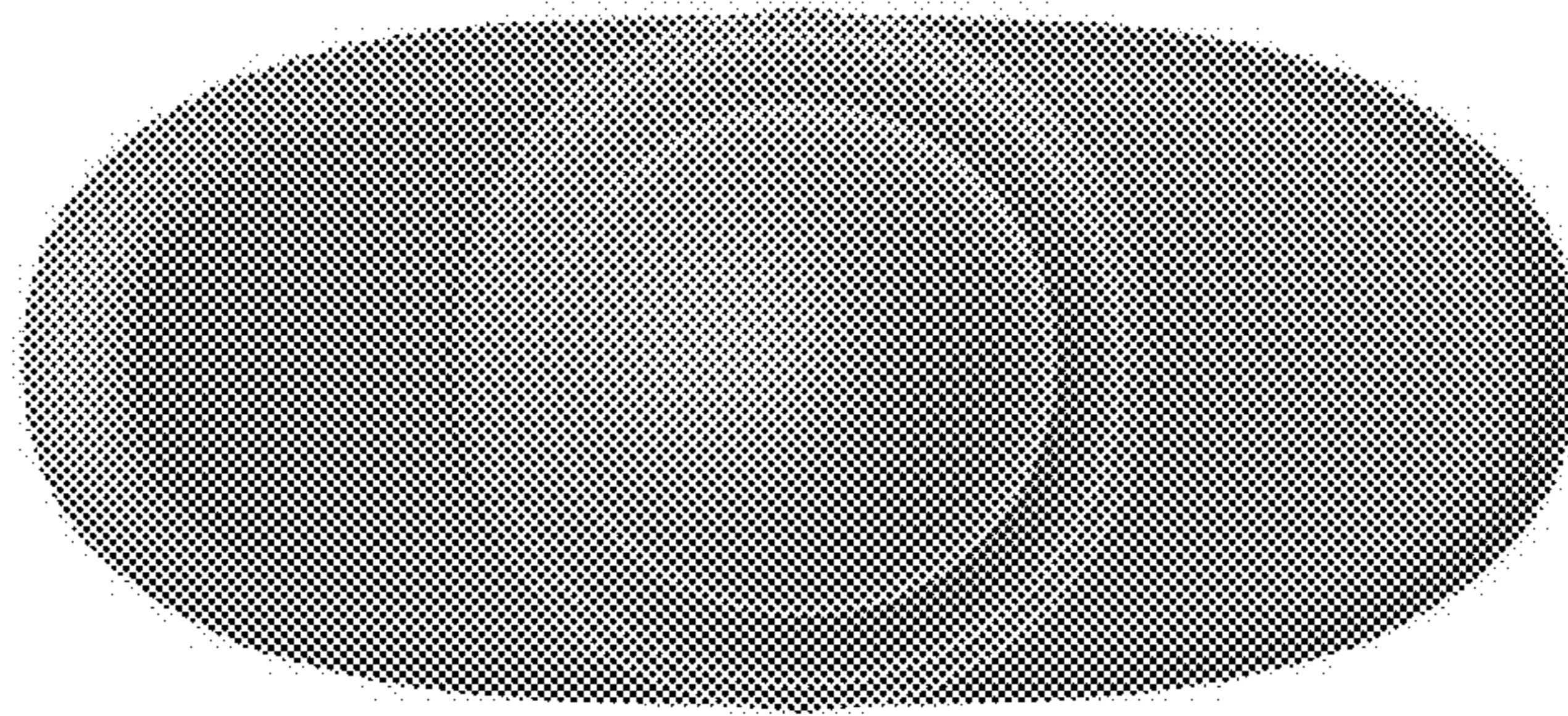

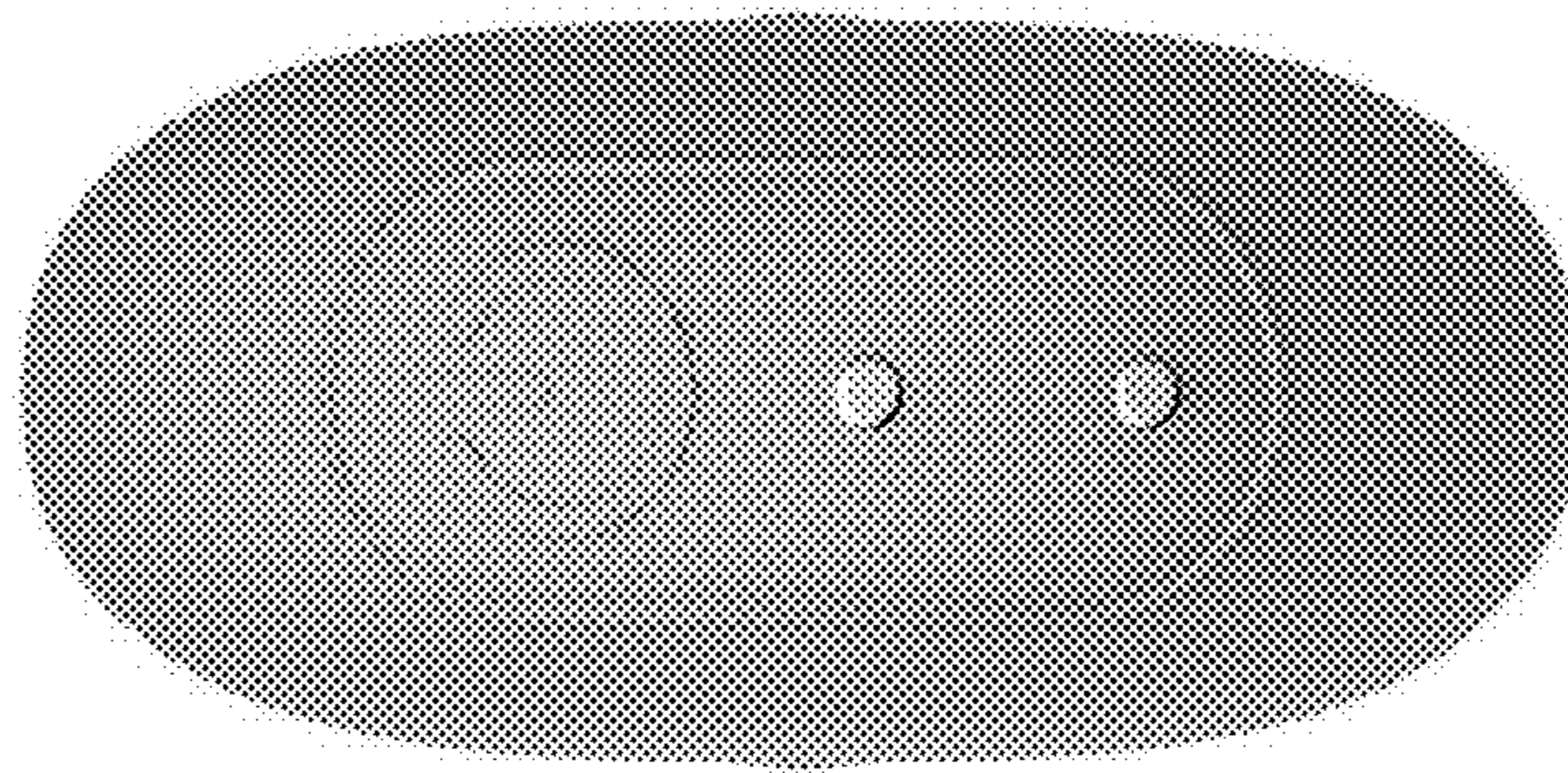
