The ornamental design for a razor cover, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a razor cover;

FIG. 2 is a bottom, front, right side perspective view of a razor cover;

FIG. 3 is a rear, top, left side perspective view of the razor cover;

FIG. 4 is a front elevation view of the razor cover;

FIG. 5 is a rear elevation view of the razor cover;

FIG. 6 is a left side plan view of the razor cover;

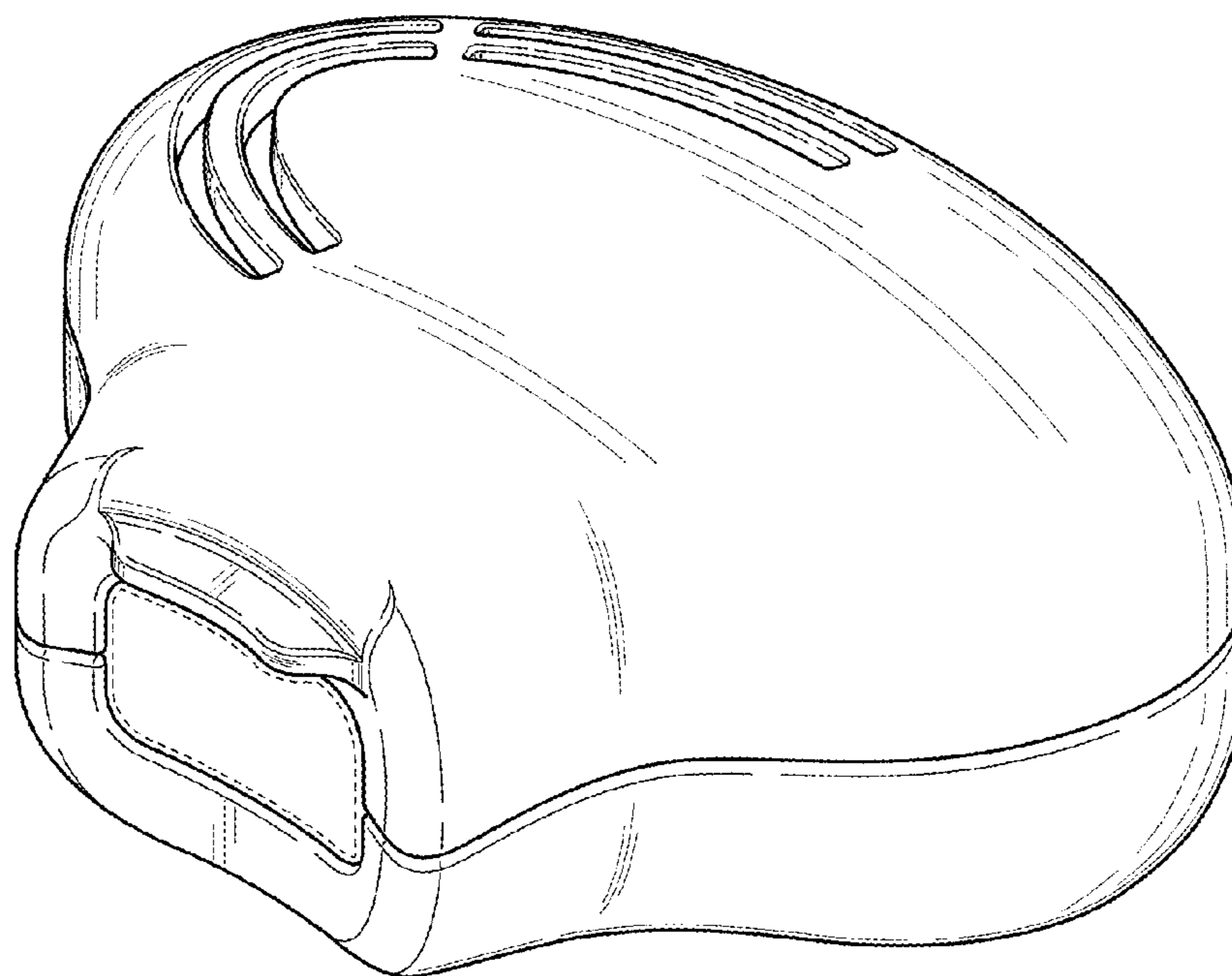
FIG. 7 is a right side plan view of the razor cover;

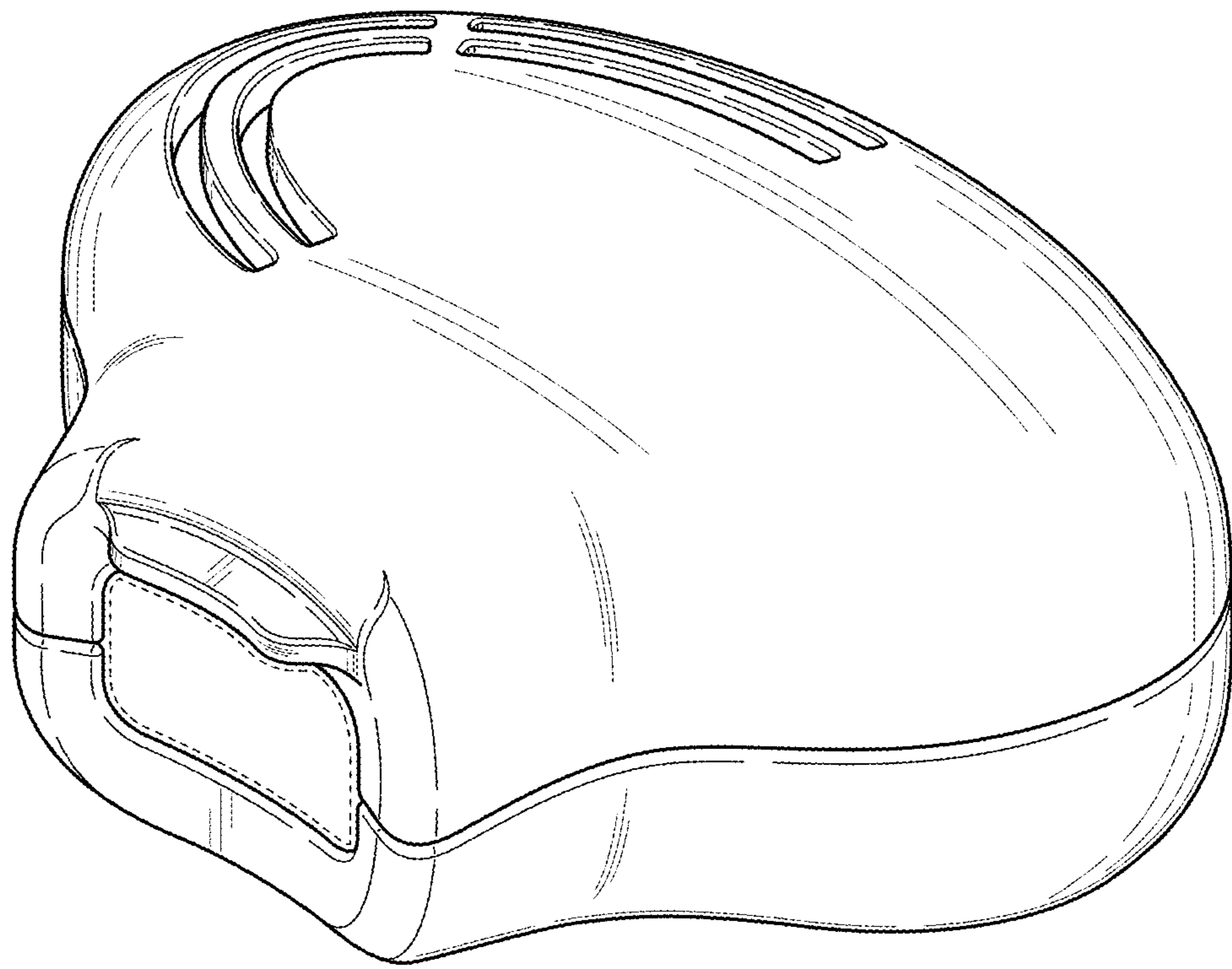

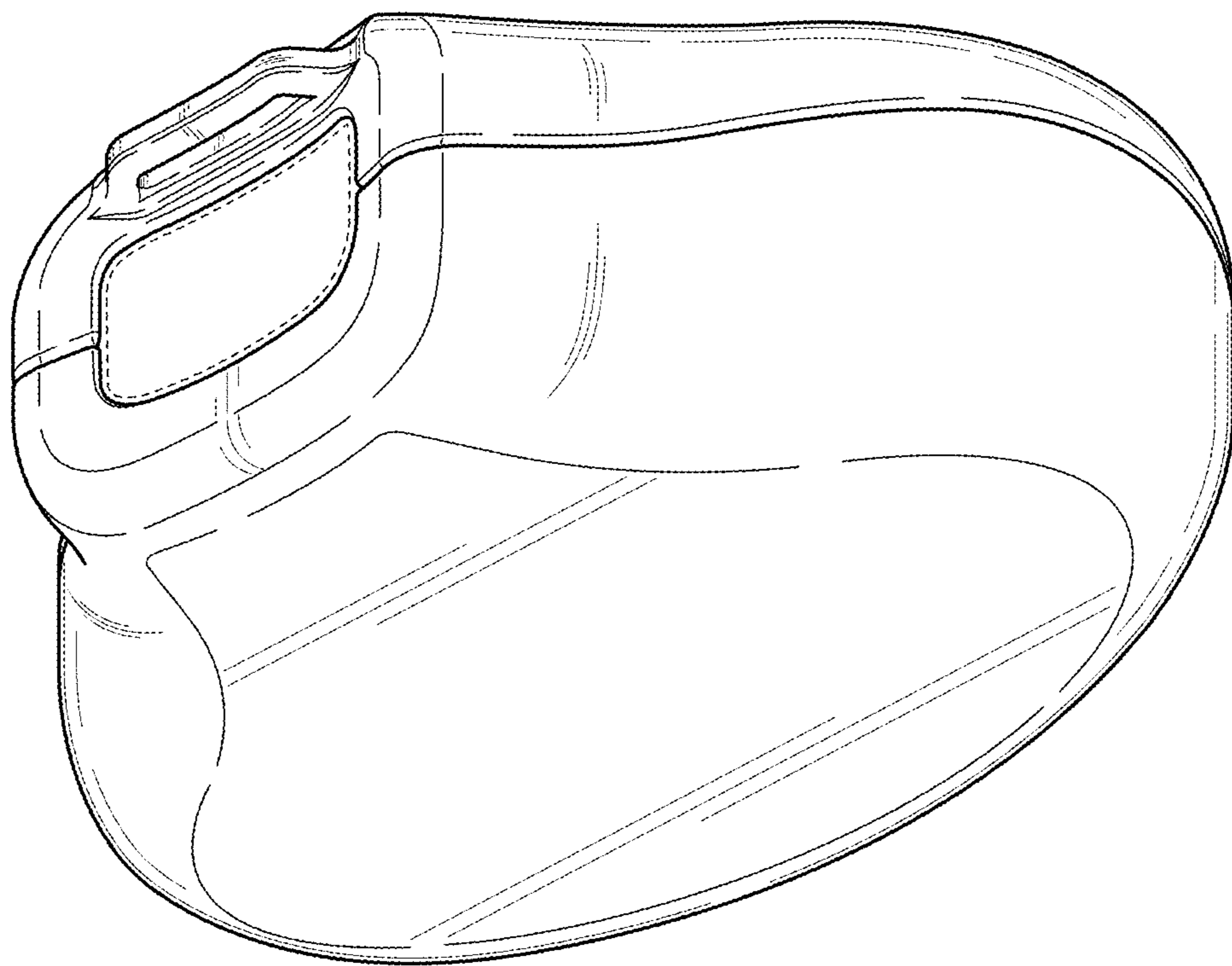

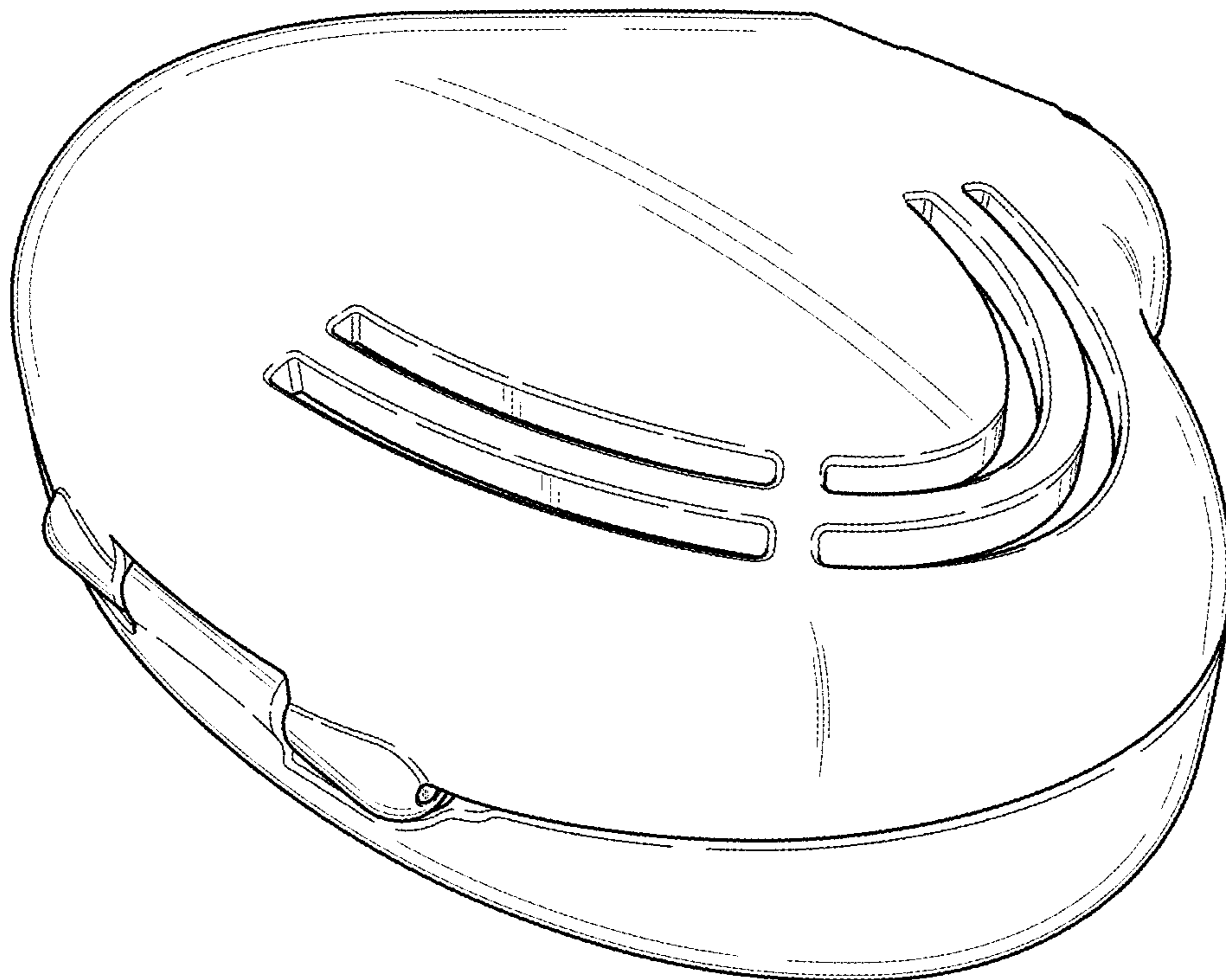

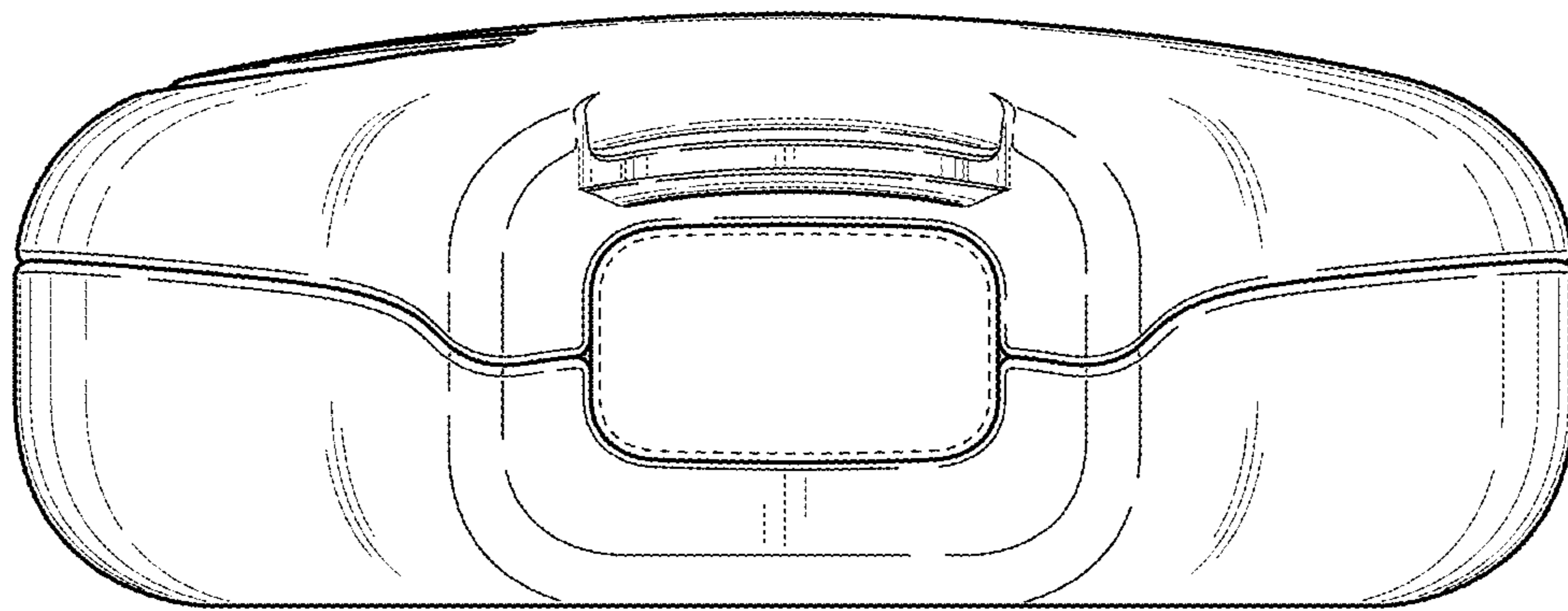

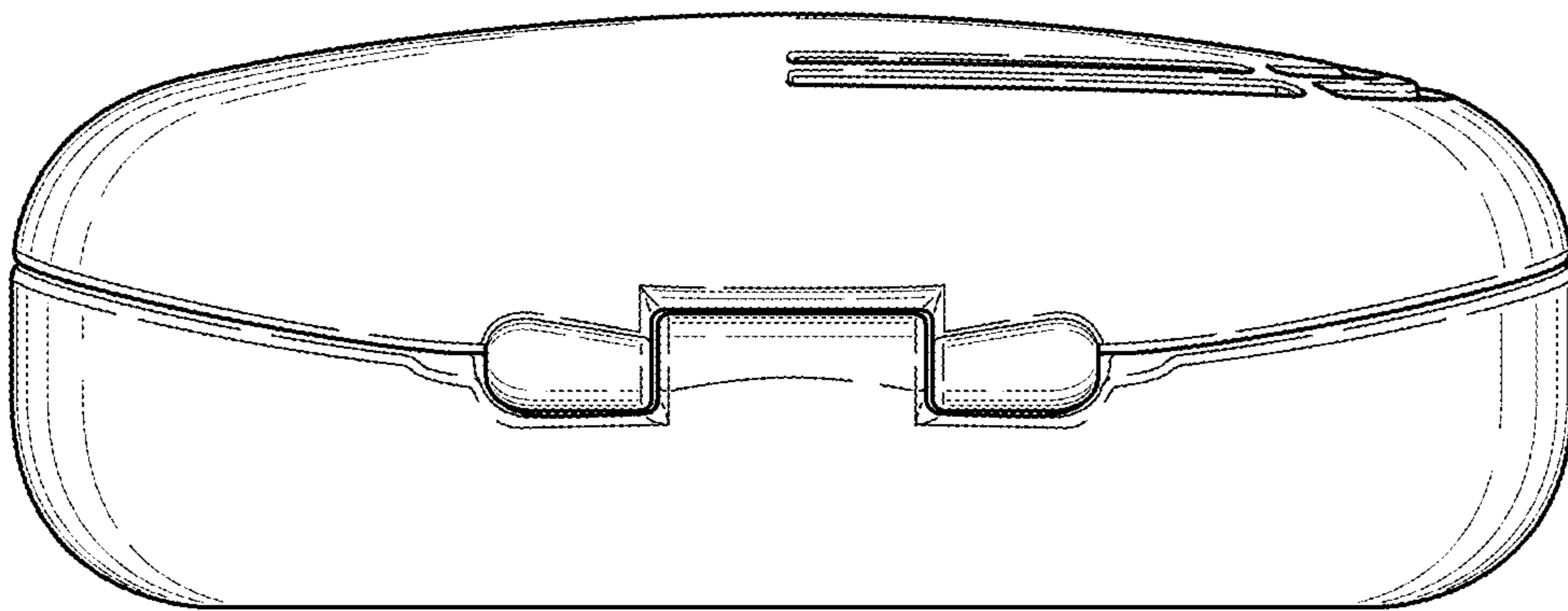

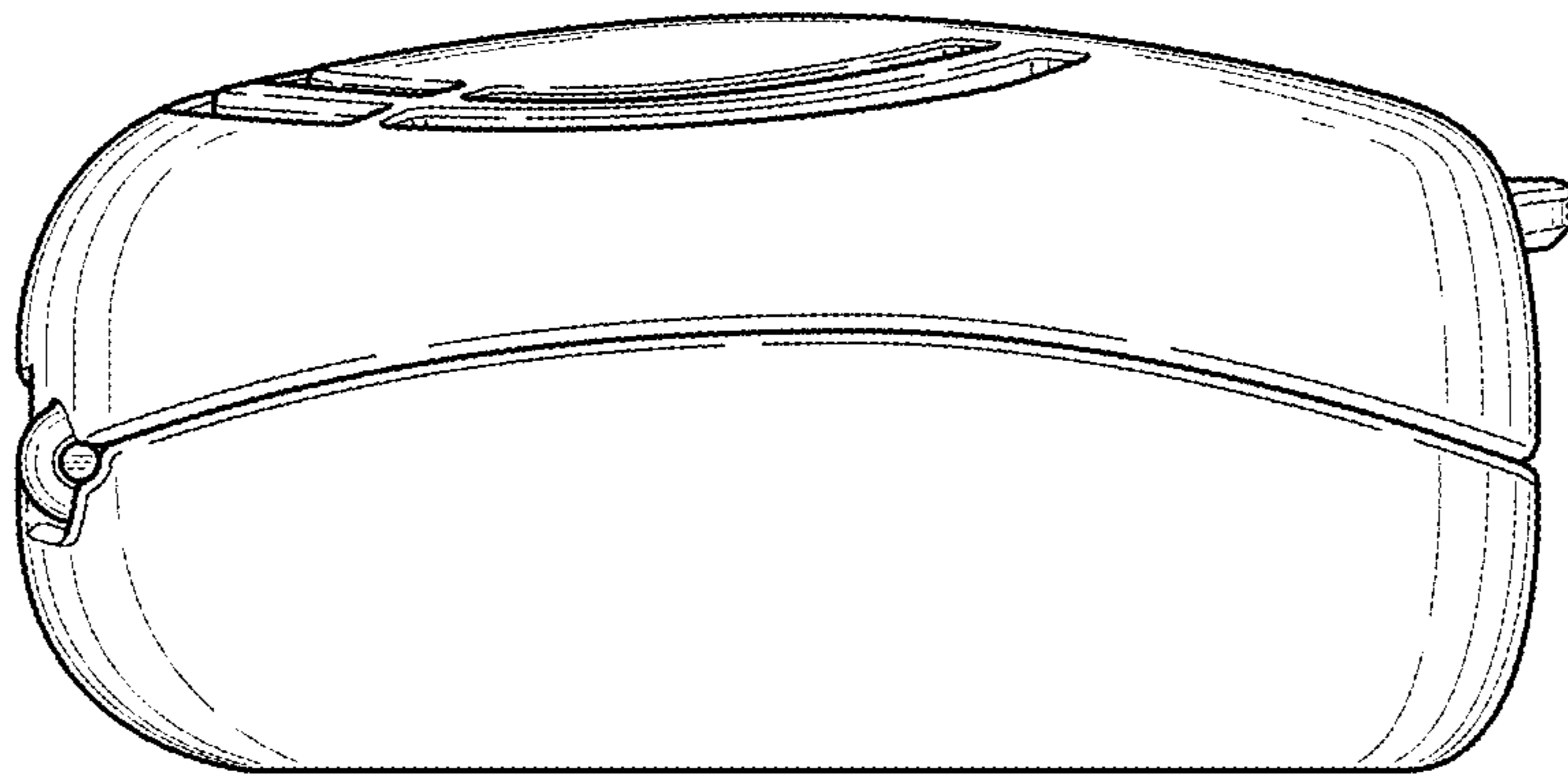

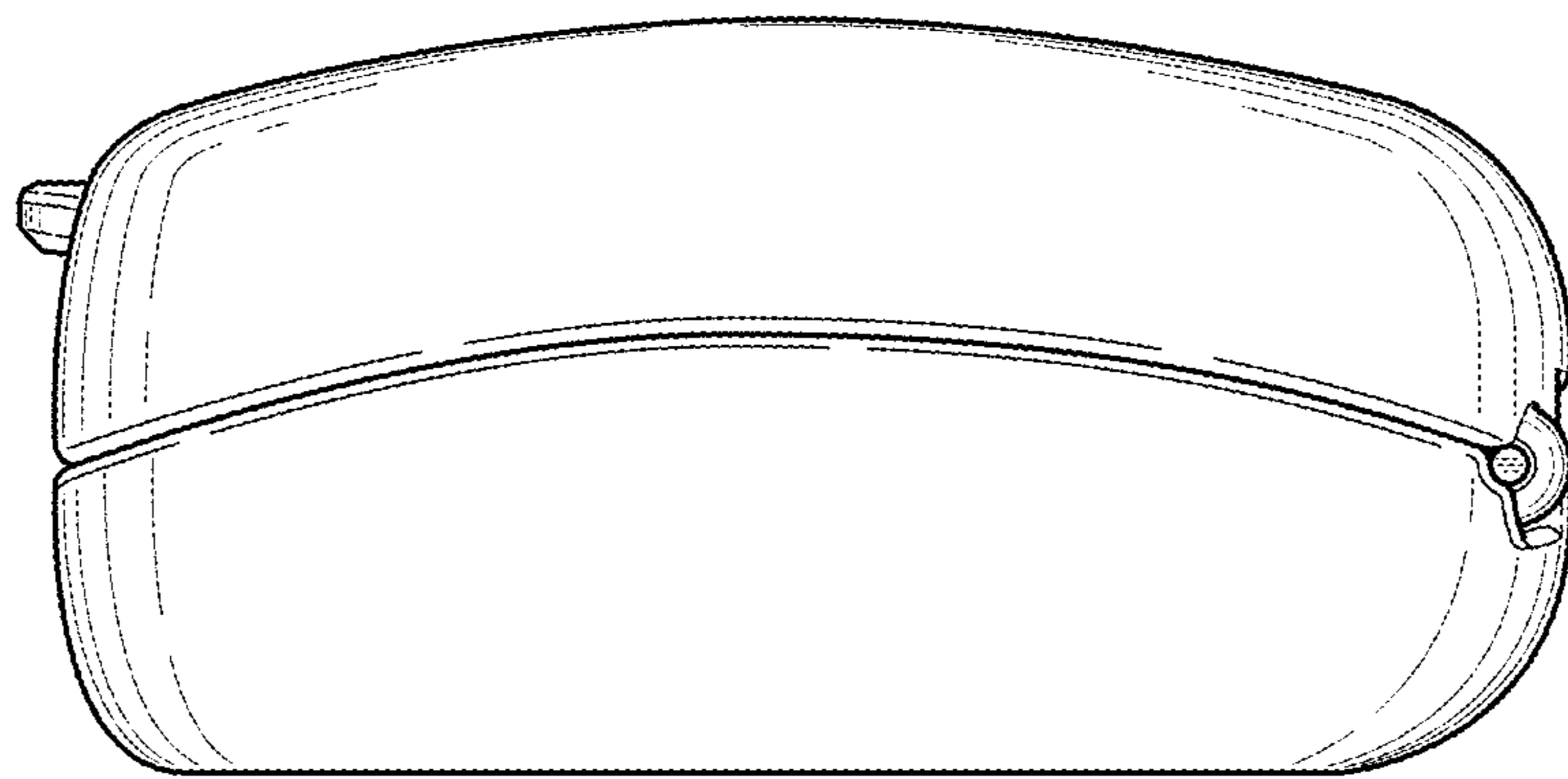

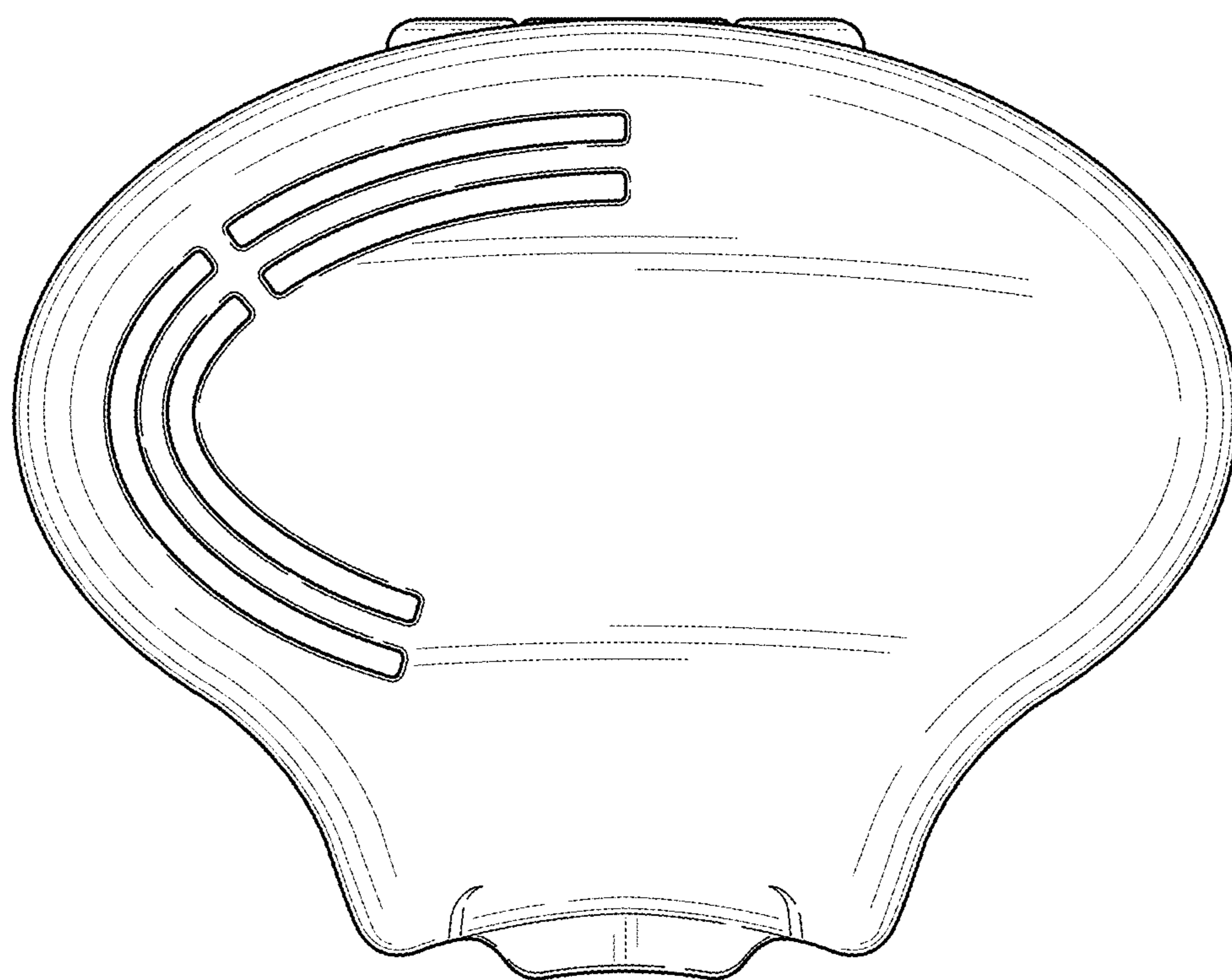

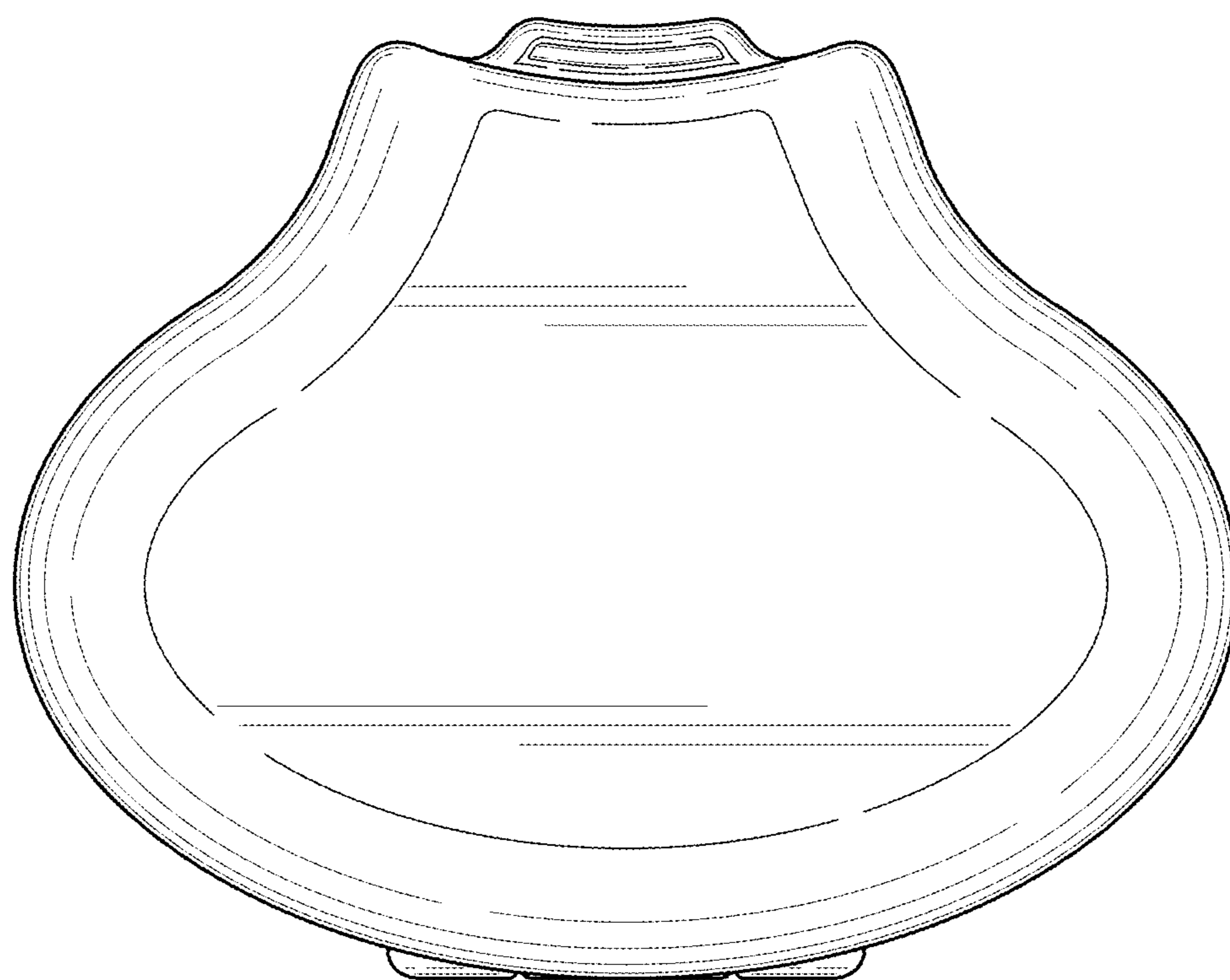
