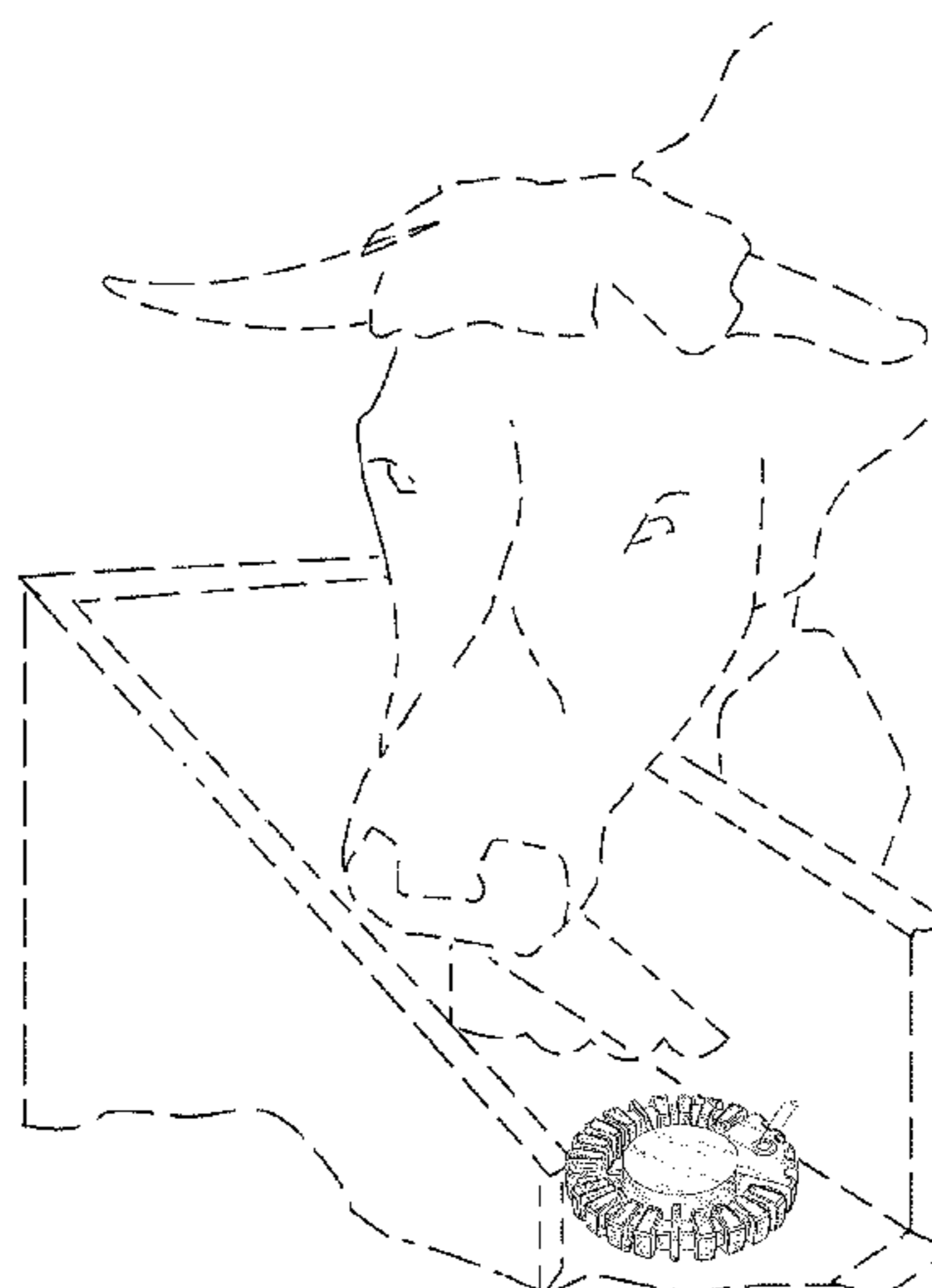
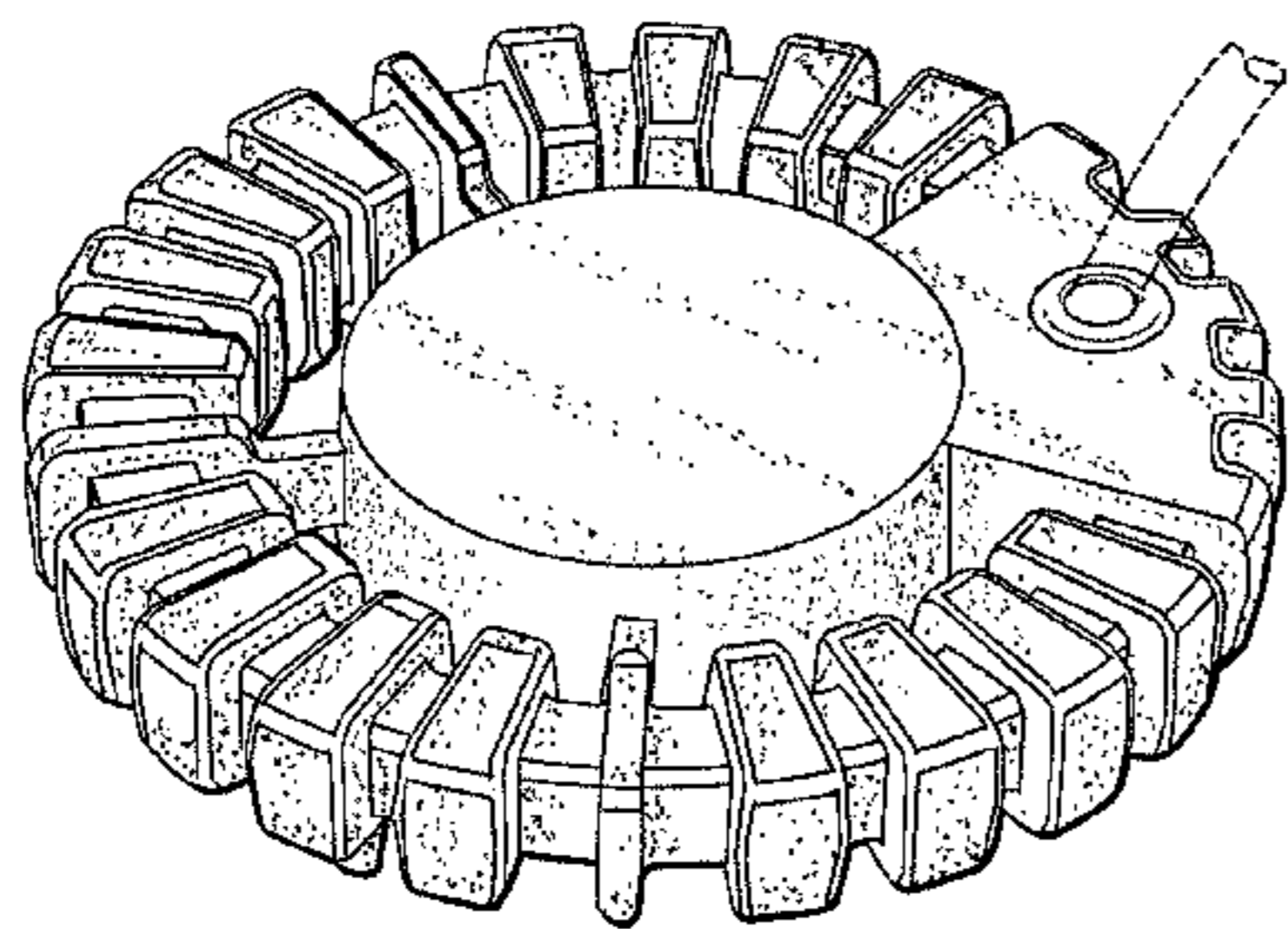
The ornamental design for a livestock water trough heater,

livestock water trough heater;
FIG. 2 is a top plan view thereof;

FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a front elevational view thereof;
FIG. 7 is a rear elevational view thereof; and,

water trough heater, shown in use.

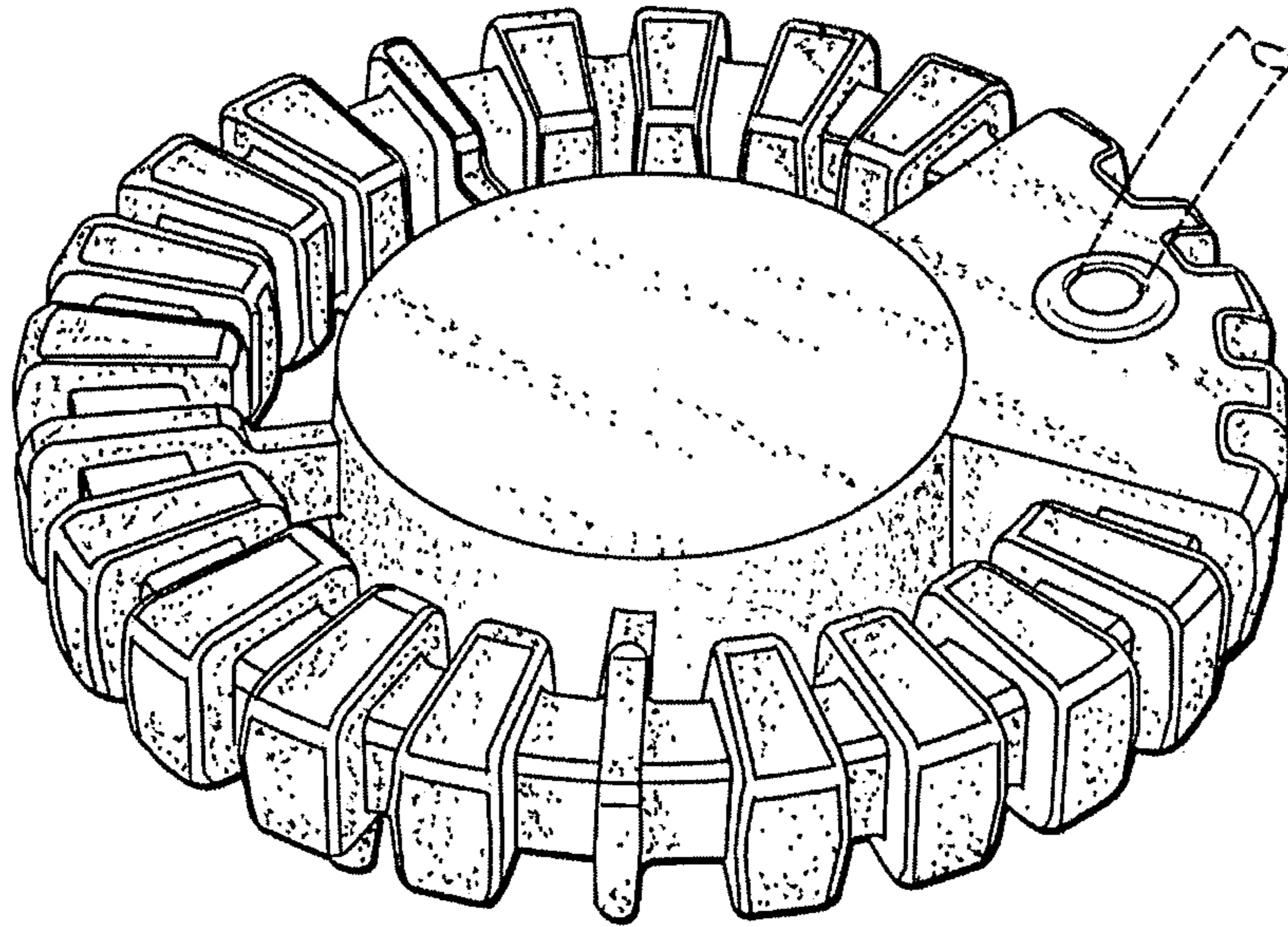

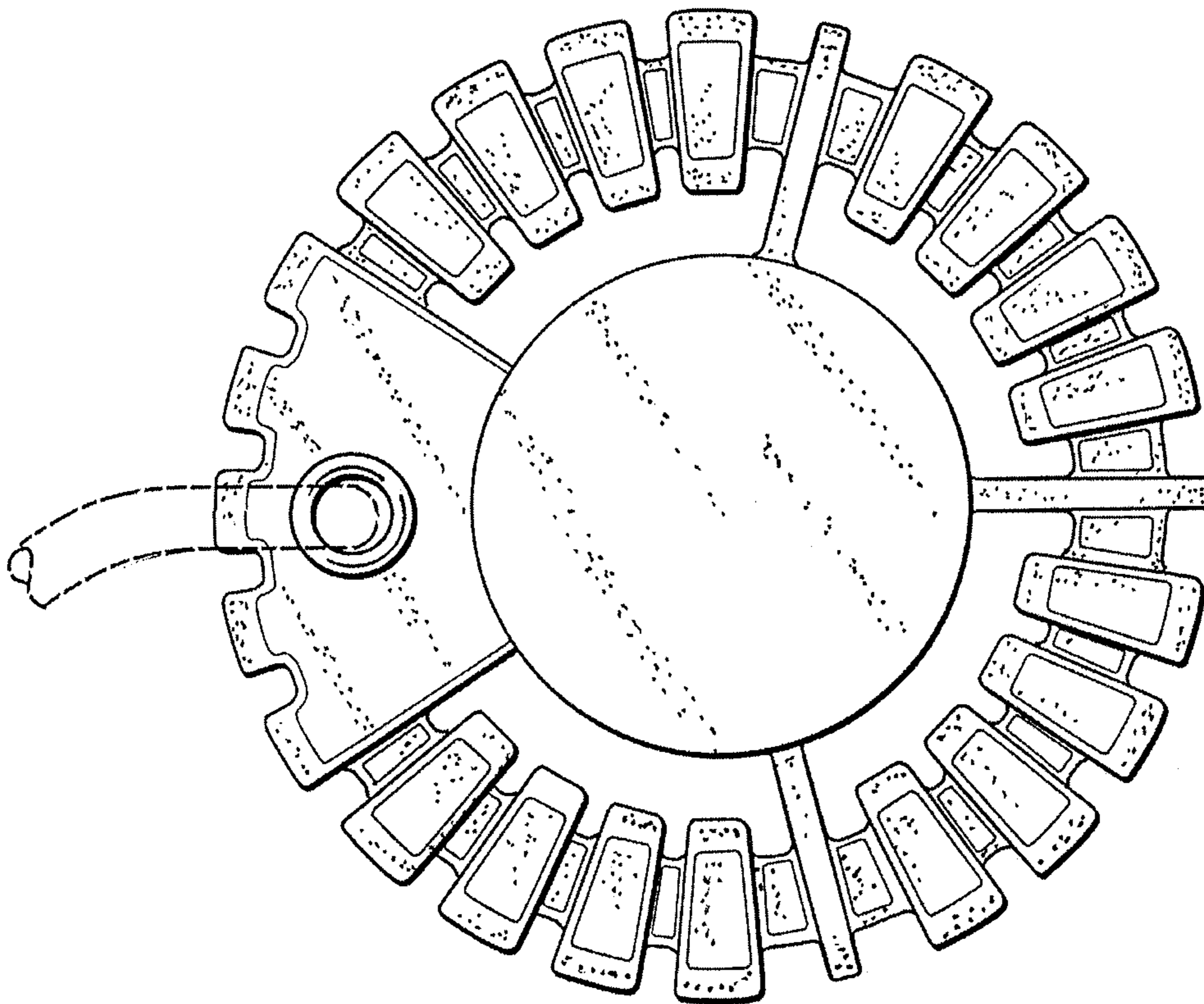

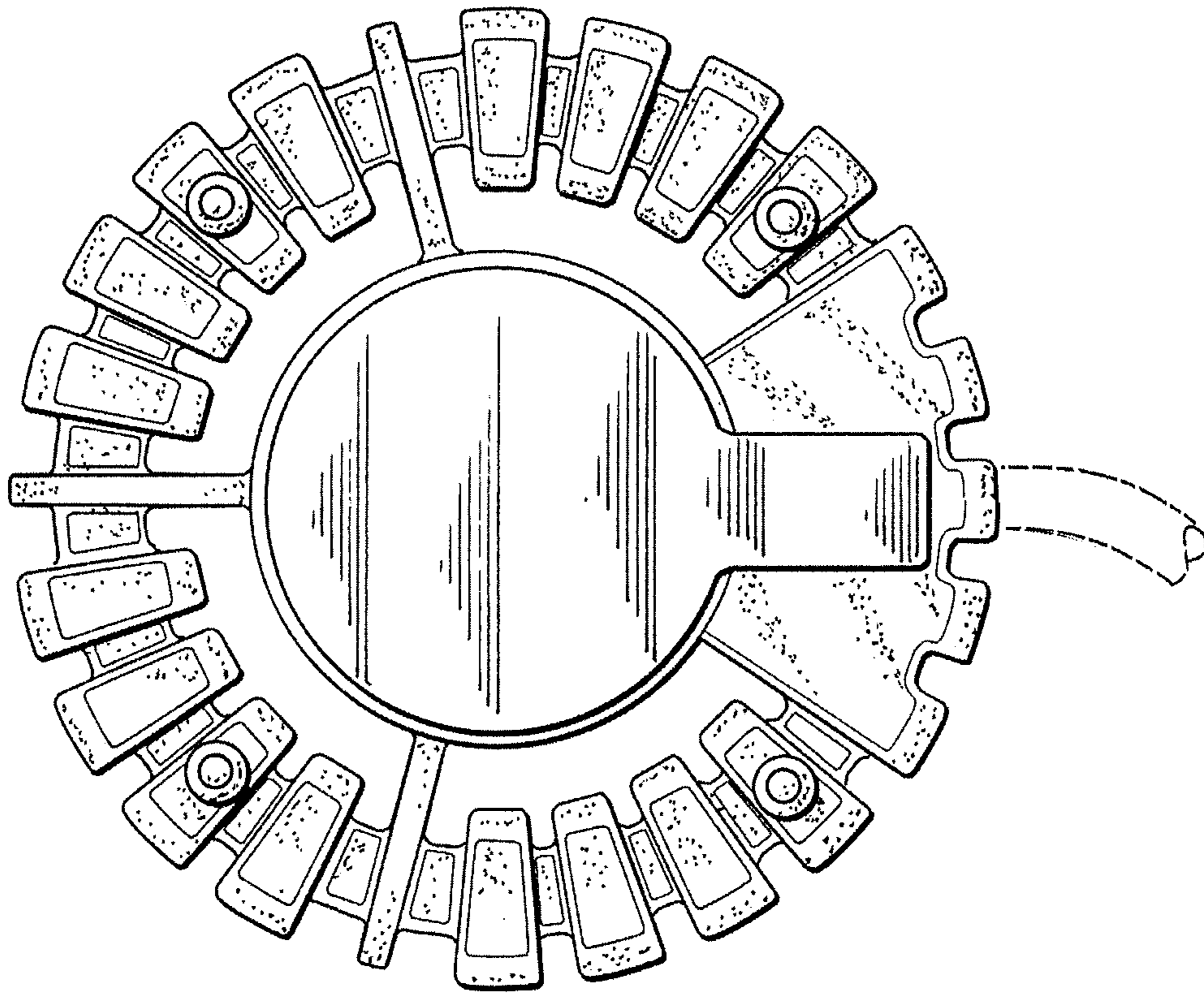

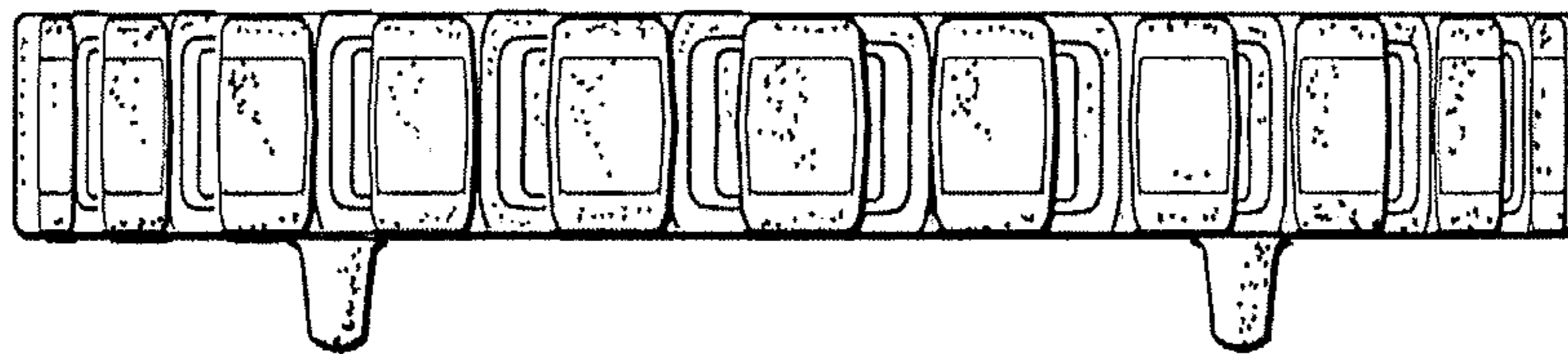

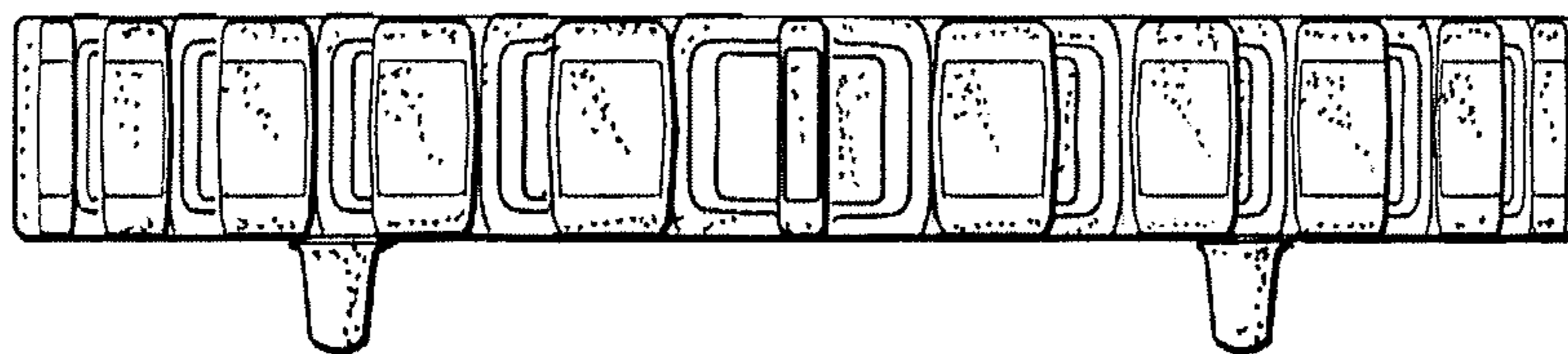

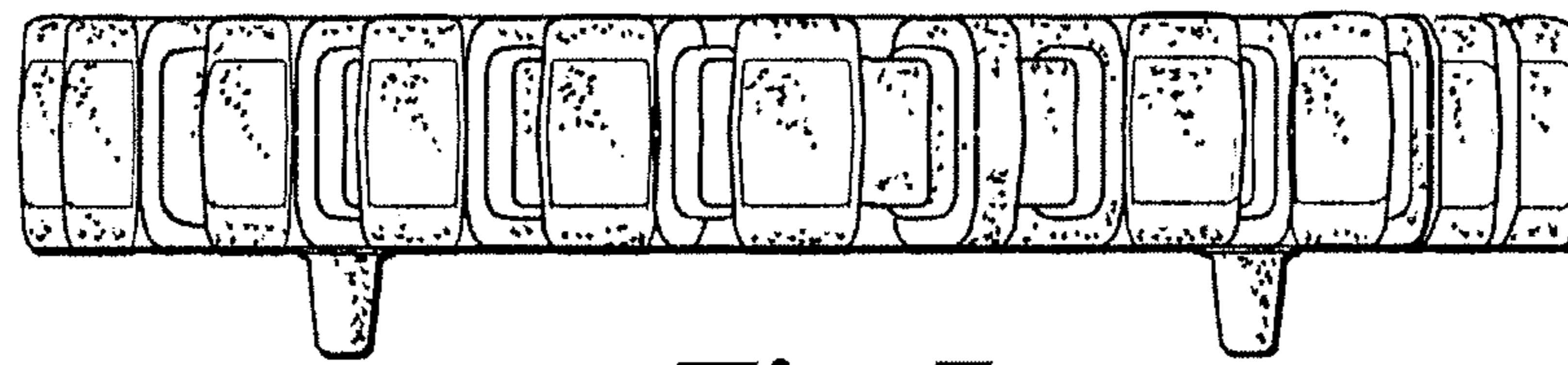

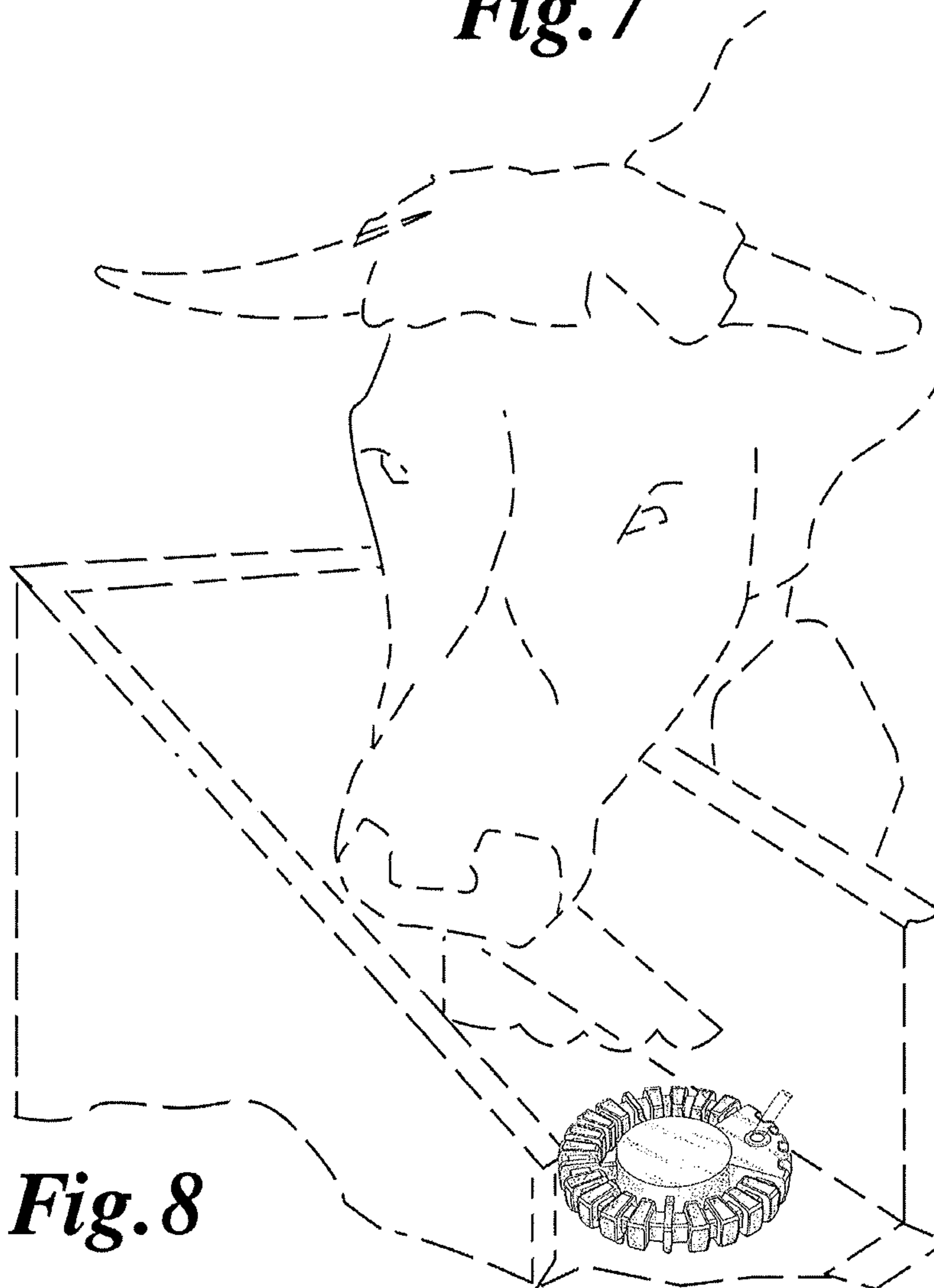
