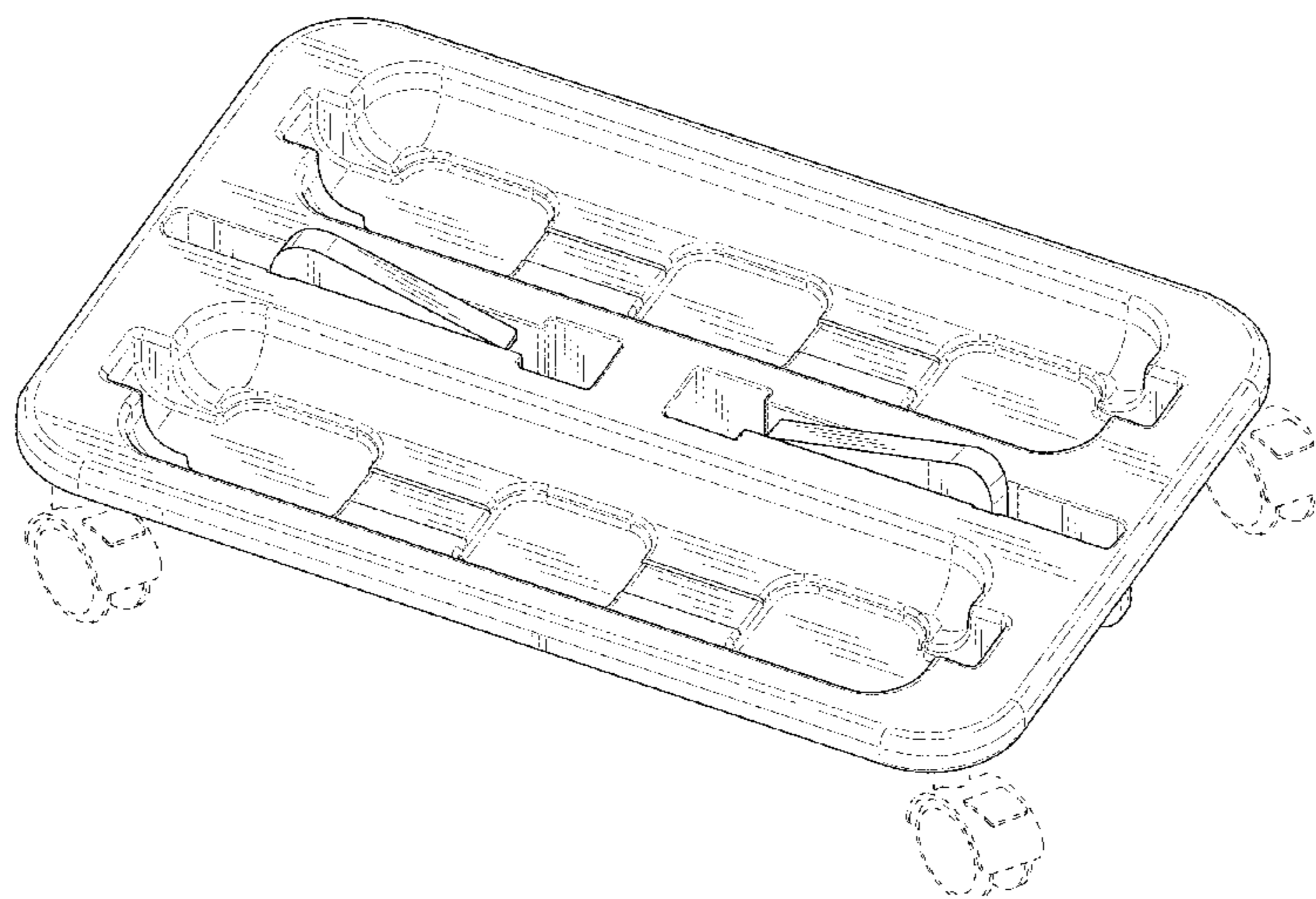
(57) **CLAIM**

The ornamental design for a customizable caddy platform, as shown and described.

**DESCRIPTION**

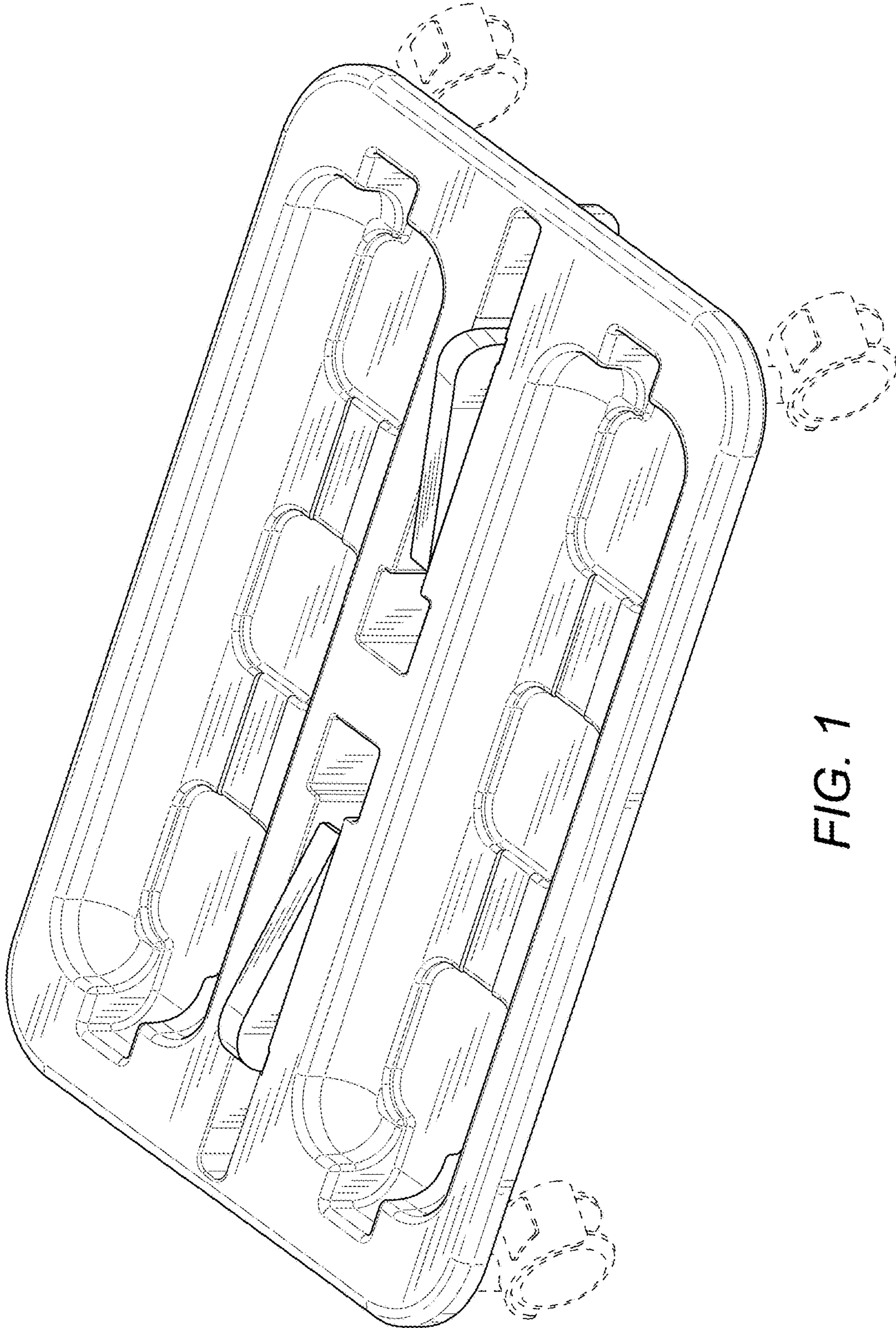

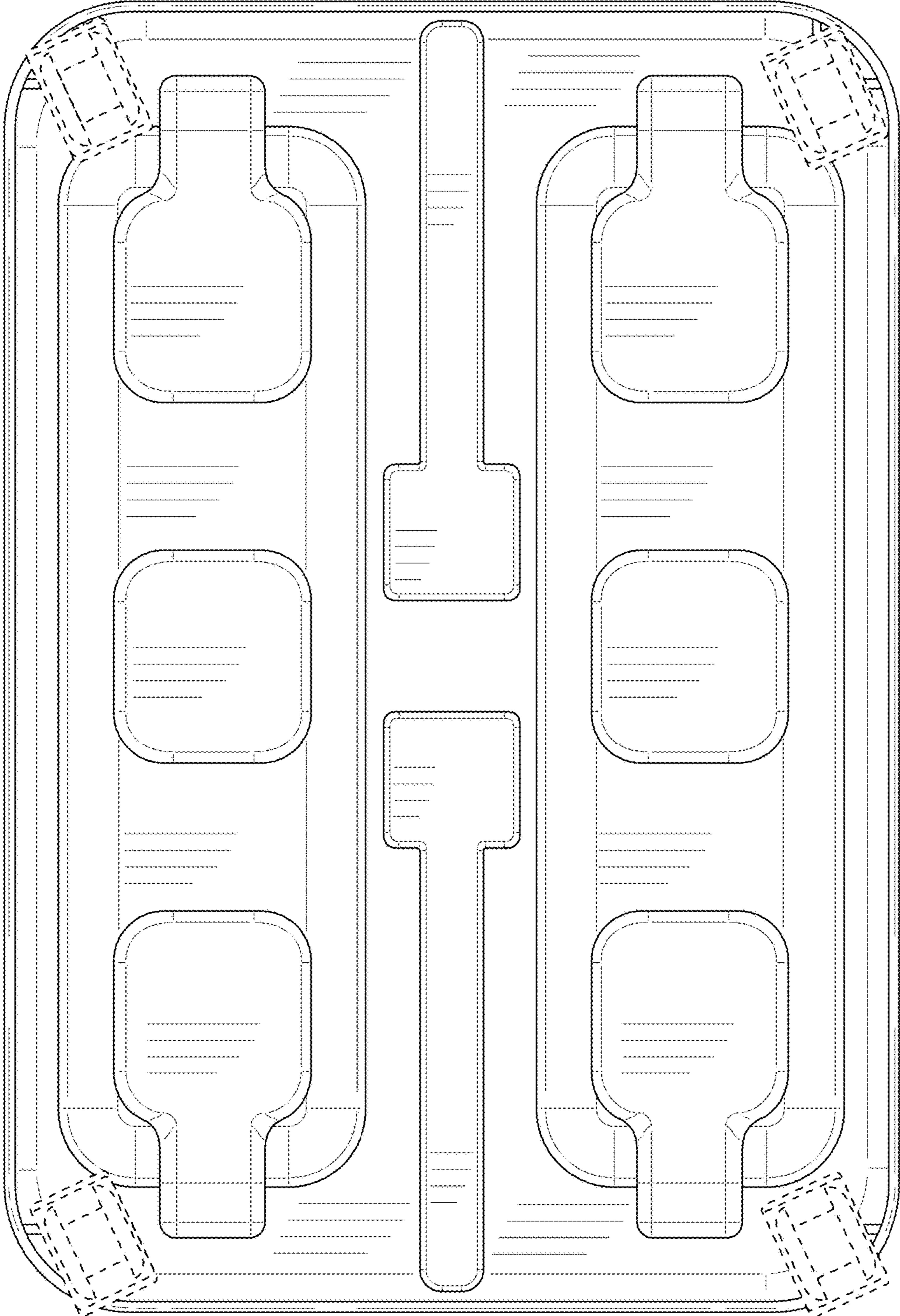

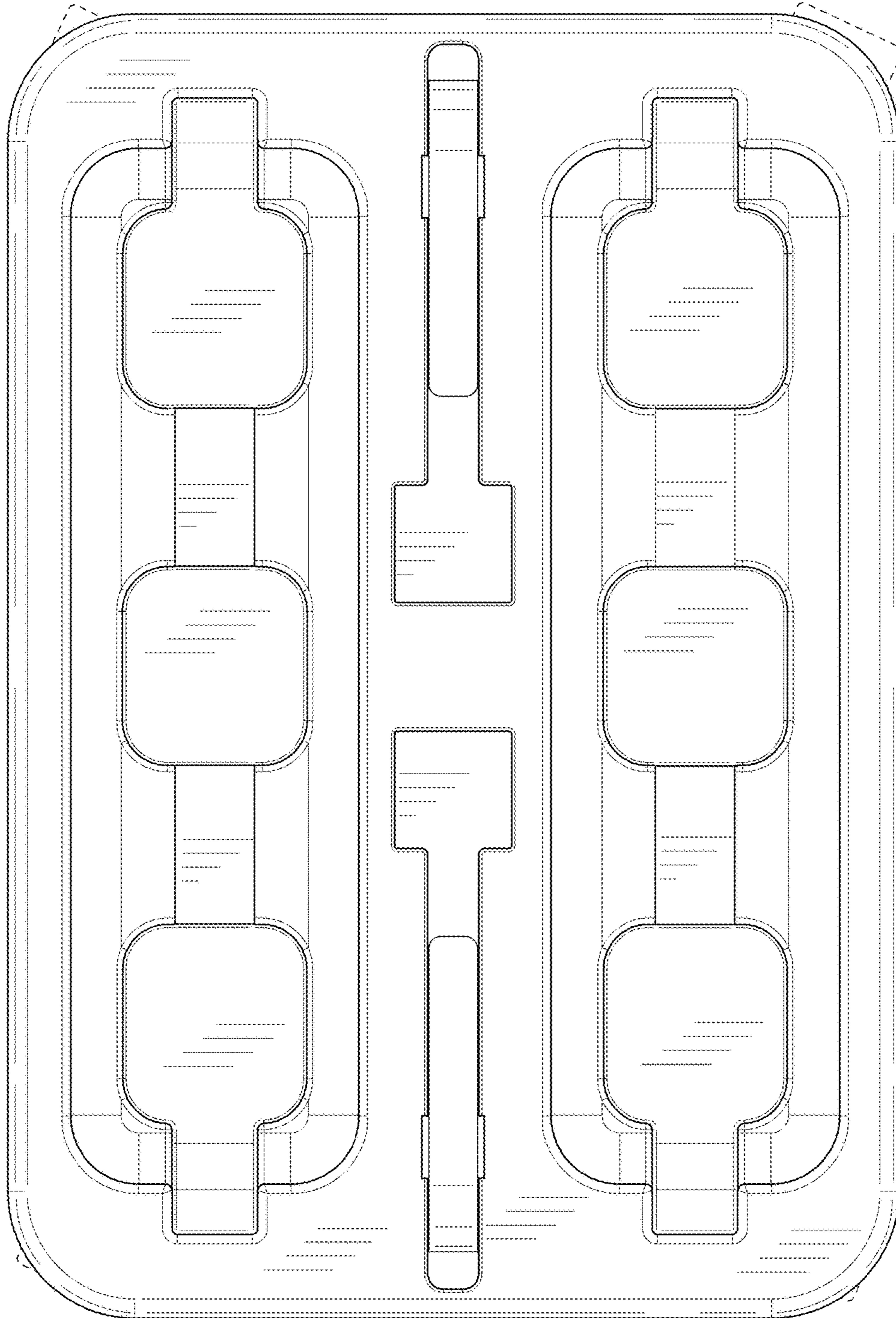
