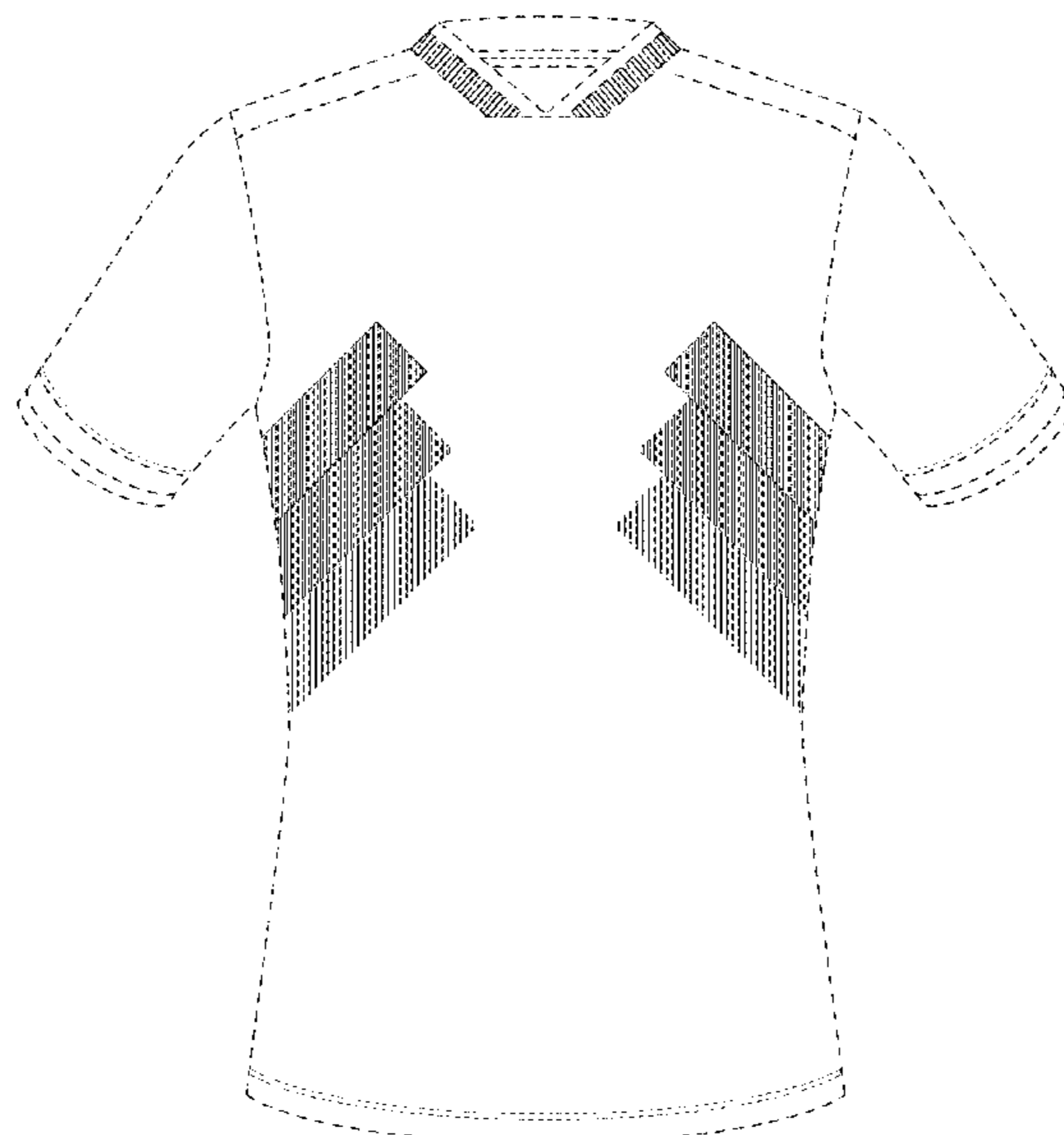
(57) **CLAIM**

The ornamental design for a jersey, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an embodiment of a jersey; and, FIG. 2 is a rear view of the jersey of FIG. 1. The broken lines with more closely spaced and smaller dashes located near the lower ends of the sleeves and the lower edge of the jersey represent stitching and are directed to environment and form no part of the claimed design. The evenly-spaced broken lines show unclaimed subject matter only and form no part of the claimed design.

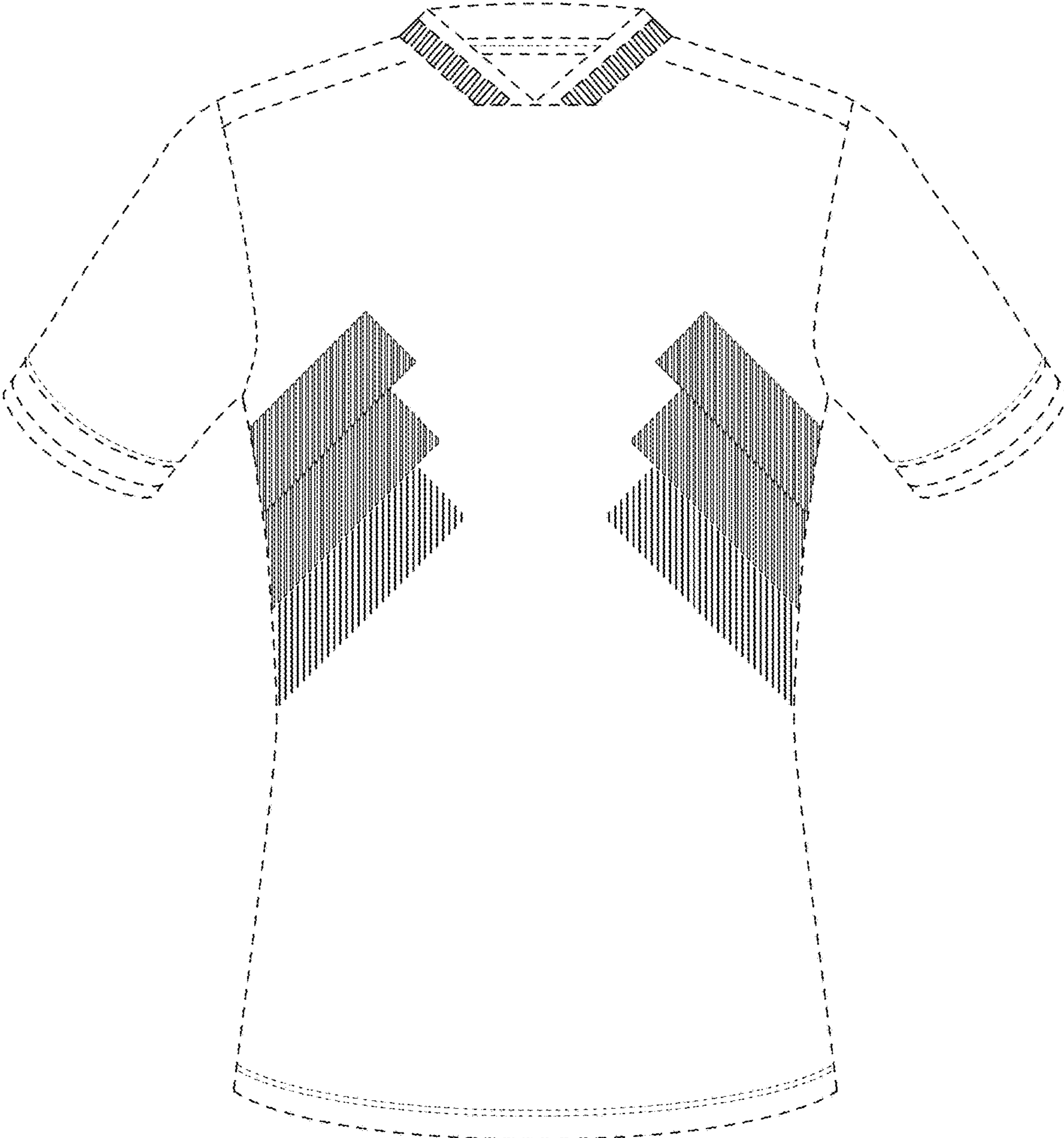

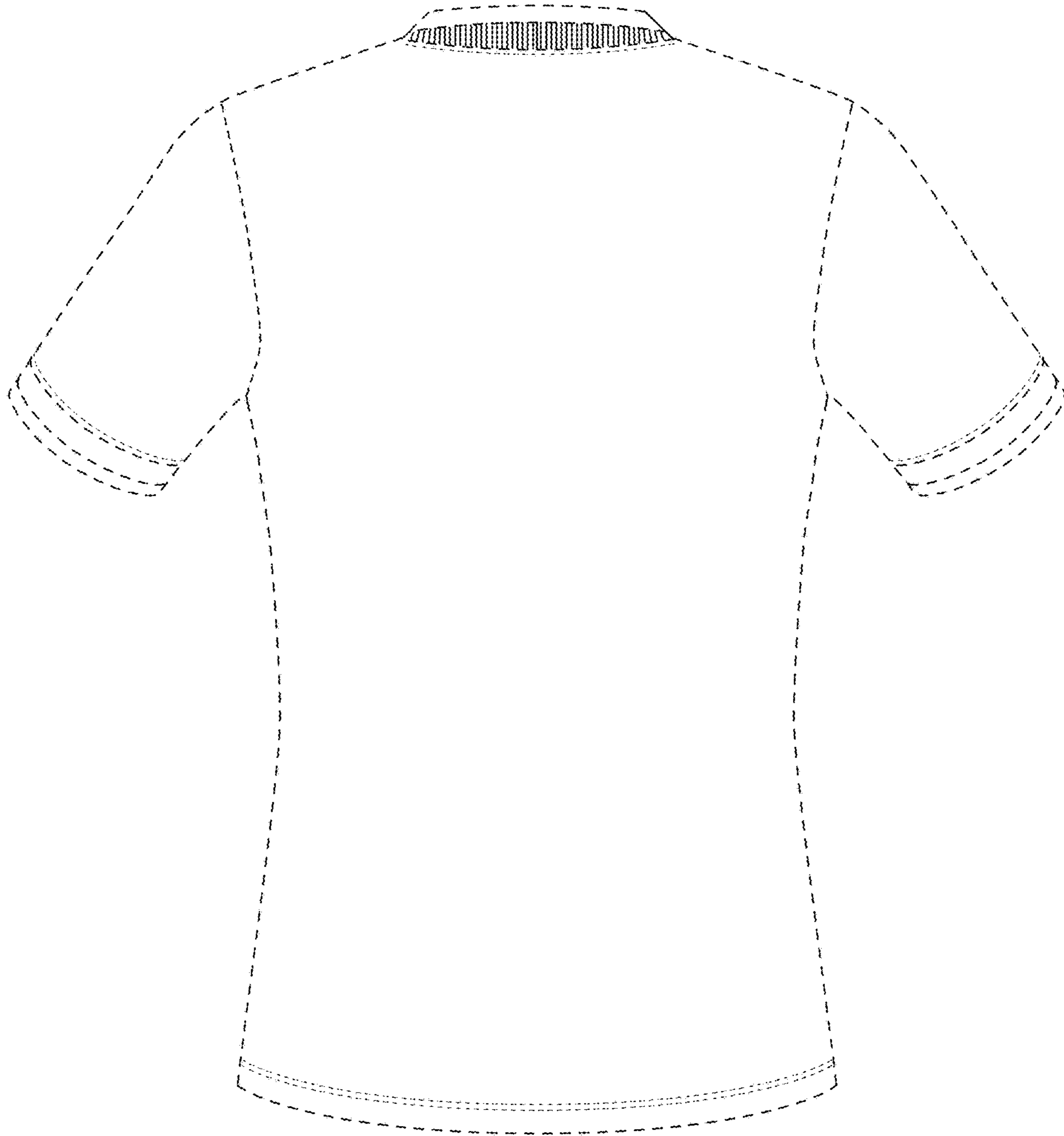
