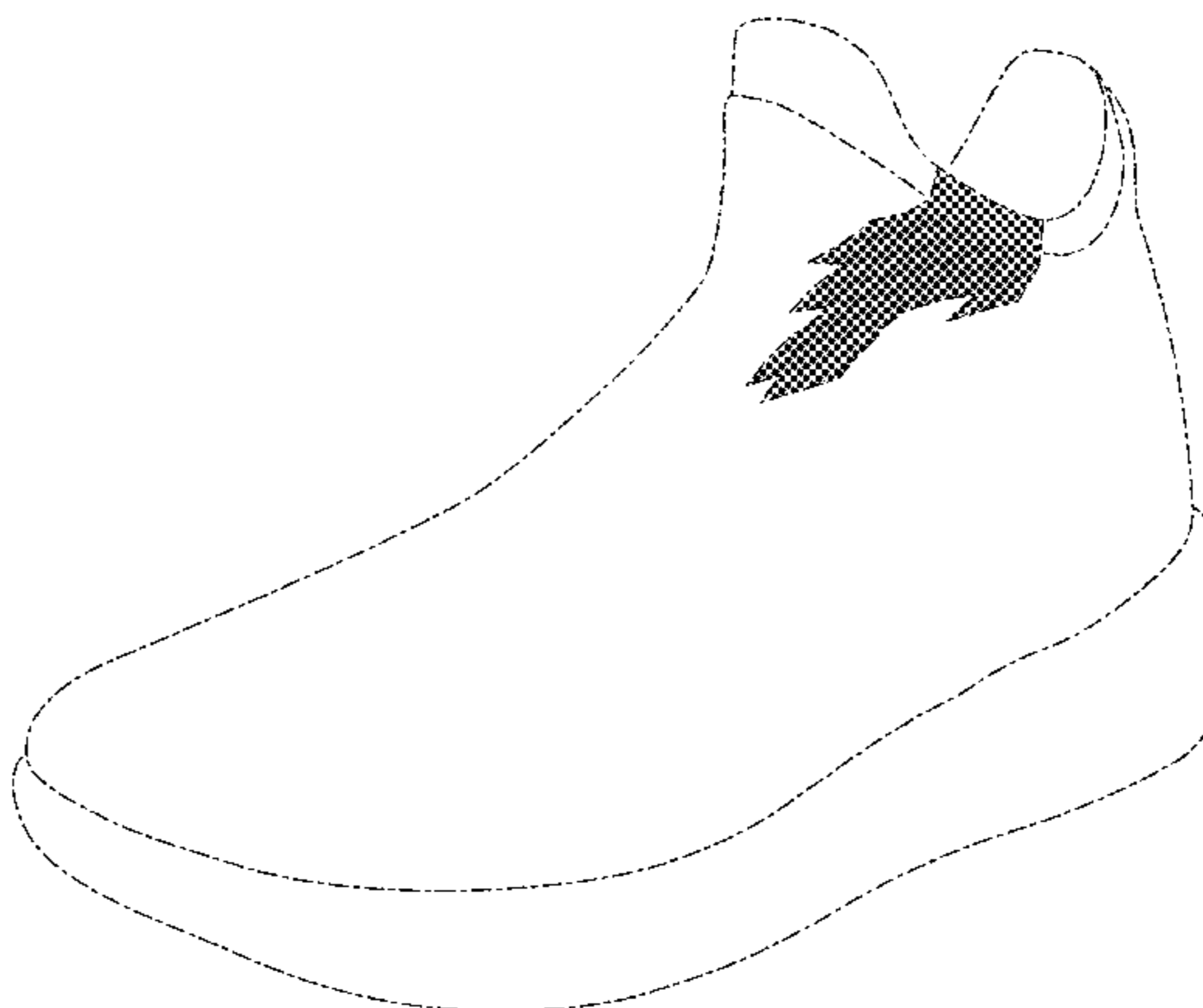
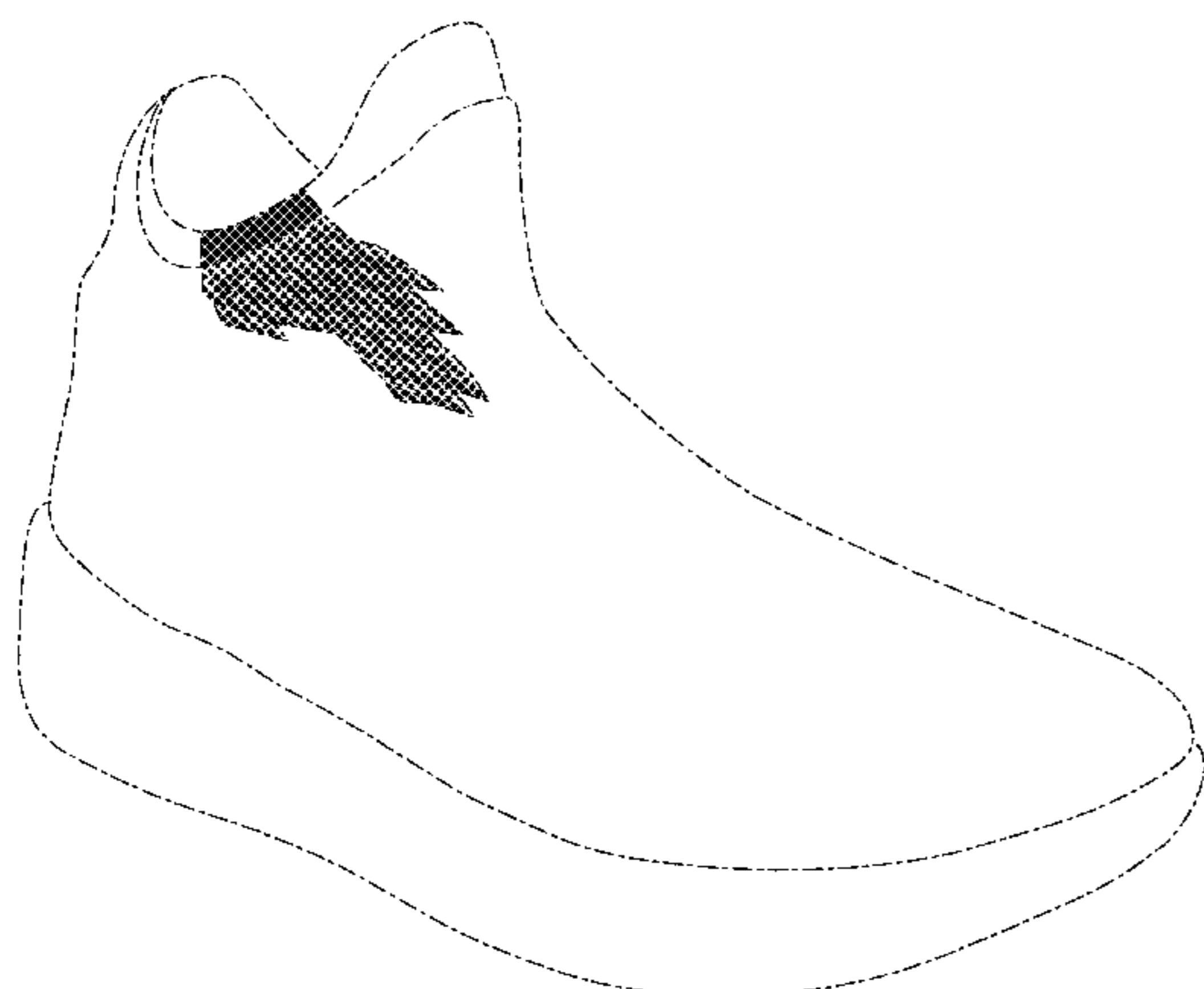
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing
my new design;

portions removed for clarity;

FIG. 7 is a front perspective view of an alternative embodi-
ment of a shoe upper showing my new design;

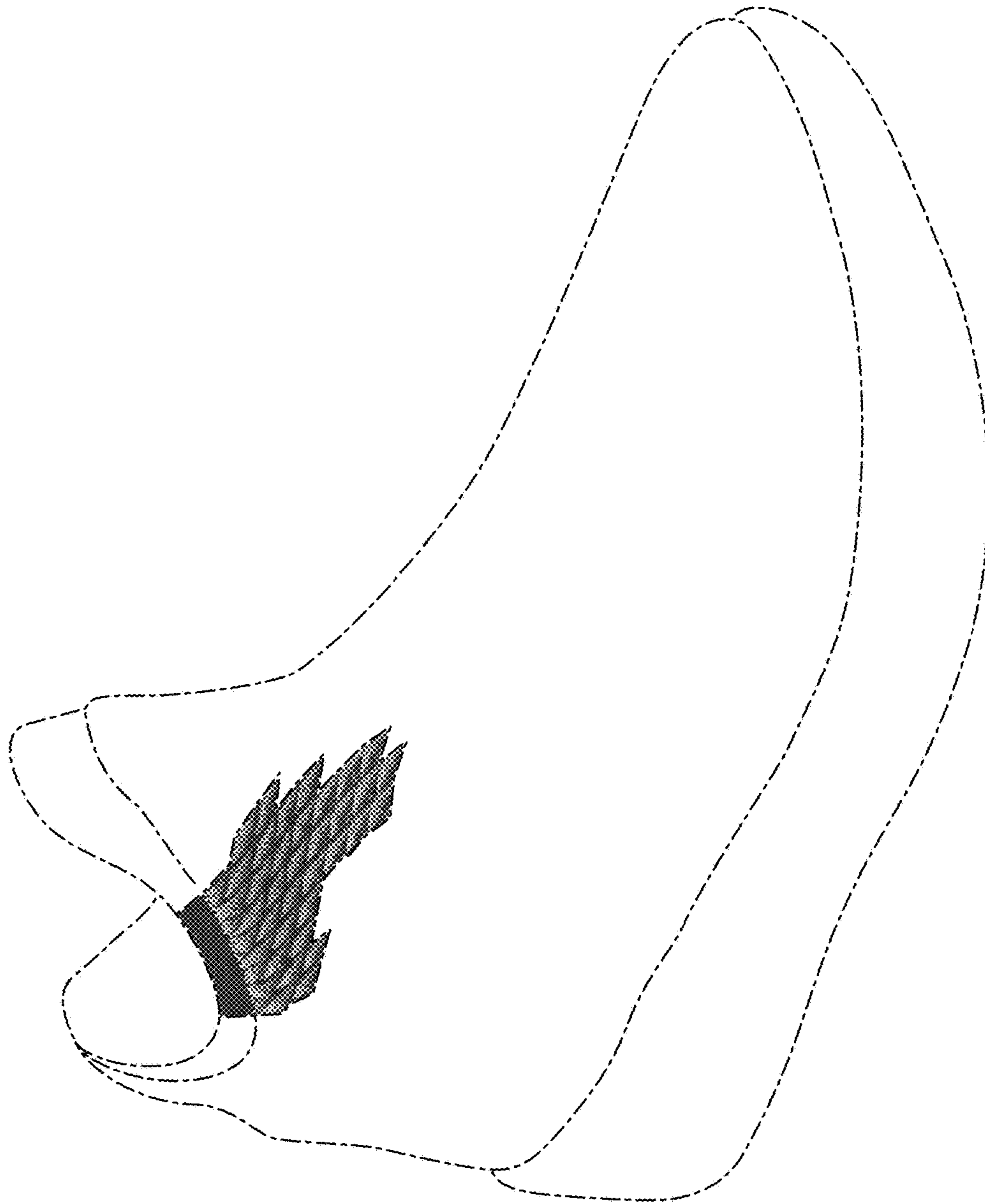

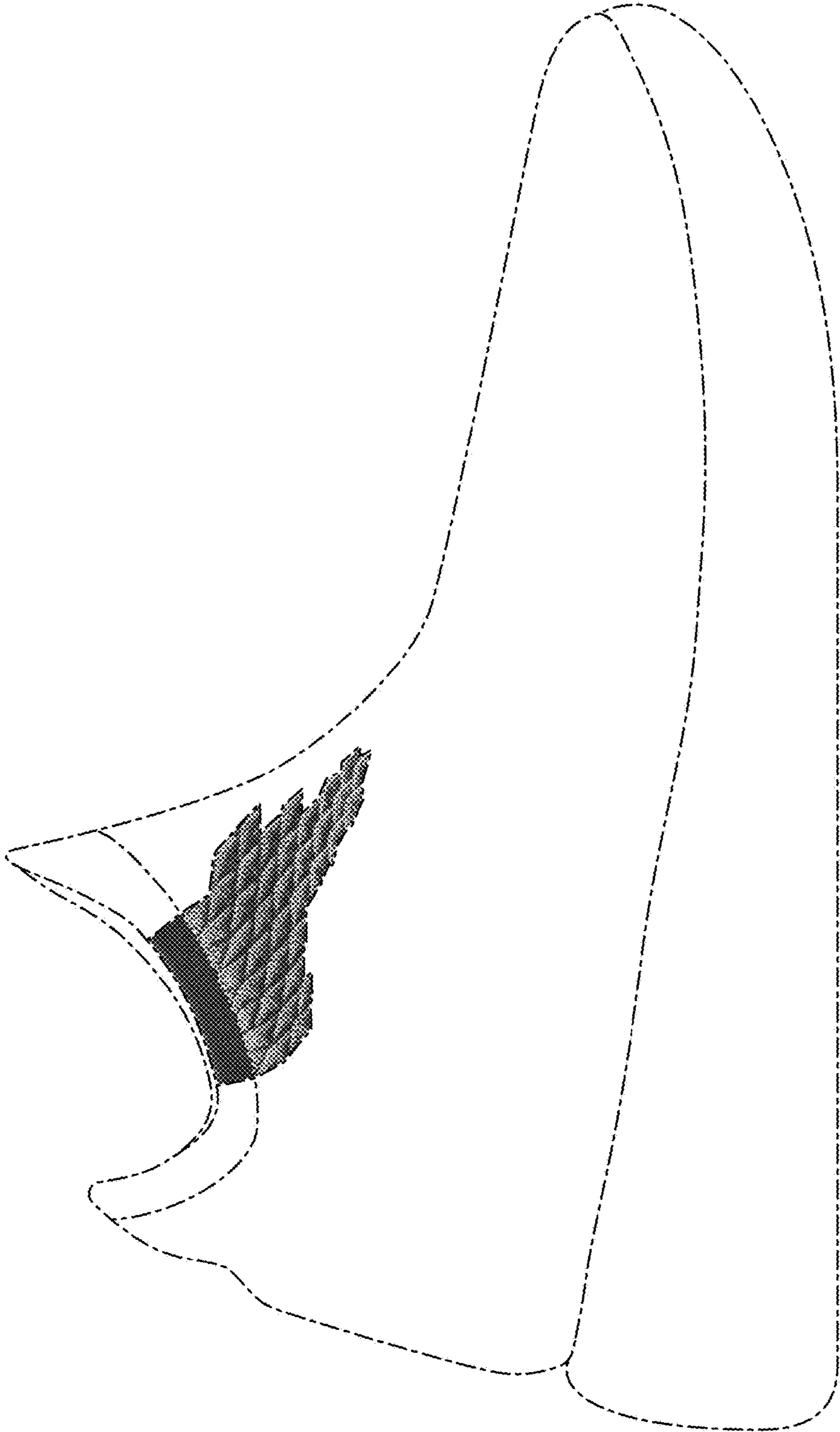

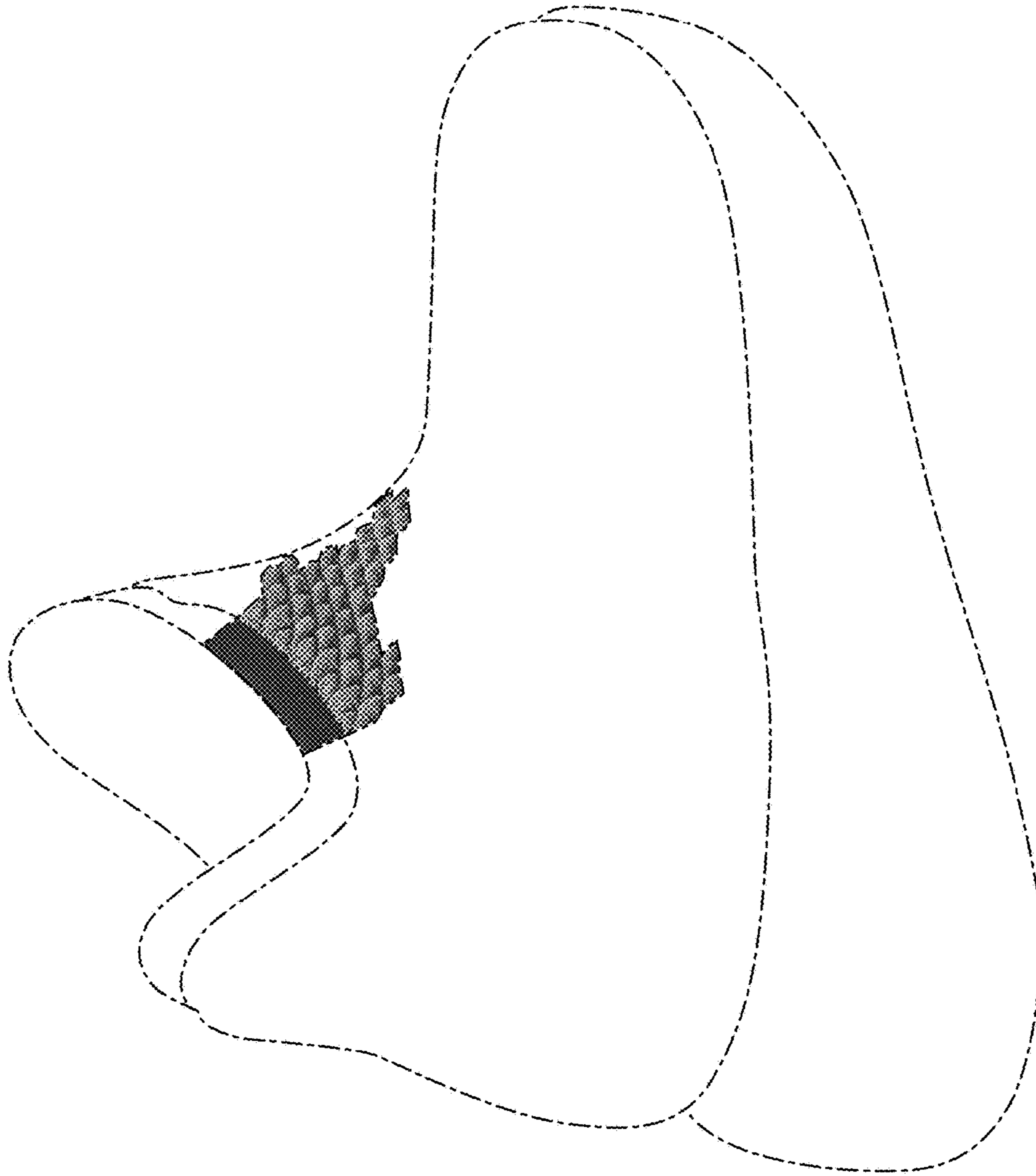

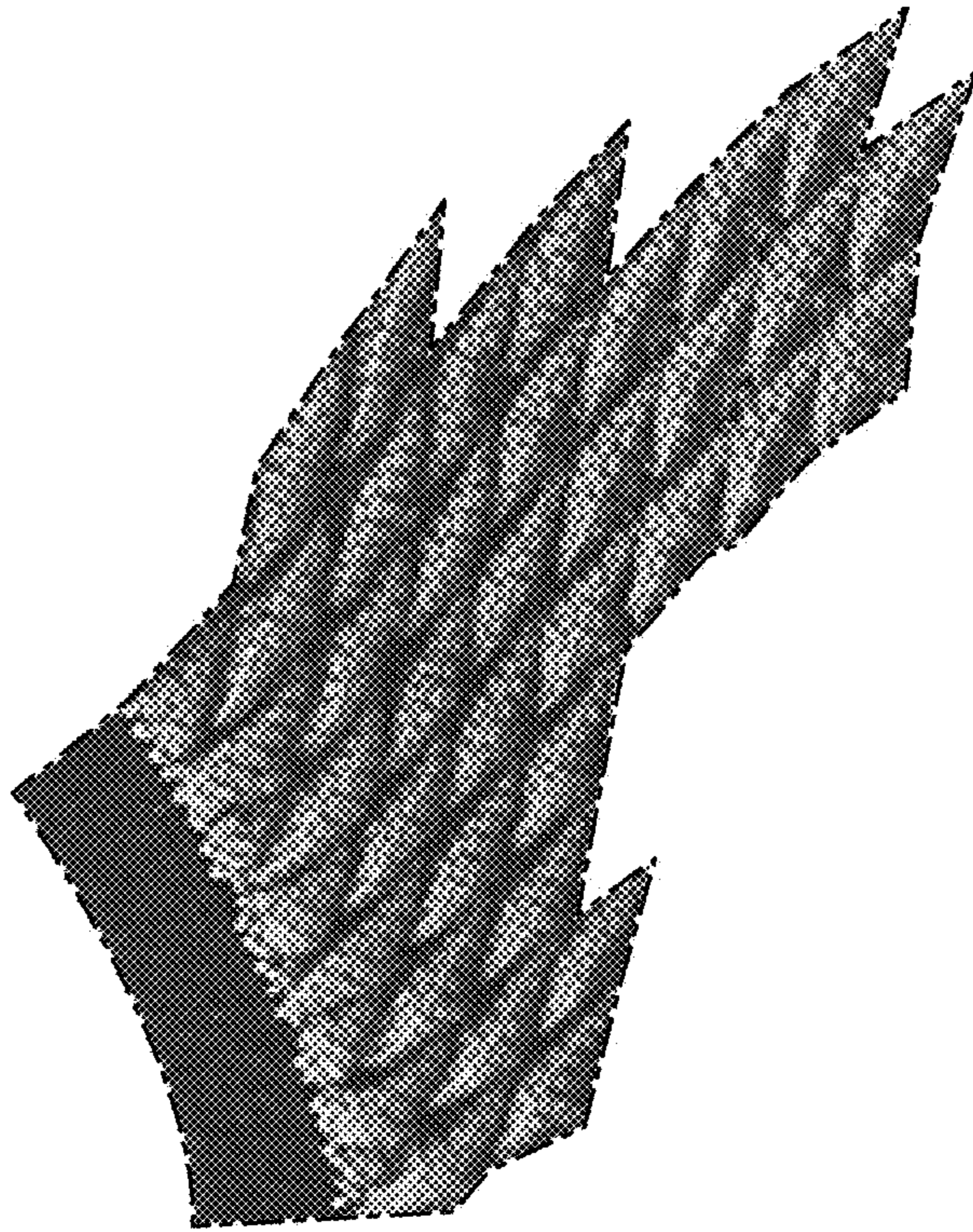

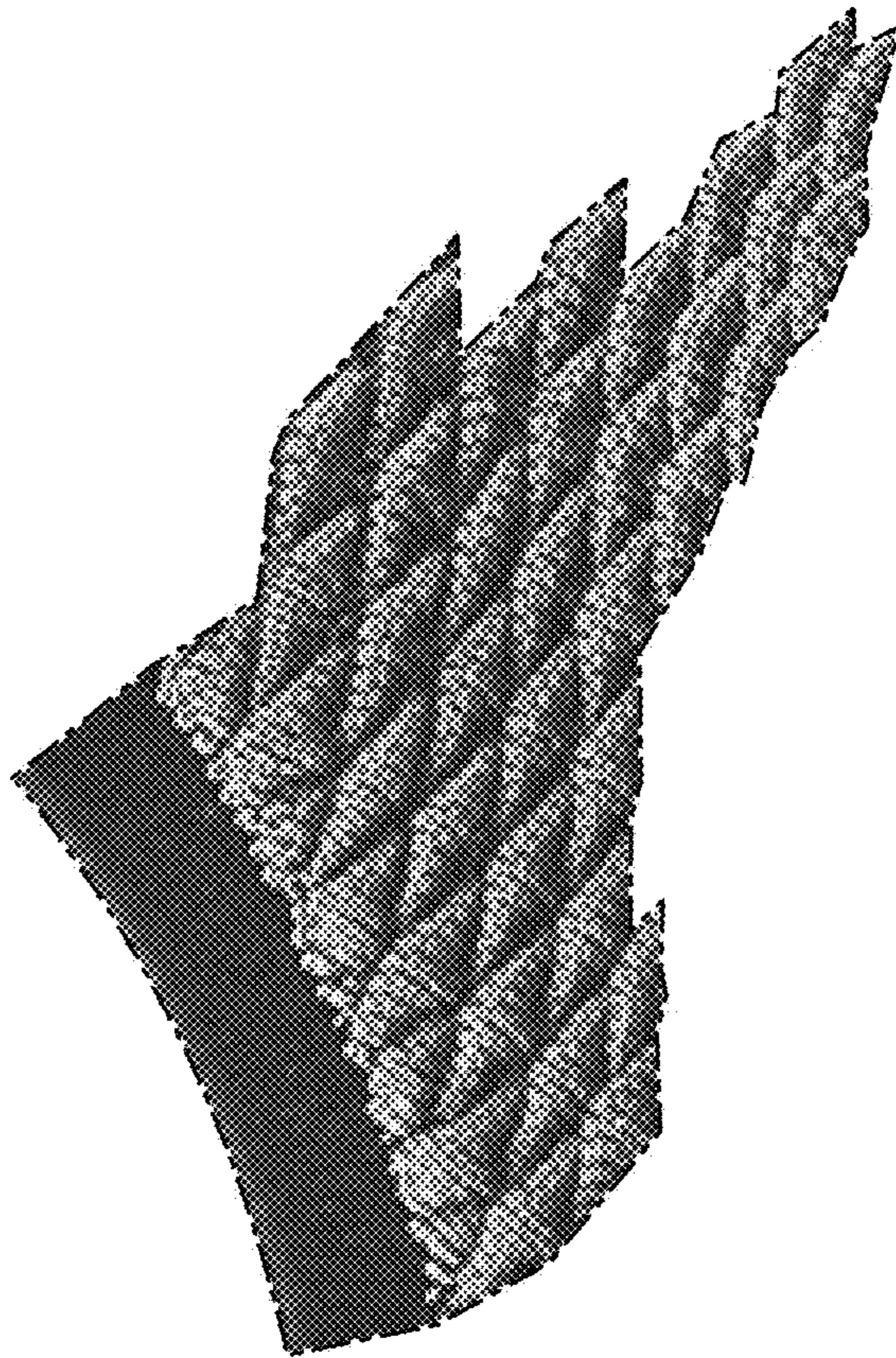

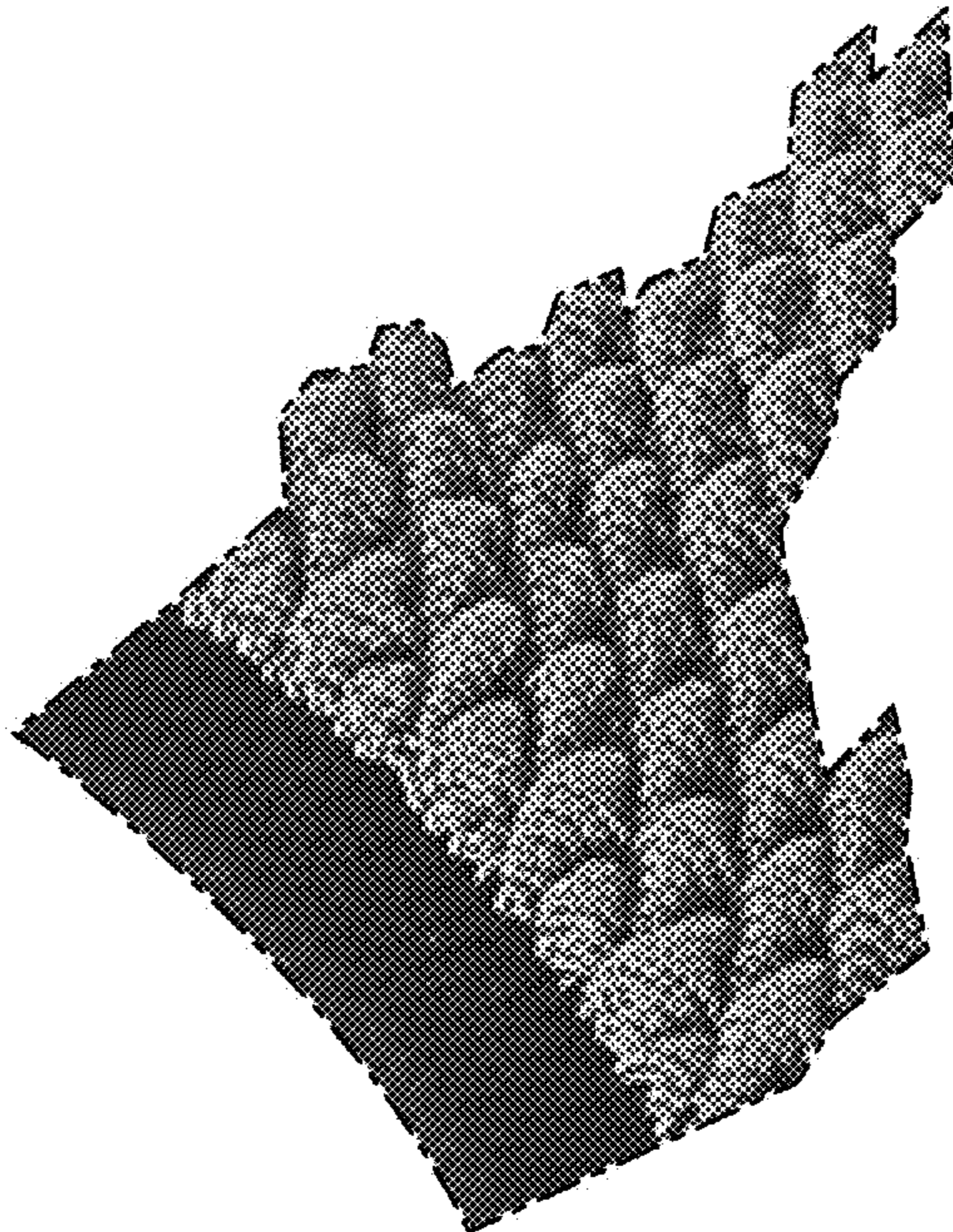

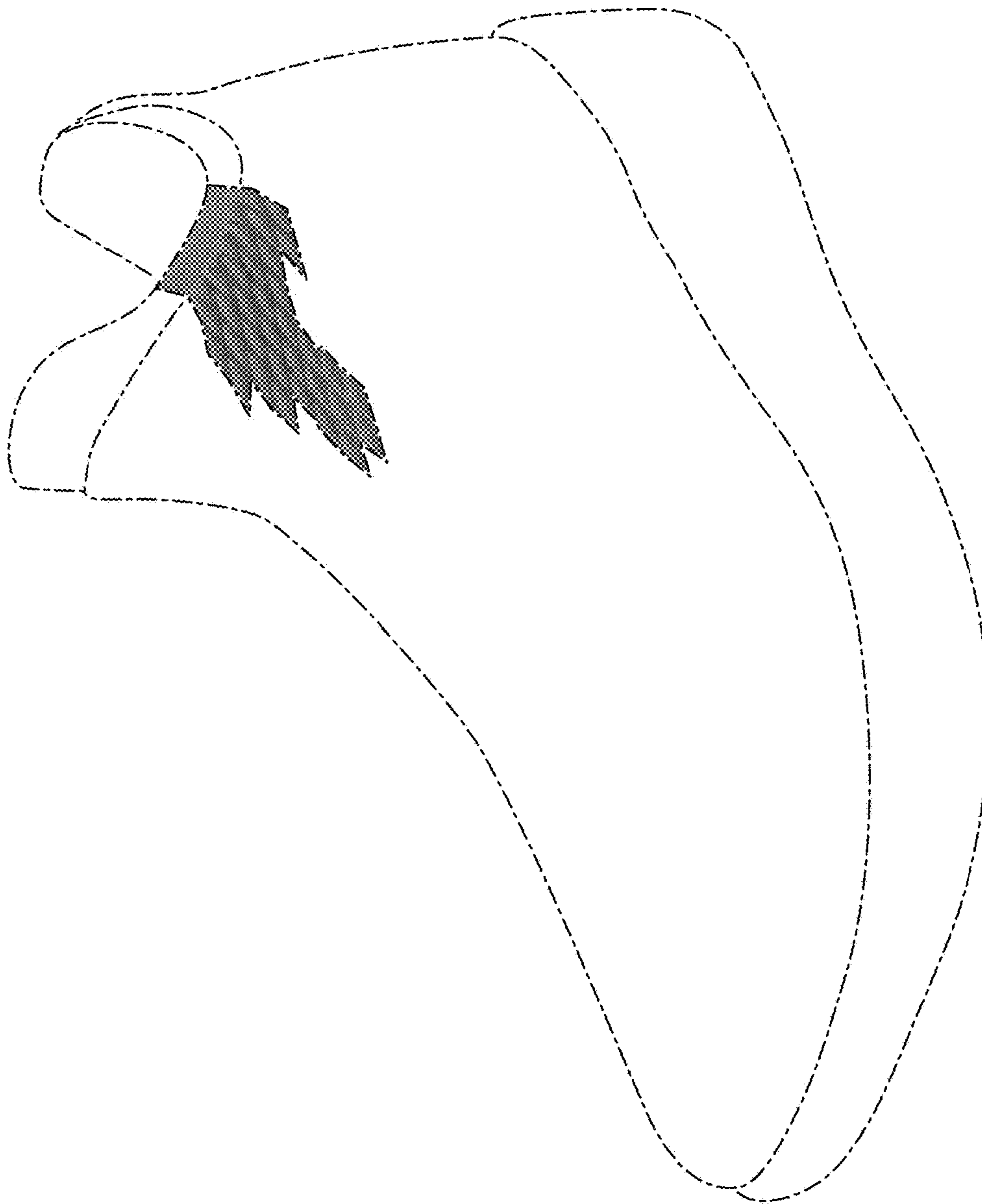

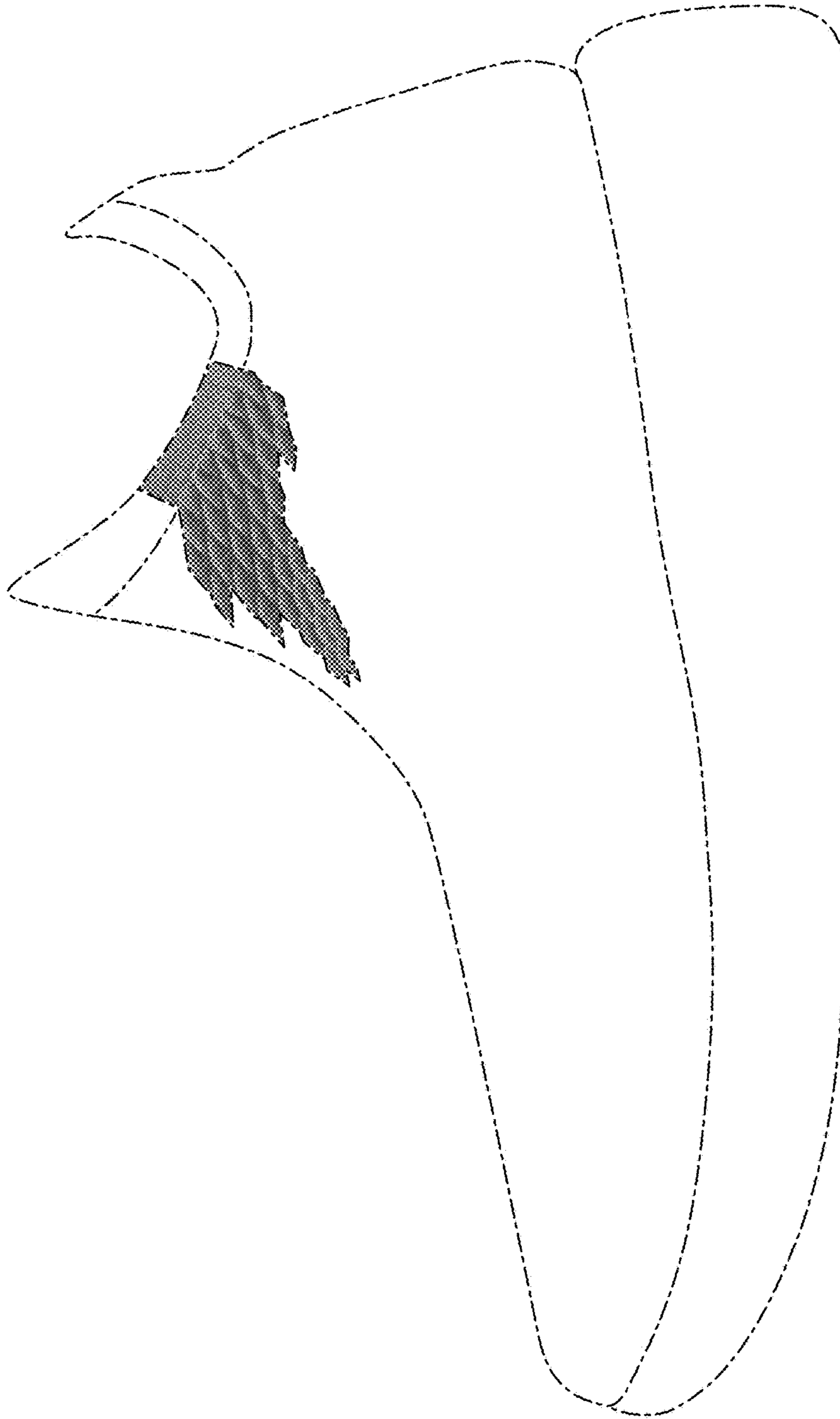

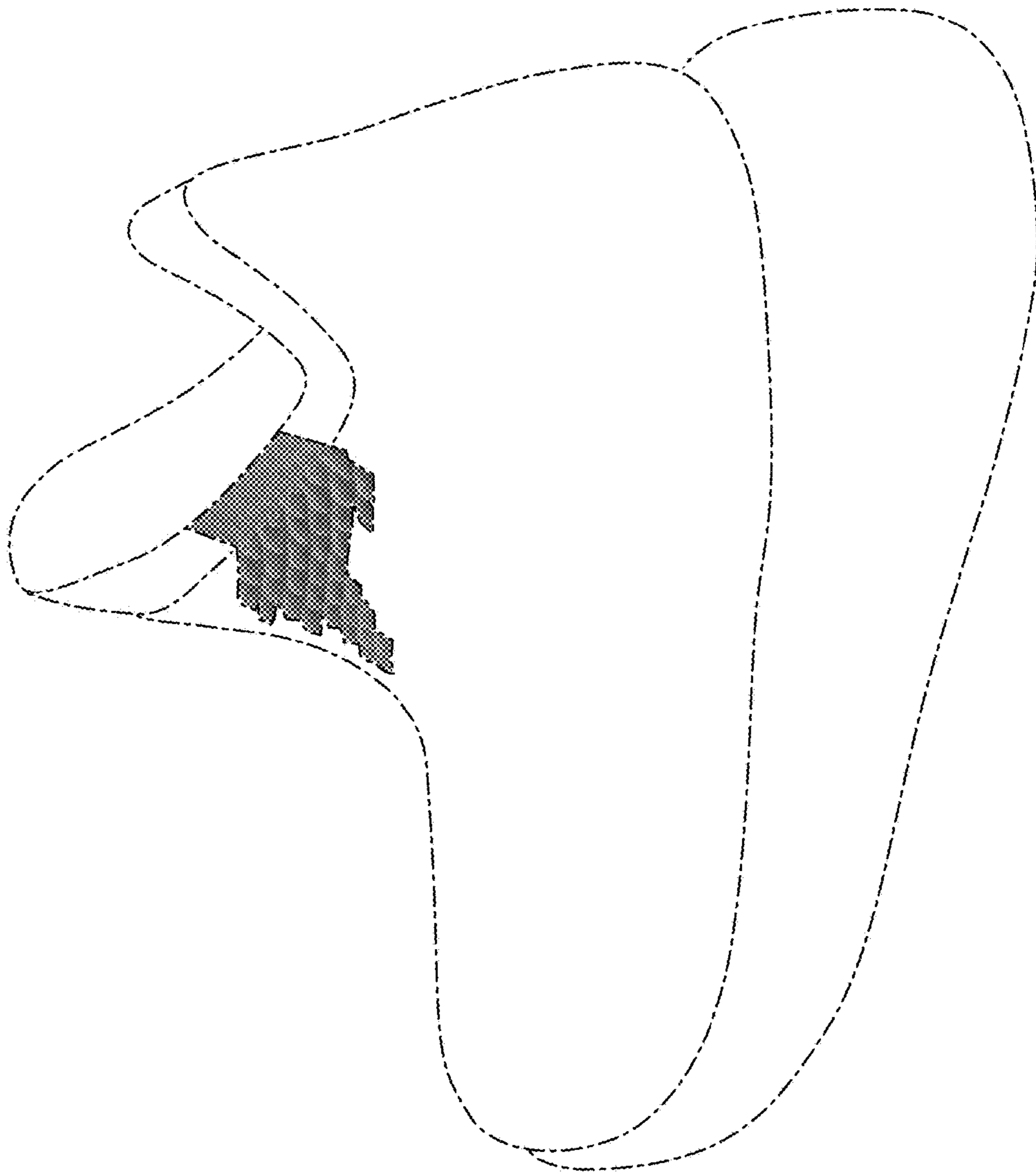

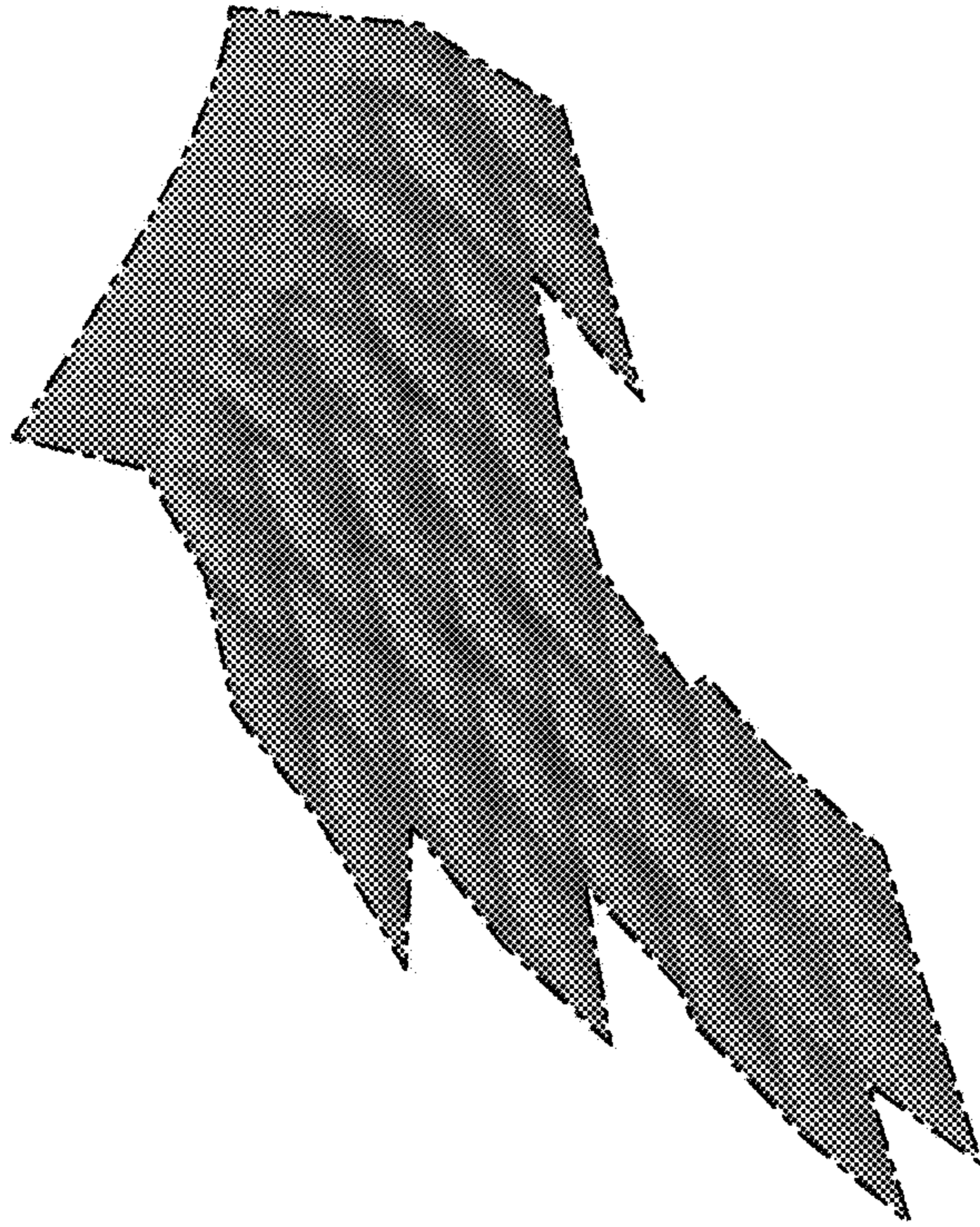

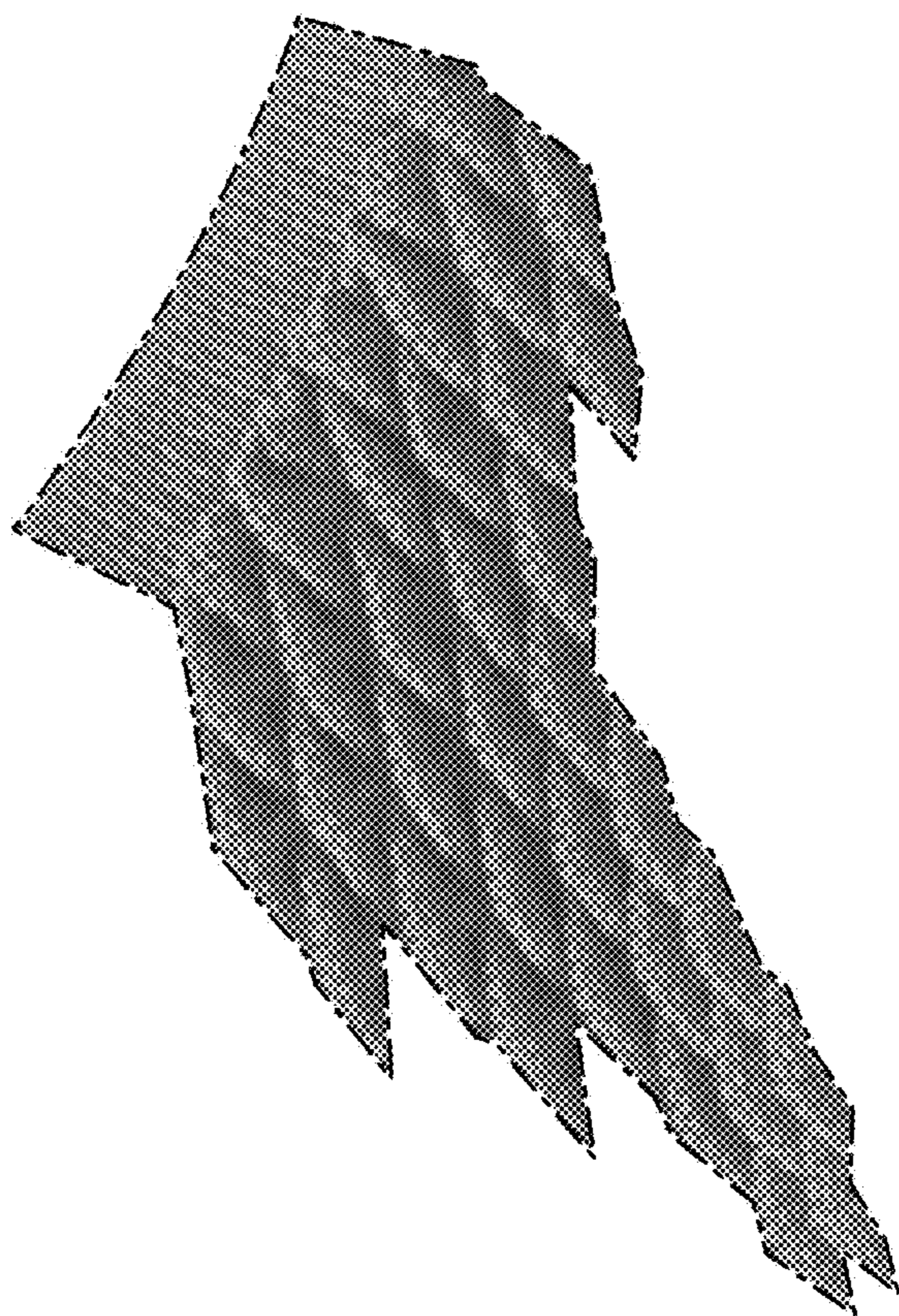

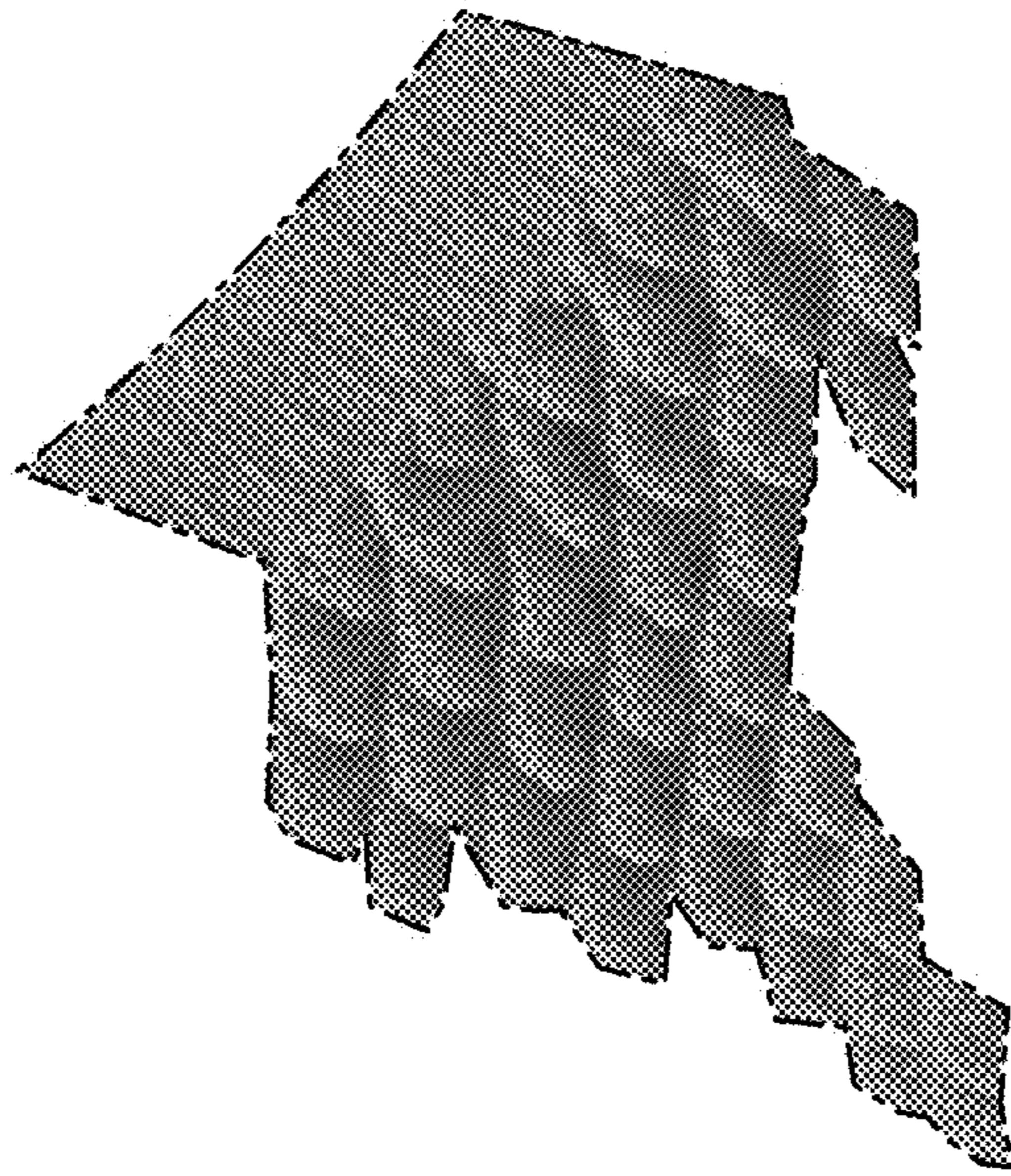
