(57) **CLAIM**

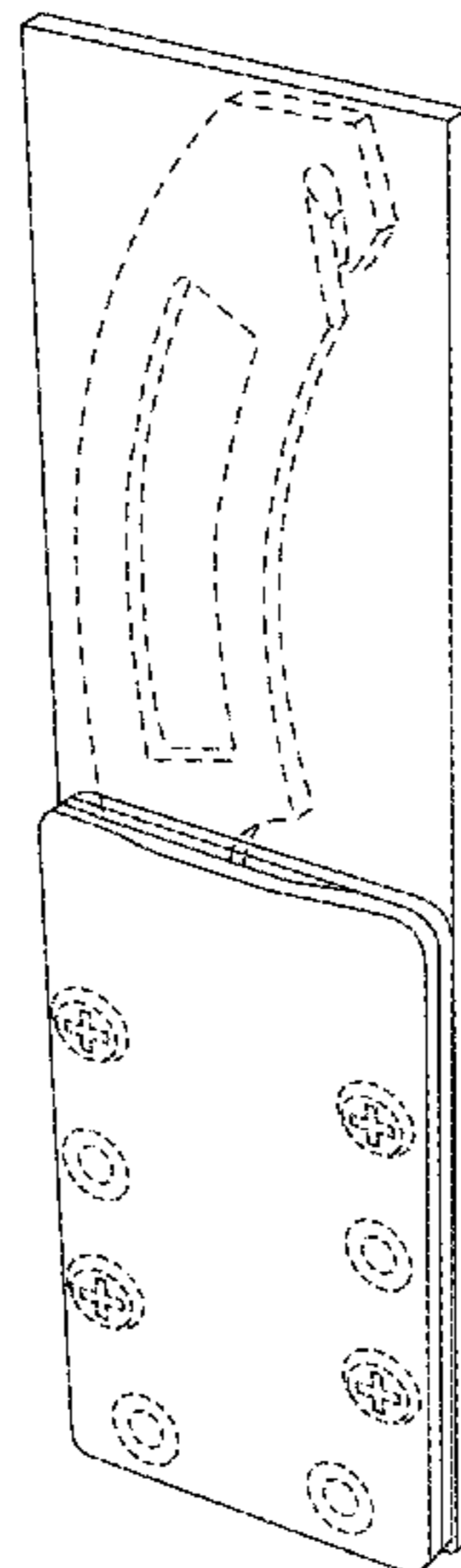
The ornamental design for a knife sheath, as shown and described.

DESCRIPTION

FIG. 1 is a front and side perspective view of a knife sheath; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is an enlarged bottom plan view thereof; and, FIG. 5 is an enlarged top plan view thereof.

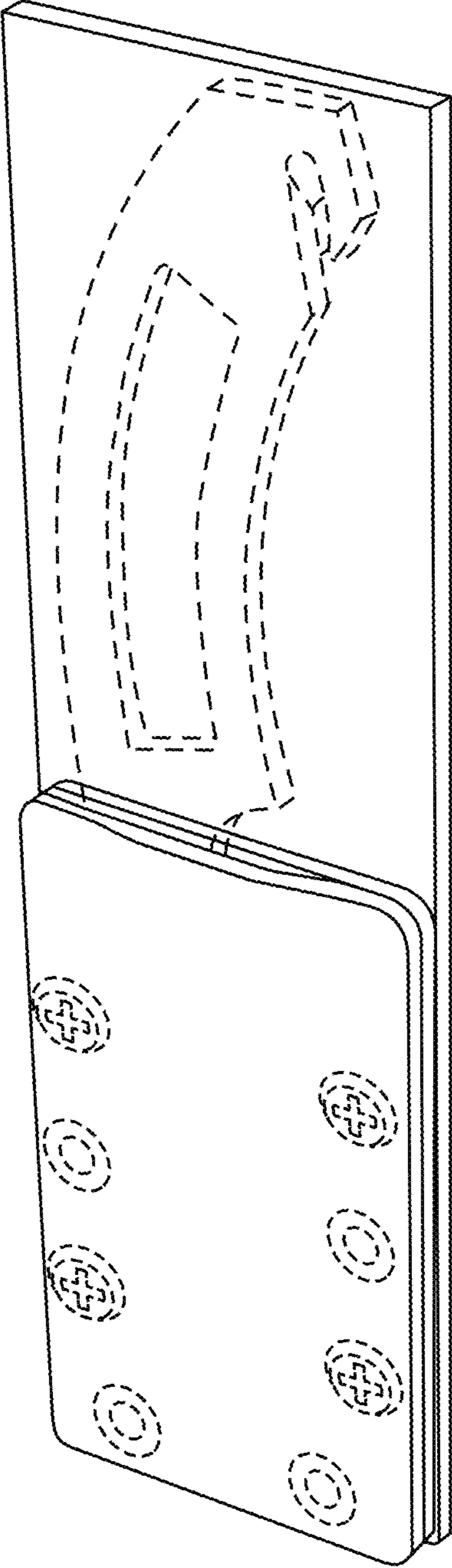

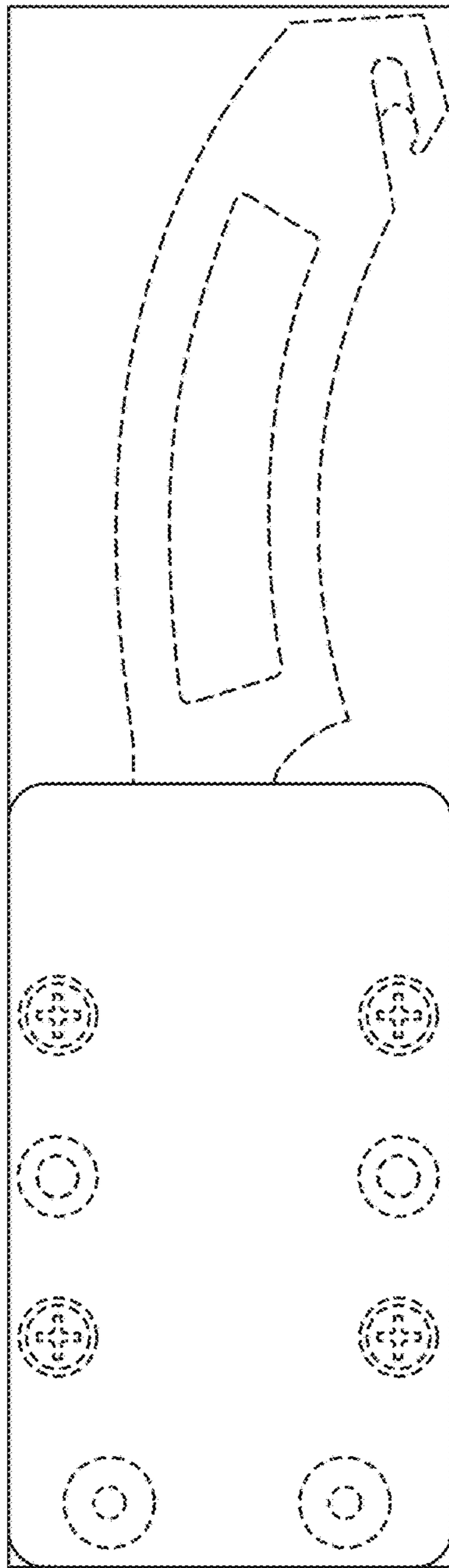

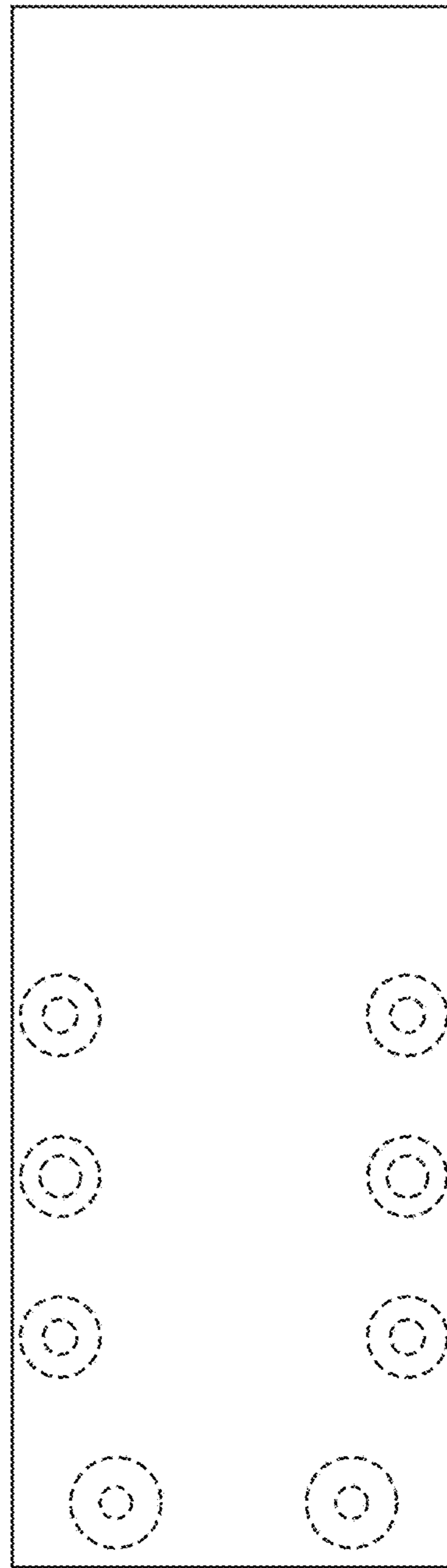

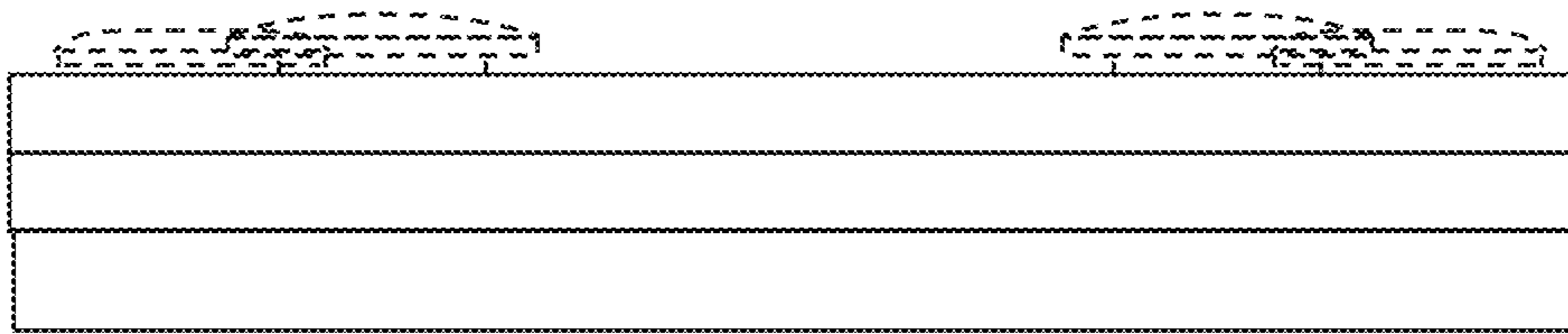

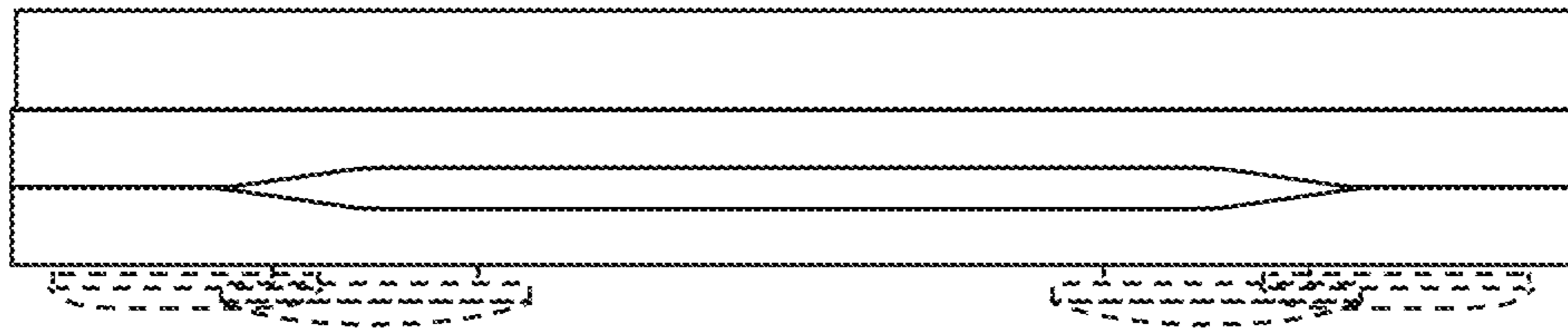
