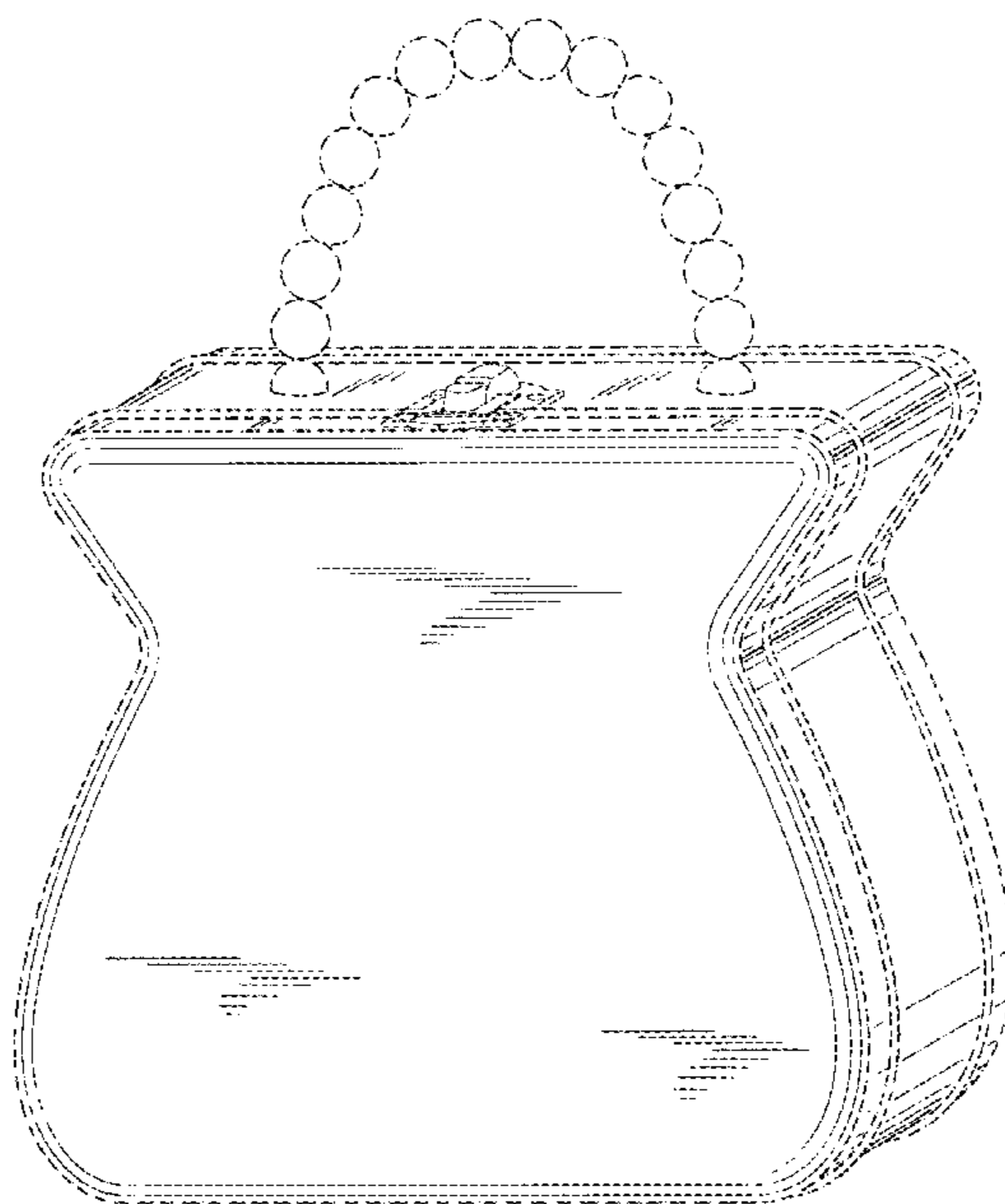
(57) **CLAIM**

The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container showing our new design;  
FIG. 2 is a front view of the container shown in FIG. 1;  
FIG. 3 is a rear view of the container shown in FIG. 1;  
FIG. 4 is a right side view of the container in FIG. 1;  
FIG. 5 is a left side view of the container shown in FIG. 1;  
FIG. 6 is a top view of the container shown in FIG. 1; and,  
FIG. 7 is a bottom view of the container shown in FIG. 1.  
The broken lines showing the handle, latch, the top and bottom edges, and the ridges along the side of the container are included to show features that form no part of the claimed design.

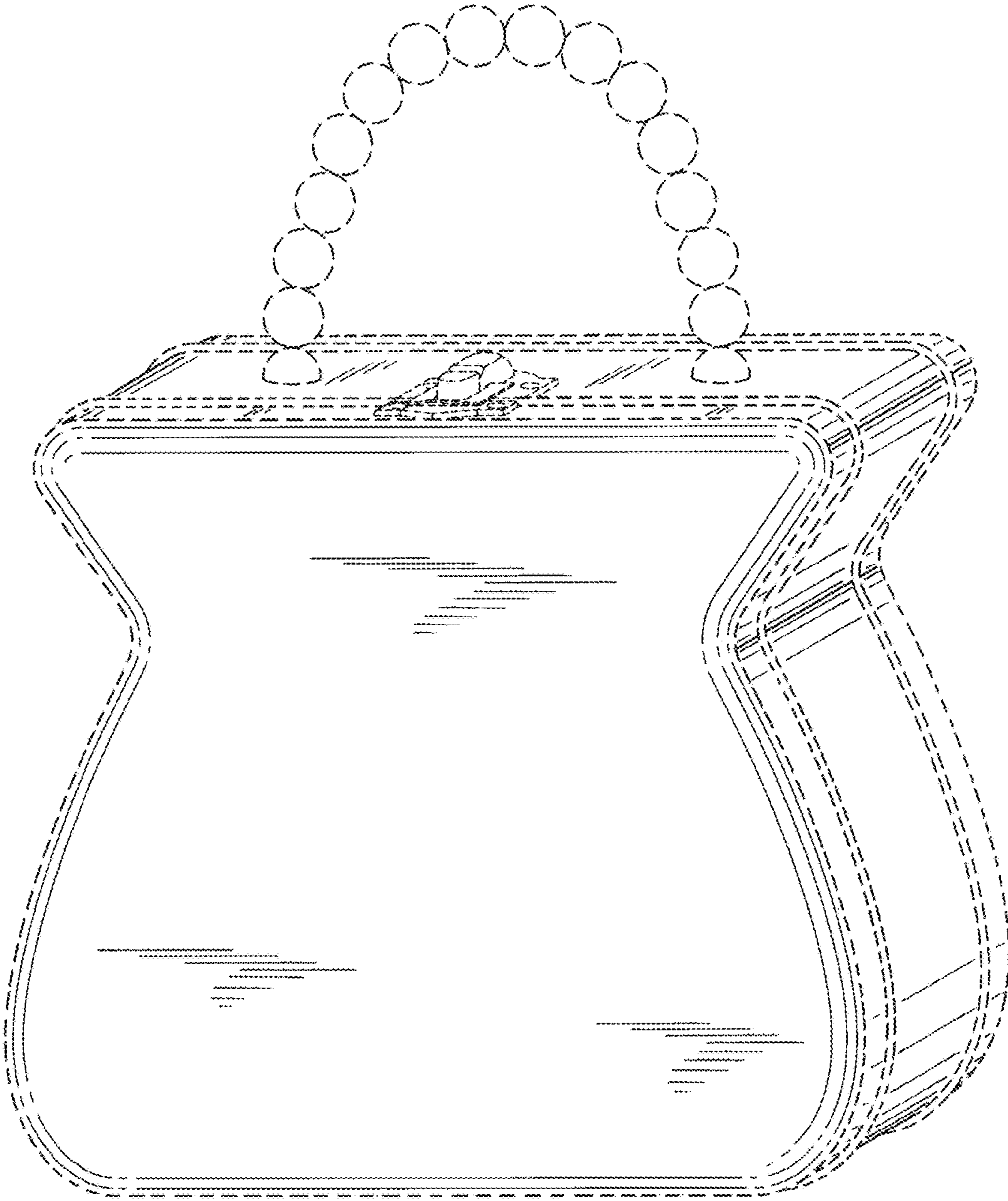

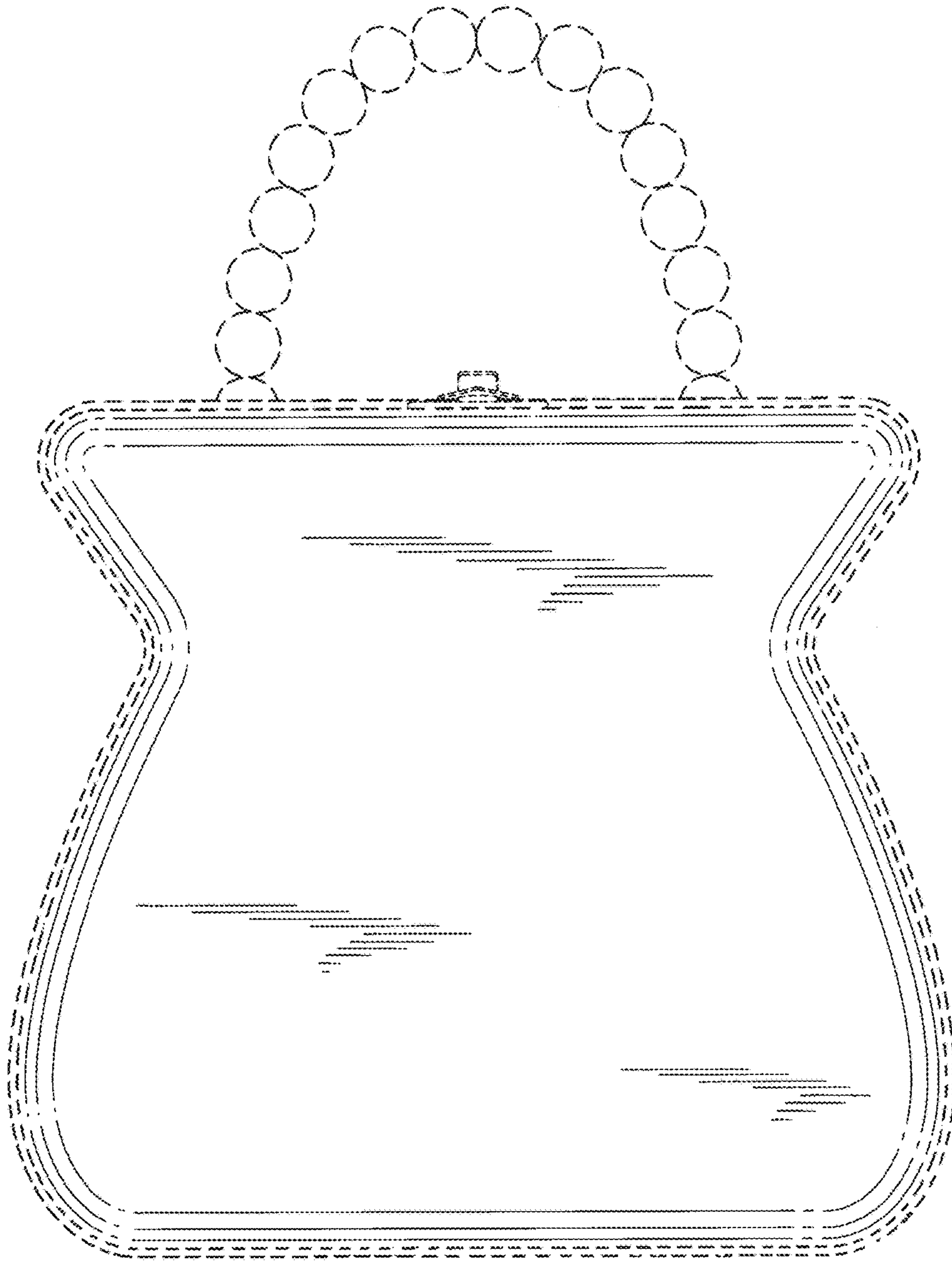

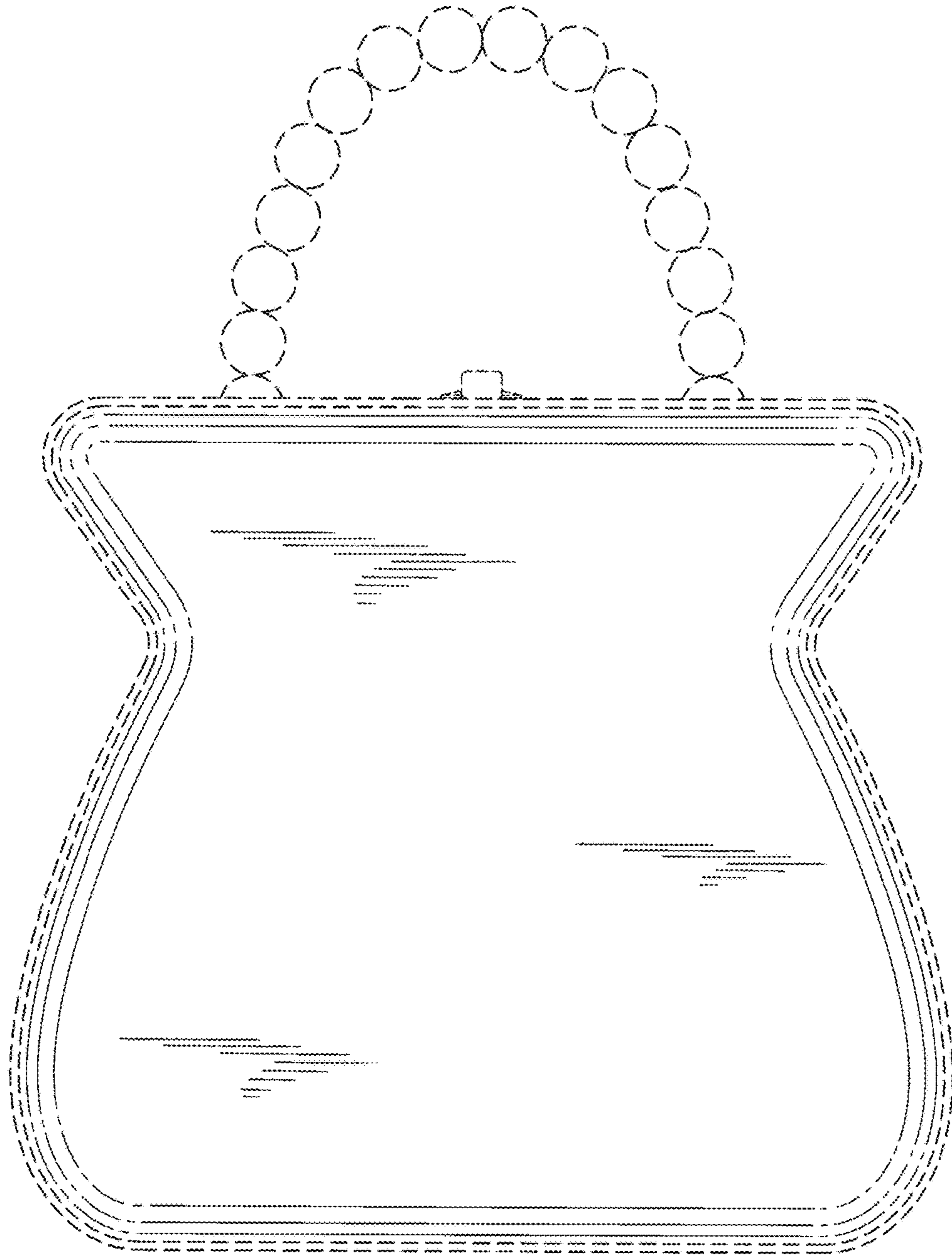

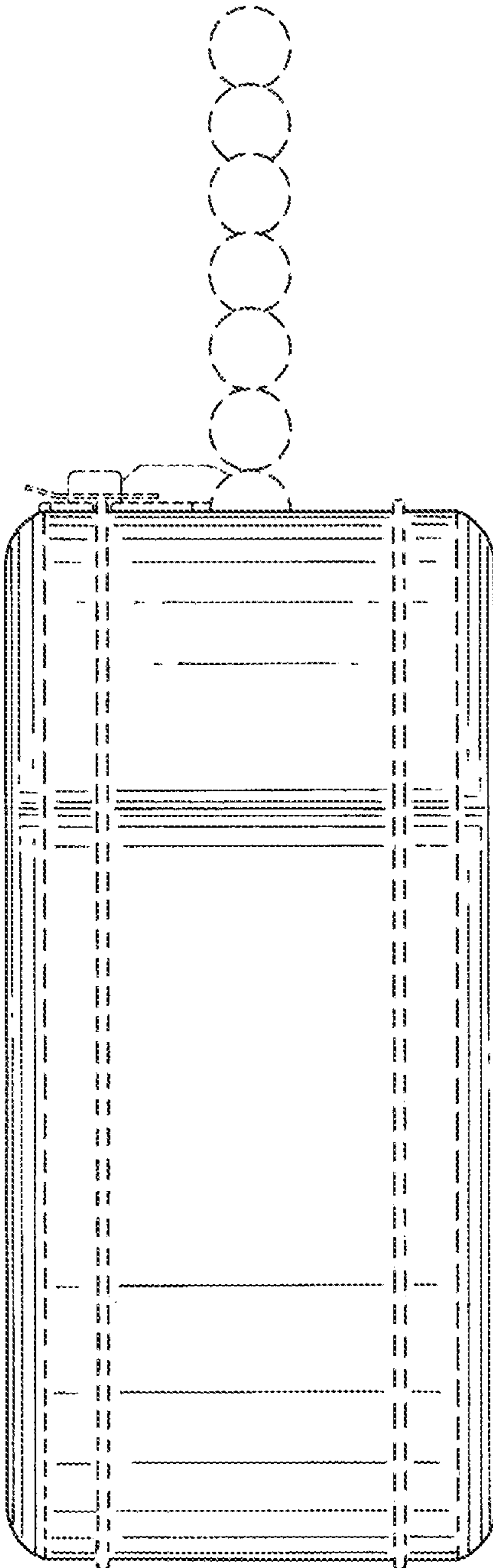

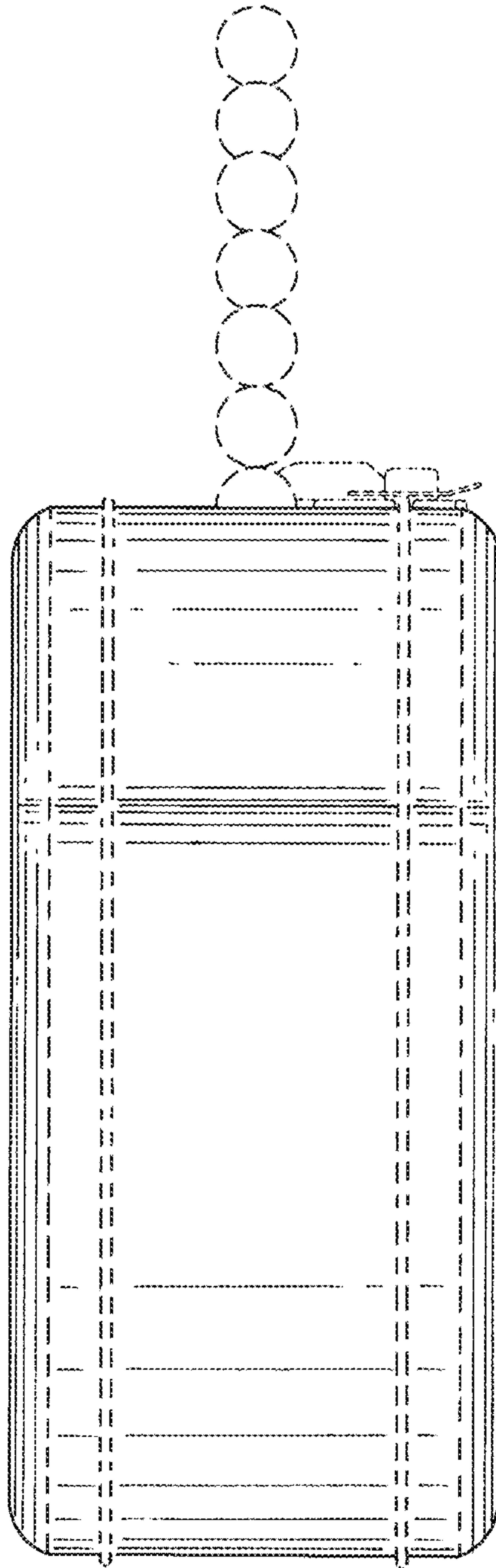

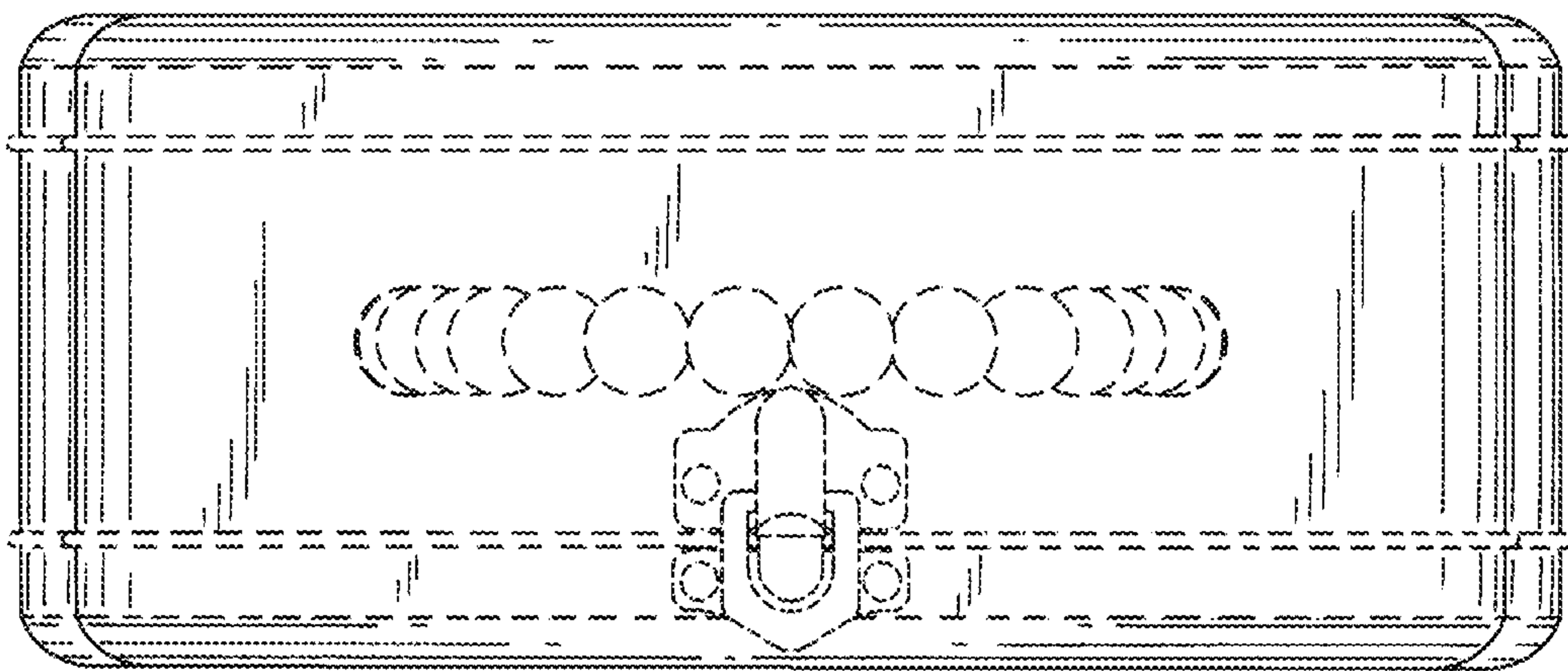

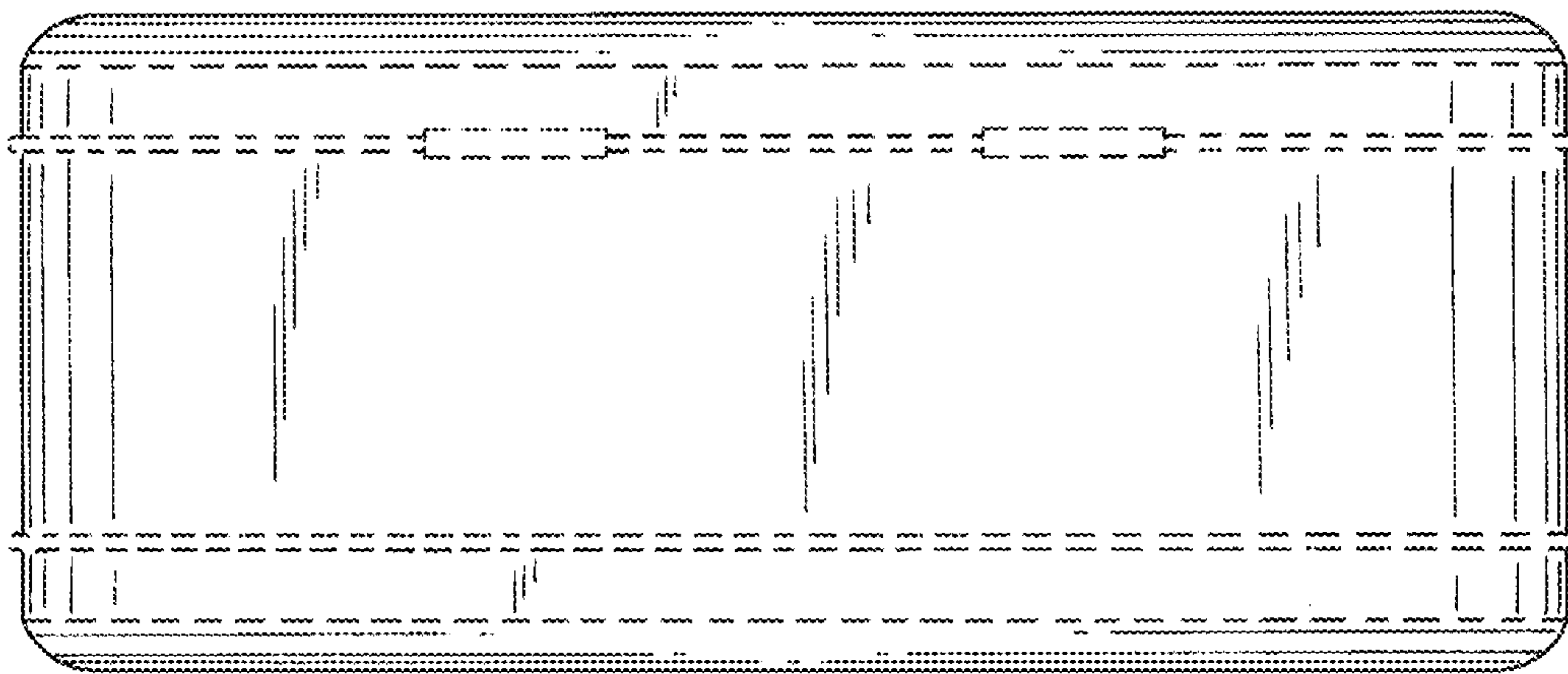
