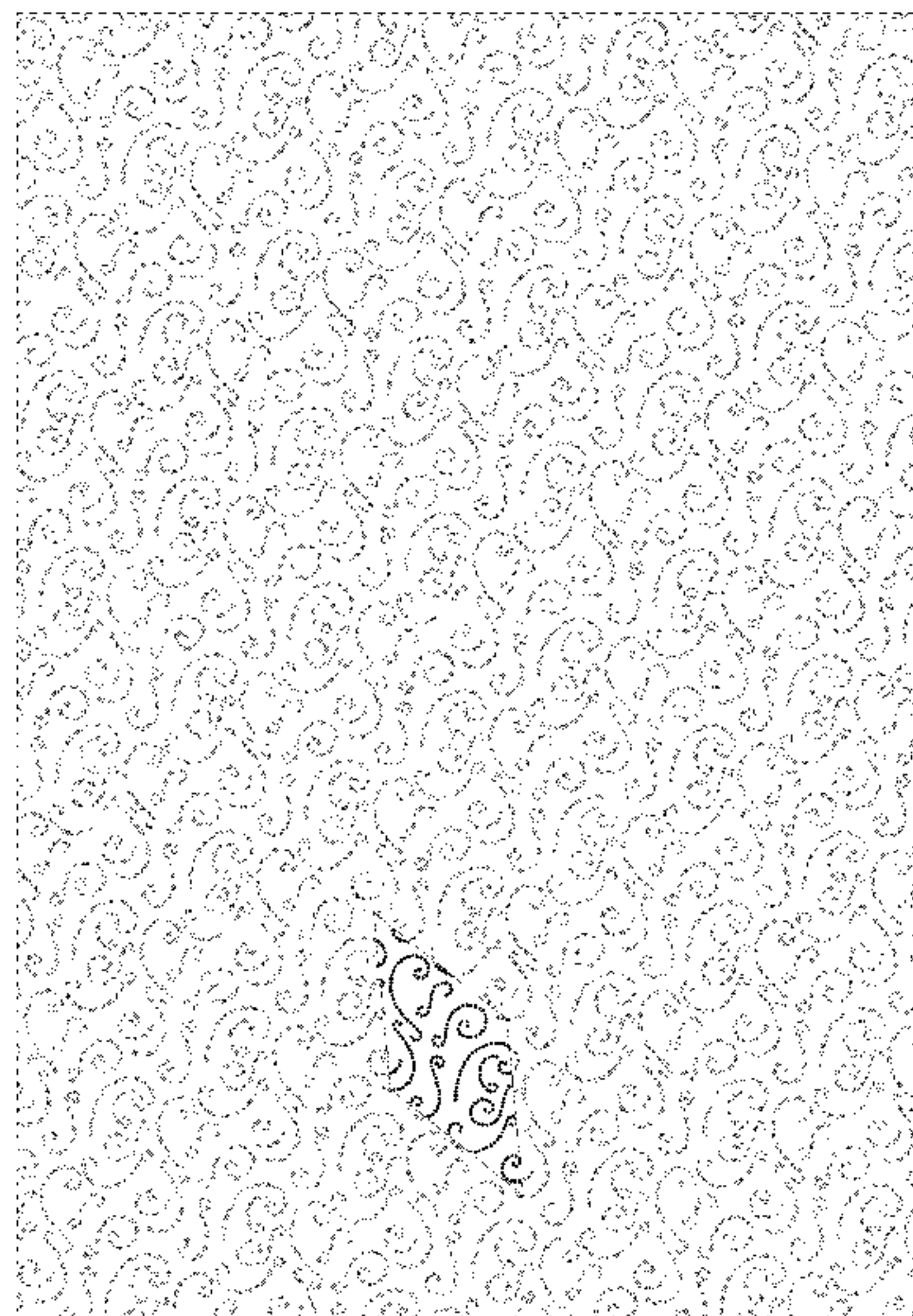
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a paper
product with pattern; and,
FIG. 2 is a top plan view of a second embodiment of a paper
product with pattern.

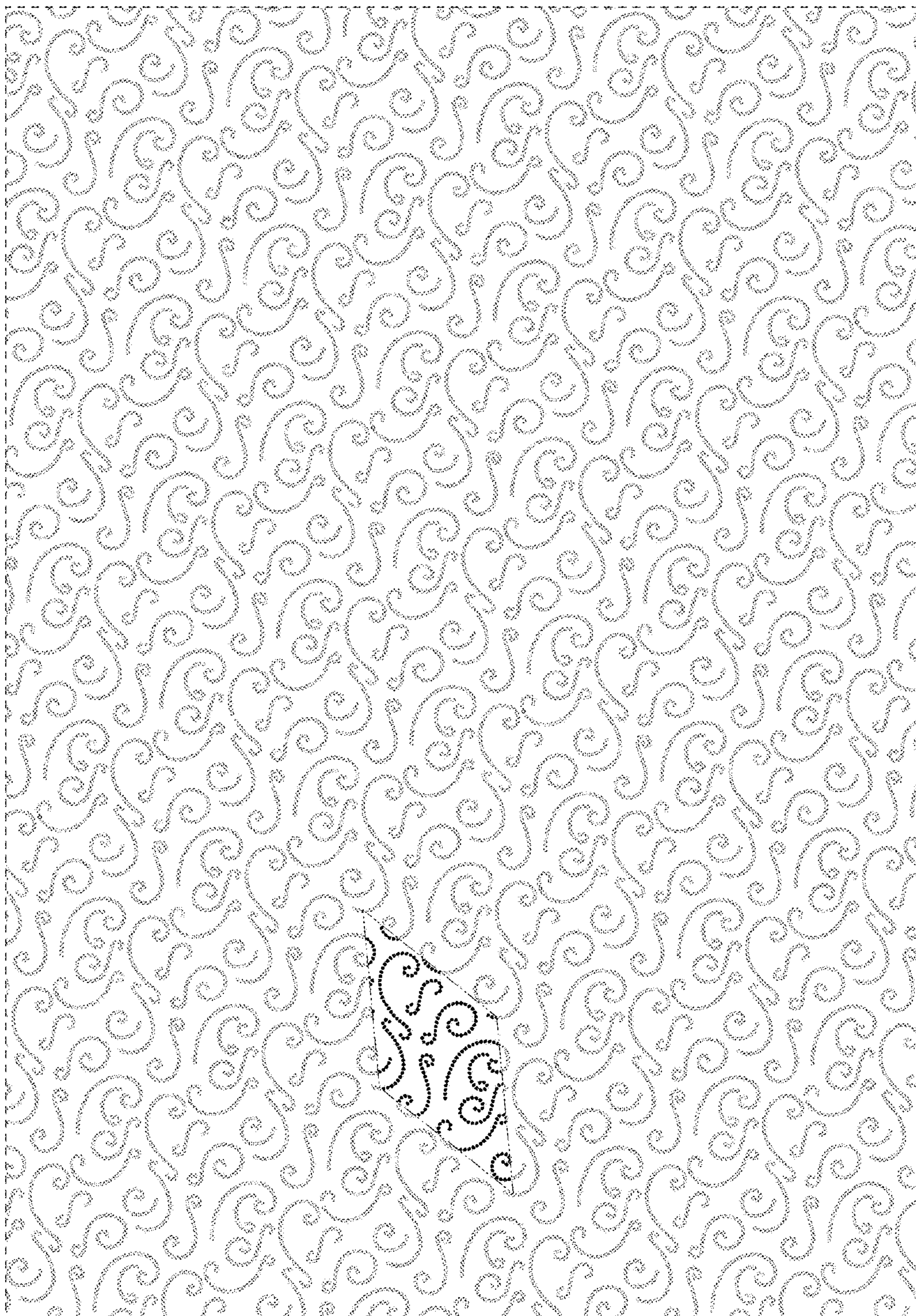

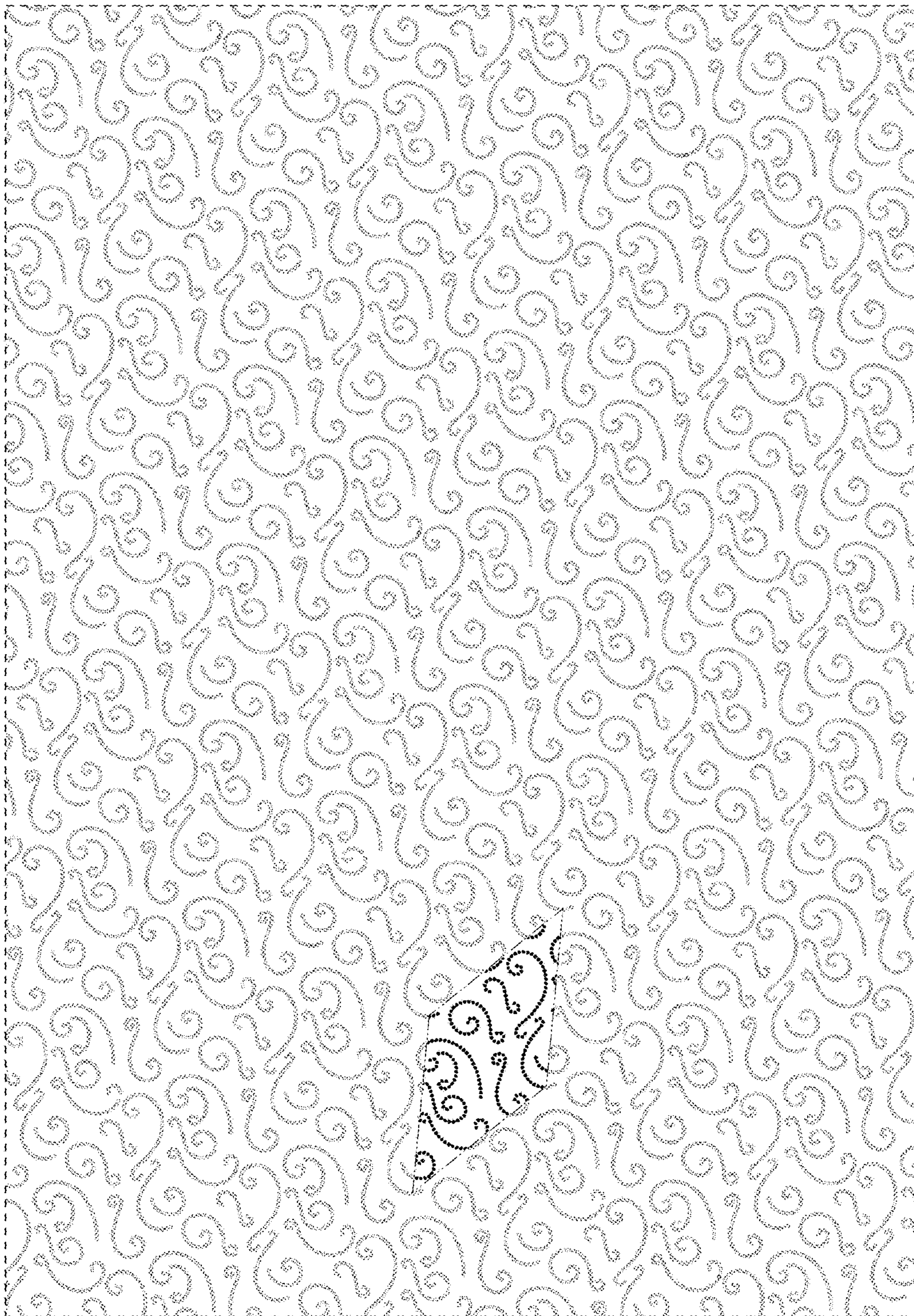
