The ornamental design for a display stand, as shown and described.

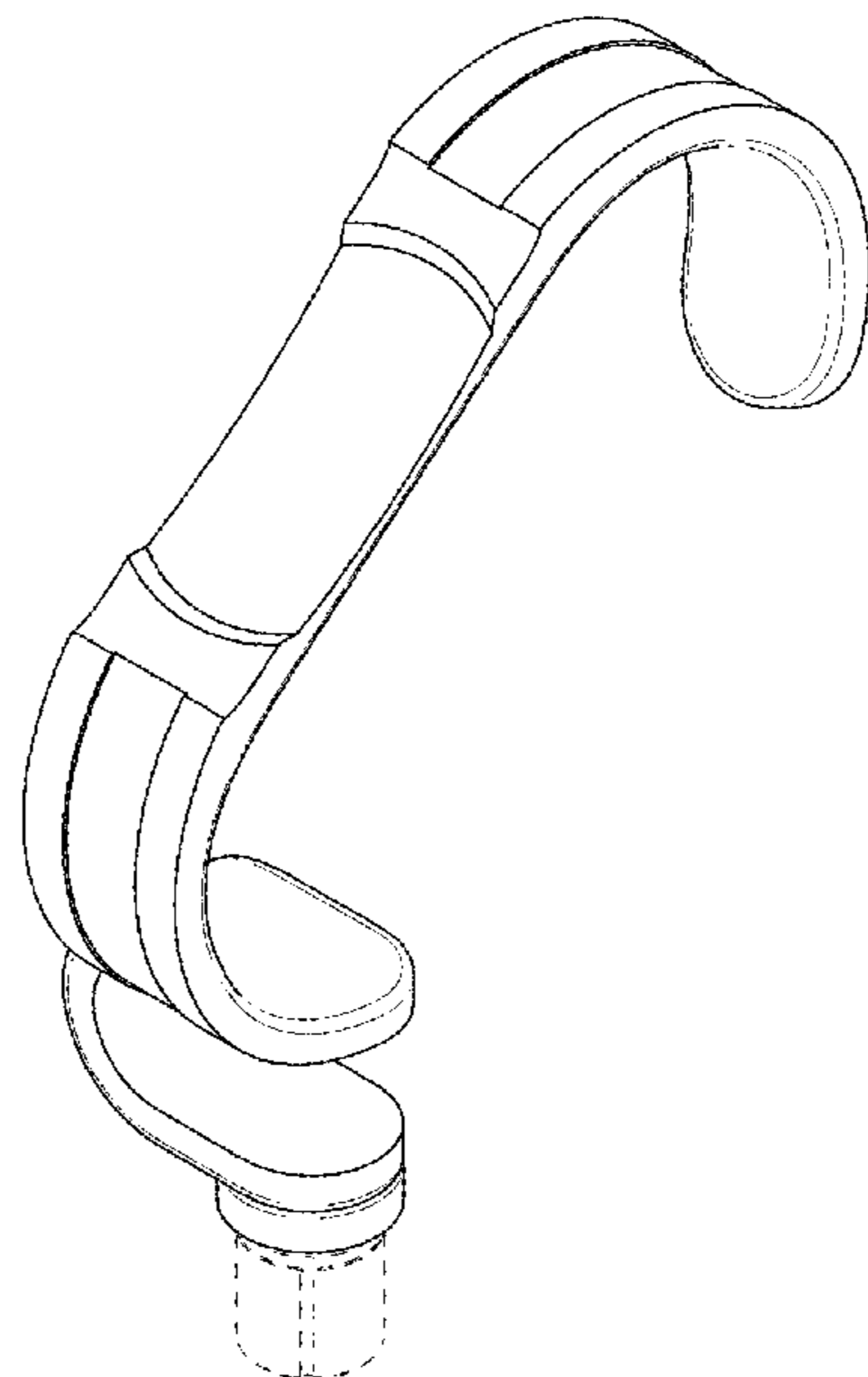

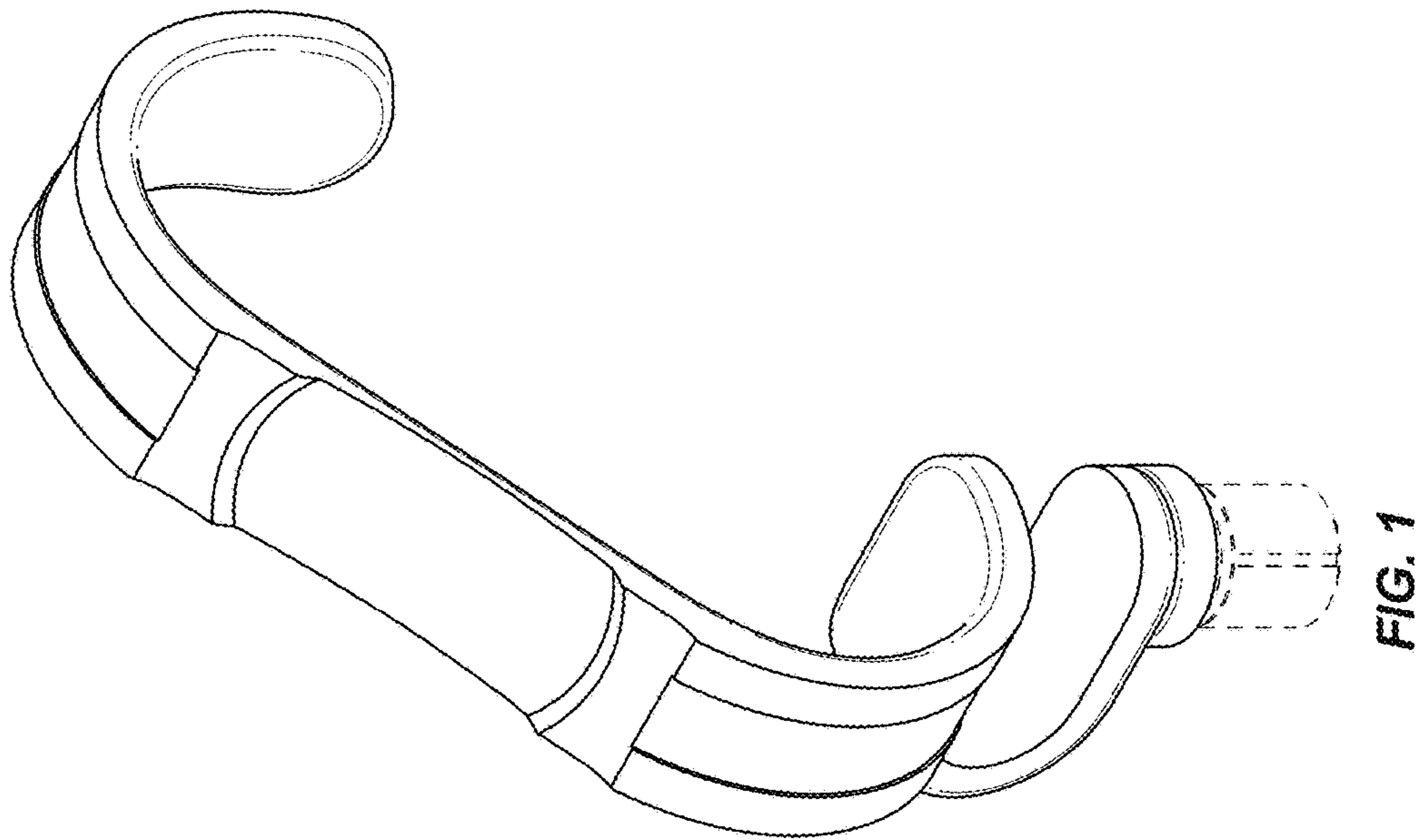
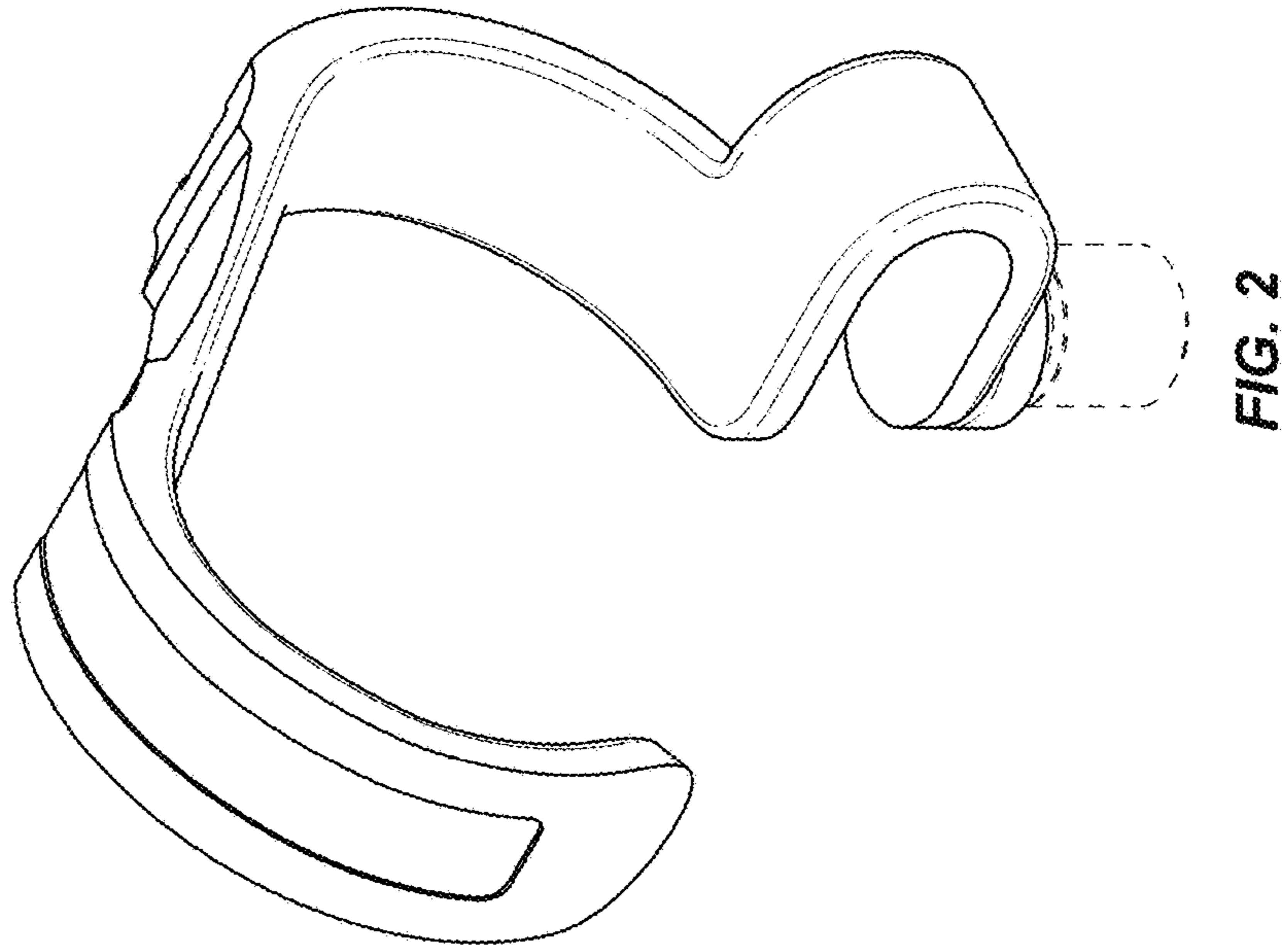
FIG. 1 is a top front perspective view of a display stand showing the claimed design;

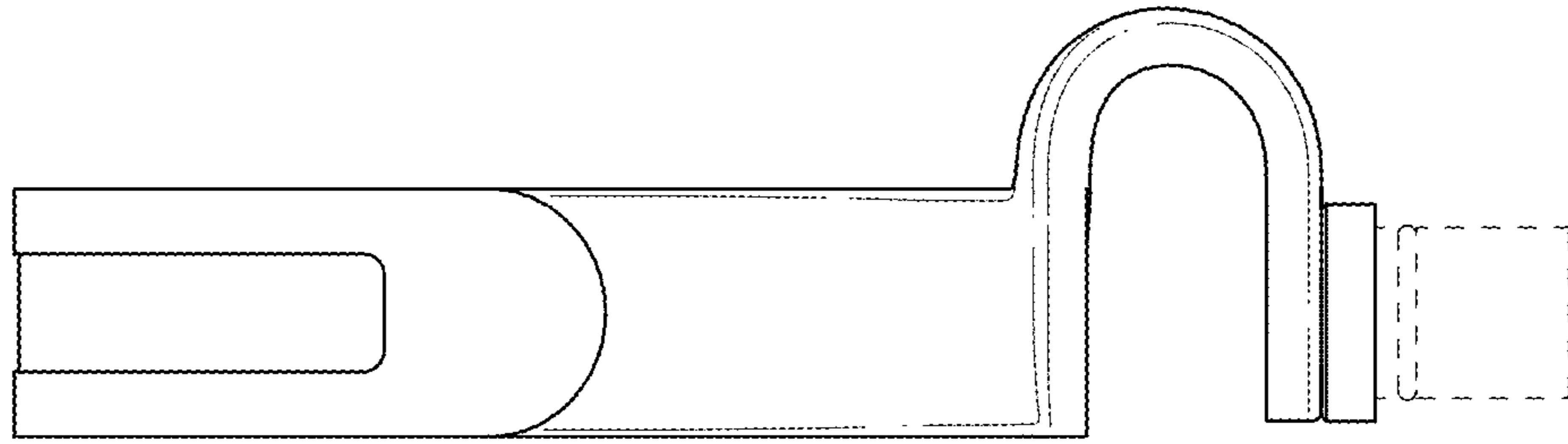

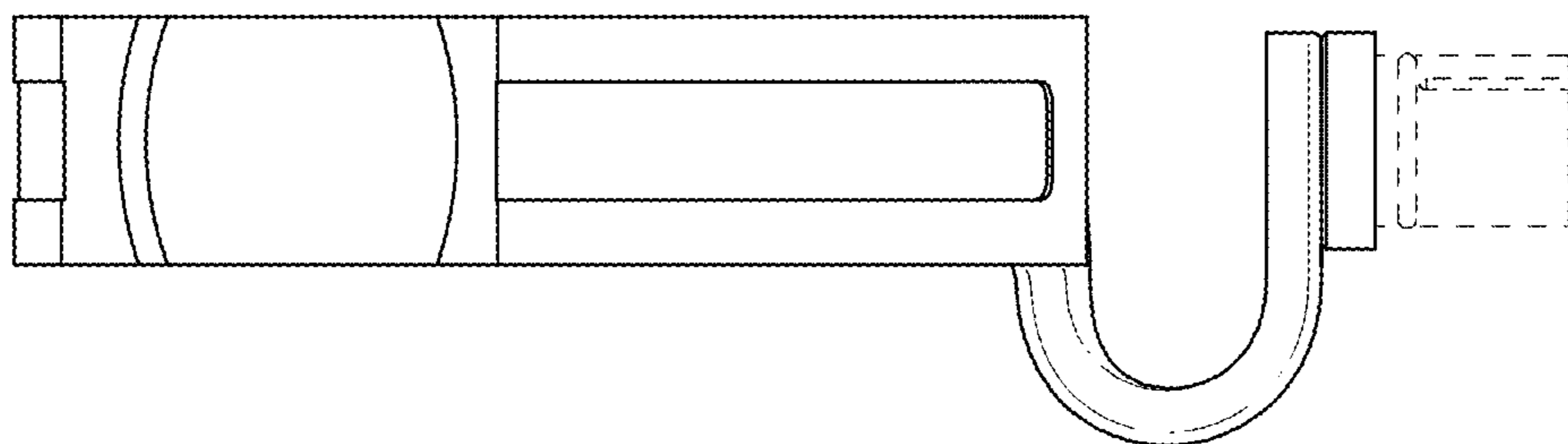

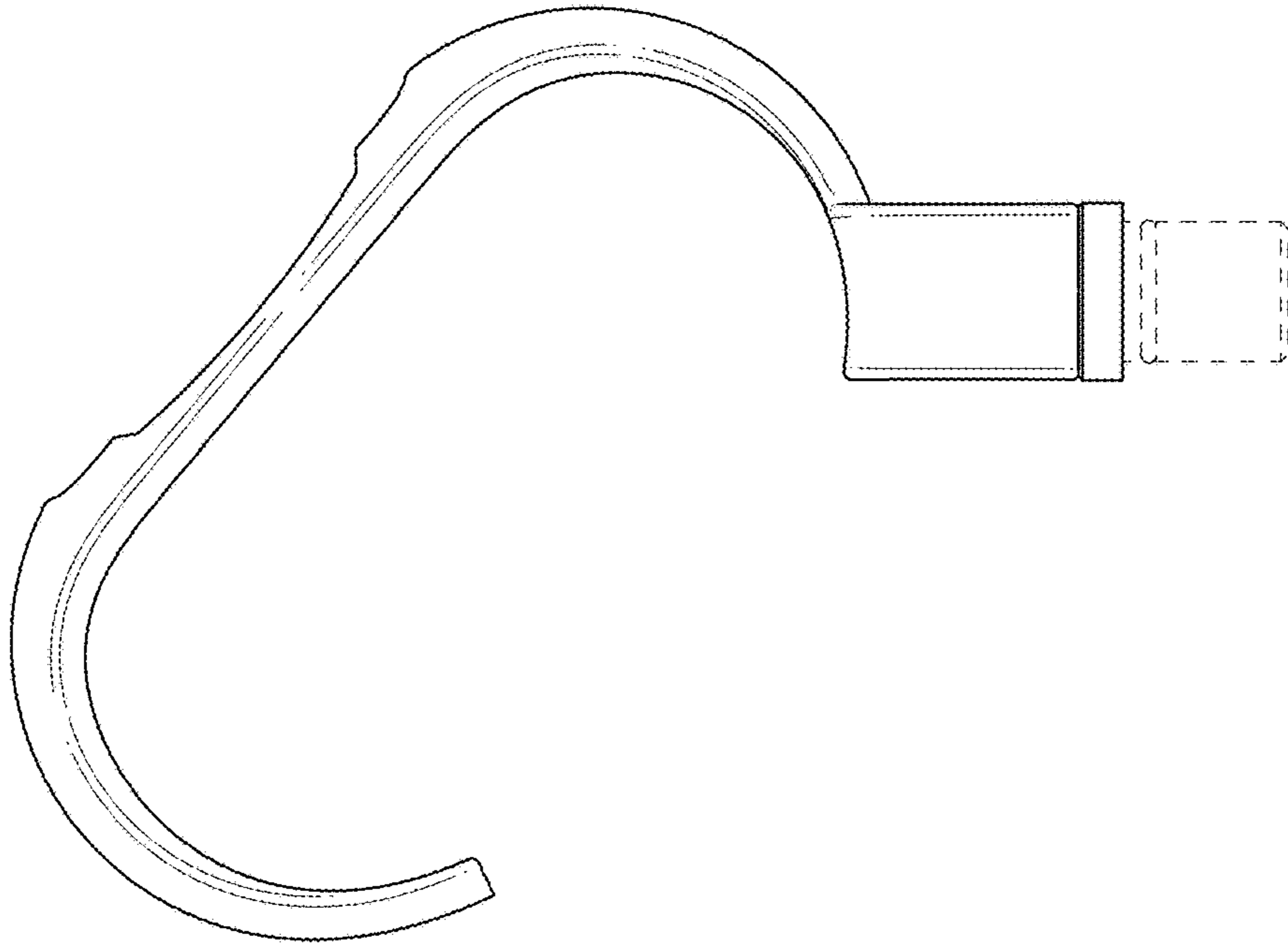

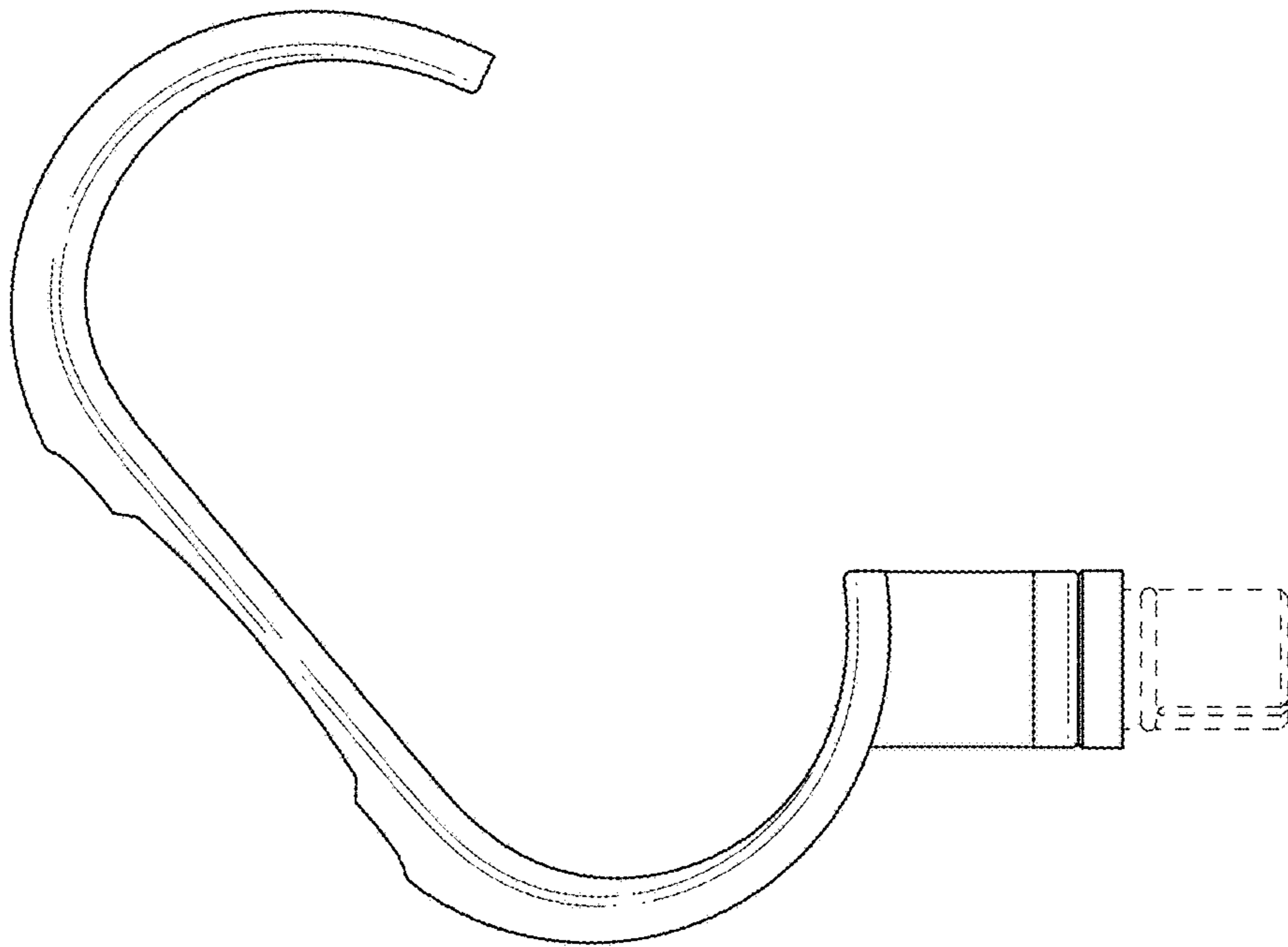

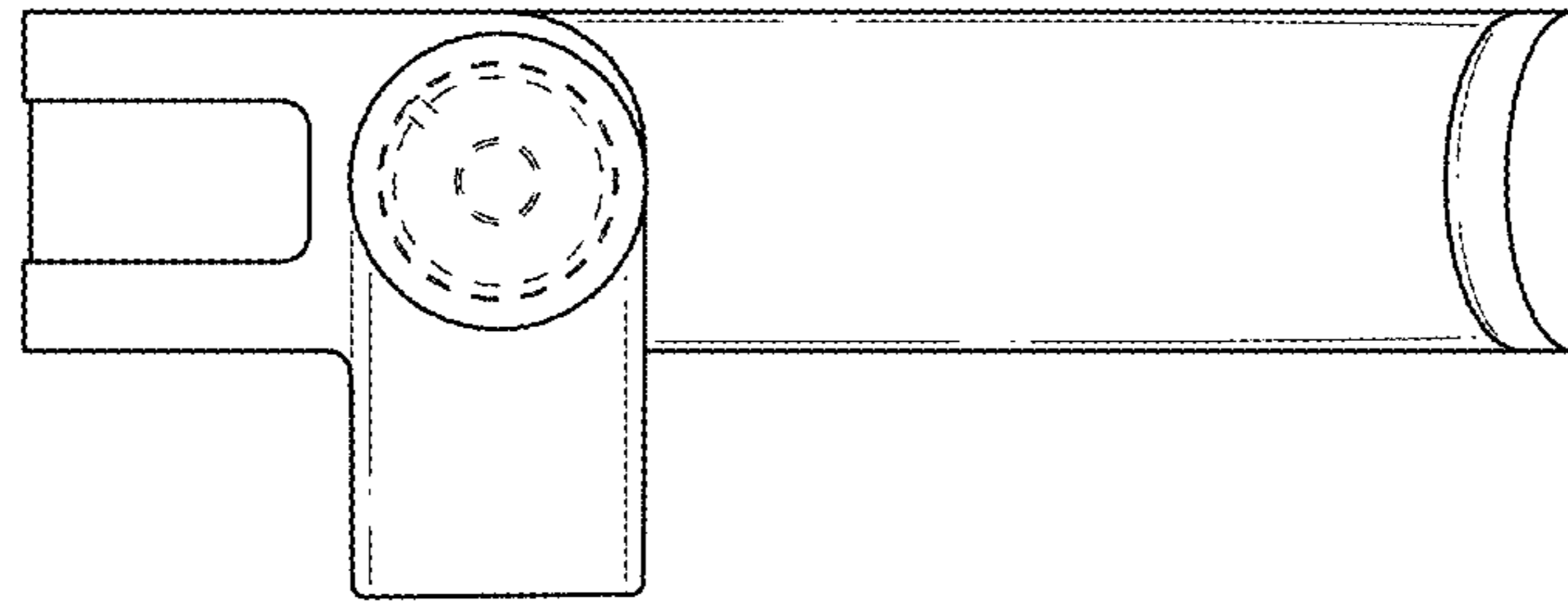

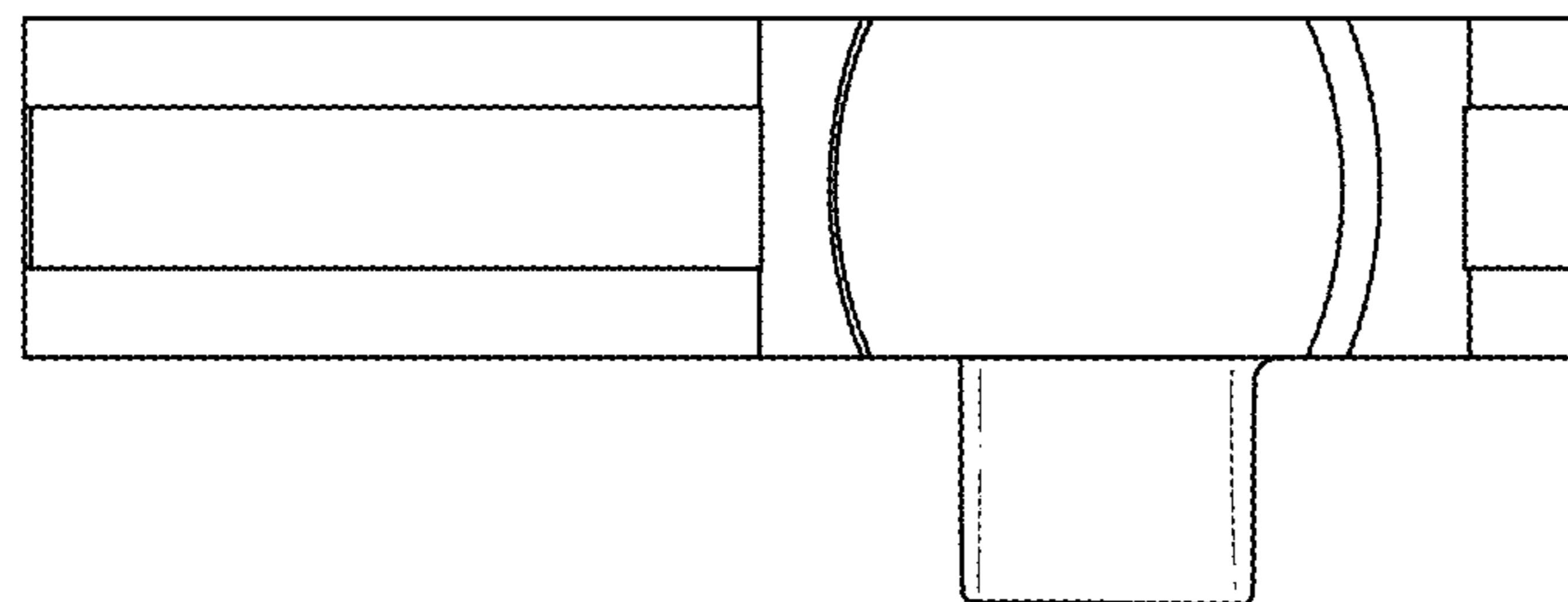
