(57) **CLAIM**

The ornamental design for a tool tip, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a tool tip of the present invention.

FIG. 2 is a front elevation view thereof, the rear elevation view thereof being disclaimed and not shown for that reason.

FIG. 3 is a right elevation view thereof, the left elevation view being a mirror image thereof; and,

FIG. 4 is a top plan view thereof, the bottom plan view being a mirror image thereof.

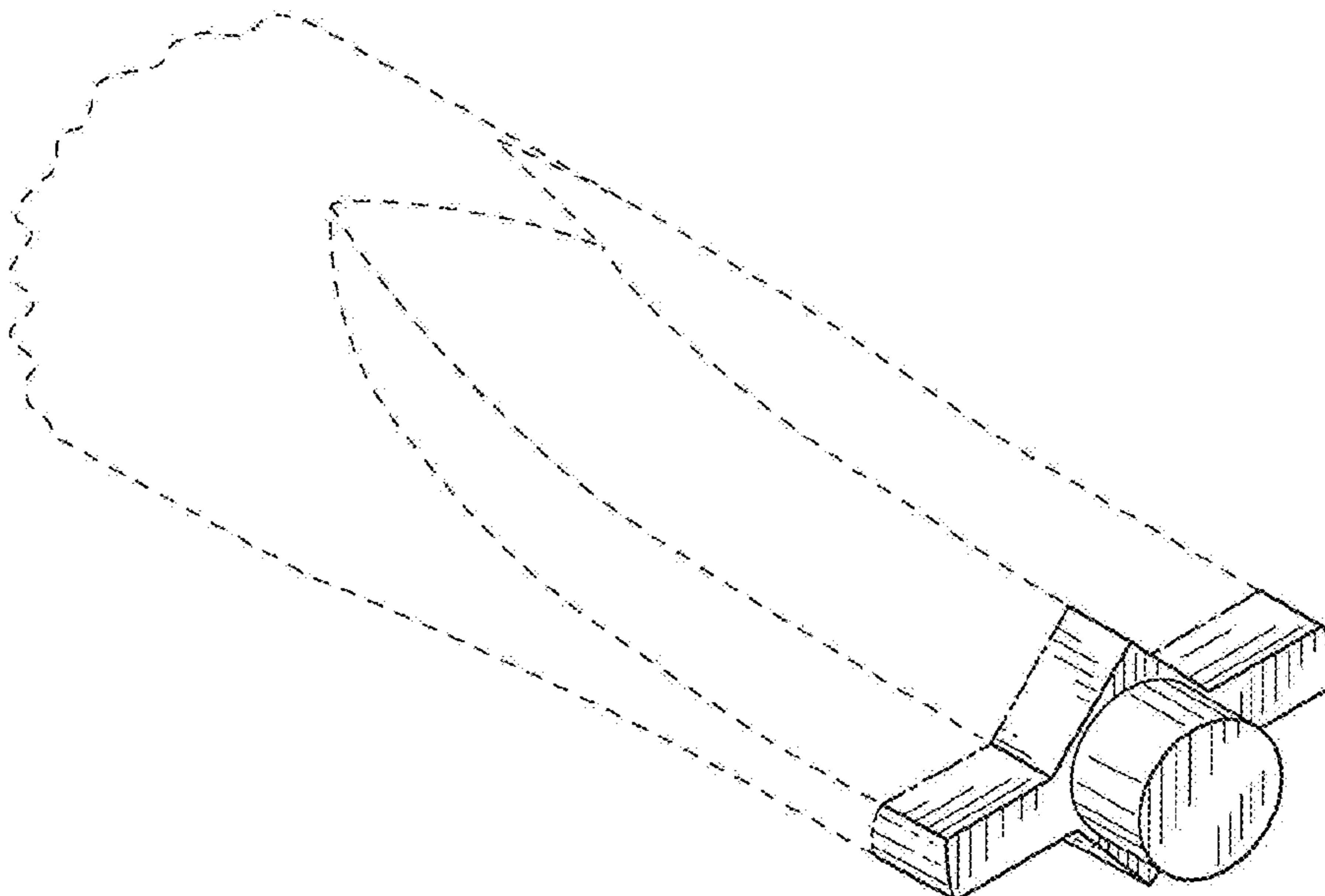

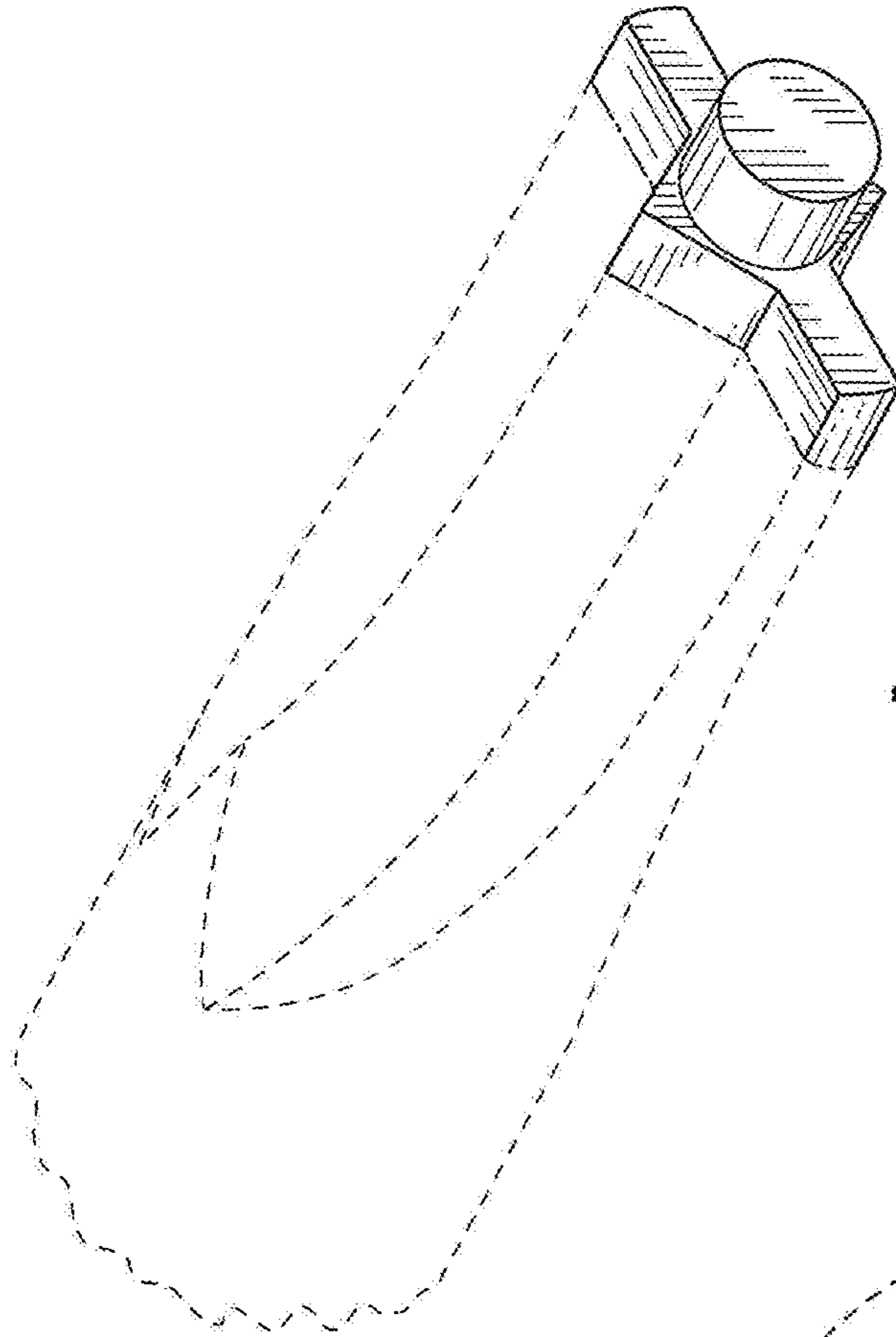

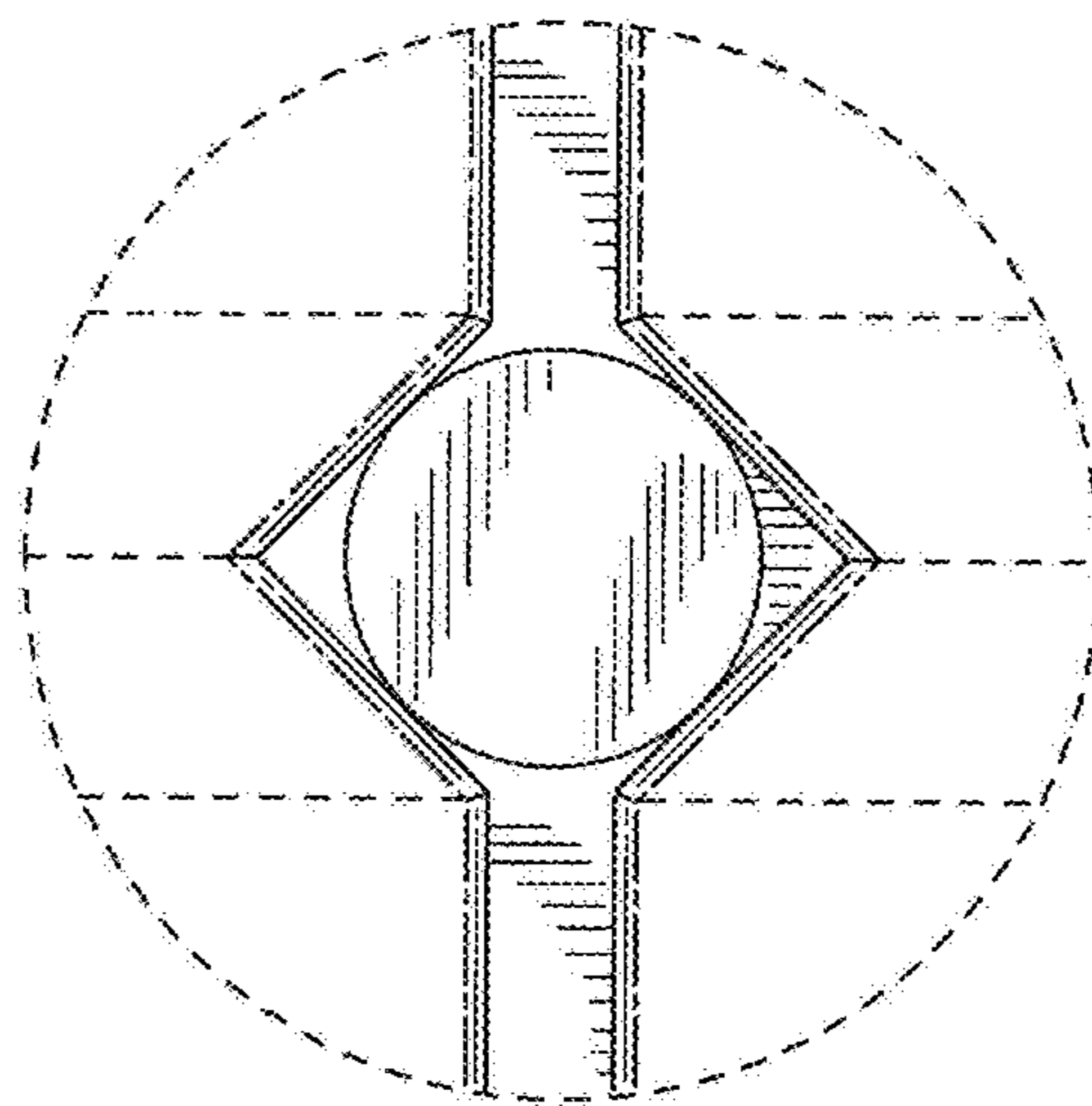

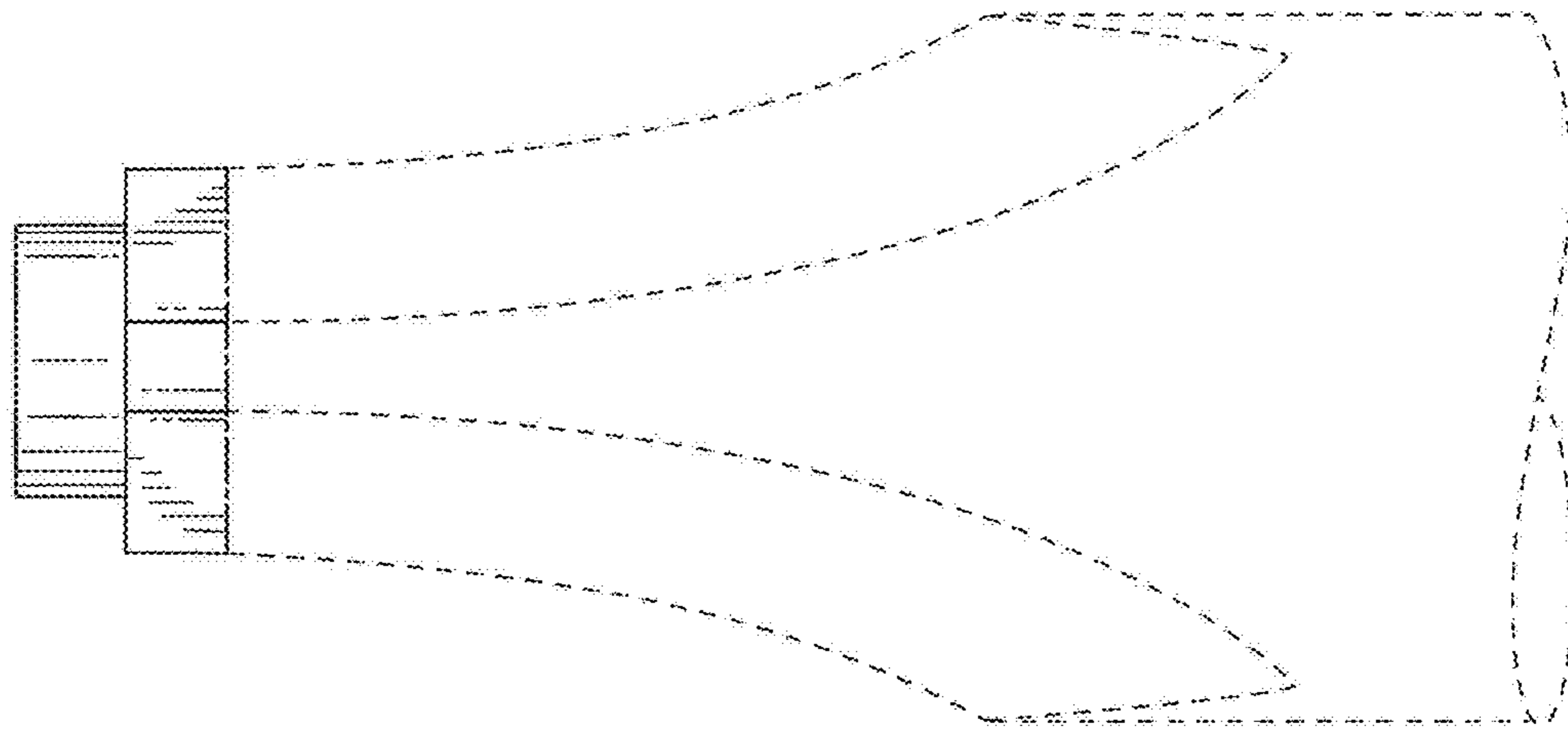

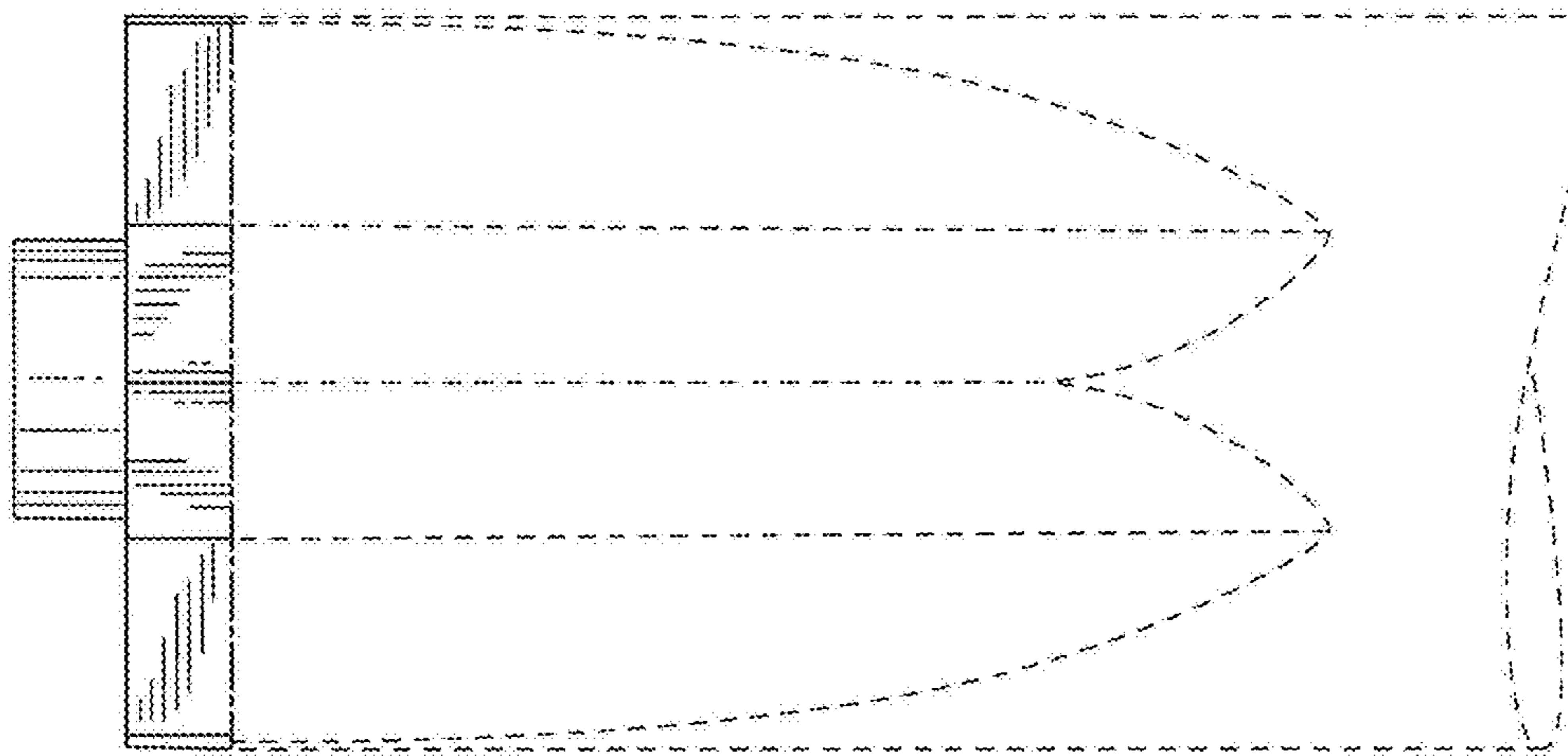
