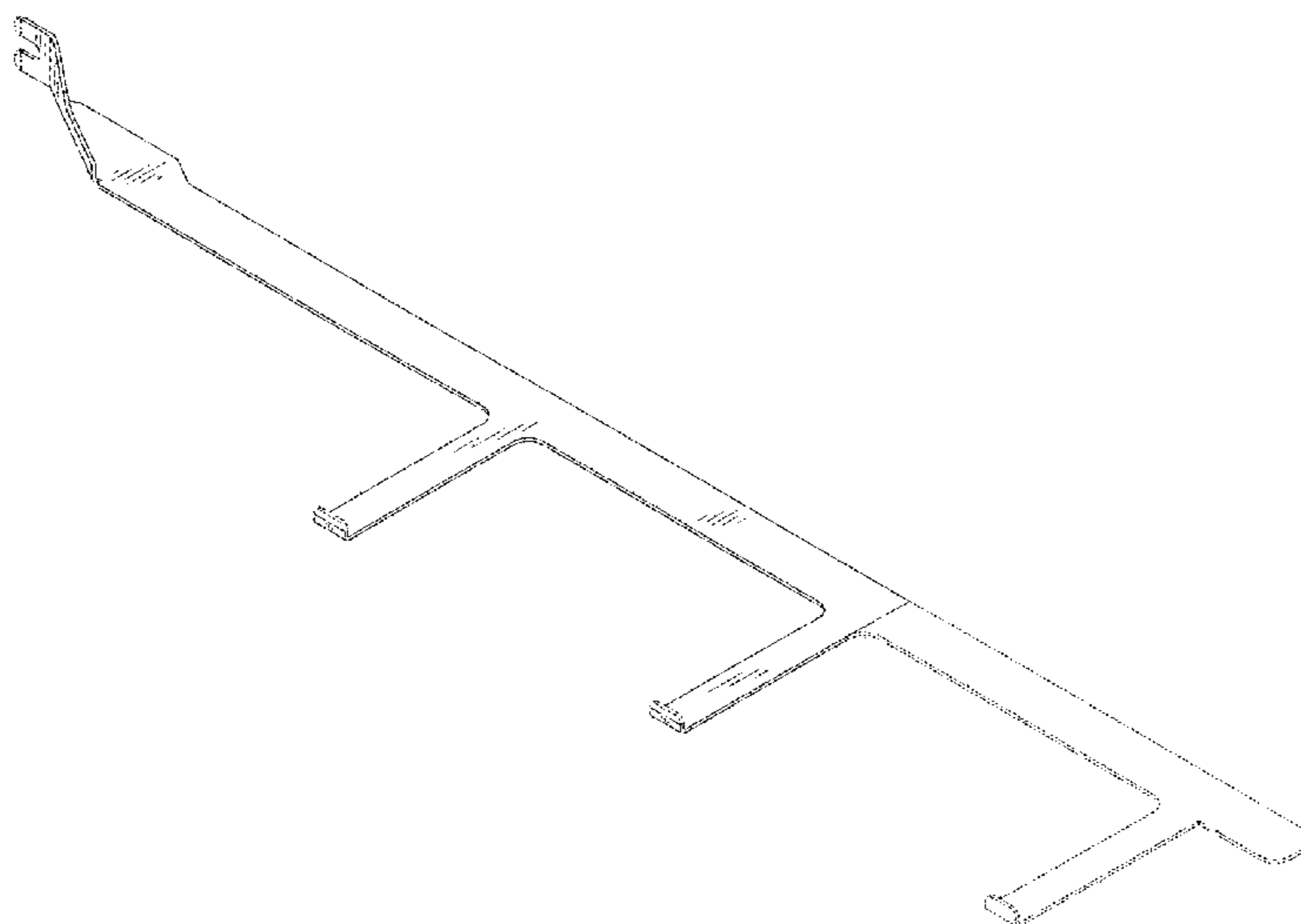
(57) **CLAIM**

The ornamental design for an optical fiber cable holder, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of an optical fiber cable holder showing our new design; FIG. 2 is a rear, bottom, and left side perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is an enlarged right side view thereof; FIG. 8 is an enlarged left side view thereof; FIG. 9 is an enlarged view of the portion indicated by line 9-9 in FIG. 3; FIG. 10 is an enlarged view of the portion indicated by line 10-10 in FIG. 3; FIG. 11 is an enlarged view of the portion indicated by line 11-11 in FIG. 3; and, FIG. 12 is a referential view showing the article in use. The features shown in broken lines in the drawings depict environmental subject matter only and form no part of the claimed design. The dash-dotted lines denote the boundary of the claim and form no part of the claimed design.

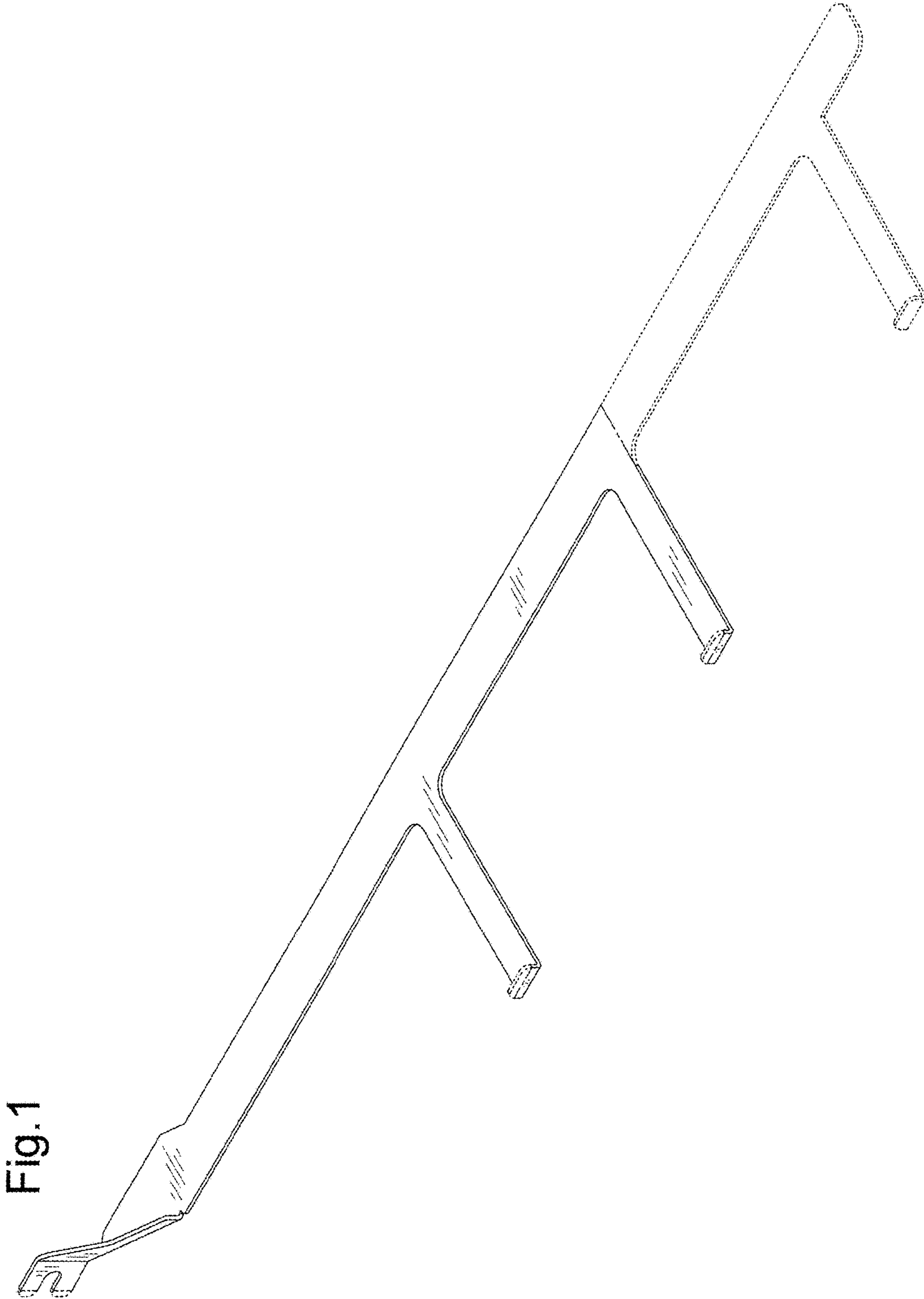

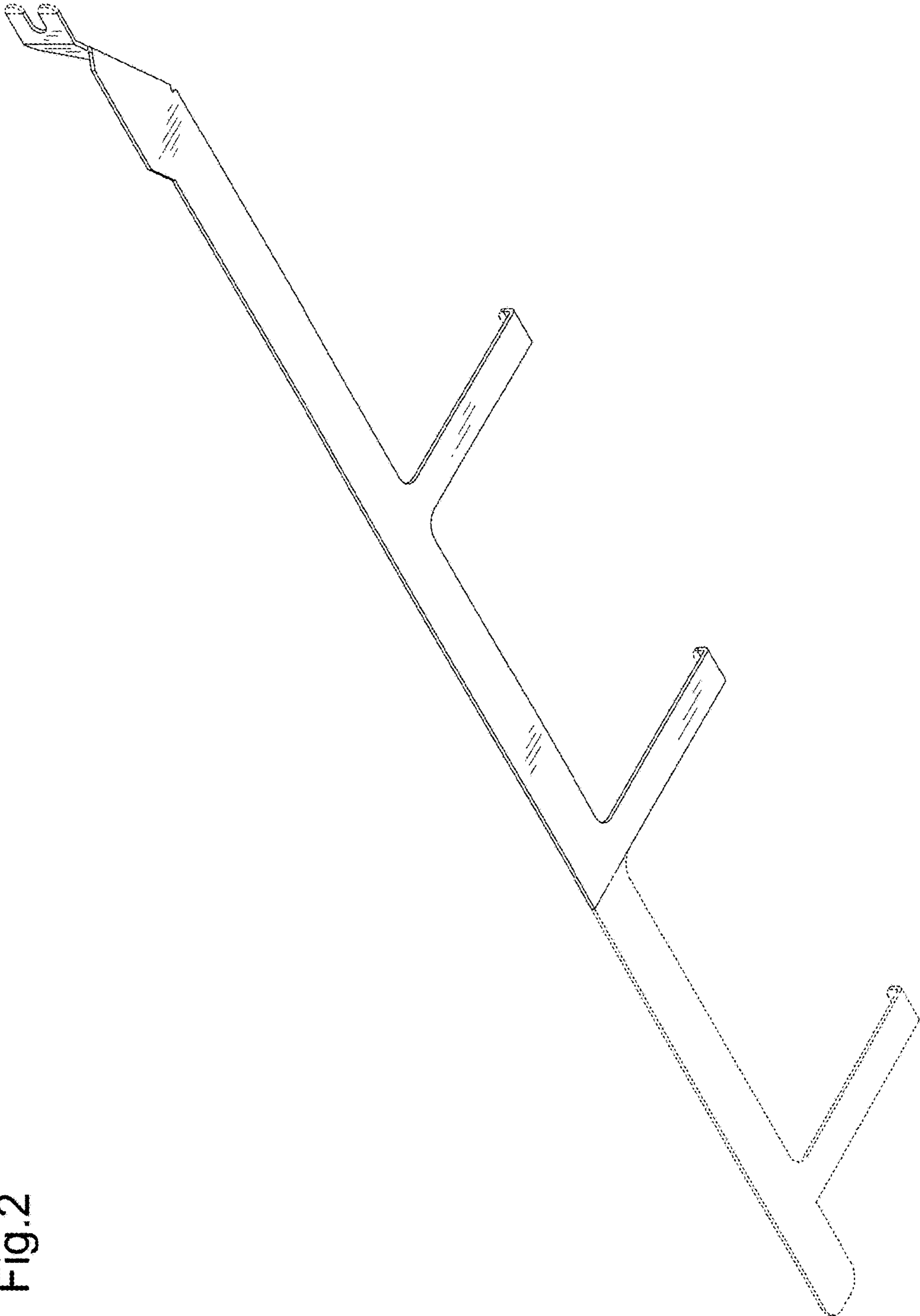

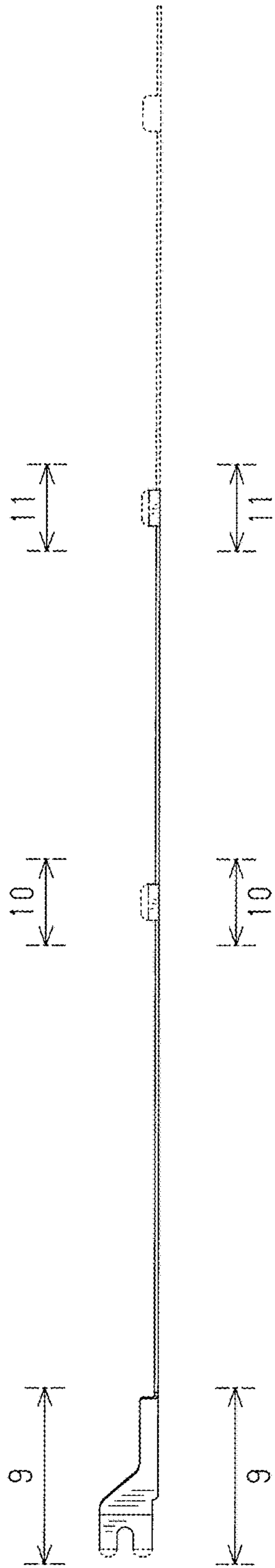

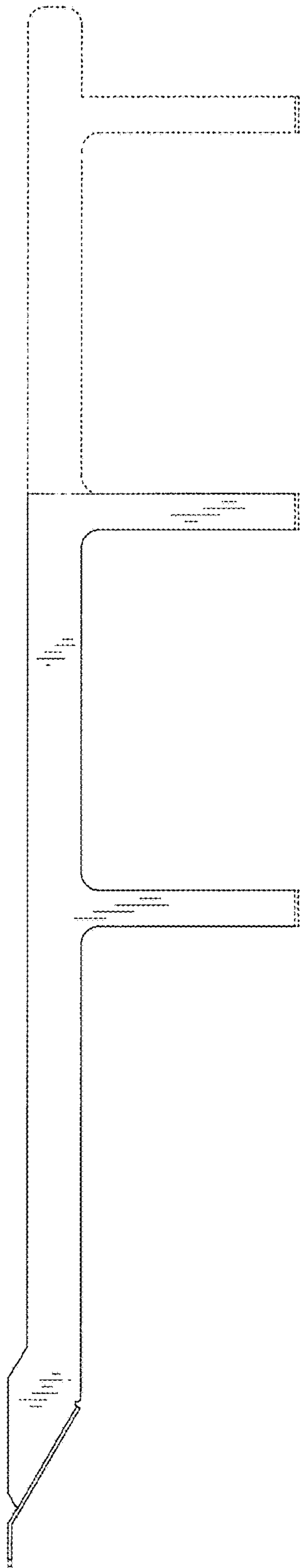

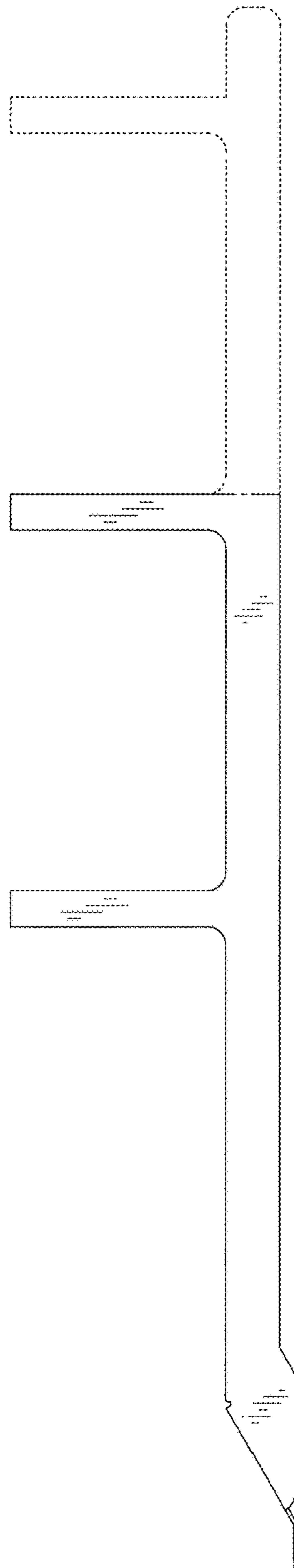

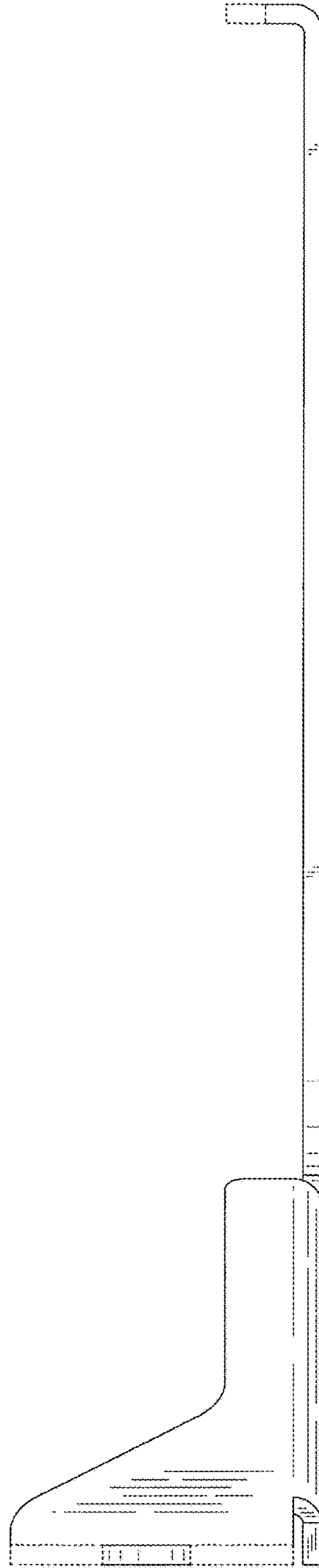
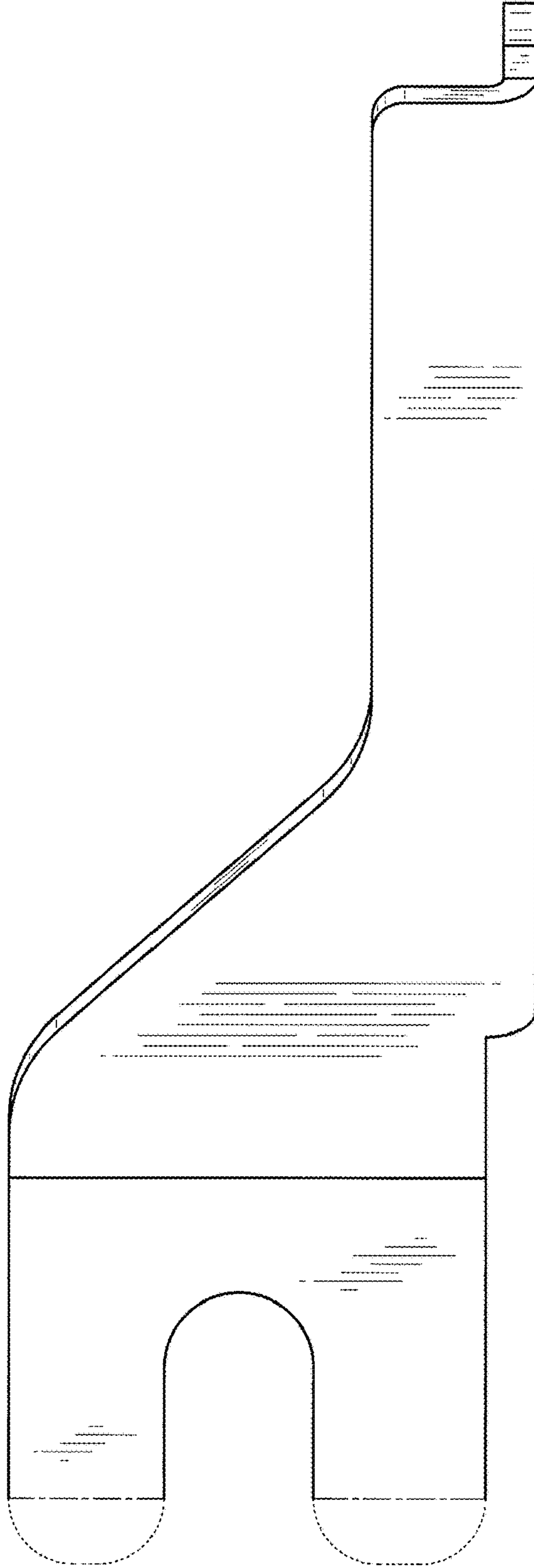

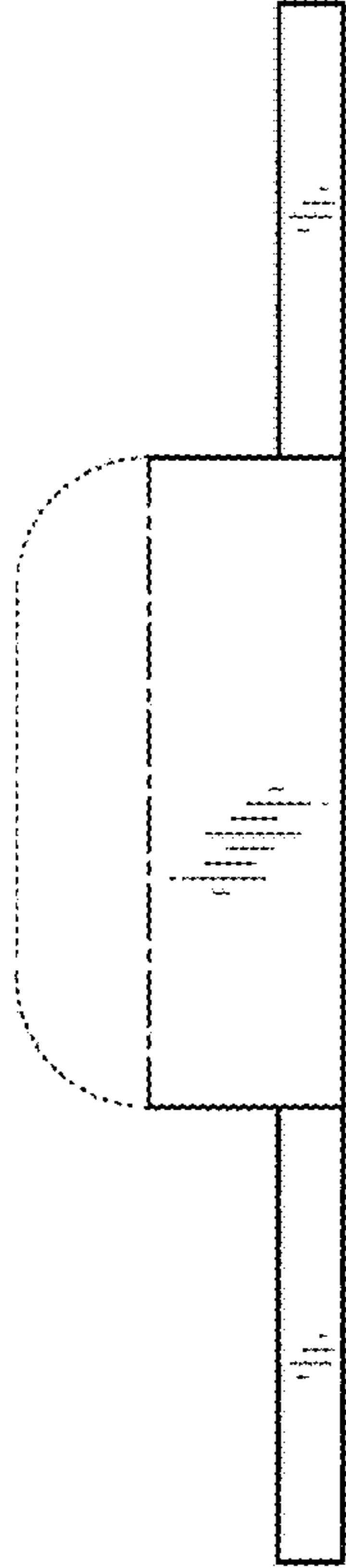

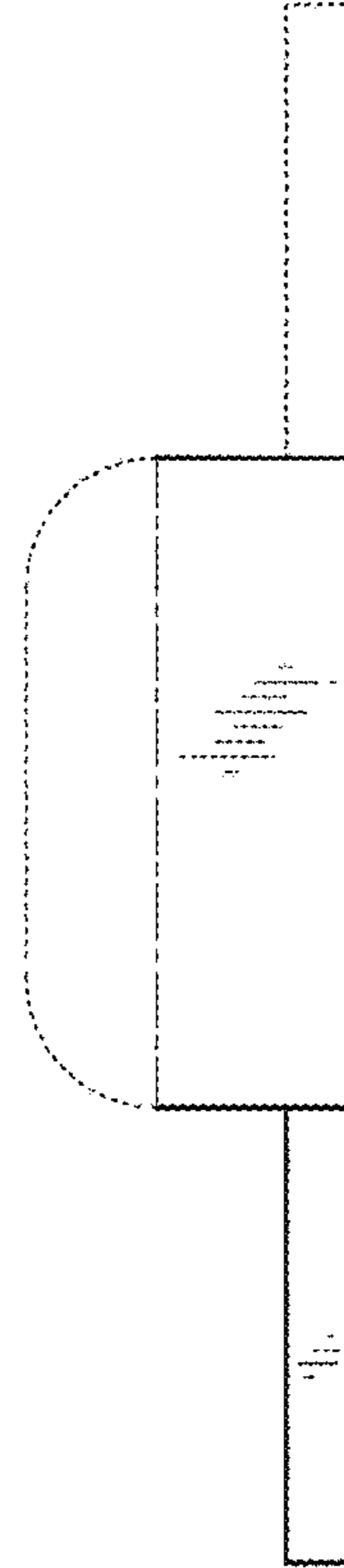

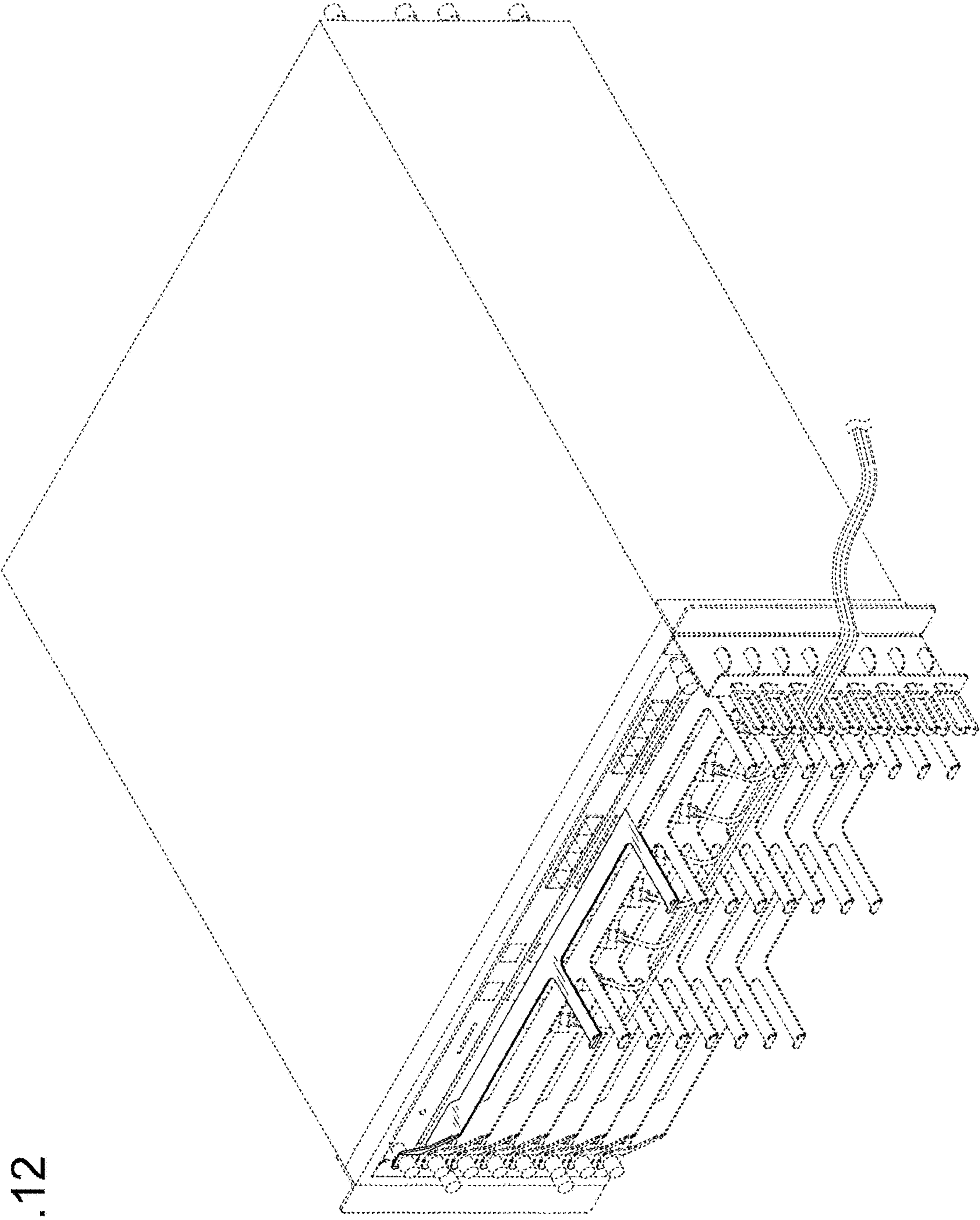
