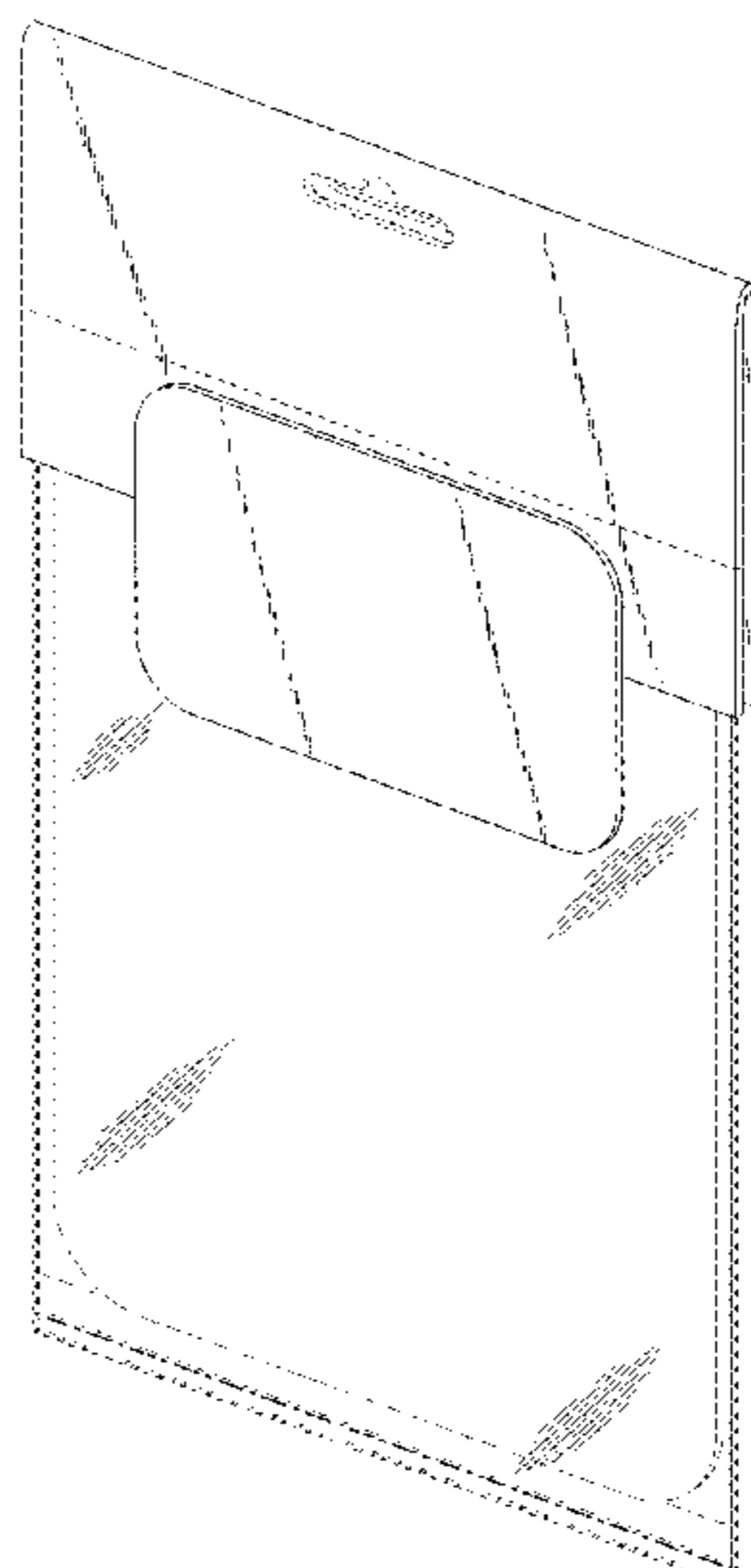
The ornamental design for a packaged transaction card

DESCRIPTION

FIG. 1 is a top and front perspective view of a packaged
transaction card product showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;

a mirror image of the right side view;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

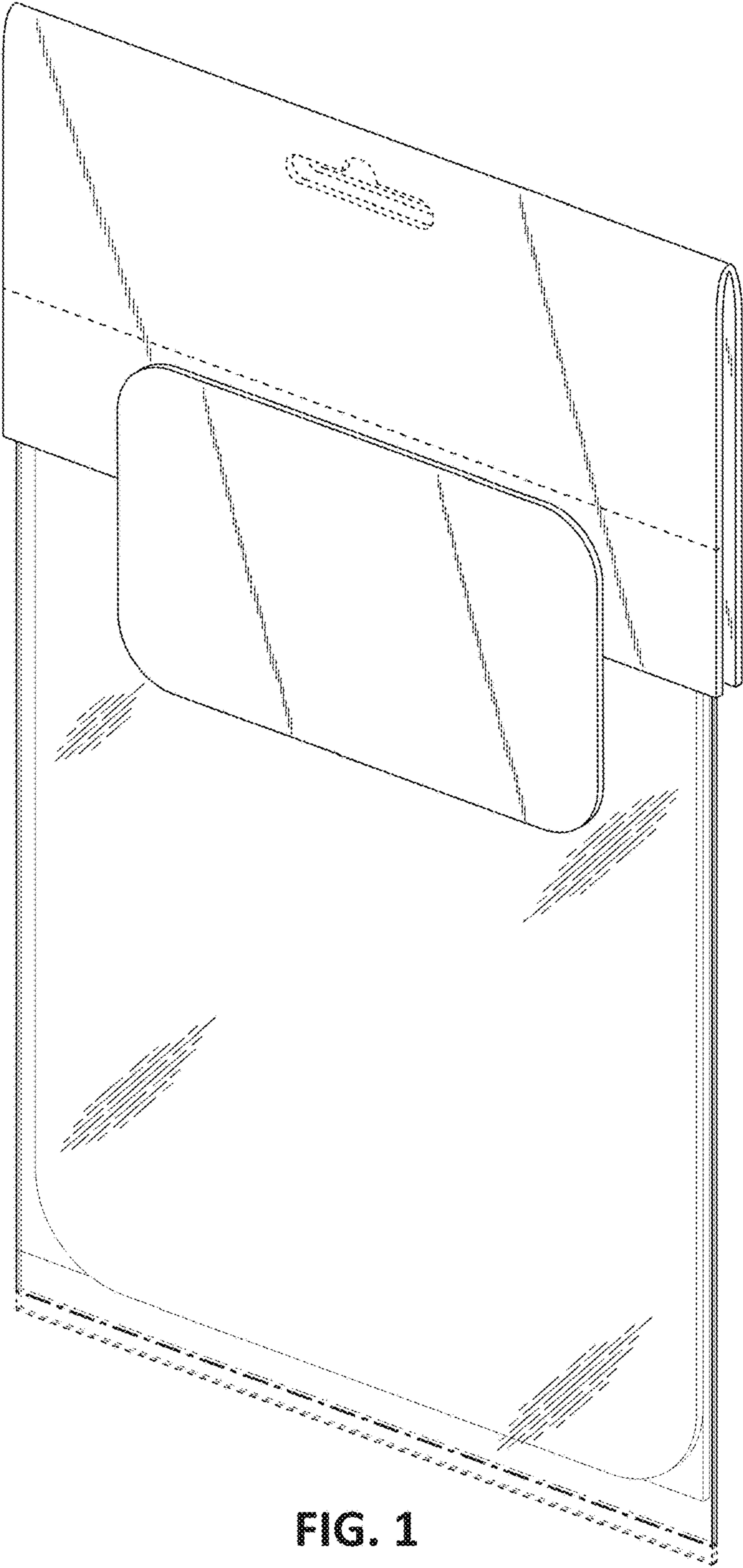

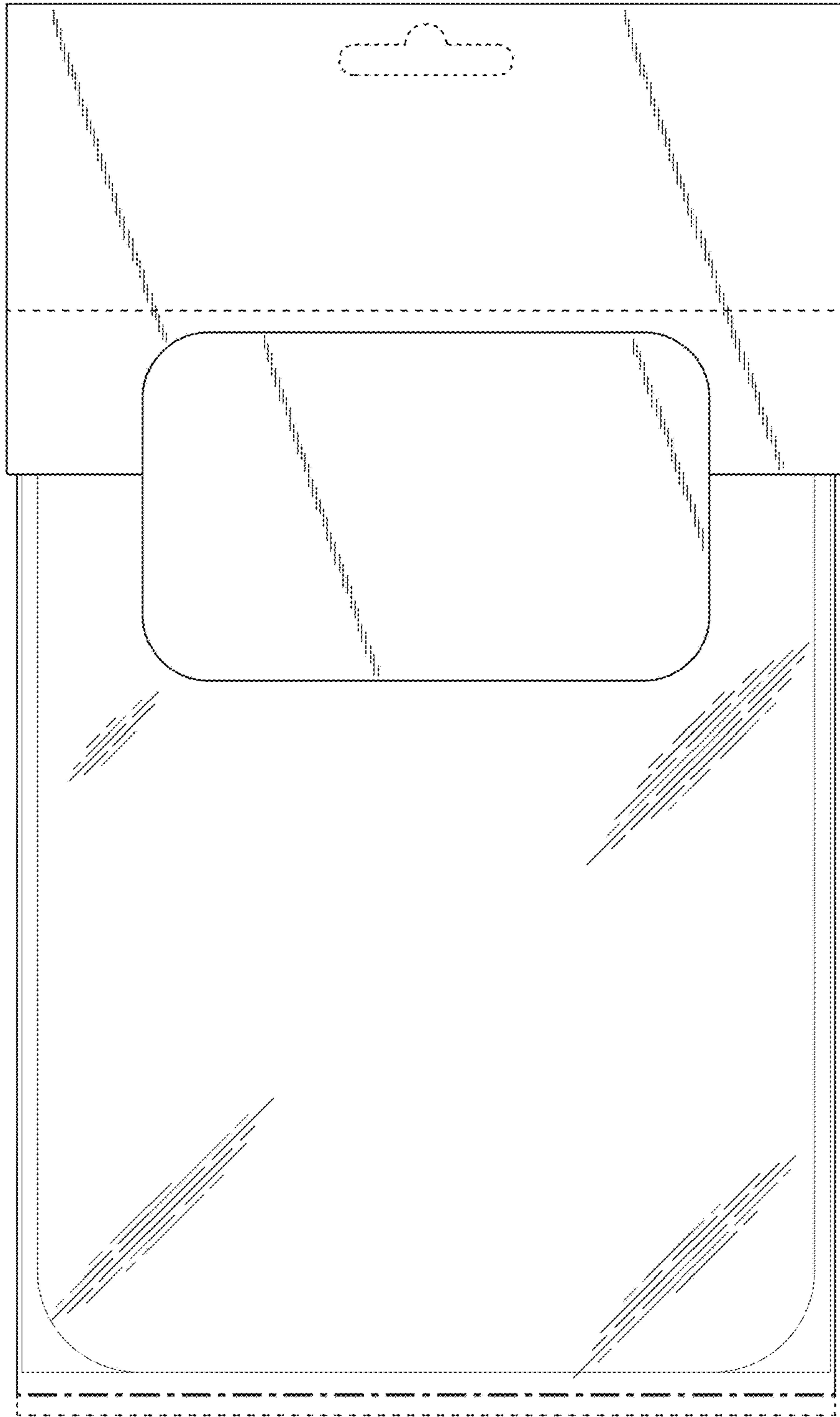

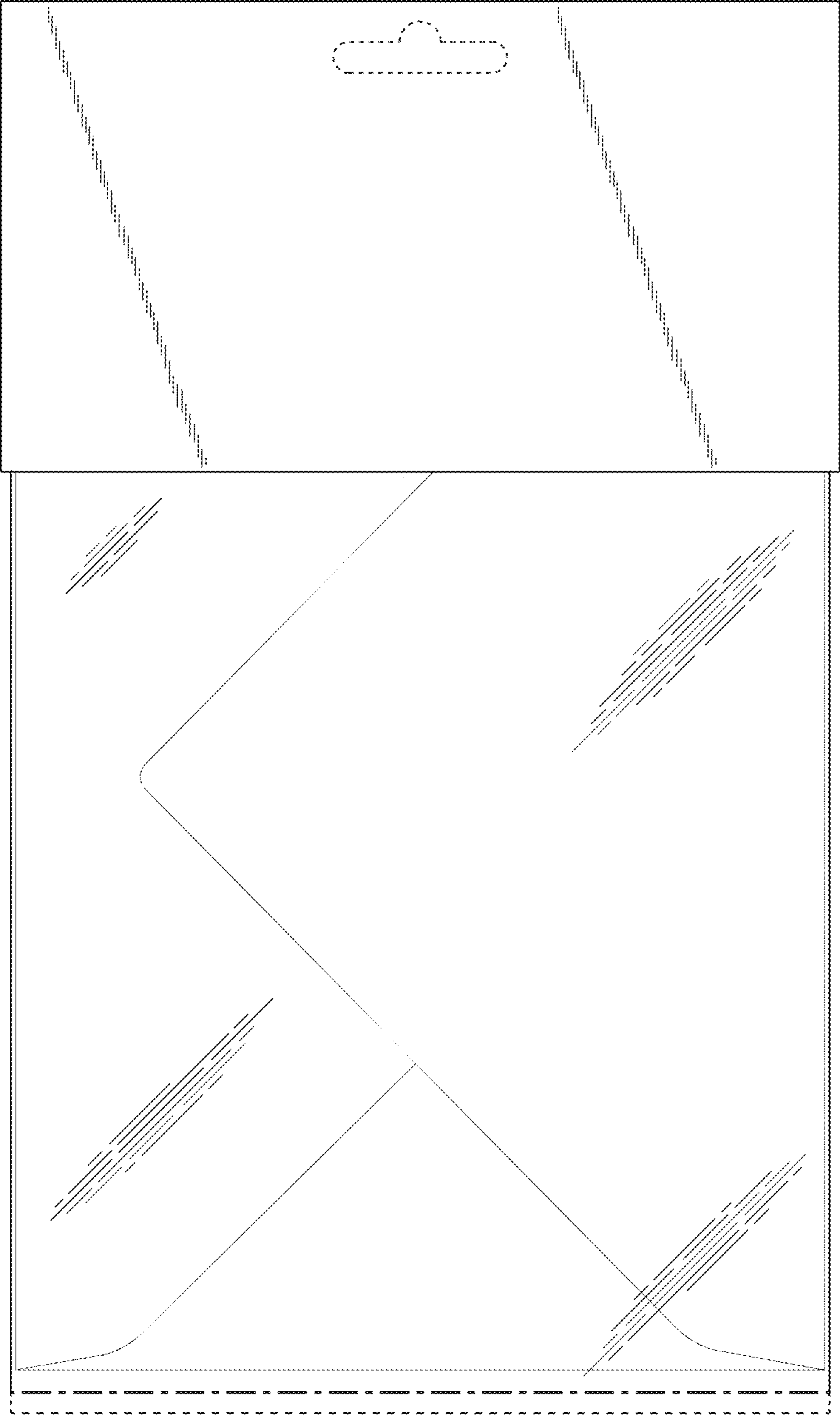

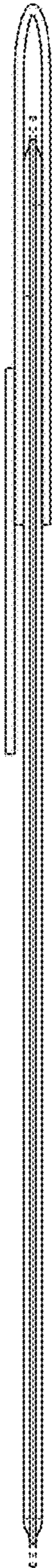

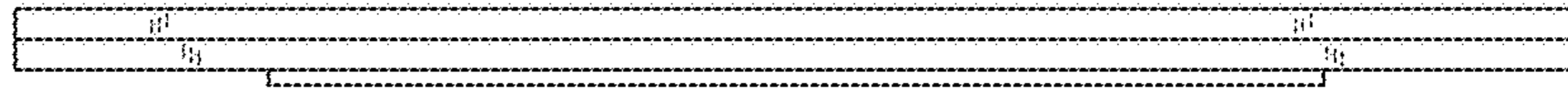

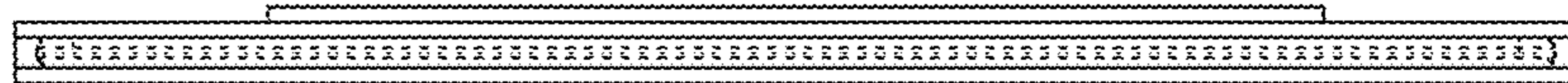
