1.1 : Right

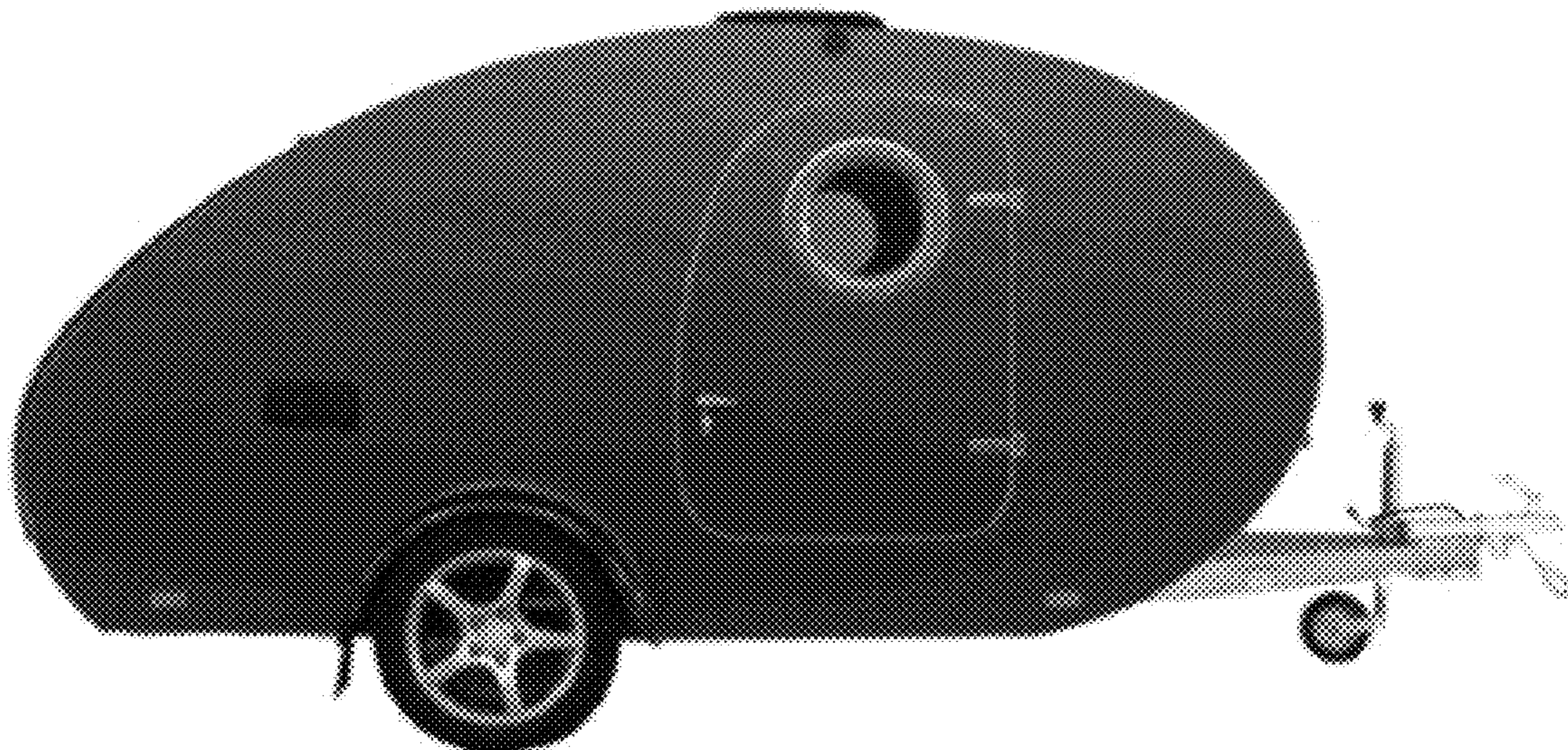
1.2 : Left rear perspective, showing the design in an open configuration

1.3 : Front

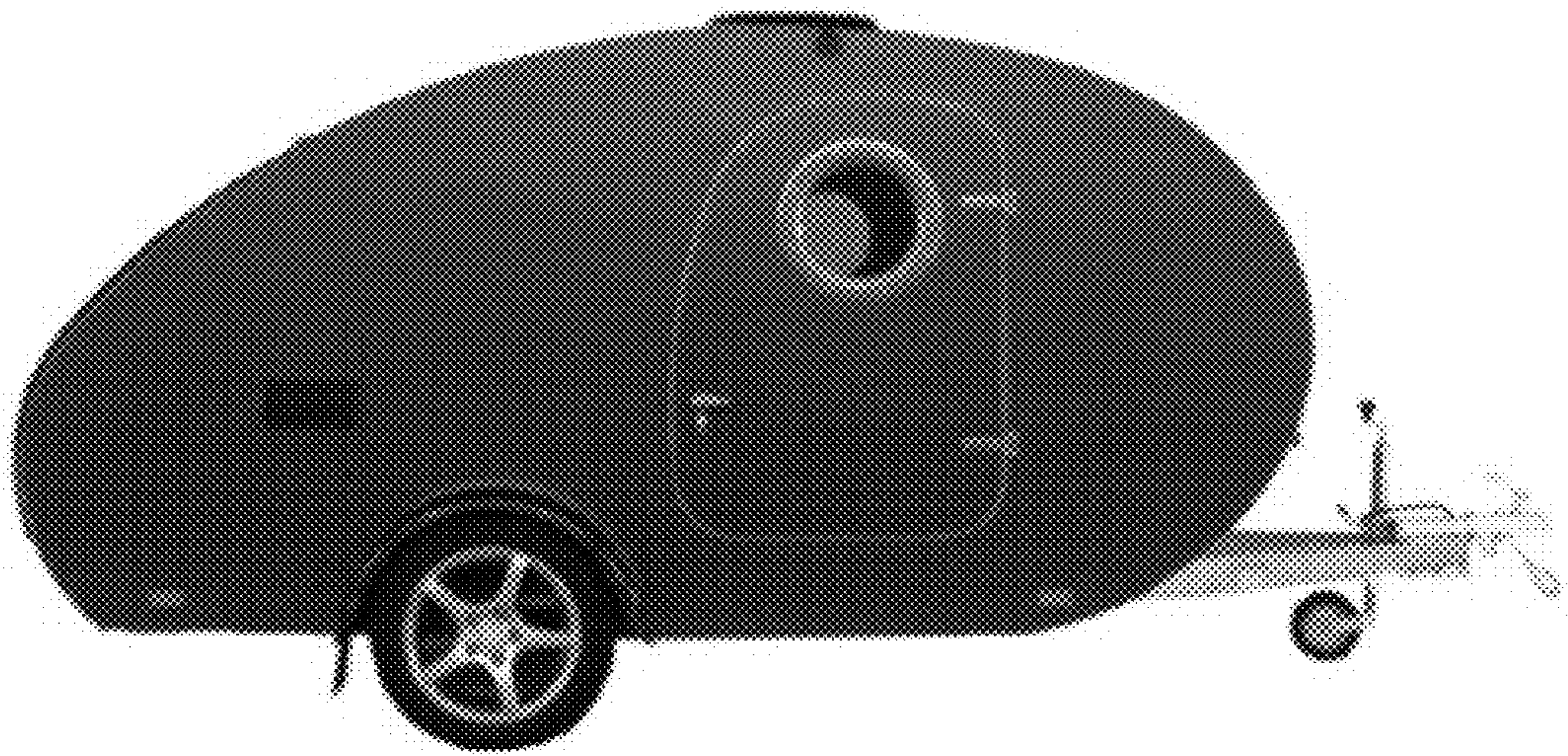
1.4 : Rear
