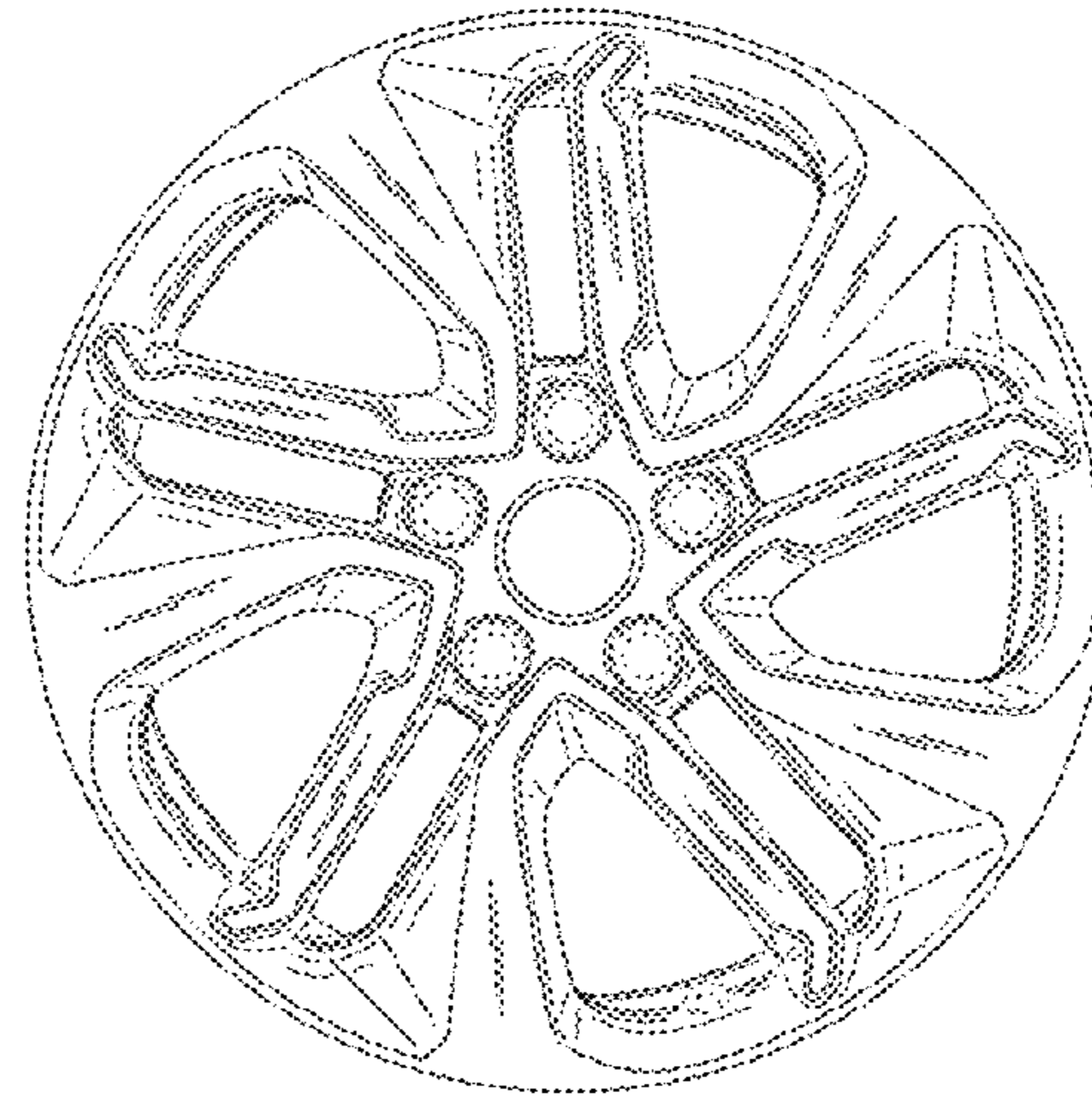
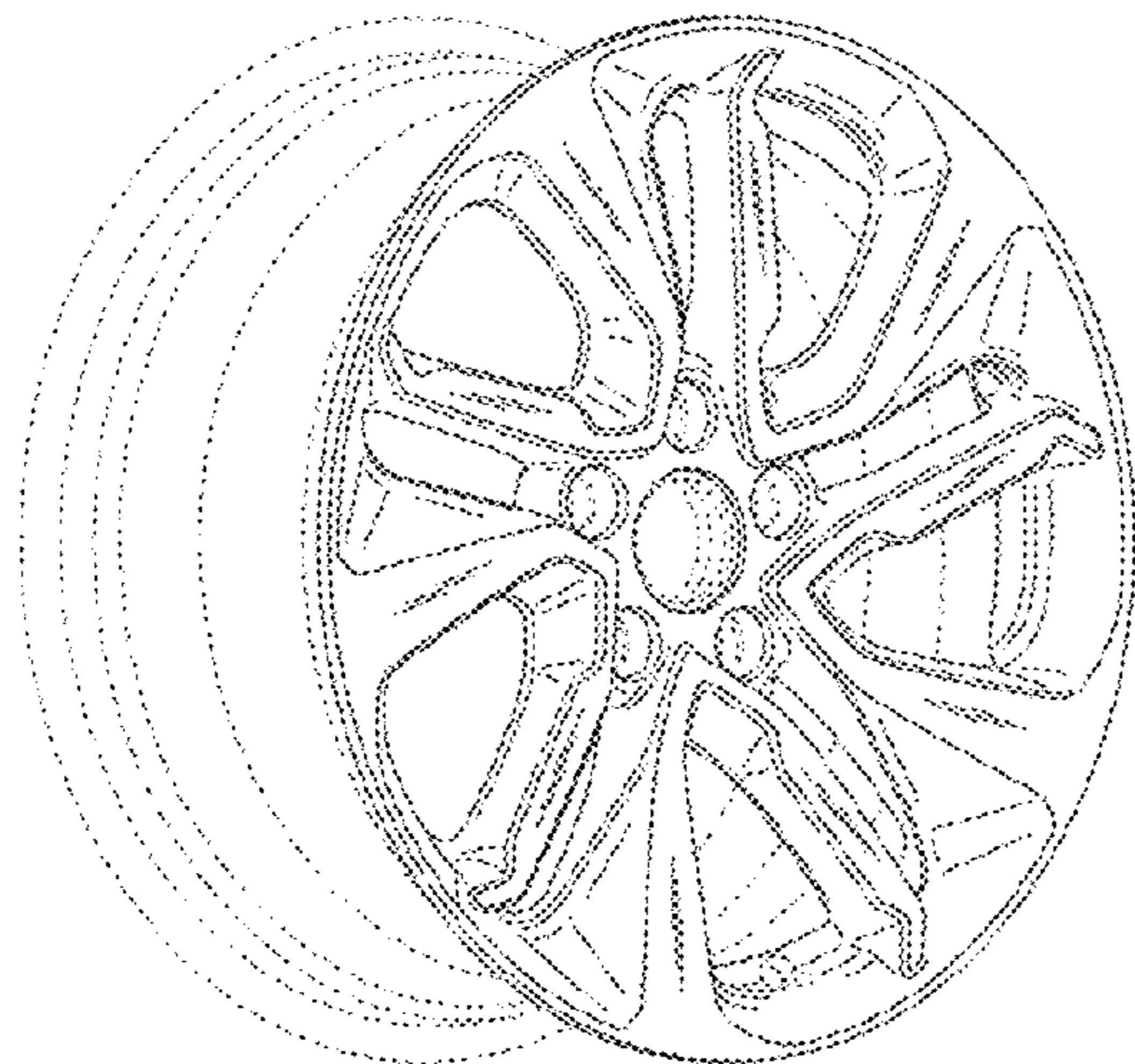
(57) **CLAIM**

The ornamental design for a wheel for an automobile, as shown and described herein.

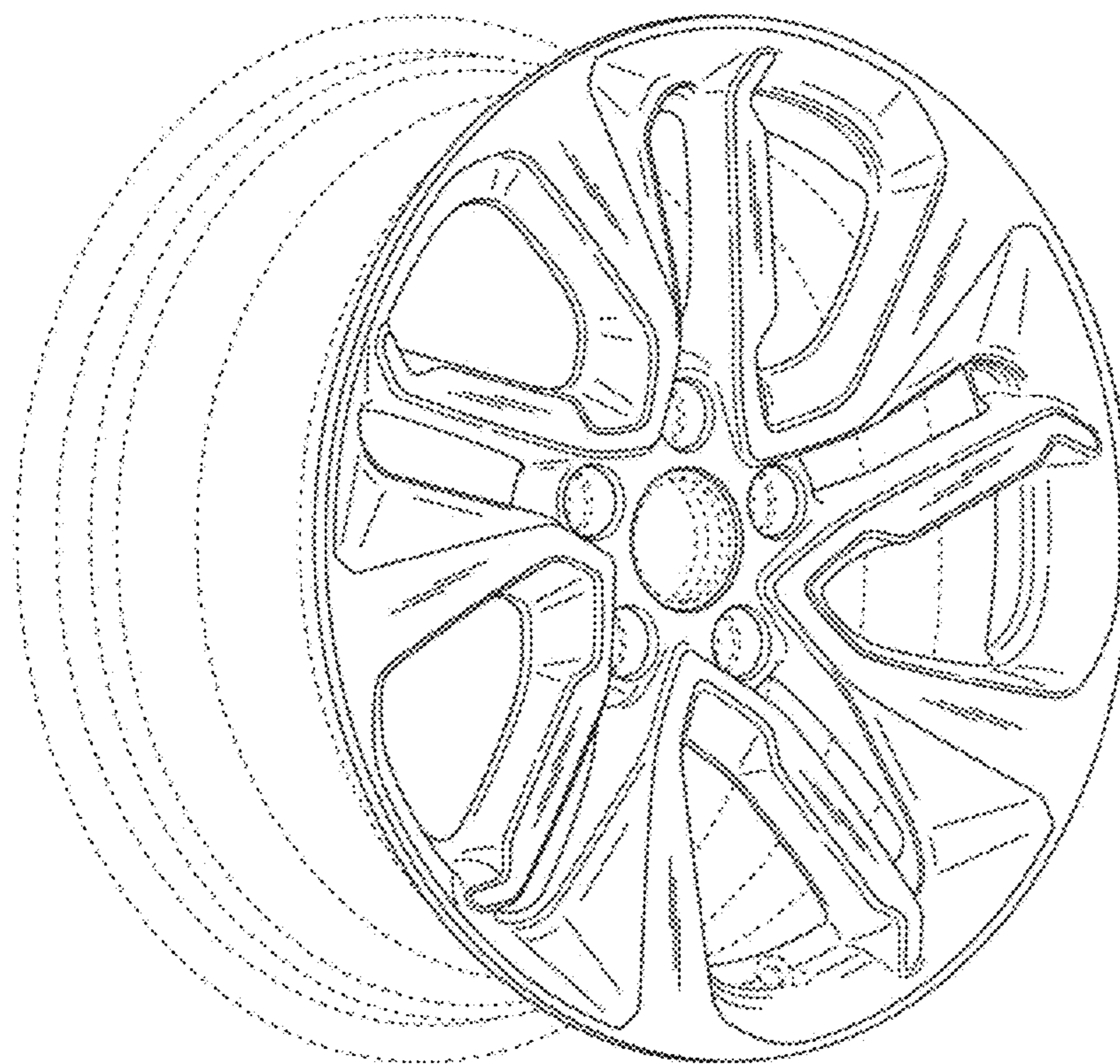

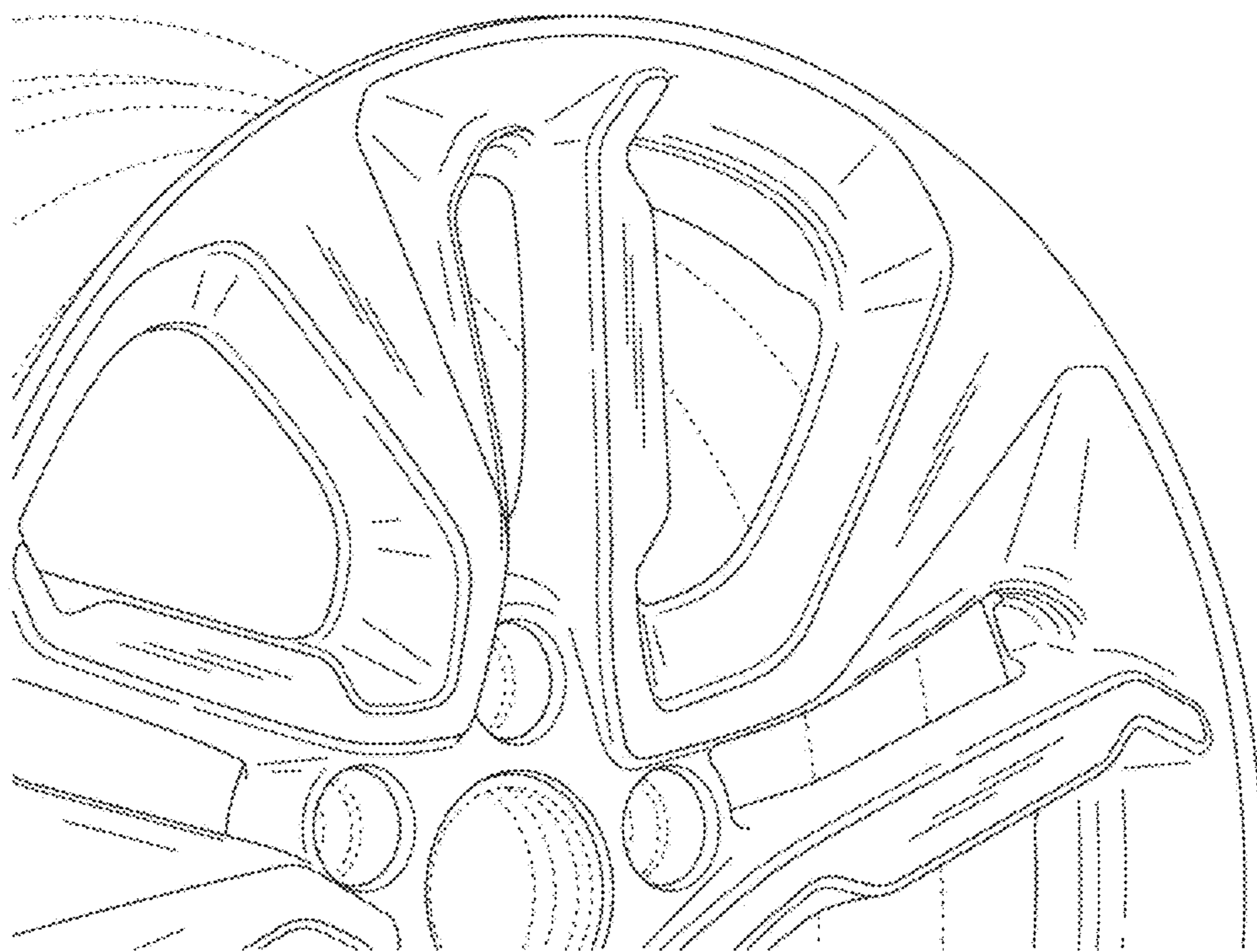
