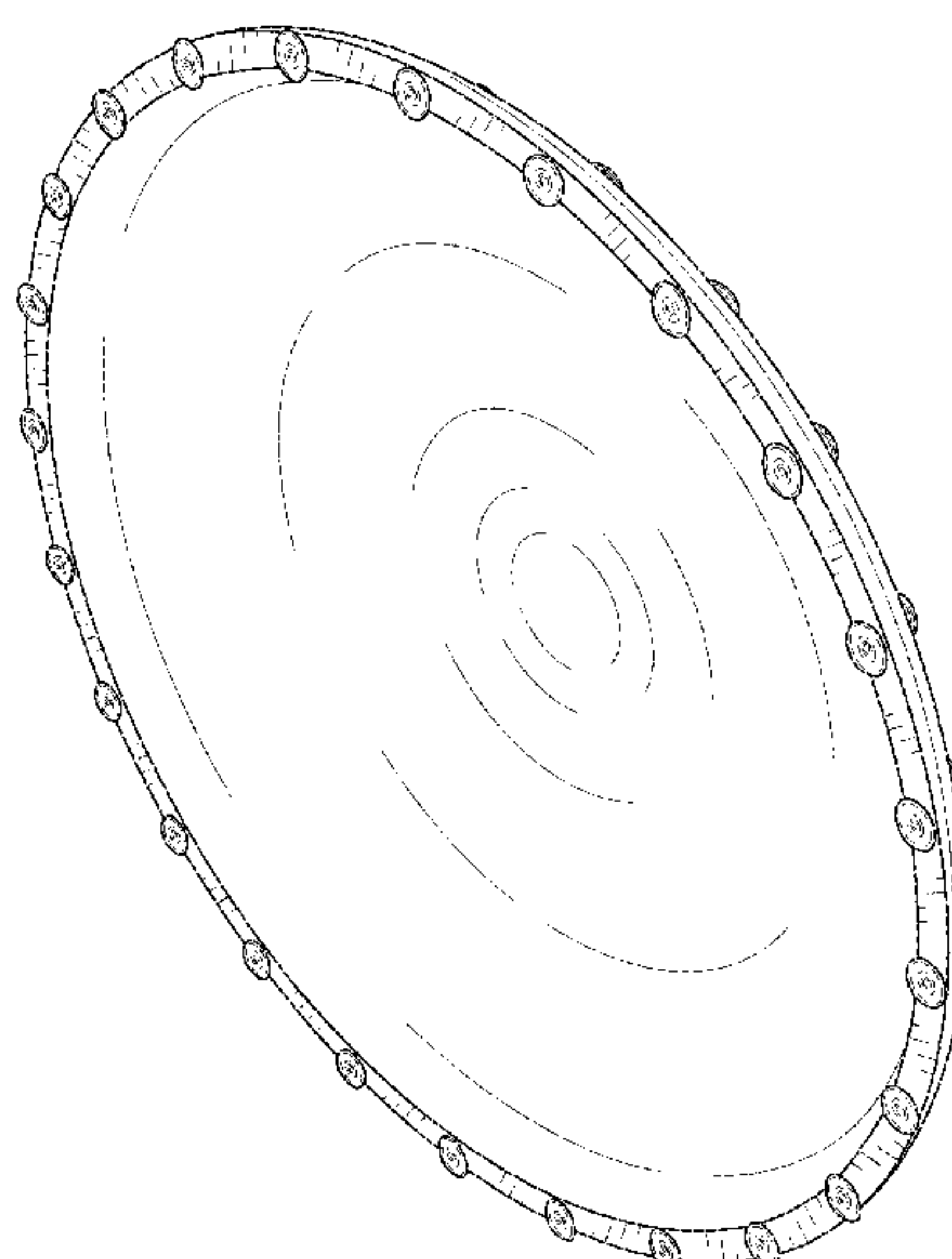
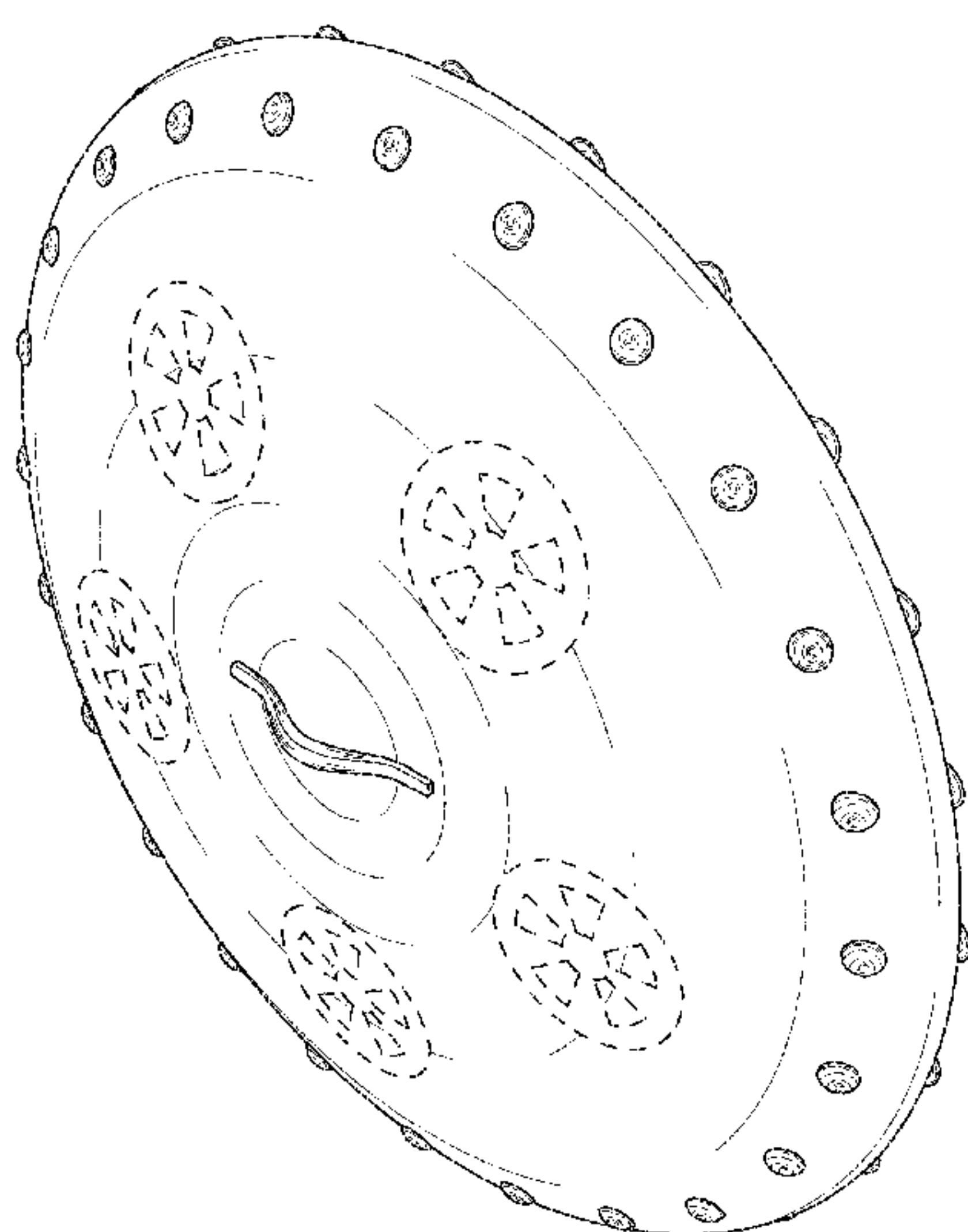
(57) **CLAIM**

The ornamental design for a spray shield, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top front right view of the spray shield, showing my new design;
FIG. 2 is a perspective top rear left view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a right elevation view thereof;
FIG. 6 is a left elevation view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

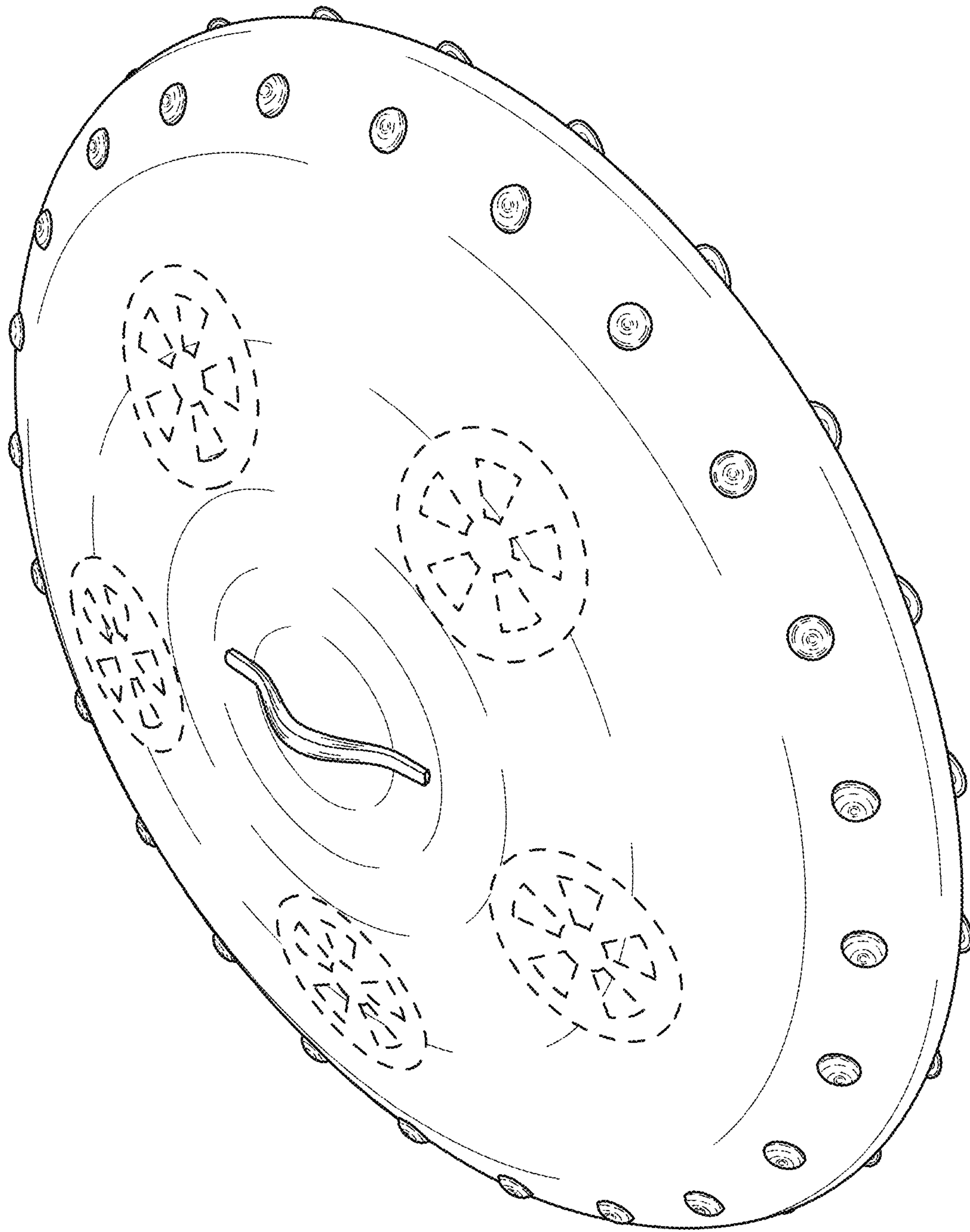

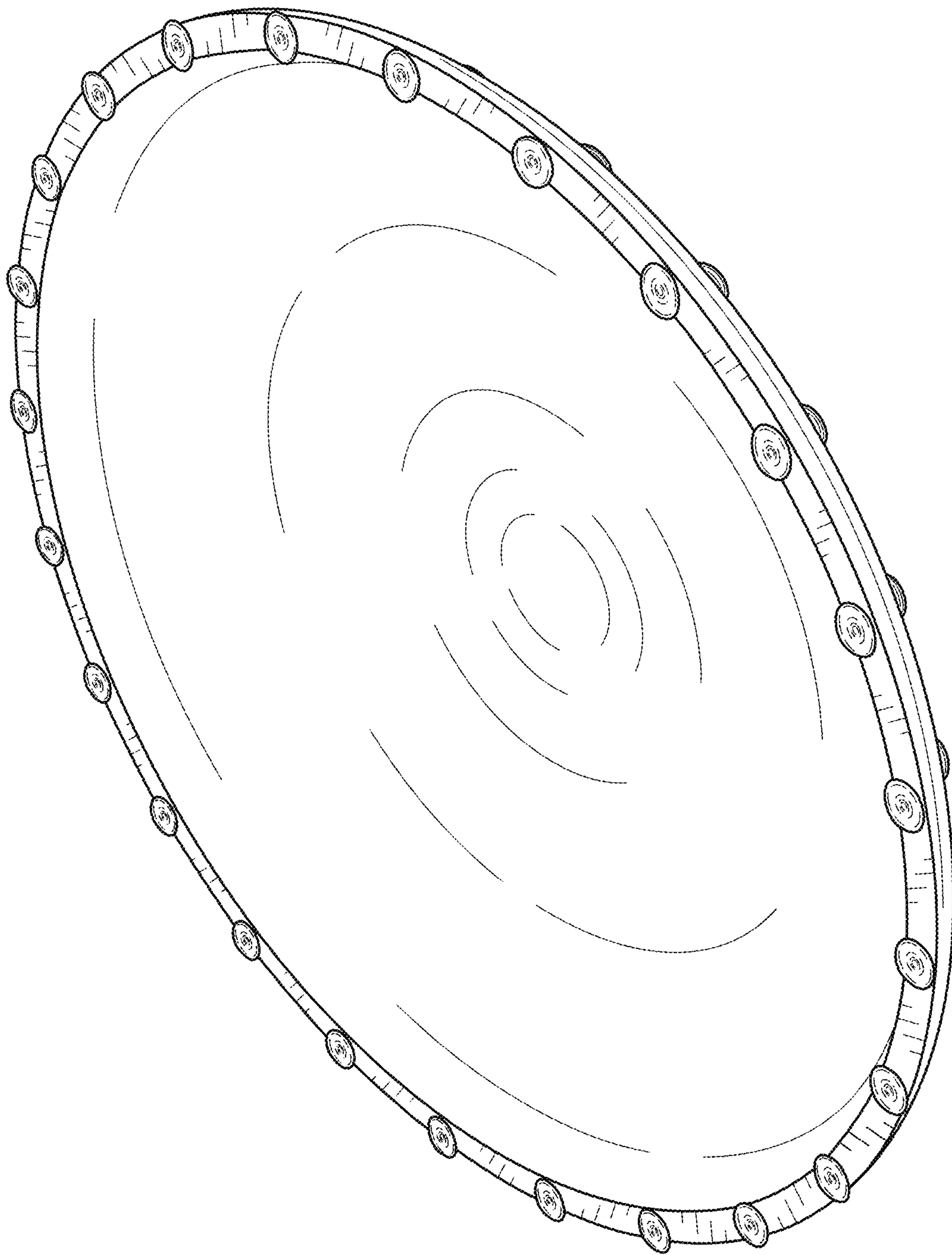

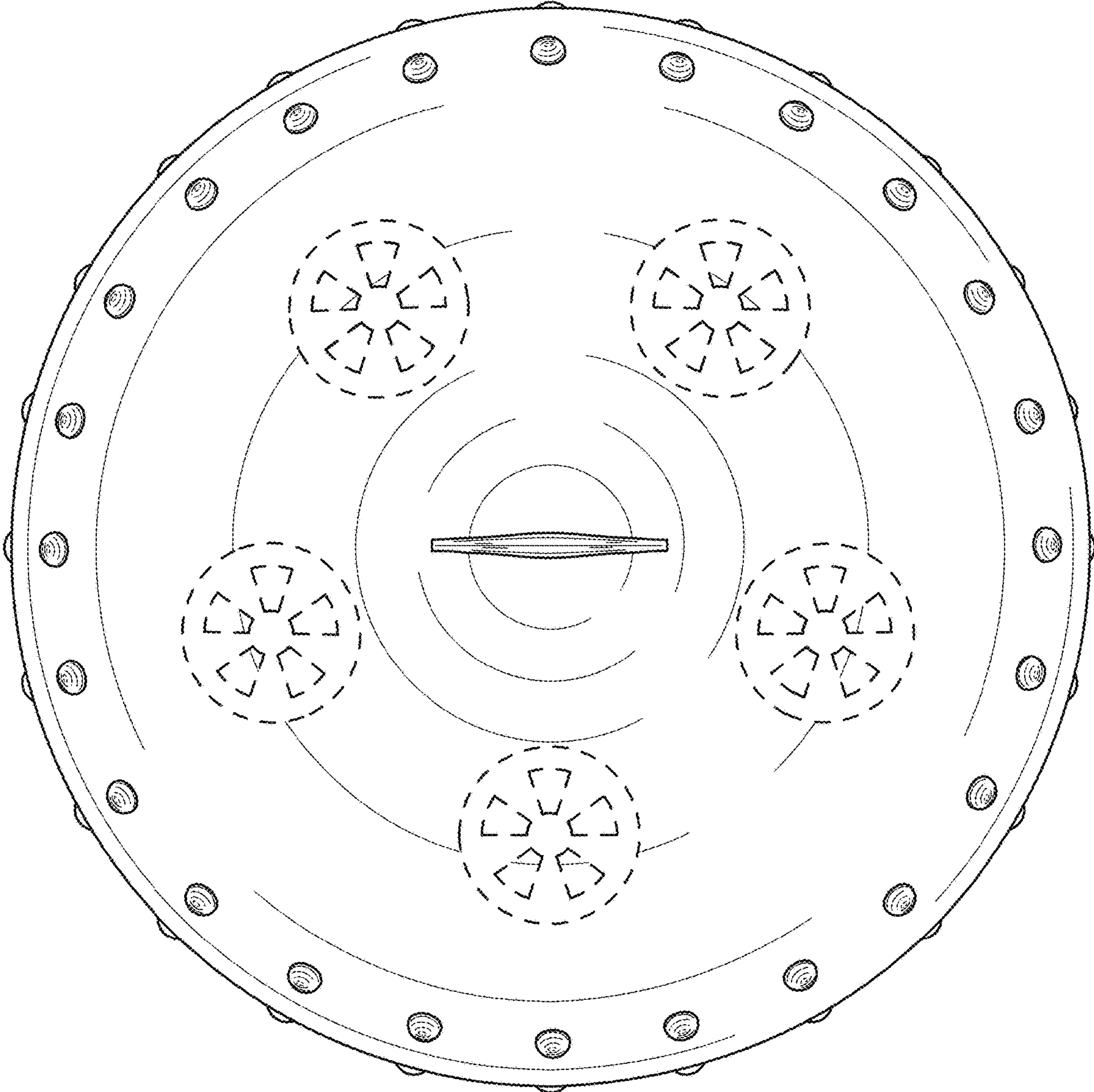

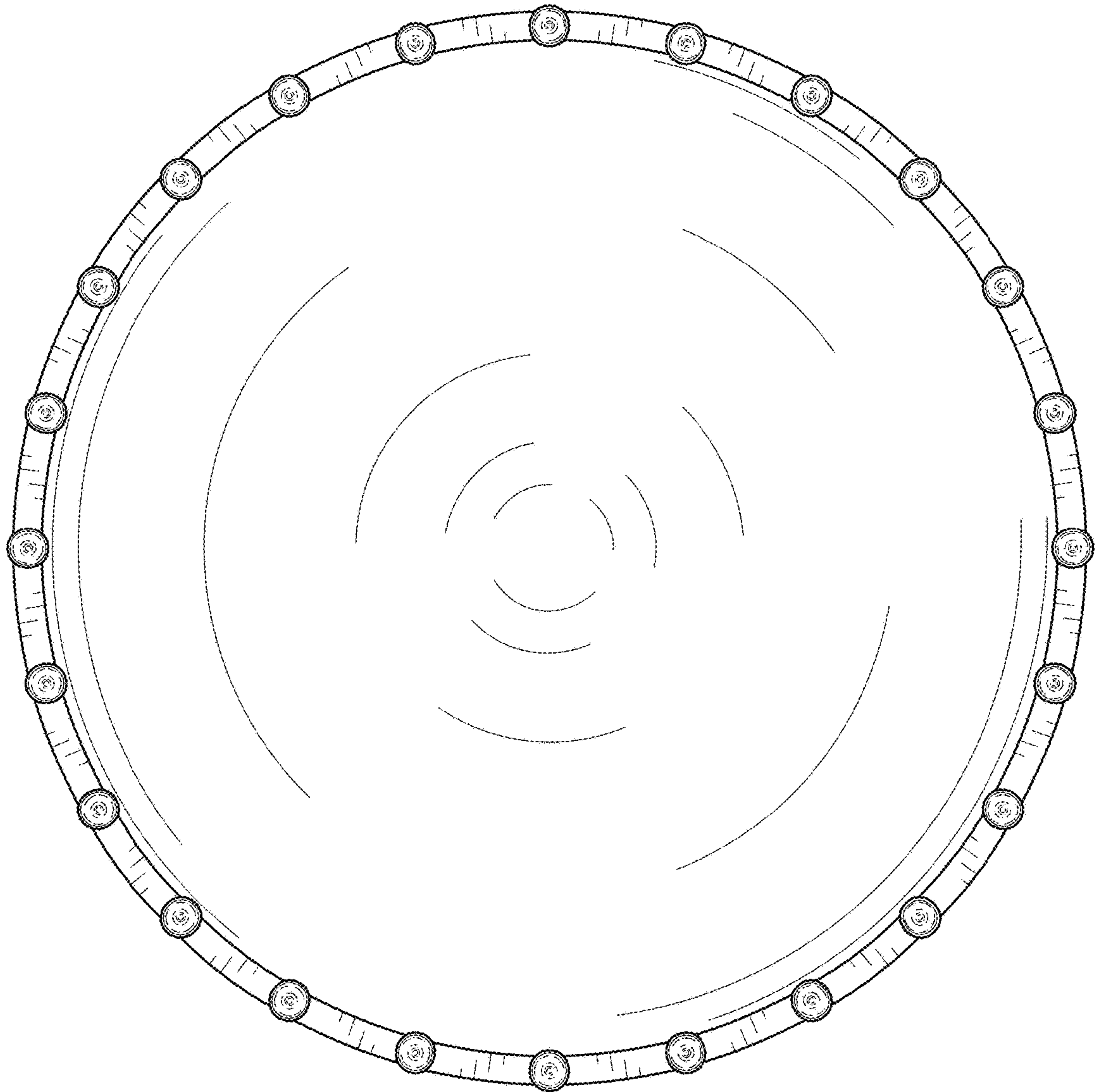

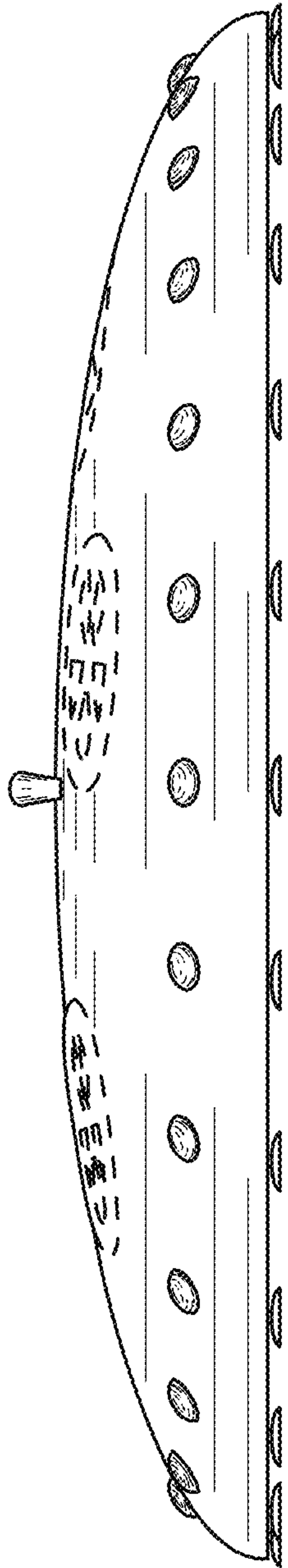

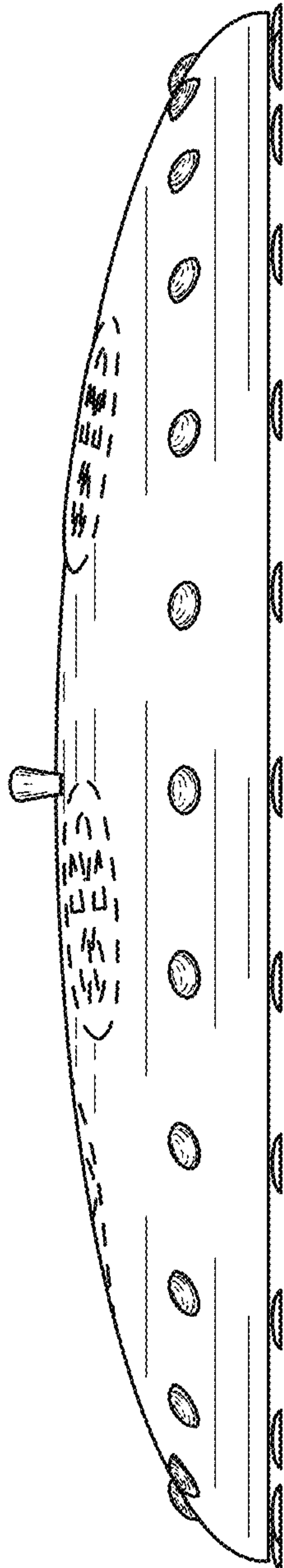

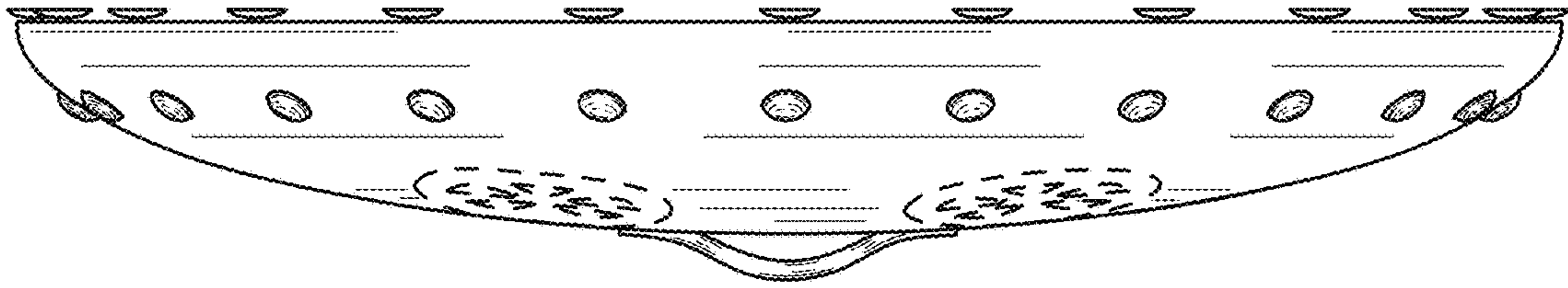

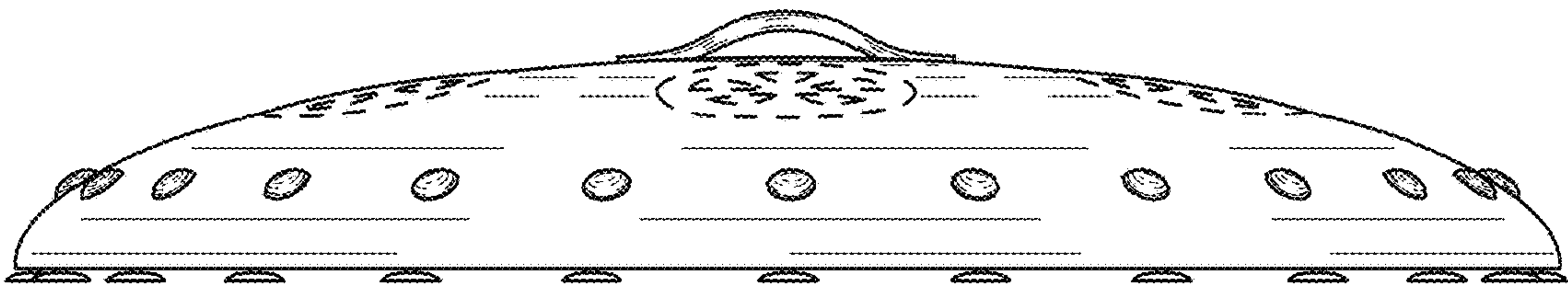
