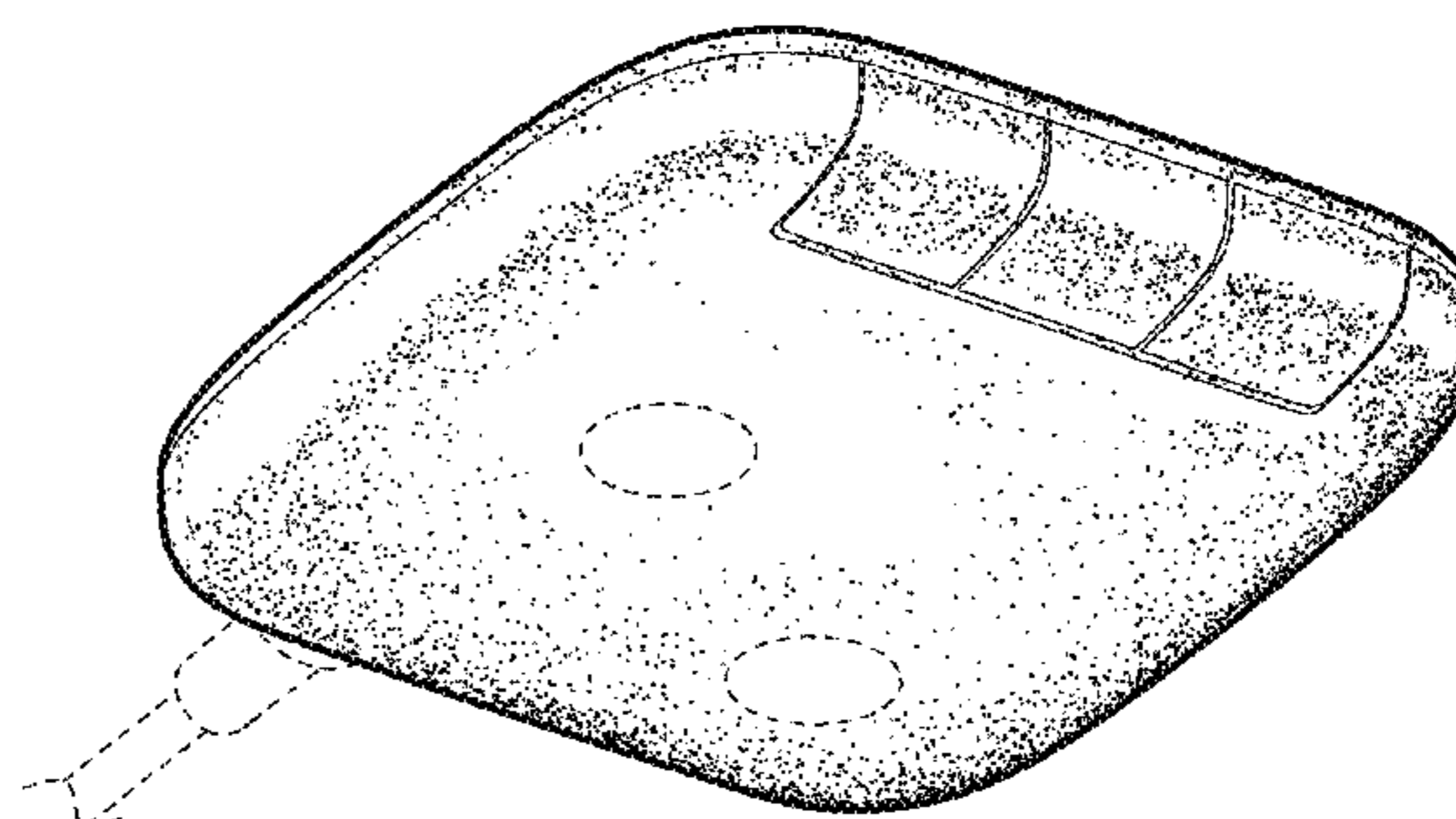
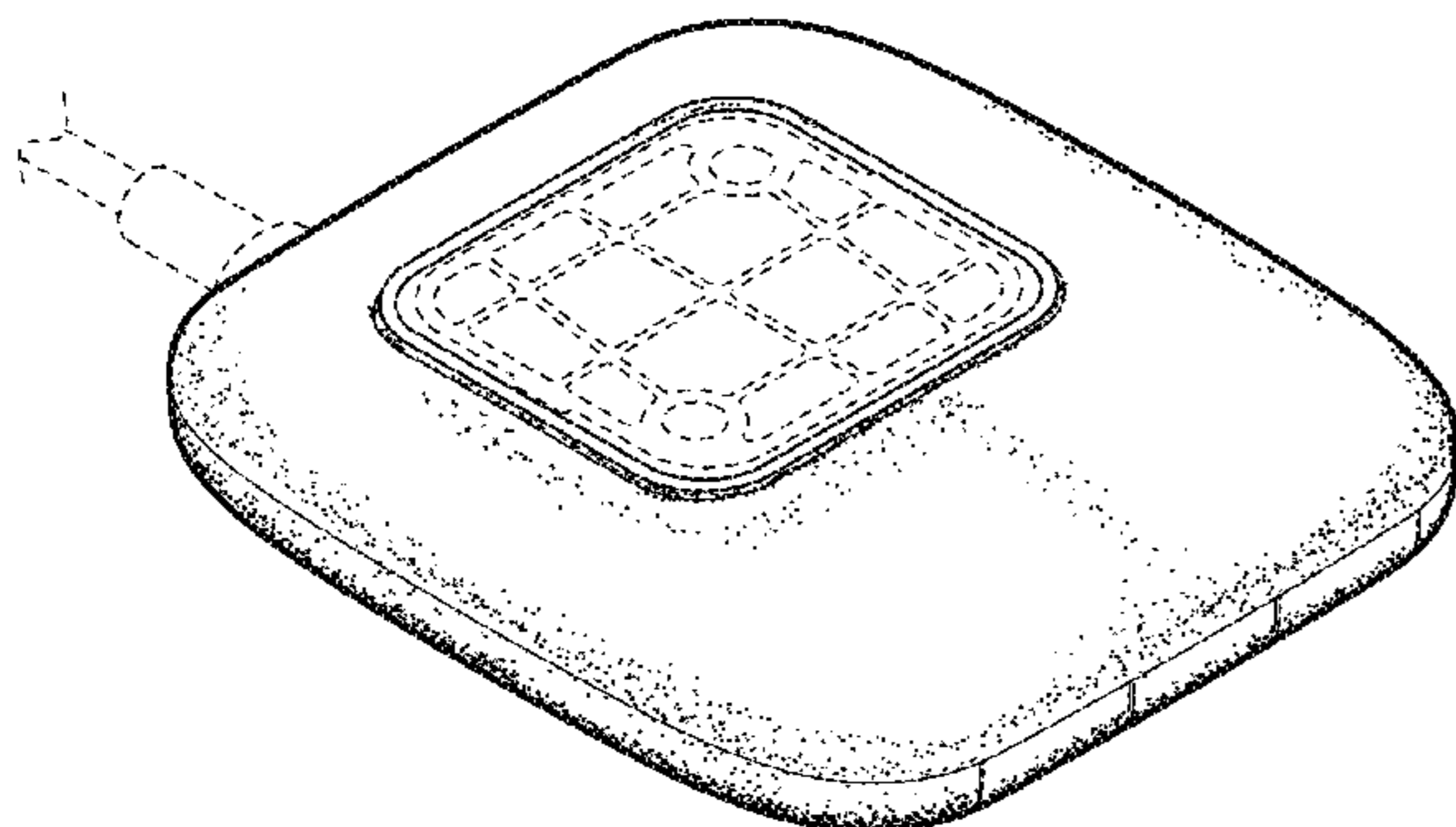
CLAIM

We claim the ornamental design for a control module, as illustrated and described.

DESCRIPTION

FIG. 1 is a front perspective view of a control module; FIG. 2 is a bottom perspective view of the control module of FIG. 1; FIG. 3 is a front view of the control module of FIG. 1; FIG. 4 is a rear view of the control module of FIG. 1; FIG. 5 is a right side view of the control module of FIG. 1; FIG. 6 is a left side view of the control module of FIG. 1; FIG. 7 is a top view of the control module of FIG. 1; and, FIG. 8 is a bottom view of the control module of FIG. 1. The dashed lines are for purposes of illustrating environmental structure and form no part of the claimed design.

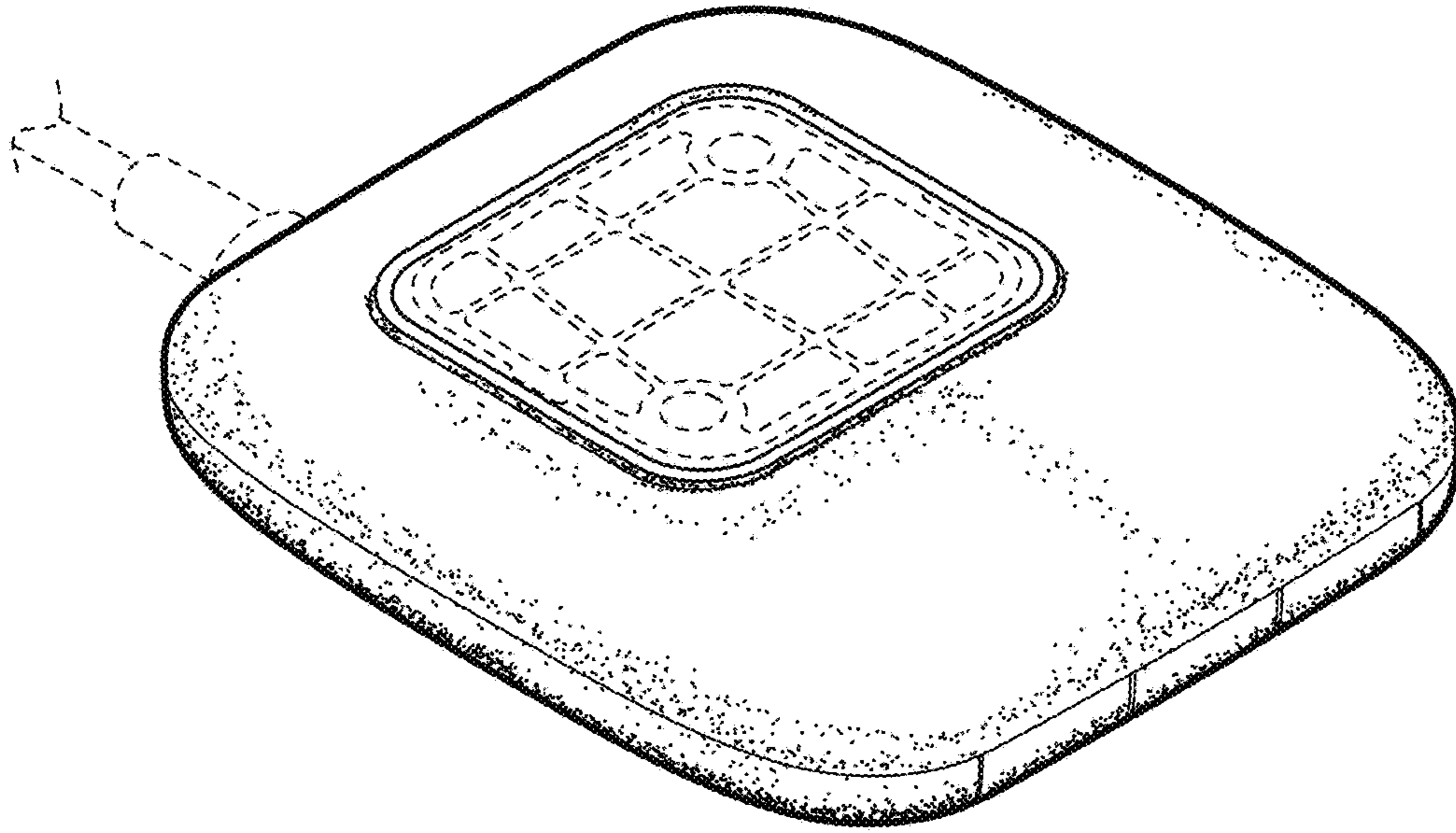

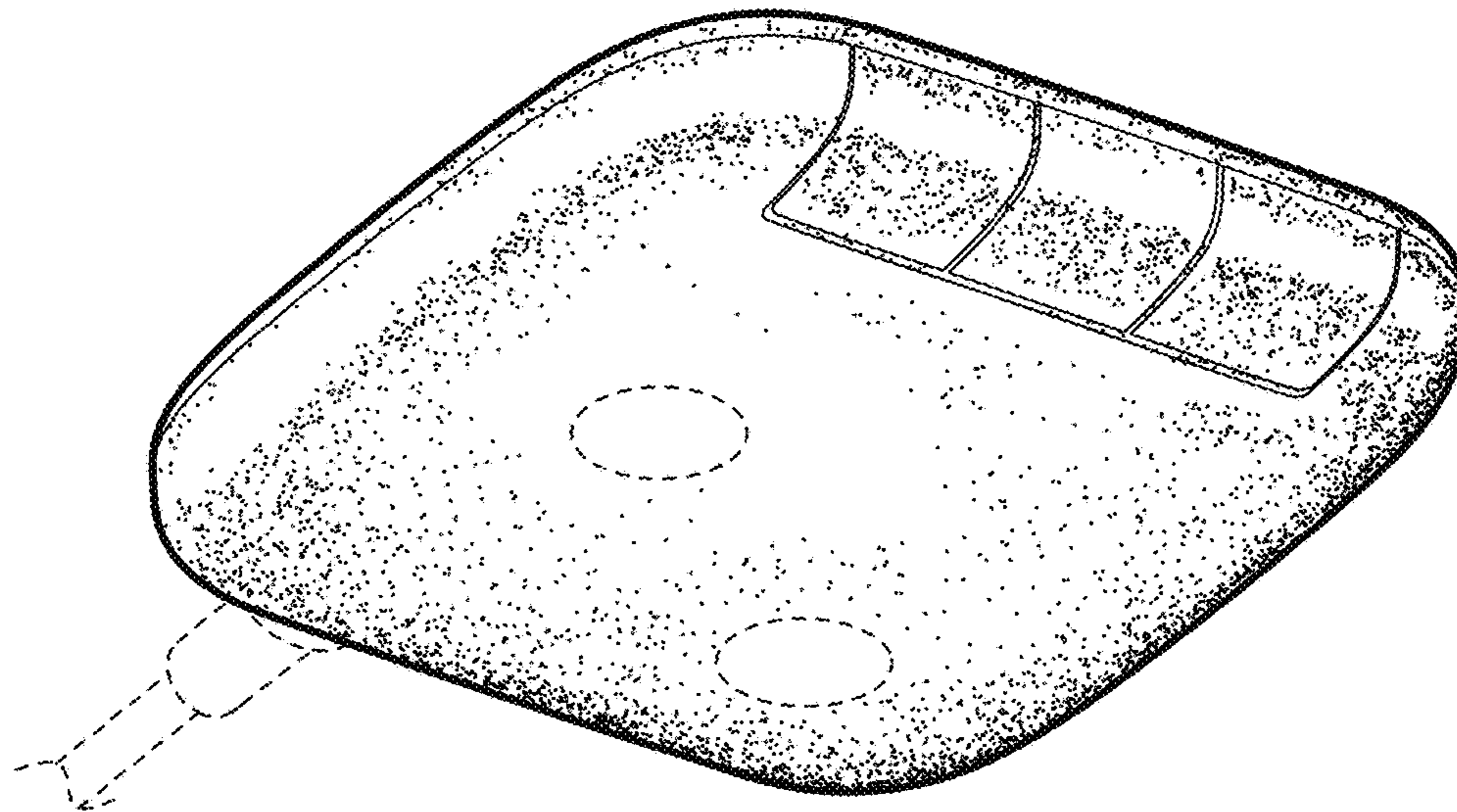

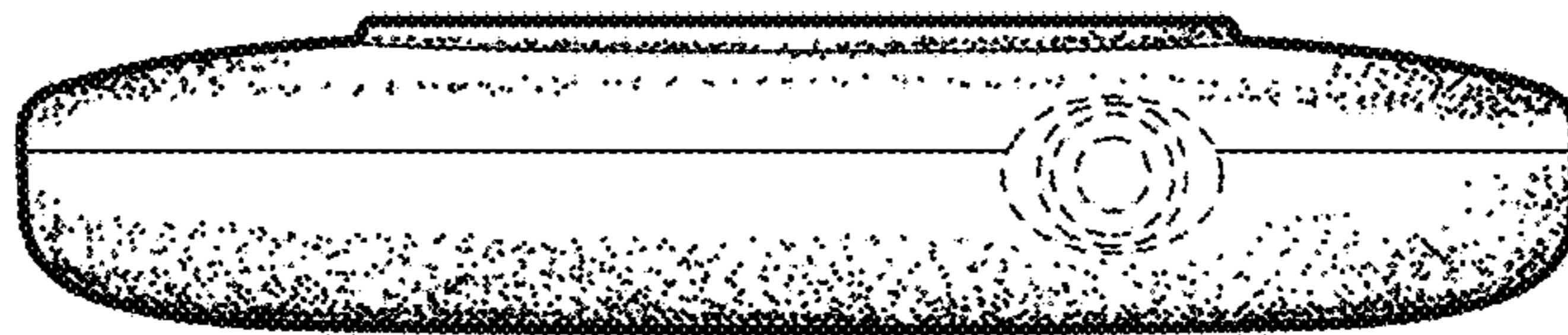

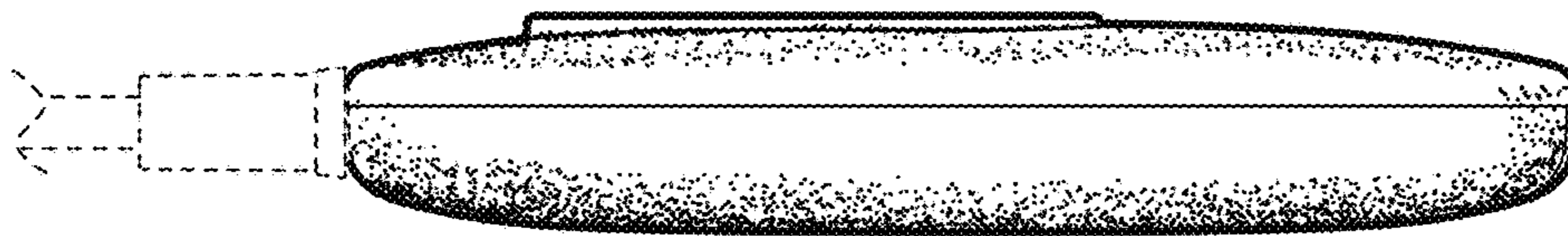

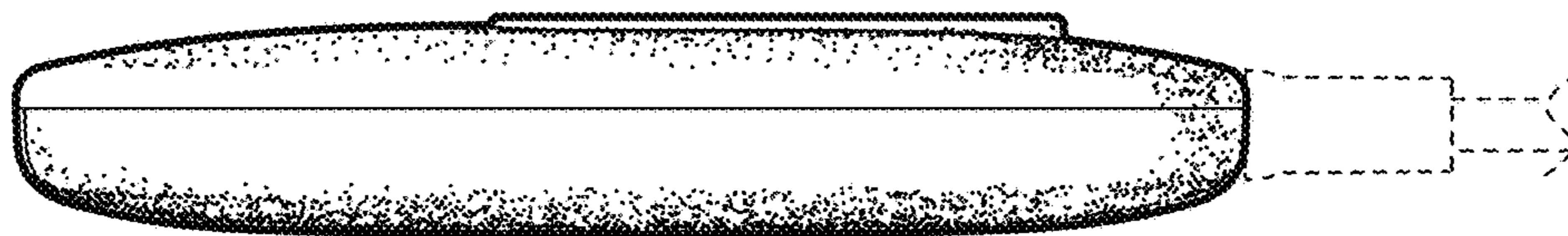

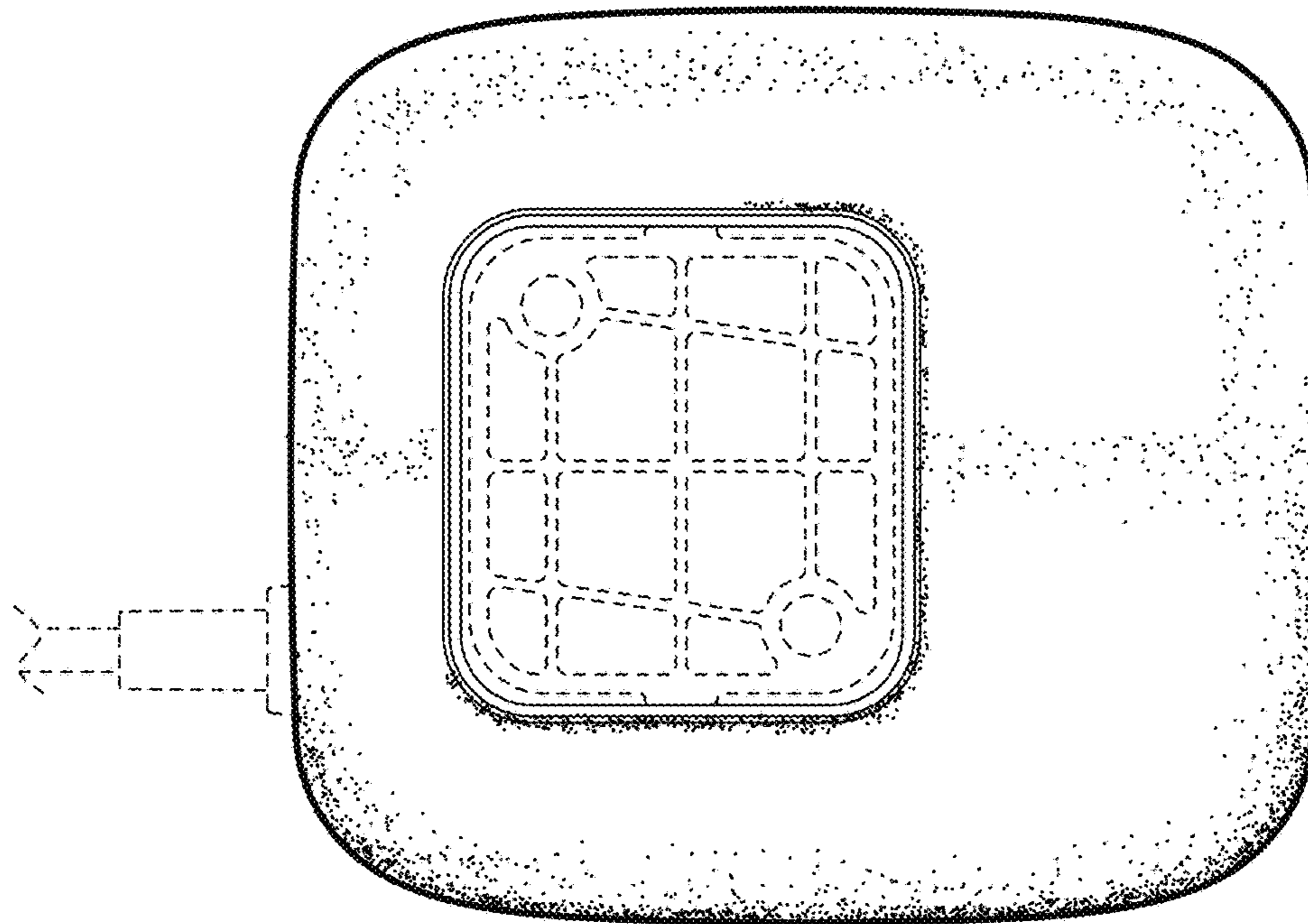

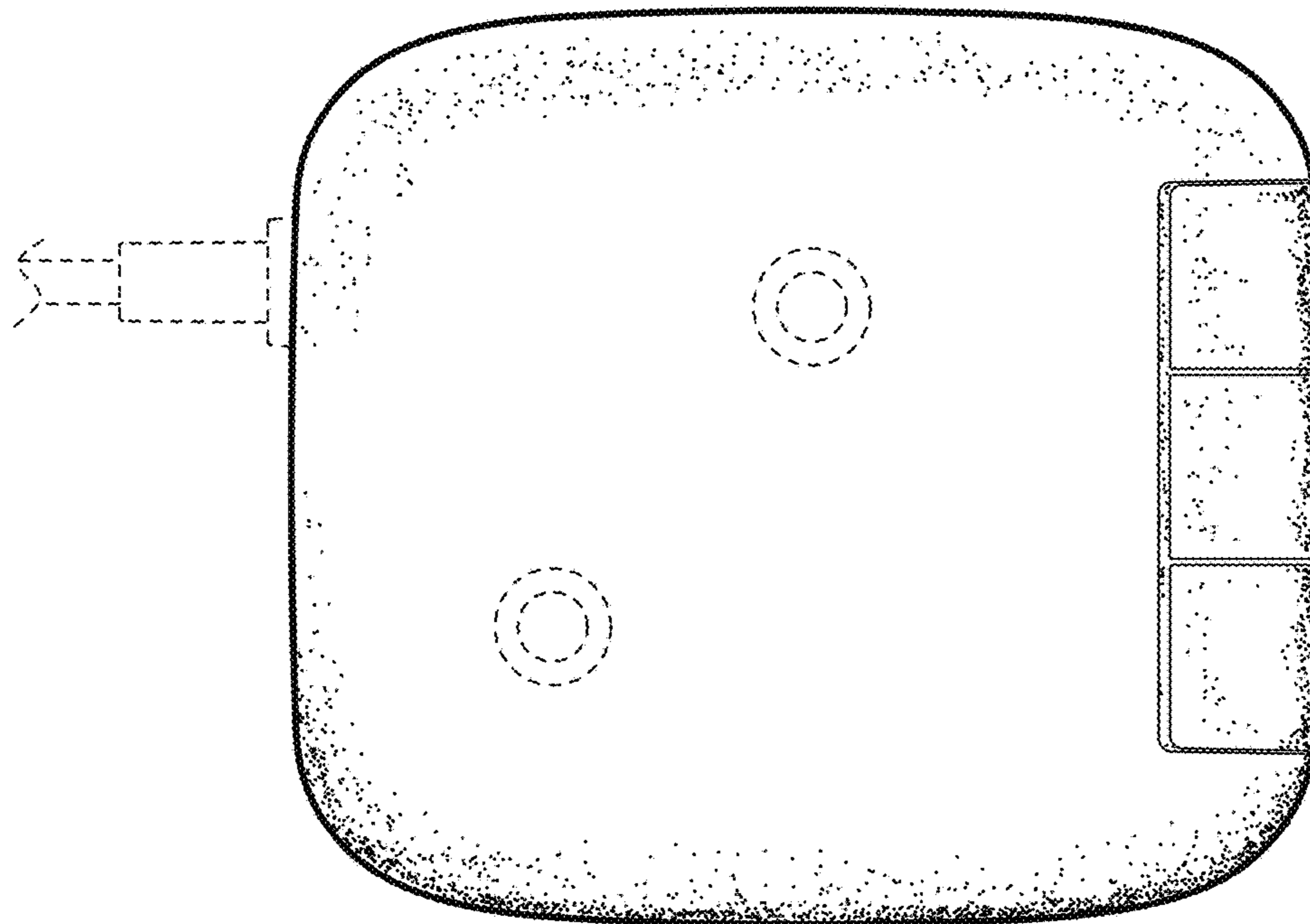
