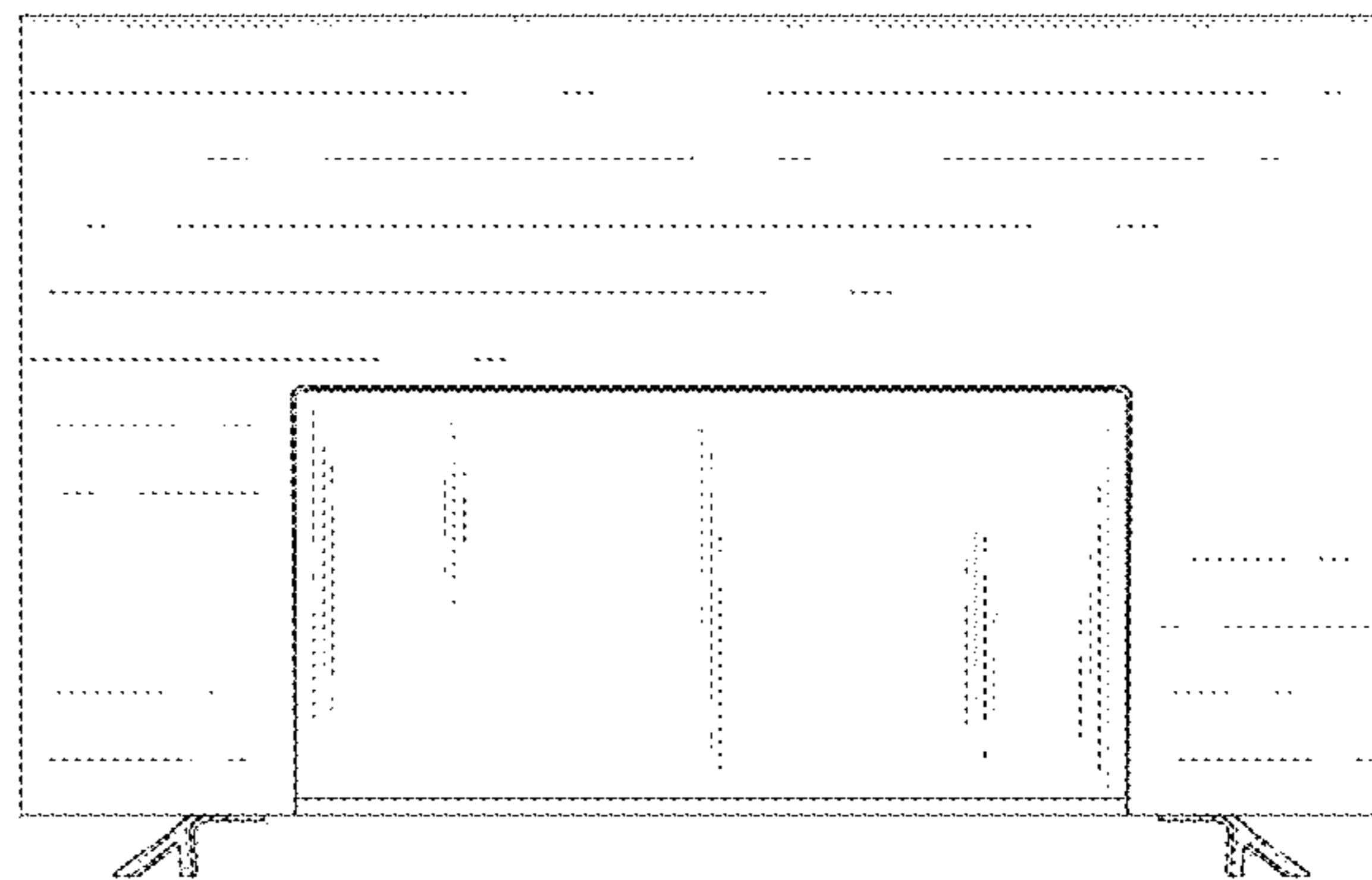
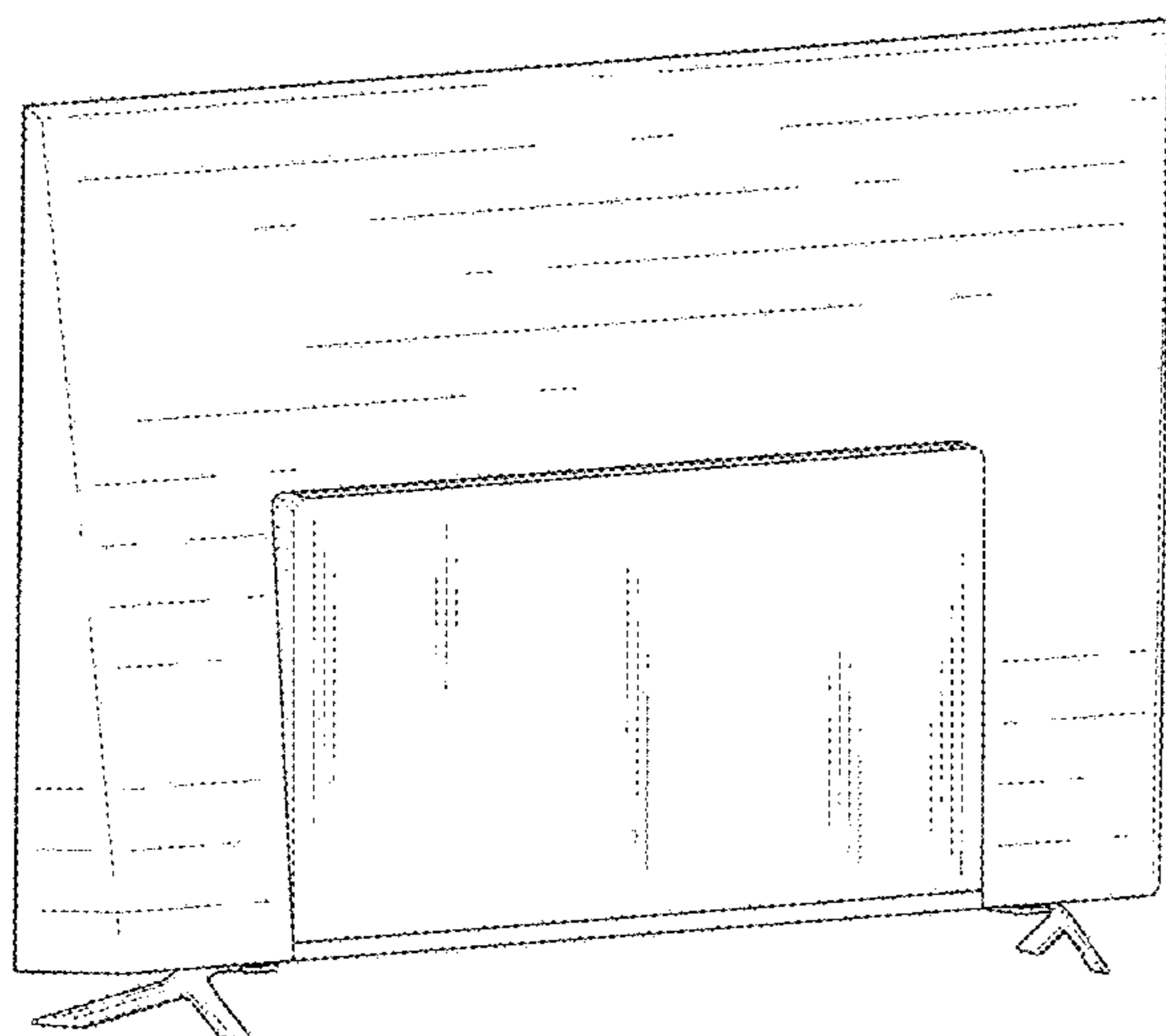
The ornamental design for a TV receiver, as shown and described.

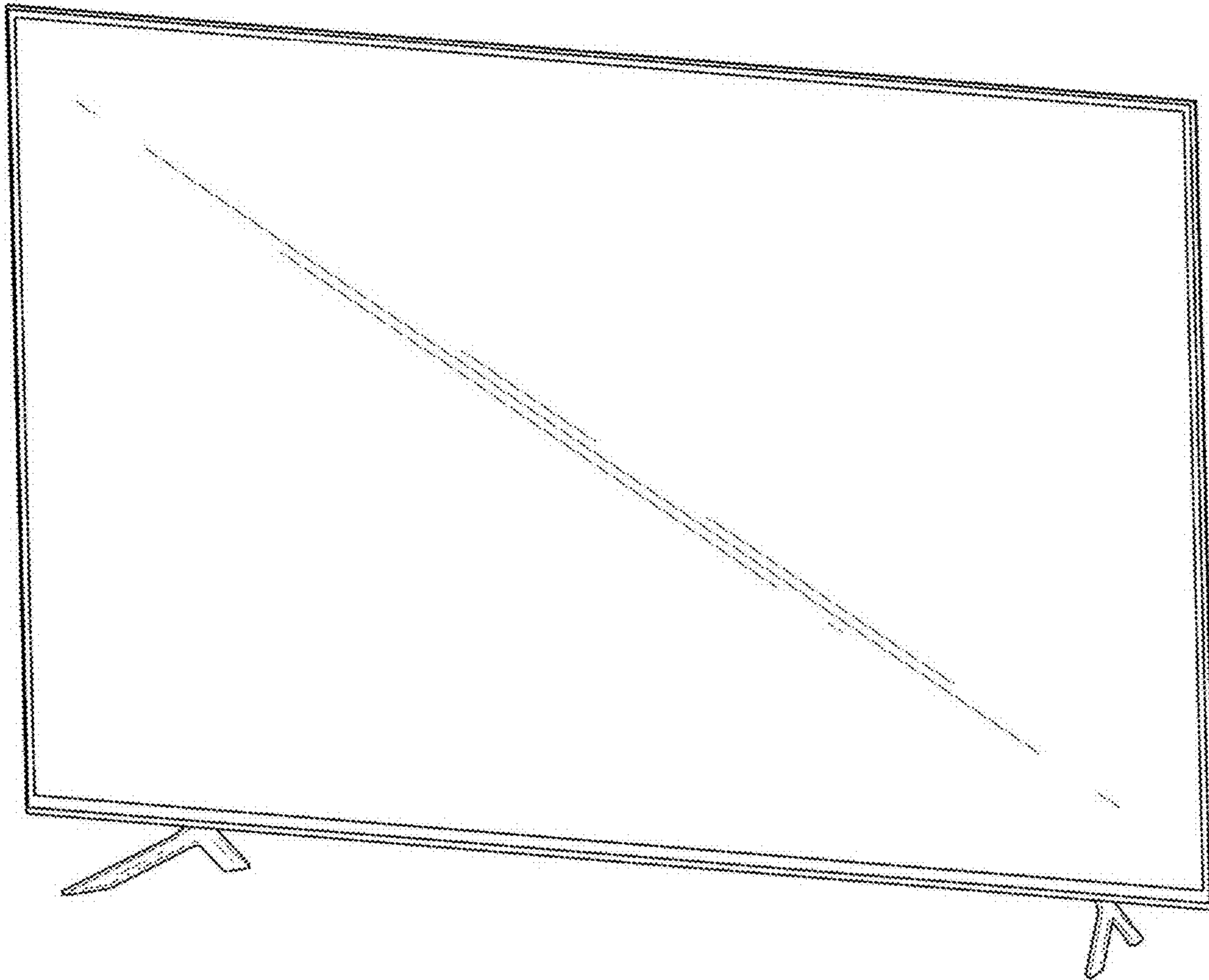

The broken line shown in FIG. 1.5 is for the purpose of illustrating portions of the TV receiver that form no part of the claimed design.

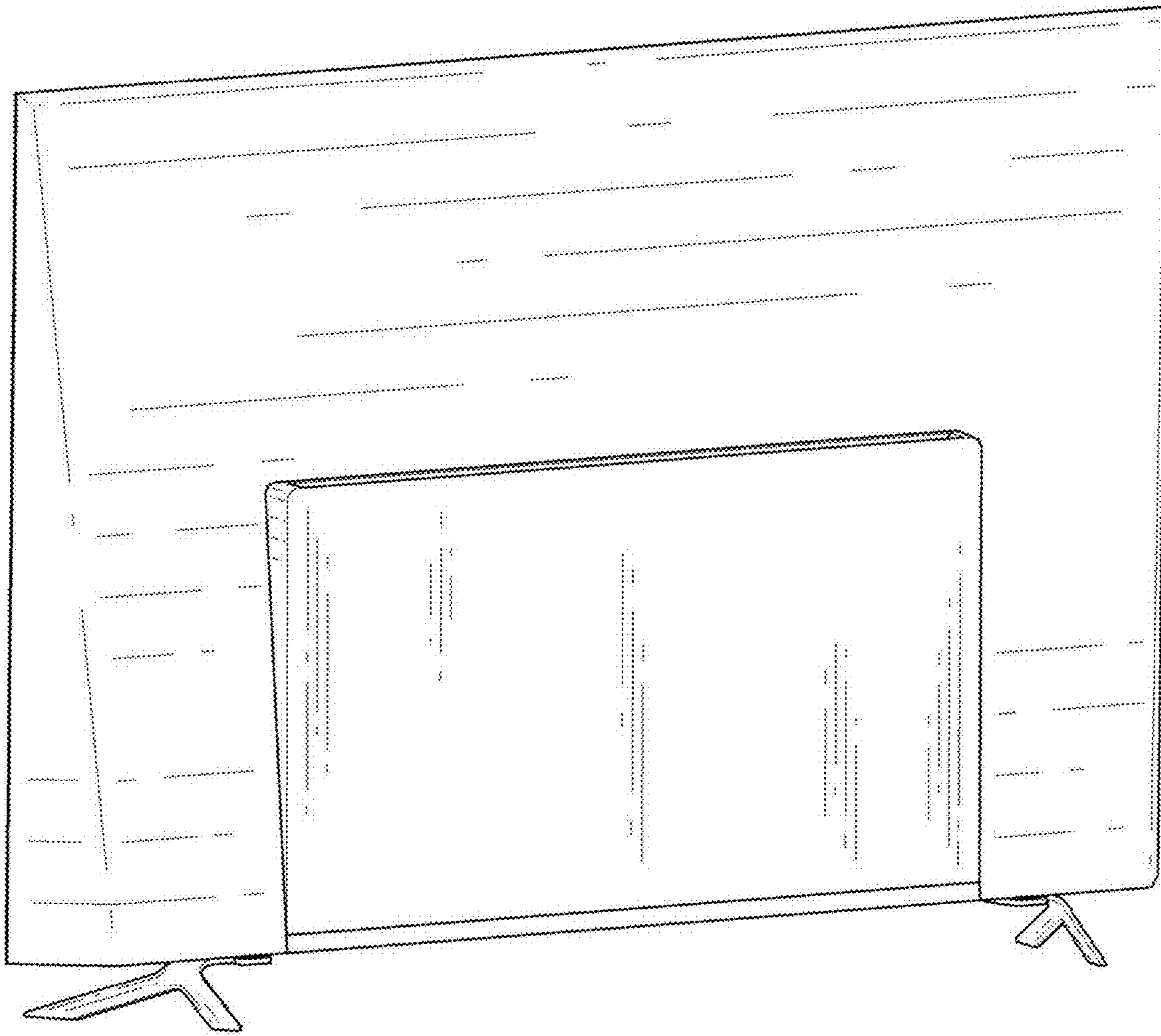

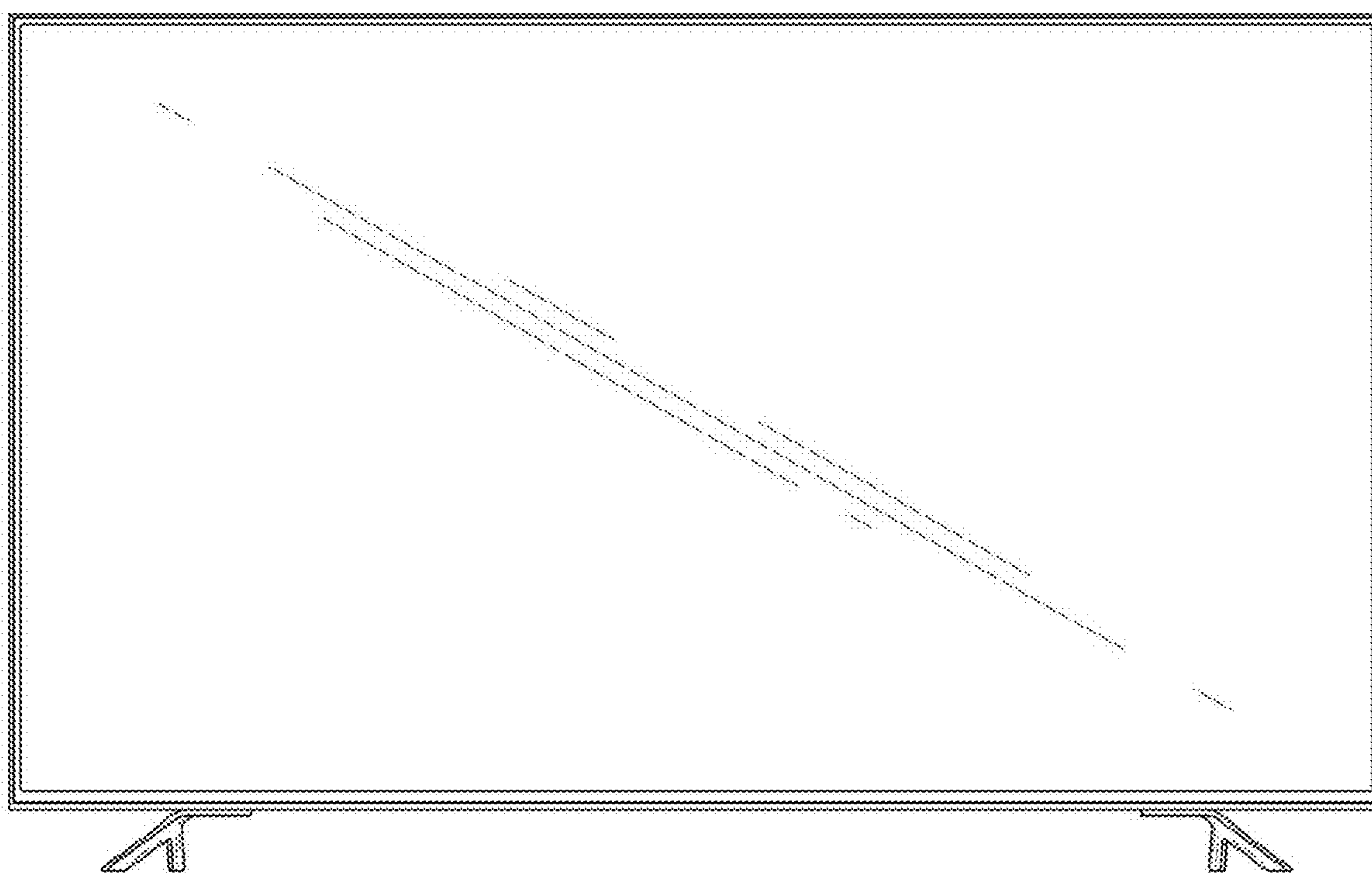

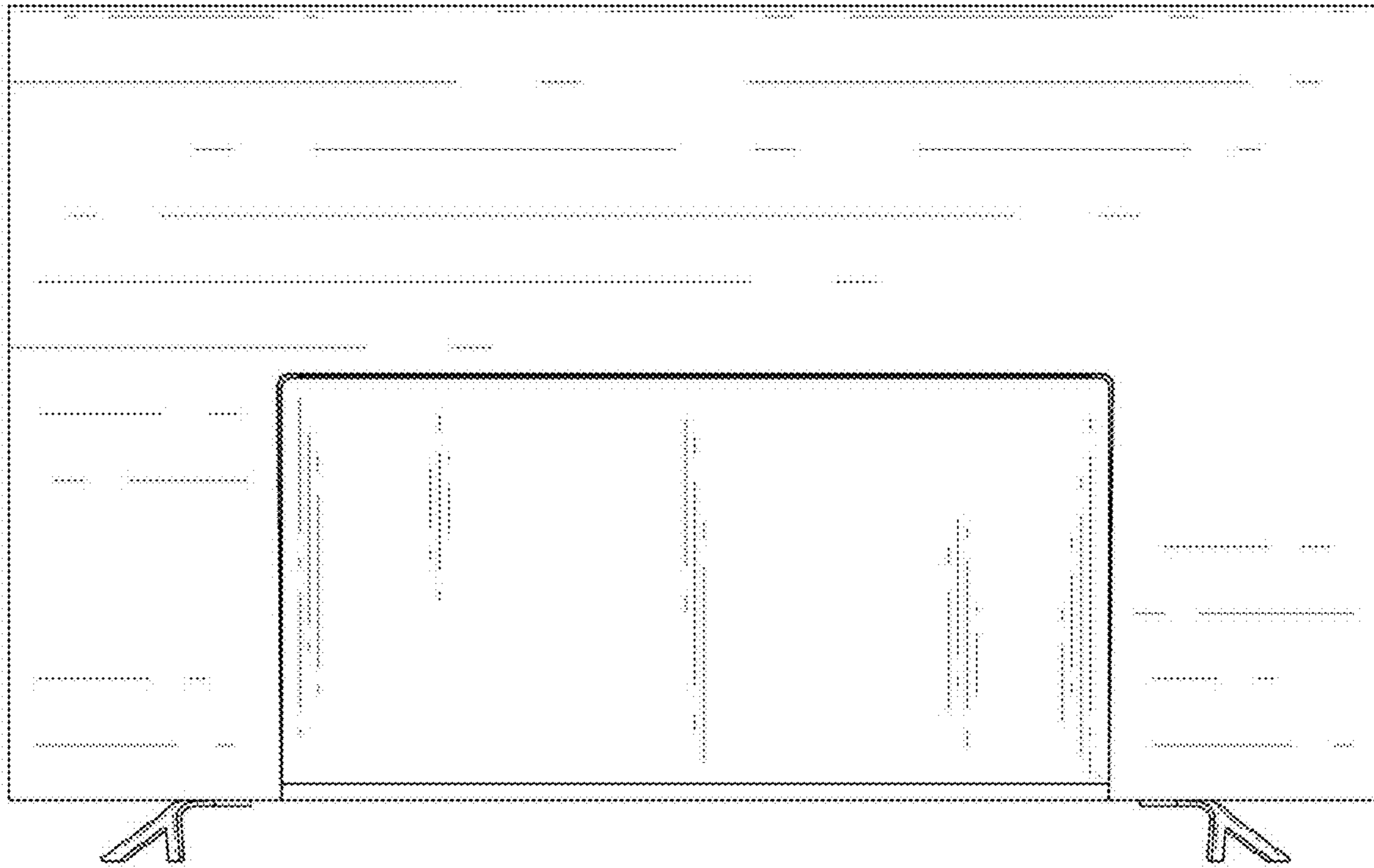

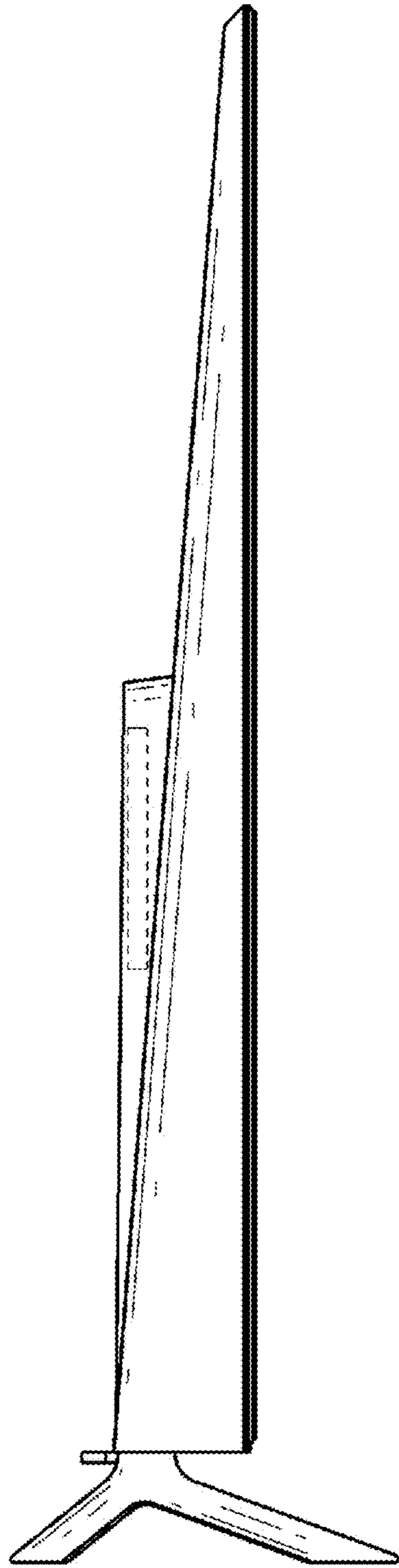

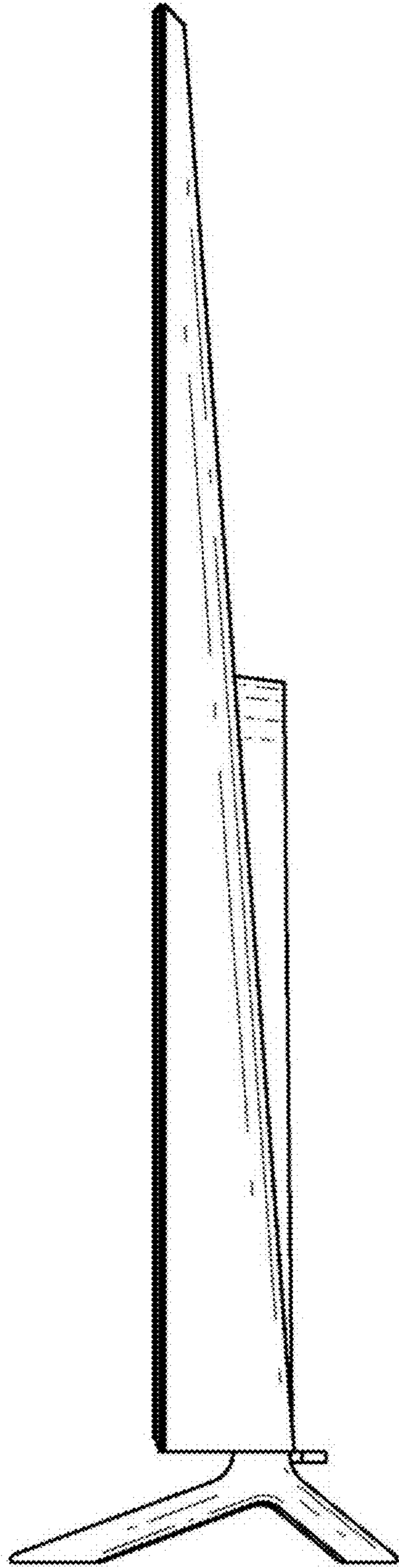

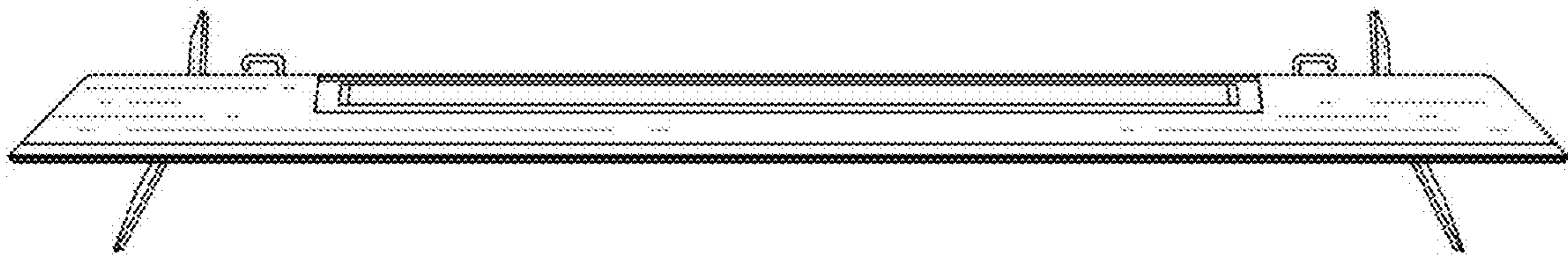

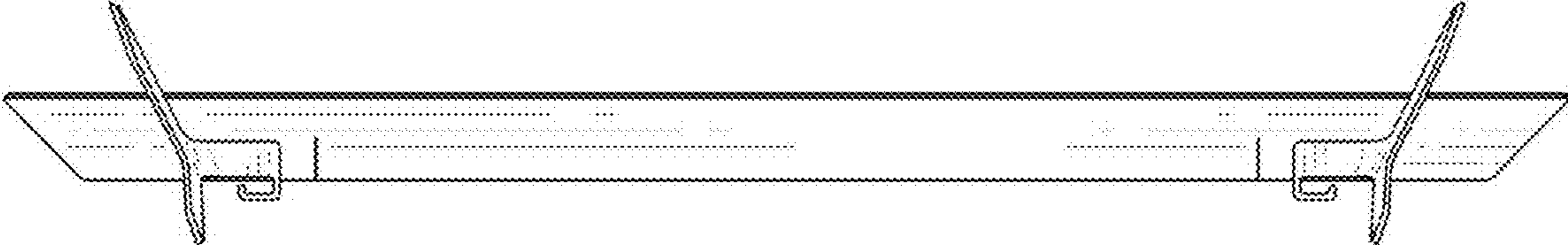
