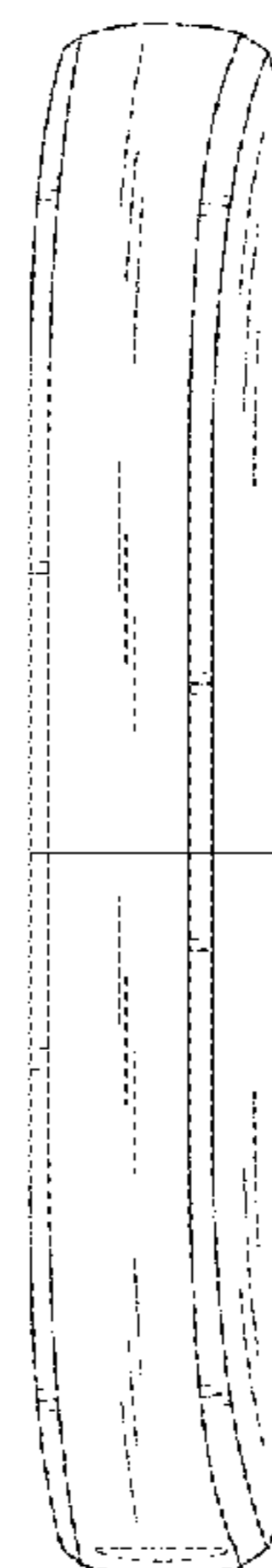
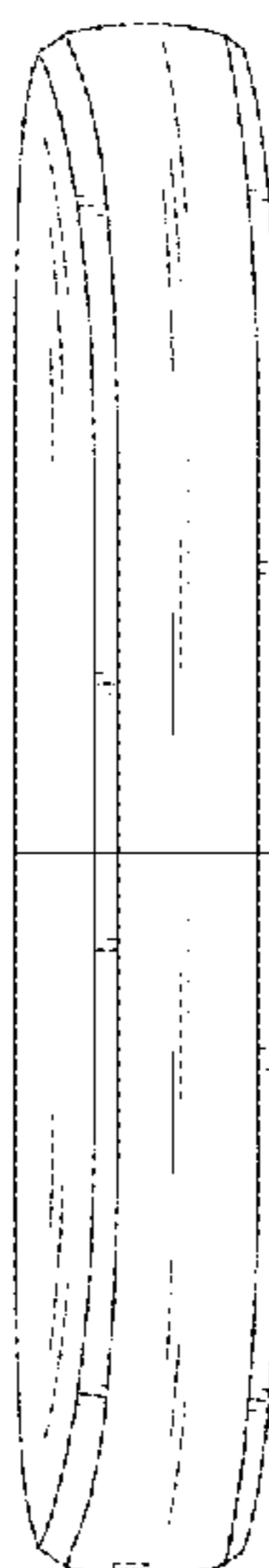
The ornamental design for an audio module for mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an audio module for mobile phone showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is an exploded perspective view thereof;
FIG. 9 is a perspective view of the audio module for mobile phone of FIG. 1, showing only the lower section wherein the upper section has been removed in order to show aspects of the design that are not otherwise apparent;
FIG. 10 is a front view thereof;
FIG. 11 is a rear view thereof;
FIG. 12 is a left side view thereof;
FIG. 13 is a right side view thereof;
FIG. 14 is a top plan view thereof and the bottom plan view is the same as shown in FIG. 7; and,
FIG. 15 is another front view thereof, shown with environment.

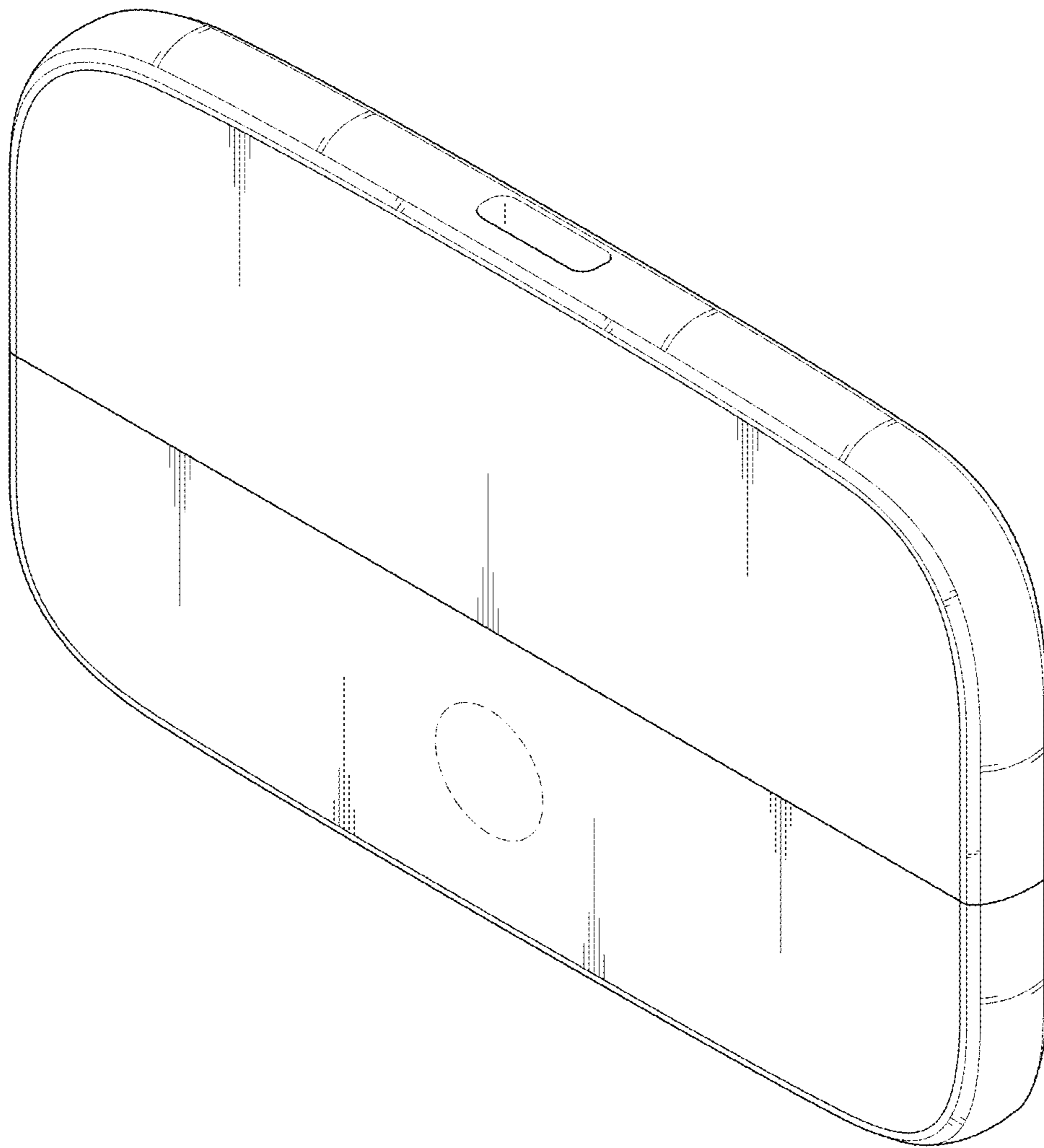

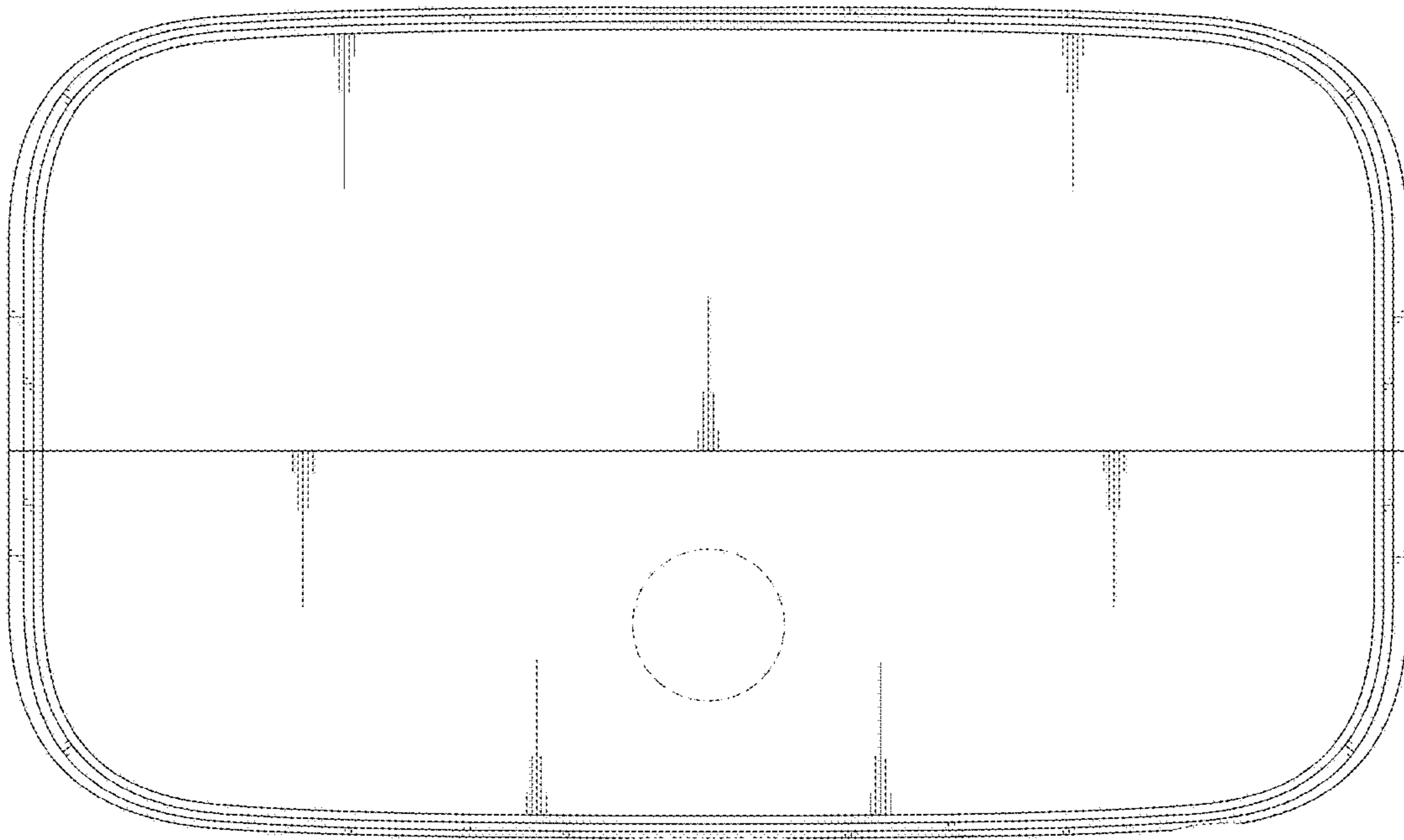

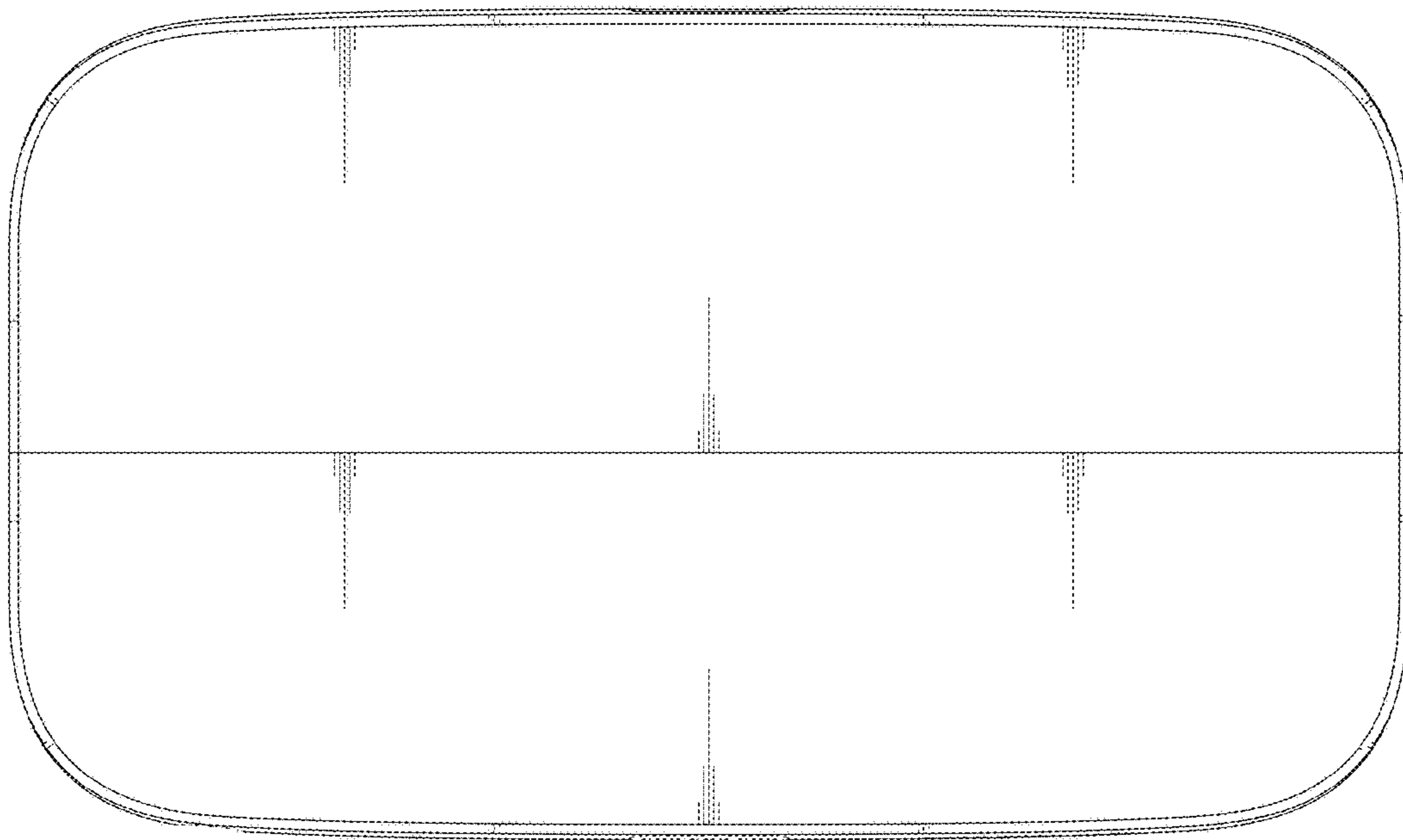

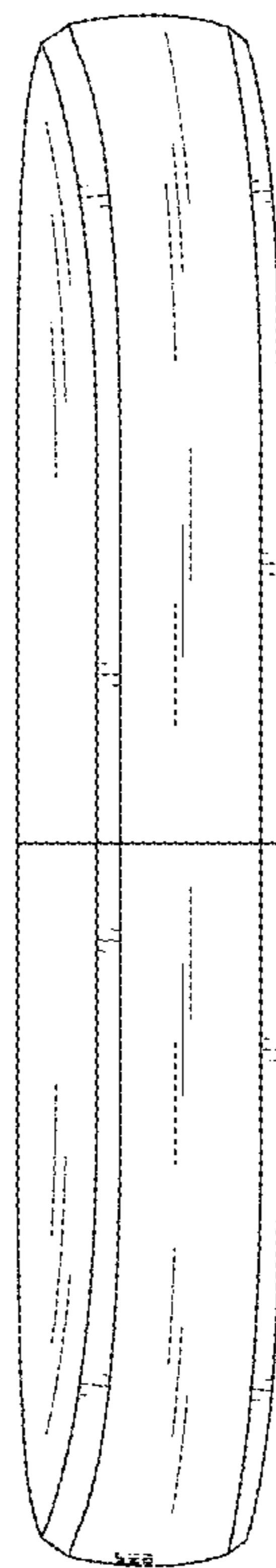

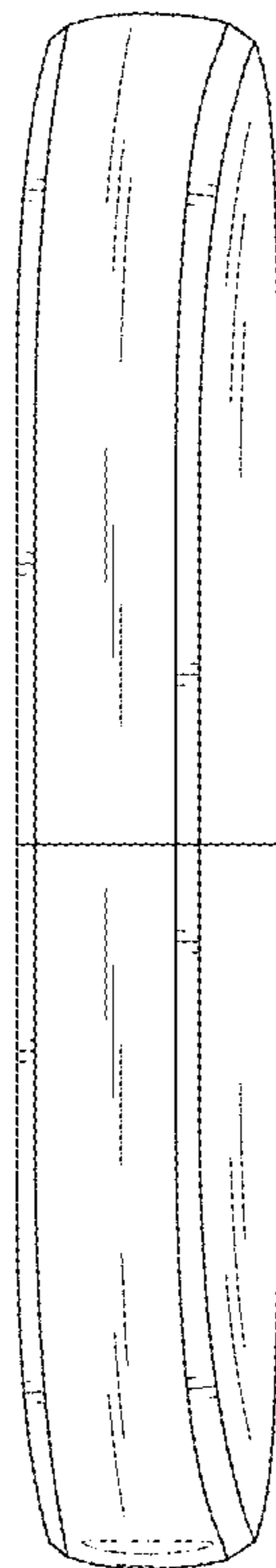

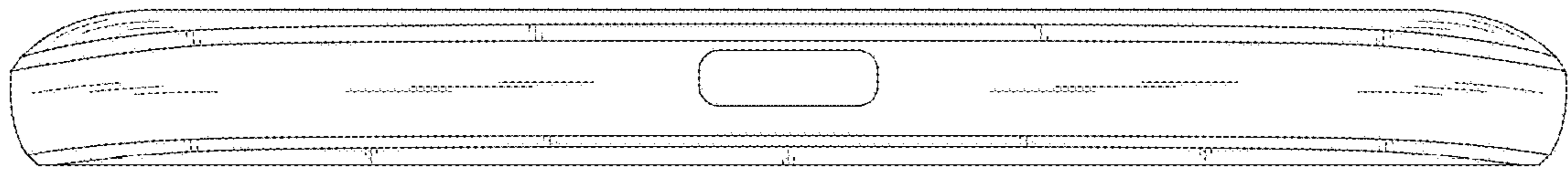

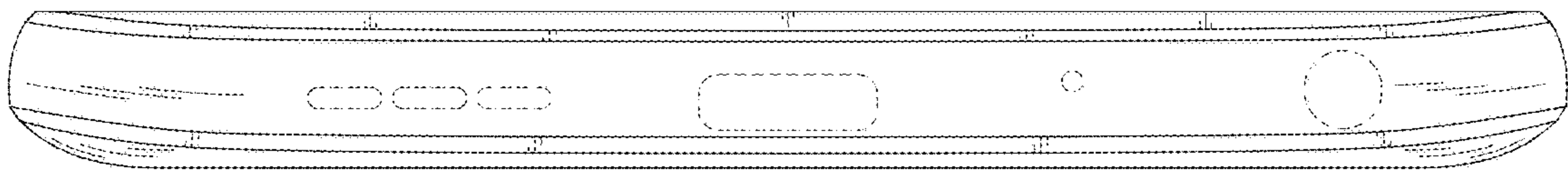

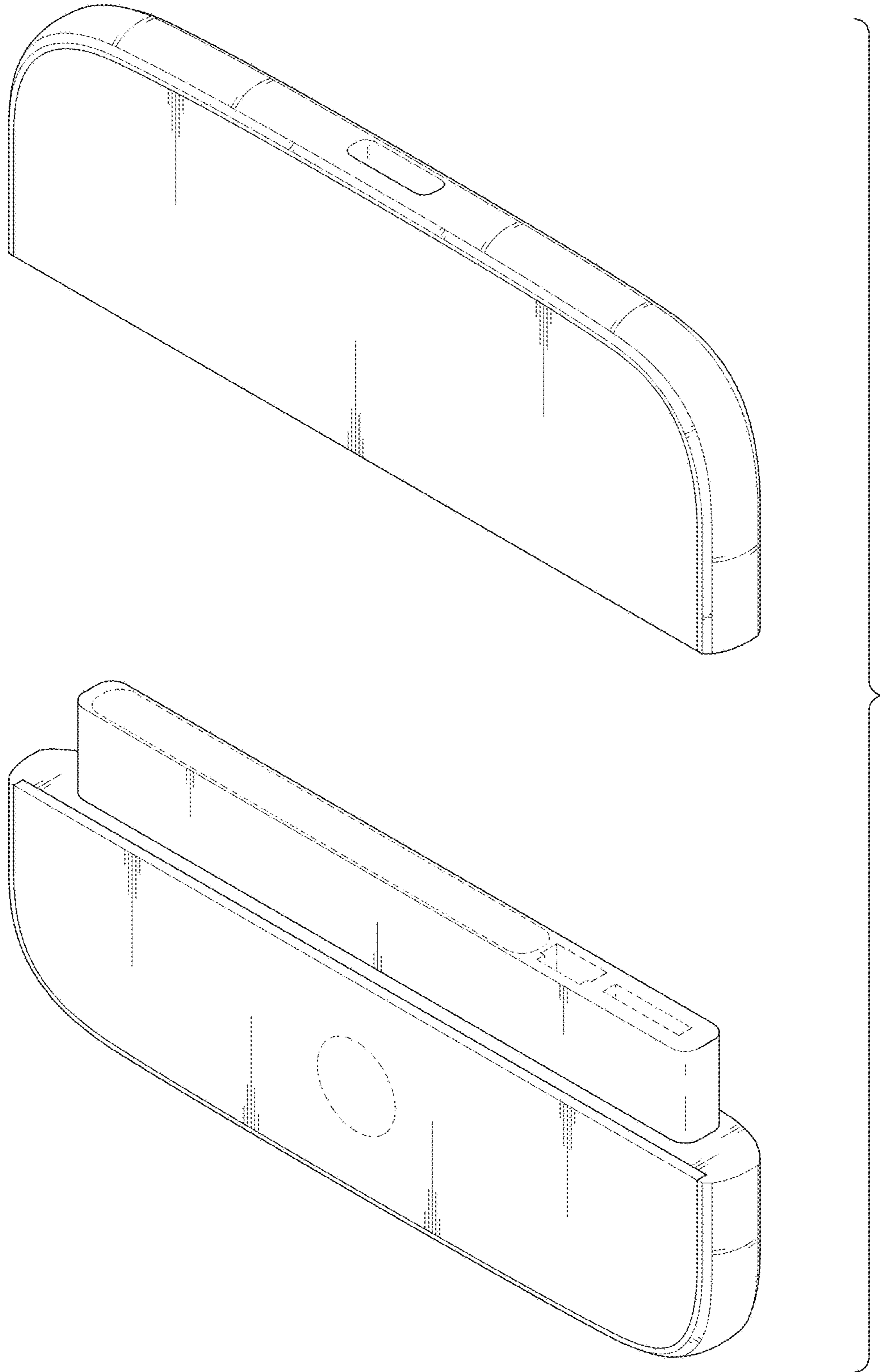

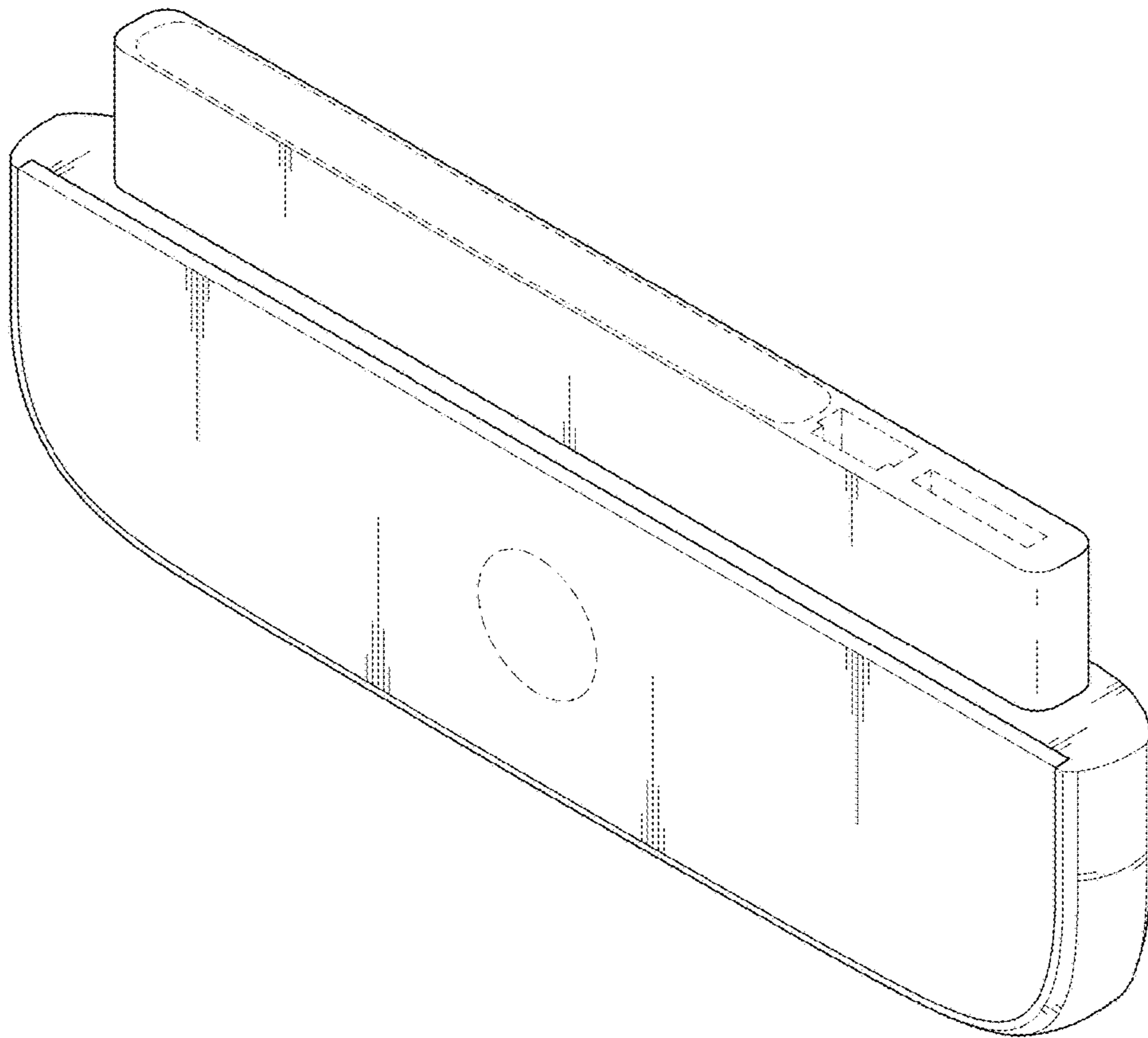

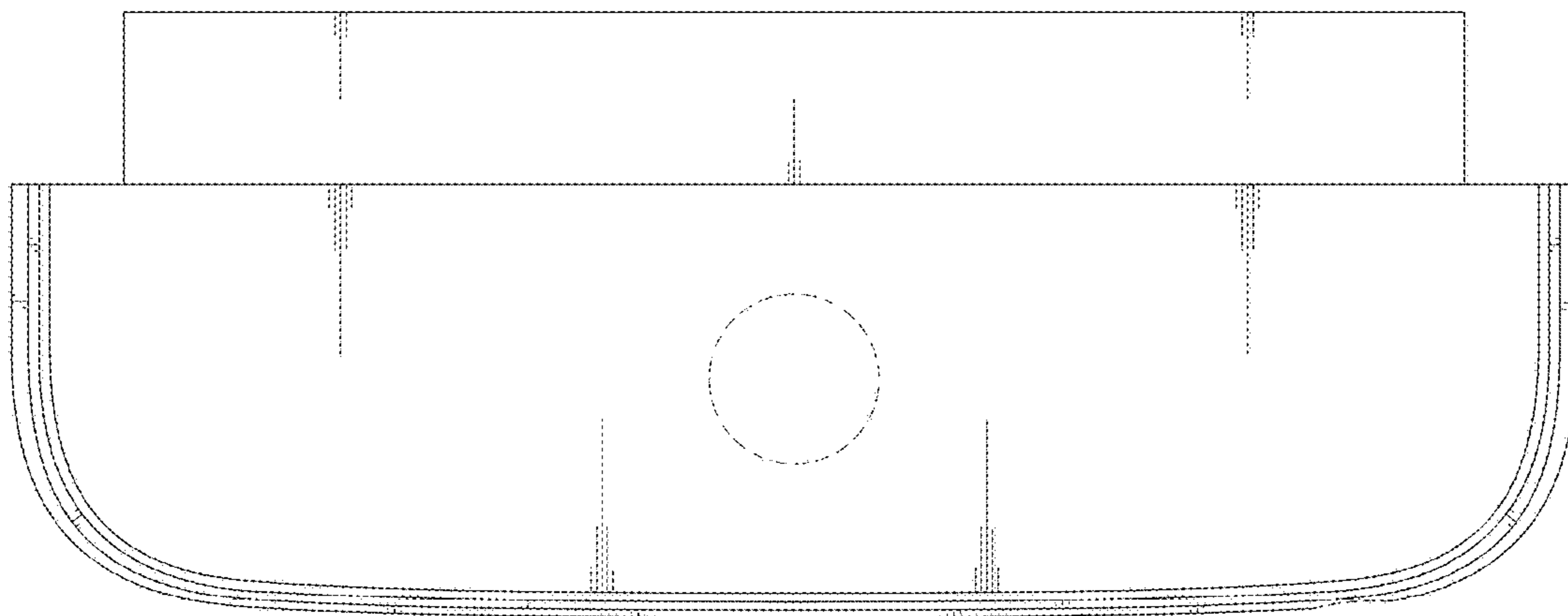

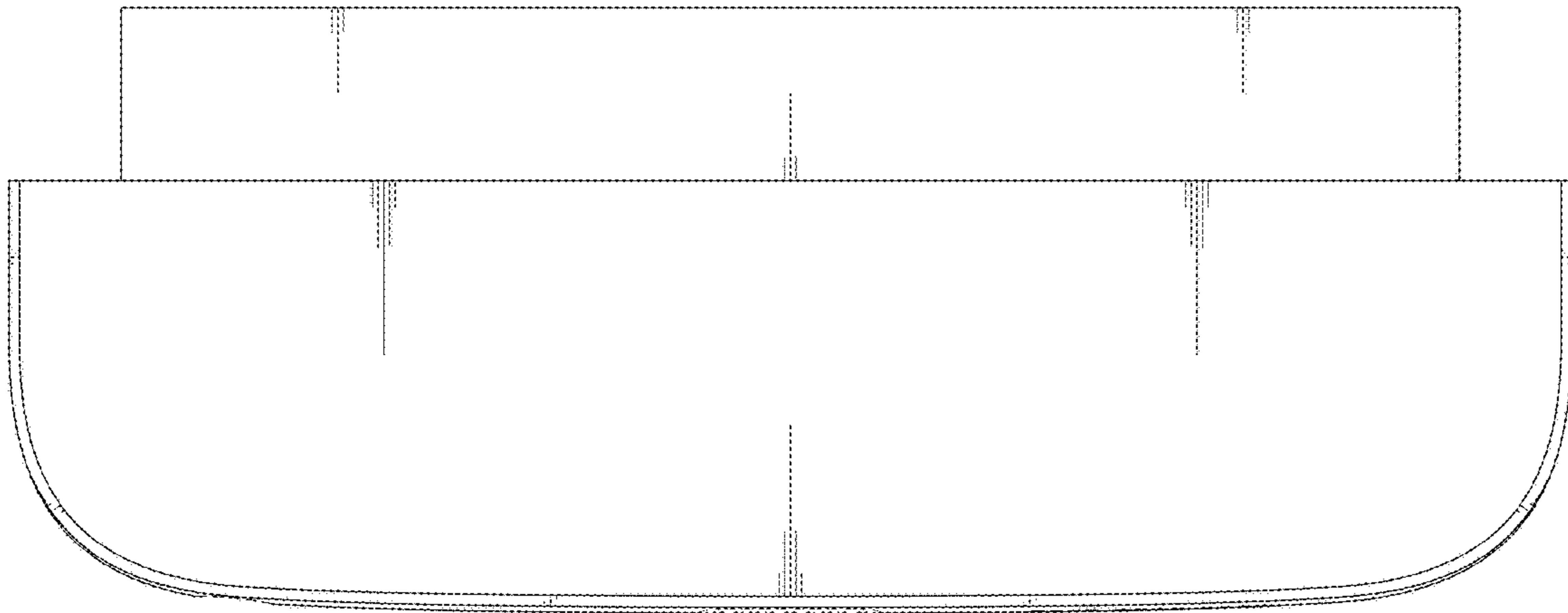

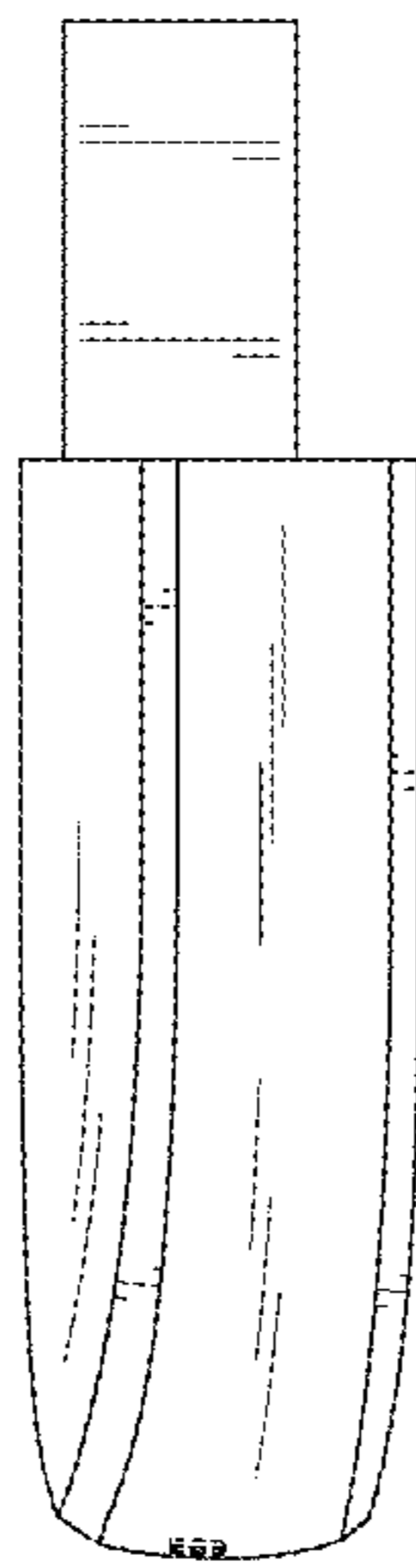

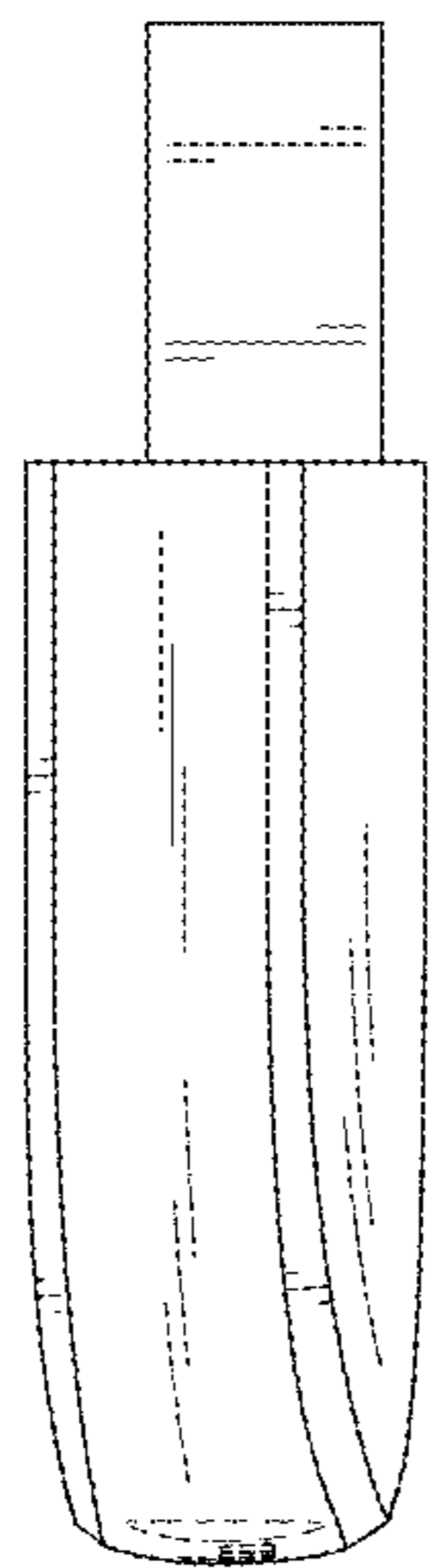

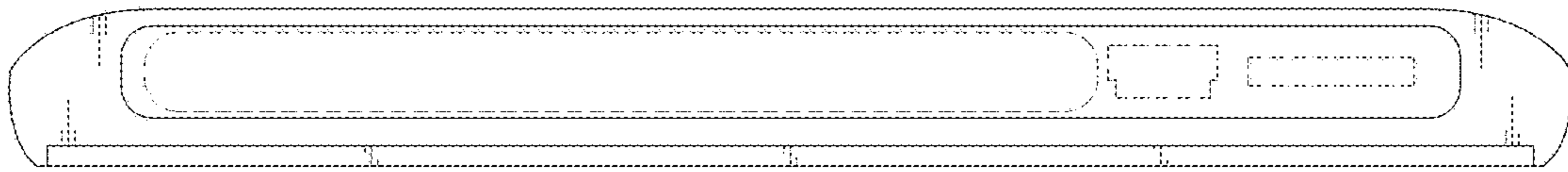
