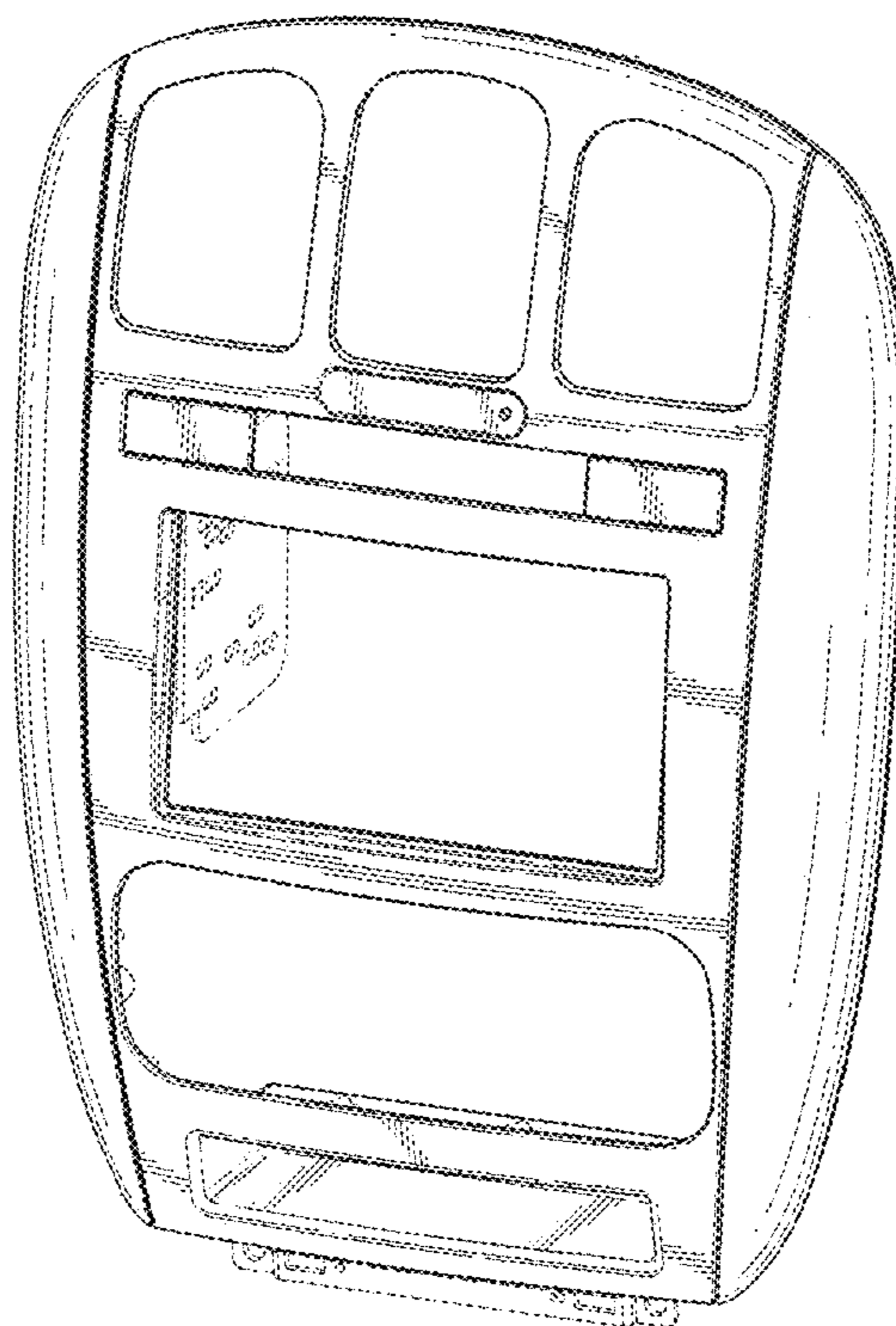
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an auto stereo mounting device, showing my design;
FIG. 2 is a front elevation view of FIG. 1;

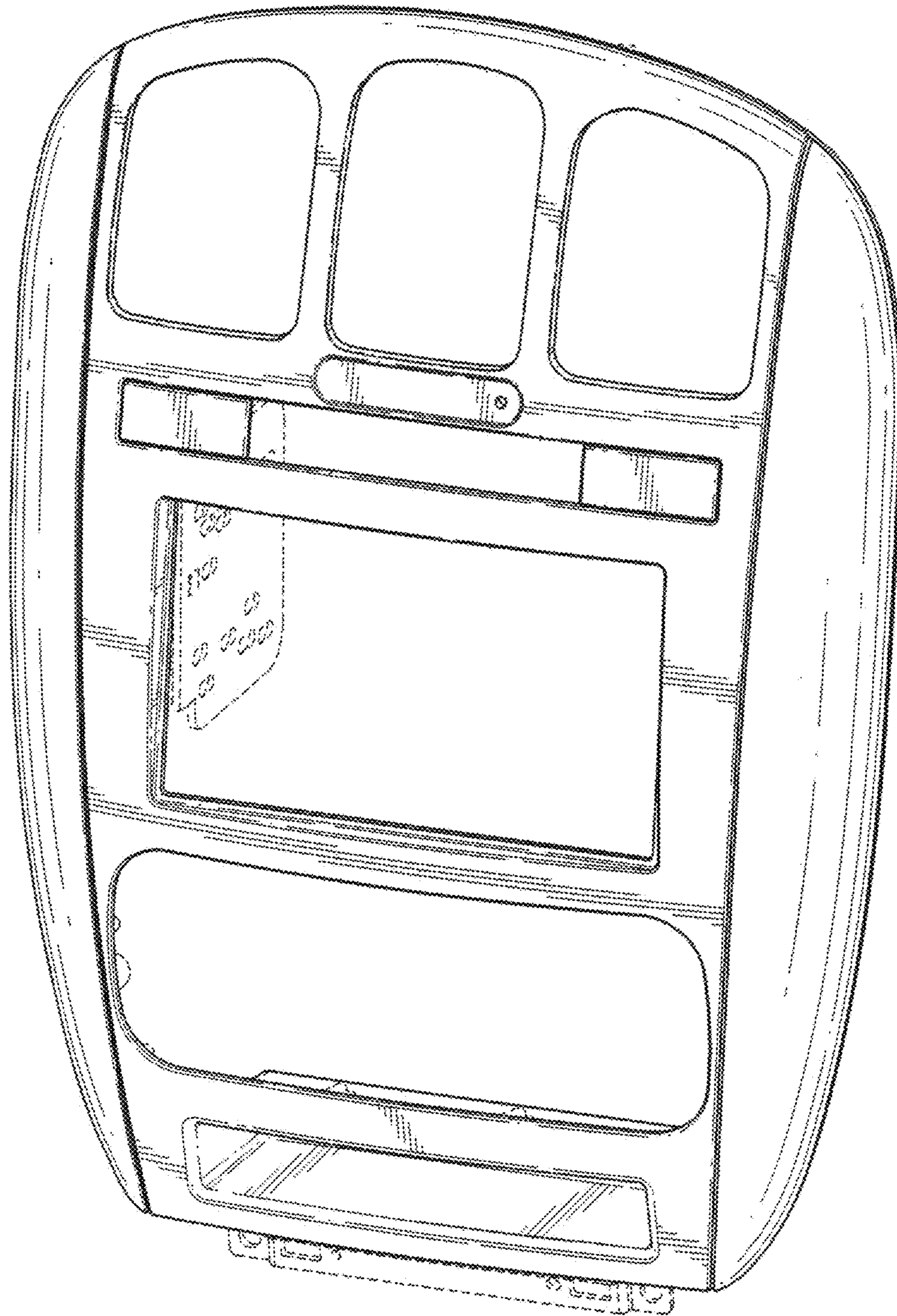

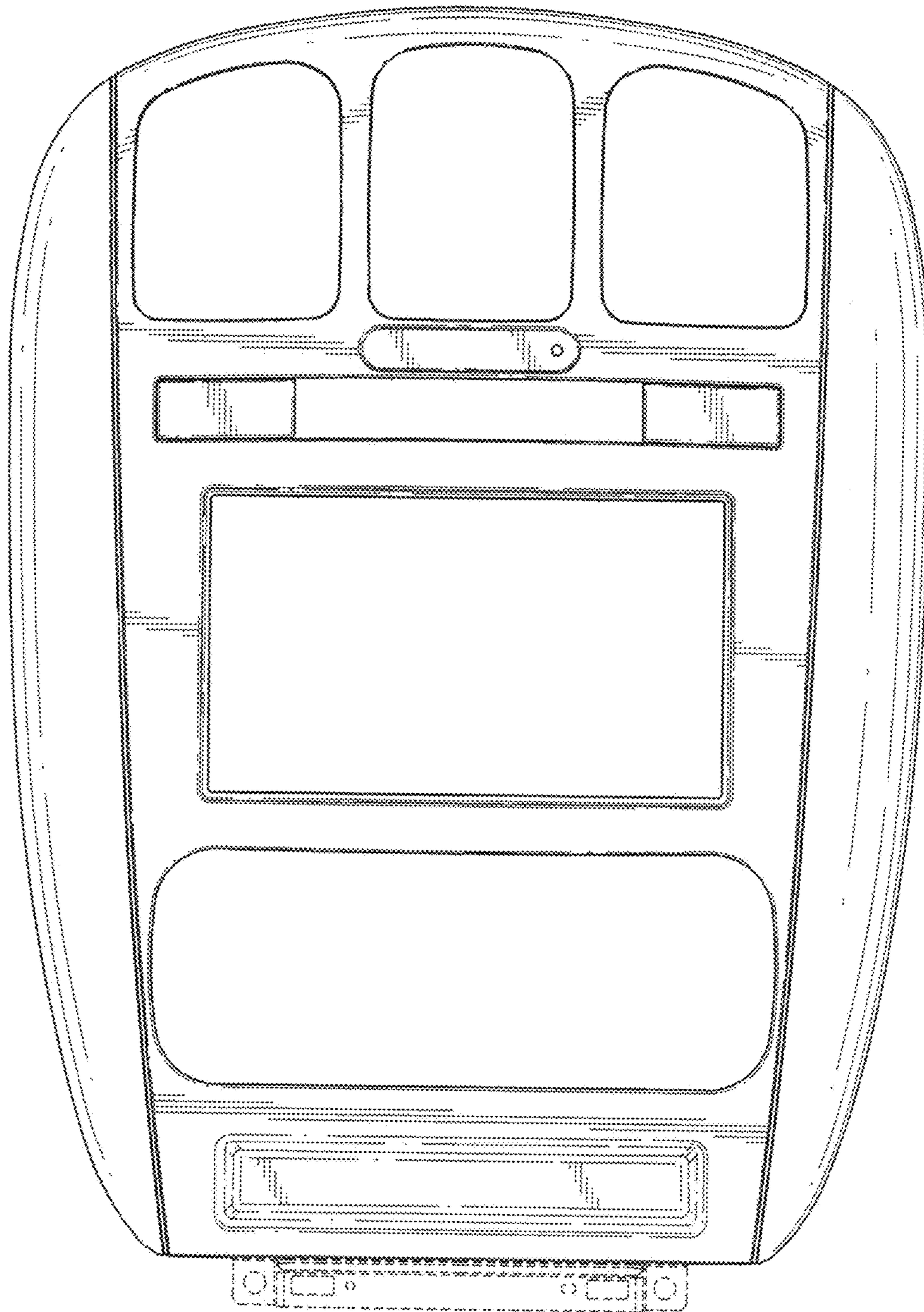

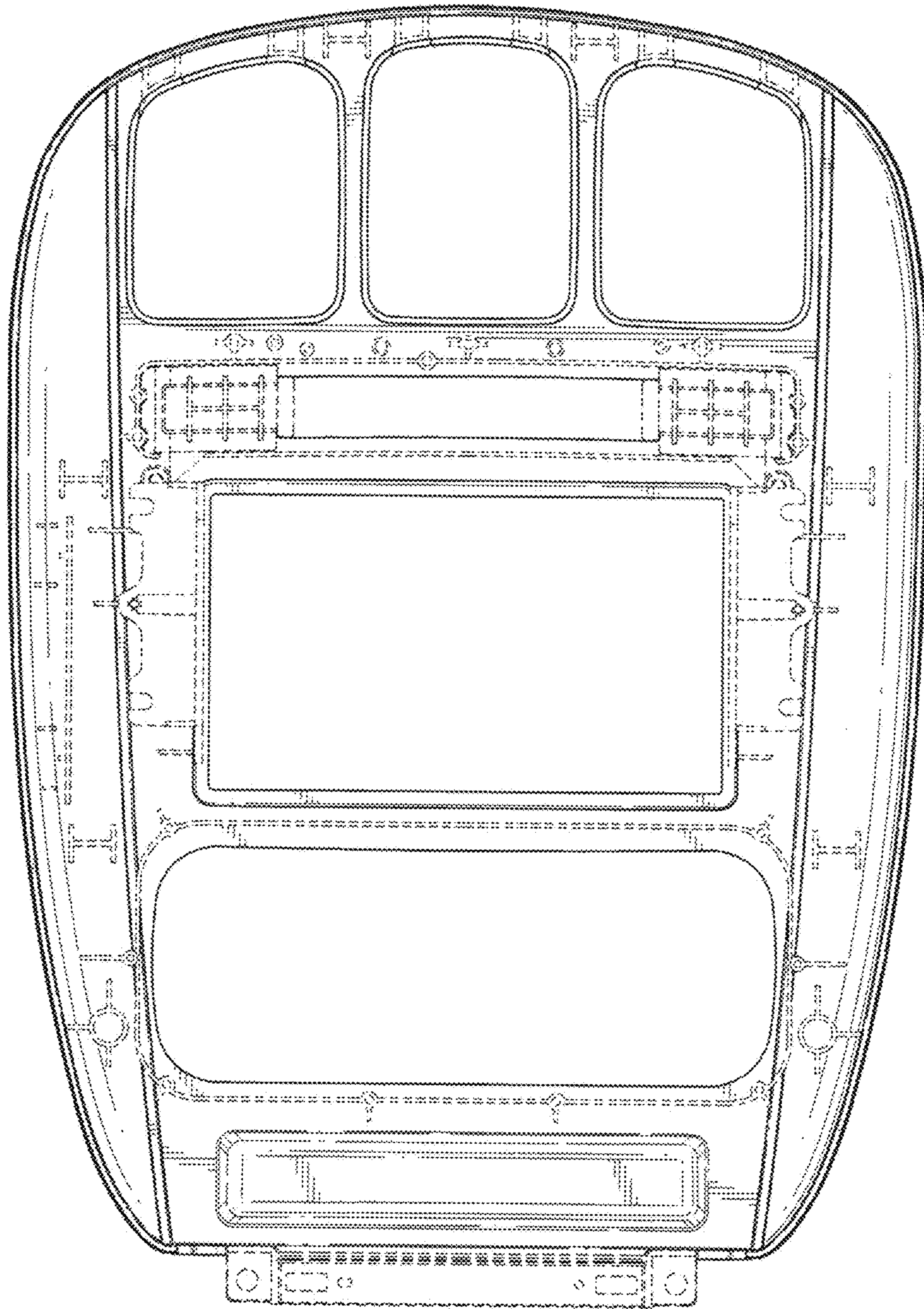

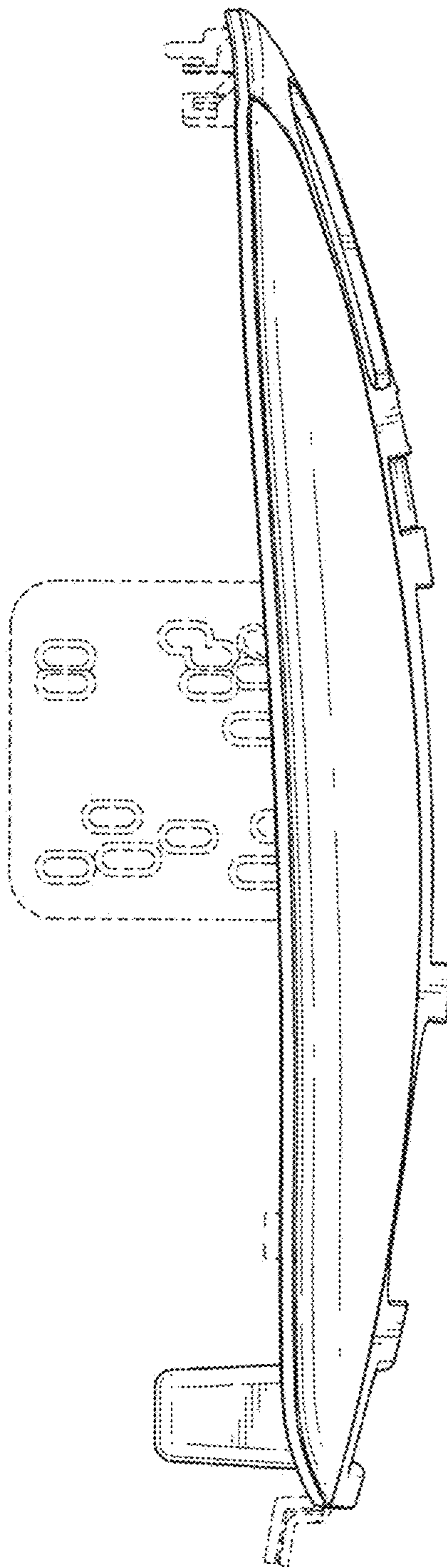

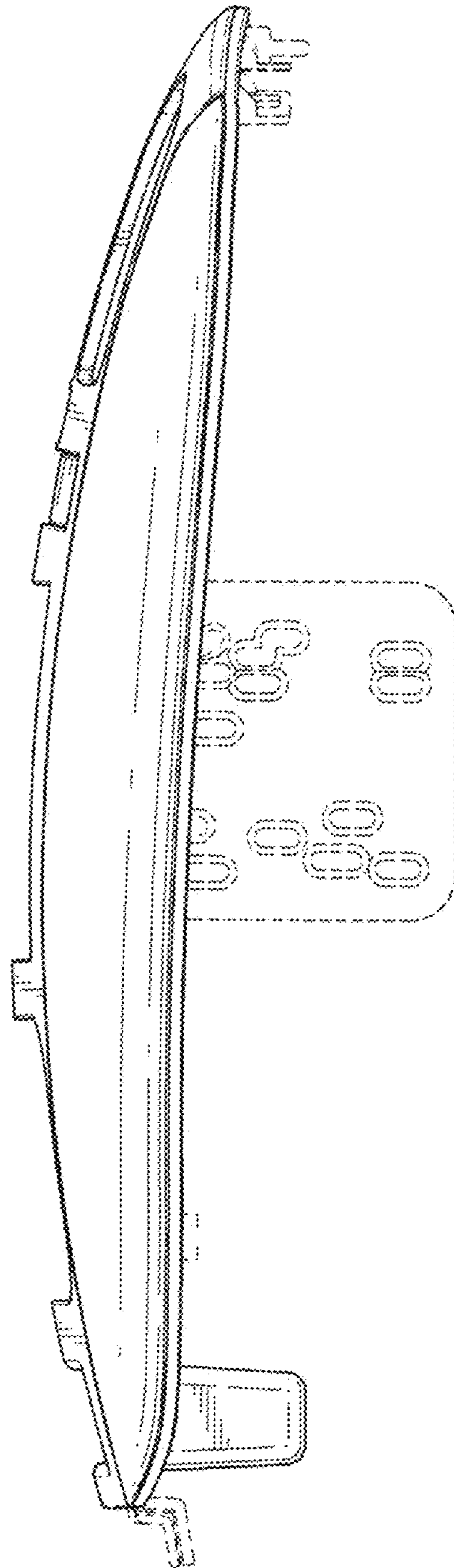

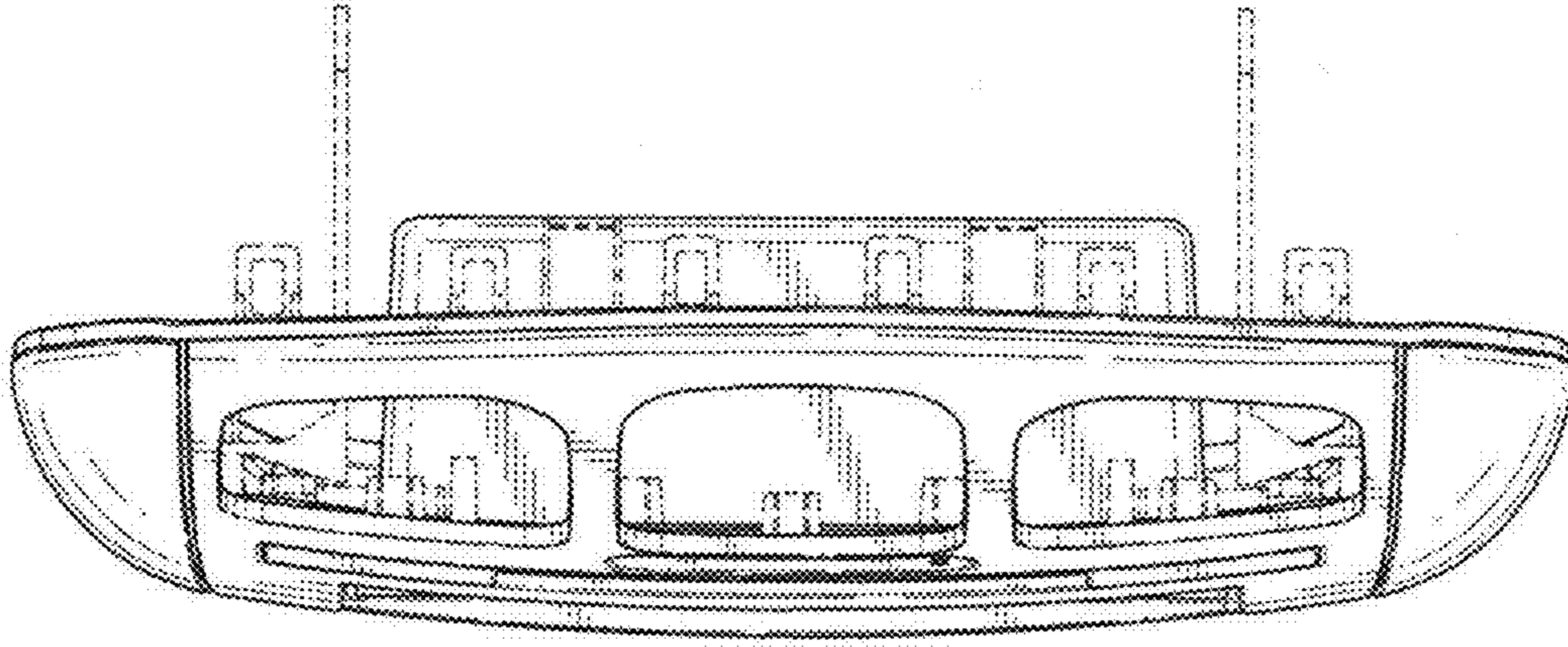

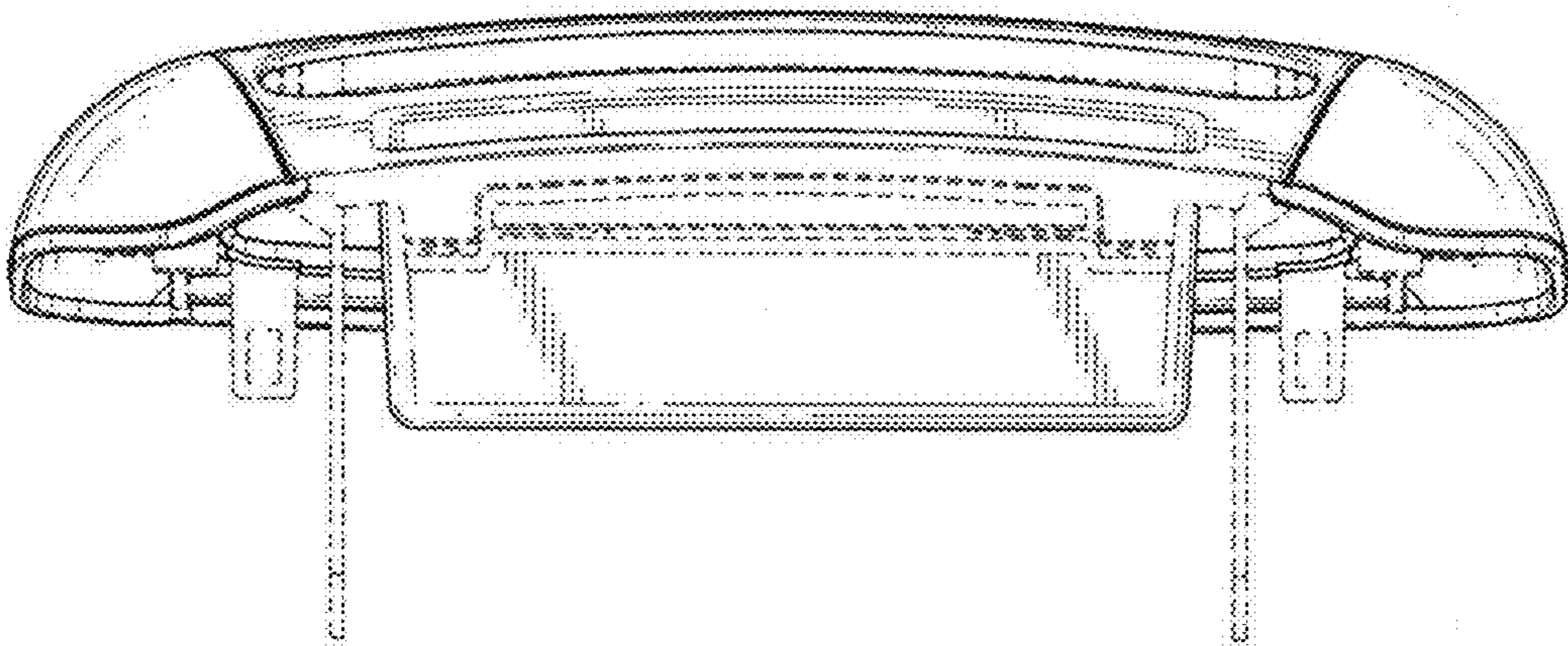
