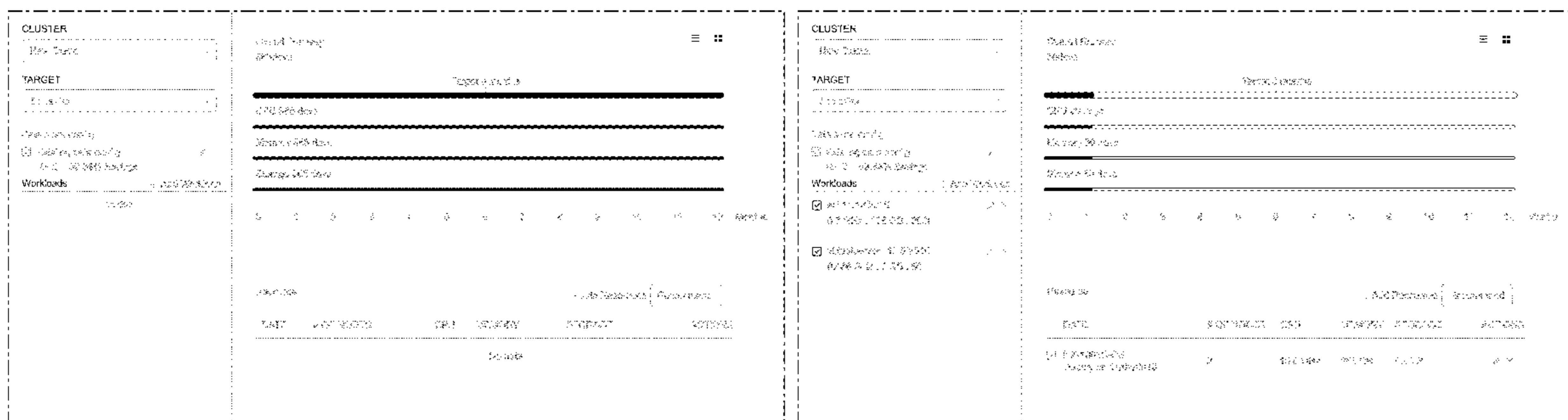
(57) **CLAIM**

The ornamental designs for display screen or portion thereof with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first image of a display screen or portion thereof with animated graphical user interface showing our new design;  
FIG. 2 is a front view of a second image thereof; and,  
FIG. 3 is a front view of a third image of our new design. The dot-dash broken line showing of a display screen or portion thereof forms no part of the claimed design. The short dash broken line showing of the remainder of the graphical user interface forms no part of the claimed design. The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-3. The process or period in which one image transitions to another forms no part of the claimed design.

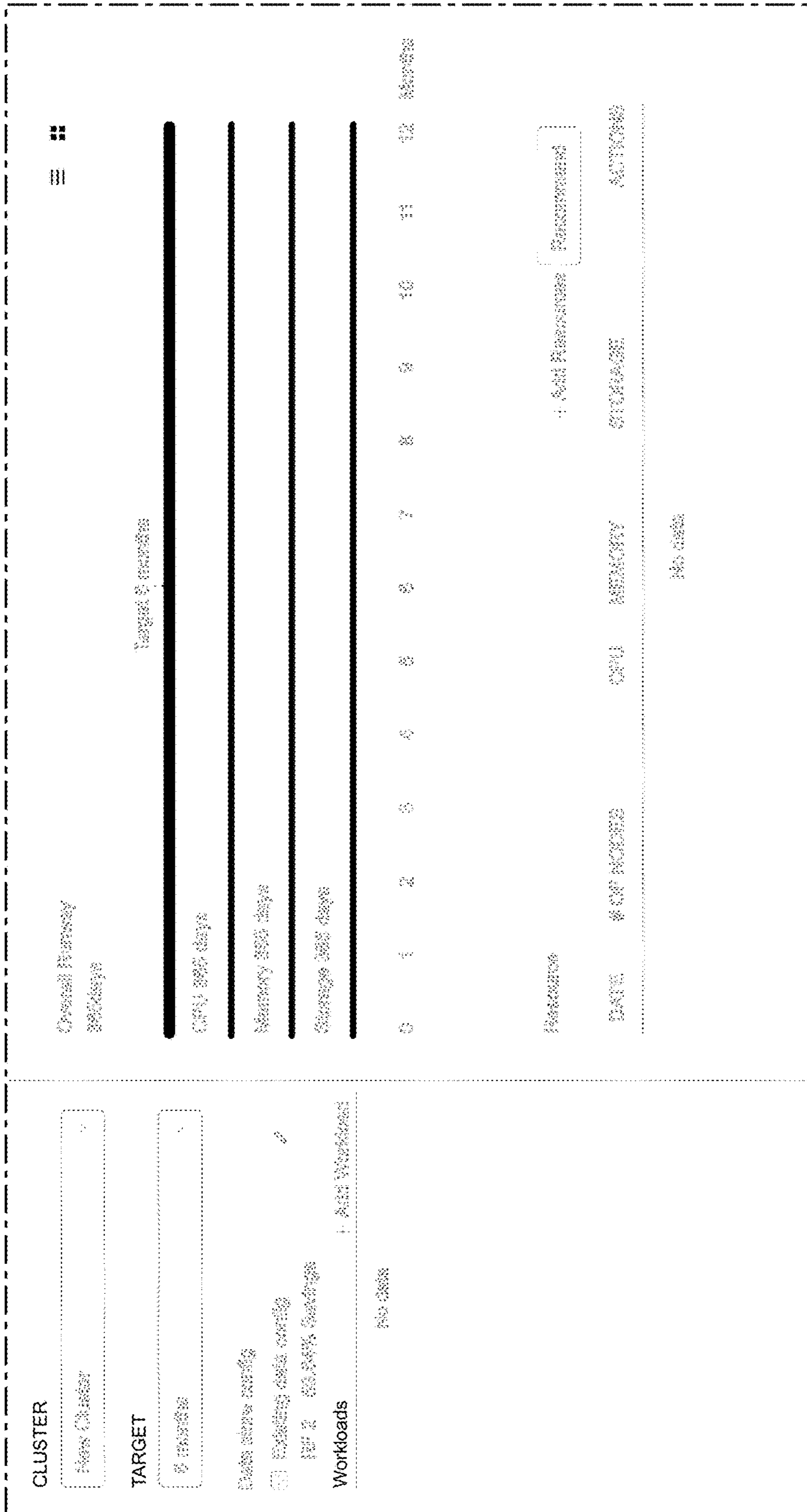

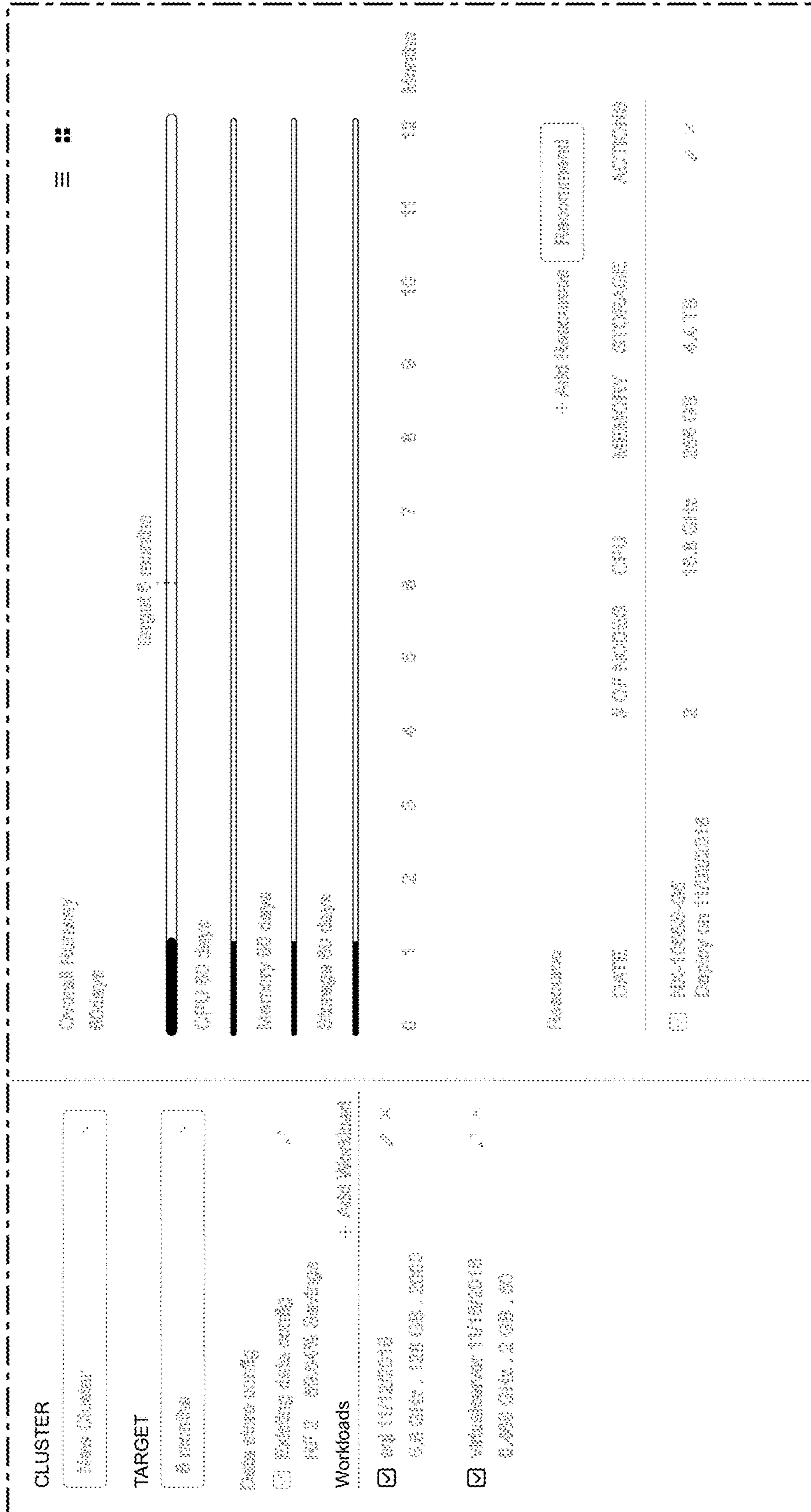

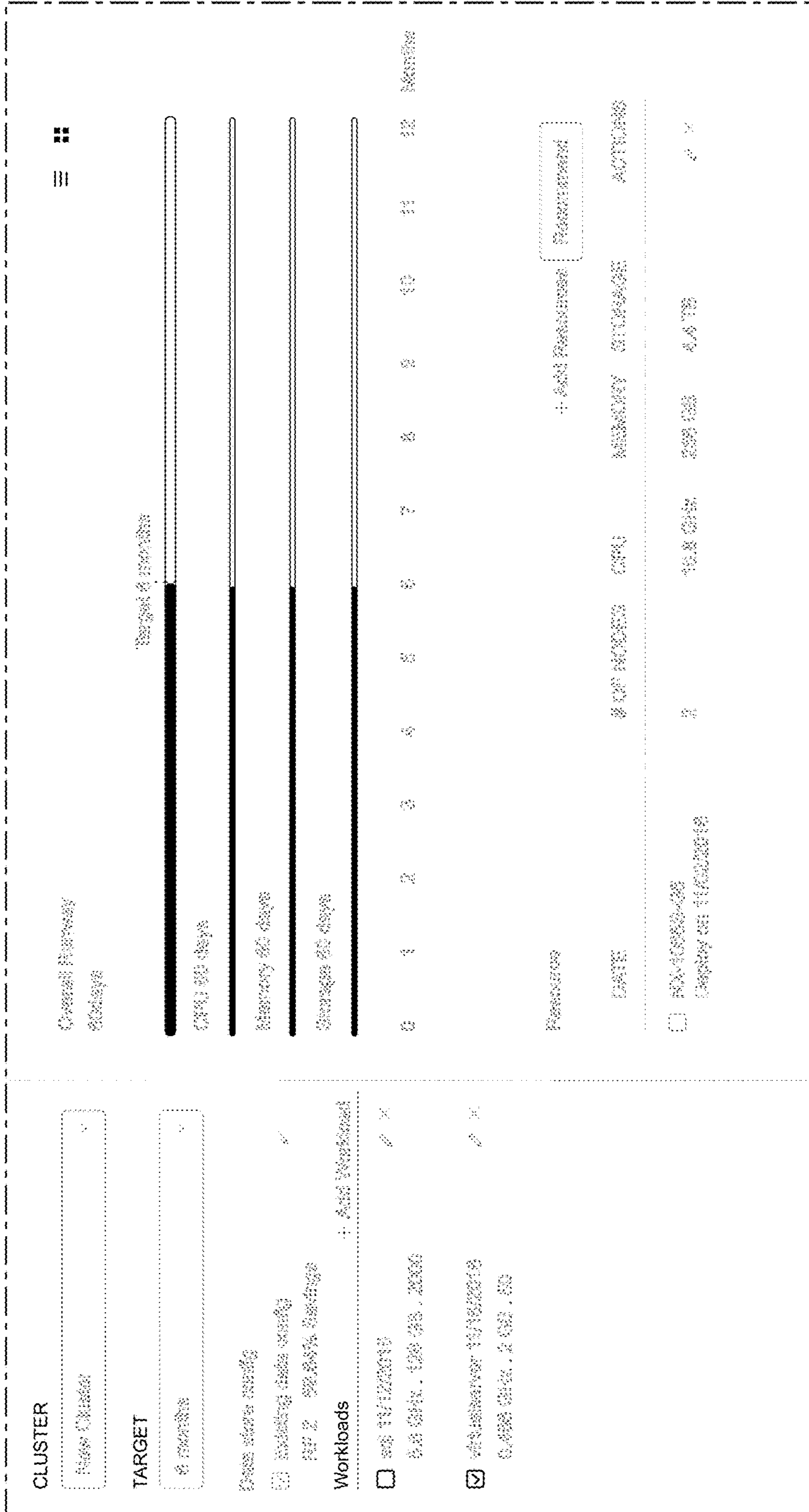
